FIG. 4 is a left end view thereof.

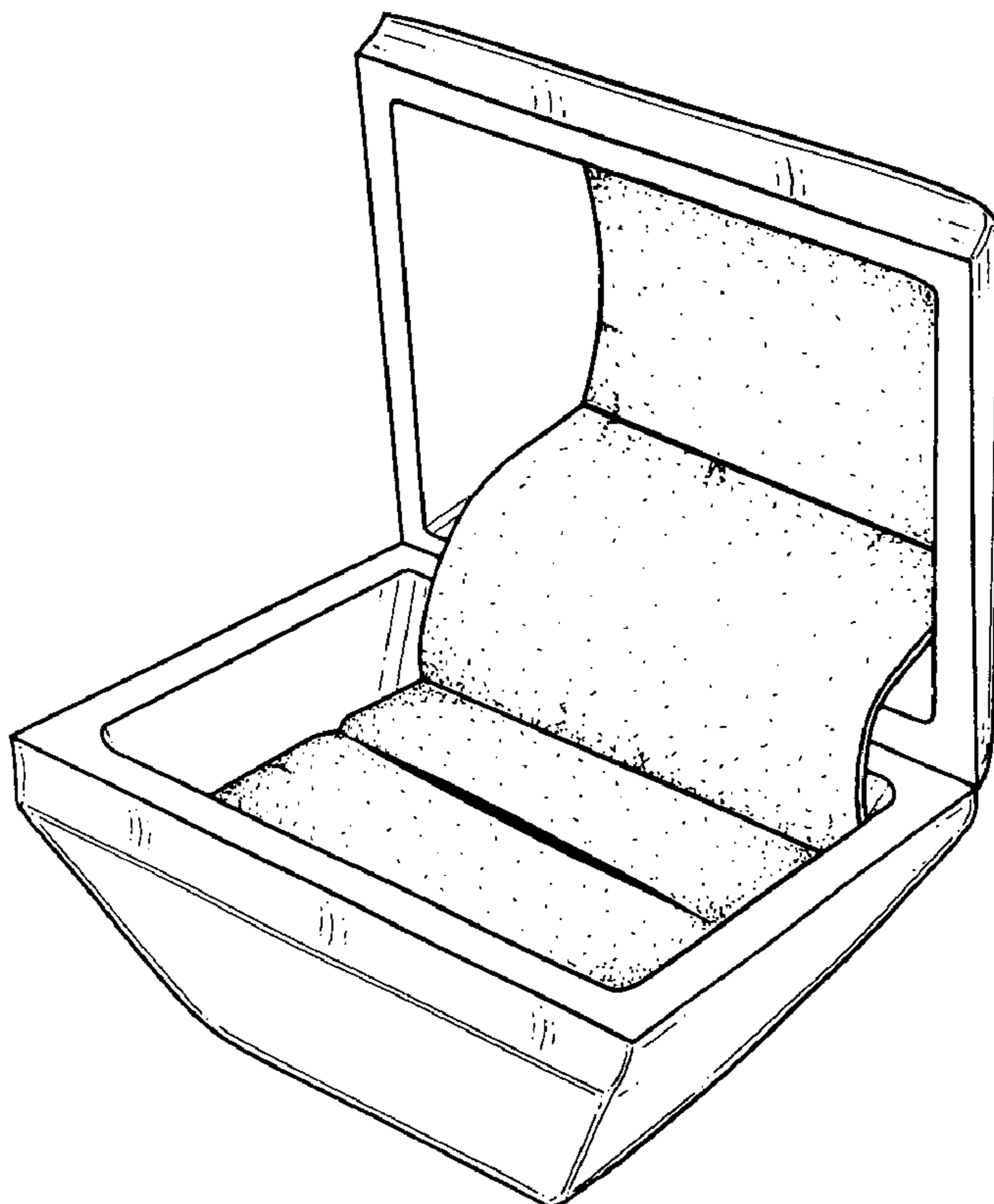
FIG. 5 is a right end view thereof.

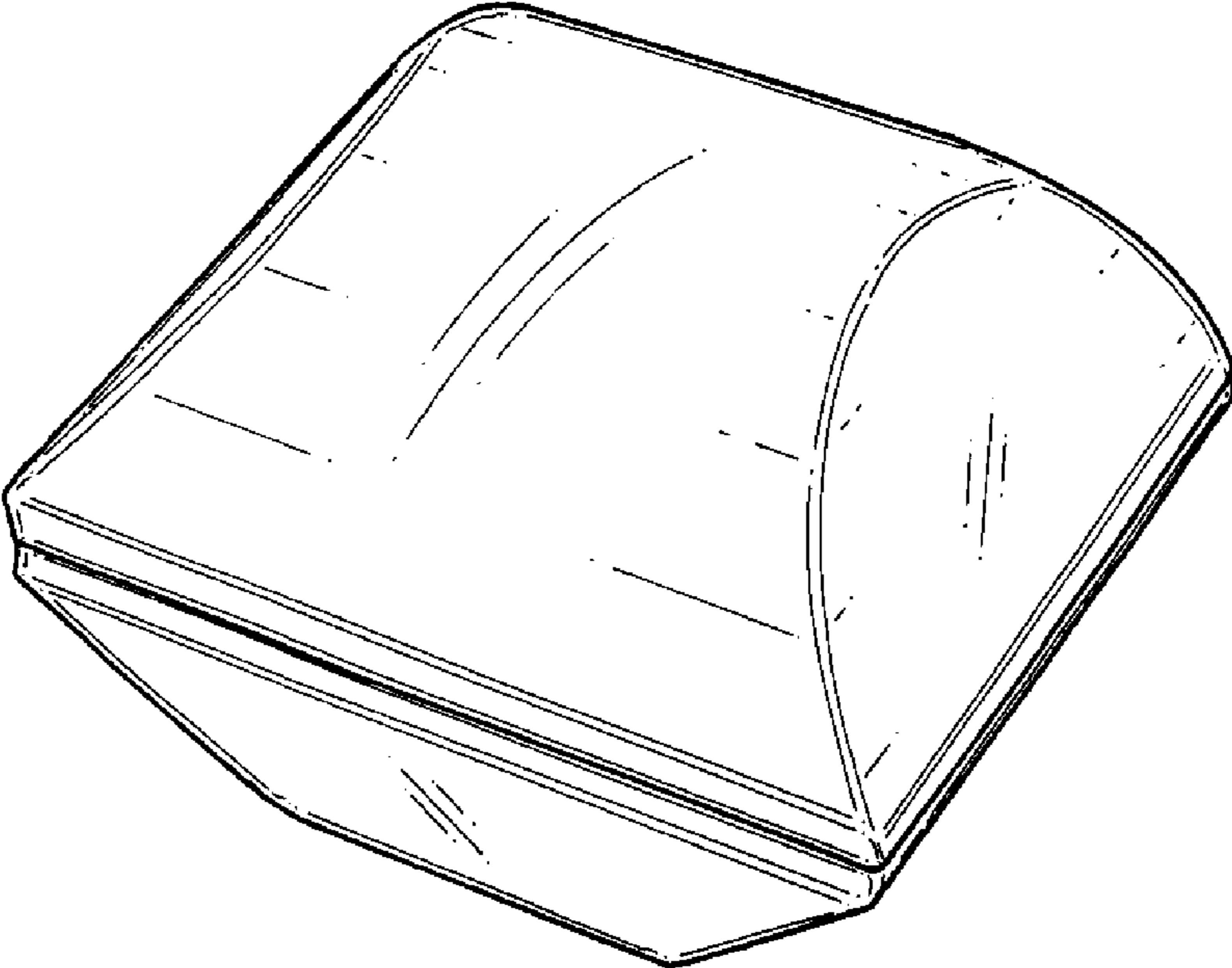

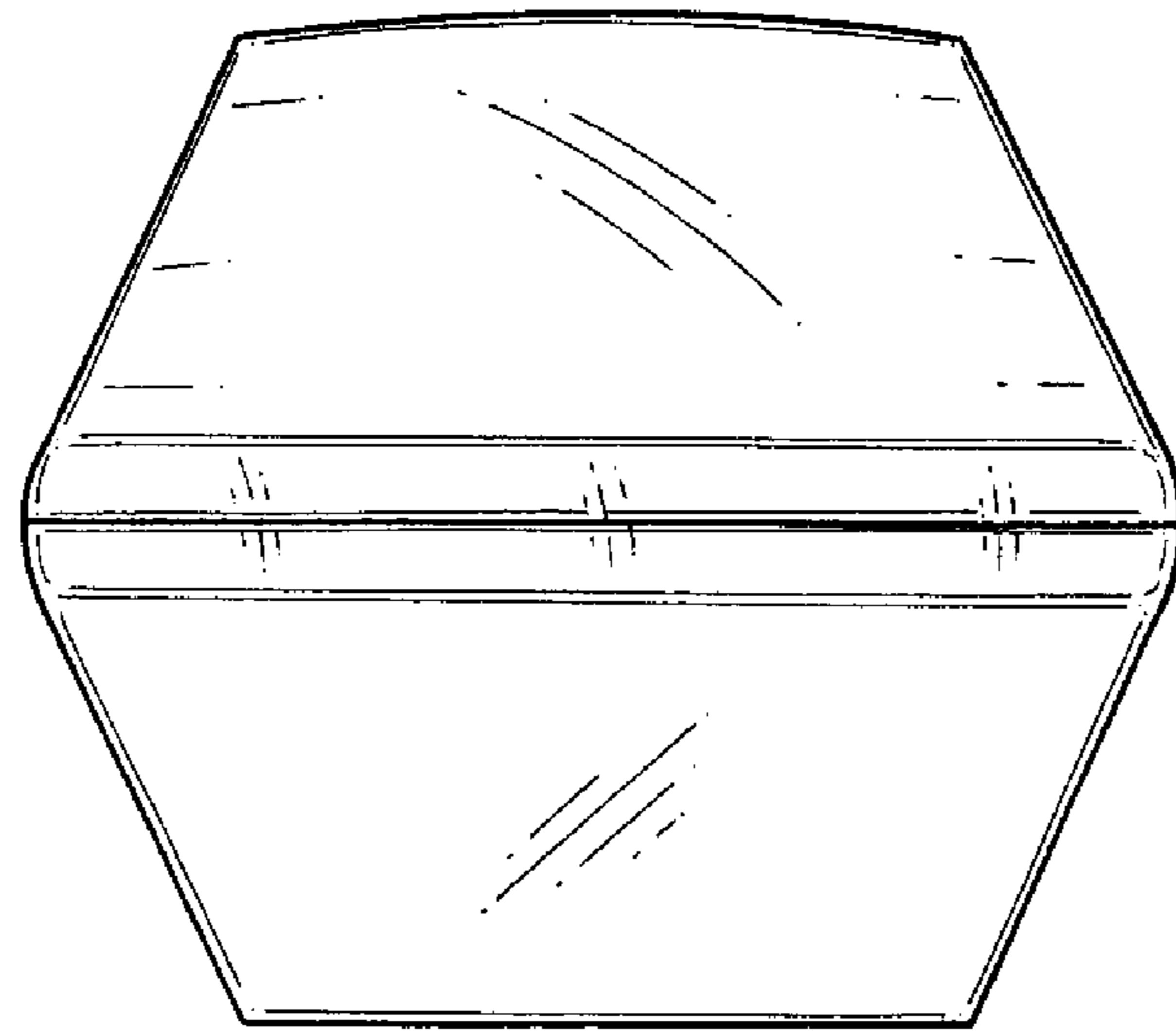

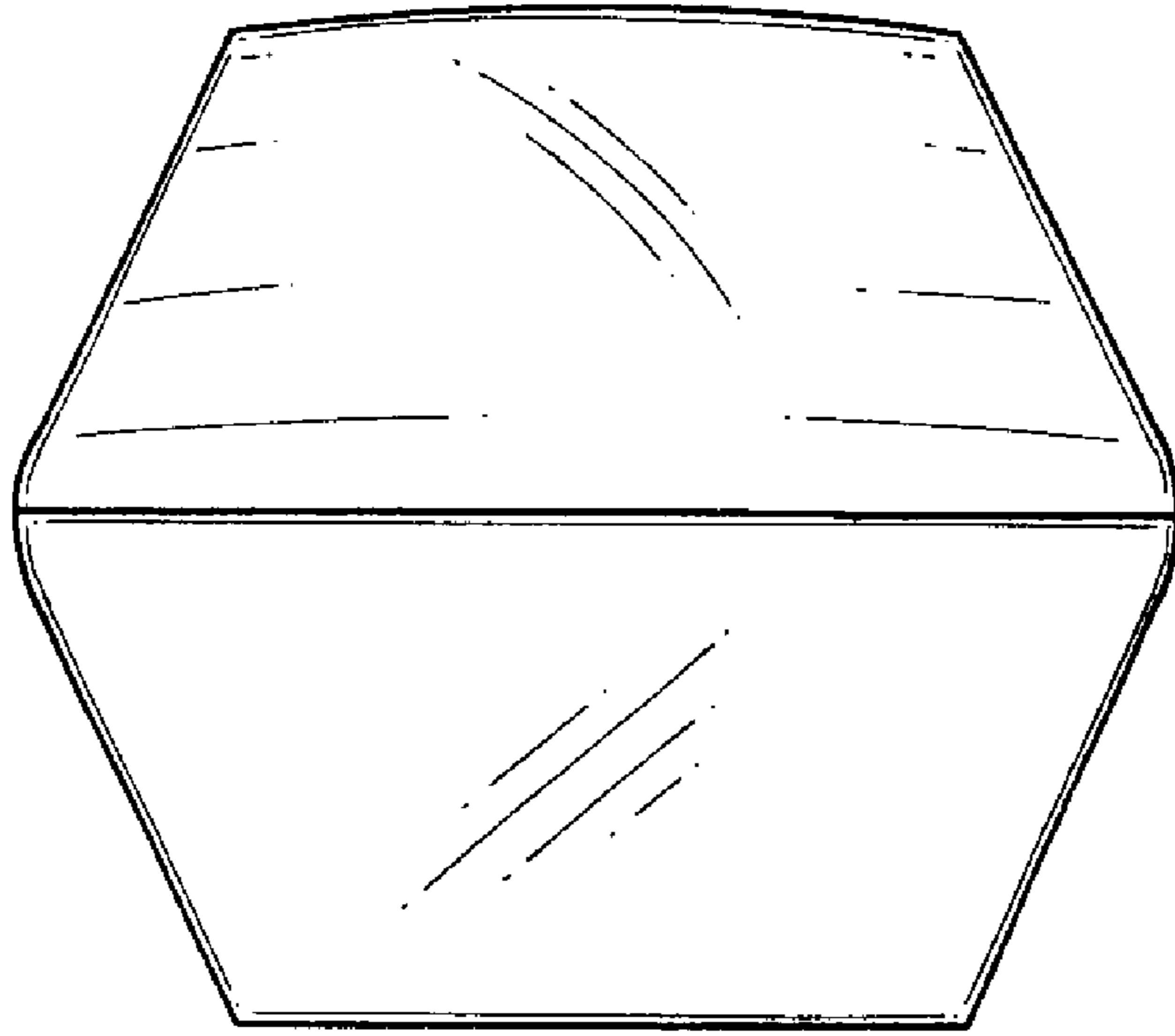

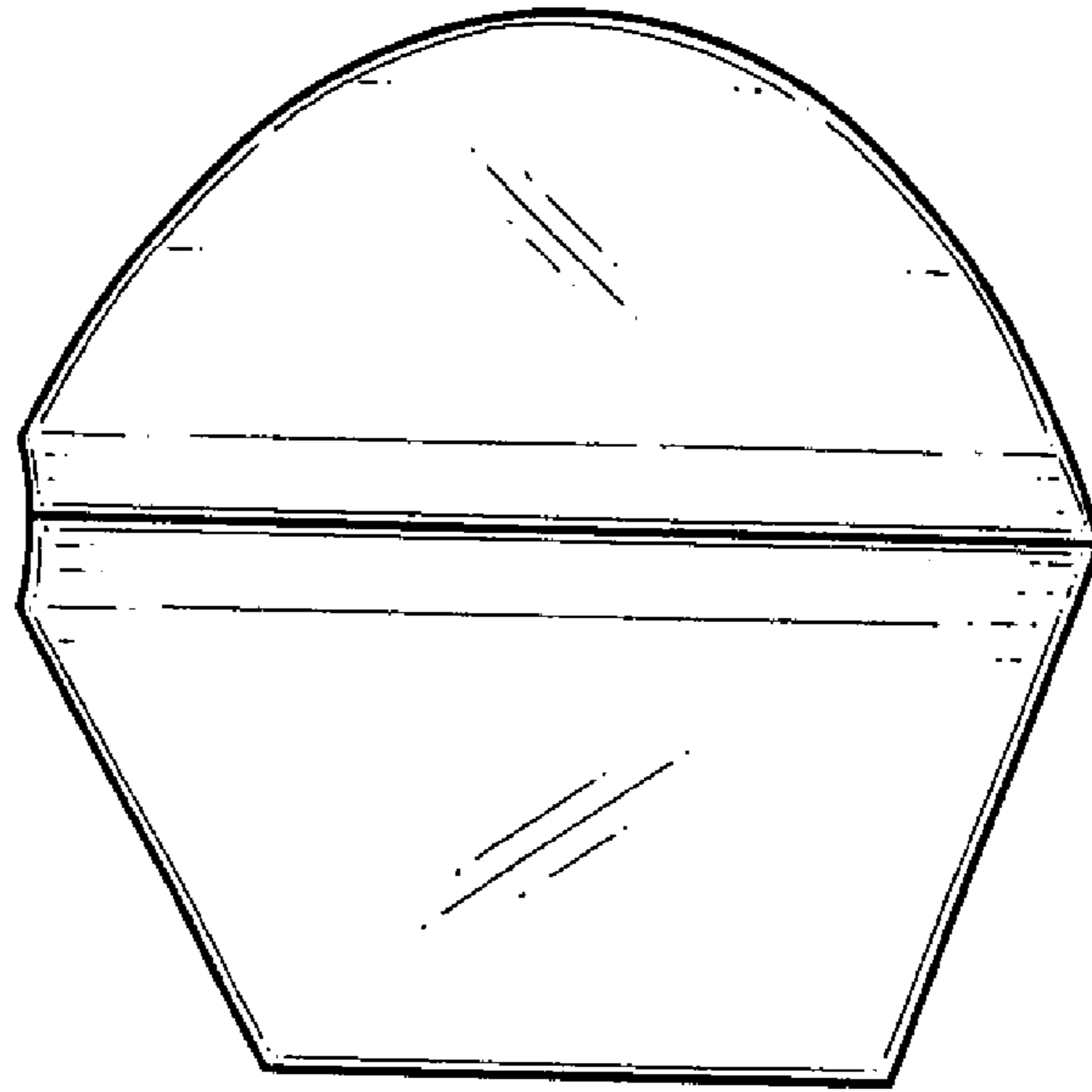

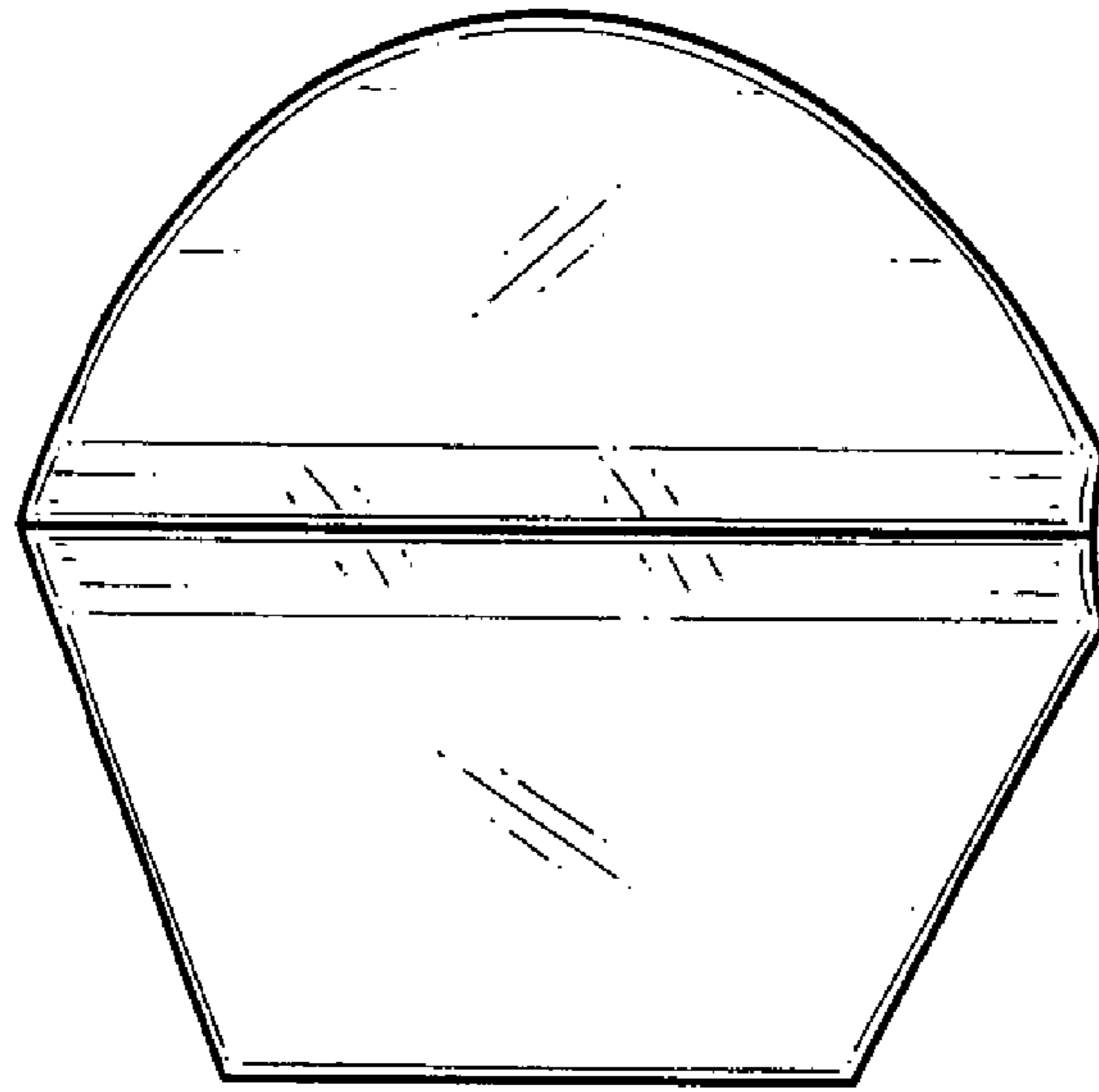

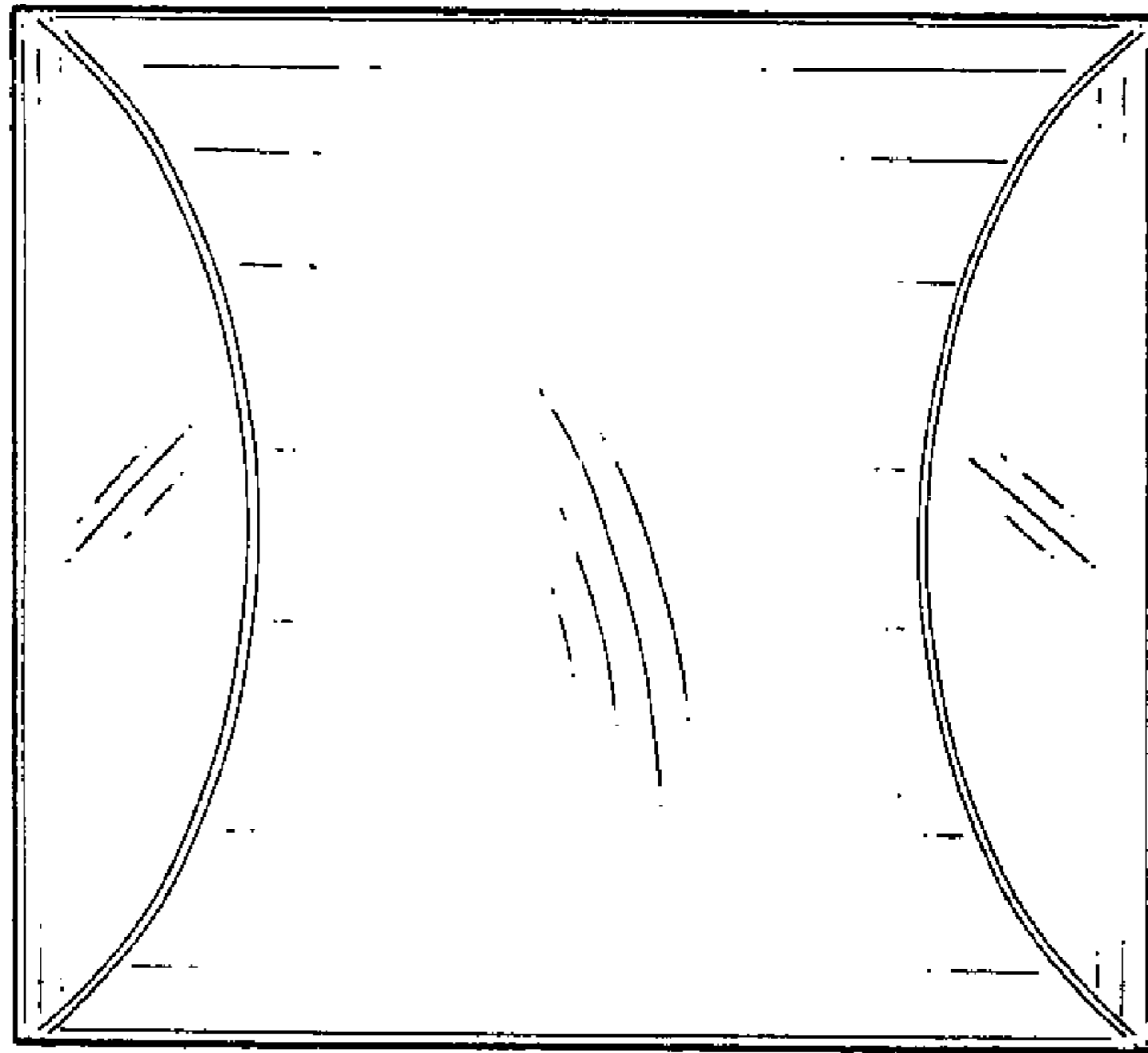

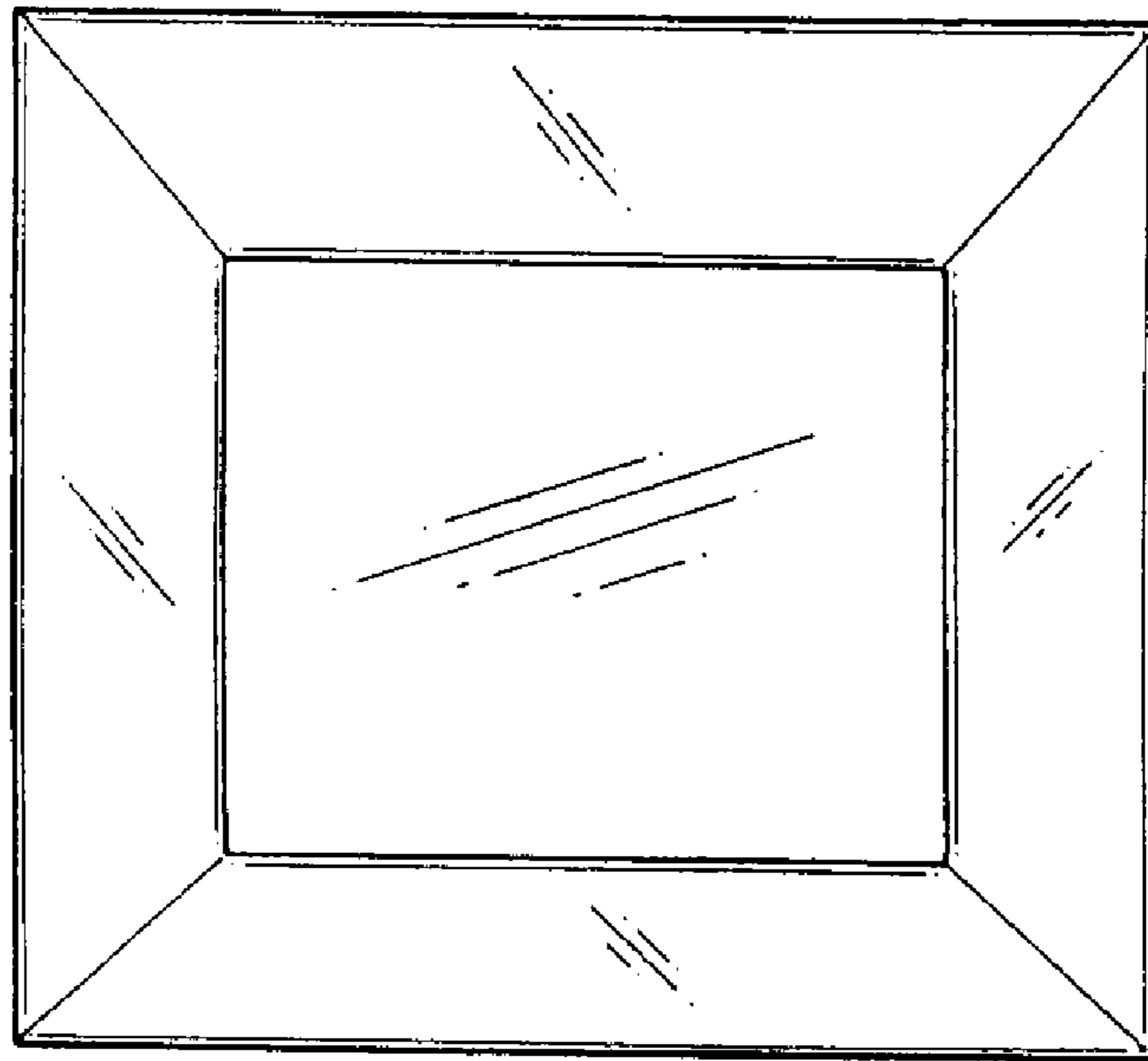

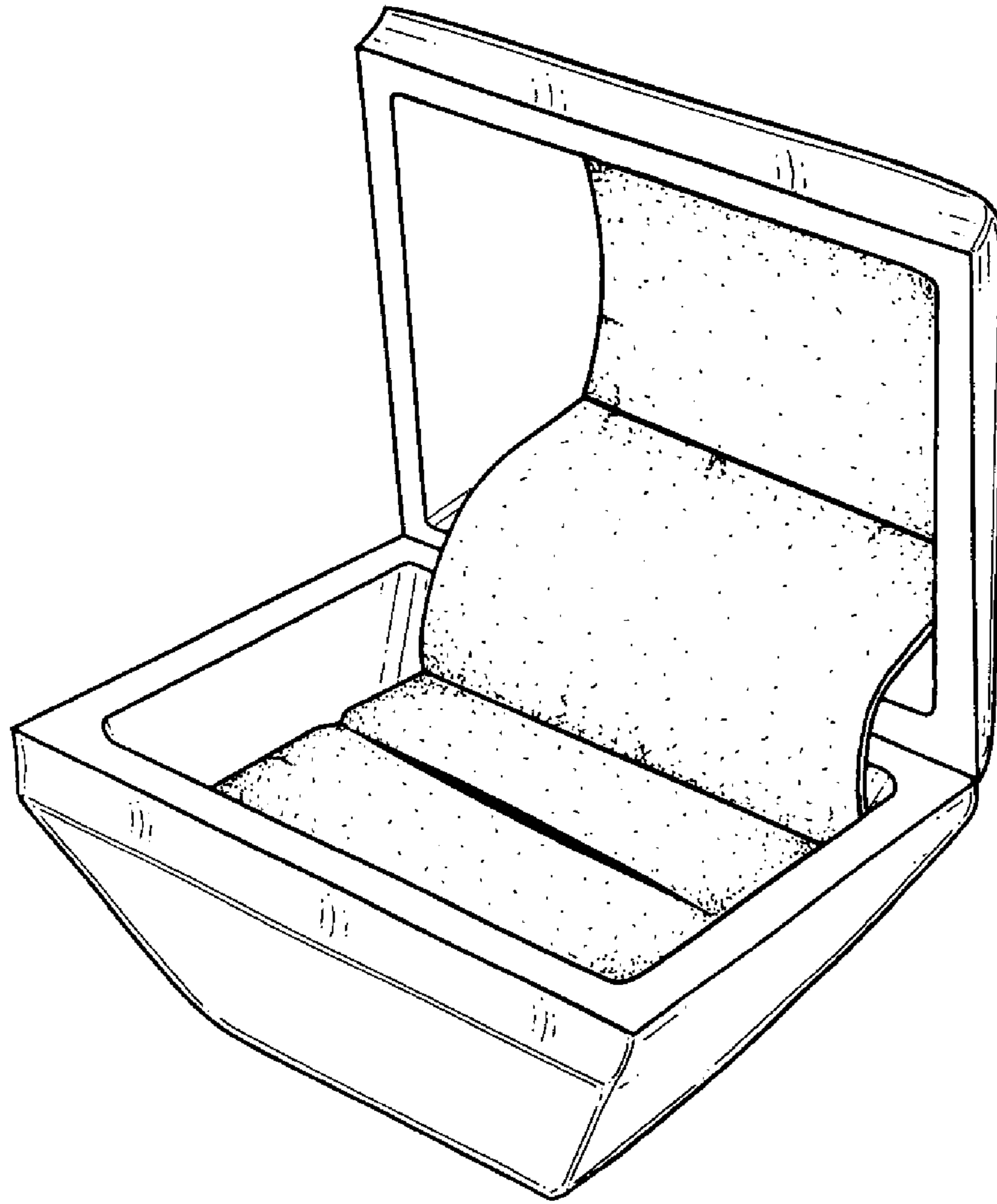
