FIG. 9 shows a perspective view of the handle of FIG. 6, shown in a folded condition.

FIG. 10 shows a handle according to a third embodiment of the present invention, shown in a top view in an unfolded condition, the bottom view being the same. FIG. 11 shows a front edge view of the handle of FIG. 10, shown in an unfolded condition.
