(57) **CLAIM**

The ornamental design for a handle, as shown and described.

DESCRIPTION

FIG. 1 shows a handle according to a first embodiment of the present invention, shown in a top view in an unfolded condition, the bottom view being the same.

FIG. 2 shows a front edge view of the handle of FIG. 1, shown in an unfolded condition.

FIG. 3 shows a rear edge view of the handle of FIG. 1, shown in an unfolded condition.

FIG. 4 shows a right edge view of the handle of FIG. 1, shown in an unfolded condition, the left edge view being the same.

FIG. 5 shows a perspective view of the handle of FIG. 1, shown in a folded condition.

FIG. 6 shows a handle according to a second embodiment of the present invention, shown in a top view in an unfolded condition, the bottom view being the same.

FIG. 7 shows a front edge view of the handle of FIG. 6, shown in an unfolded condition, the rear edge view being the same.

FIG. 8 shows a front edge view of the handle of FIG. 6, shown in an unfolded condition, the left edge view being the same.

FIG. 9 shows a perspective view of the handle of FIG. 6, shown in a folded condition.

FIG. 10 shows a handle according to a third embodiment of the present invention, shown in a top view in an unfolded condition, the bottom view being the same.

FIG. 11 shows a front edge view of the handle of FIG. 10, shown in an unfolded condition.

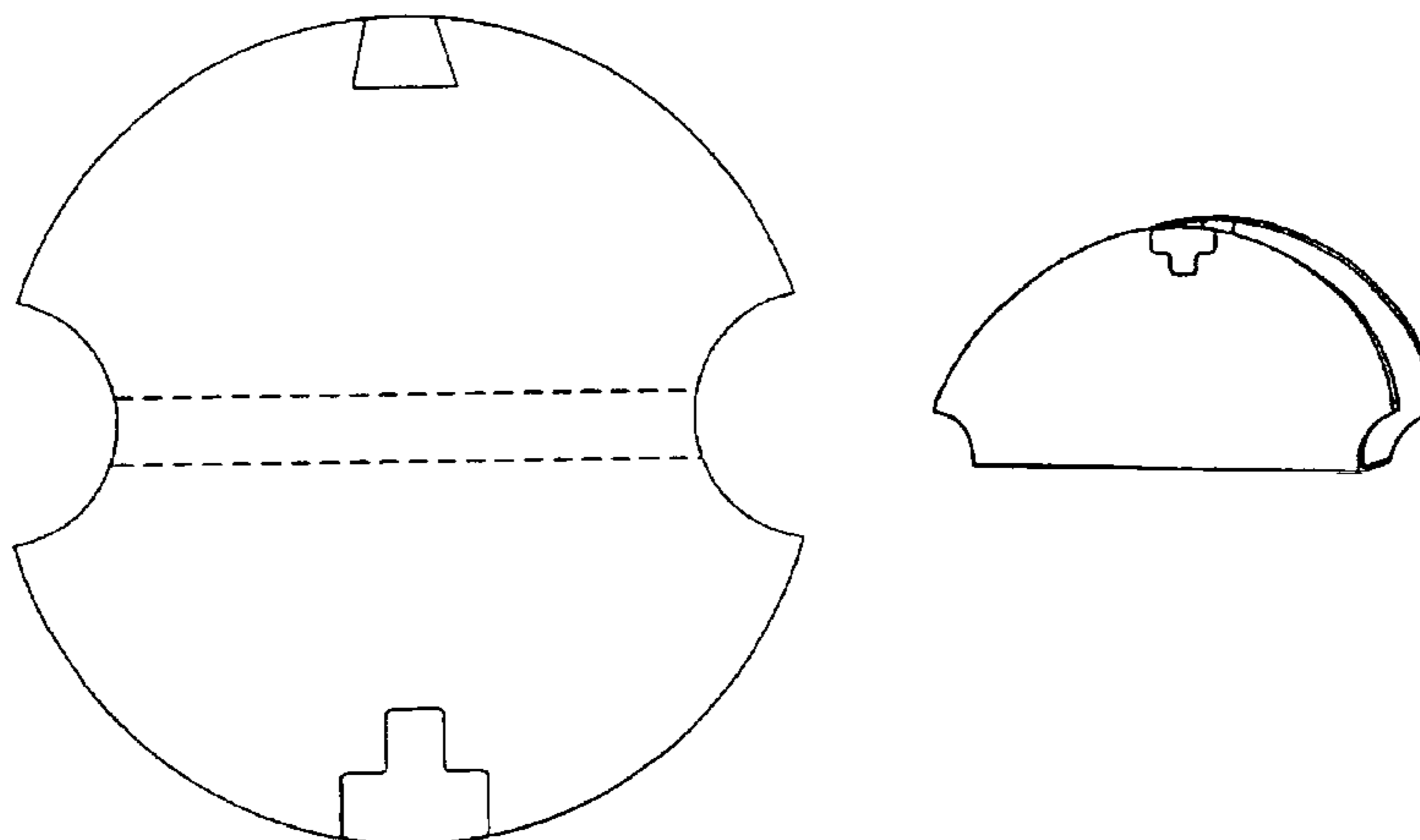
FIG. 12 shows a rear edge view of the handle of FIG. 10, shown in an unfolded condition.

FIG. 13 shows a right edge view of the handle of FIG. 10, shown in an unfolded condition, the left edge view being the same; and,

FIG. 14 shows a perspective view of the handle of FIG. 10, shown in a folded condition.

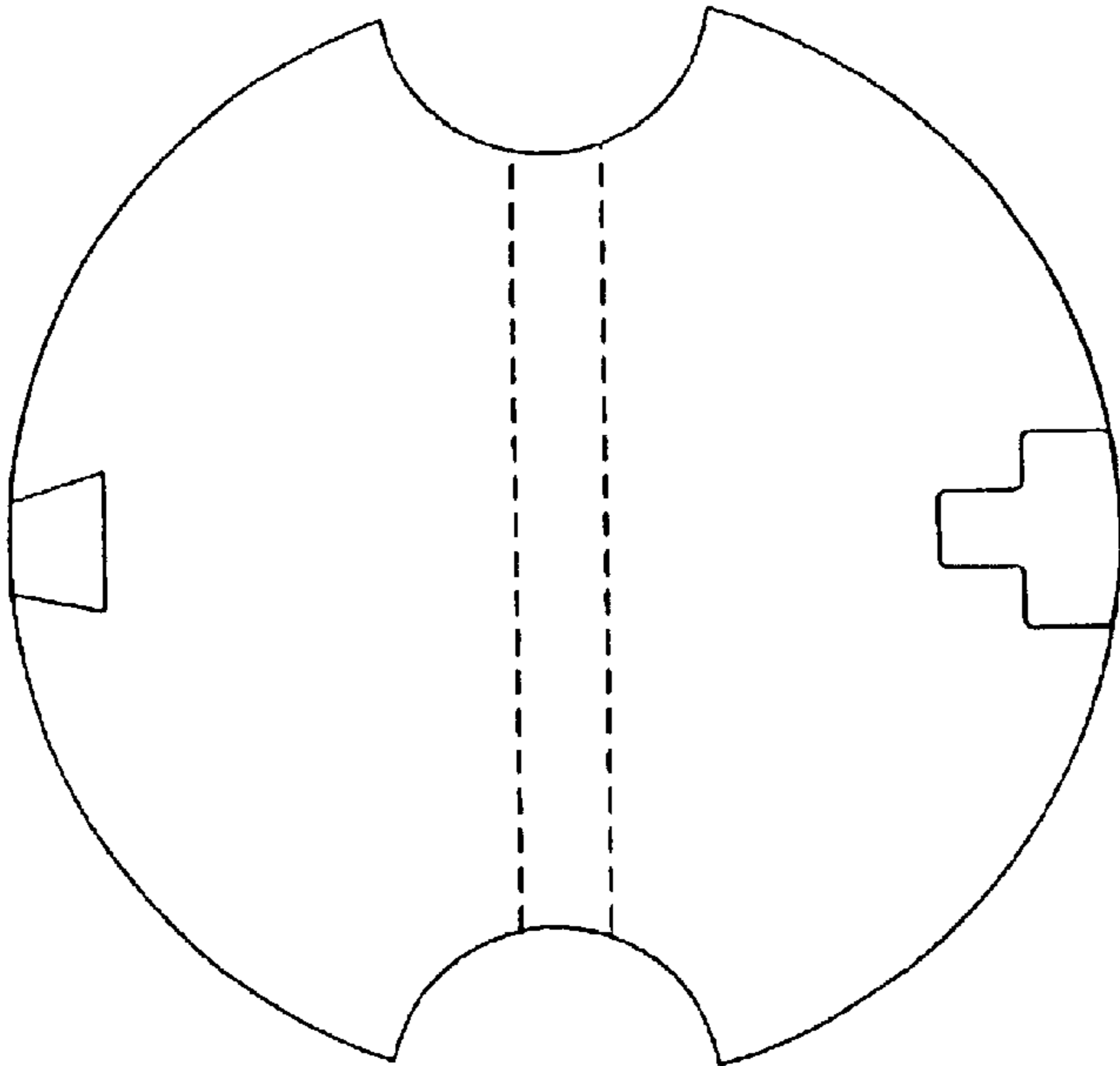

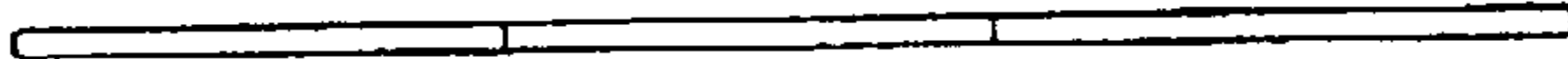

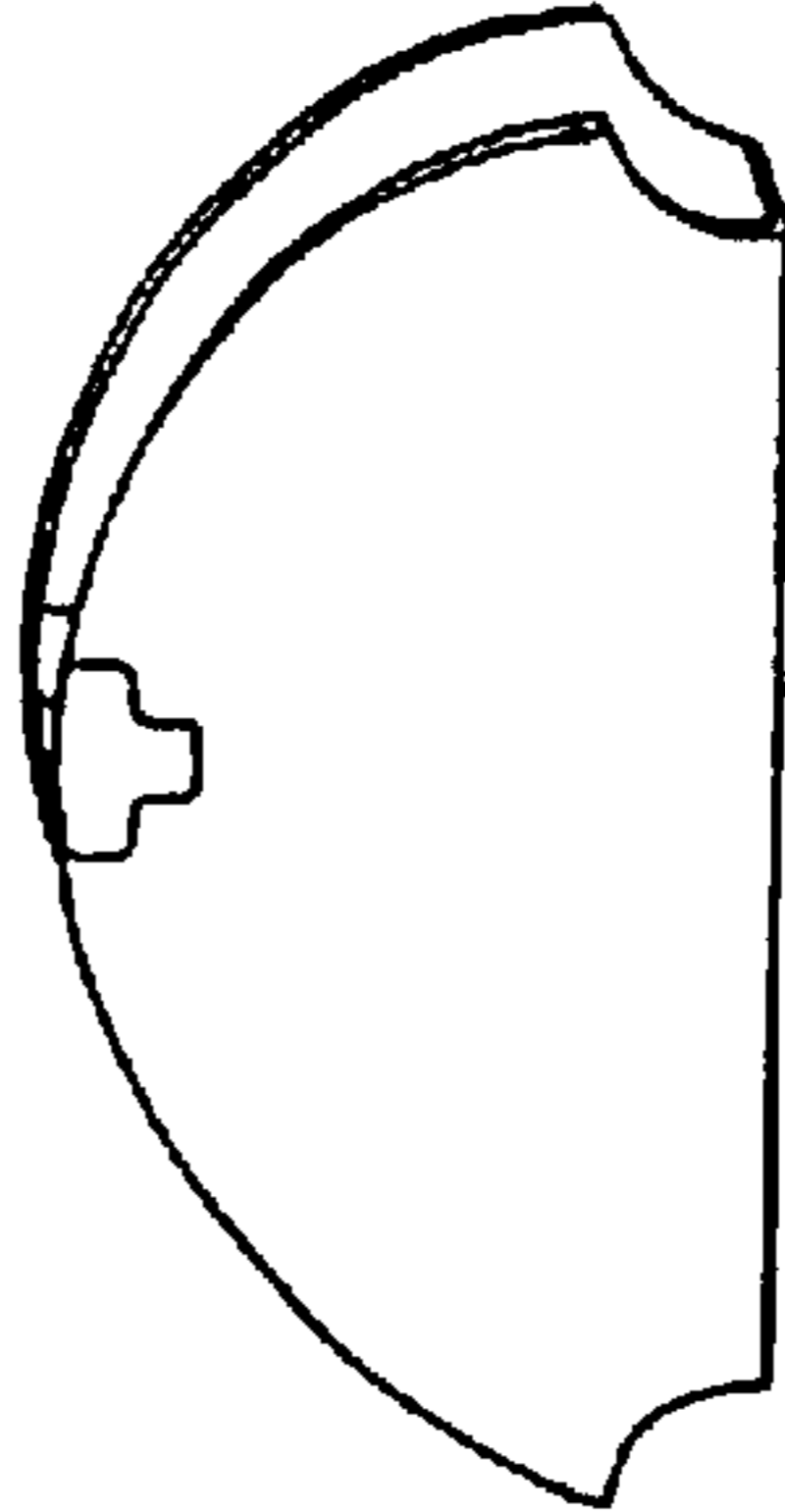

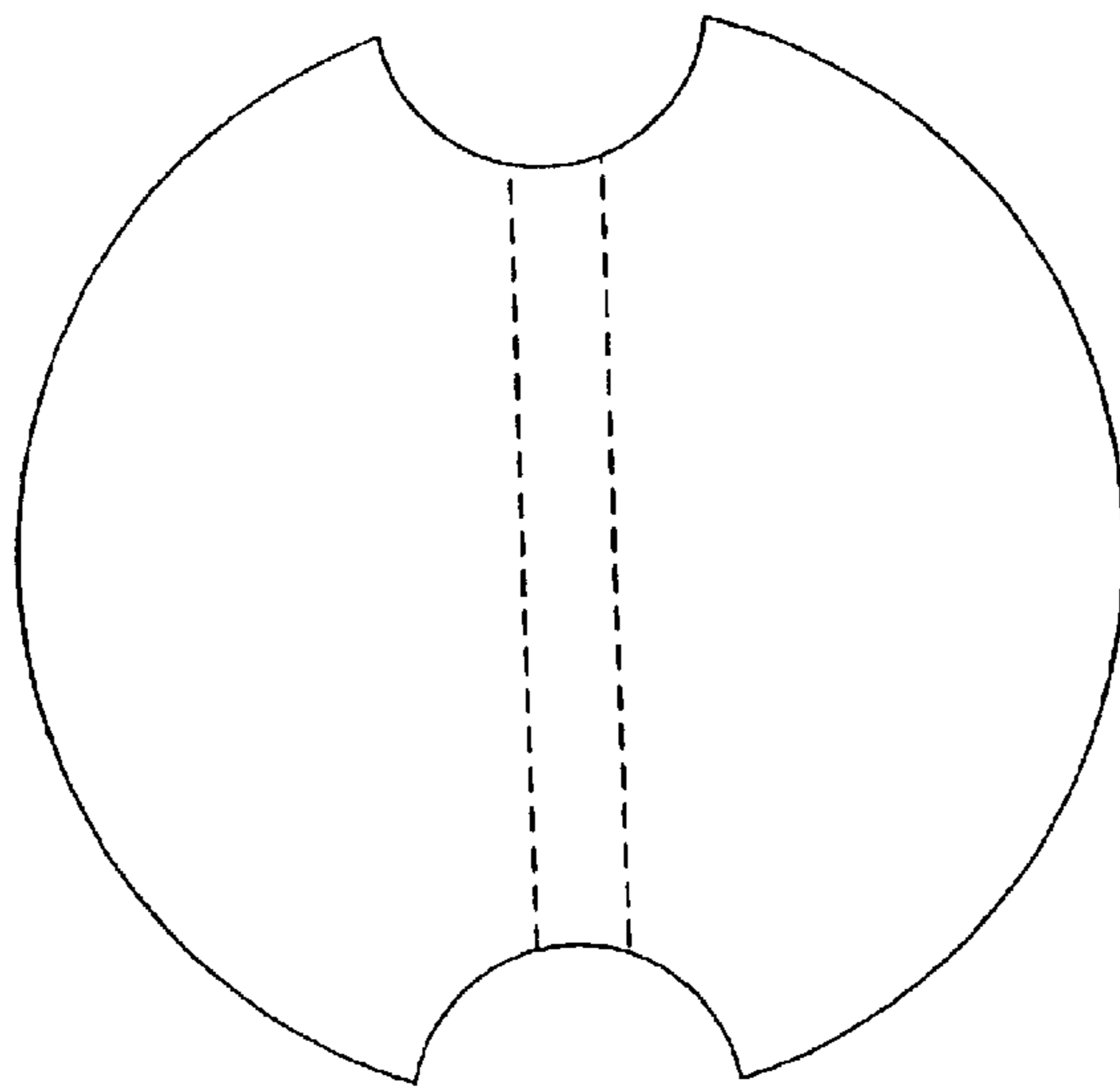

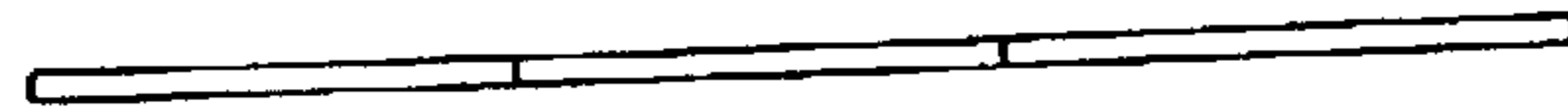

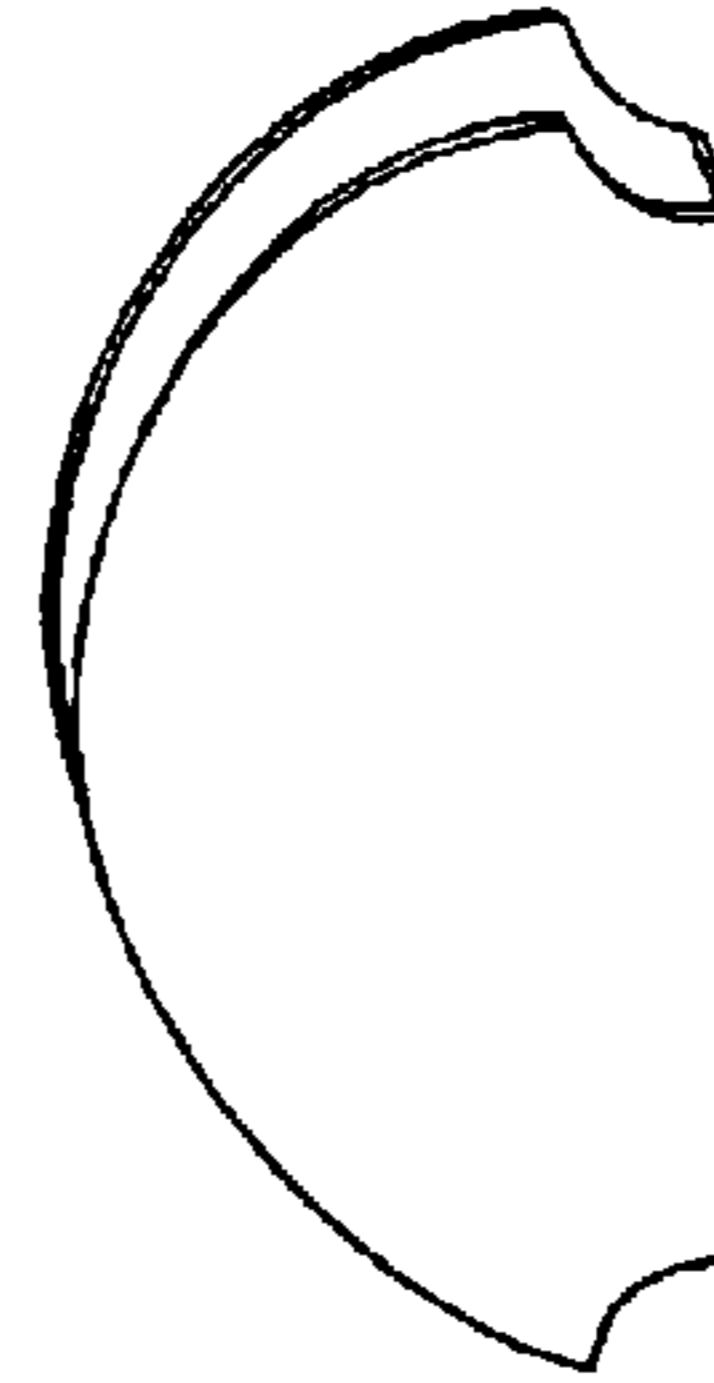

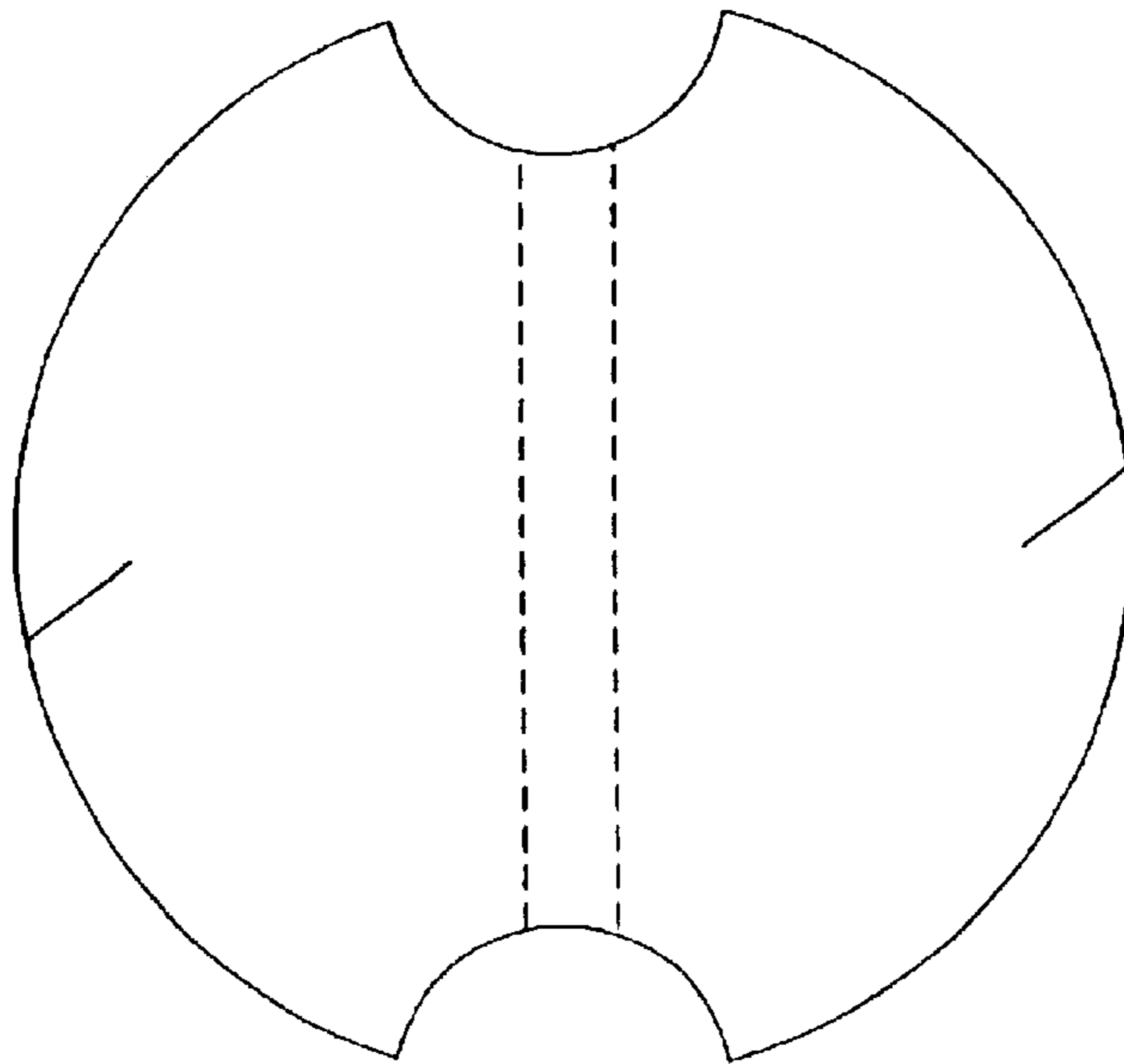

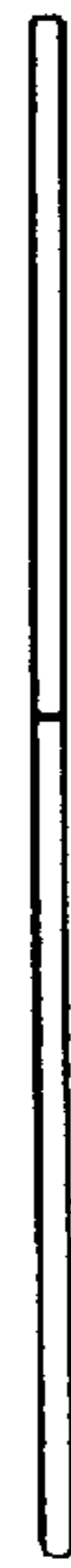

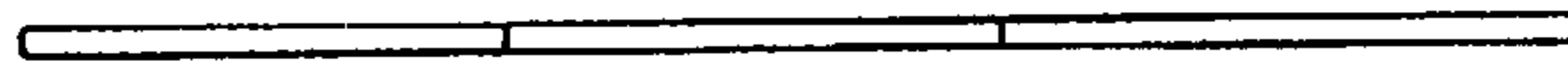

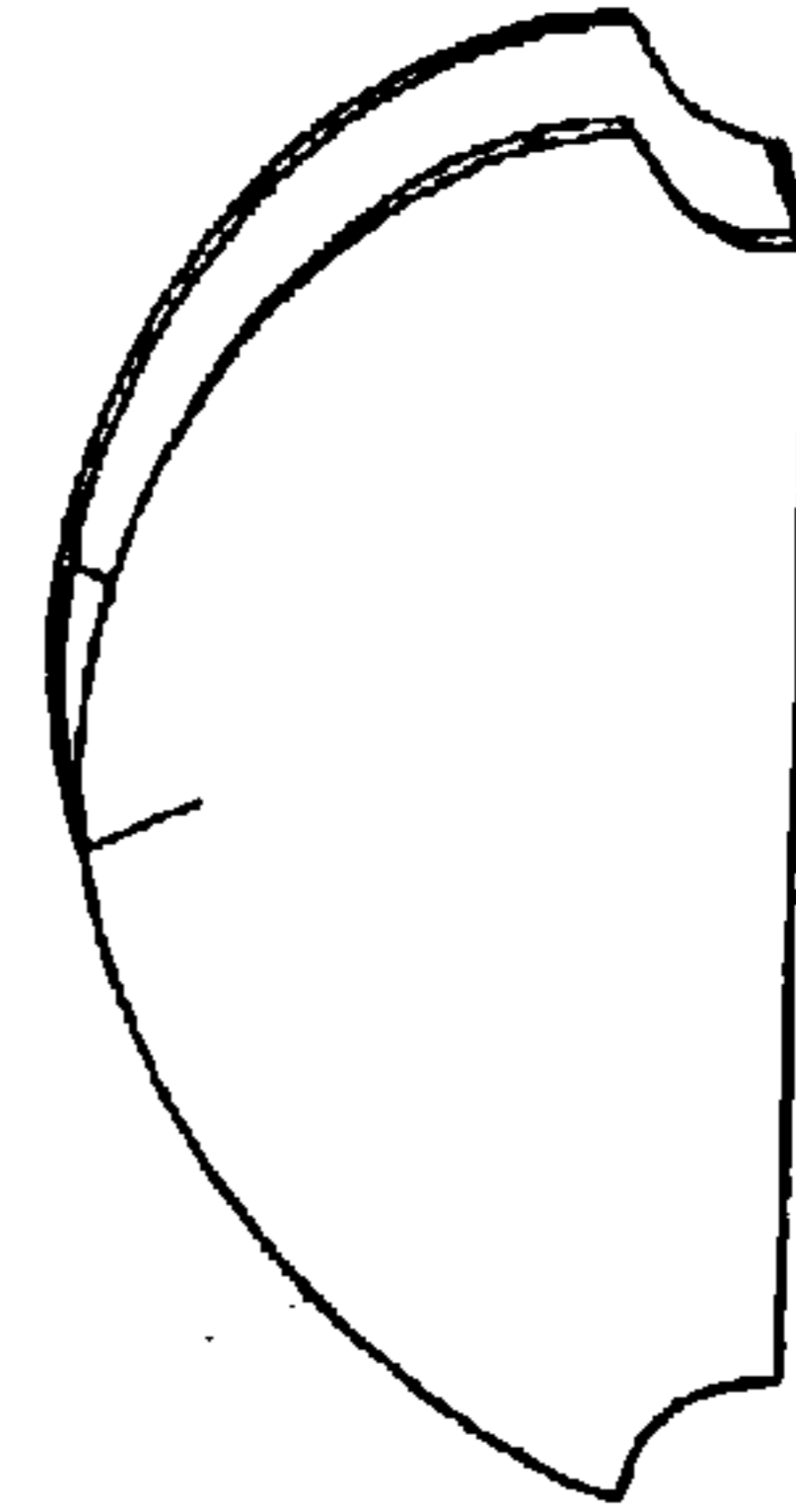
