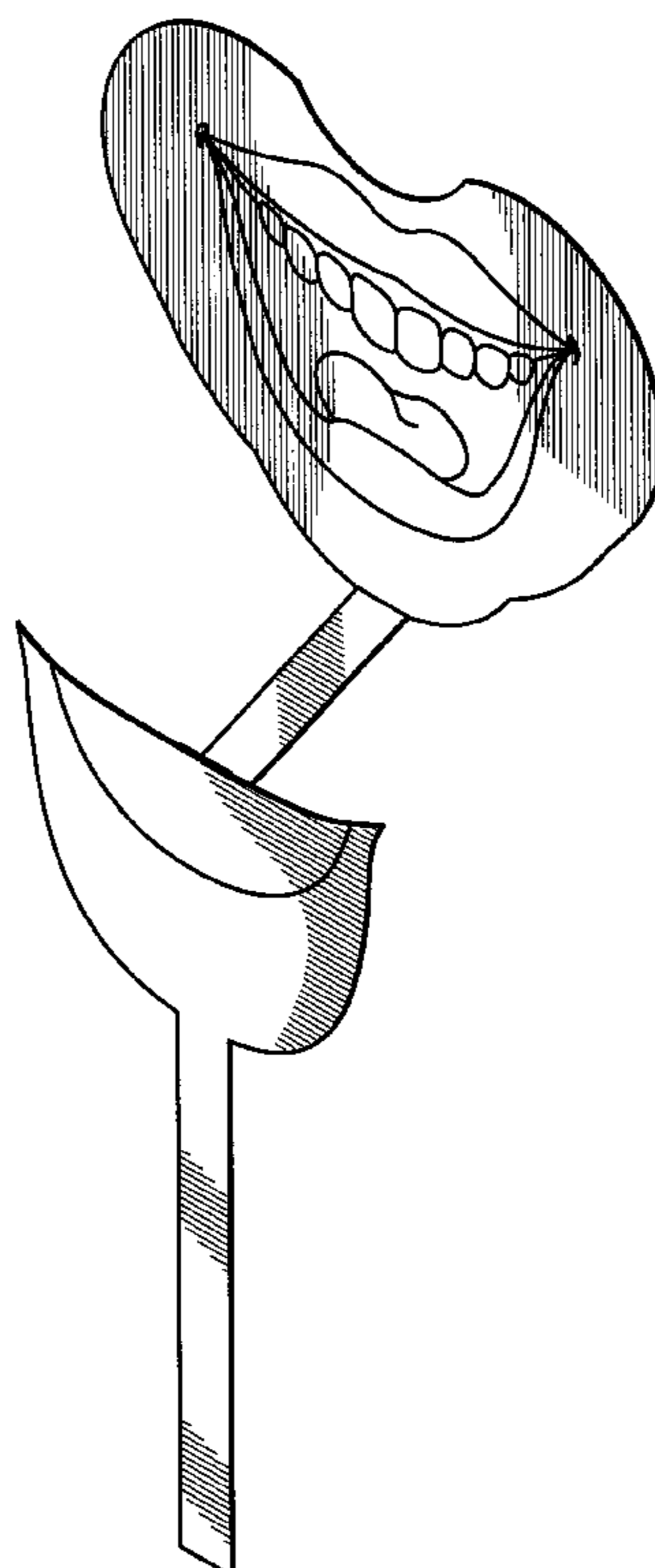
(57) **CLAIM**

The ornamental design for a movable mask, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a movable mask of the present invention in a closed position; FIG. 2 is a front elevation view of the mask of FIG. 1; FIG. 3 is a rear elevation view of the mask of FIG. 1; FIG. 4 is a right side elevation view of the mask of FIG. 1, the left side elevation view being a mirror image thereof; FIG. 5 is a top plan view of the mask of FIG. 1; and FIG. 6 is a bottom plan view of the mask of FIG. 1. FIG. 7 is a perspective view of a movable mask of the present invention in an open position; FIG. 8 is a front elevation view of the mask of FIG. 7; FIG. 9 is a rear elevation view of the mask of FIG. 7; FIG. 10 is a right side elevation view of the mask of FIG. 7, the left side elevation view being a mirror image thereof; FIG. 11 is a top plan view of the mask of FIG. 7; and FIG. 12 is a bottom plan view of the mask of FIG. 7.

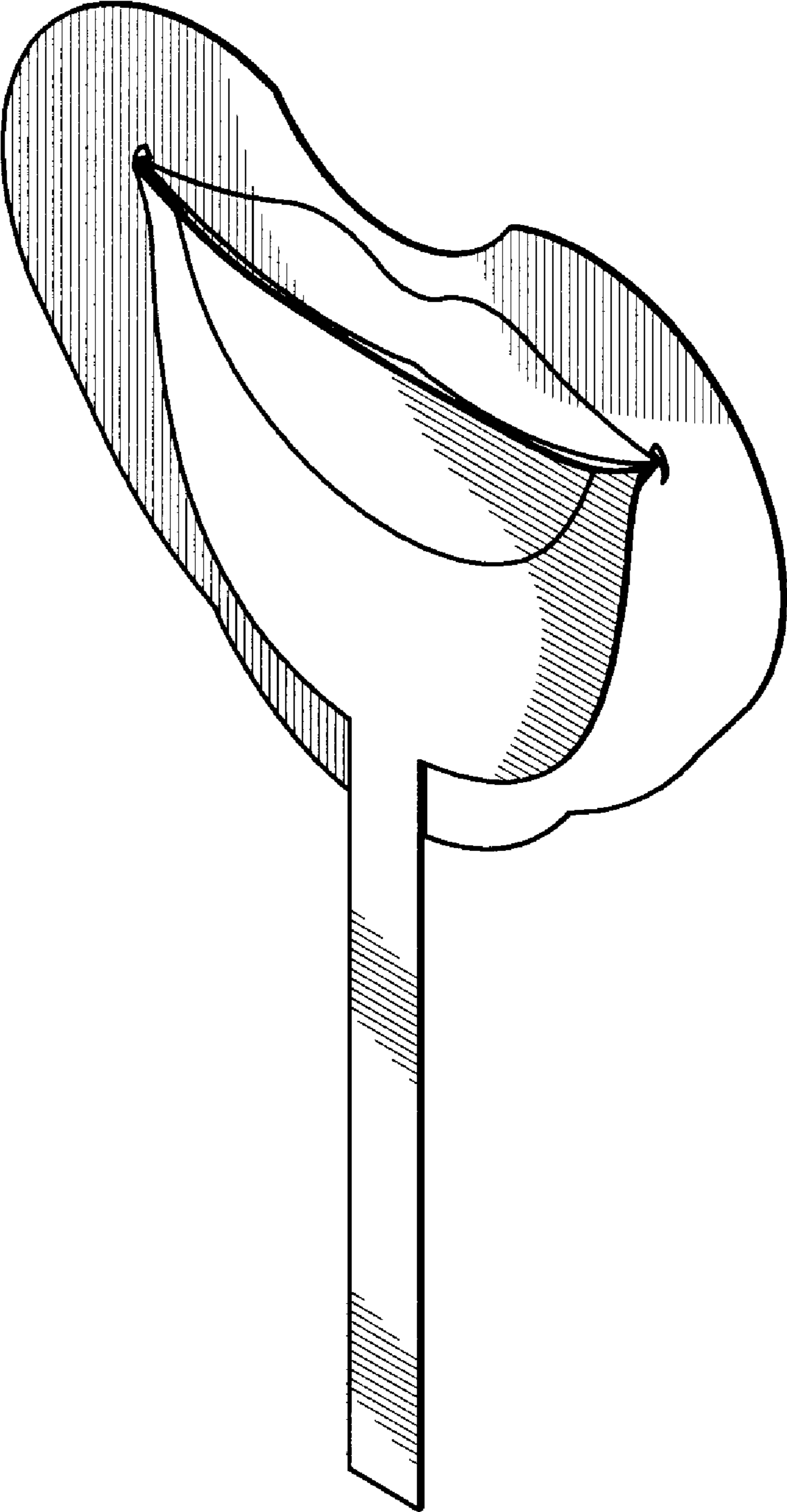

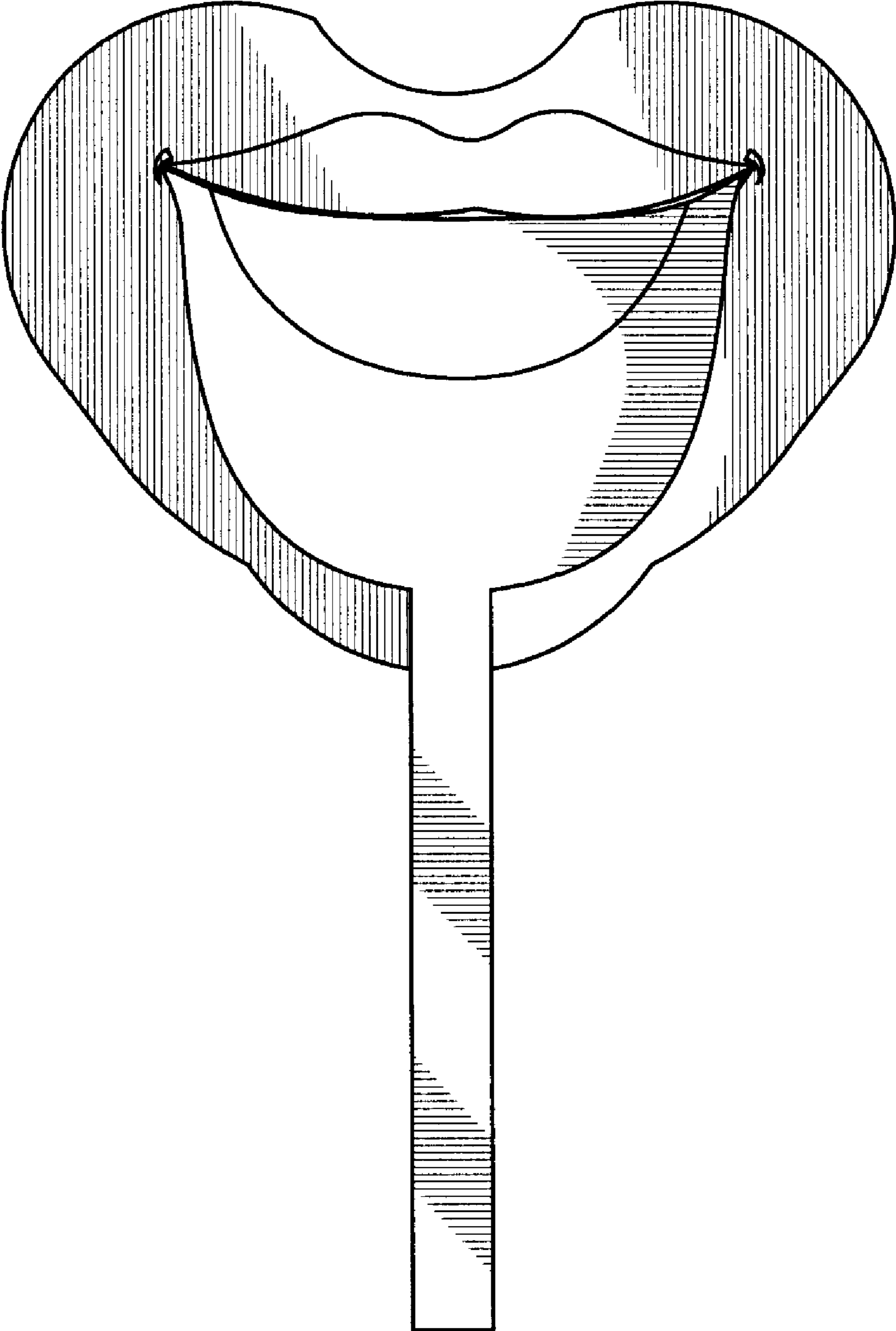

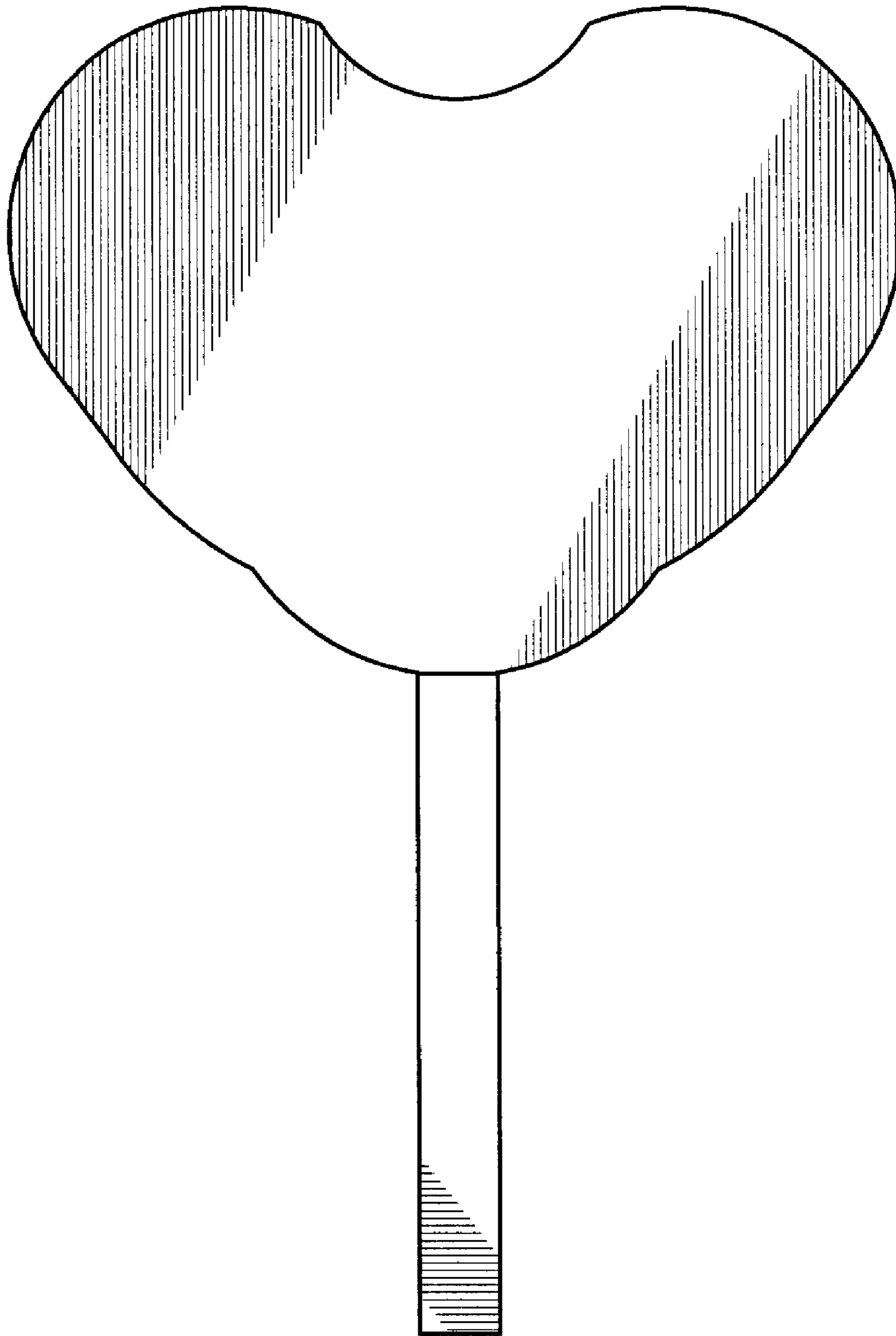

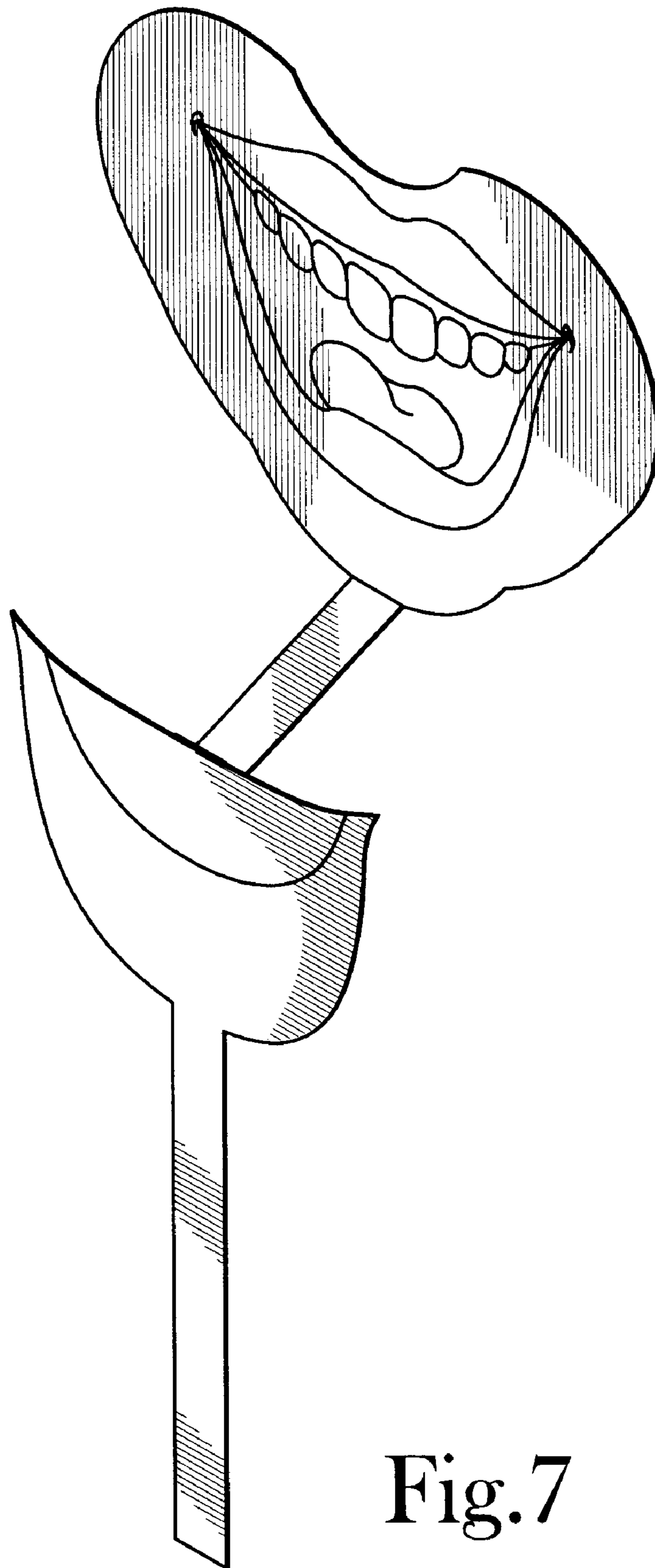

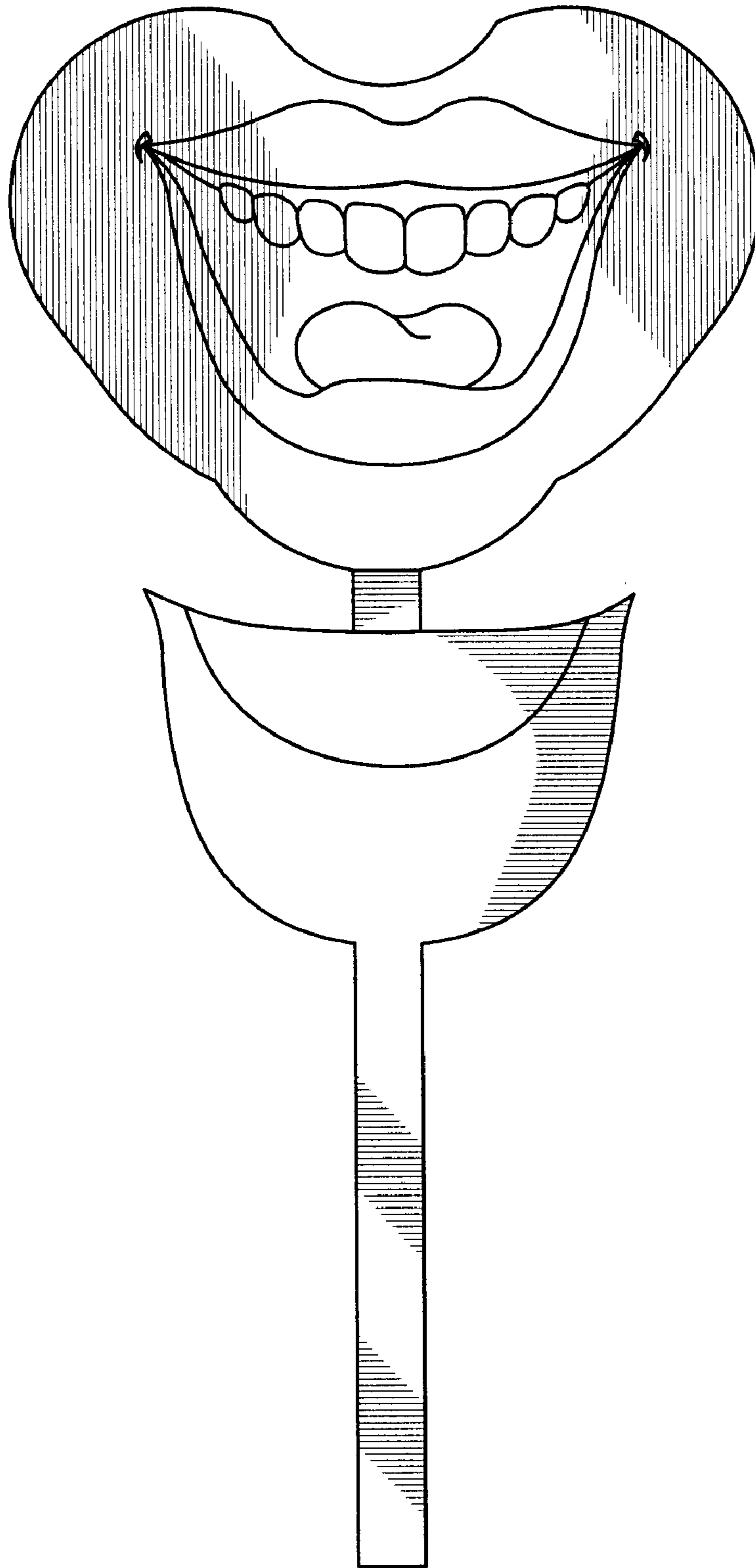

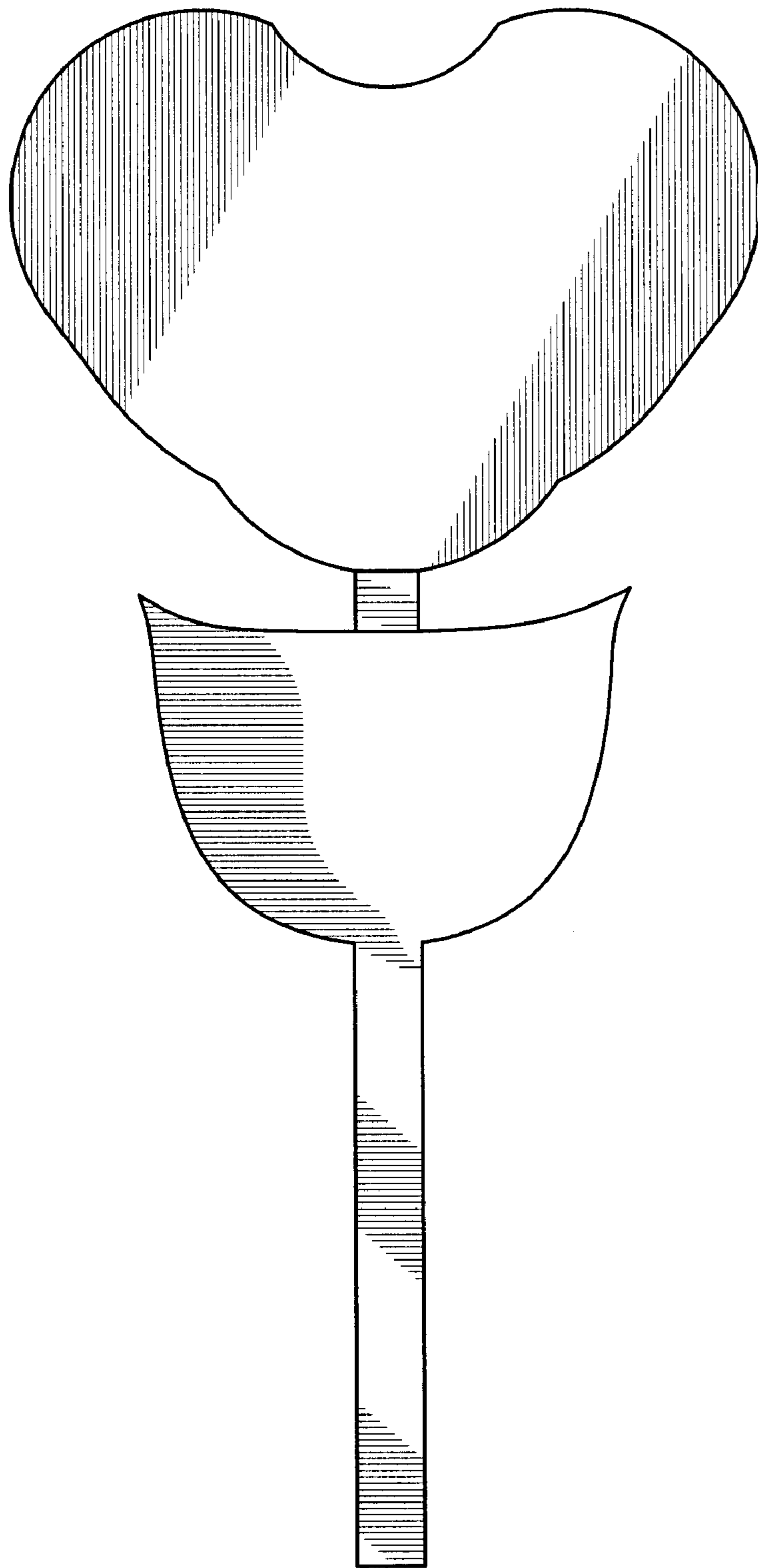

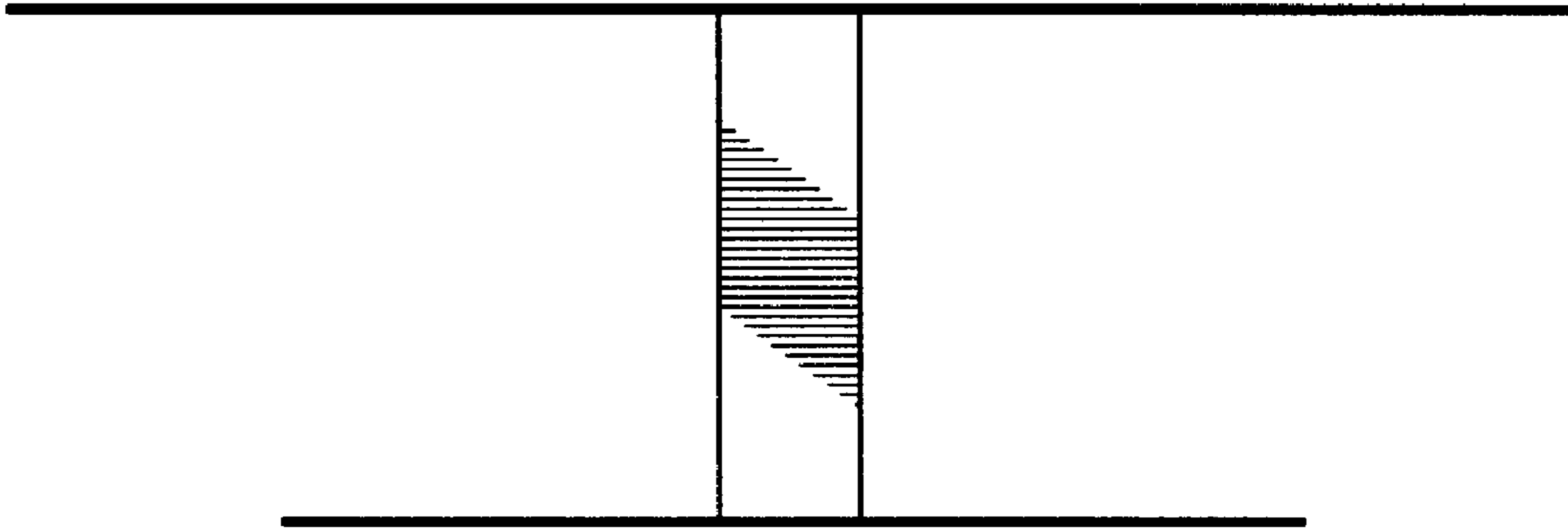

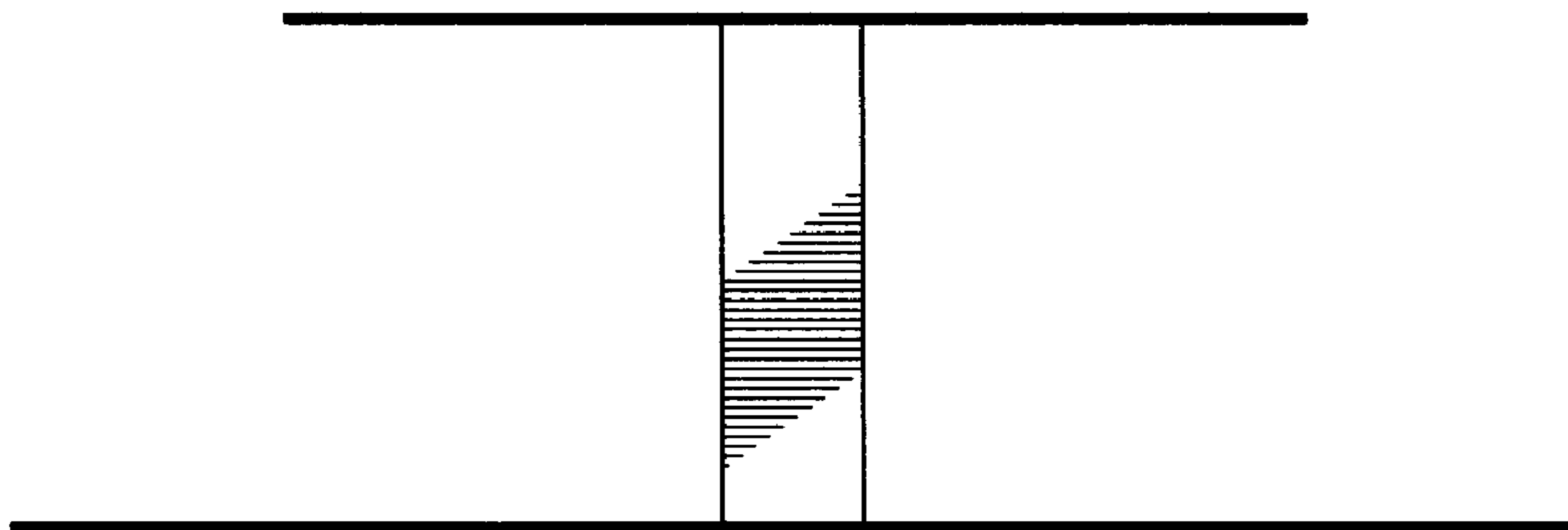
