The ornamental design for a surgical retractor blade, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical retractor blade according to the present invention;
FIG. 2 is a front elevational view of the retractor blade of FIG. 1;
FIG. 3 is a rear elevational view of the retractor blade of FIG. 1;
FIG. 4 is a top plan view of the retractor blade of FIG. 1;
FIG. 5 is a side elevational view of the retractor blade of FIG. 1; and,
FIG. 6 is a bottom plan view of the retractor blade of FIG. 1.
The broken line showing in FIGS. 1 through 6 are for illustrative purposes only and forms no part of the claimed design.

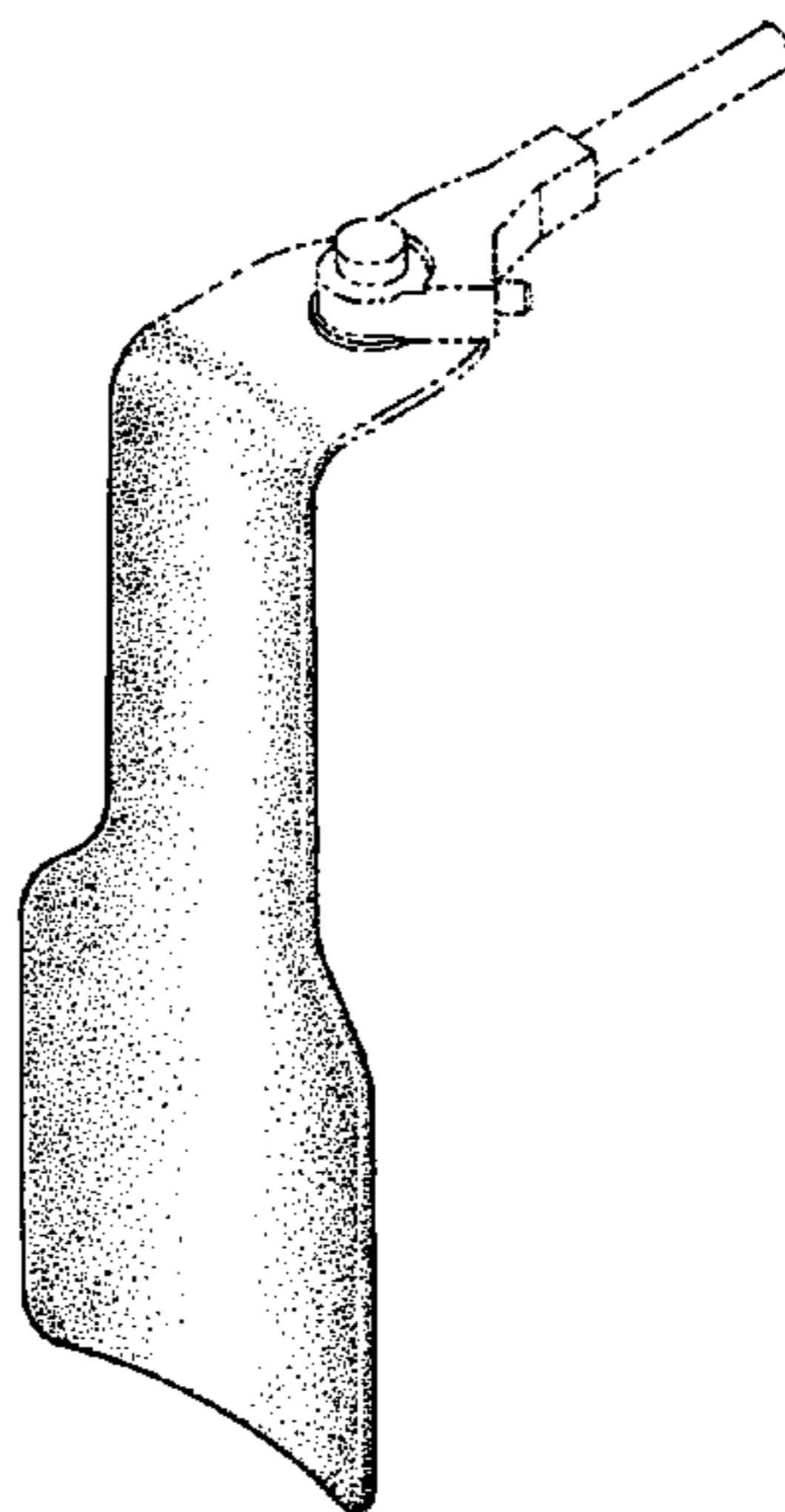

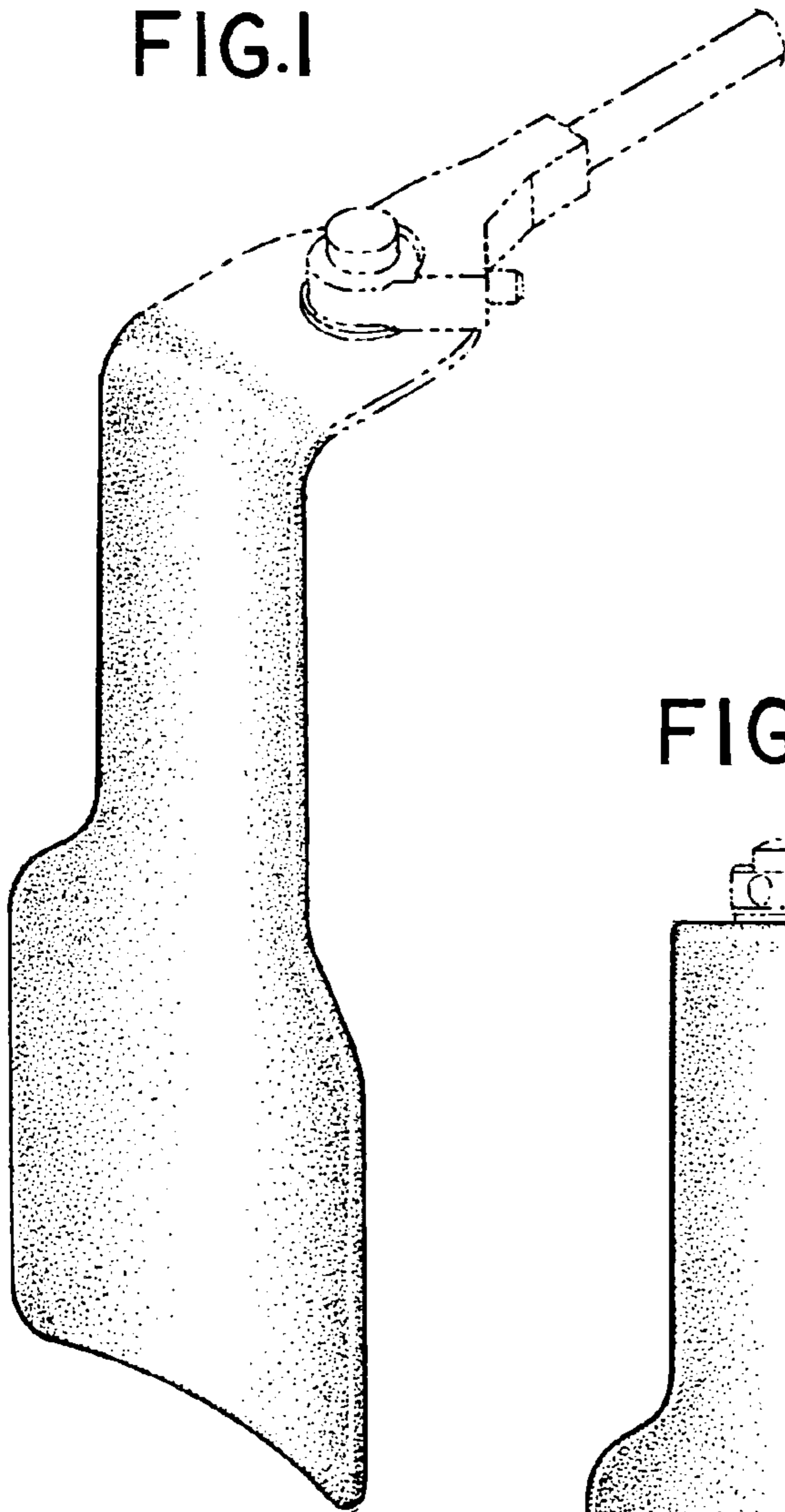

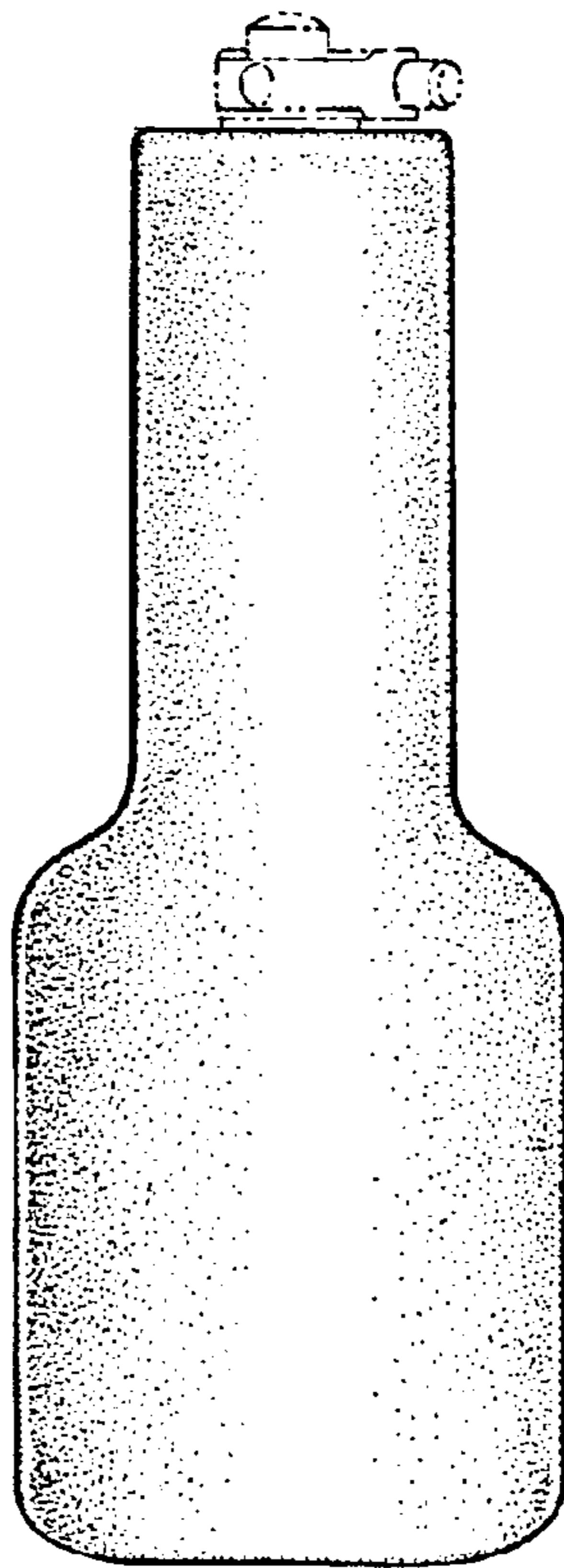

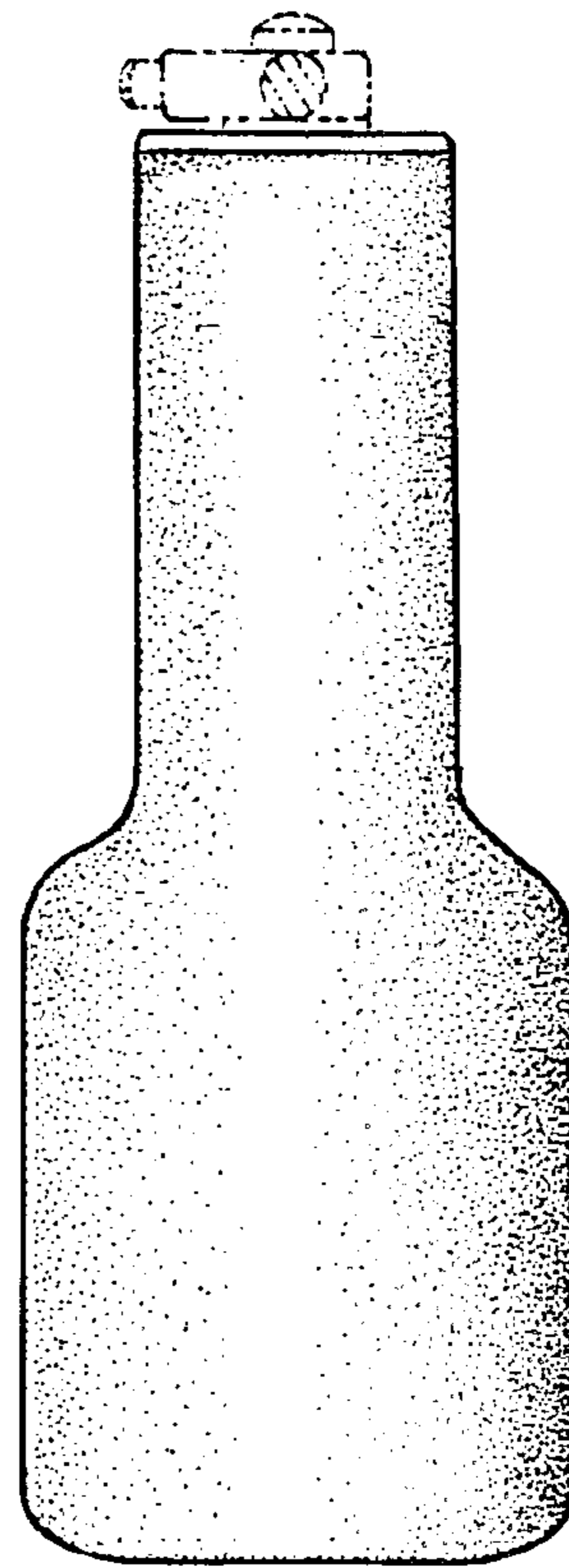

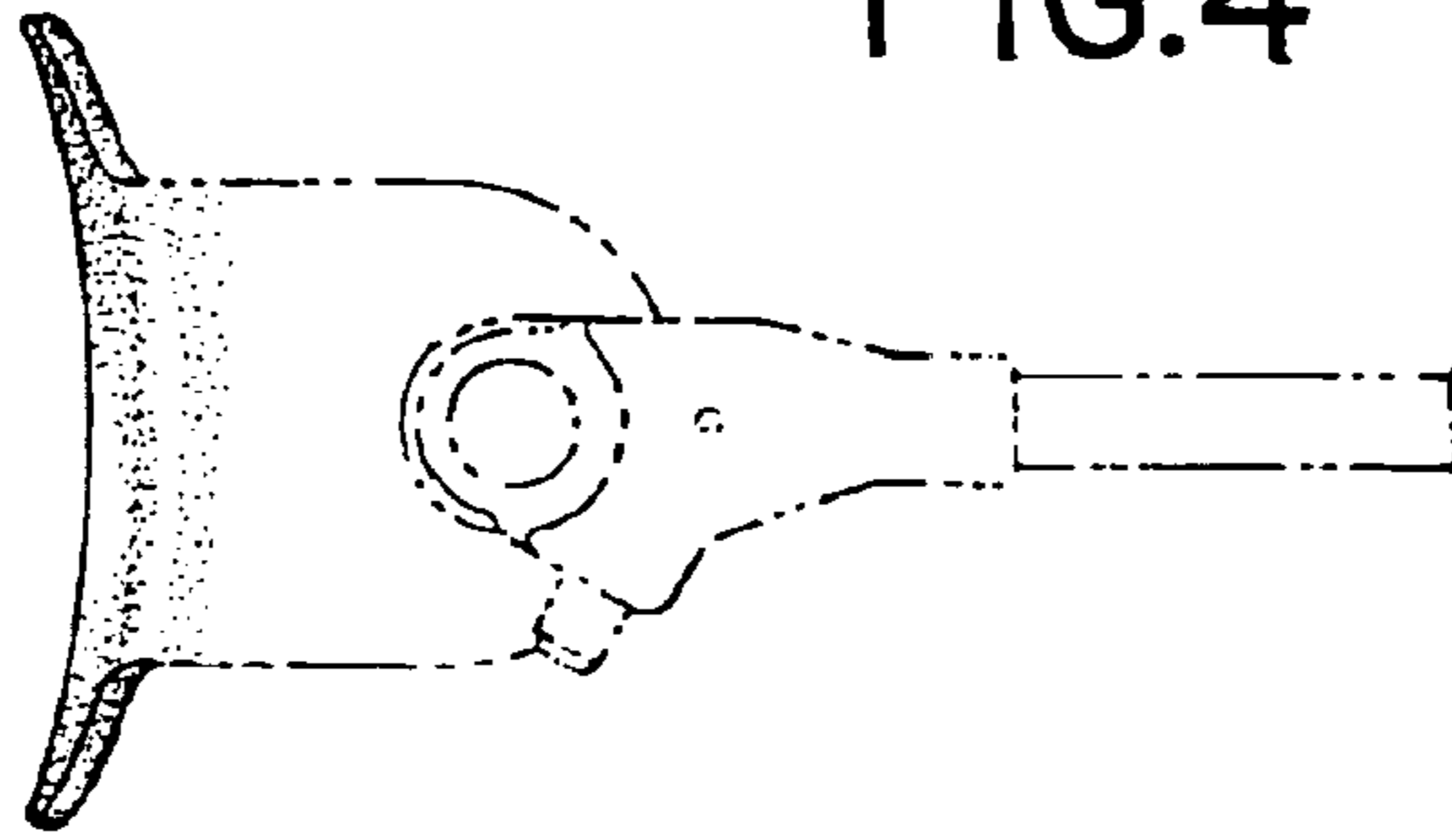

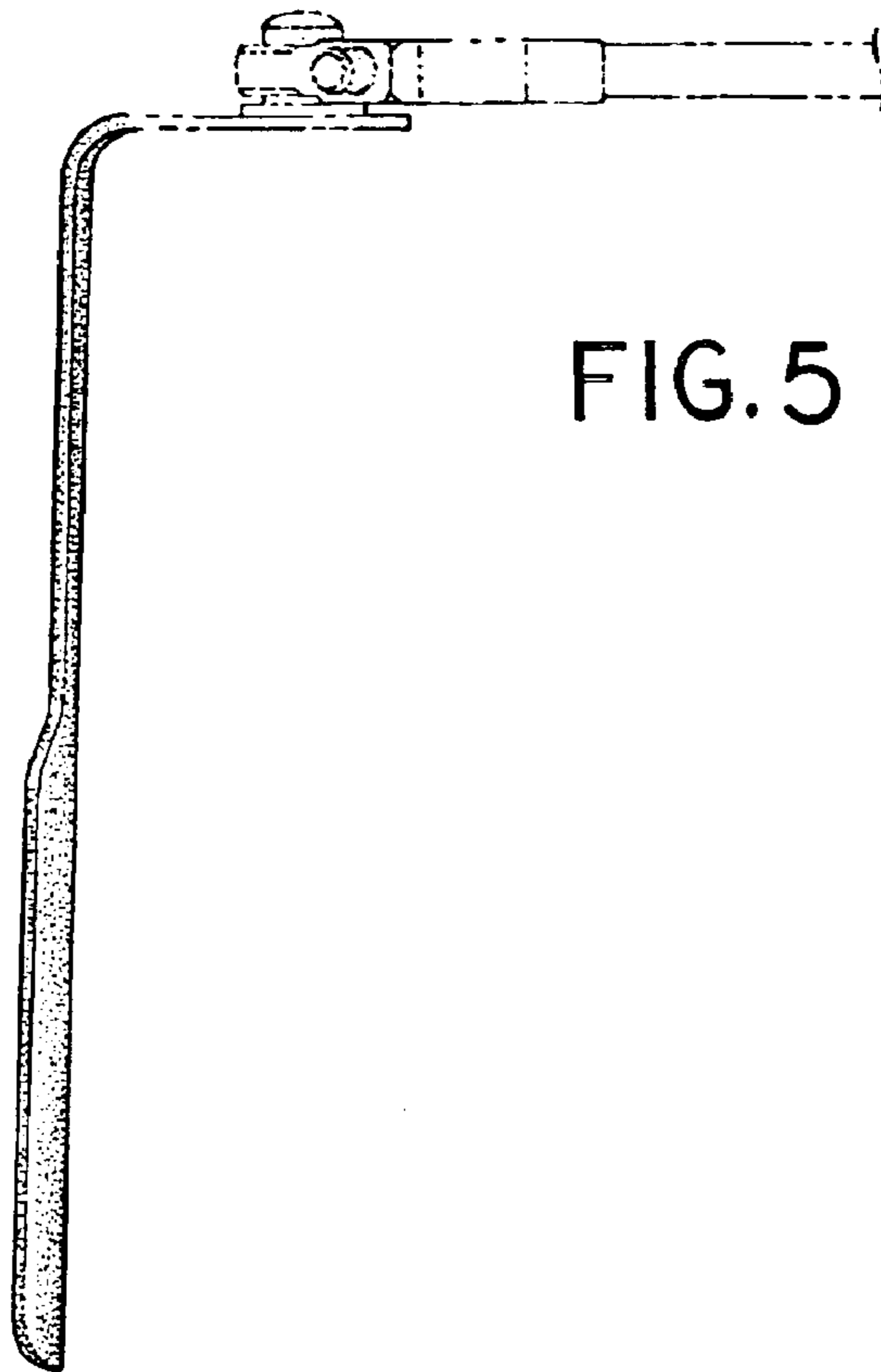
