FIG. 2 is a rear elevation view of the shirt illustrated I FIG. 1;

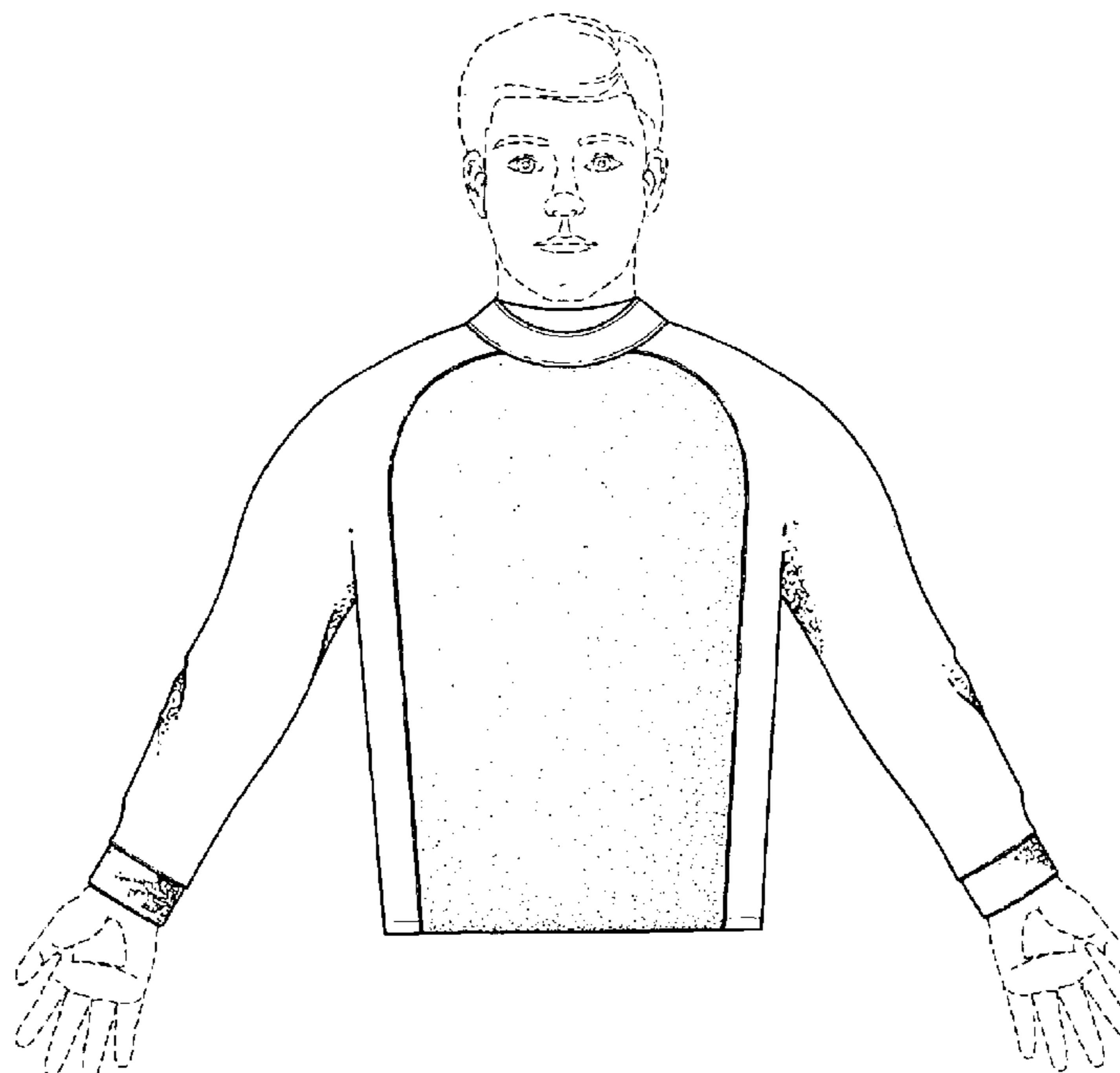
FIG. 3 is a right side elevation view of the shirt illustrated in FIG. 1;

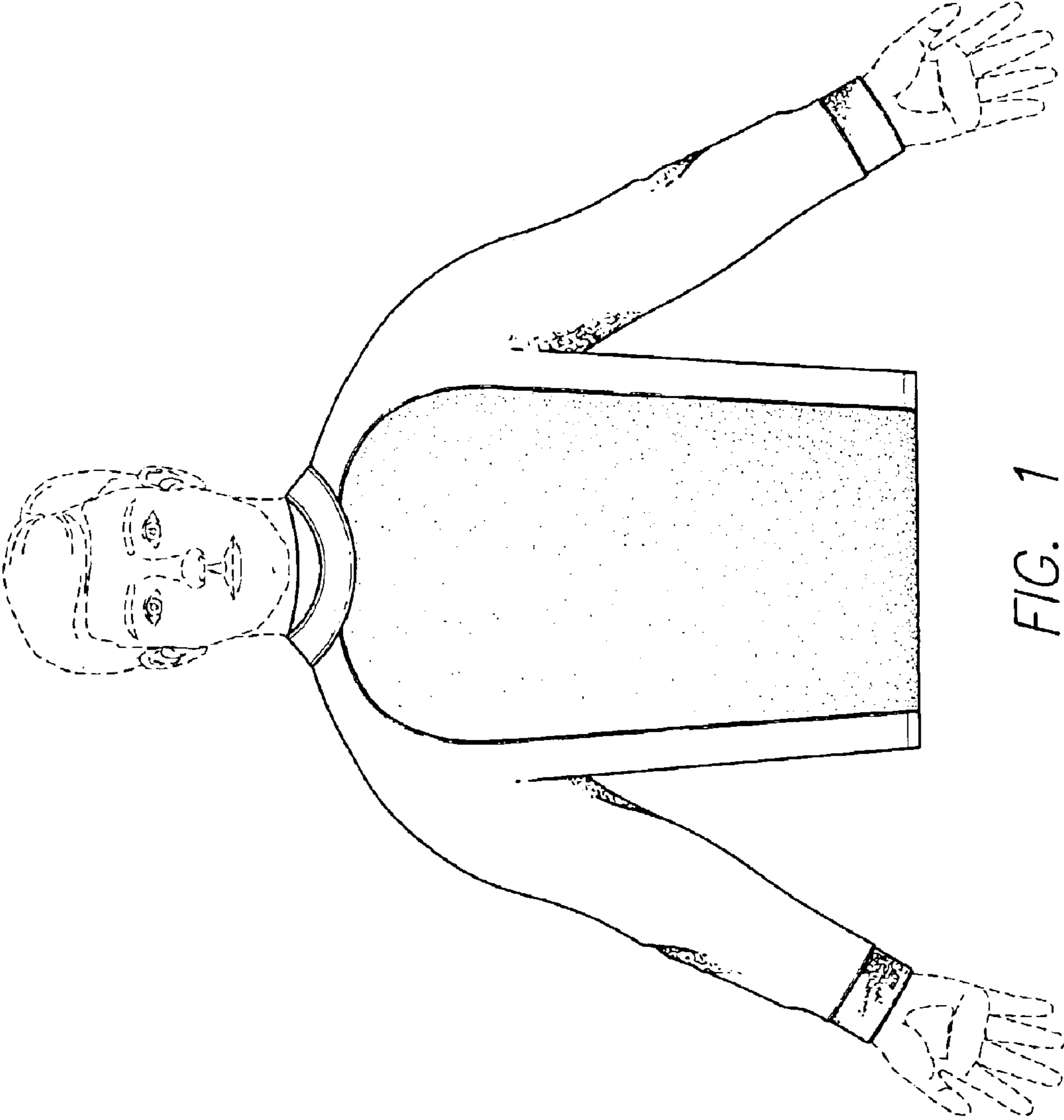

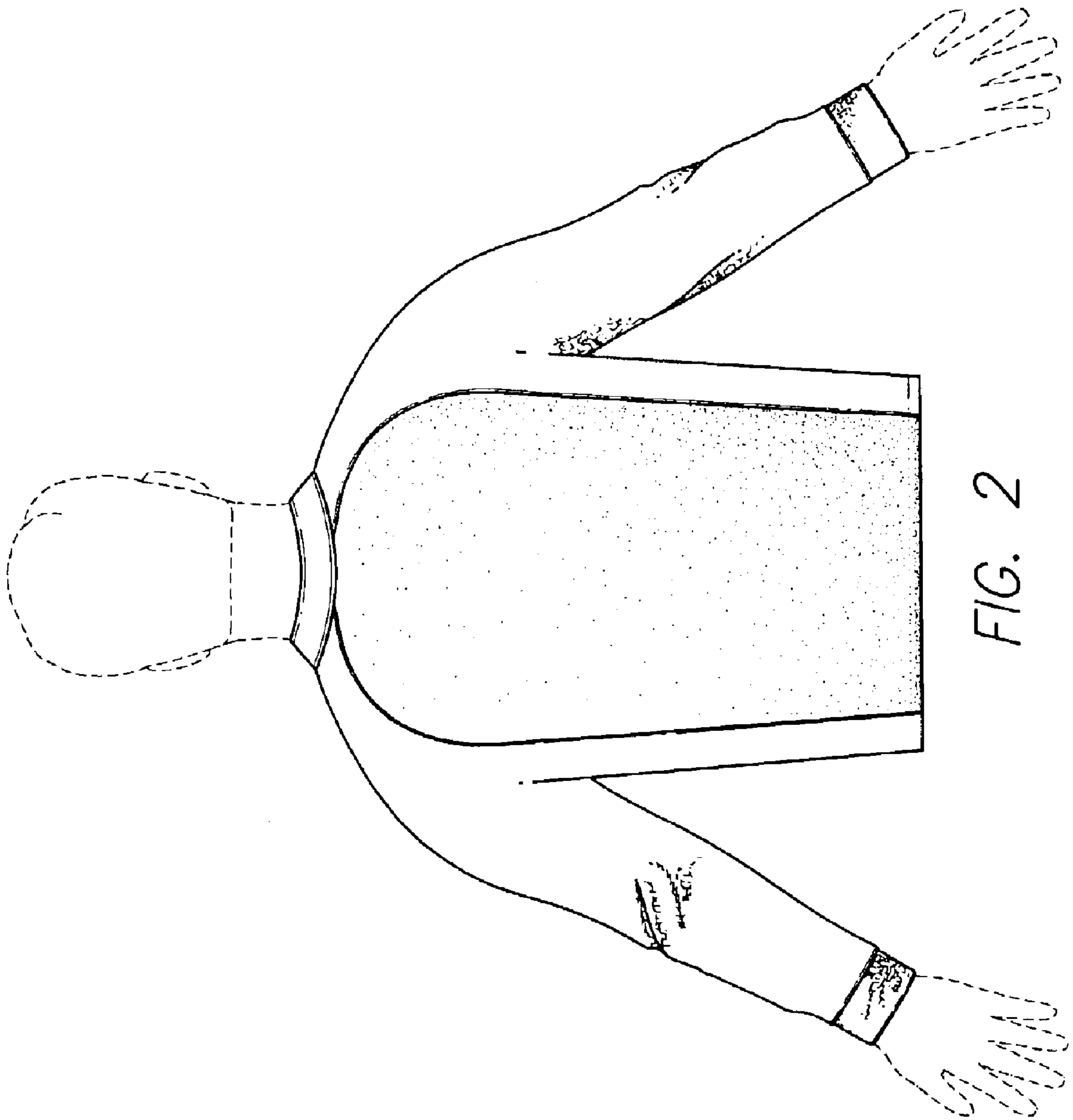

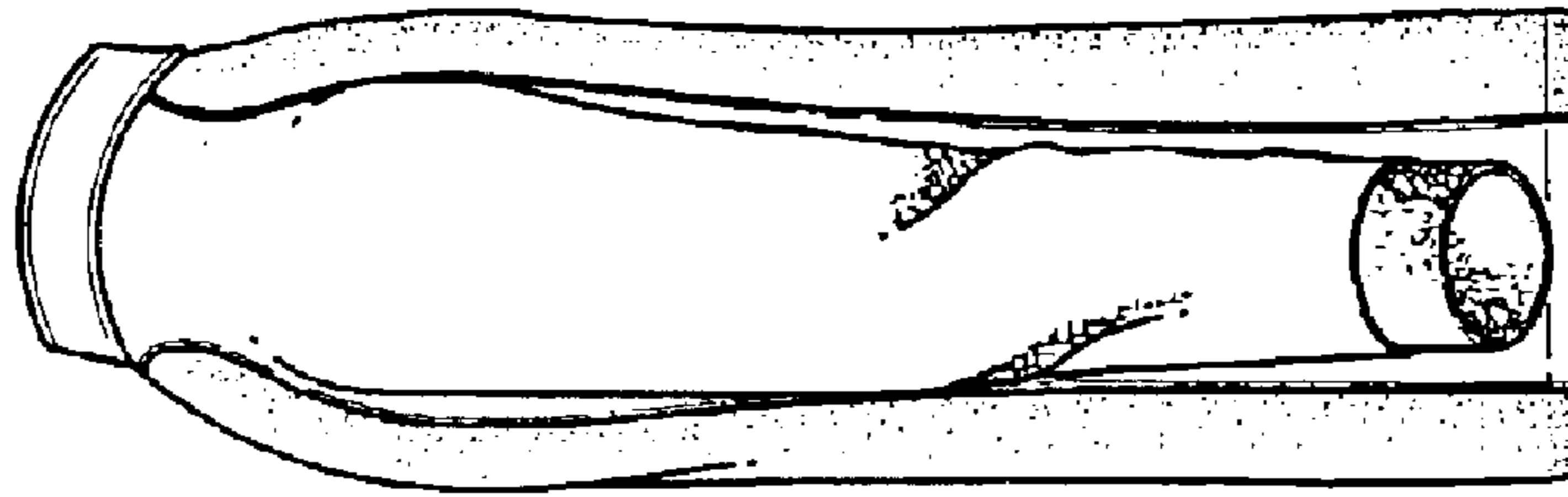

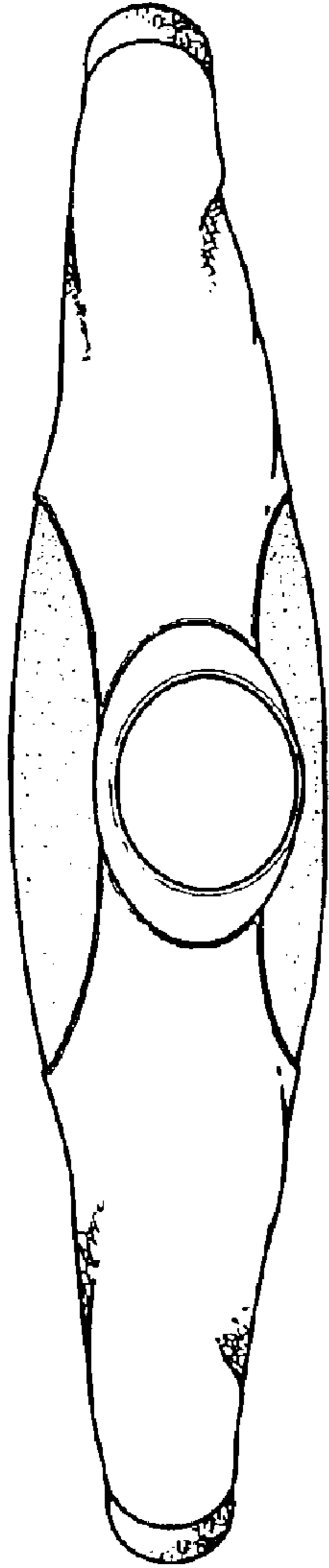

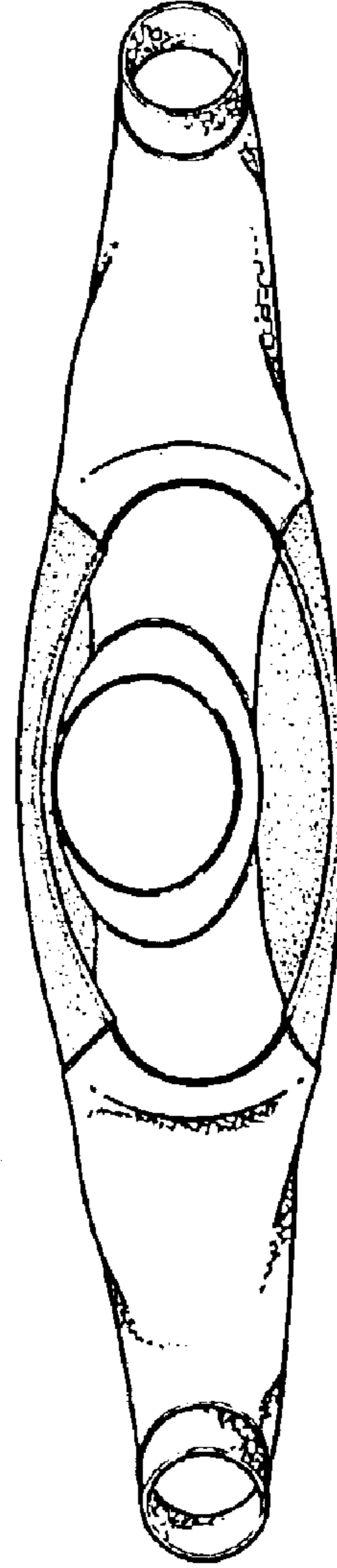
