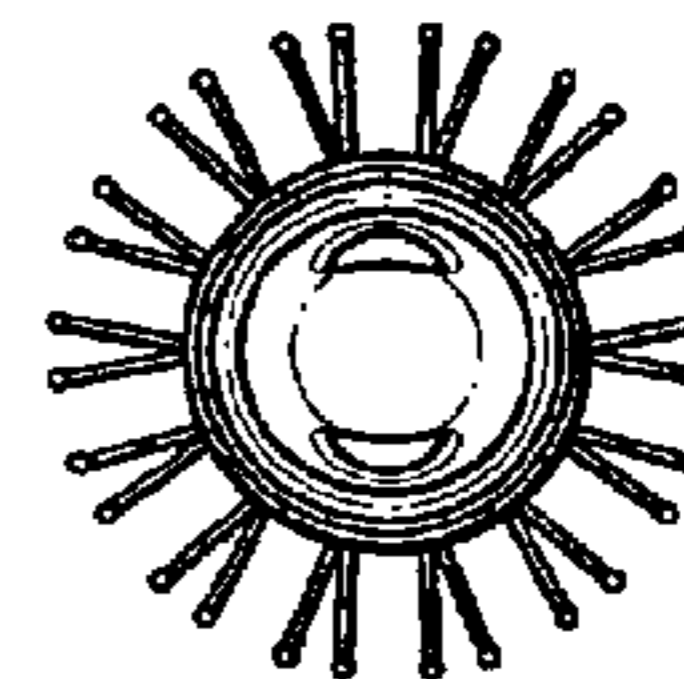
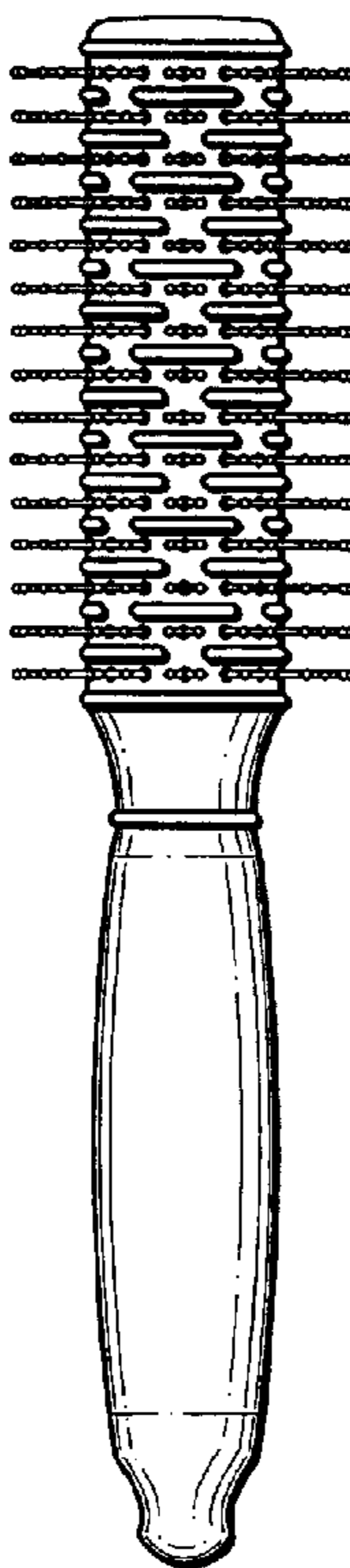
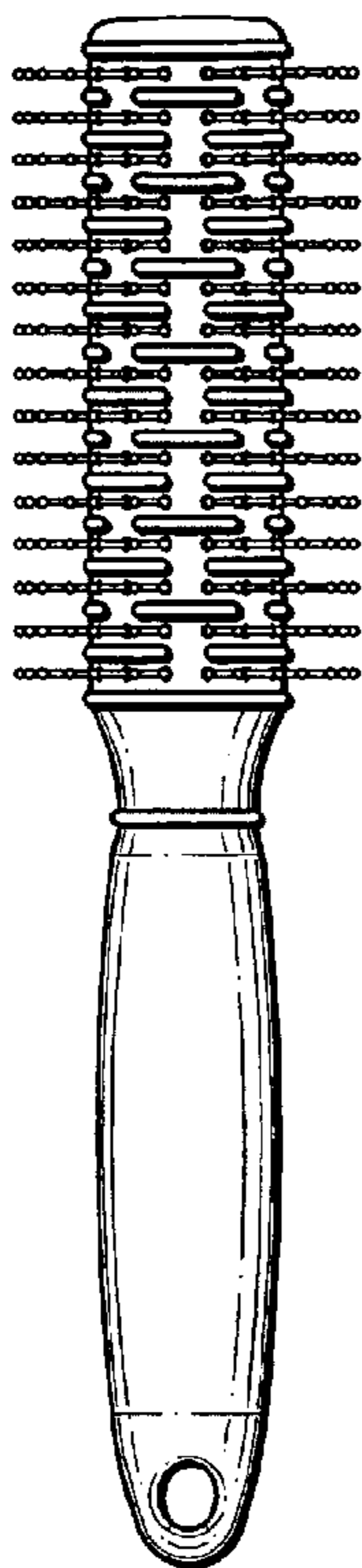
FIG. 1 is a front view of a hair brush showing our new design;

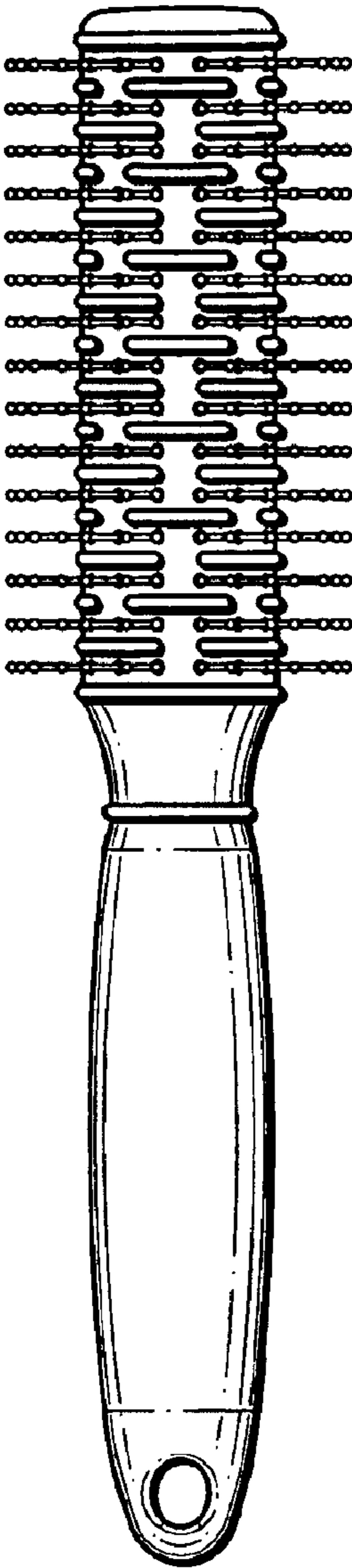

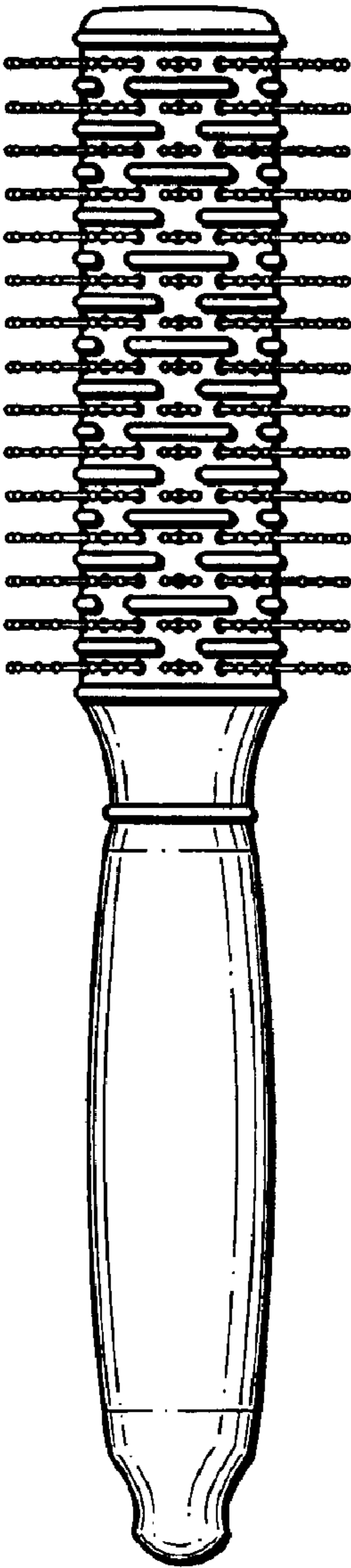

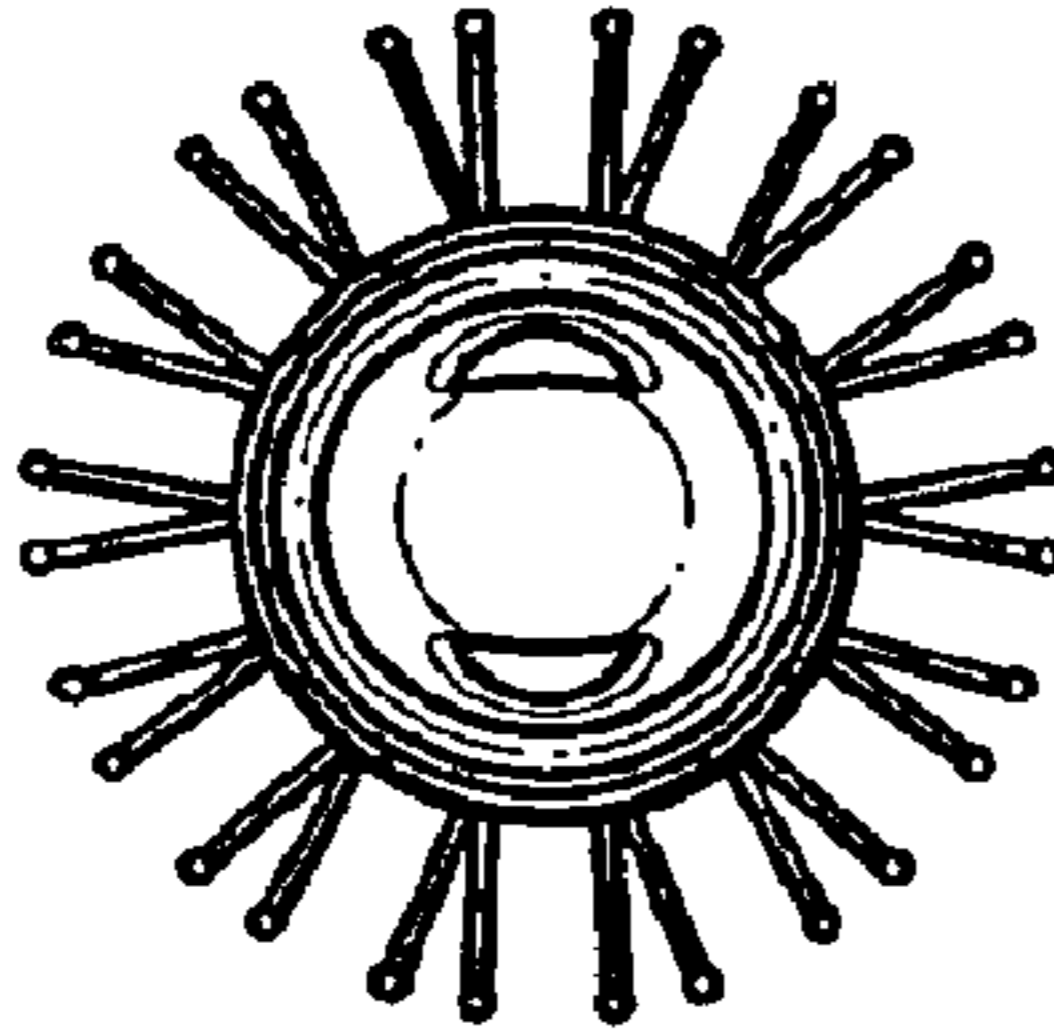

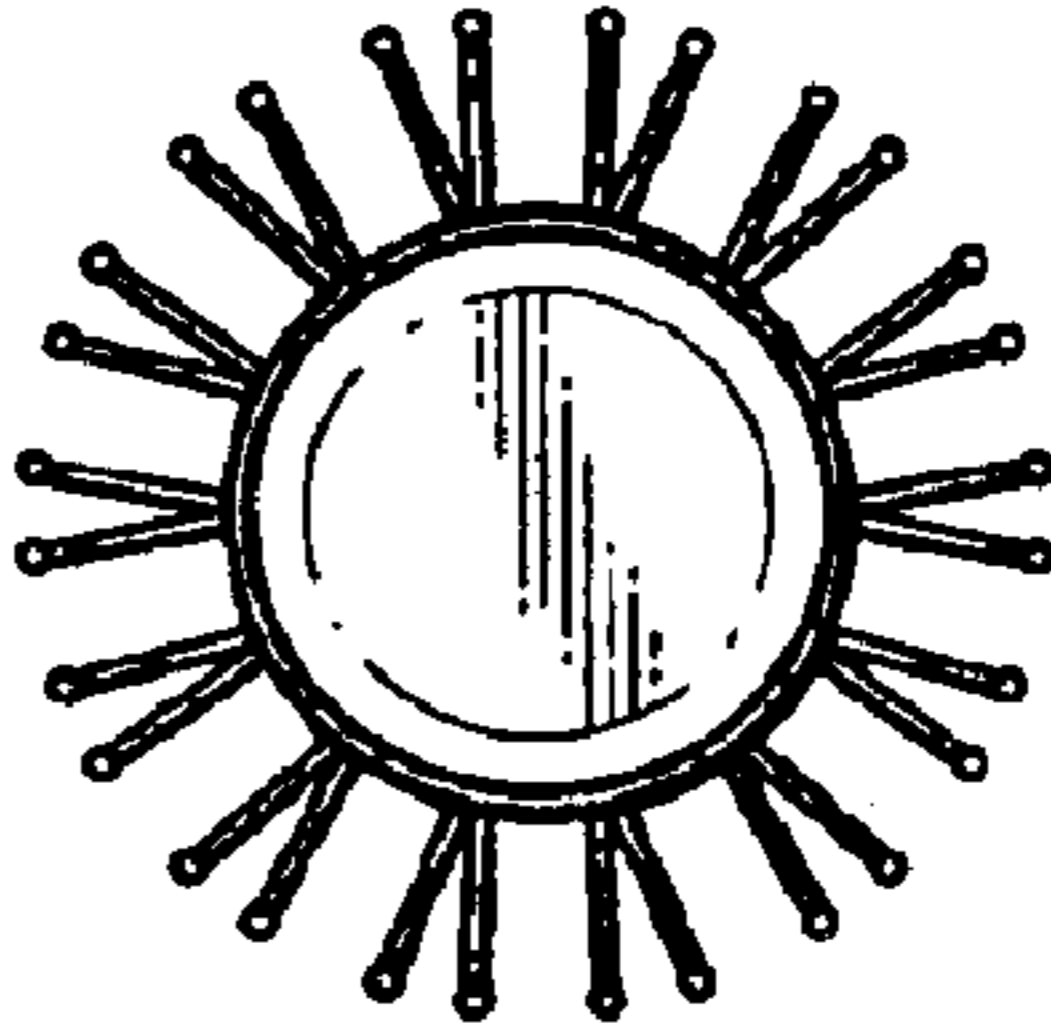
