(57) **CLAIM**

The ornamental design for a “coffee table with adjustable cloth magazine holder”, as shown and described.

**DESCRIPTION**

FIG. 1 is a front Perspective view of “coffee table with adjustable cloth magazine holder”, rear Perspective view is mirror image of front;

FIG. 2 is cross-sectional view taken along lines 2—2 in FIGS. 1 and 7 showing the cloth magazine holder in an alternate position;

FIG. 3 is a cross-sectional view taken along lines 2—2 in FIGS. 1 and 7 showing the cloth magazine holder in a second alternate position; and

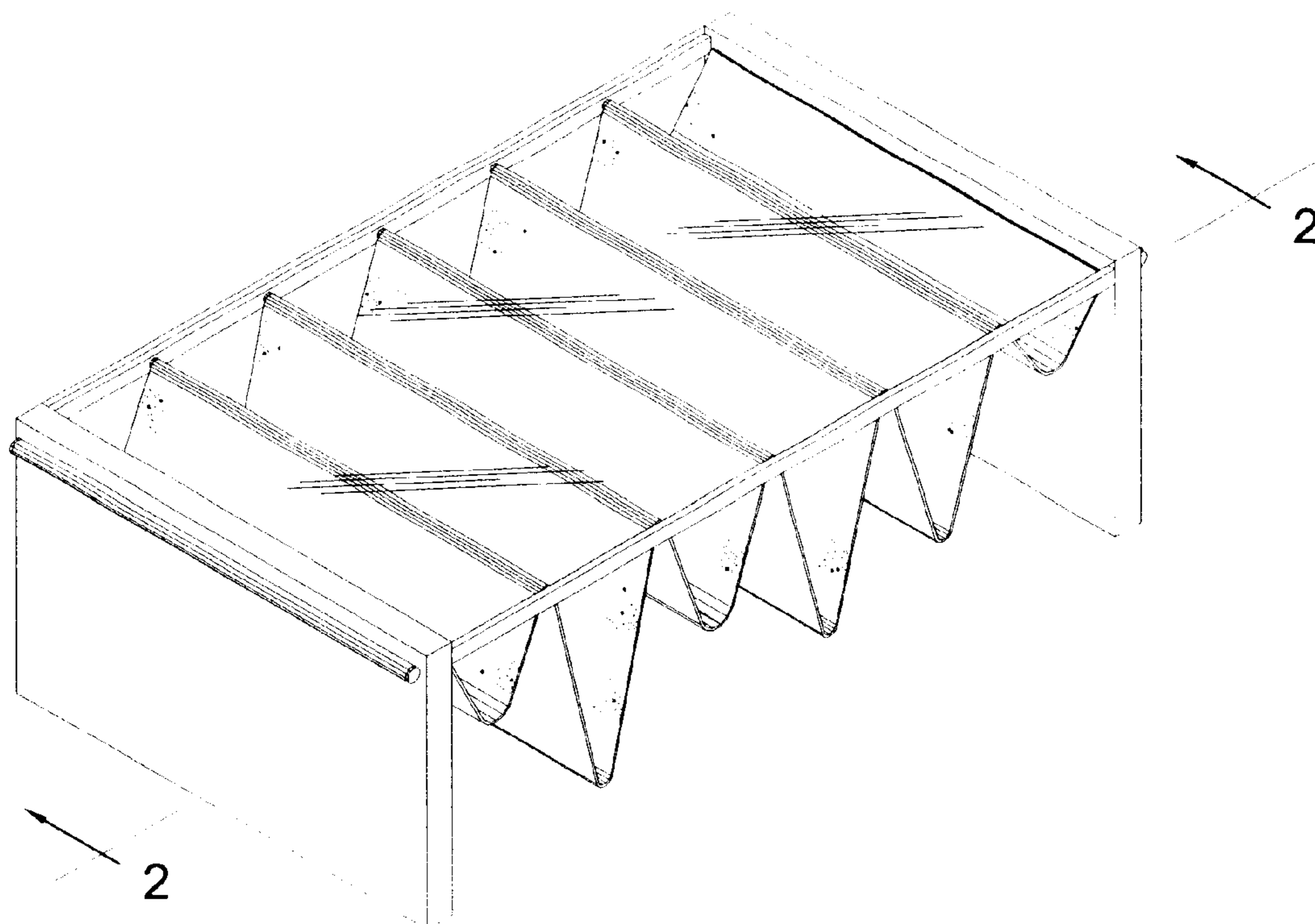
FIG. 4 is a cross-sectional view taken along lines 2—2 in FIGS. 1 and 7 showing the cloth magazine holder in a third alternate position;

FIG. 5 is a front Elevational view of the coffee table, rear Elevational view is a mirror image of front;

FIG. 6 is a right side Elevational view of the coffee table, left side Elevational view is mirror image of right side Elevational view; and,

FIG. 7 is a top Plan view of coffee table.

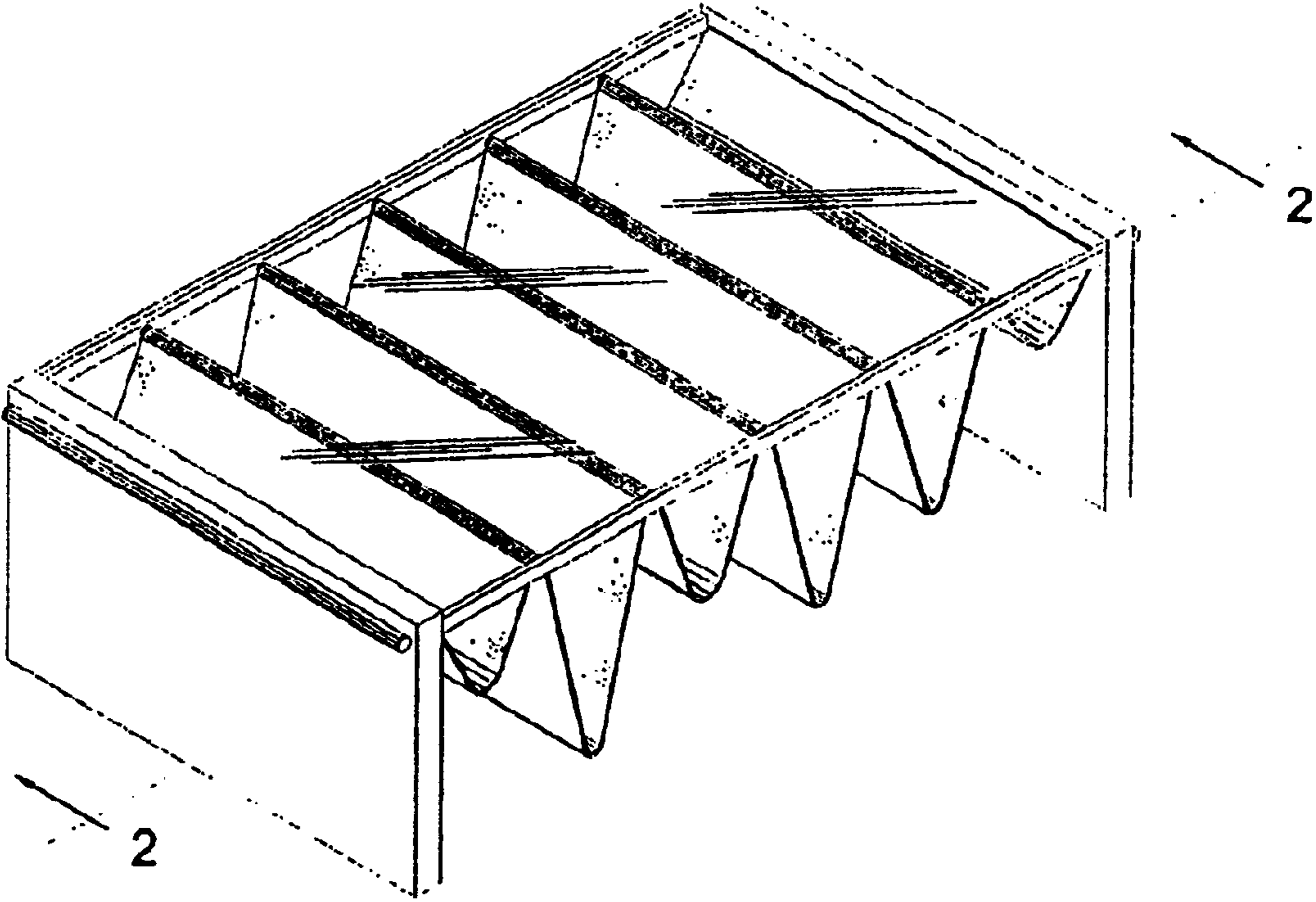

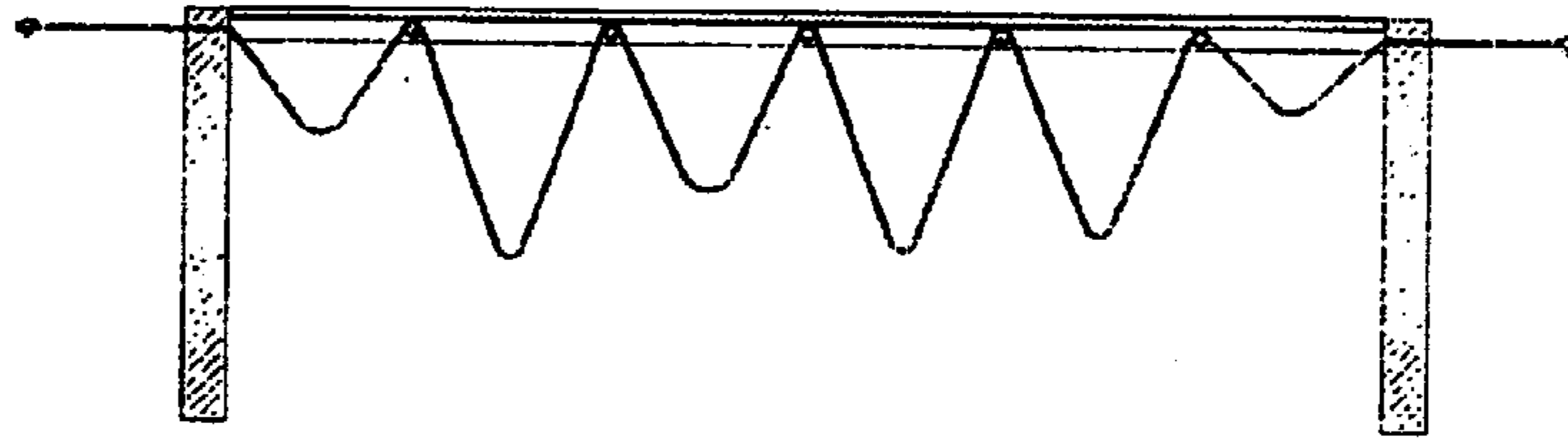

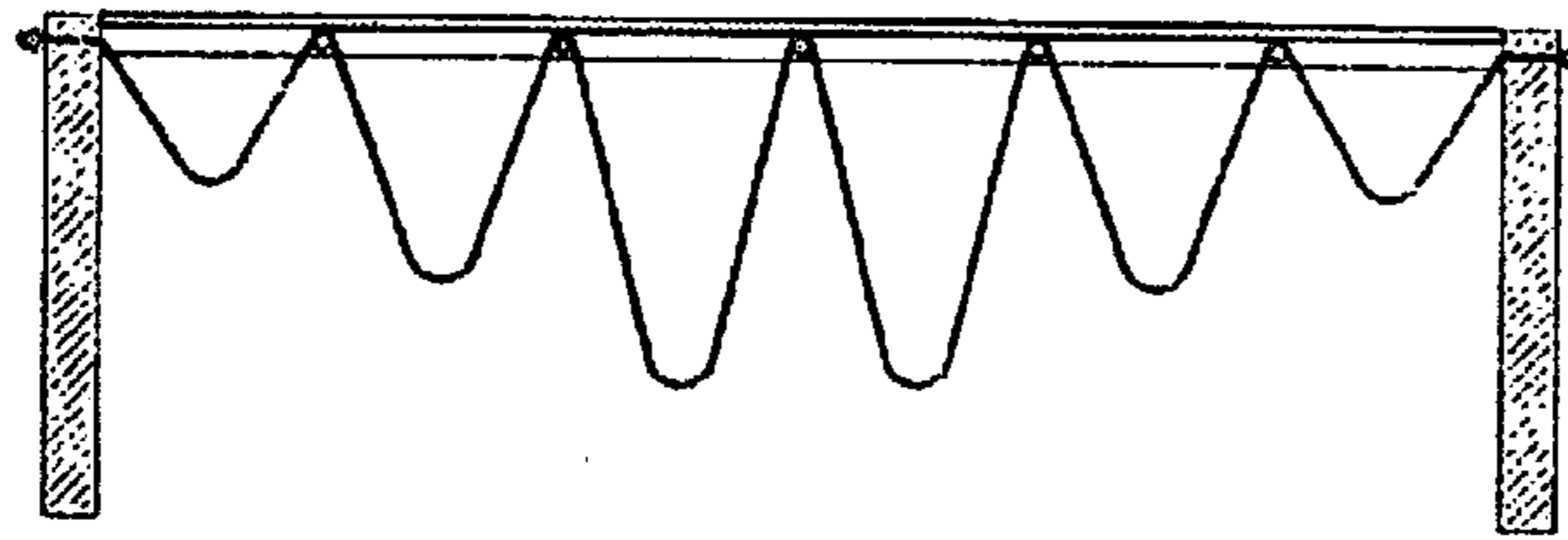

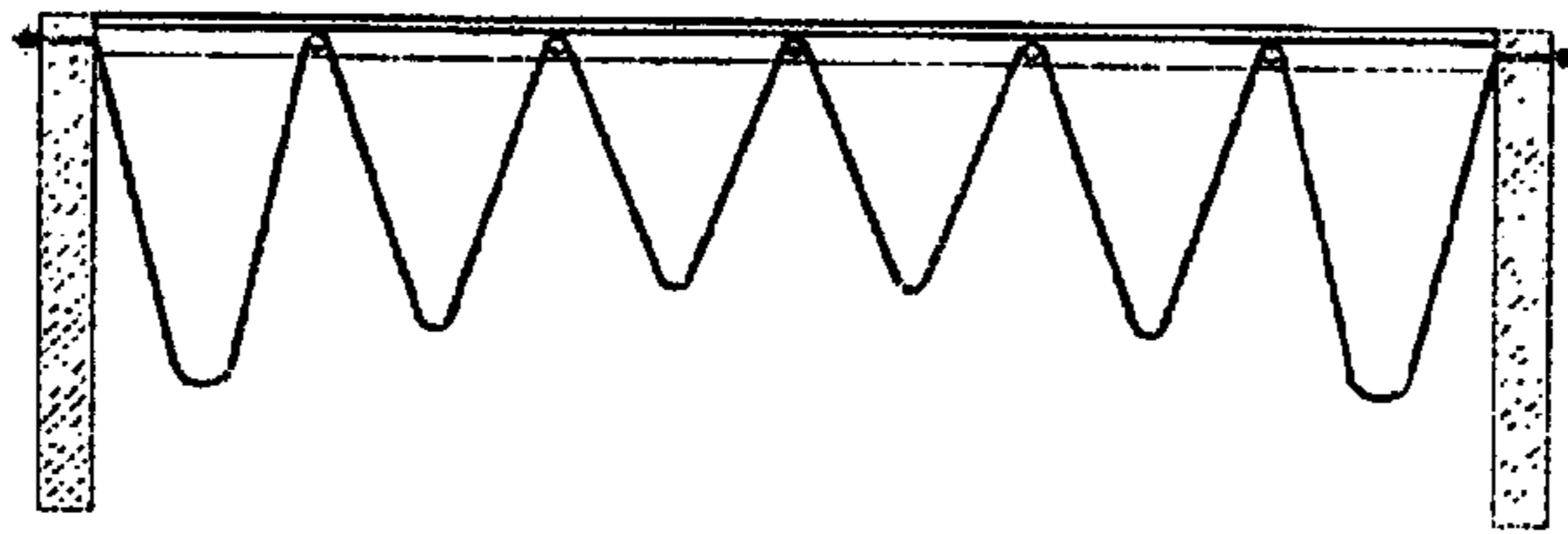

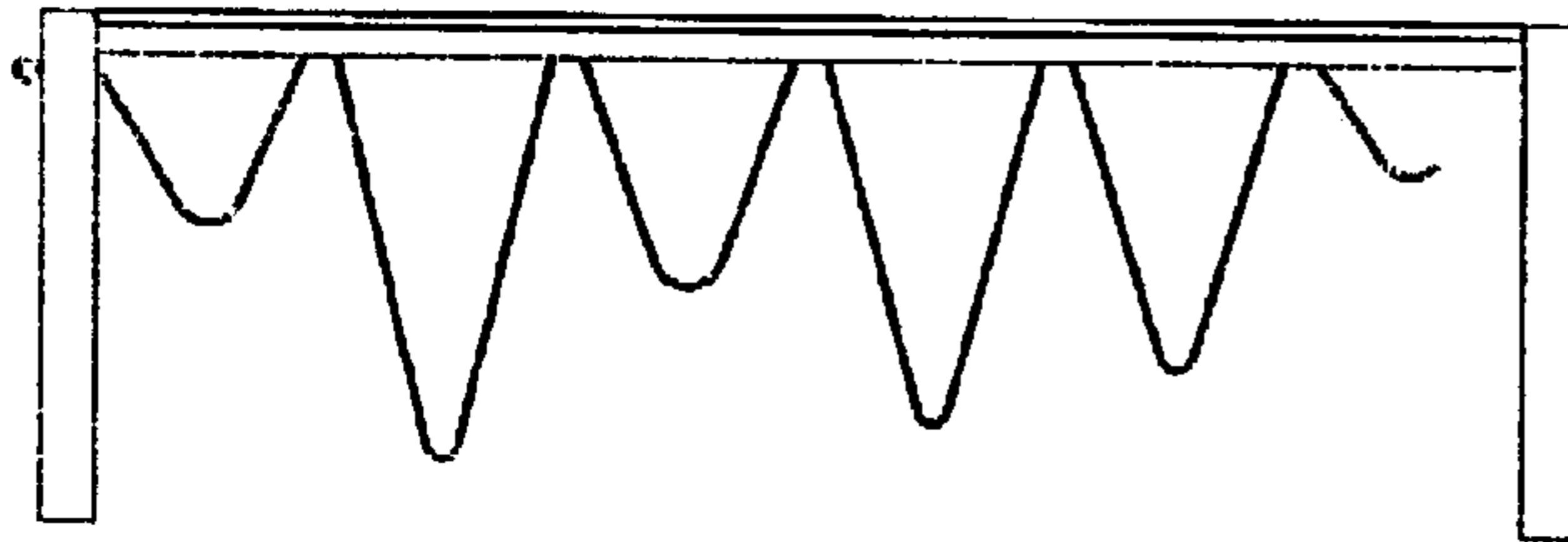

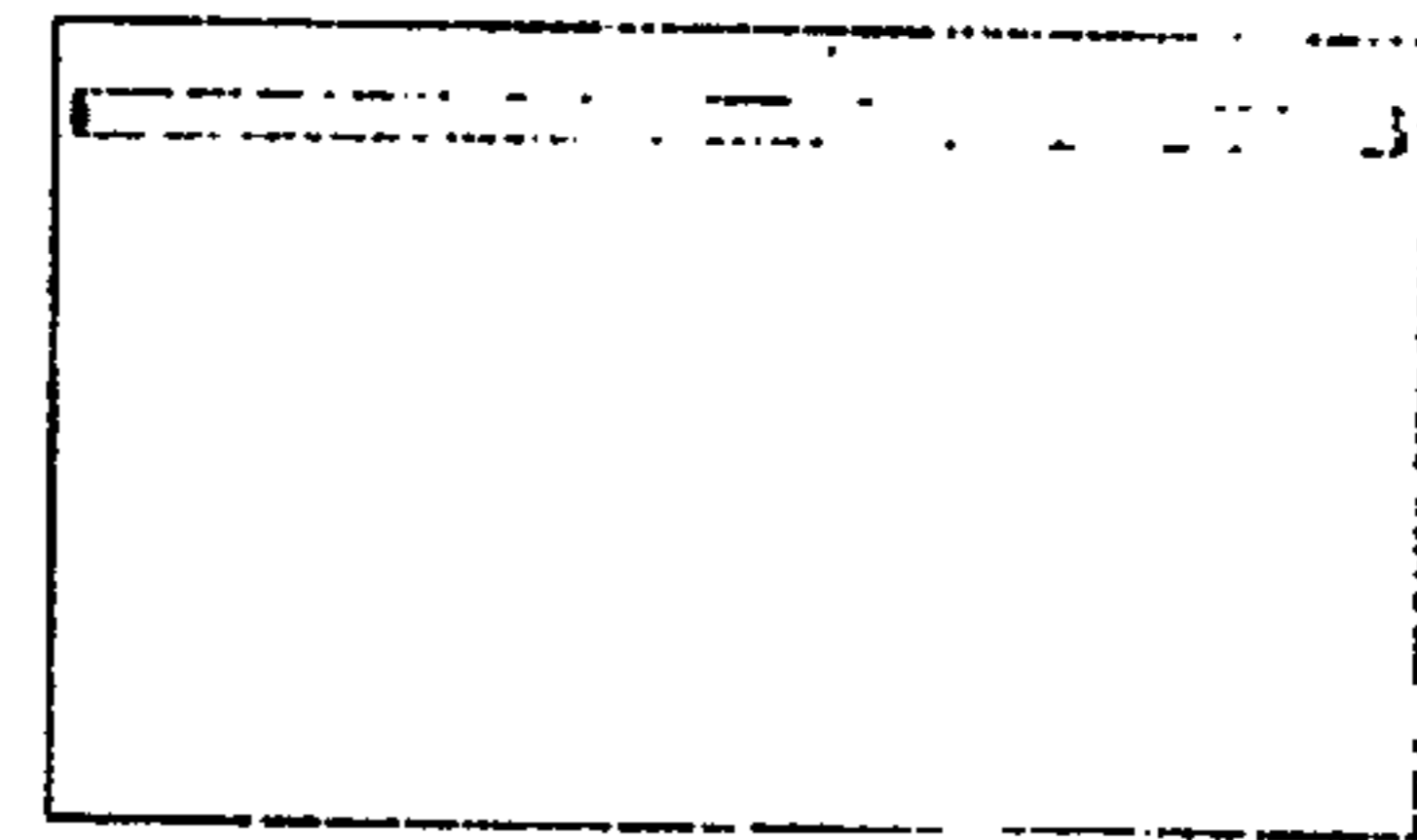

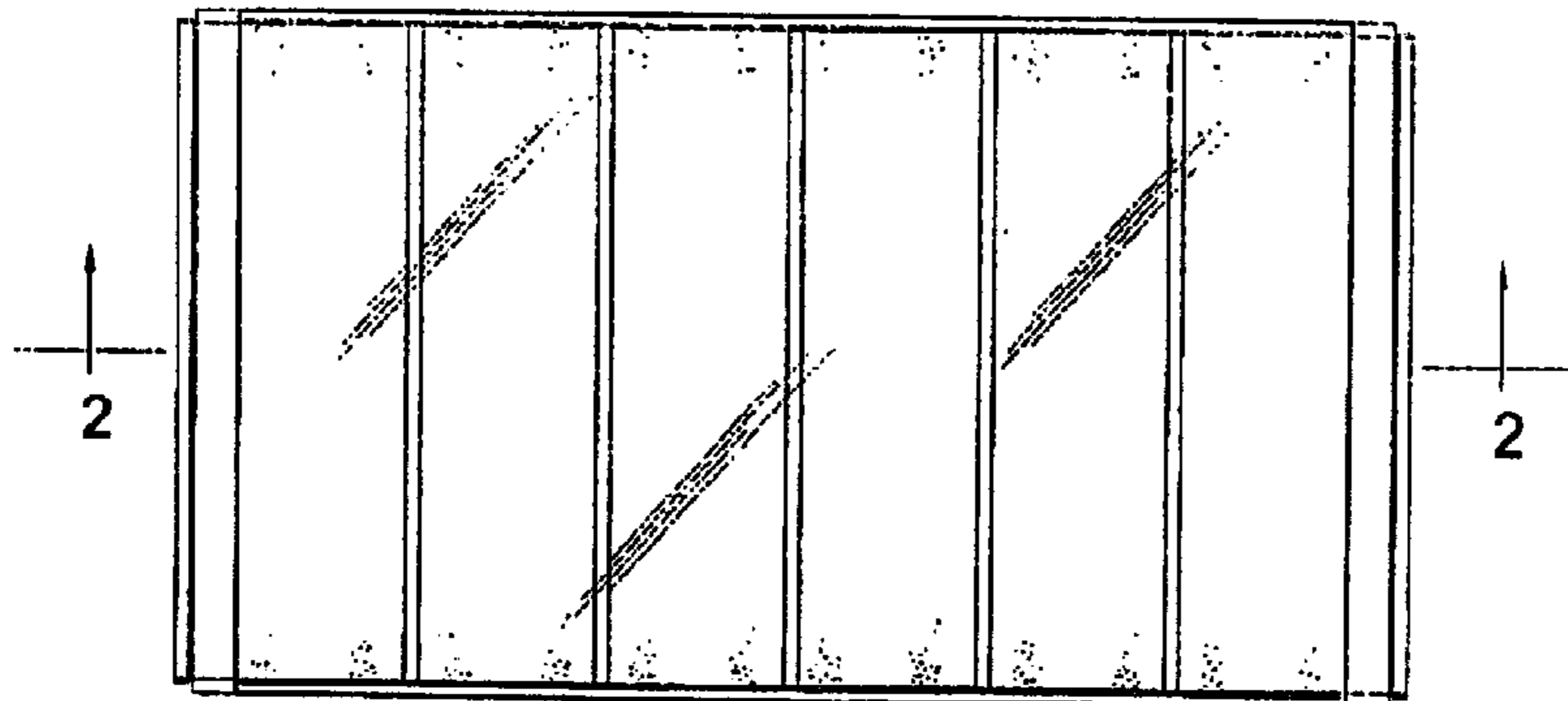
