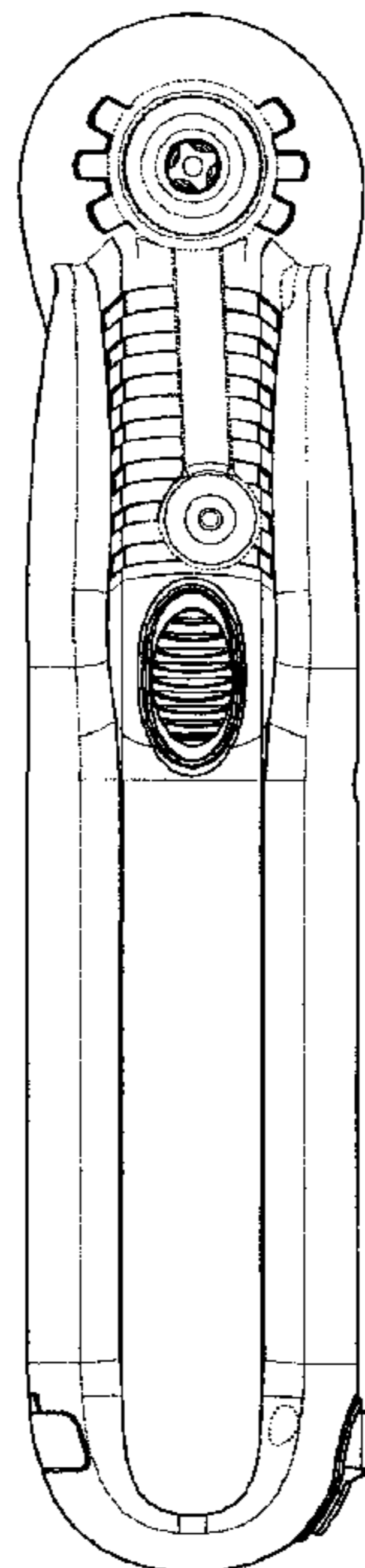
(57) **CLAIM**

The ornamental design for a portable air compressor, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the portable air compressor of this invention
 FIG. 2 is a rear elevational view of the portable air compressor of this invention
 FIG. 3 is a left side elevational view of the portable air compressor of this invention
 FIG. 4 is a right side elevational view of the portable air compressor of this invention
 FIG. 5 is a top elevational view of the portable air compressor of this invention
 FIG. 6 is a bottom elevational view of the portable air compressor of this invention
 FIG. 7 is a rear-left perspective view of the portable air compressor of this invention; and,
 FIG. 8 is a front-right perspective view of the portable air compressor of this invention.

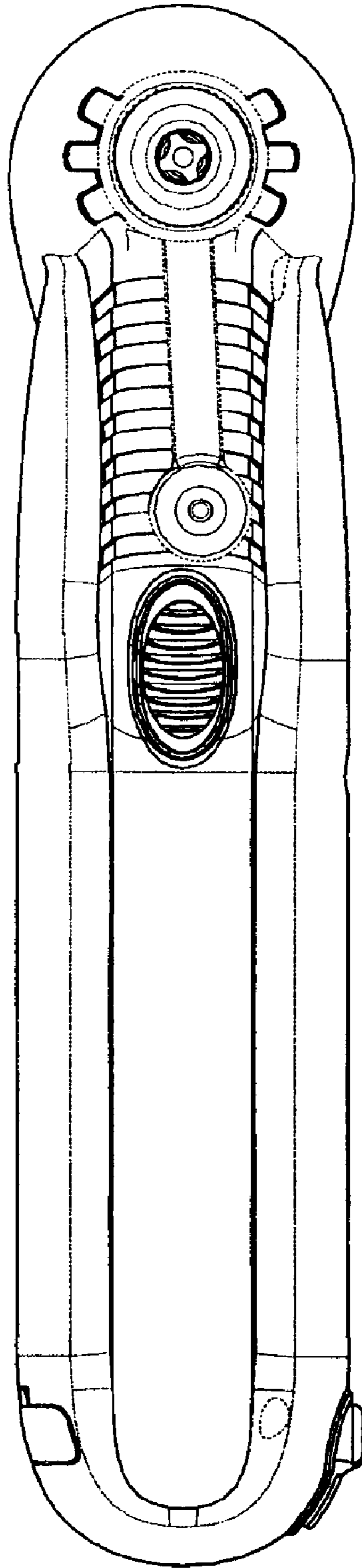

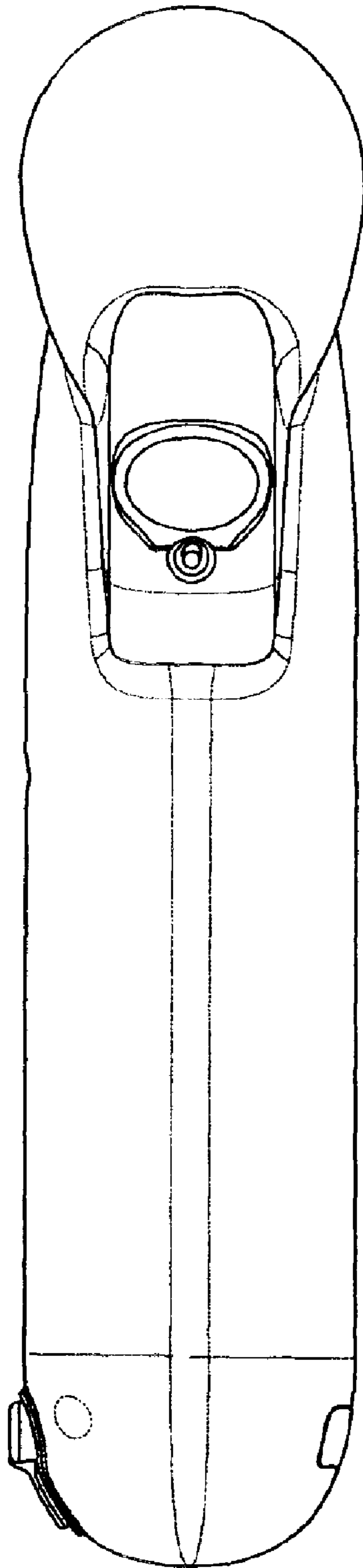

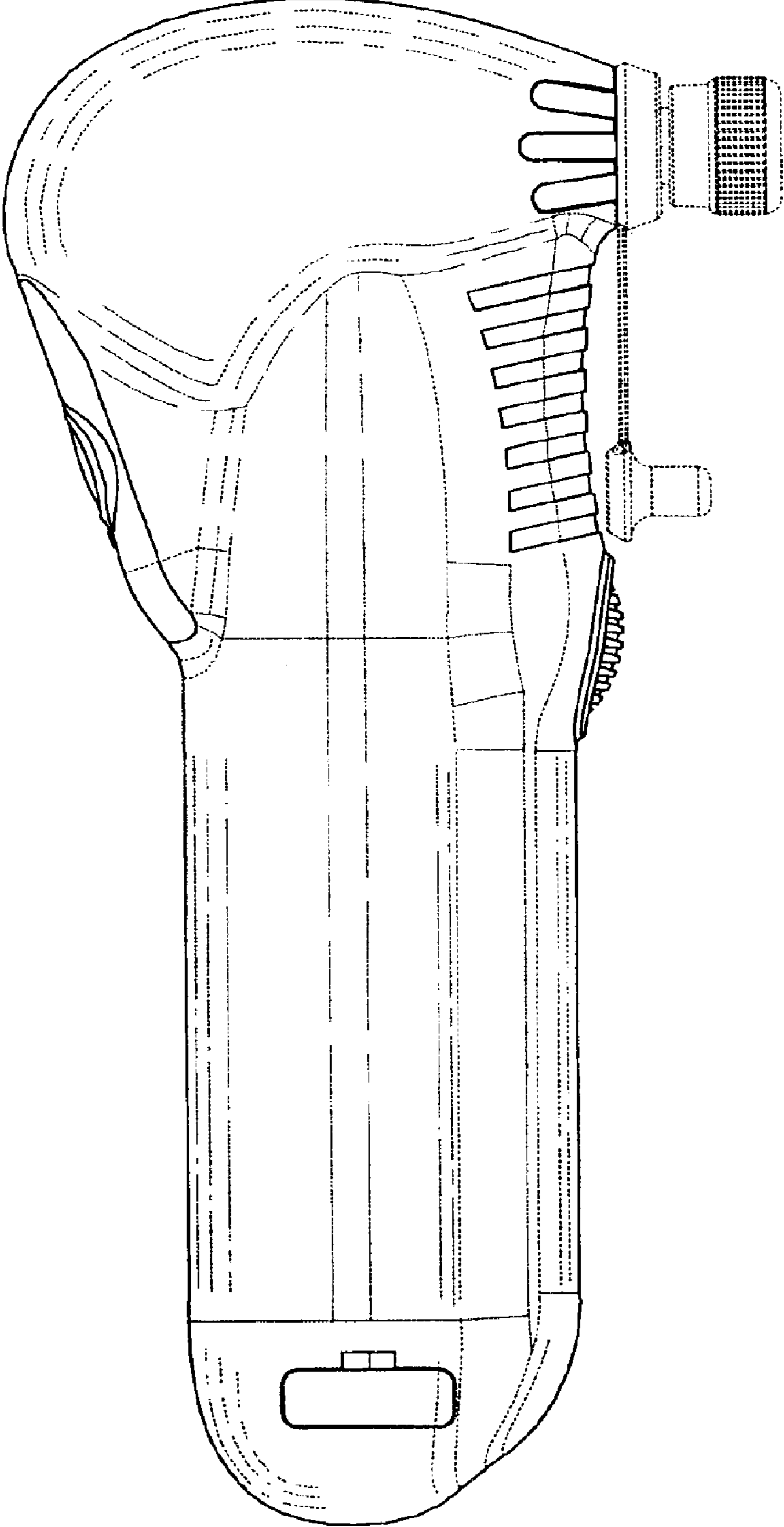

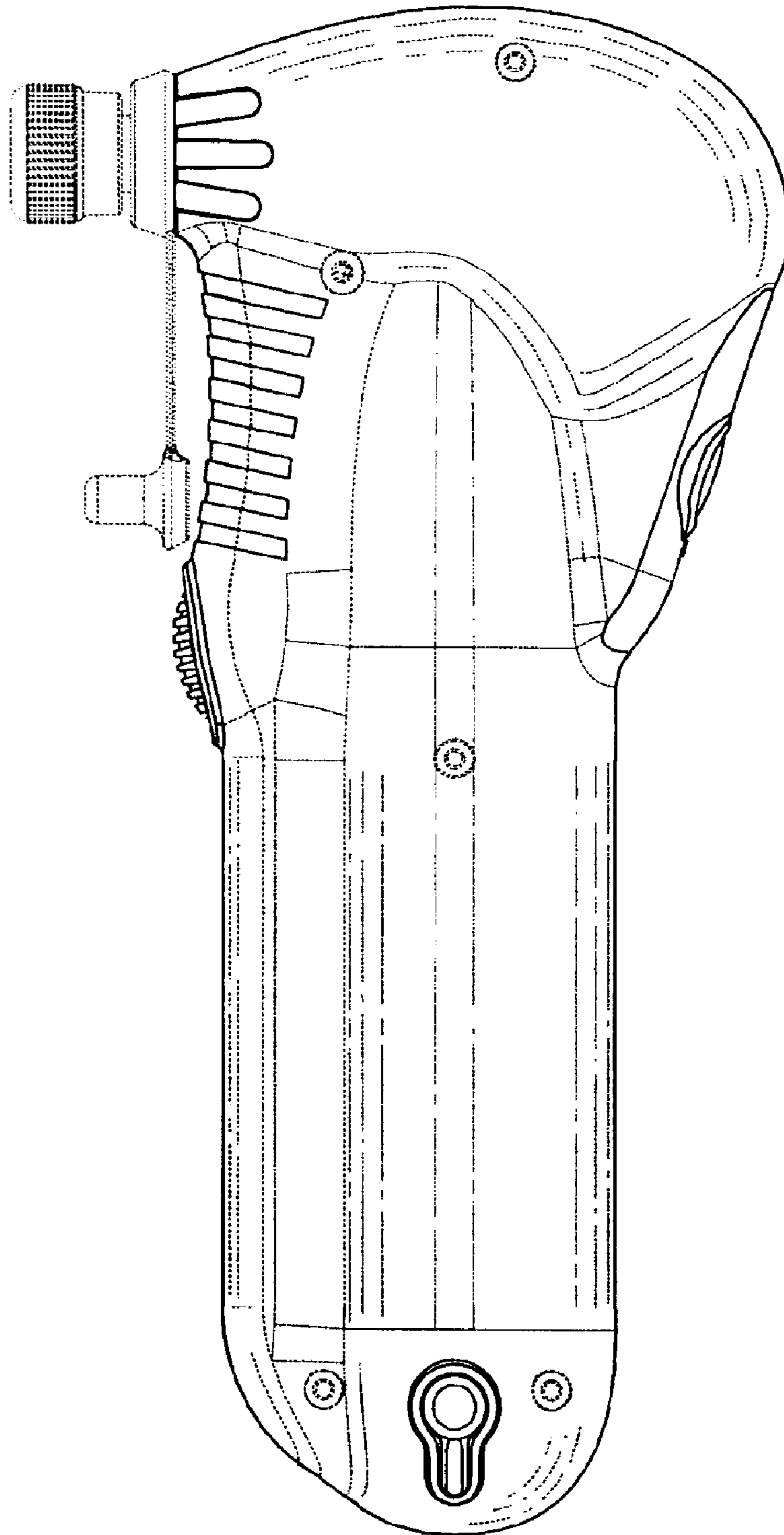

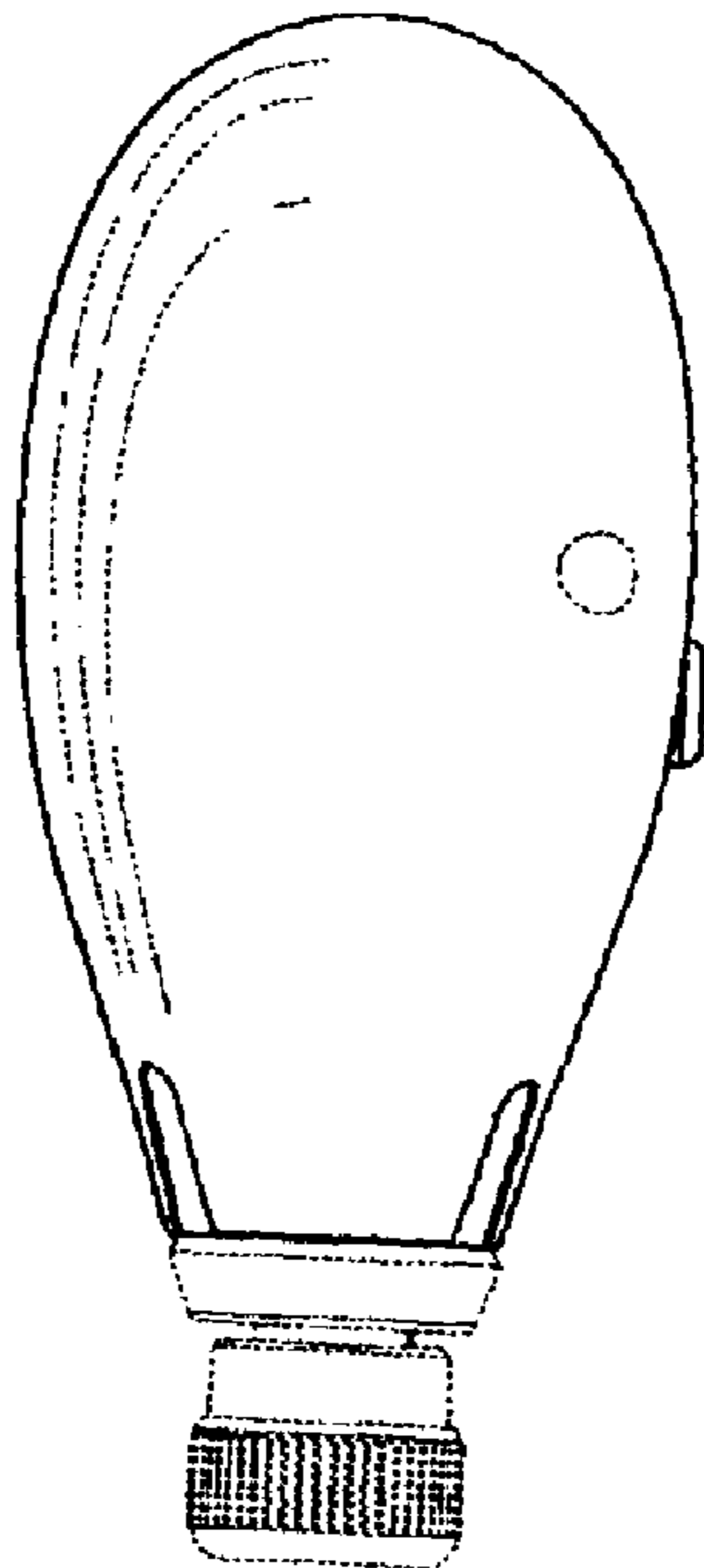

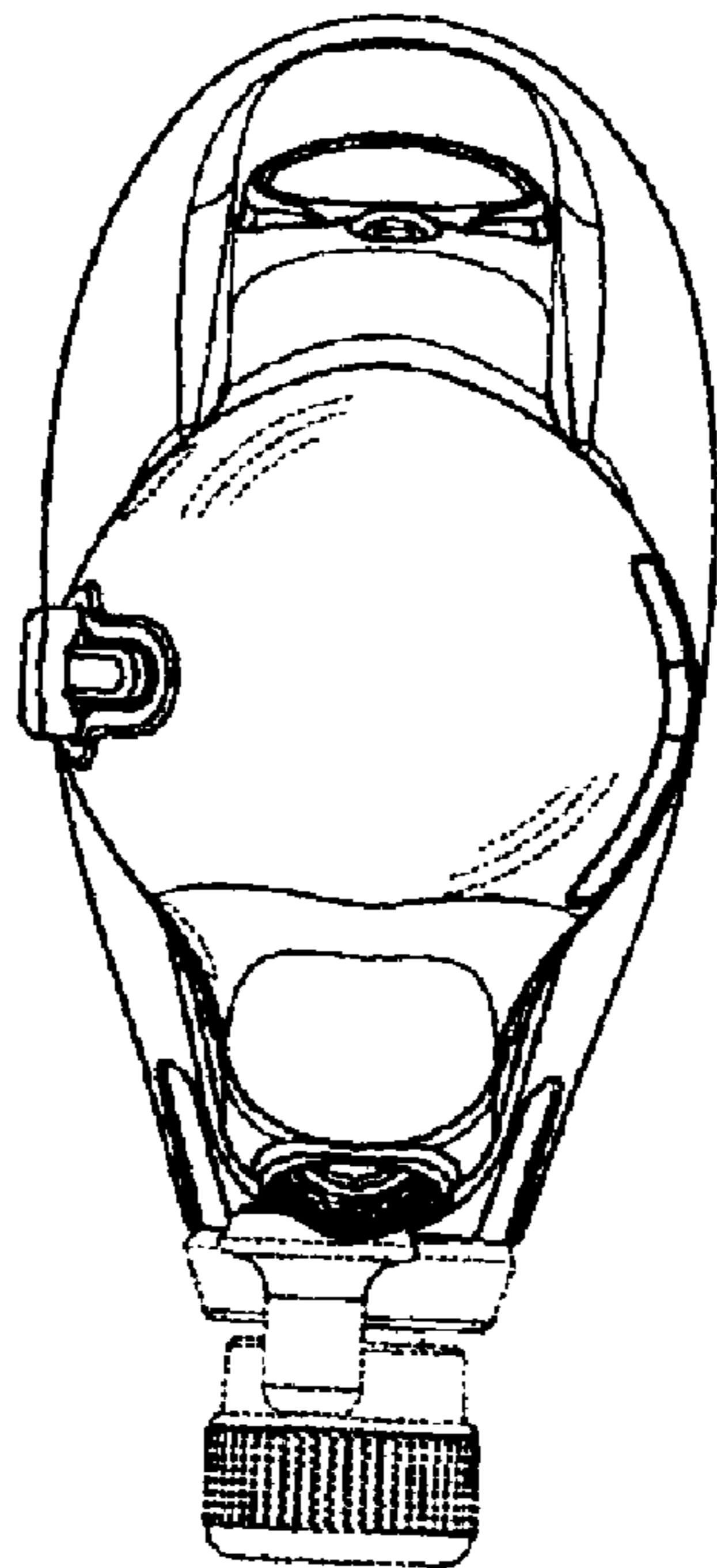

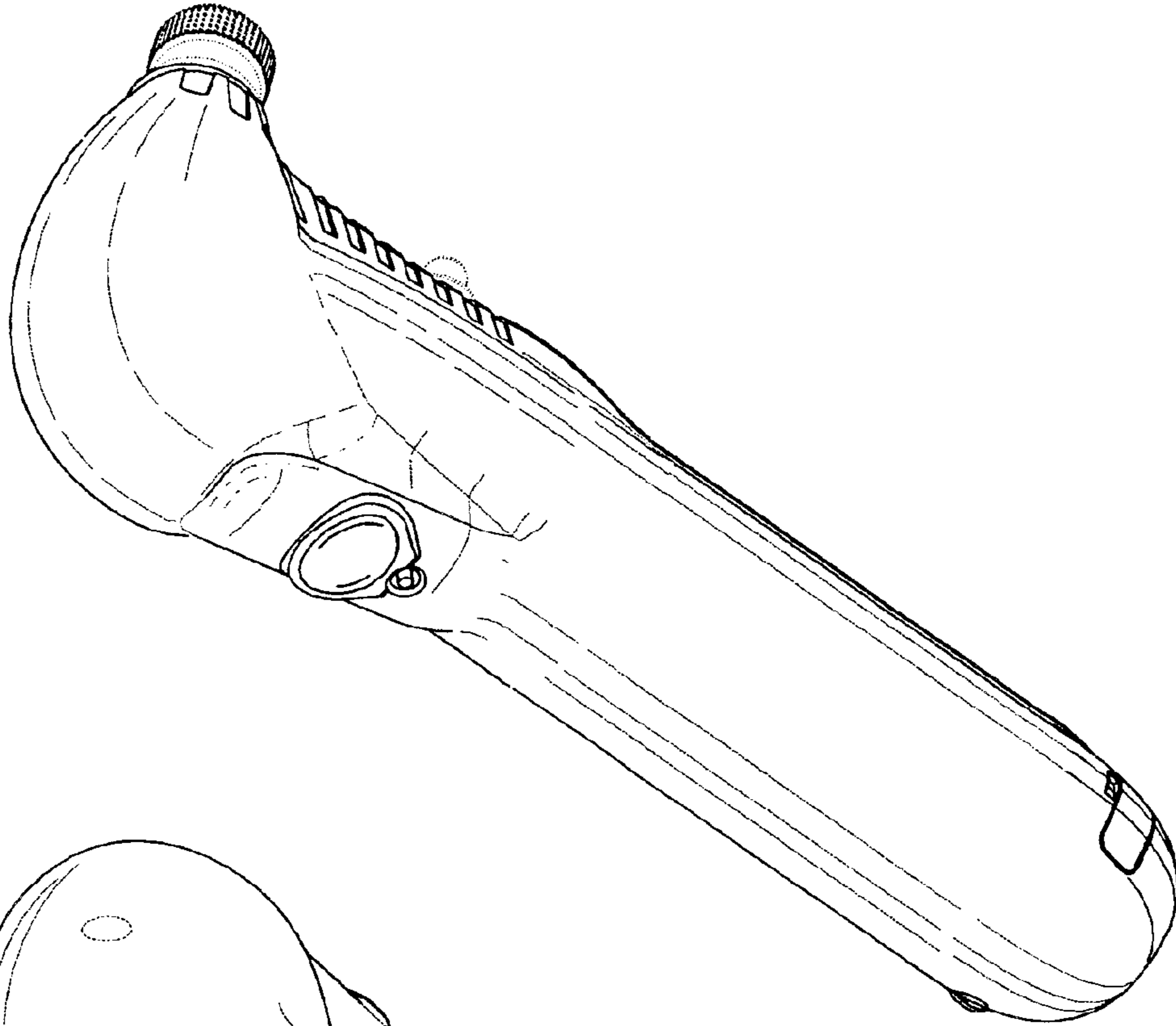

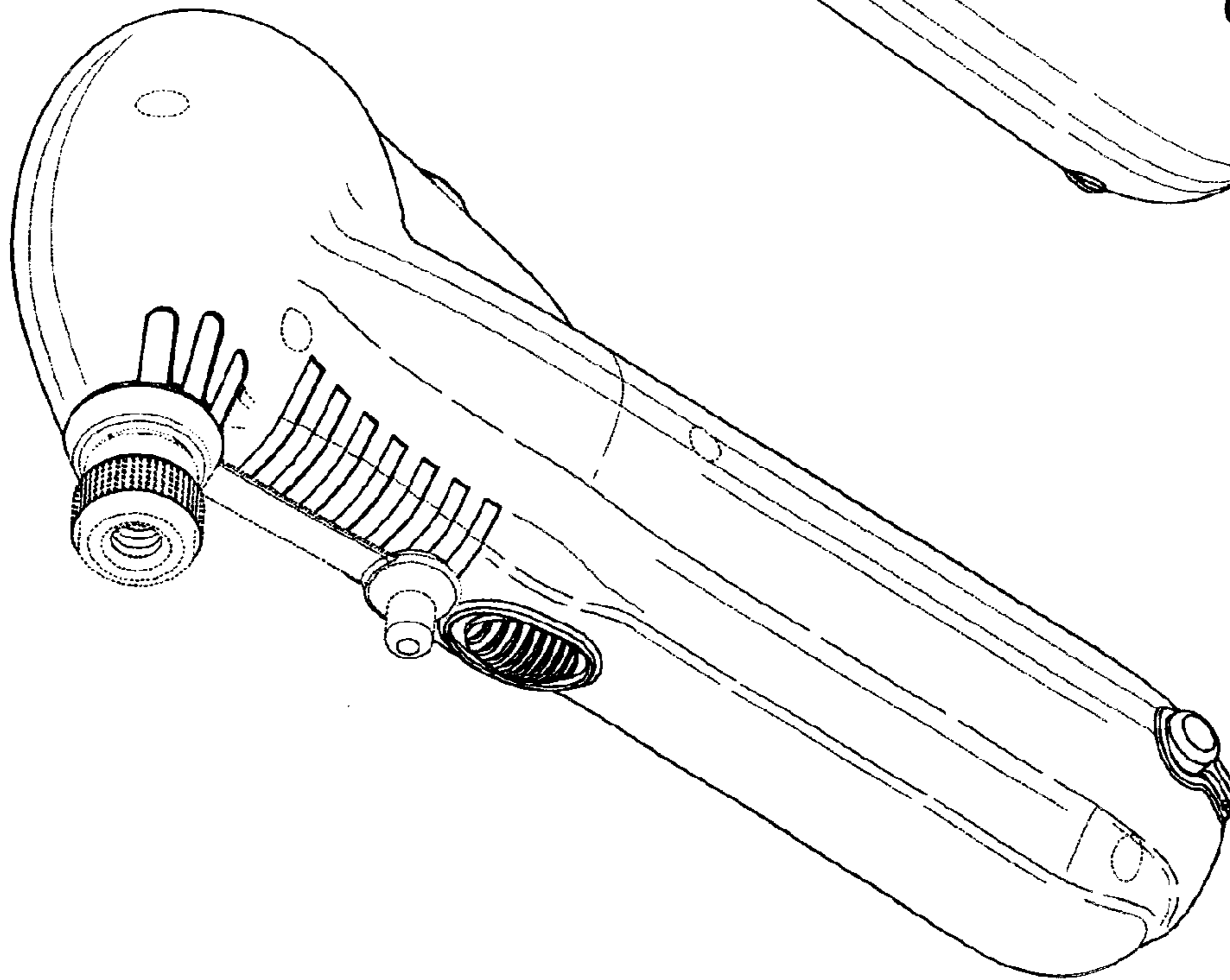
