FIG. 1 is a perspective view of a pet toy showing my new design;

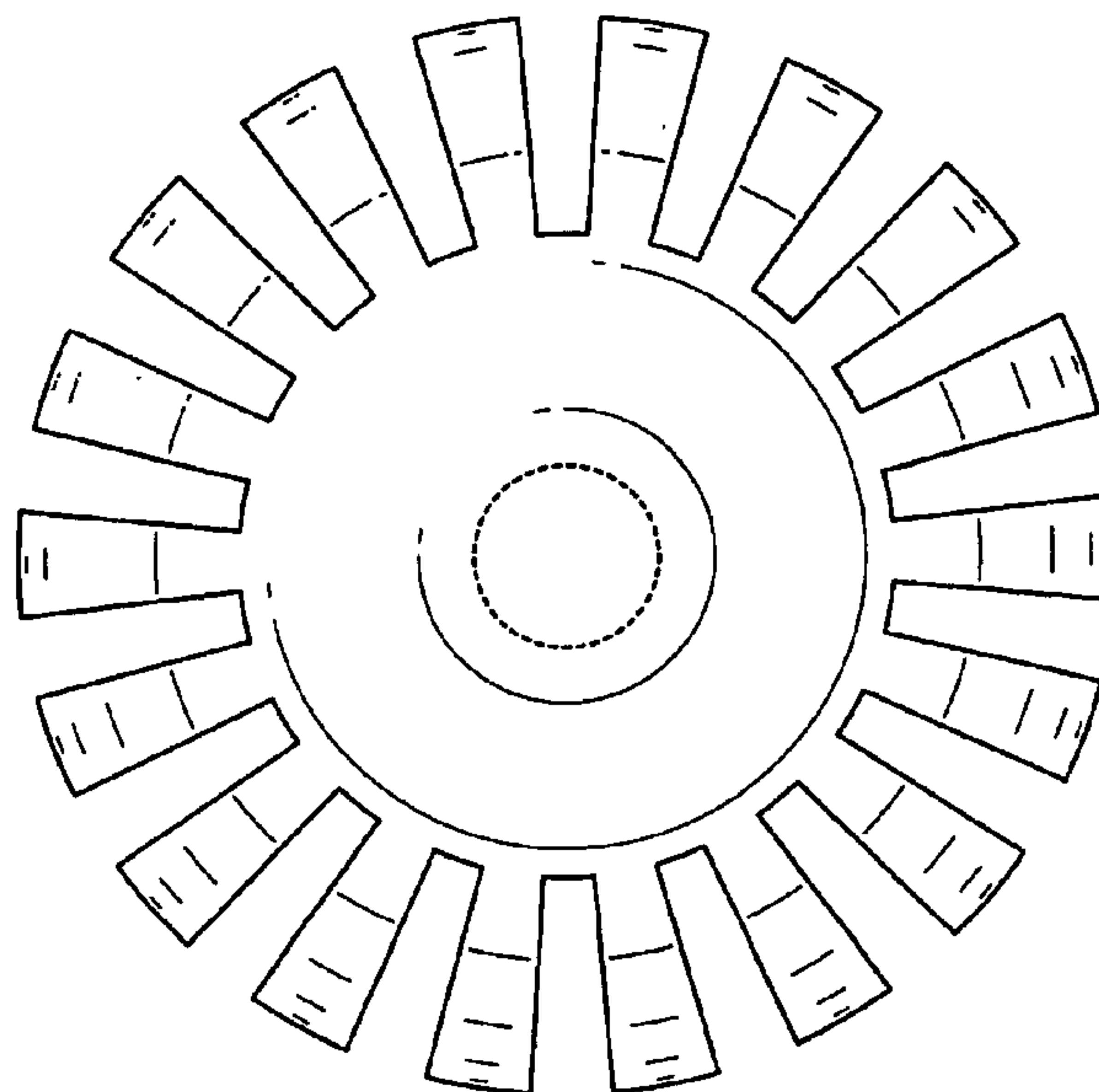
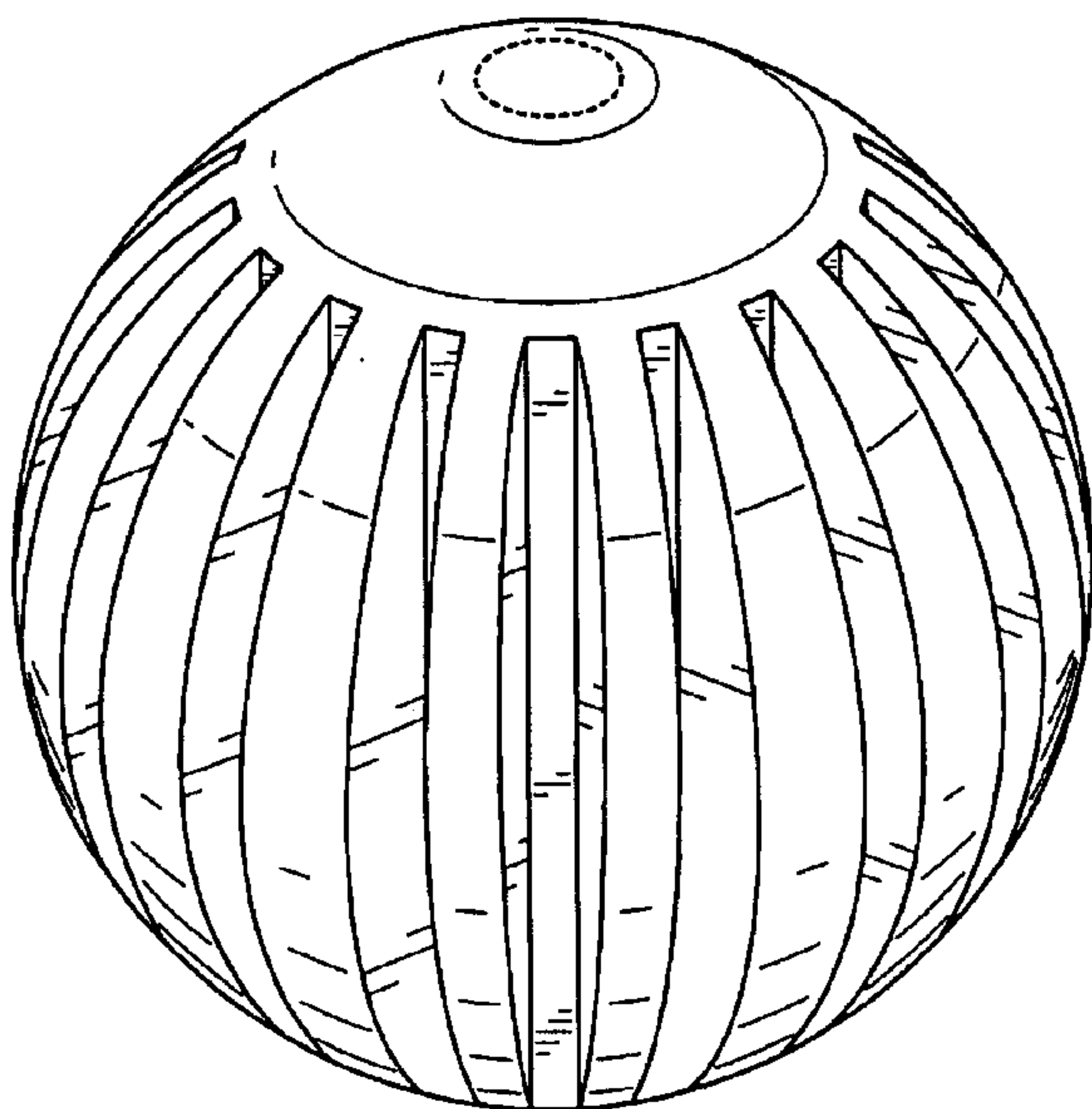
FIG. 2 is a top view thereof, the bottom view being the same;

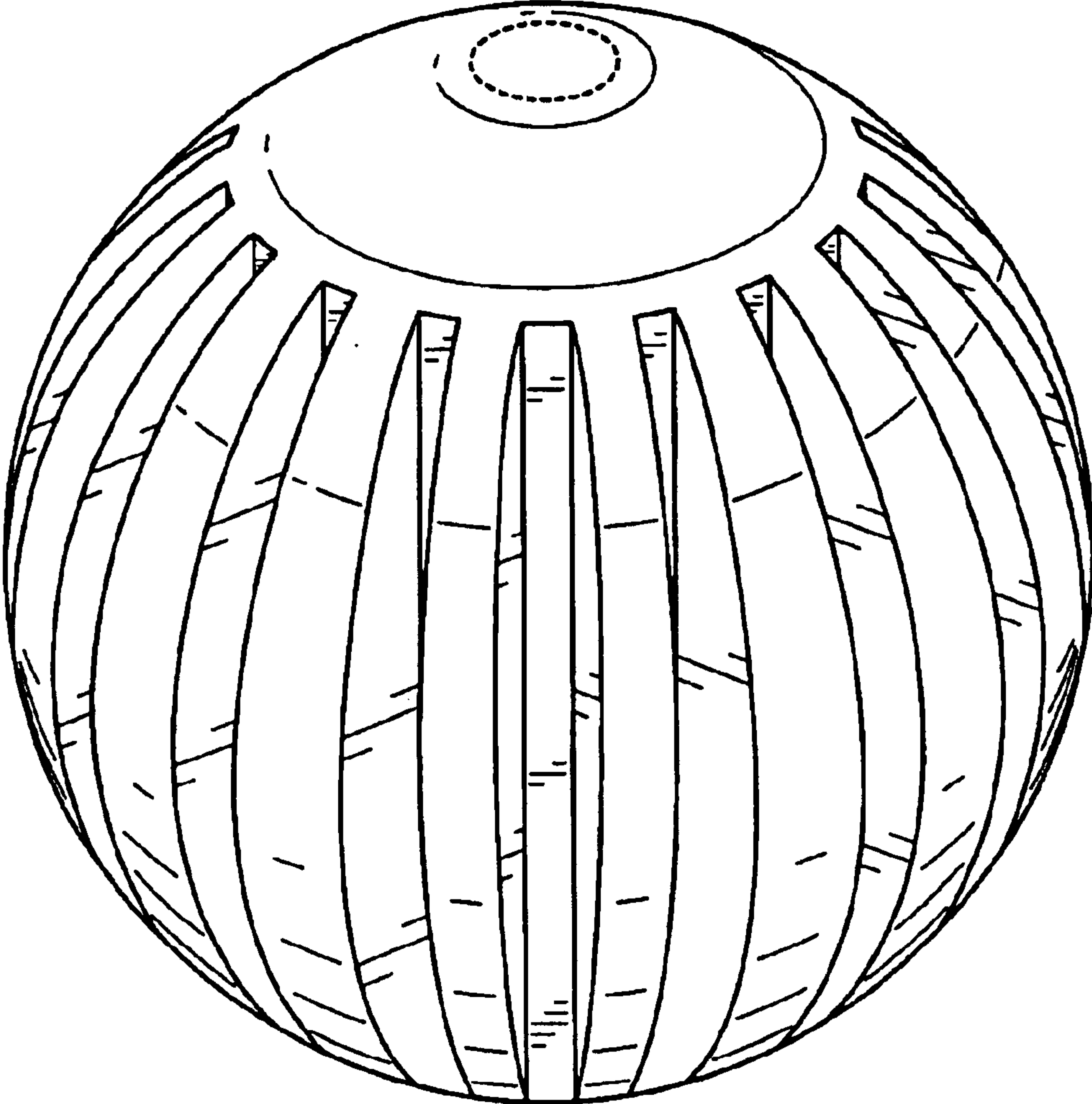

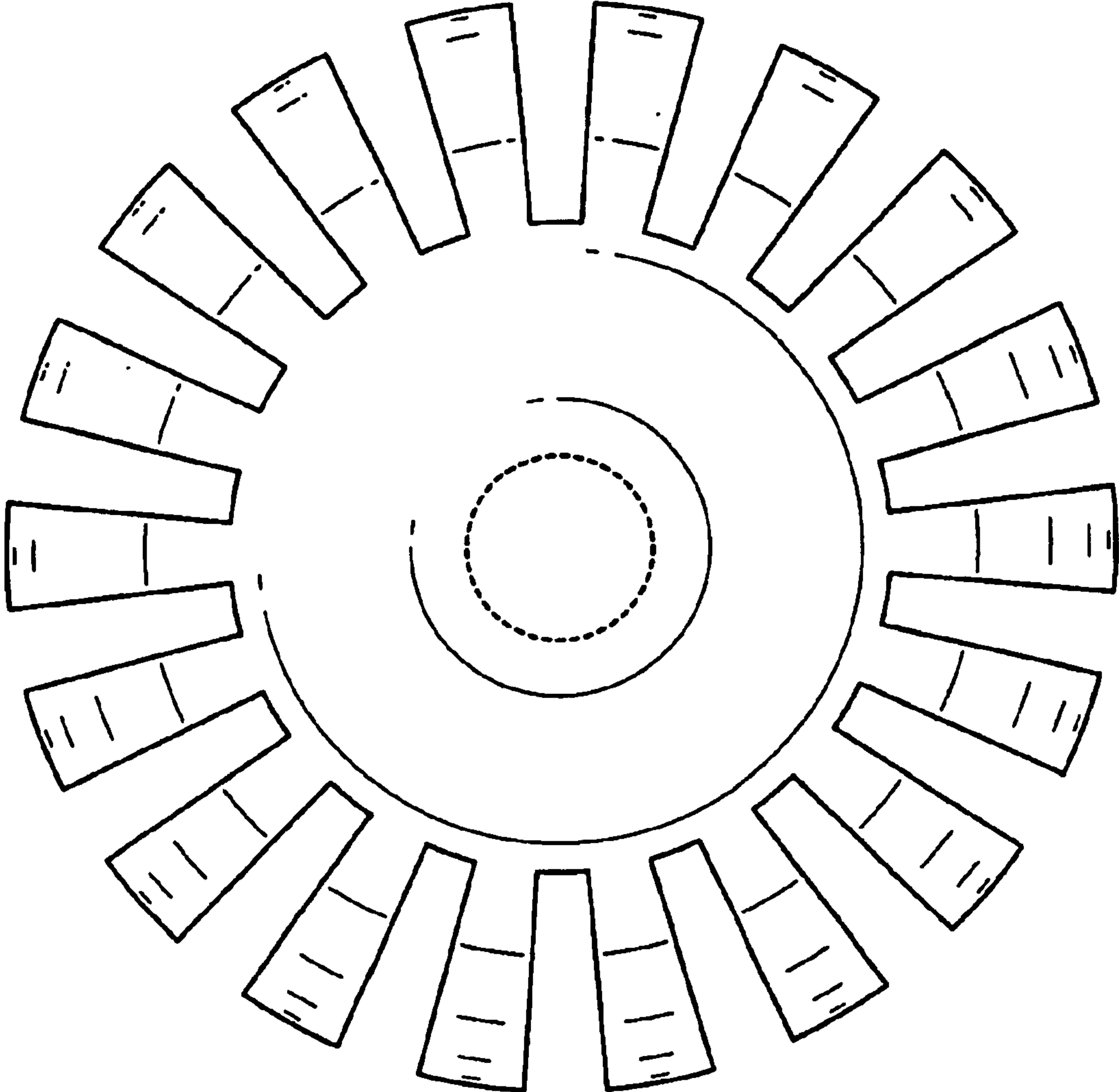

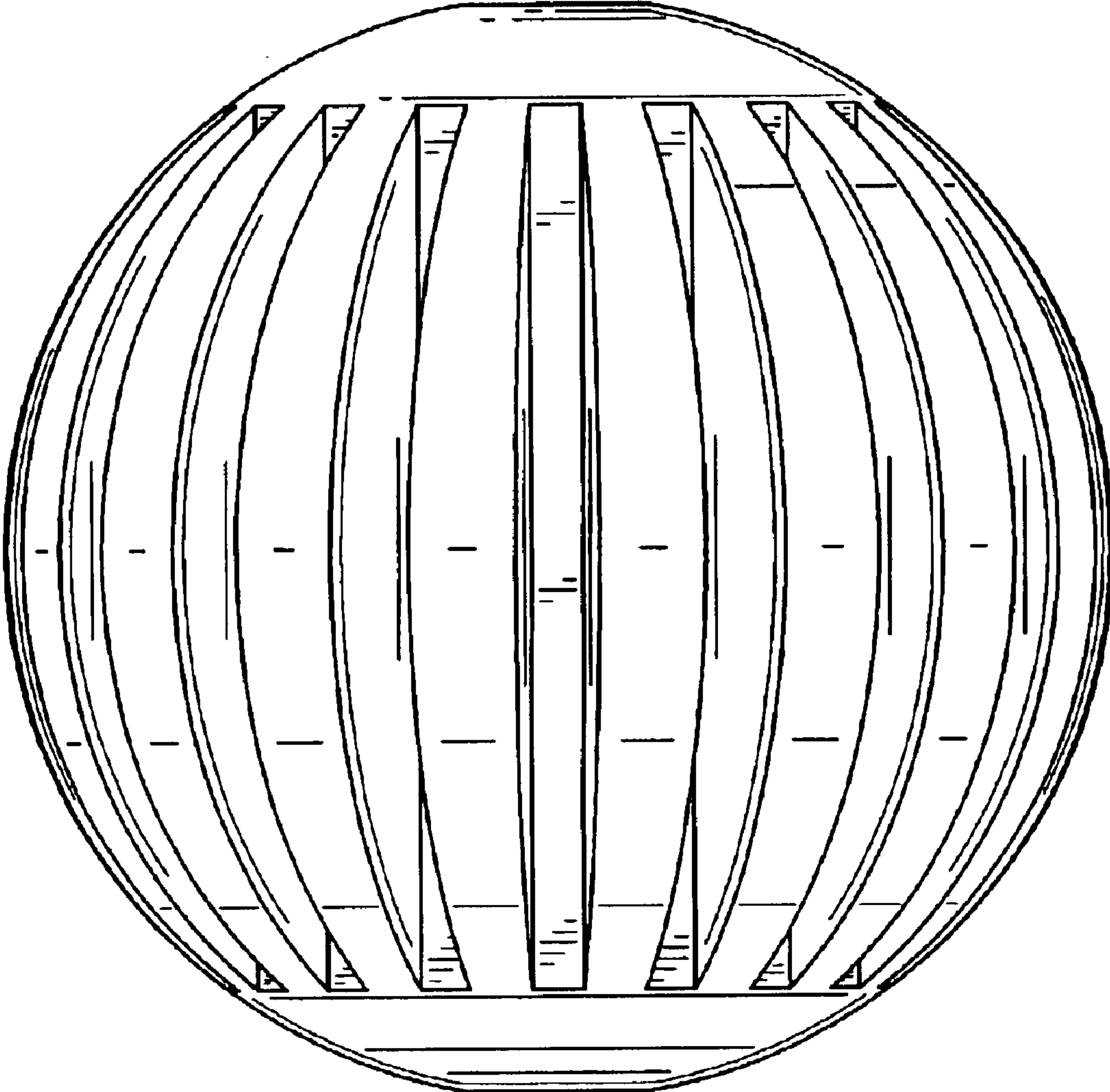

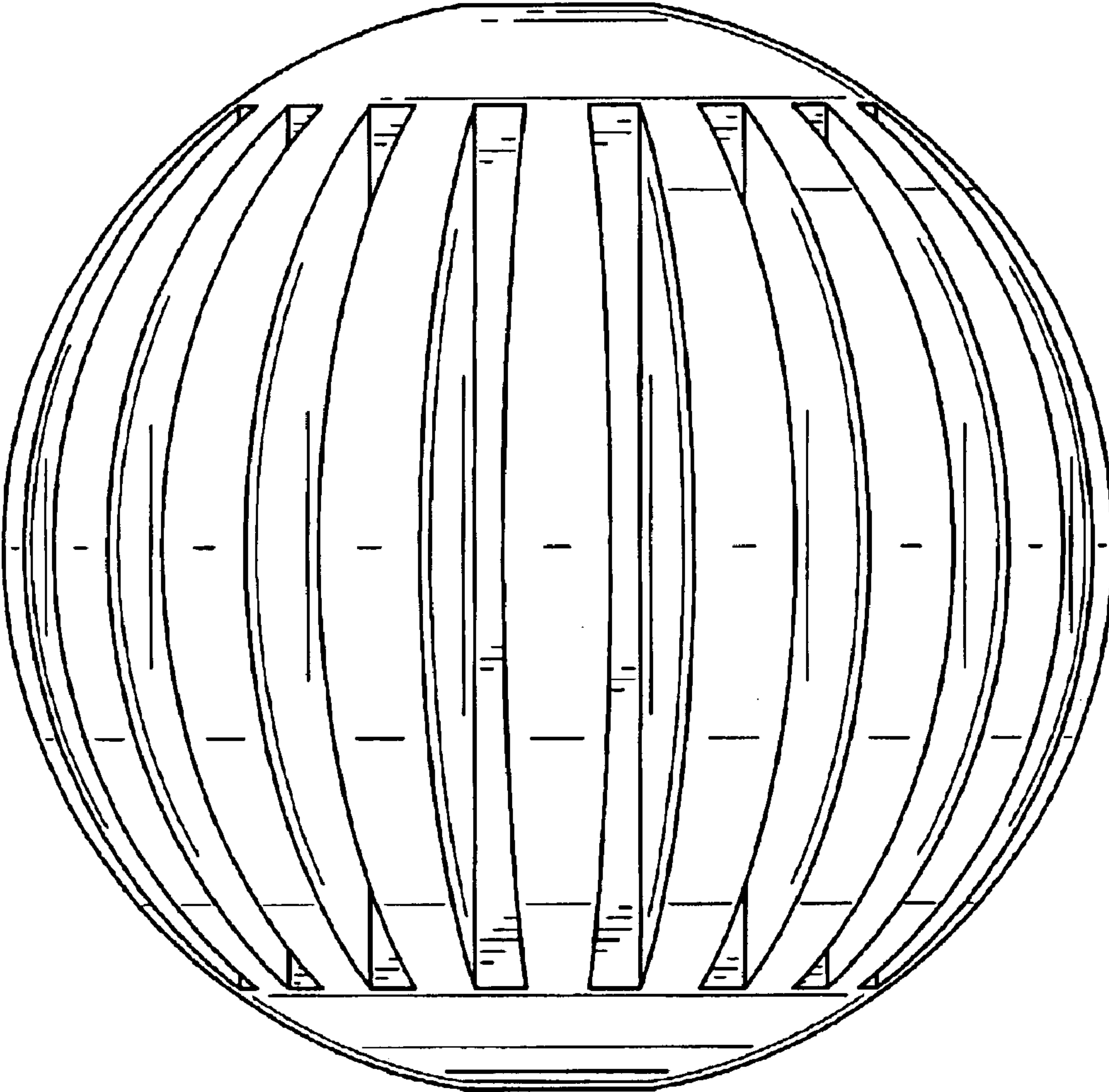
