(57) **CLAIM**

The ornamental design for a teardrop wall clock, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a teardrop wall clock according to the present invention.

FIG. 2 is a front elevational view of the teardrop wall clock of FIG. 1.

FIG. 3 is a top plan view of the teardrop wall clock of FIG. 1.

FIG. 4 is a bottom plan view of the teardrop wall clock of FIG. 1.

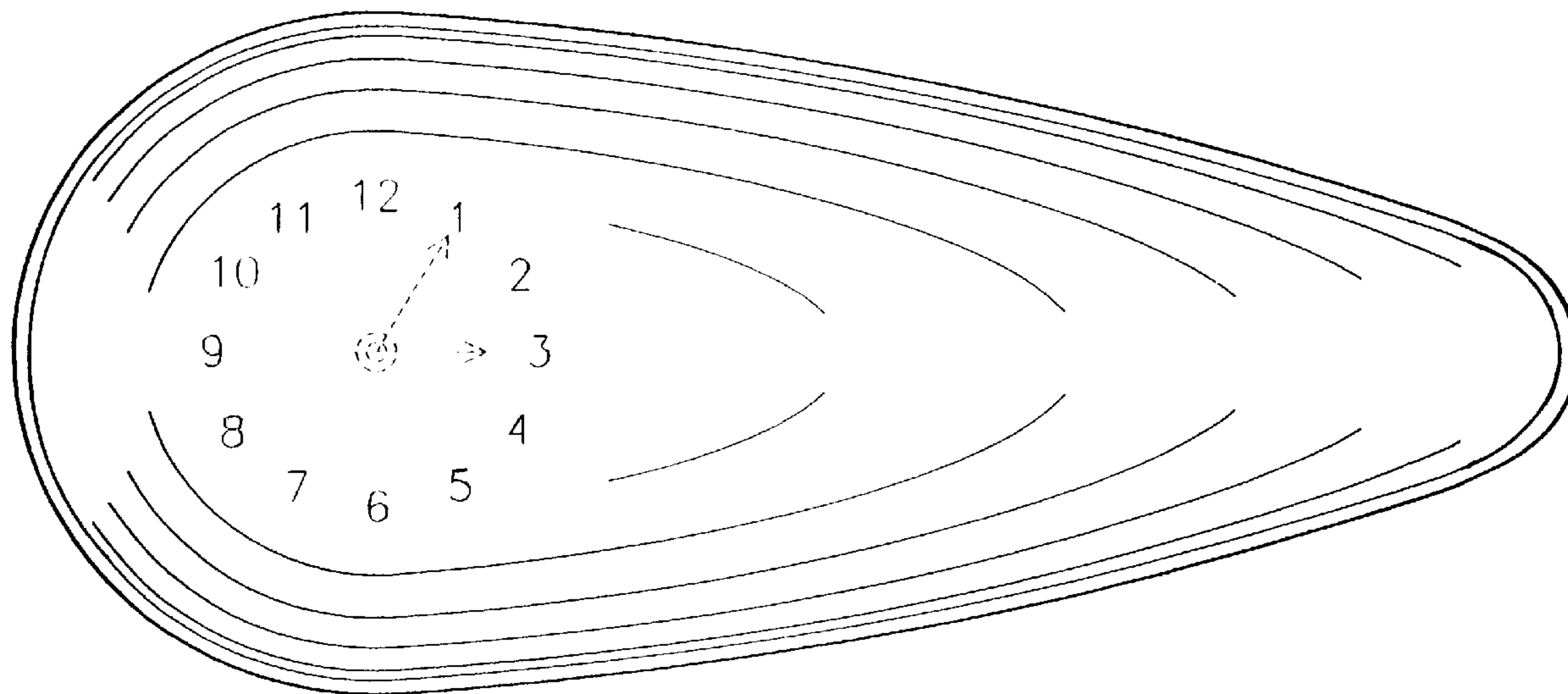
FIG. 5 is a right side elevational view of the teardrop wall clock of FIG. 1.

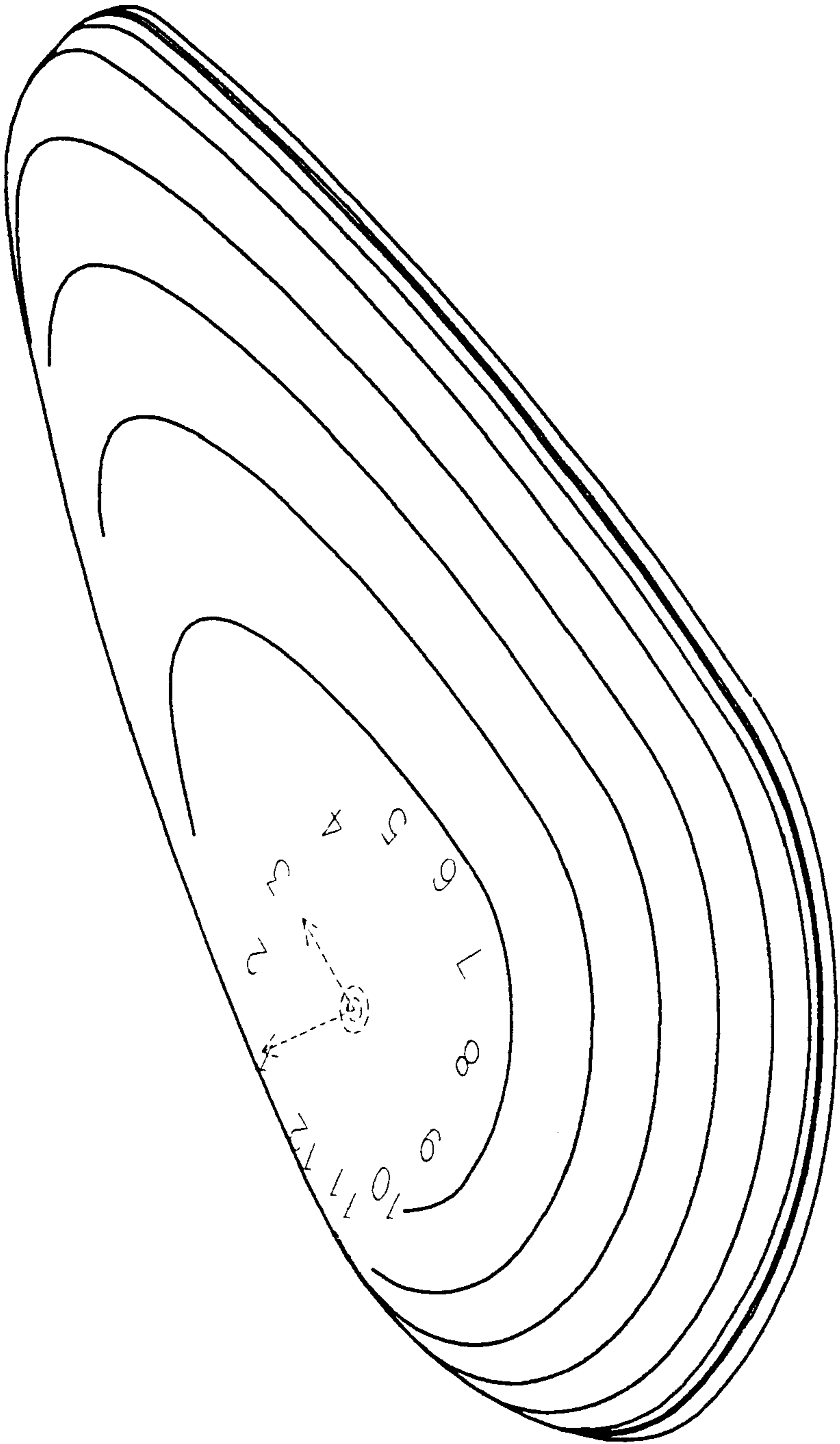

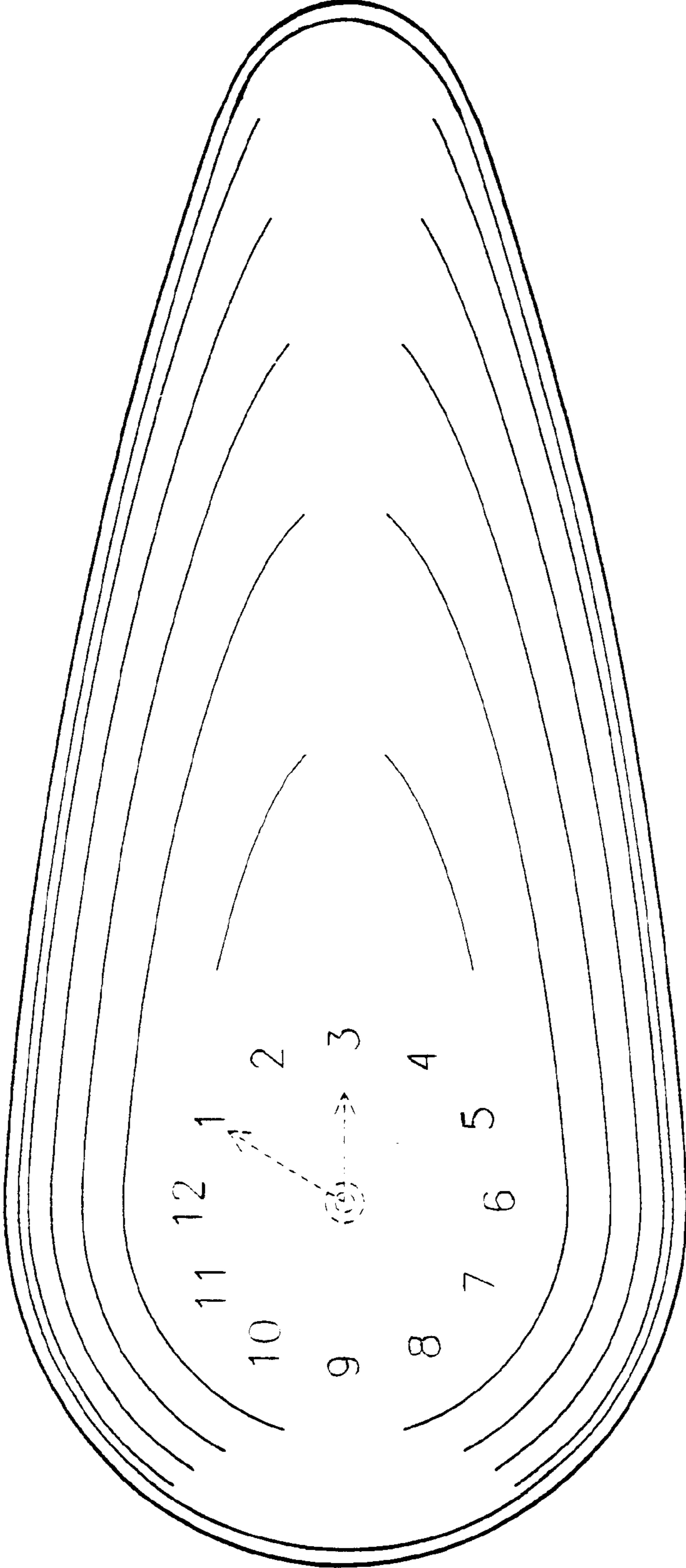

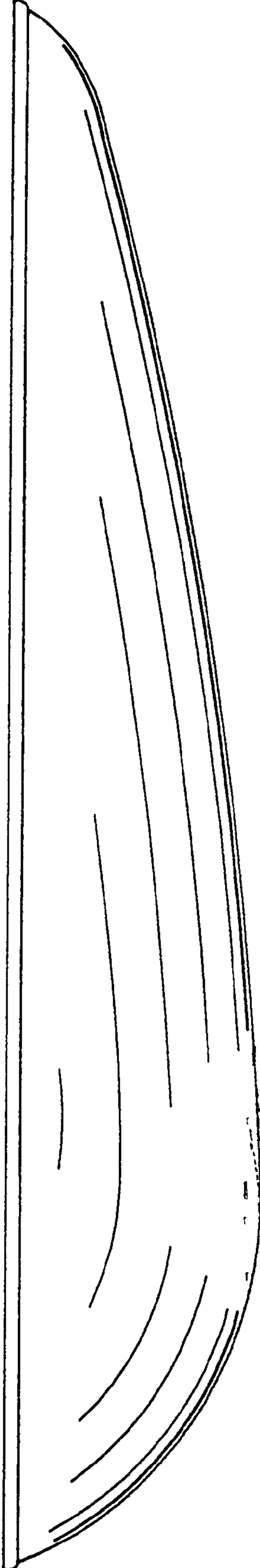

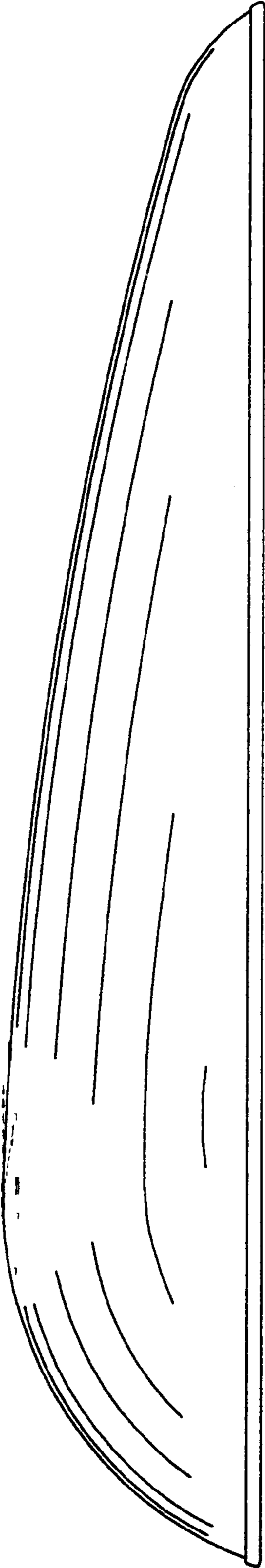

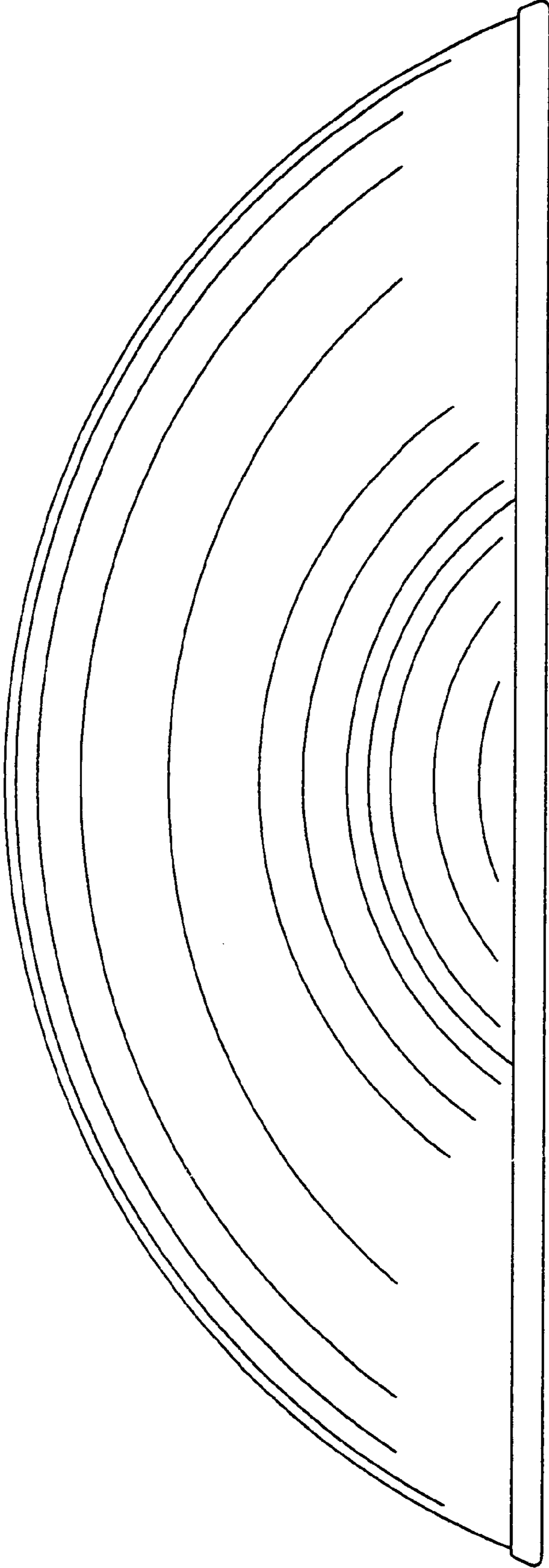

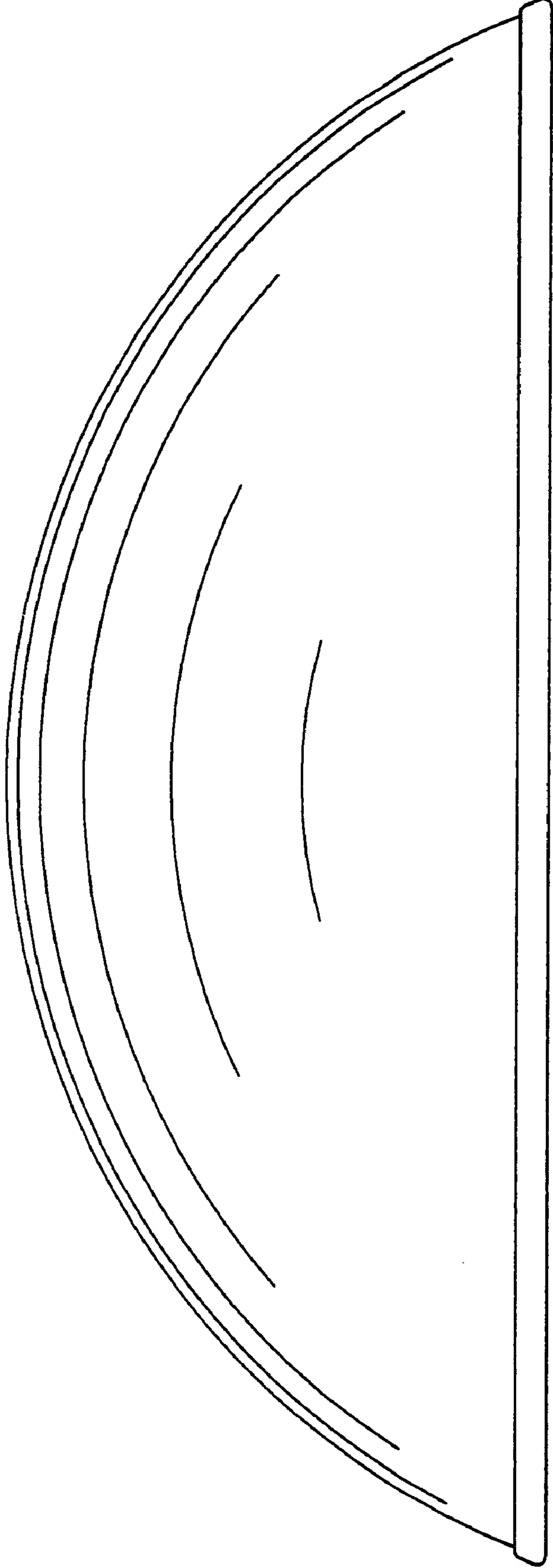

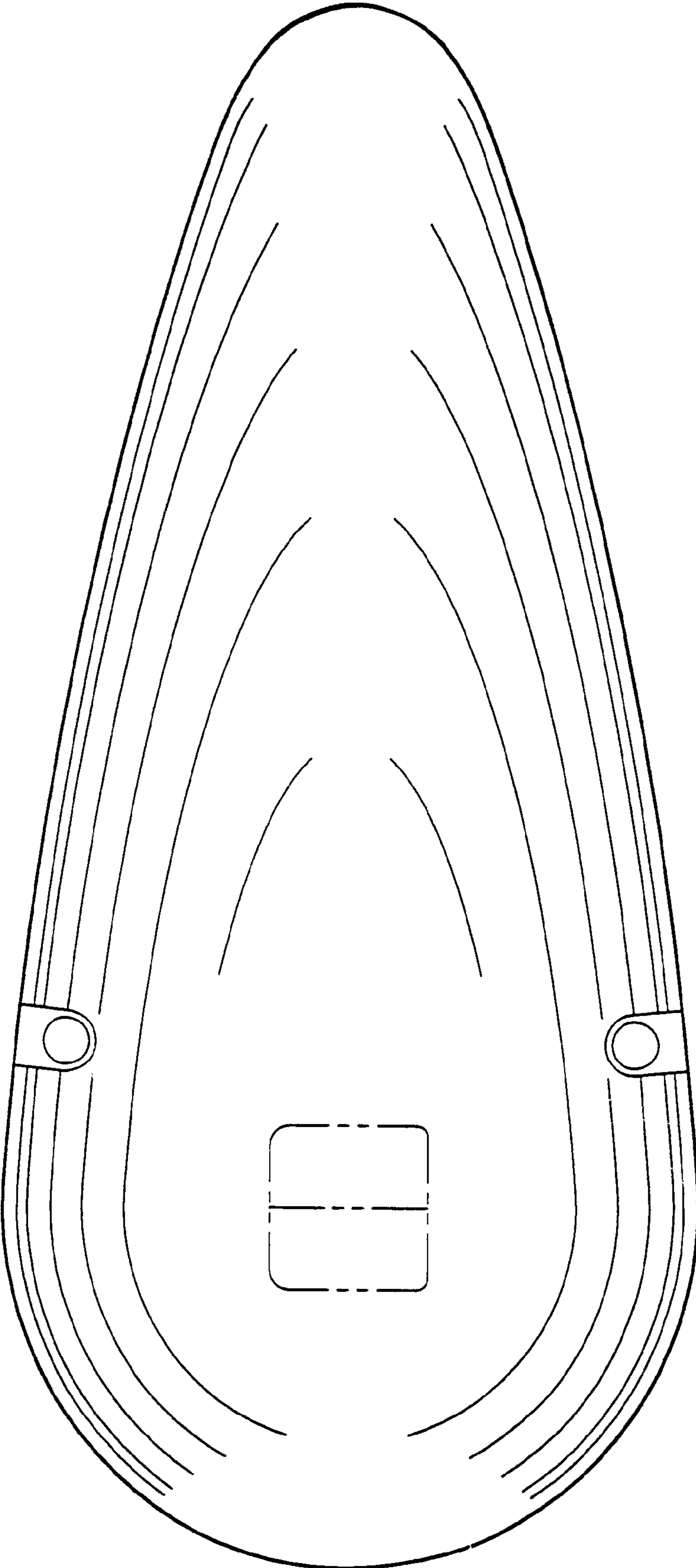
