(57) **CLAIM**

The ornamental design for a surface configuration of a side door for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 3 is a front view of the first embodiment of the surface configuration of a side door for a vehicle according to my novel design;

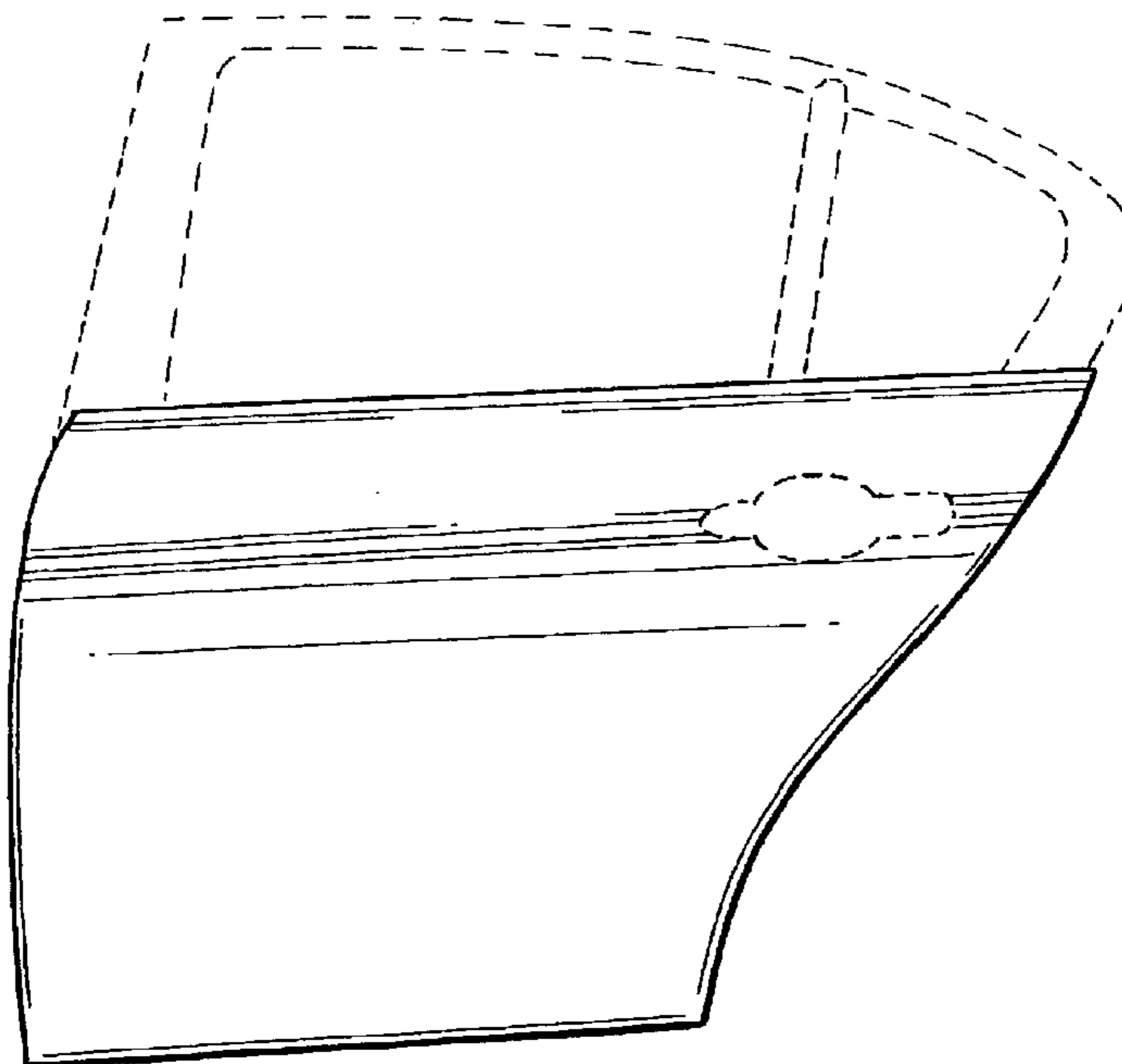
FIG. 4 is a perspective view of a second embodiment of the surface configuration of a side door for a vehicle according to my novel design;

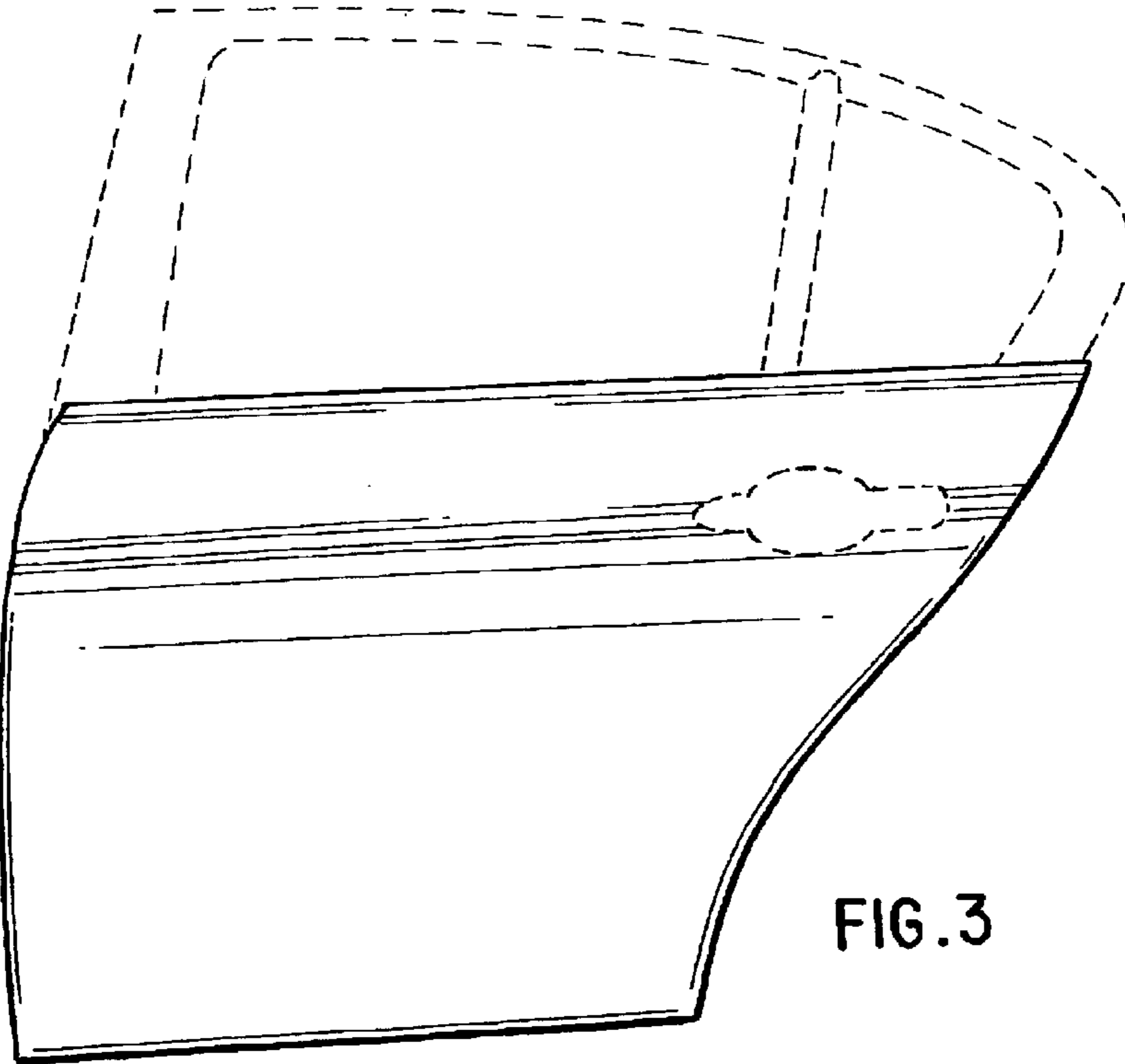
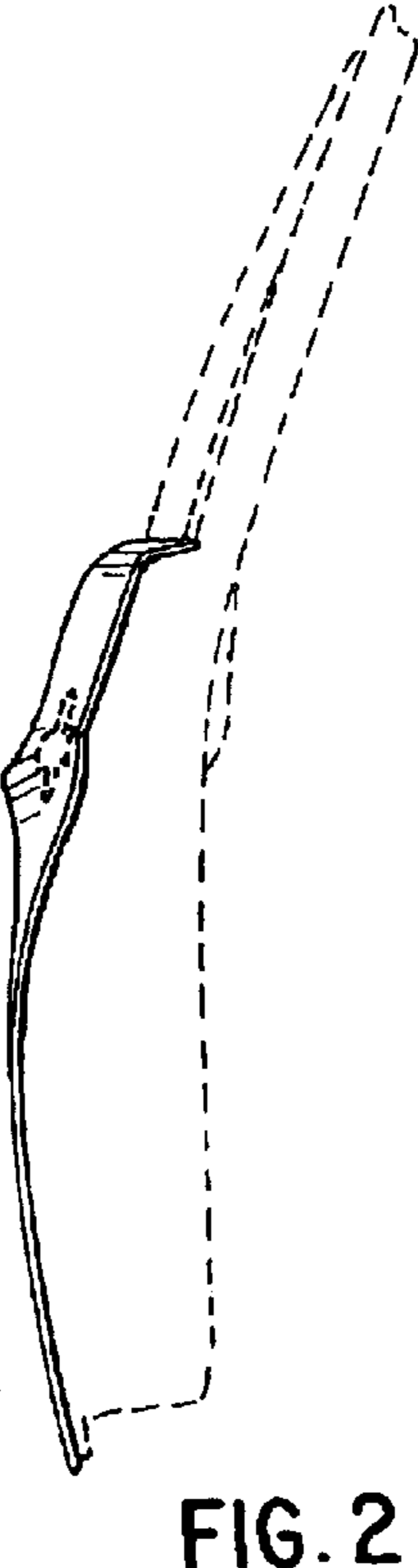
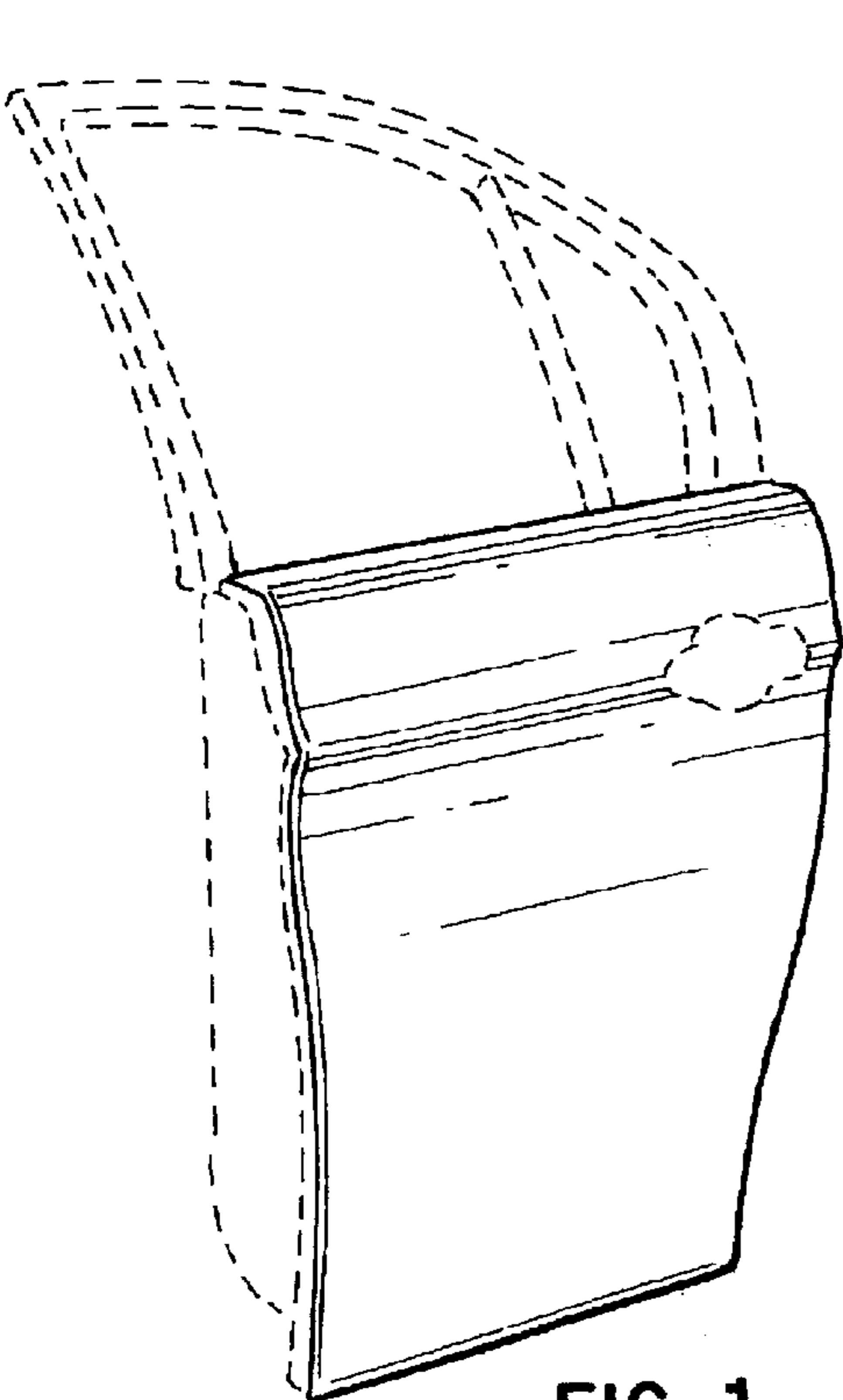
FIG. 5 is a side view of the second embodiment of the surface configuration of a side door for a vehicle according to my novel design; and,

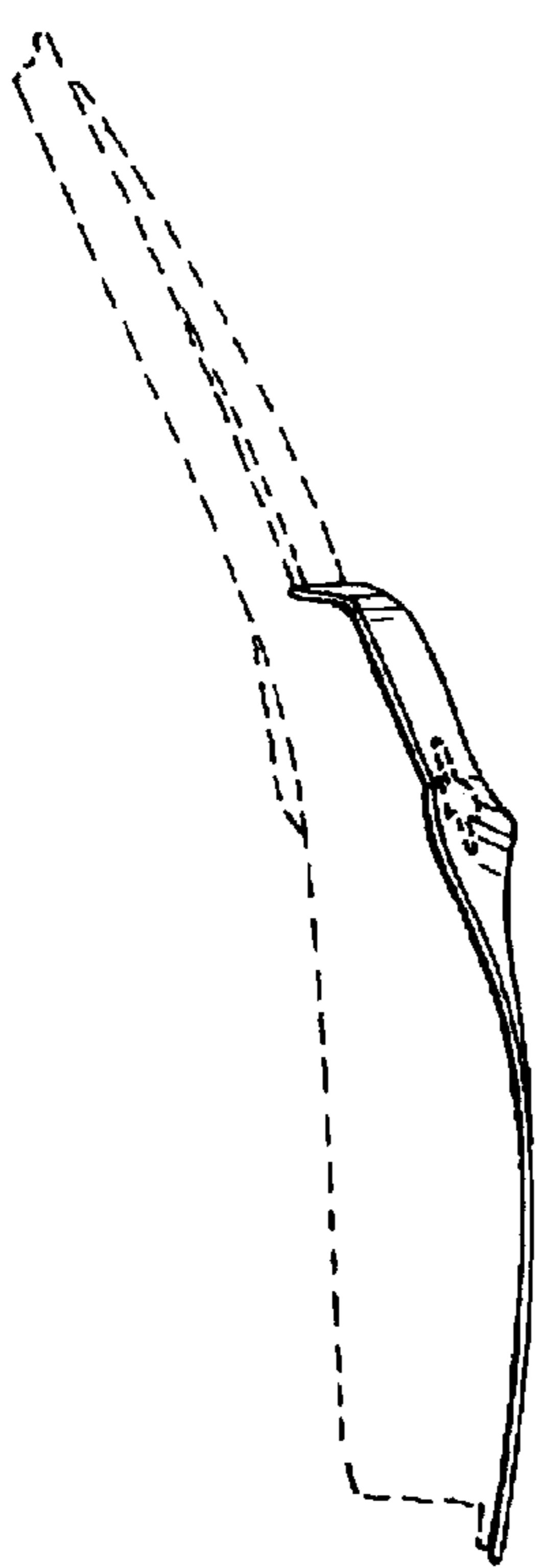

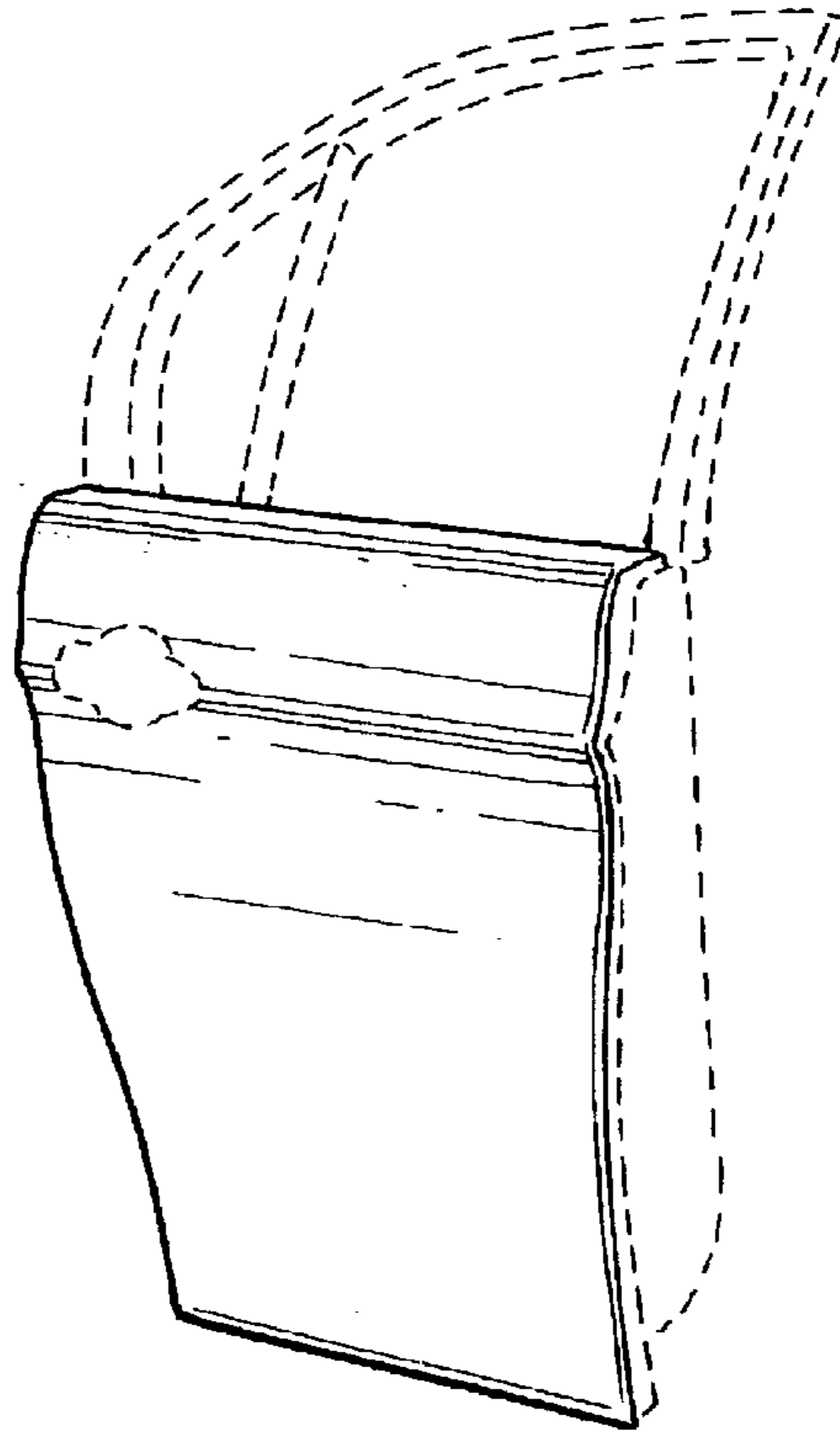

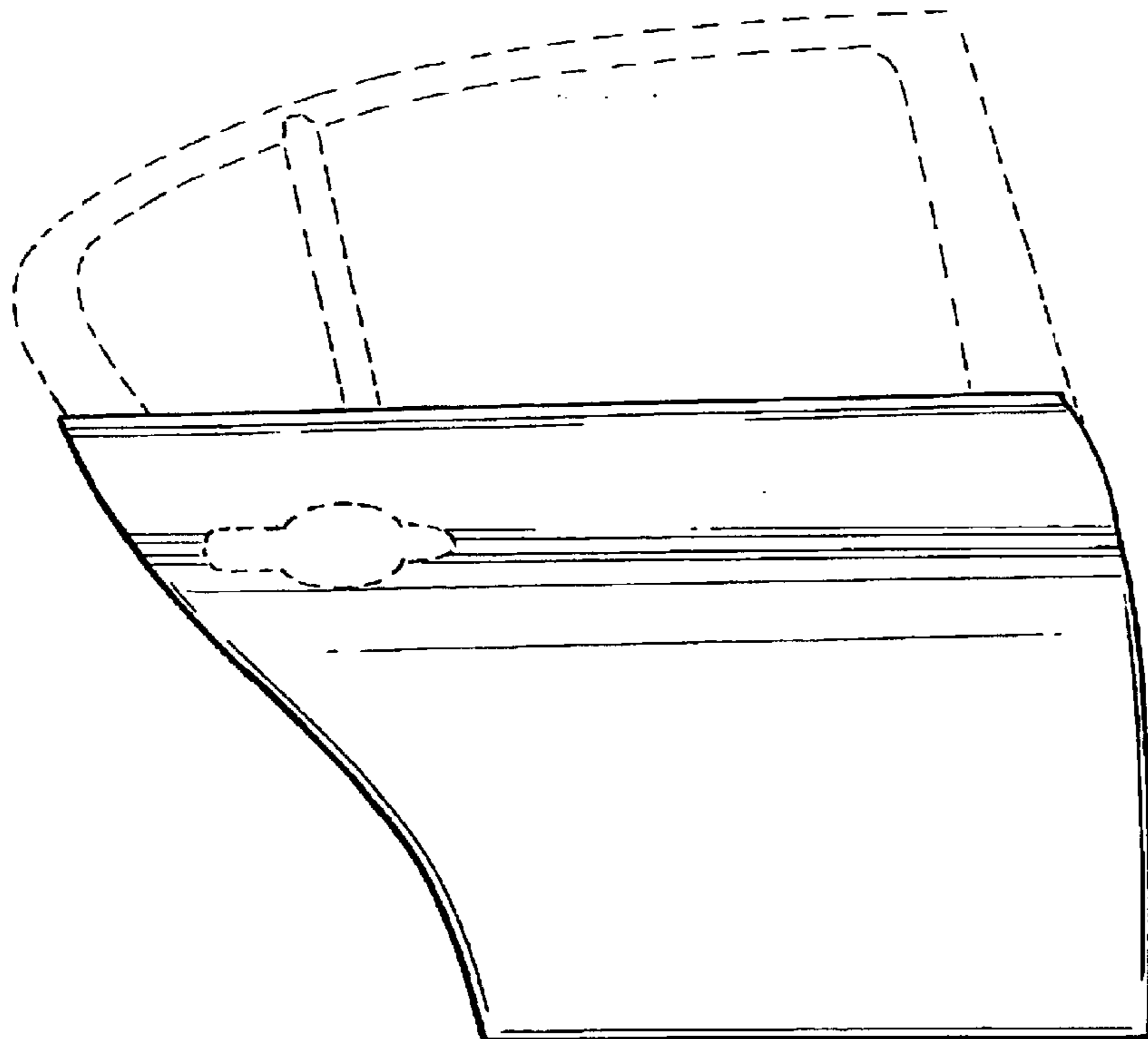
