FIG. 14 is a top perspective view of a third embodiment of a baseball field mouse pad; and,

FIG. 15 is a right side elevation view thereof.

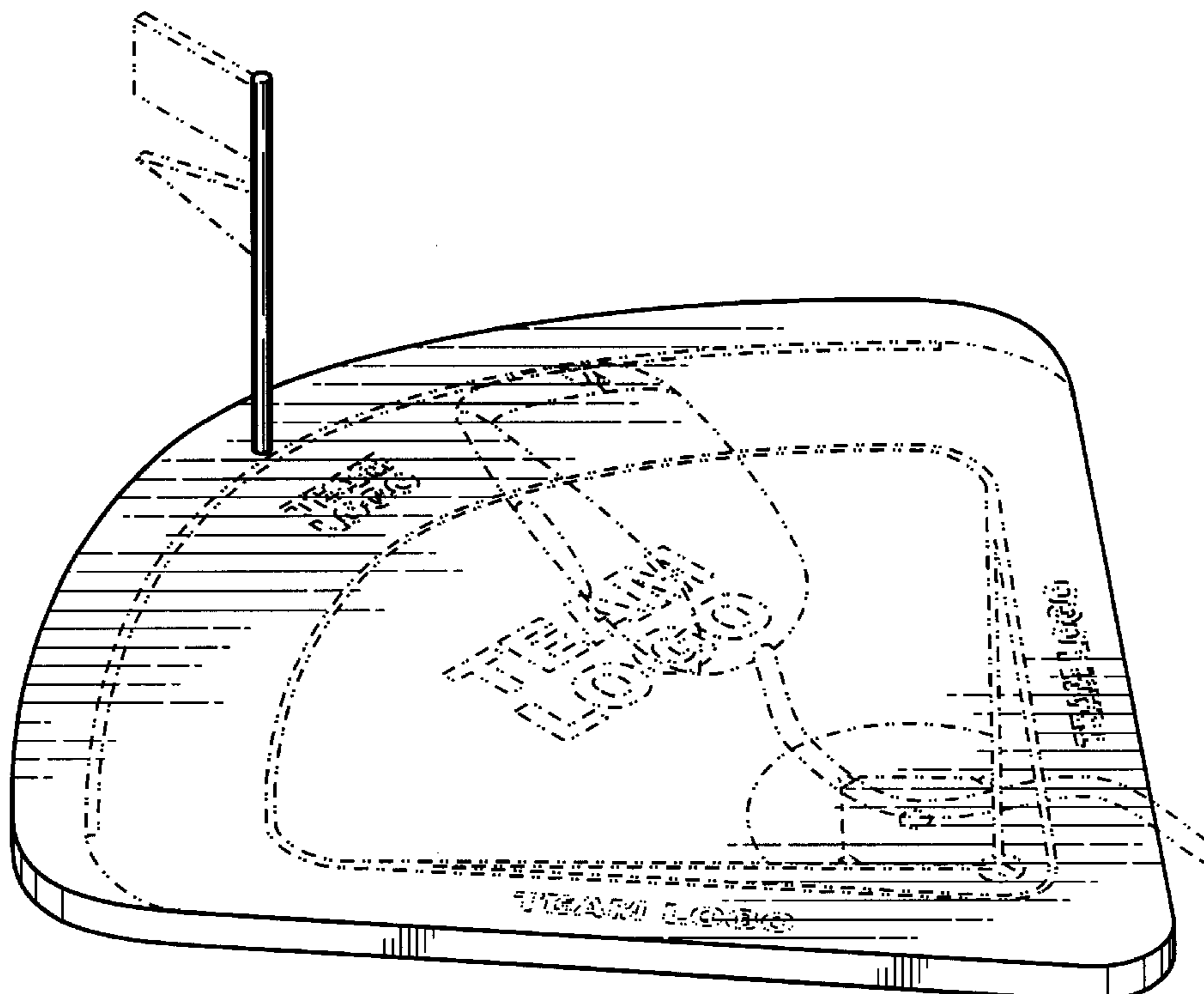

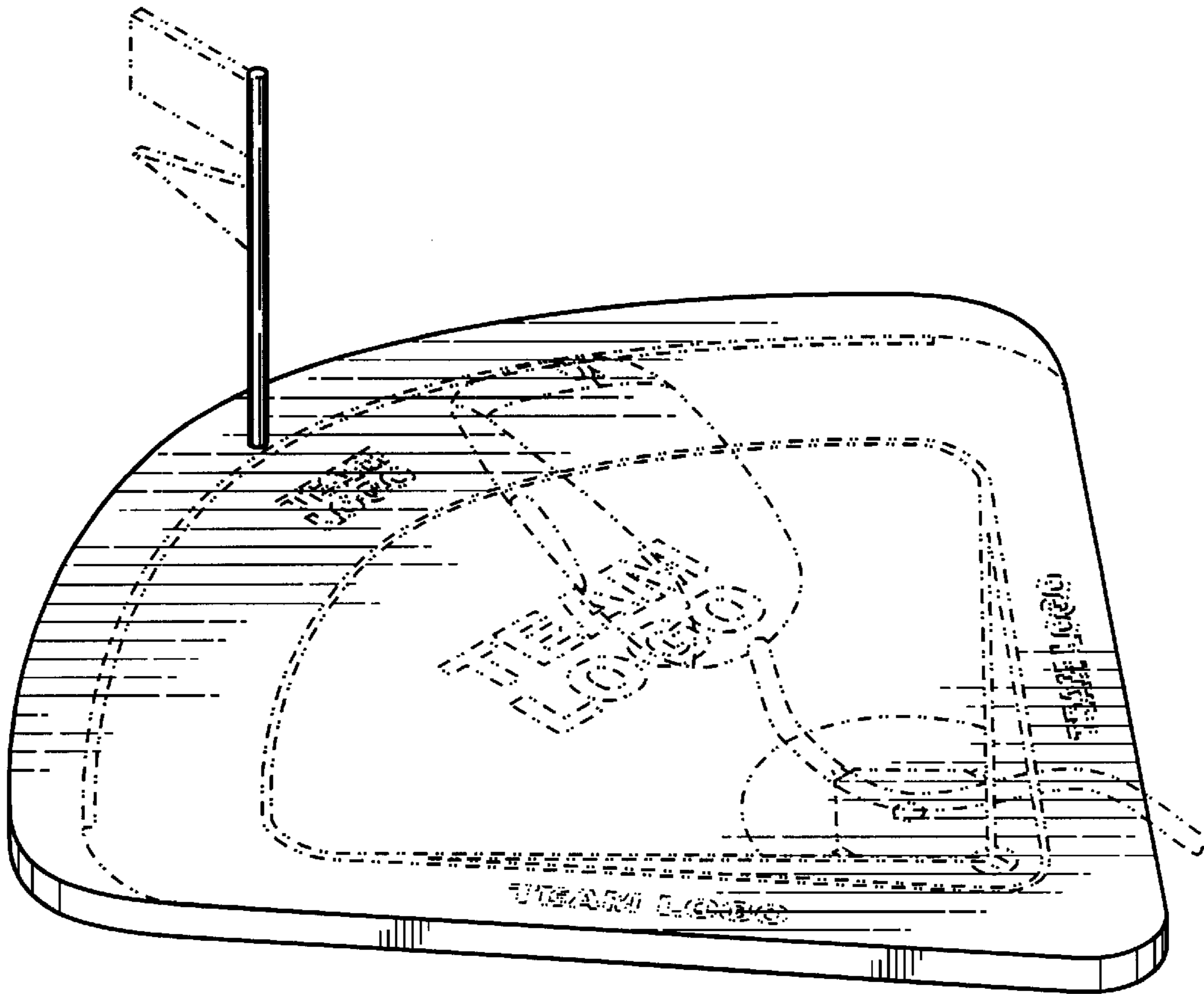

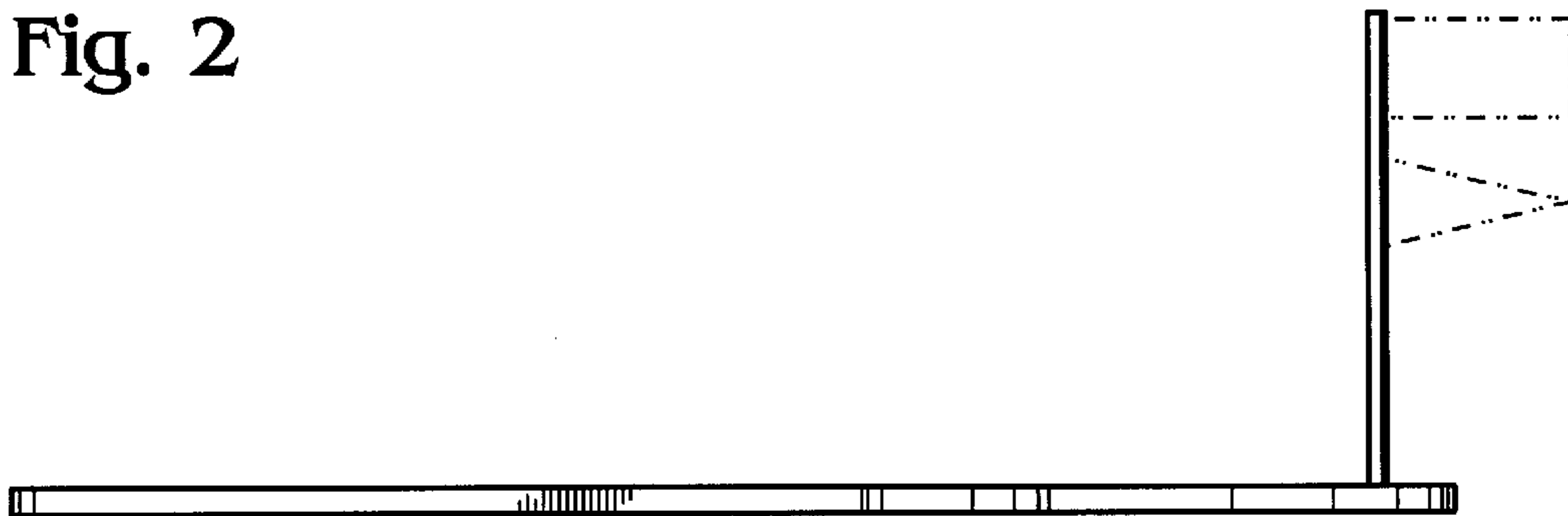

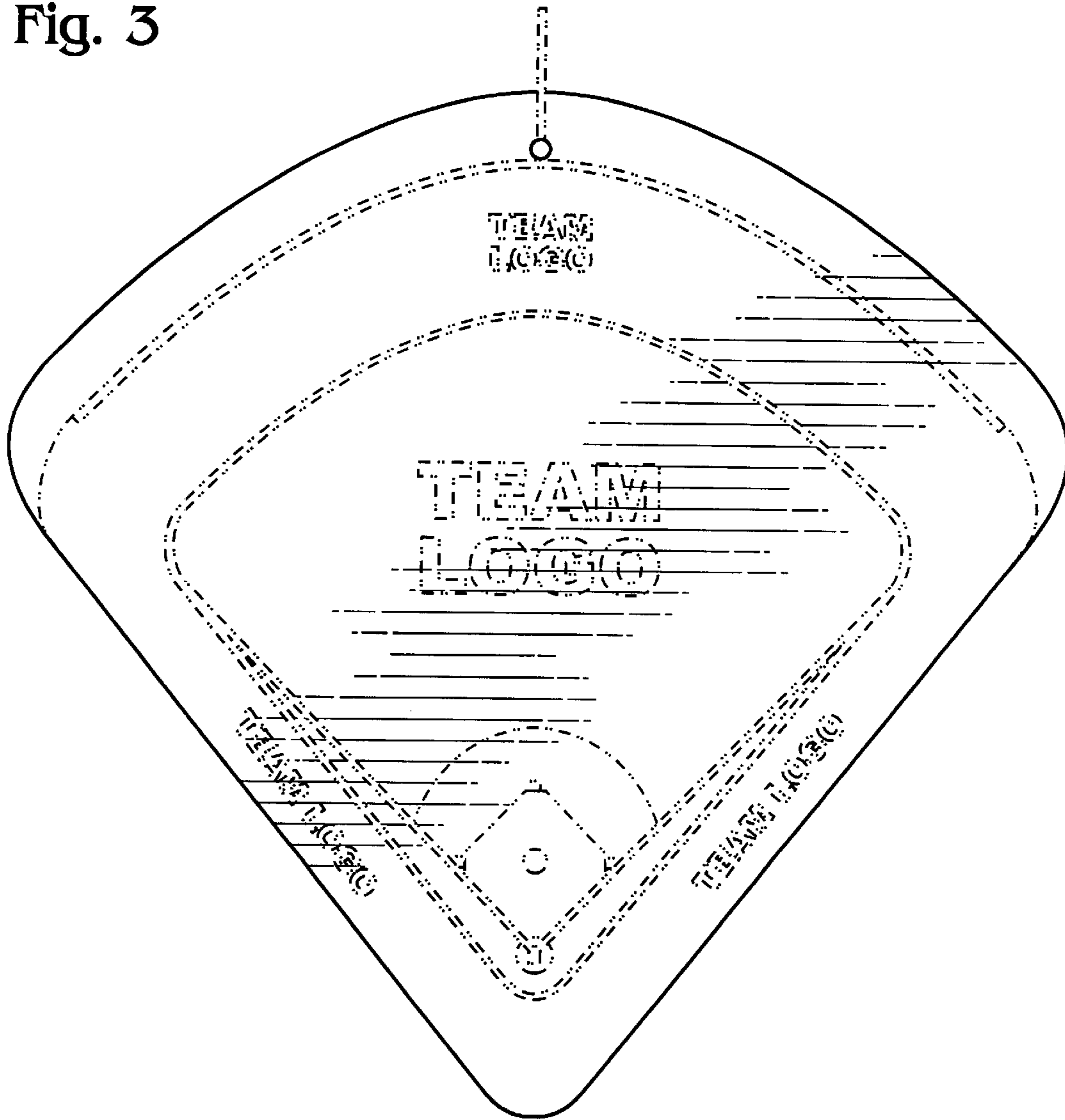

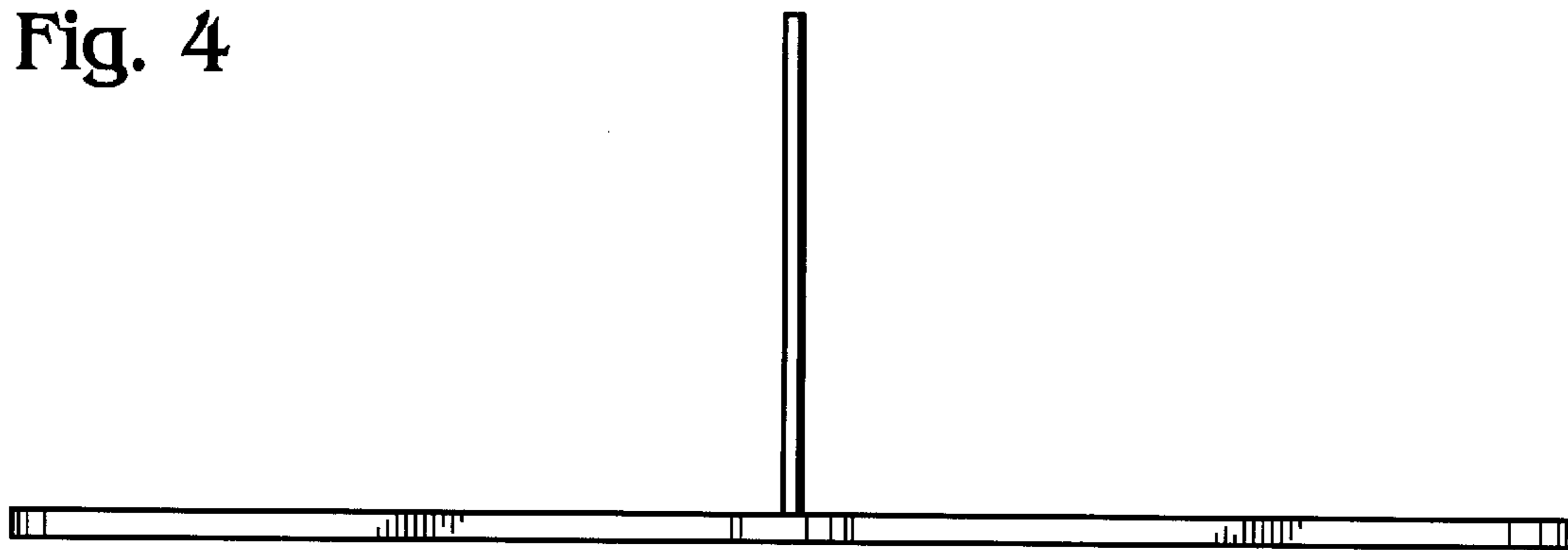

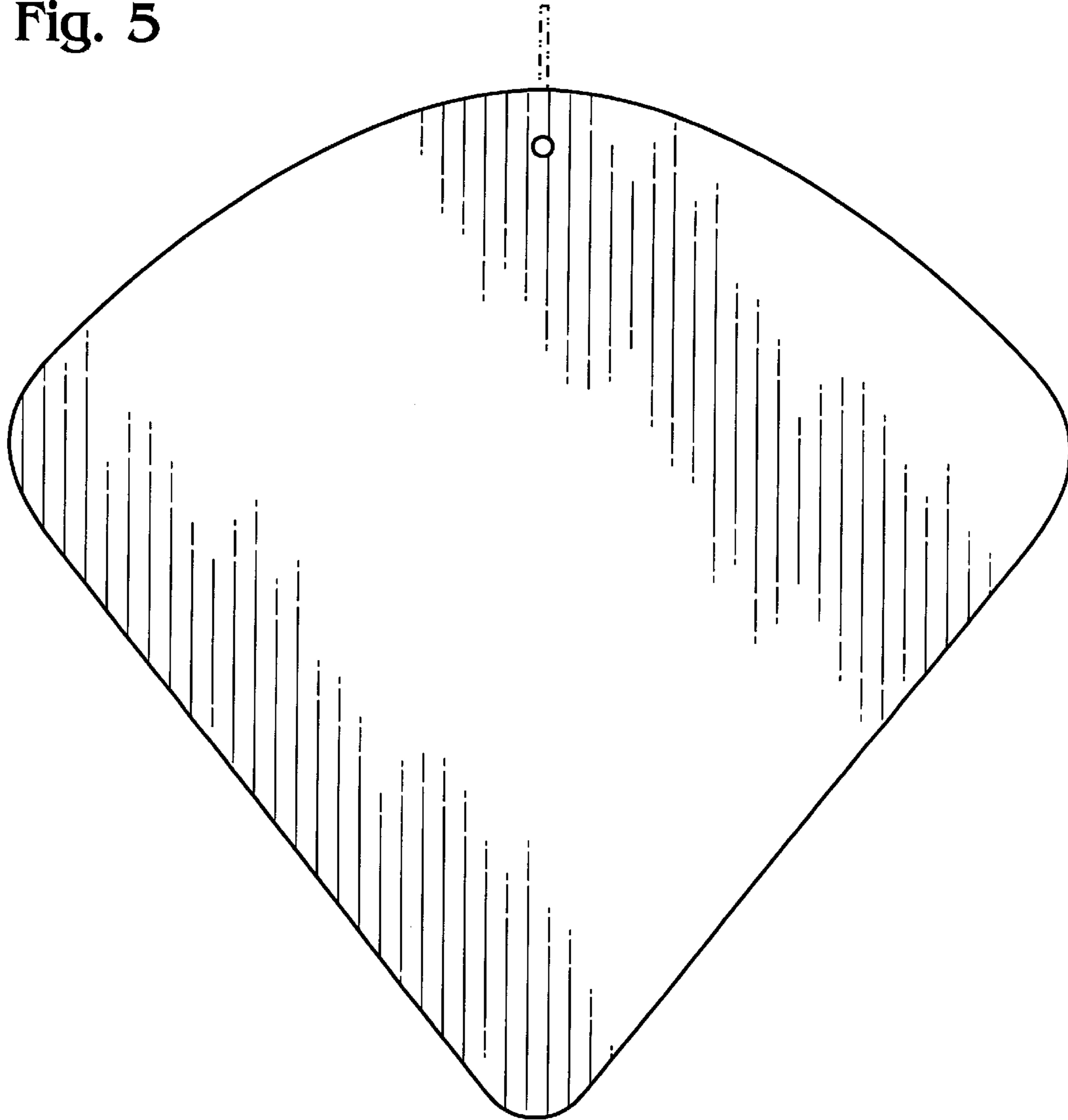

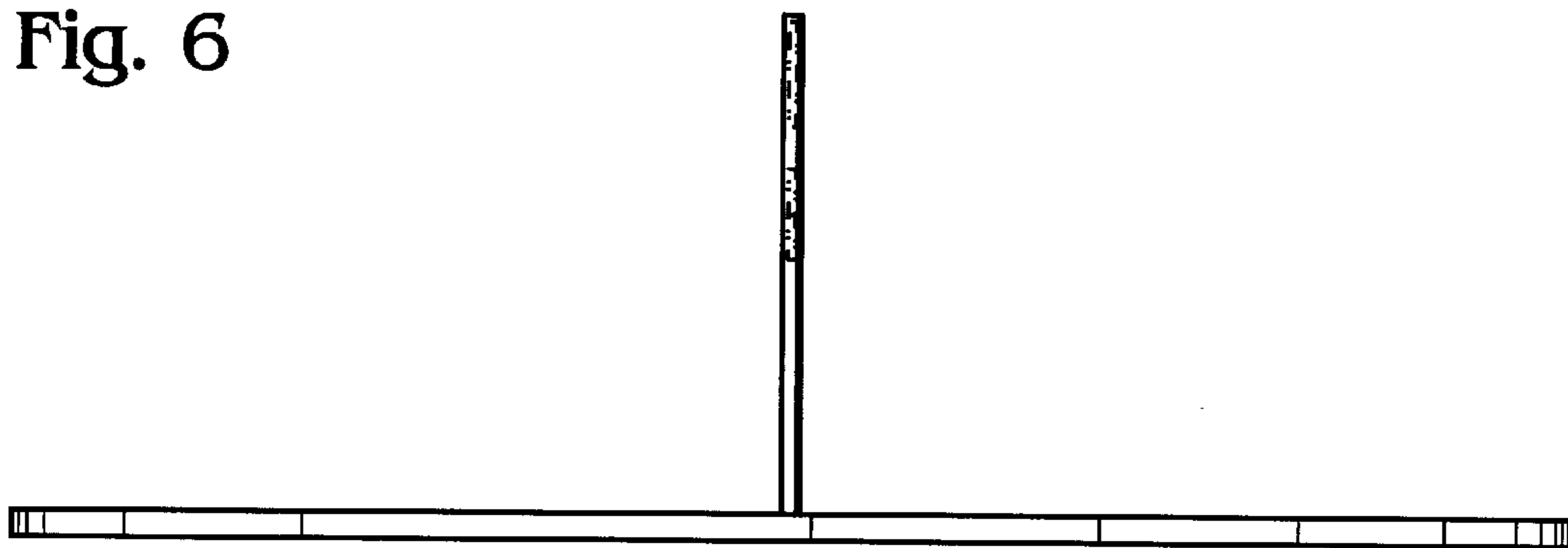

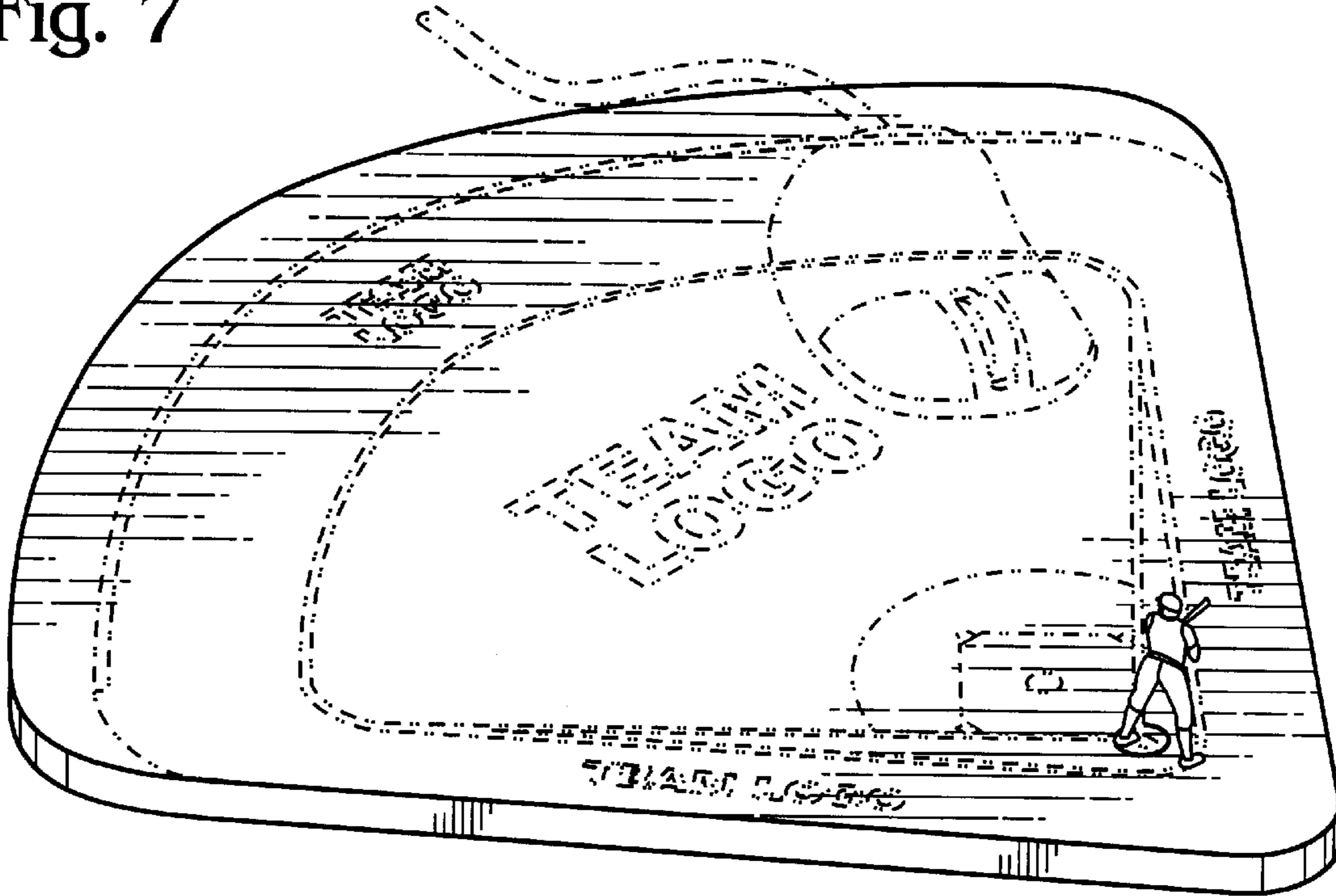

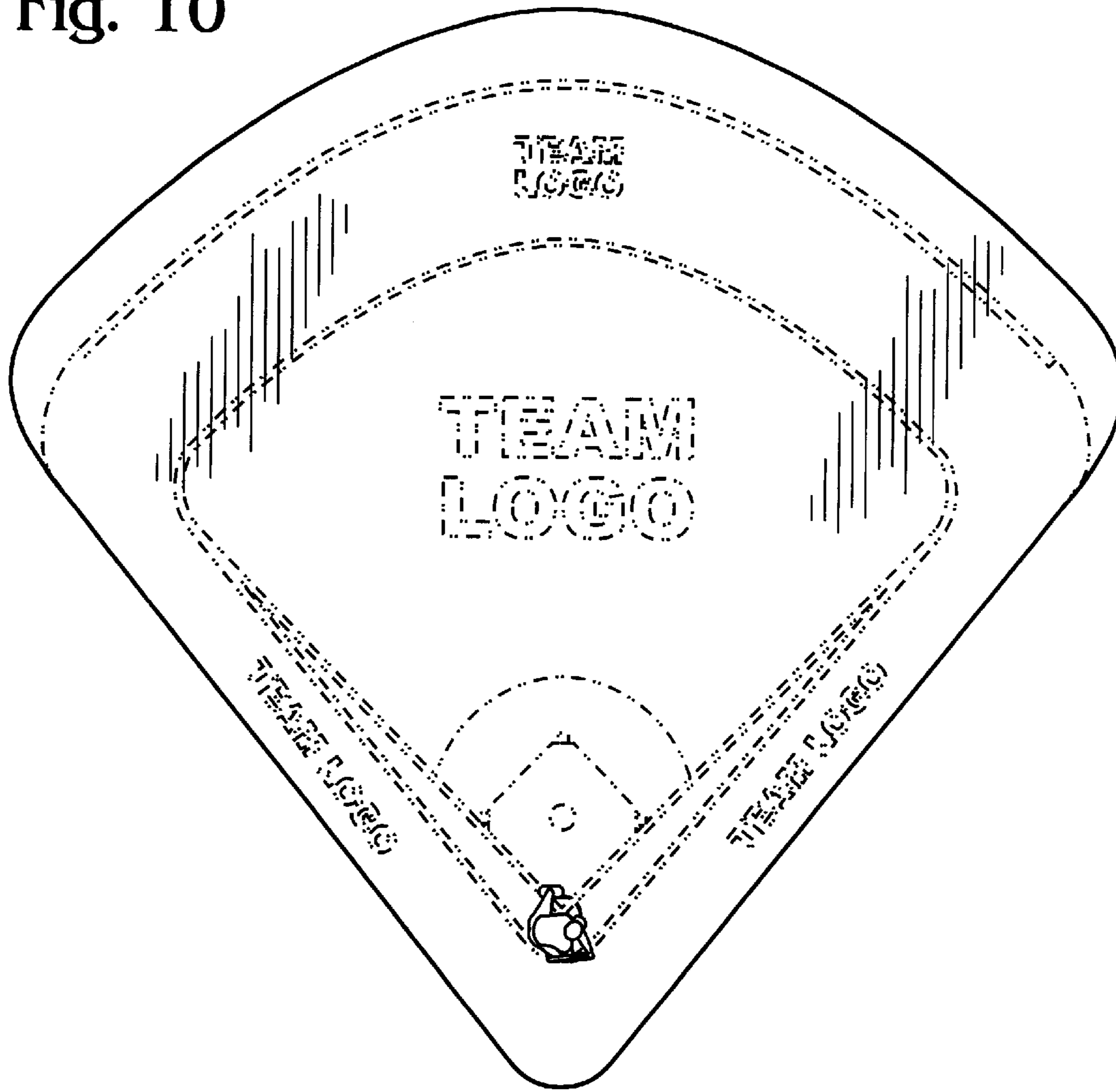

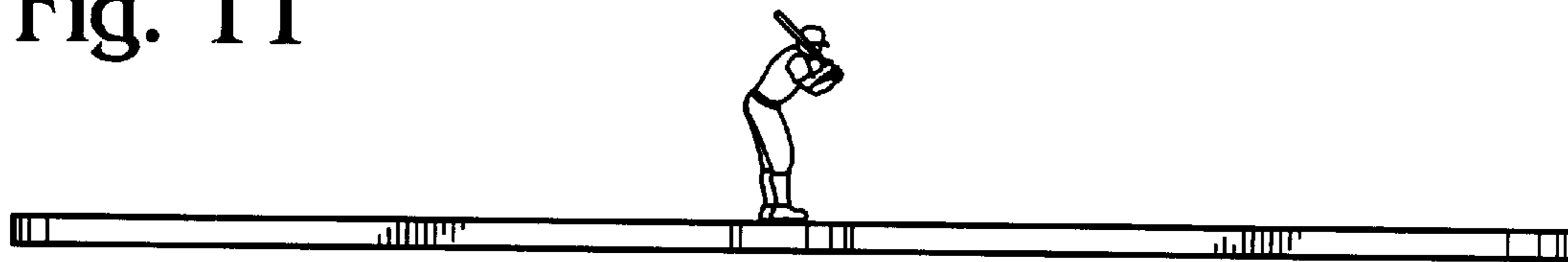

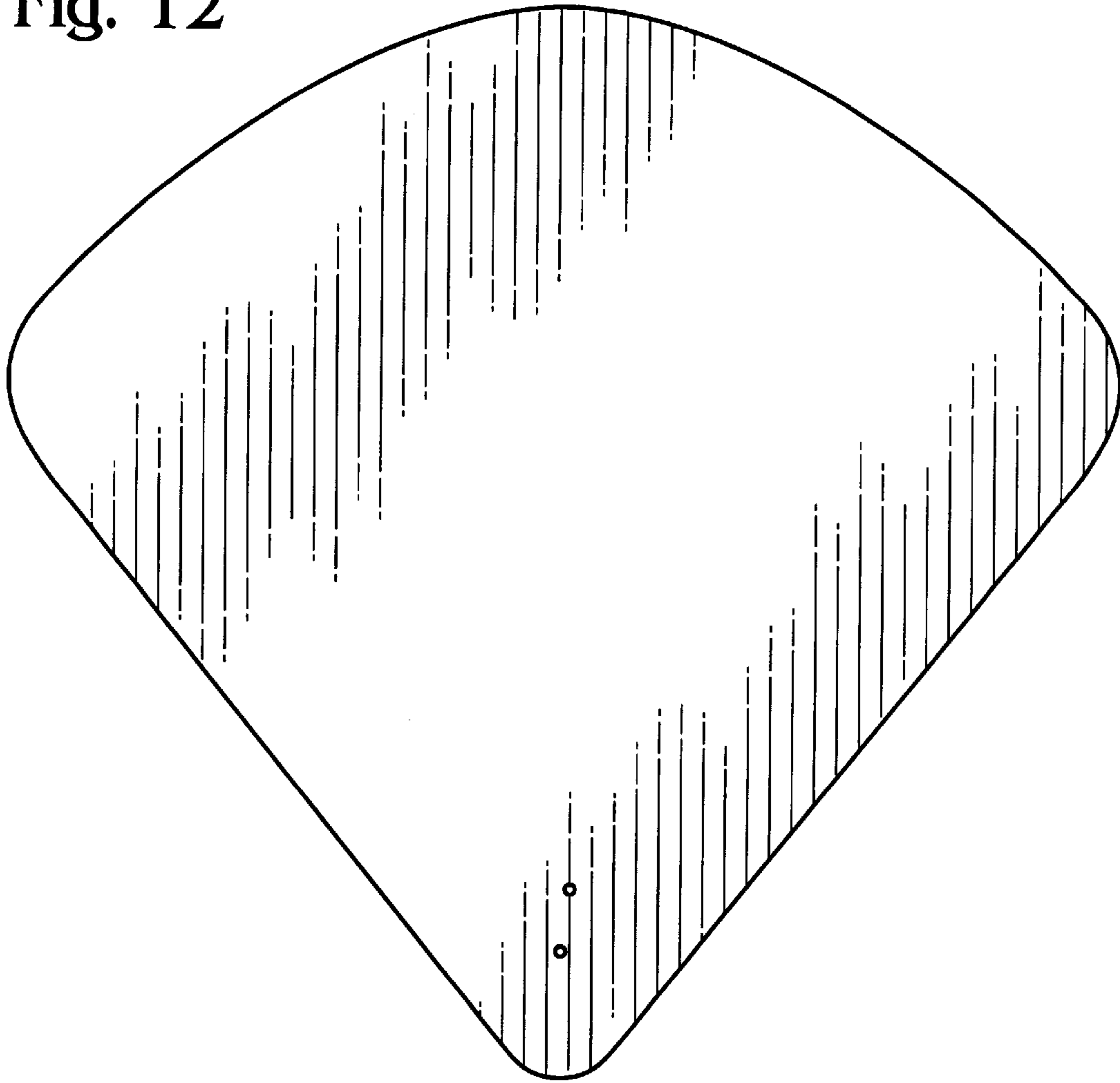

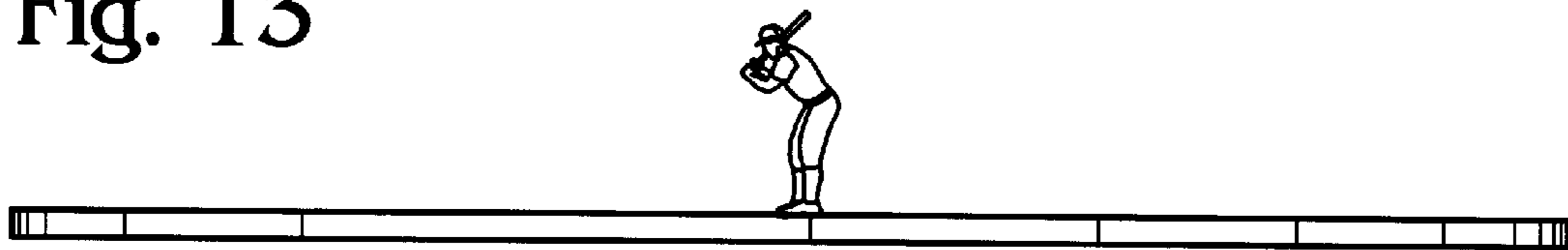

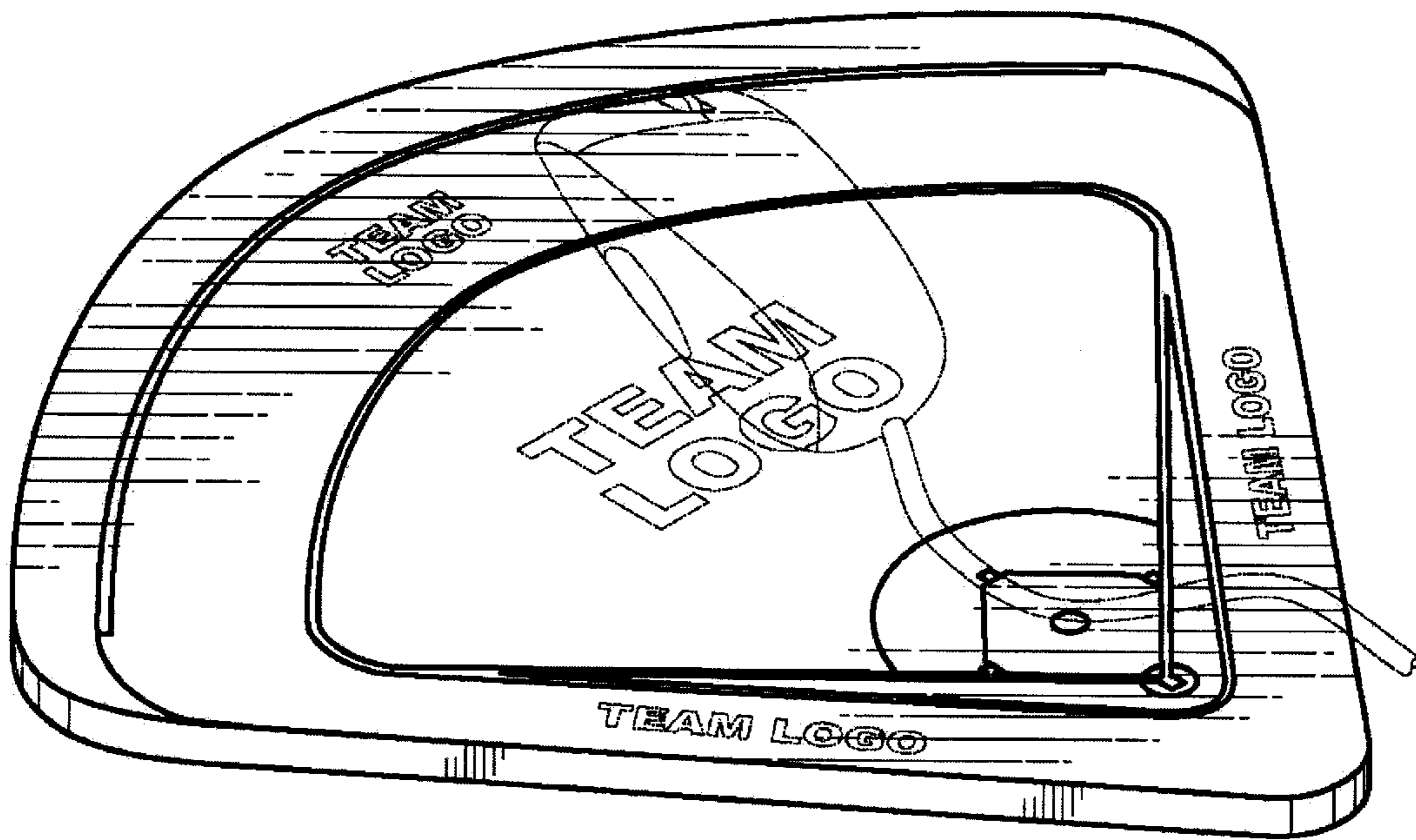
