(57) **CLAIM**

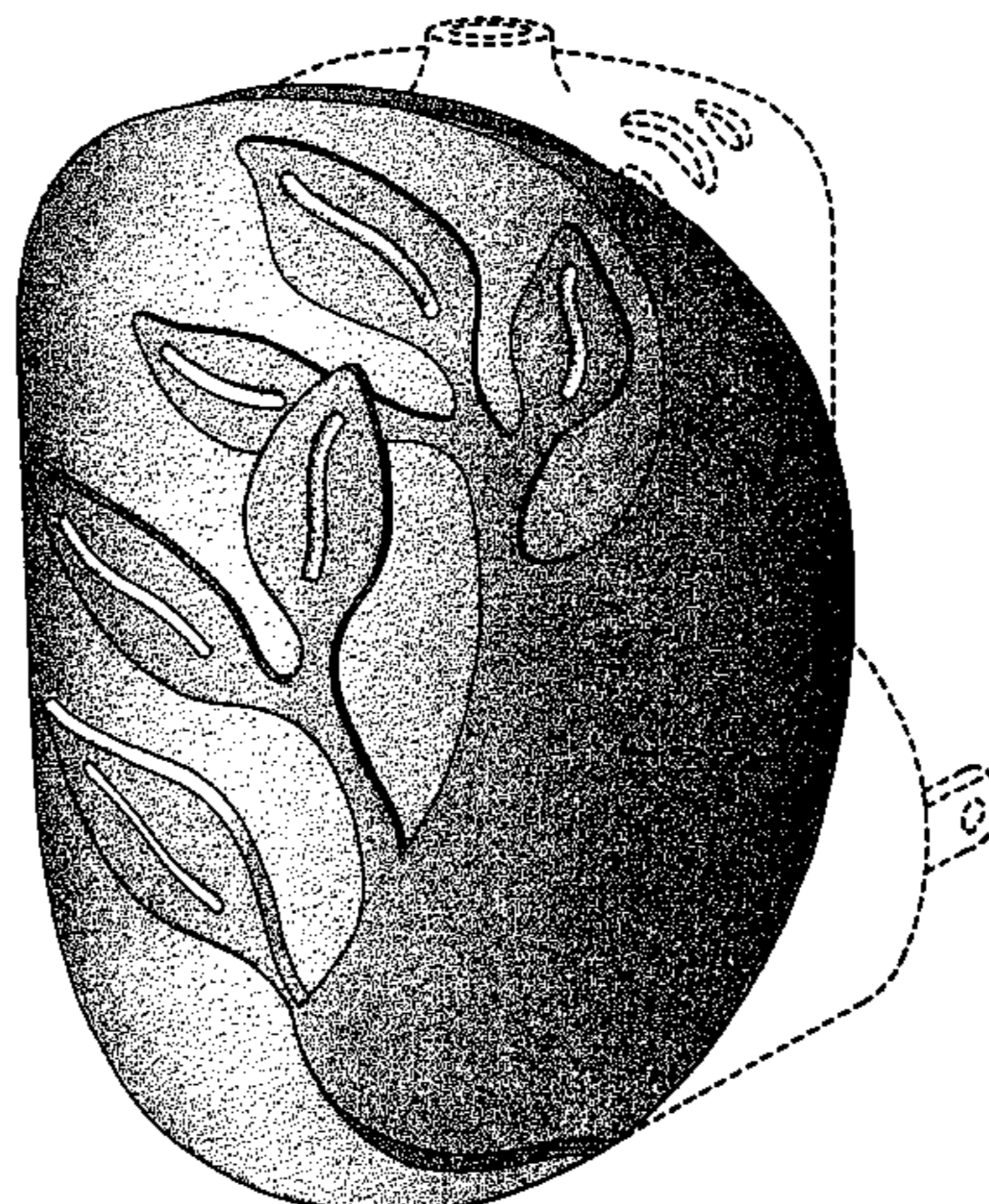
The ornamental design for a “diffuser,” as shown and

**DESCRIPTION**

FIG. 1 is a left side perspective view taken from the front  
and side of a diffuser, showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a rear view thereof.

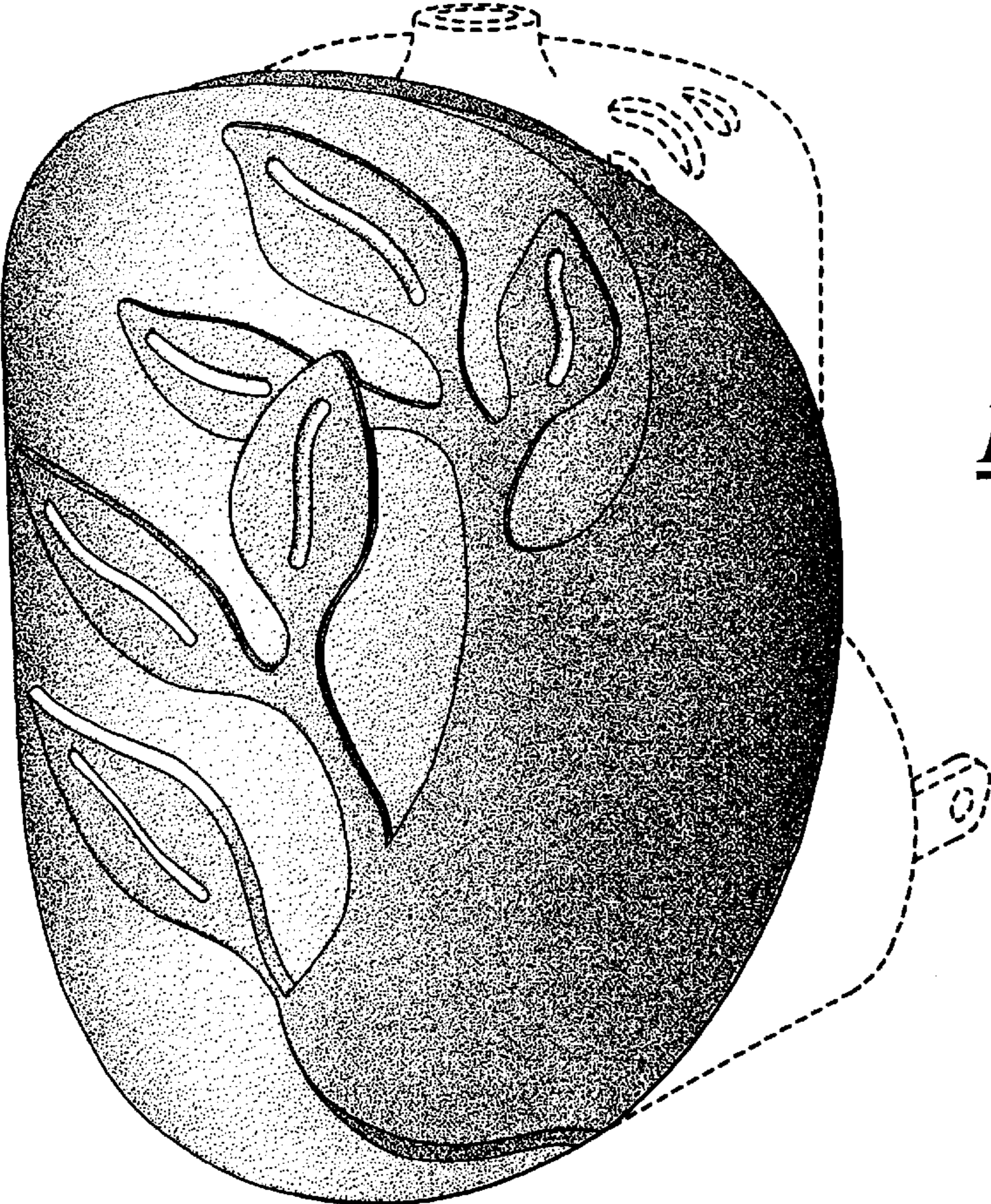

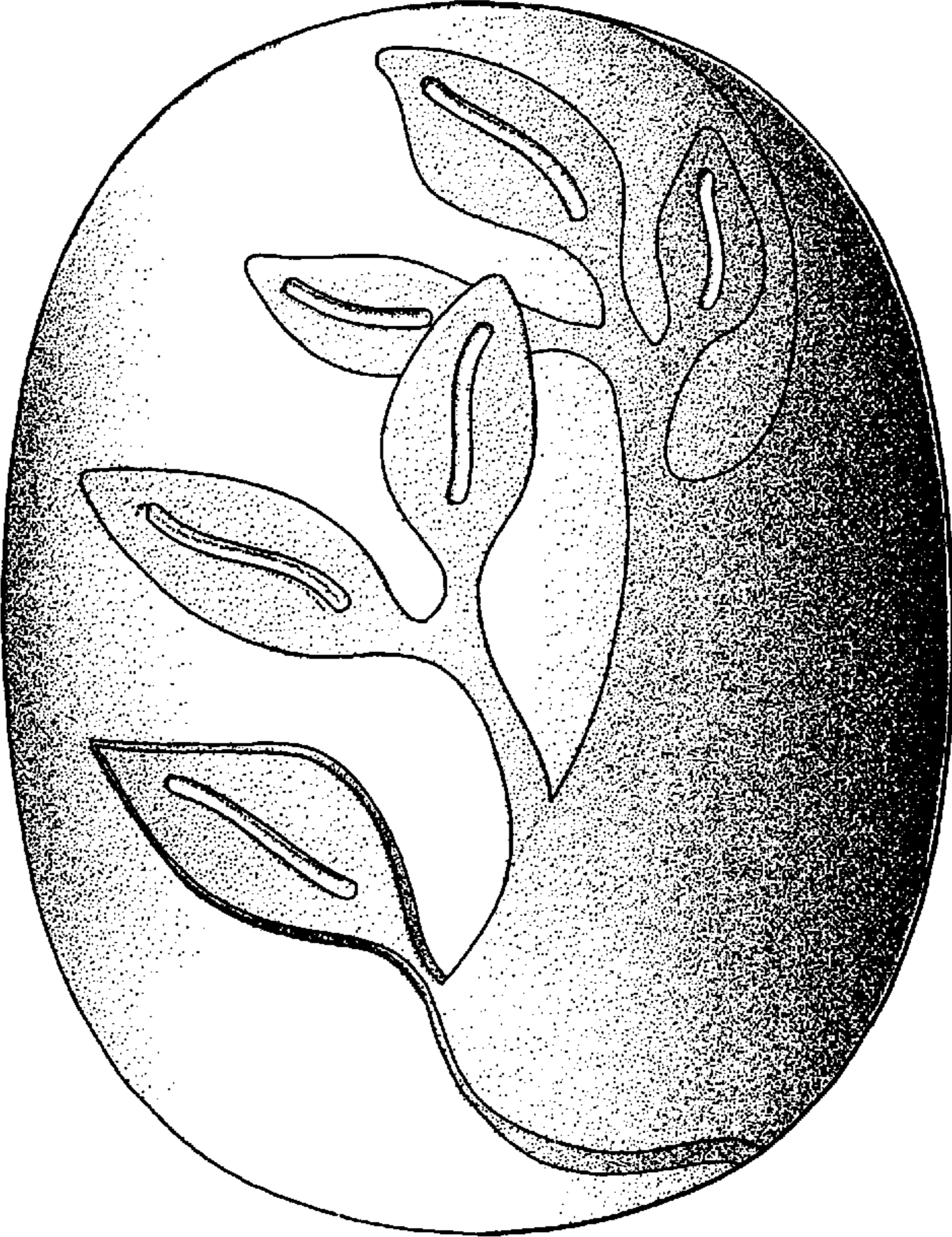

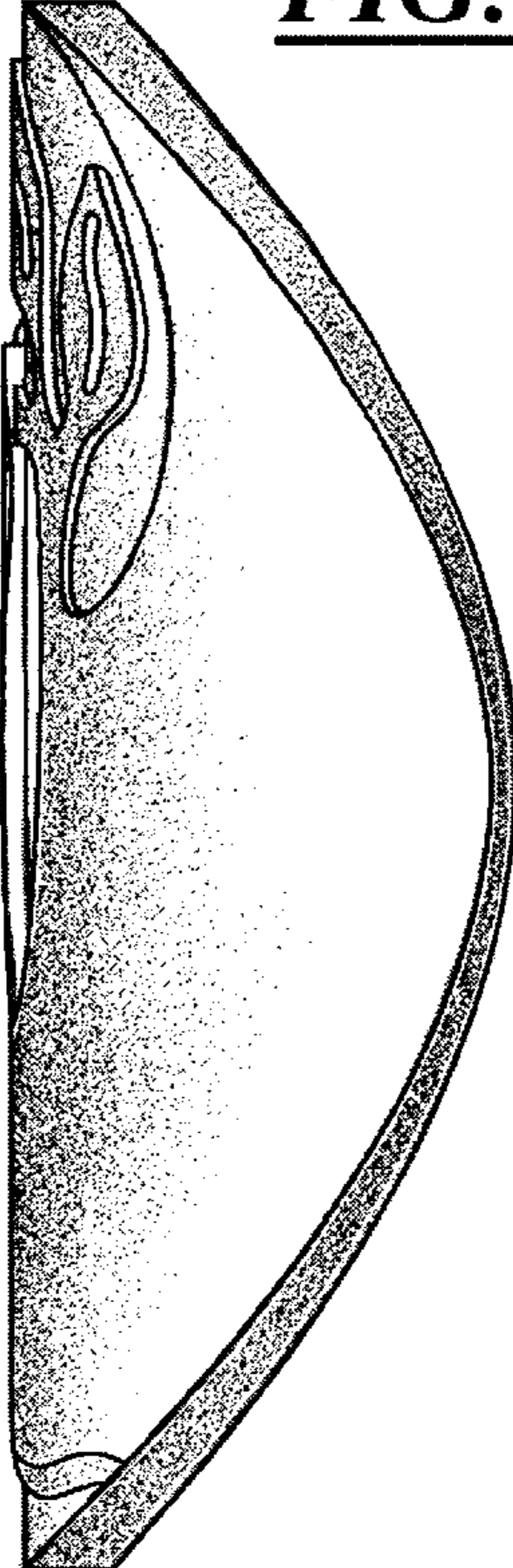

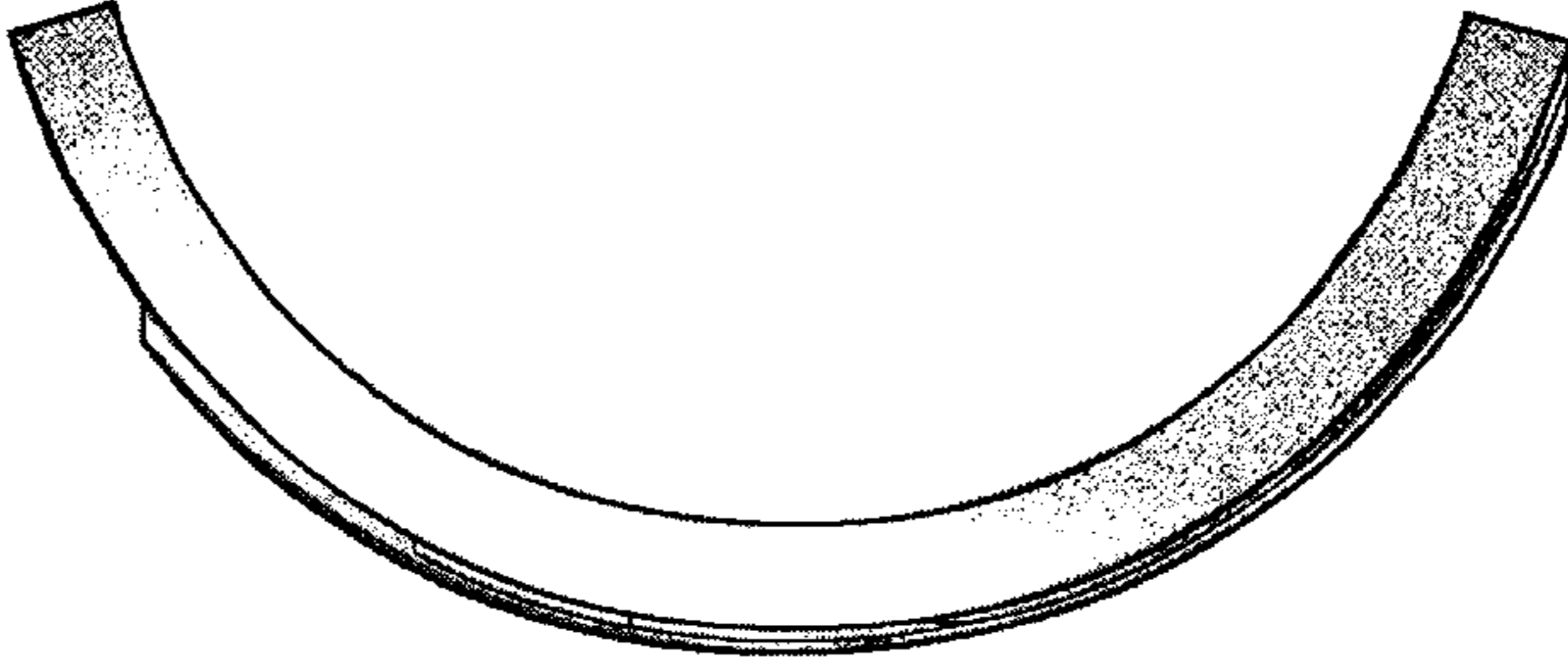

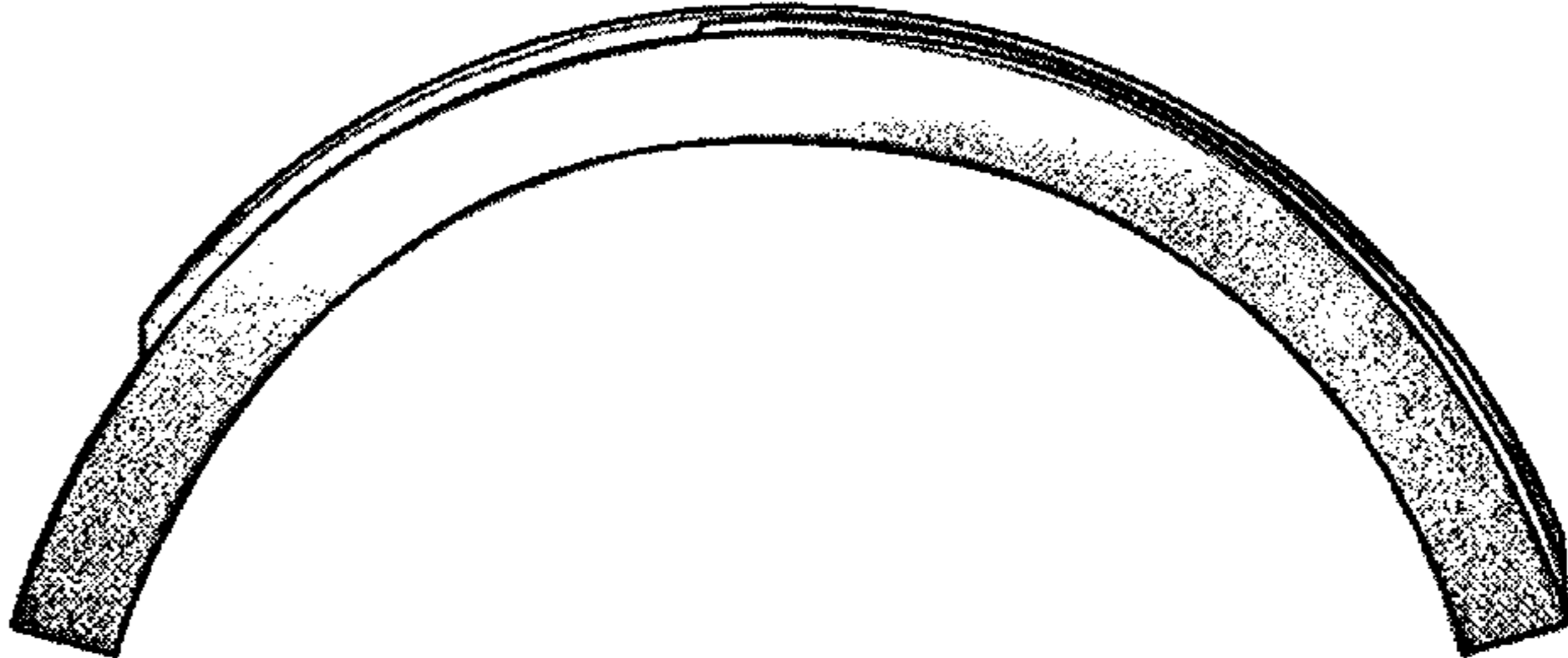

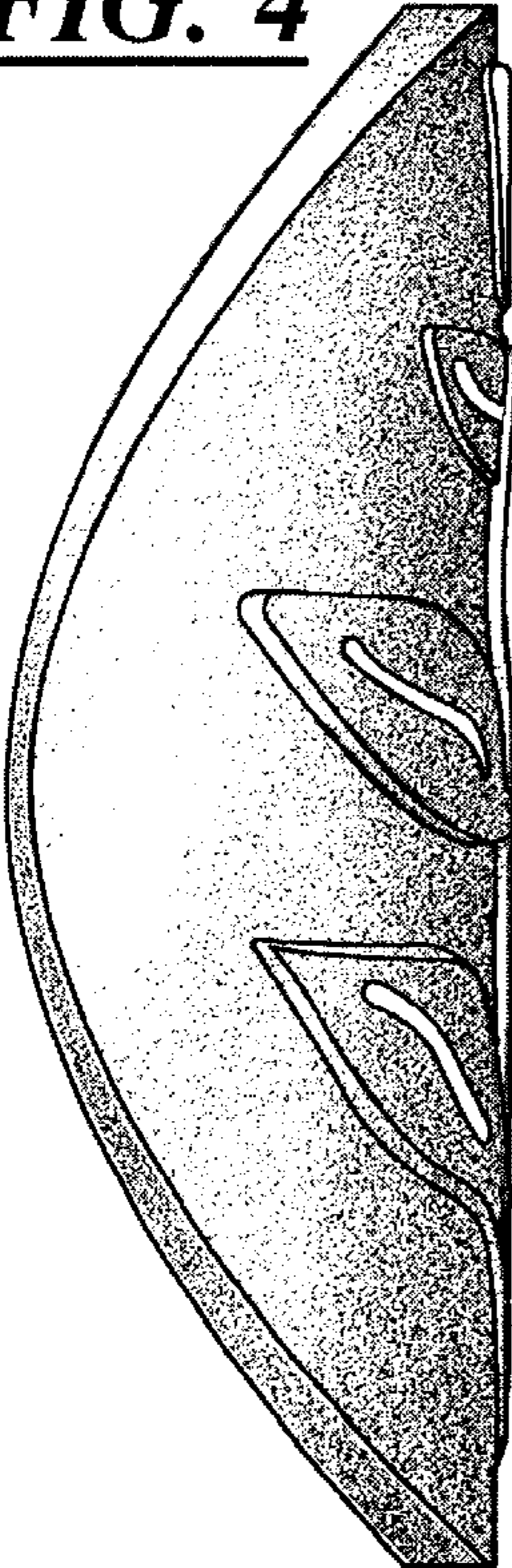
