(57) **CLAIM**

The ornamental design of the combined hammer and adjustable jaw wrench, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the combined hammer and adjustable jaw wrench of my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is an end elevational view of the left end thereof;

FIG. 6 is an end elevational view of the right end thereof;

FIG. 7 is a front elevational view of the combined hammer and adjustable jaw wrench of FIG. 1 with the jaw insert removed;

FIG. 8 is a rear elevational view of FIG. 7;

FIG. 9 is a top plan view of FIG. 7;

FIG. 10 is a bottom plan view of FIG. 7;

FIG. 11 is an end elevational view of the left end of FIG. 7;

FIG. 12 is an end elevational view of the right end of FIG. 7;

FIG. 13 is a side elevational view of the jaw insert for the combined hammer and adjustable jaw wrench of FIG. 1, the opposite side being a mirror image thereof;

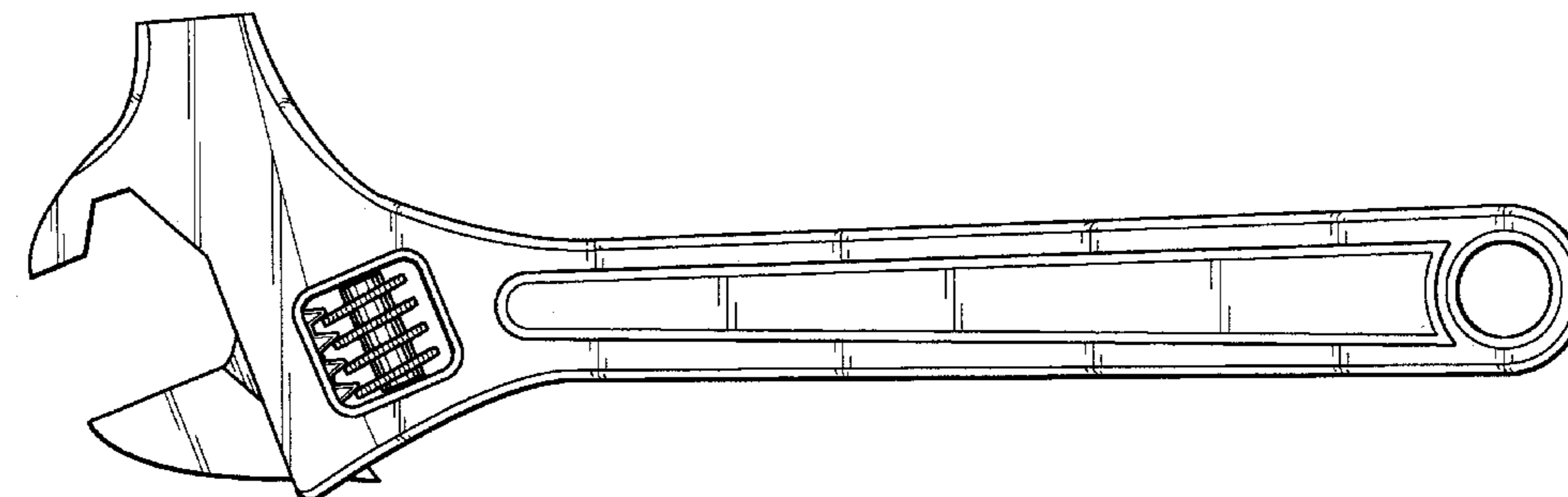
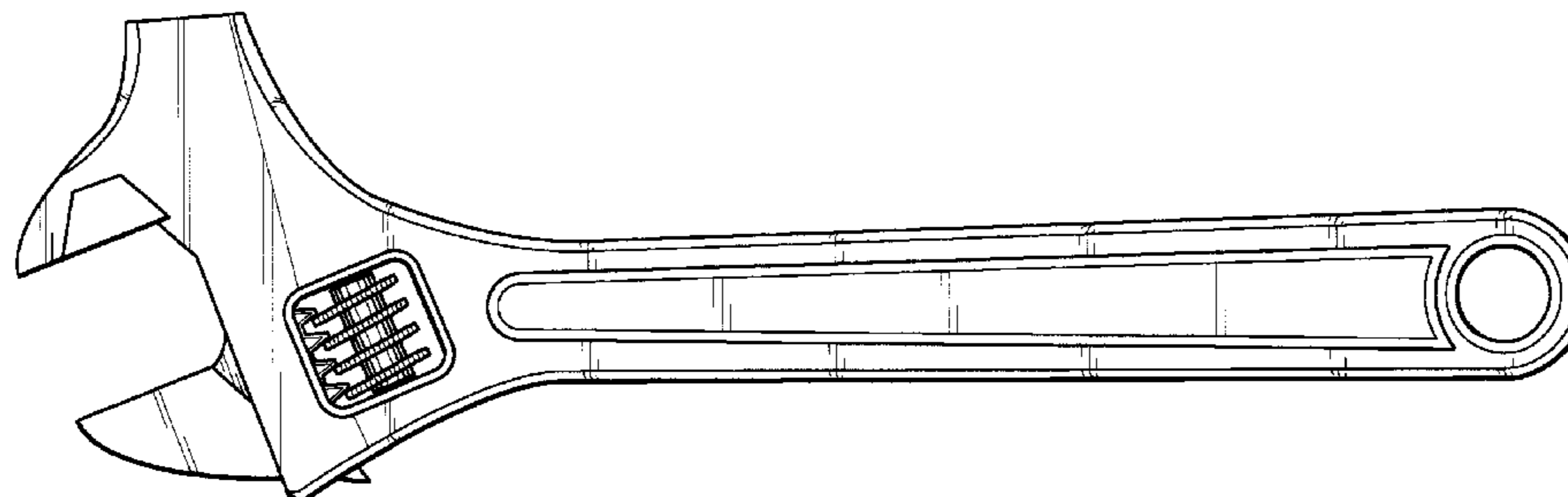
FIG. 14 is an end elevational view of FIG. 13, the opposite end being a mirror image thereof;

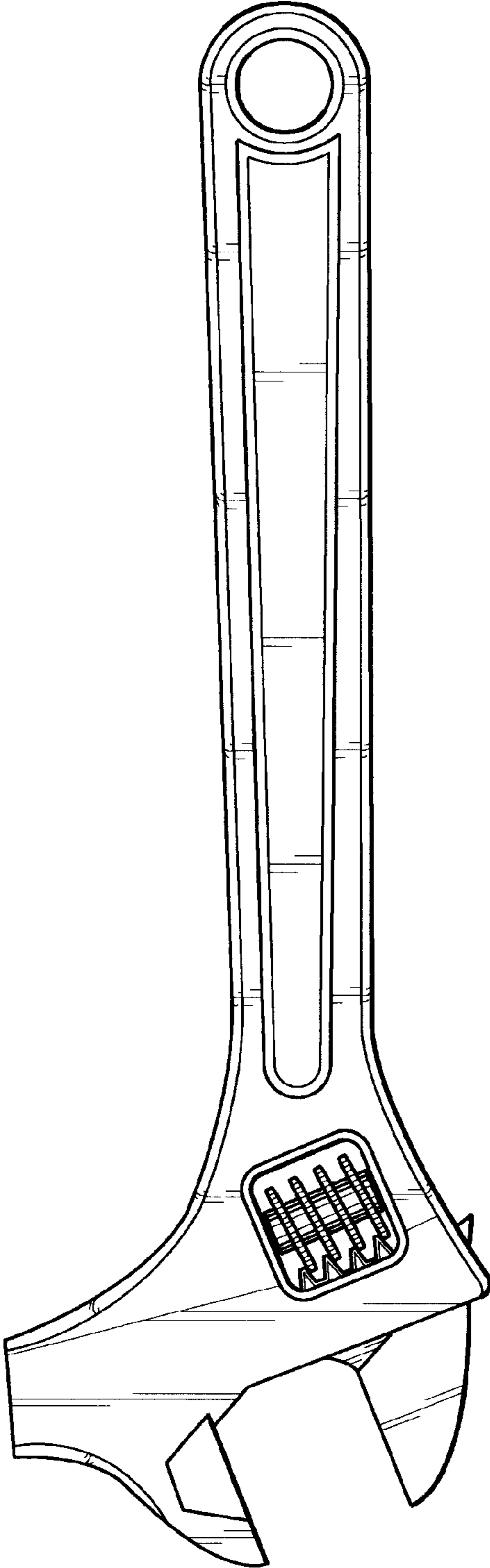

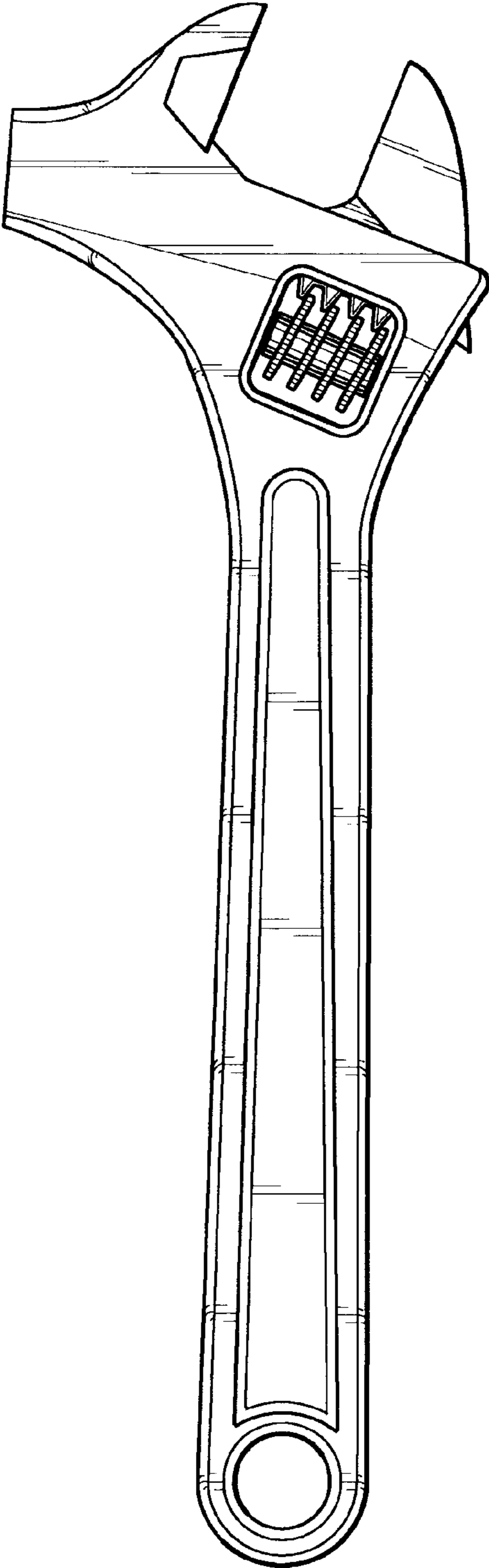

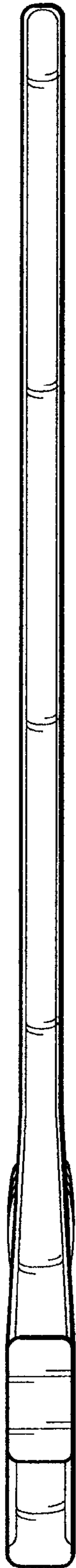

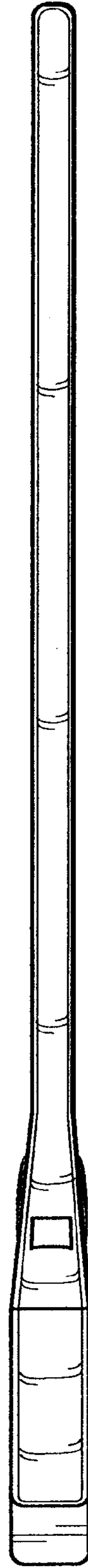

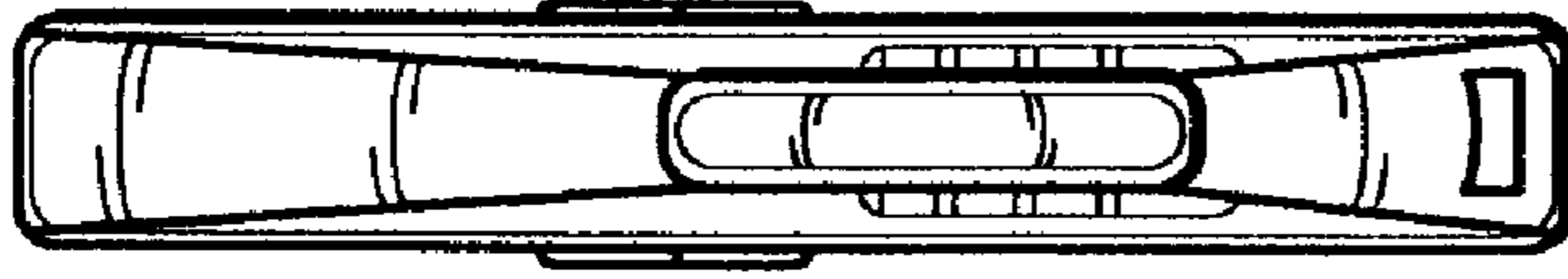

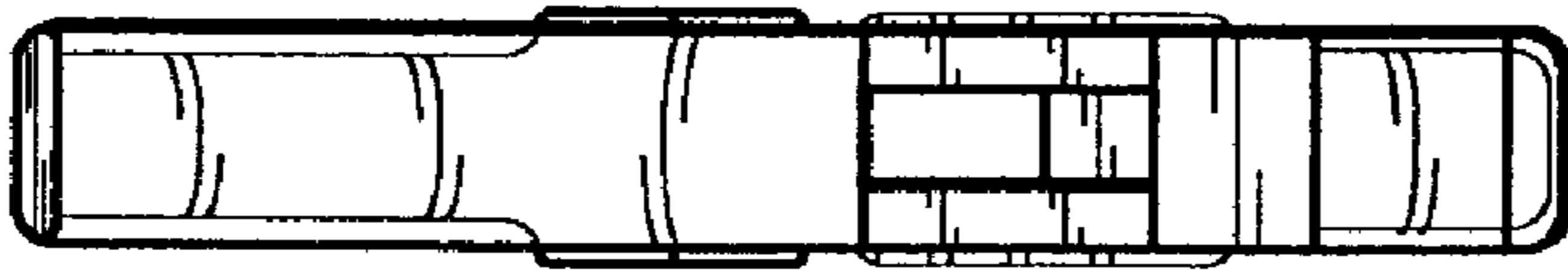

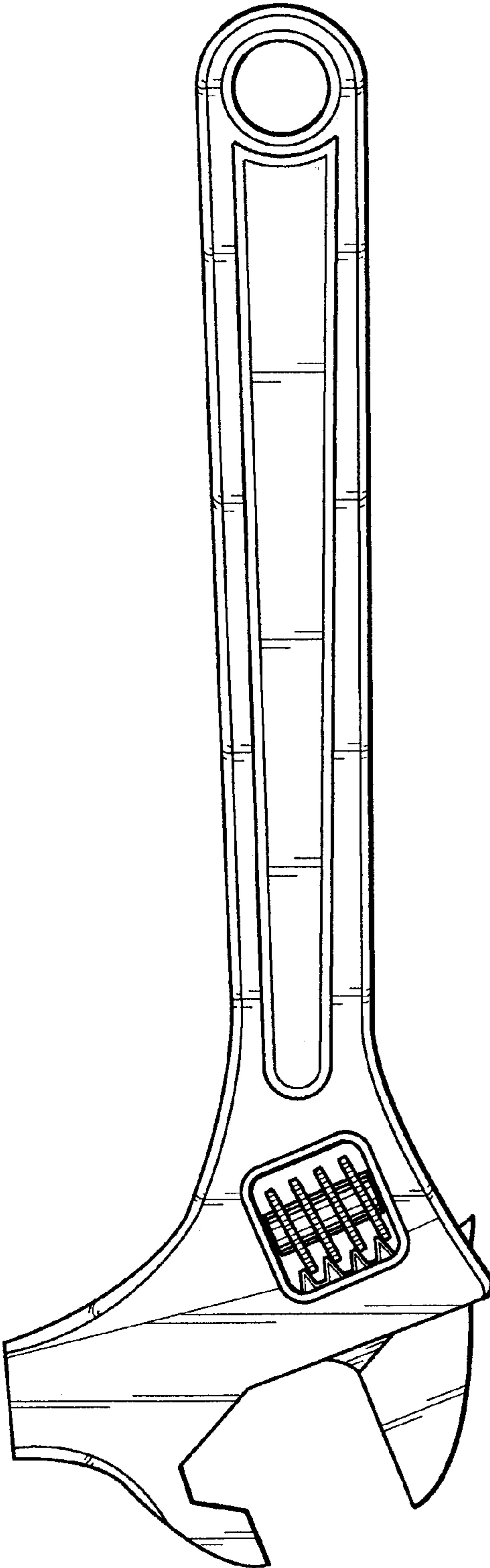

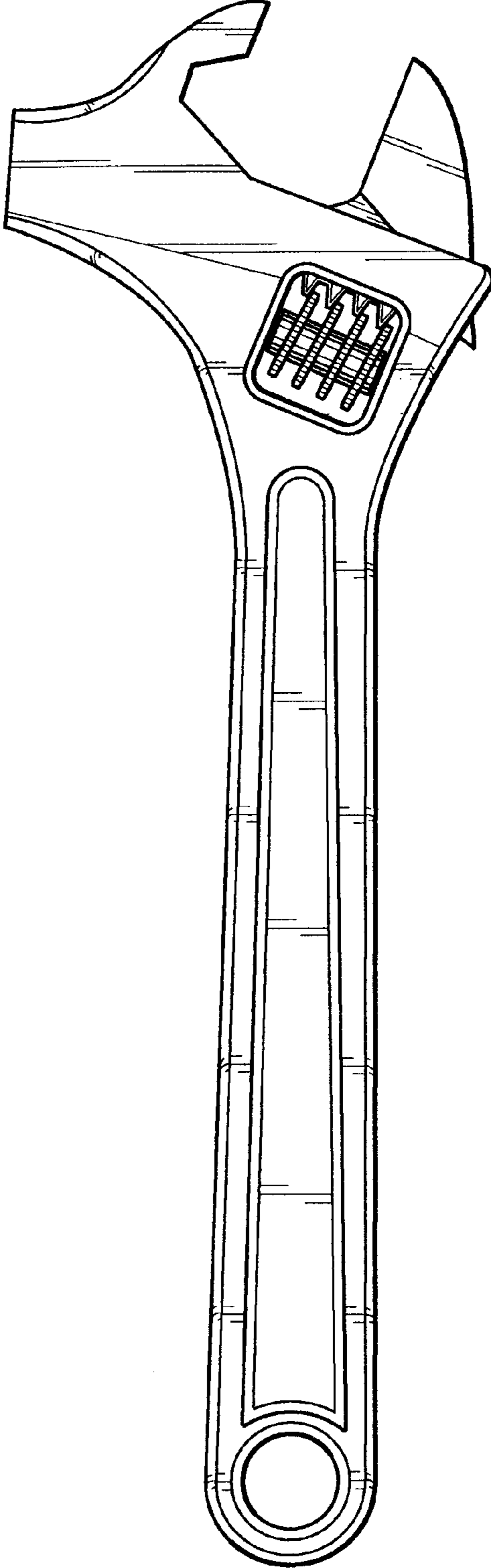

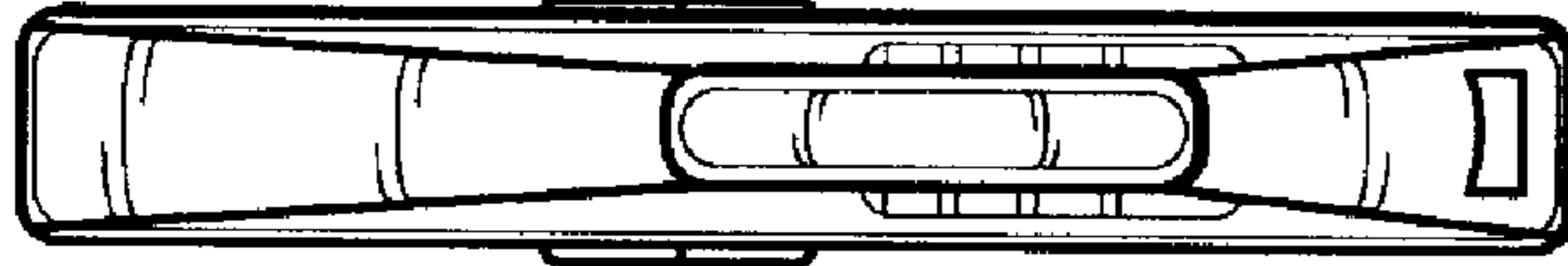

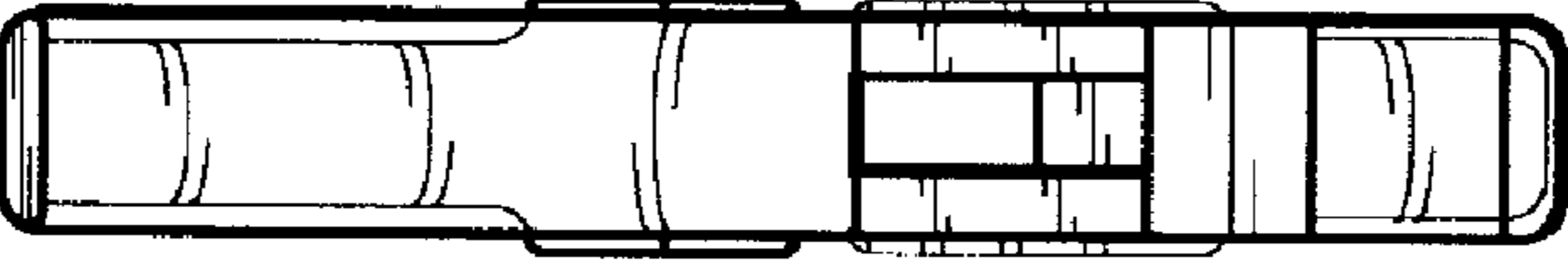

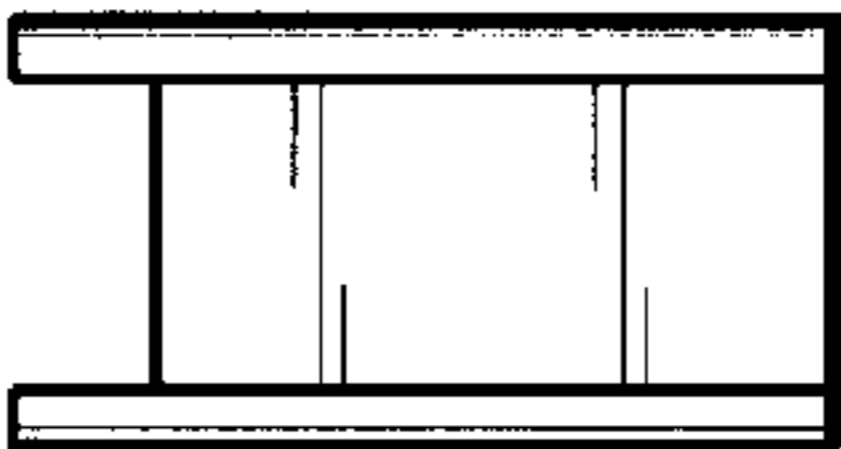

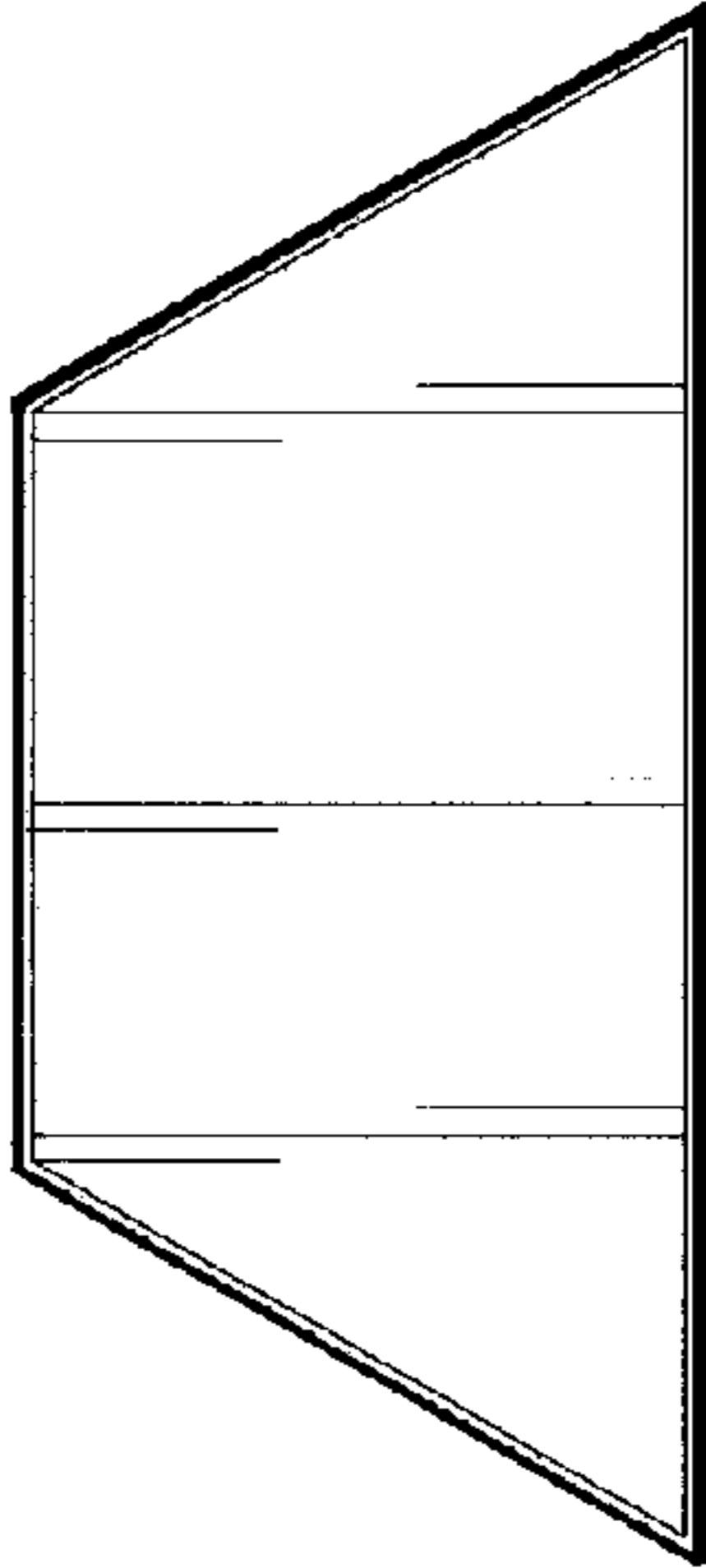

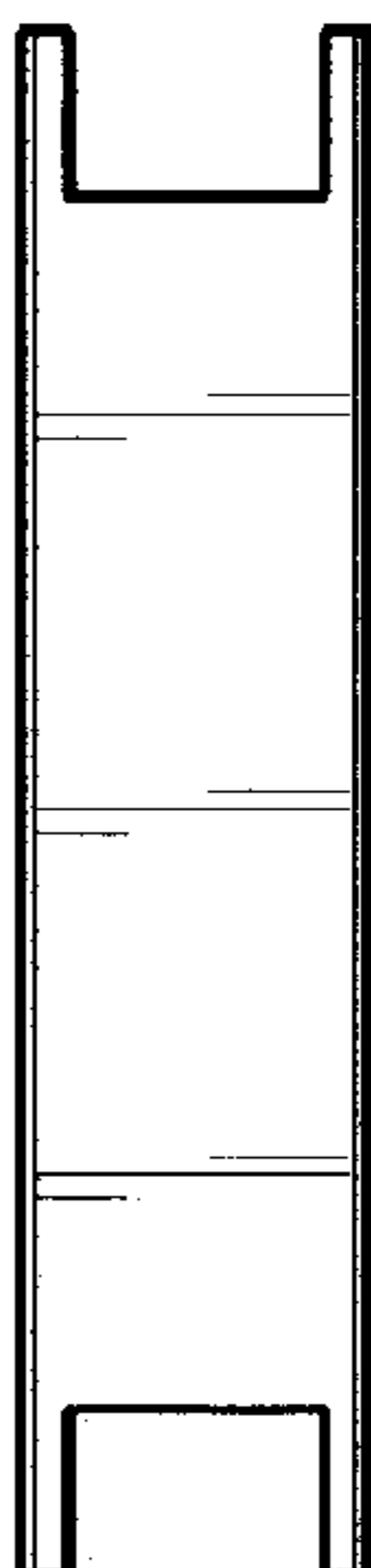
