**DESCRIPTION**

FIG. 1 is a front perspective view of the angle grinder showing our new design;

FIG. 2 is a right side elevational view of the angle grinder of FIG. 1;

FIG. 3 is a left side elevational view of the angle grinder of FIG. 1;

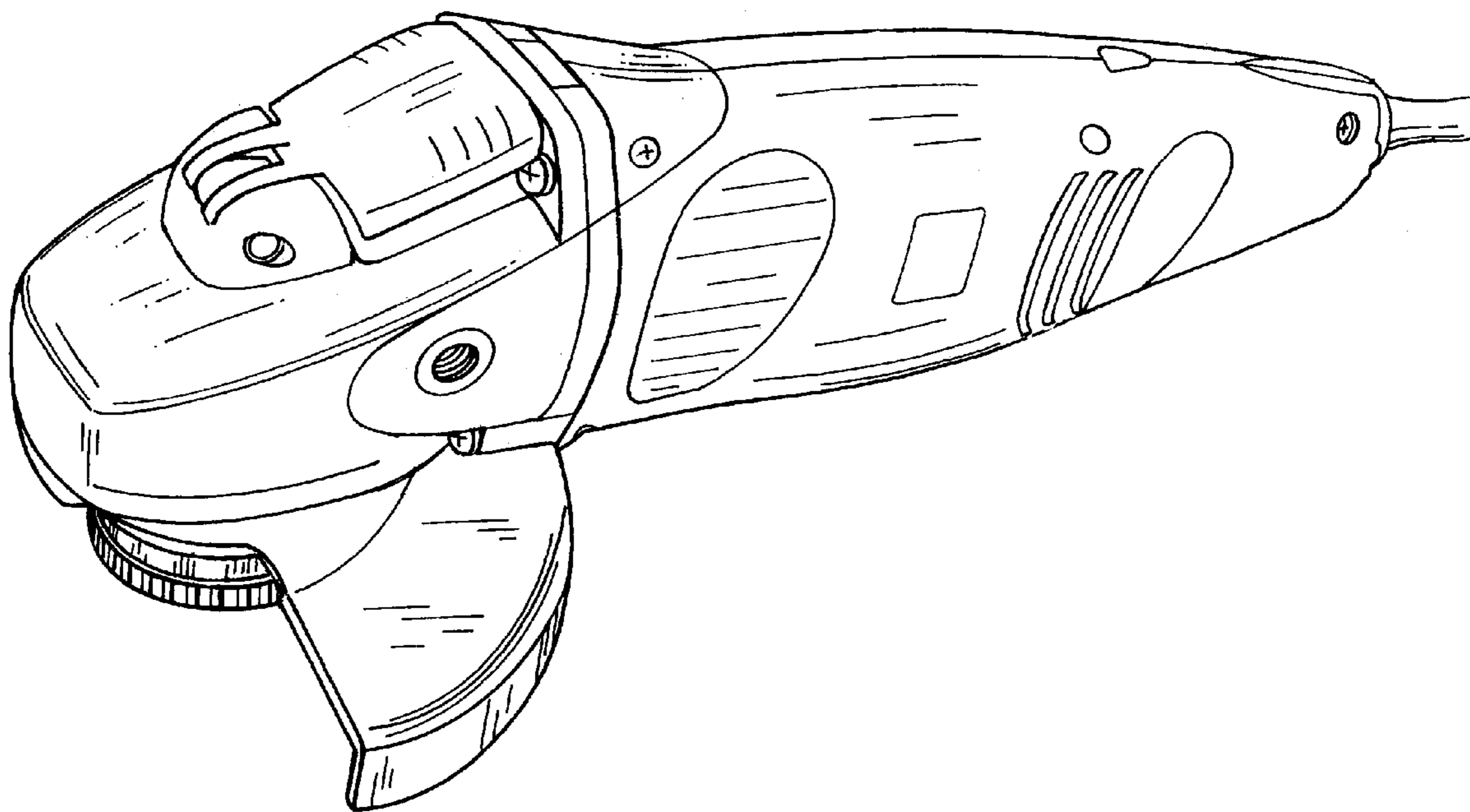
FIG. 4 is a top plan view of the angle grinder of FIG. 1;

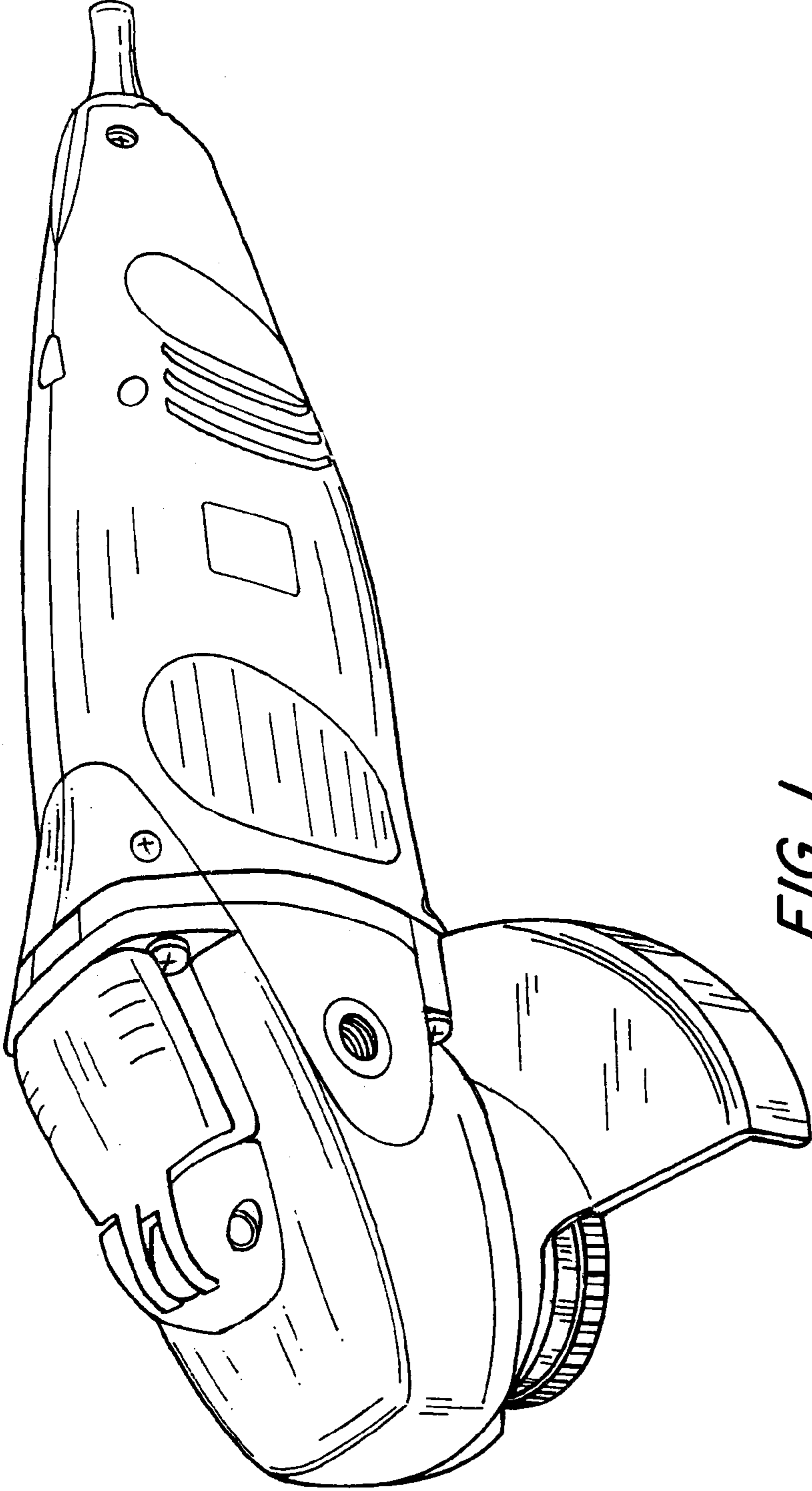

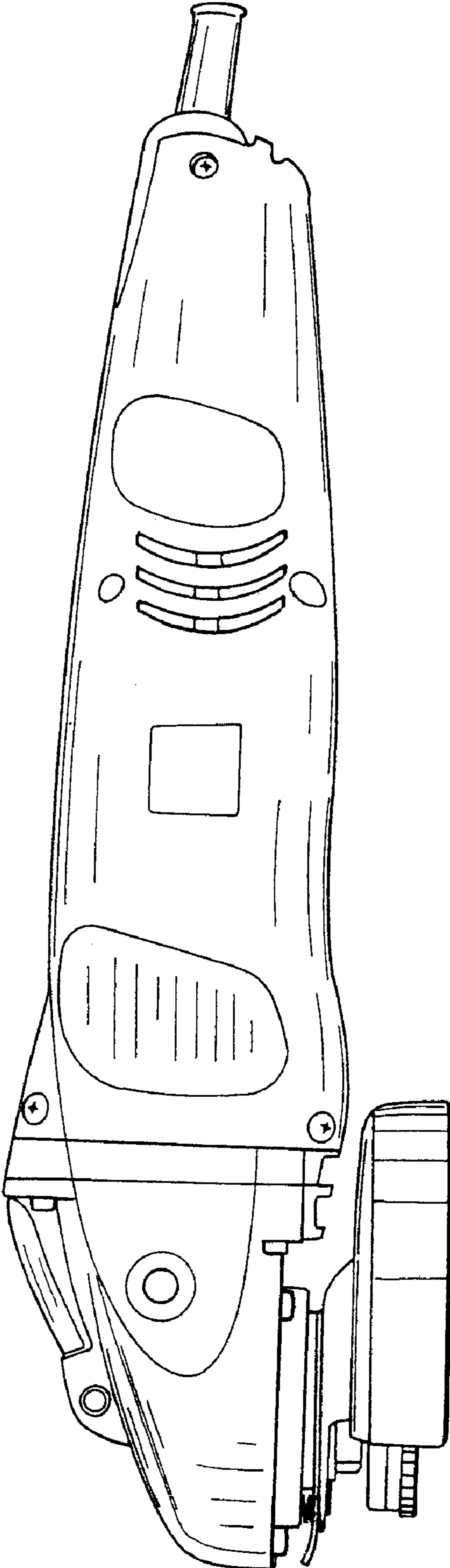

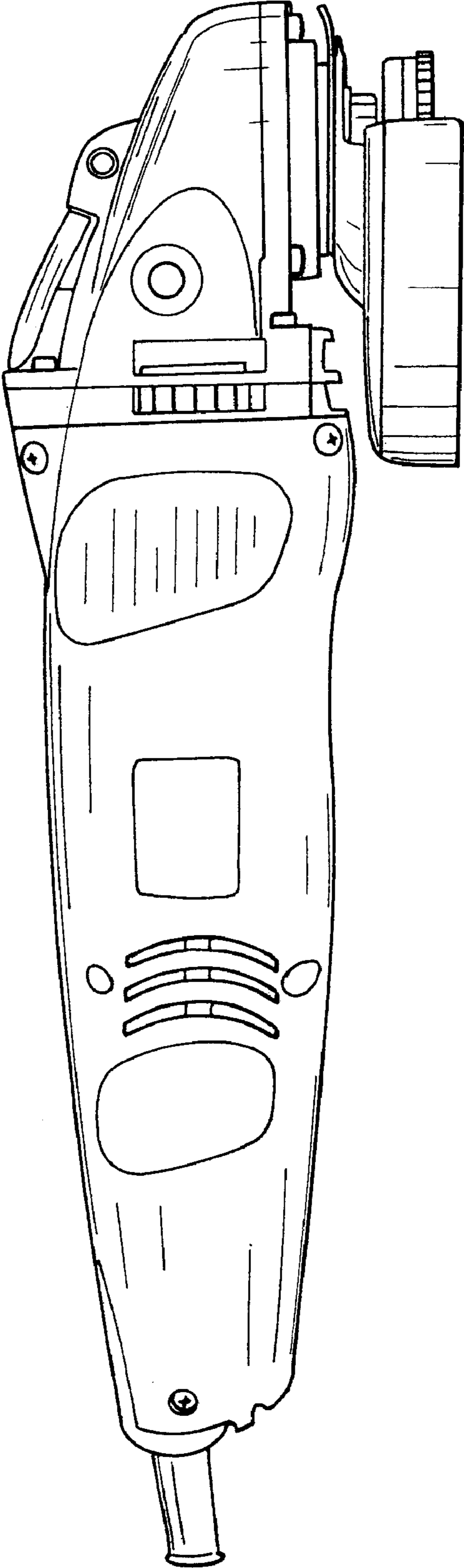
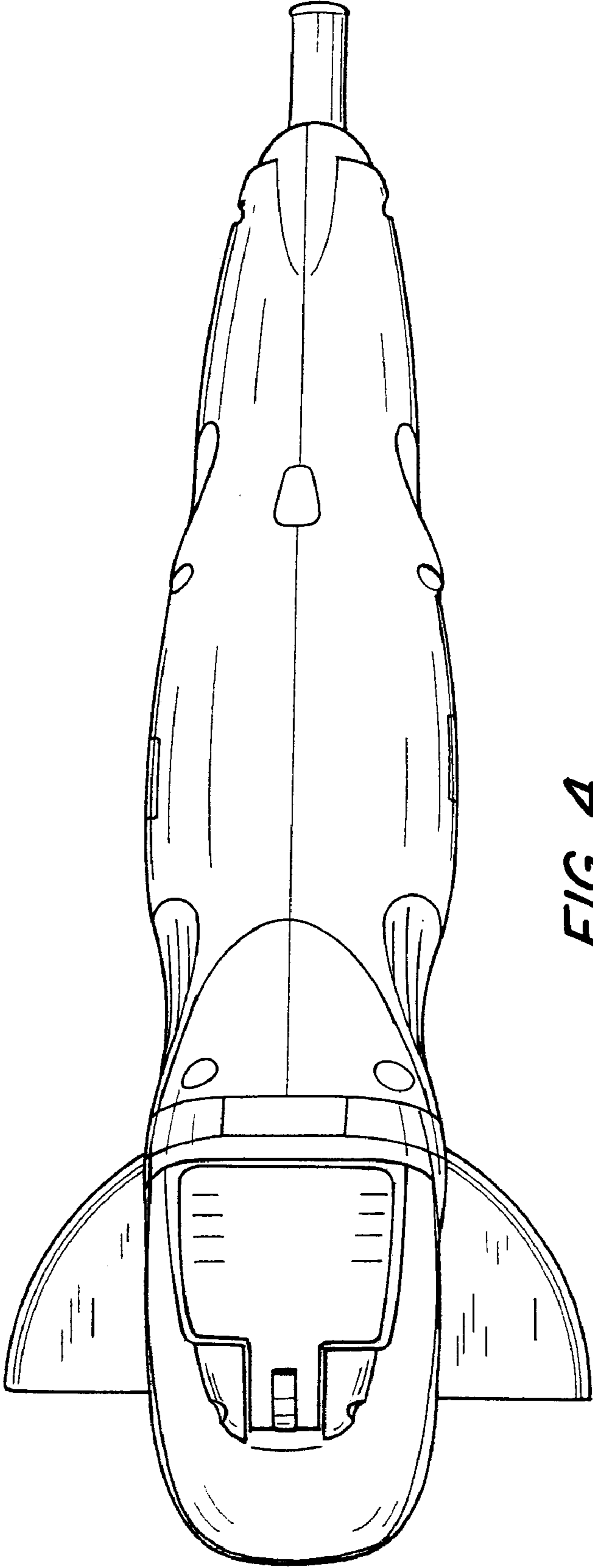

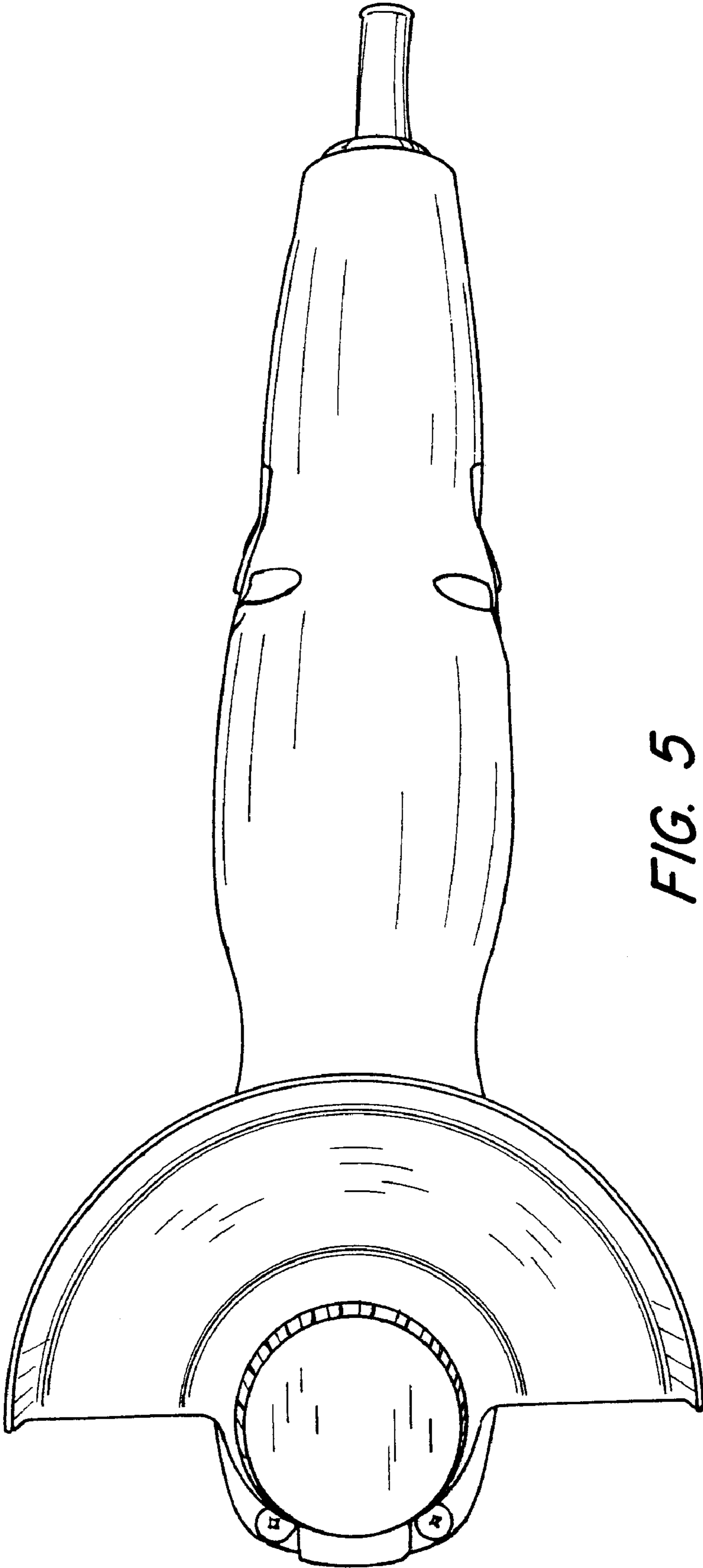
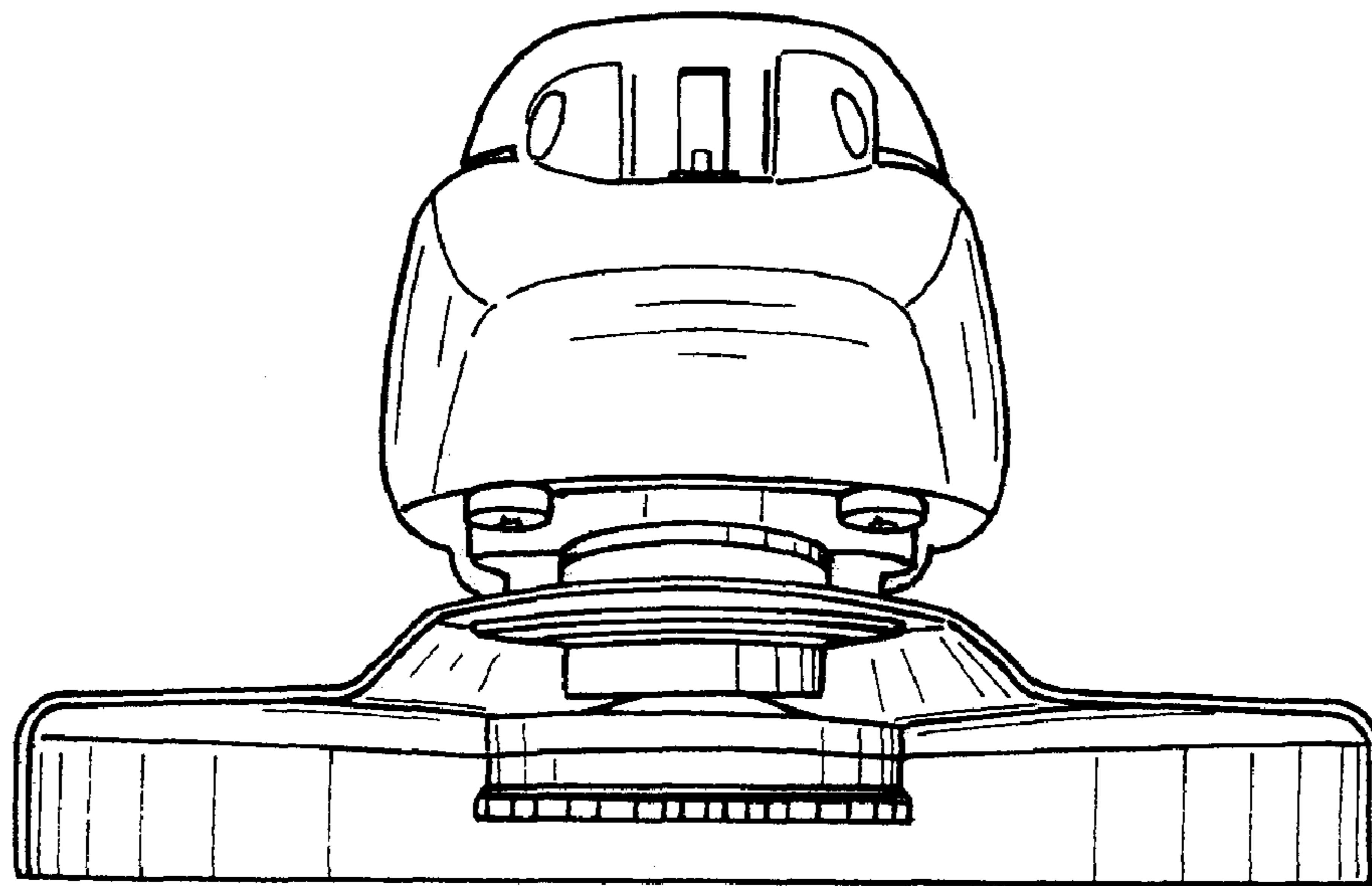
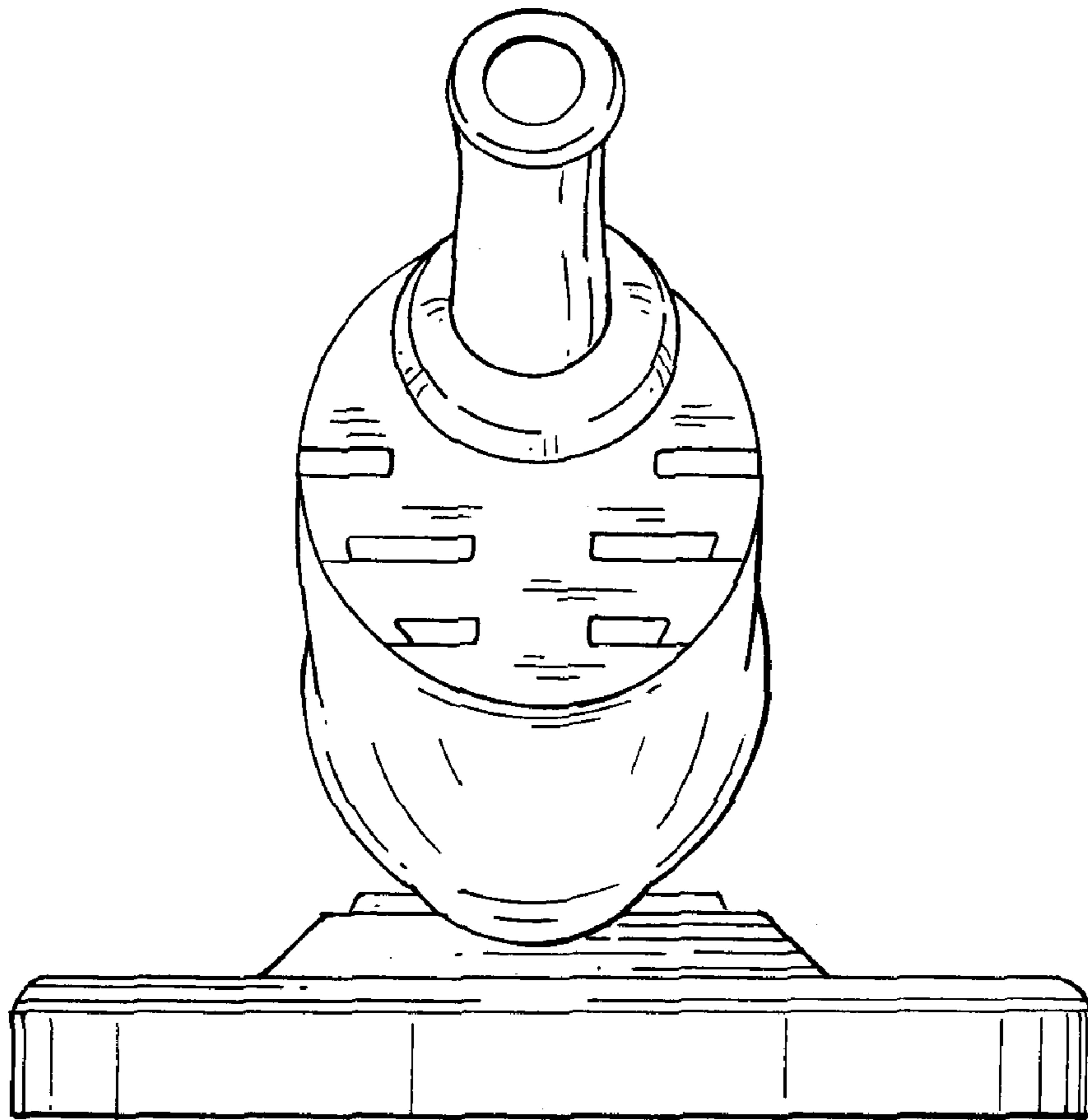
