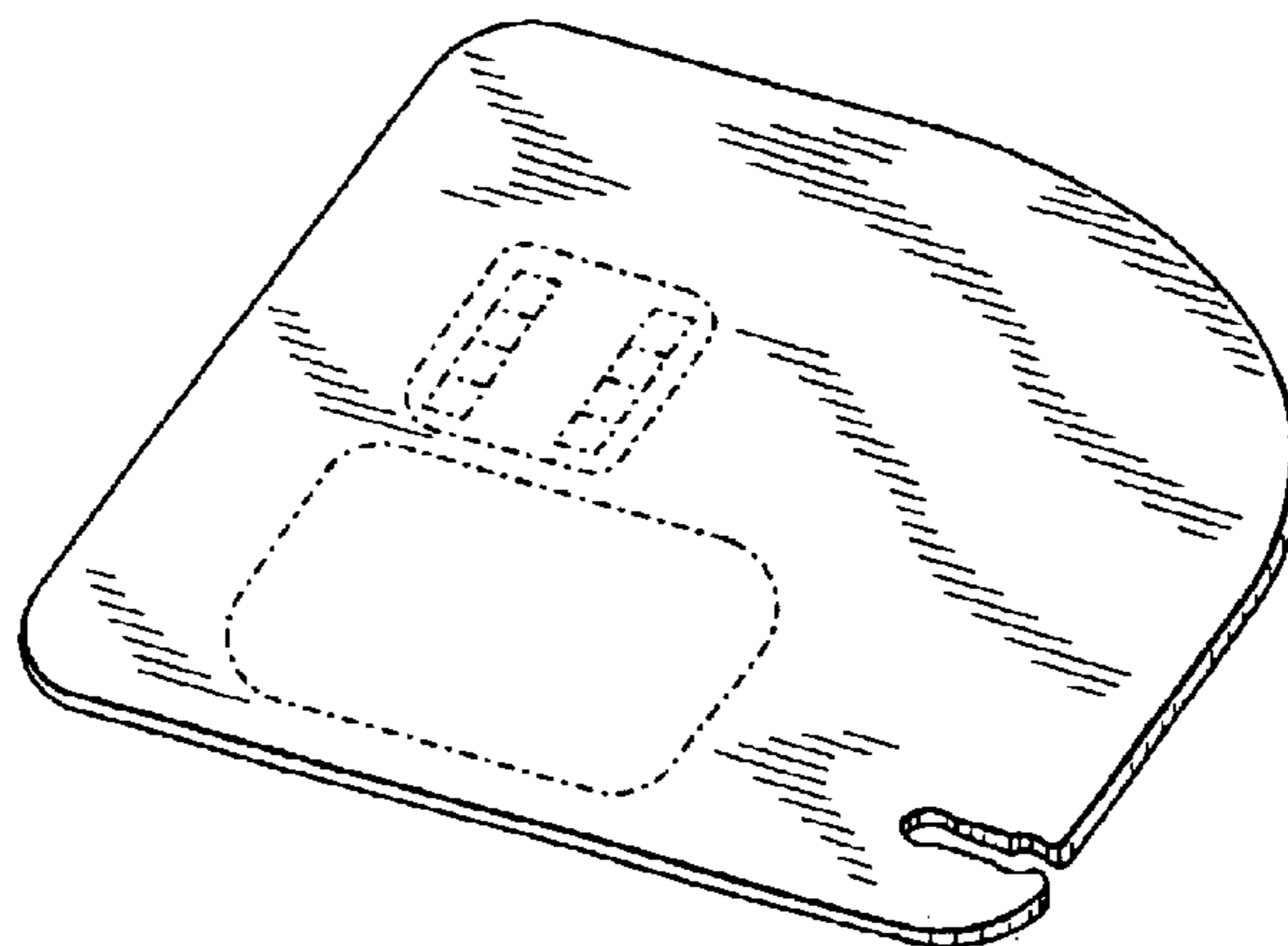
The ornamental design for a card with notch, as shown and described.

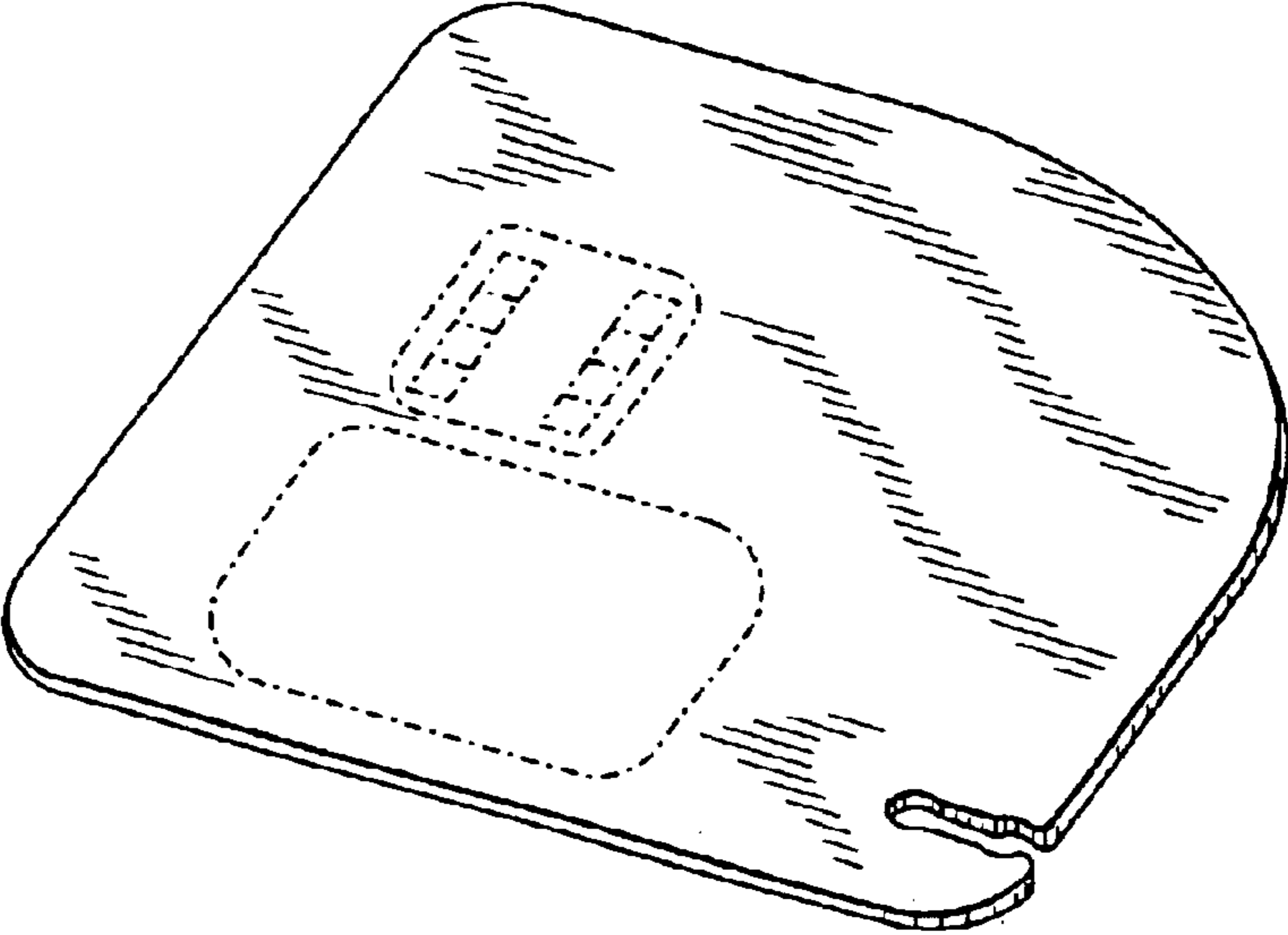

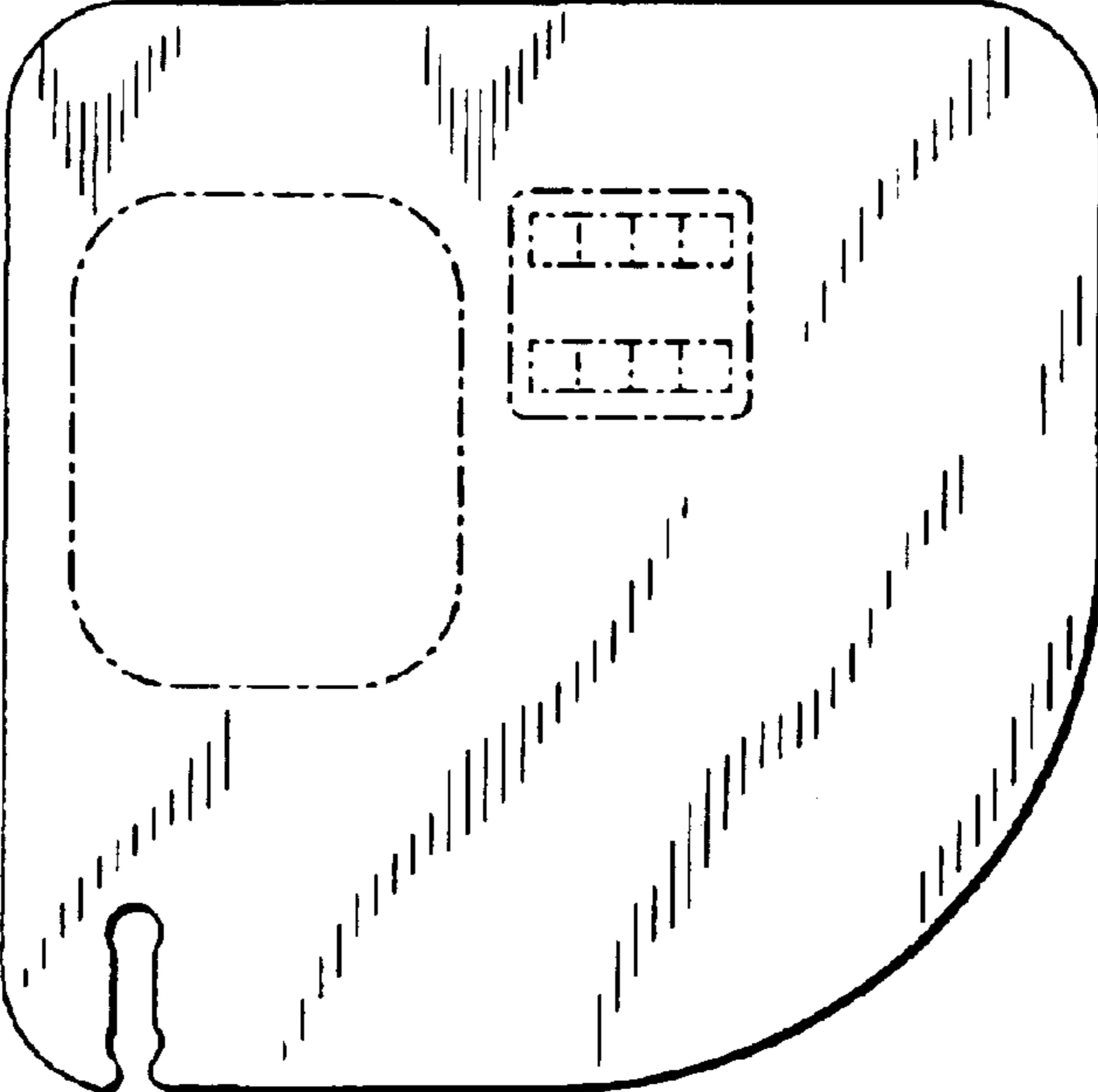

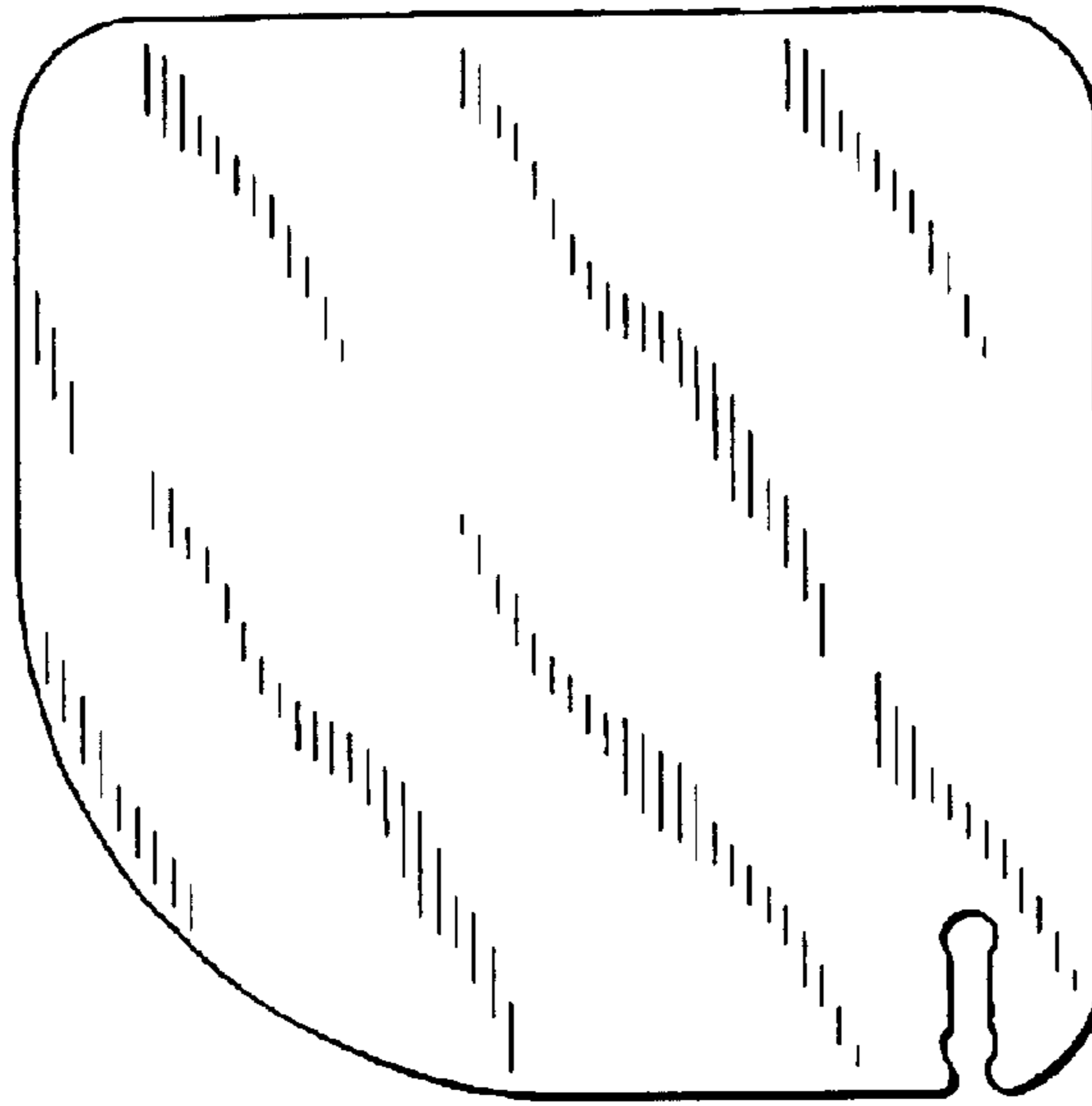
