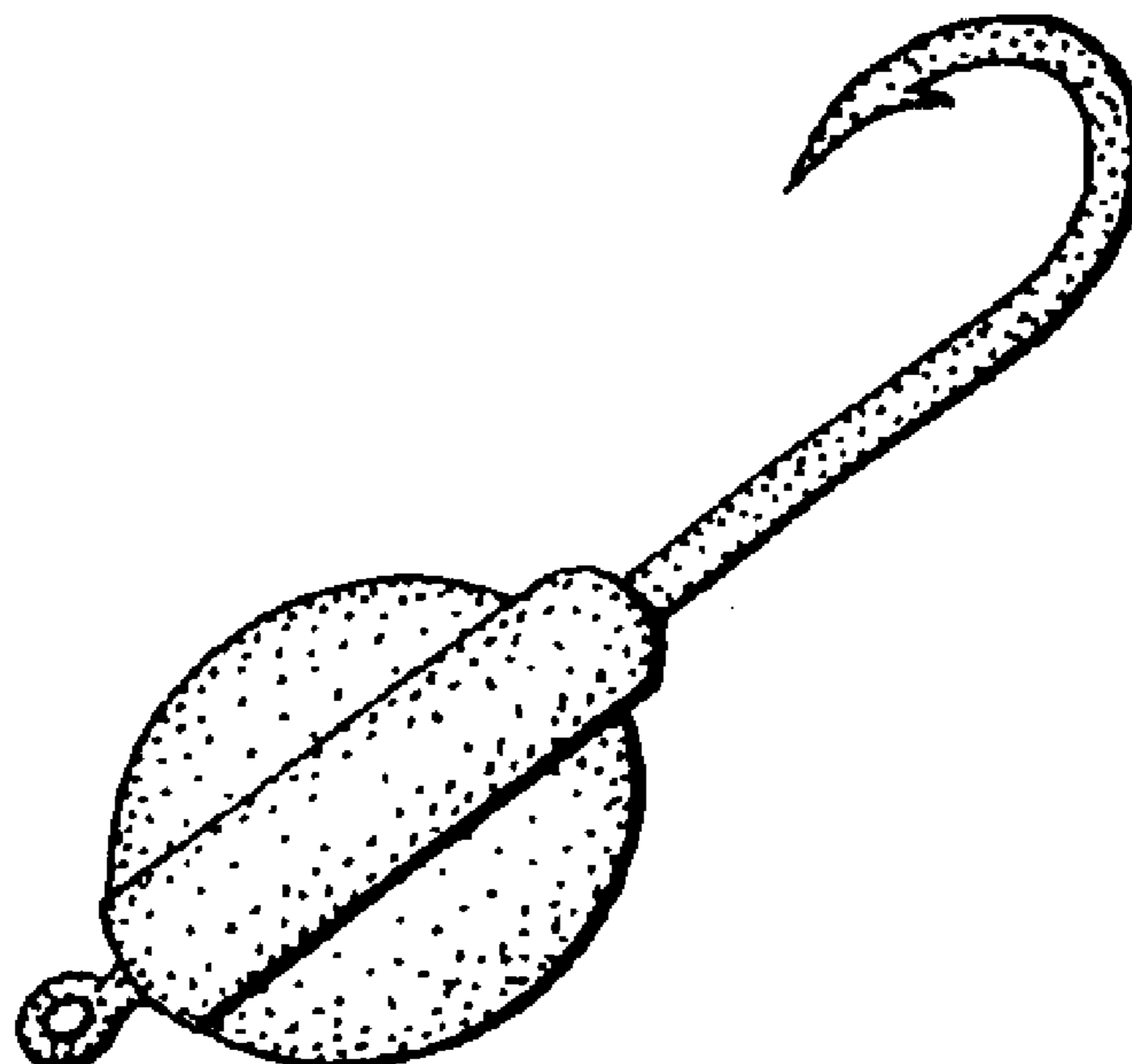
(57) **CLAIM**

The ornamental design for a fishing jig lure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fishing jig lure of my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a side elevational view thereof, the opposite side elevational view being a mirror image thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a front elevational view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a sectional view taken along line 7—7 of FIG. 2;
 FIG. 8 is a sectional view taken along line 8—8 of FIG. 2;
 FIG. 9 is a perspective view of a modification of the fishing jig lure of FIG. 1;
 FIG. 10 is a top plan view of FIG. 9;
 FIG. 11 is a side elevational view of FIG. 9, the opposite side being a mirror image thereof;
 FIG. 12 is a bottom plan view of FIG. 9;
 FIG. 13 is a front elevational view of FIG. 9;
 FIG. 14 is a rear elevational view of FIG. 9;
 FIG. 15 is a sectional view taken along line 15—15 of FIG. 10; and,
 FIG. 16 is a sectional view taken long line 16—16 of FIG. 10.

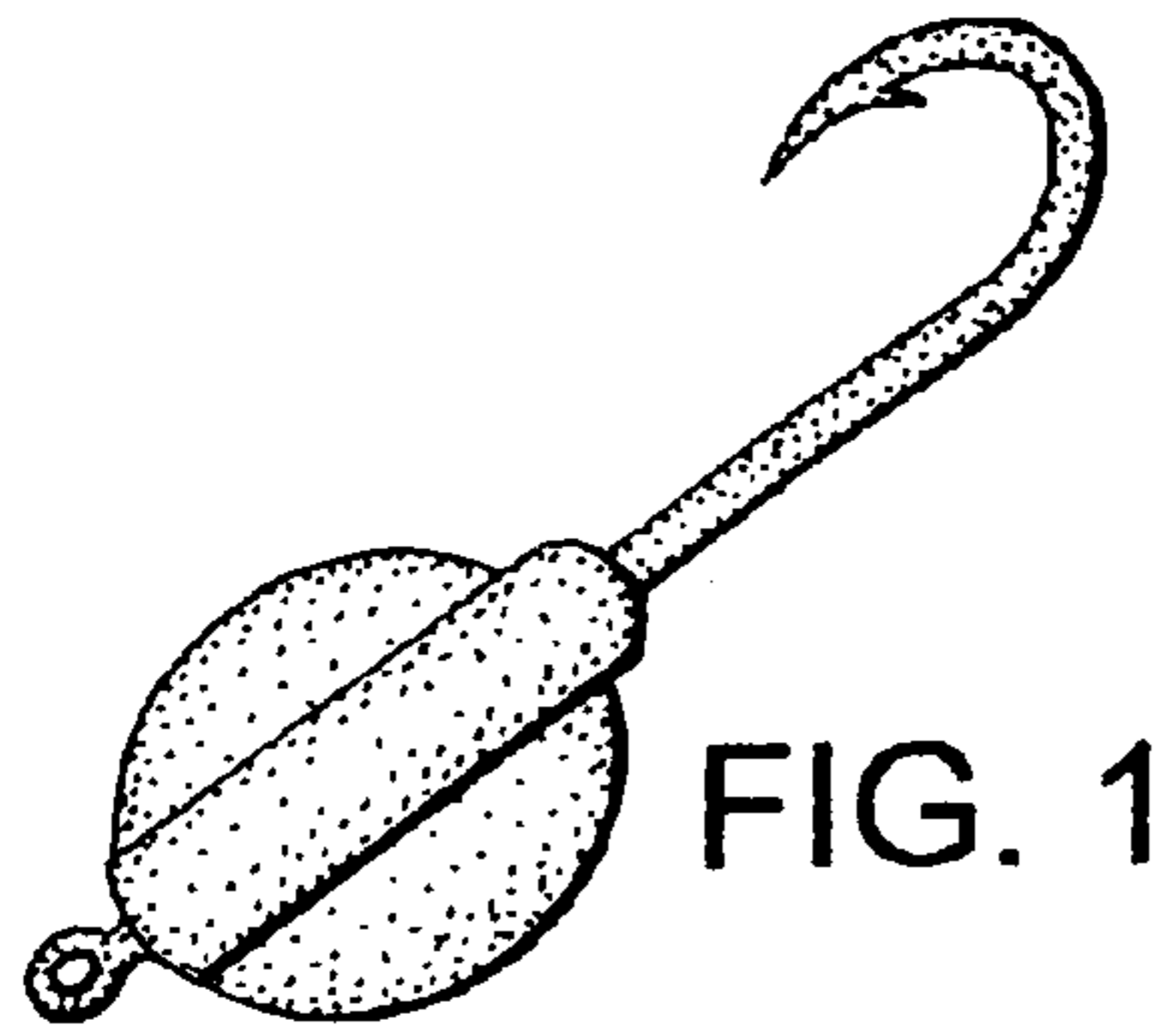

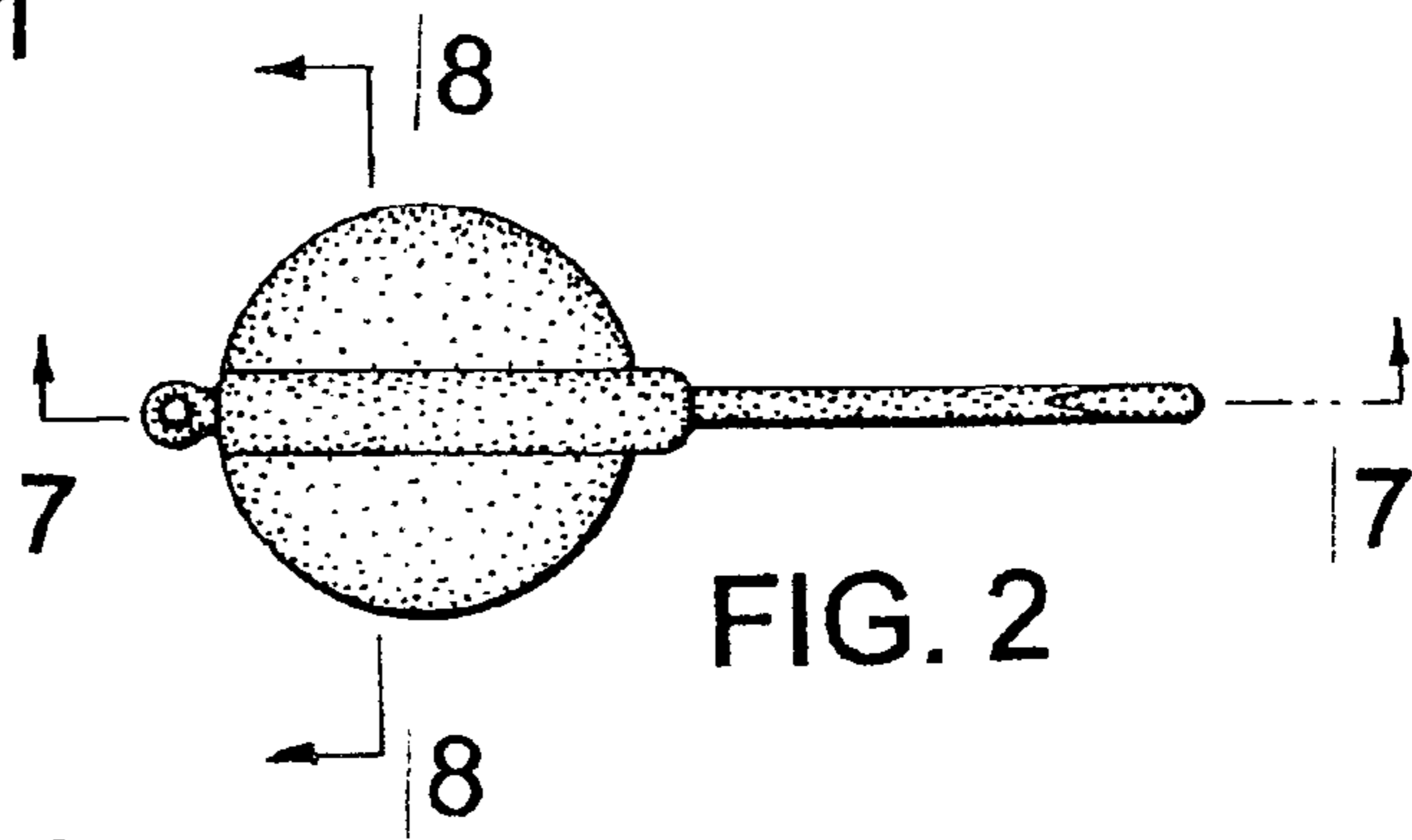

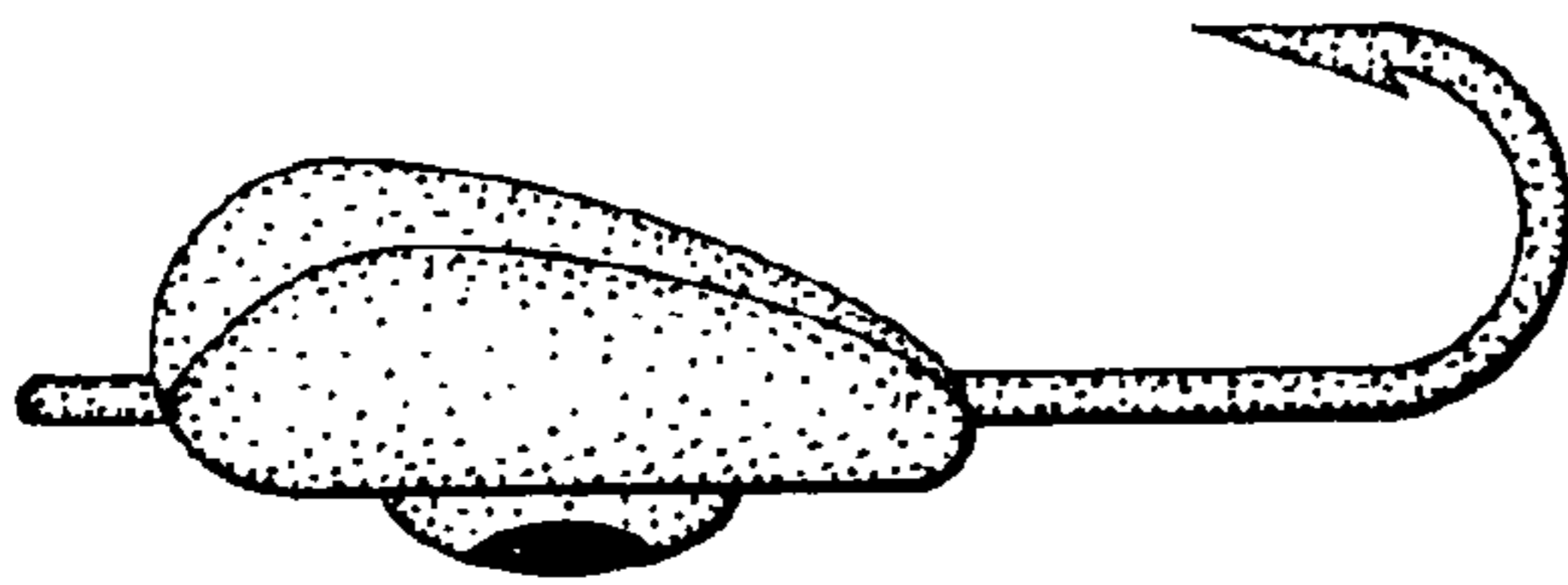

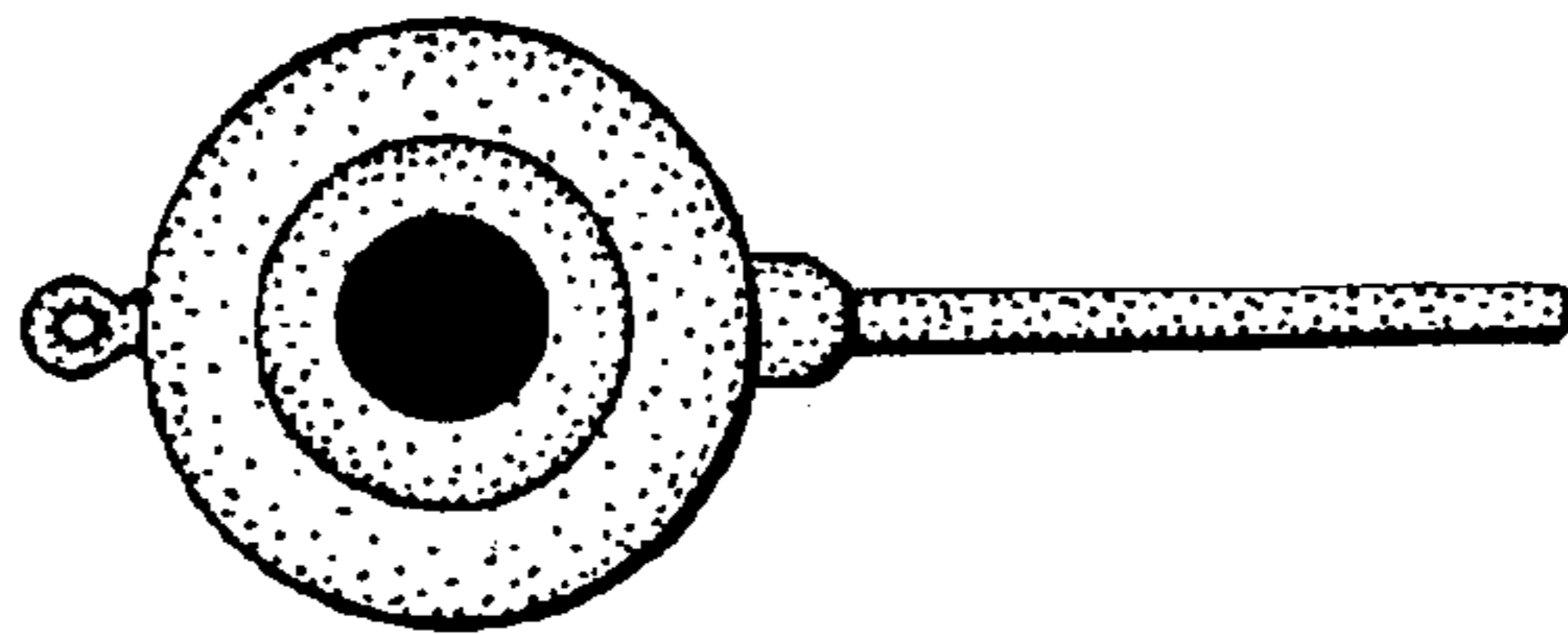

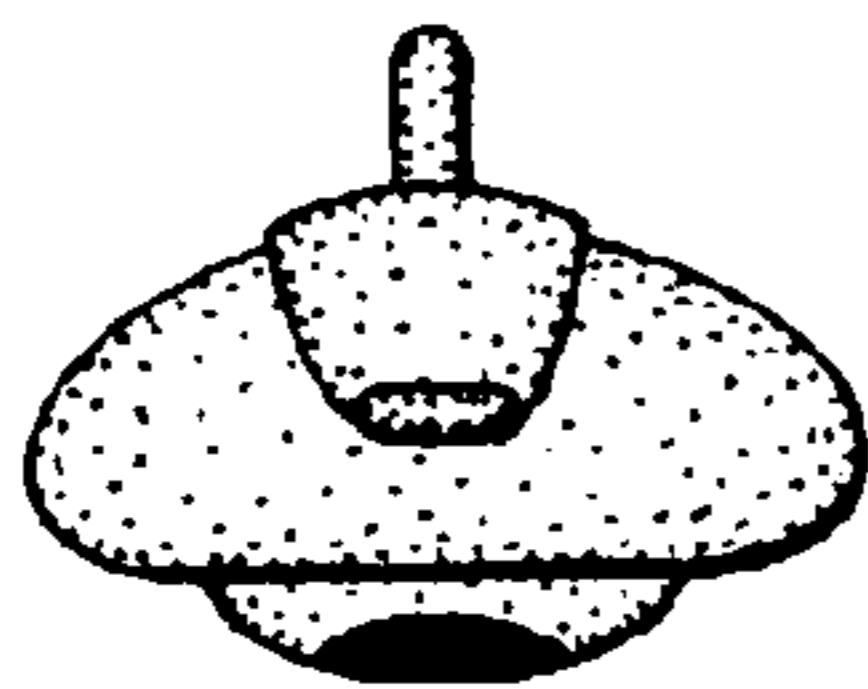

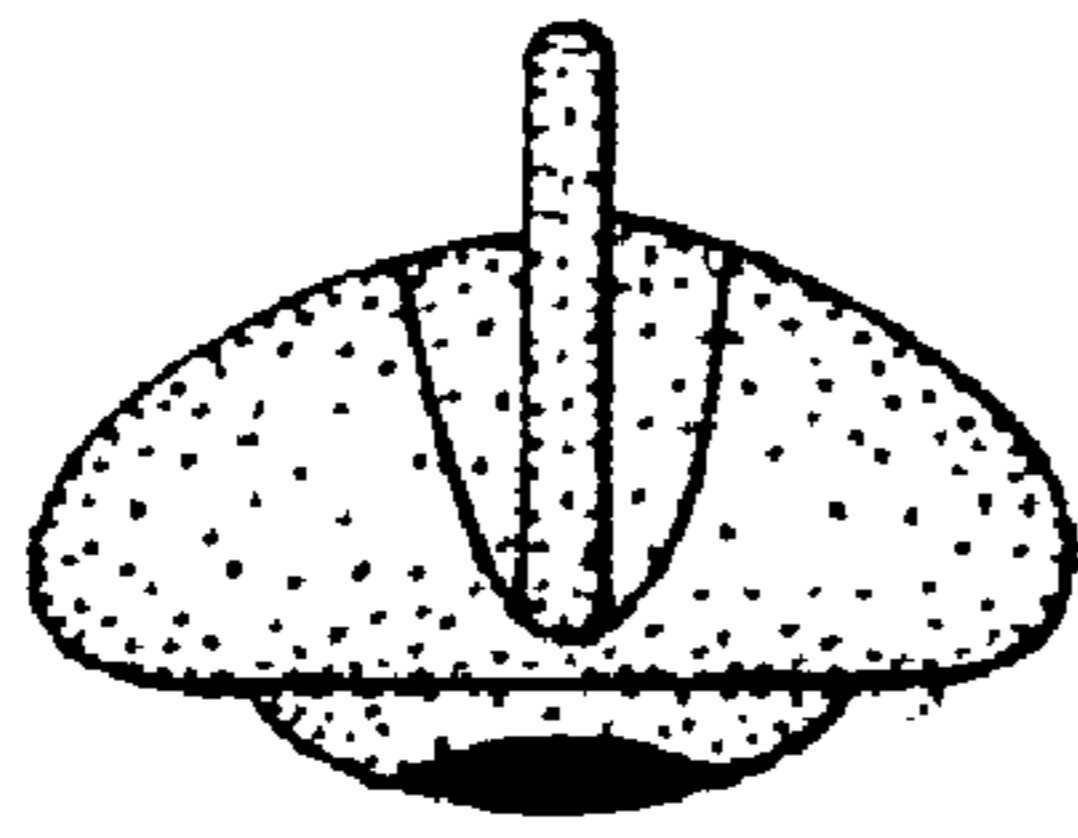

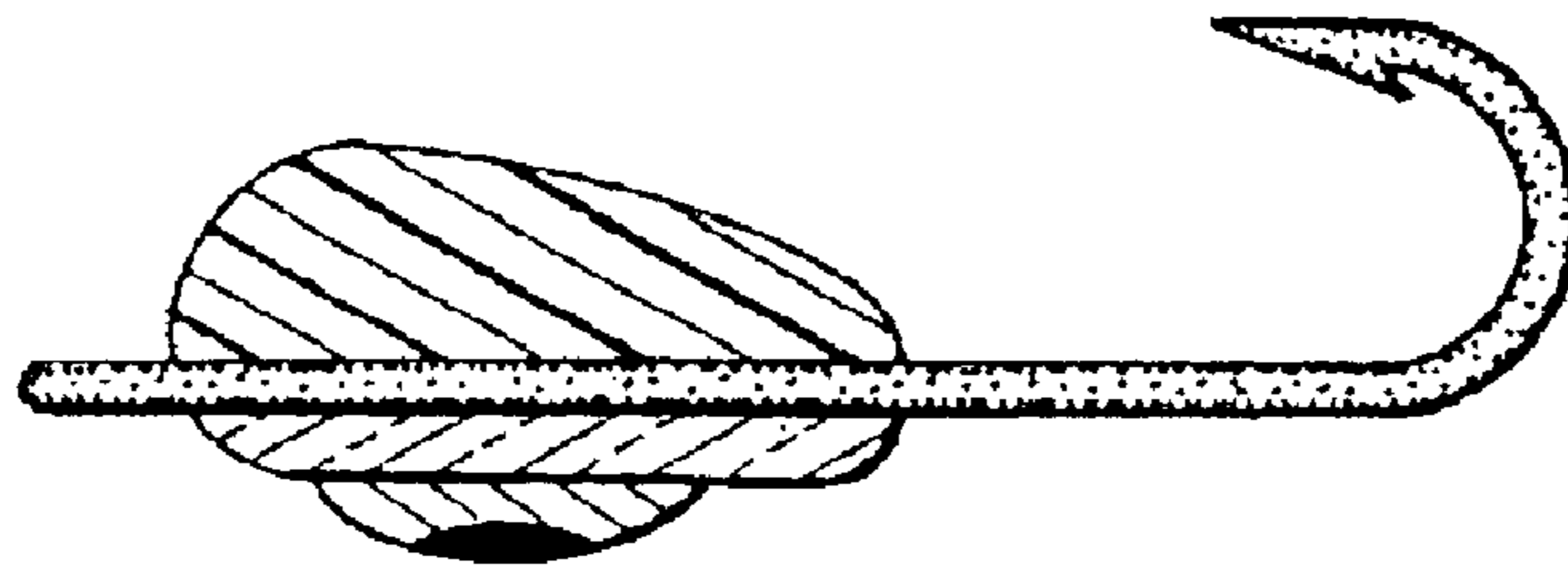

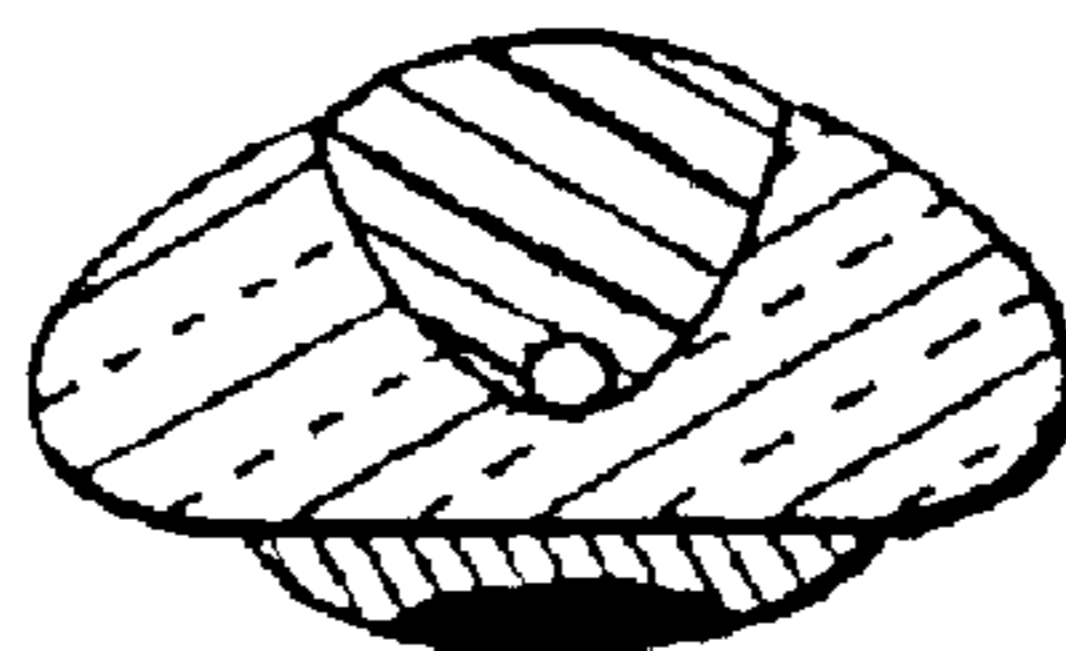

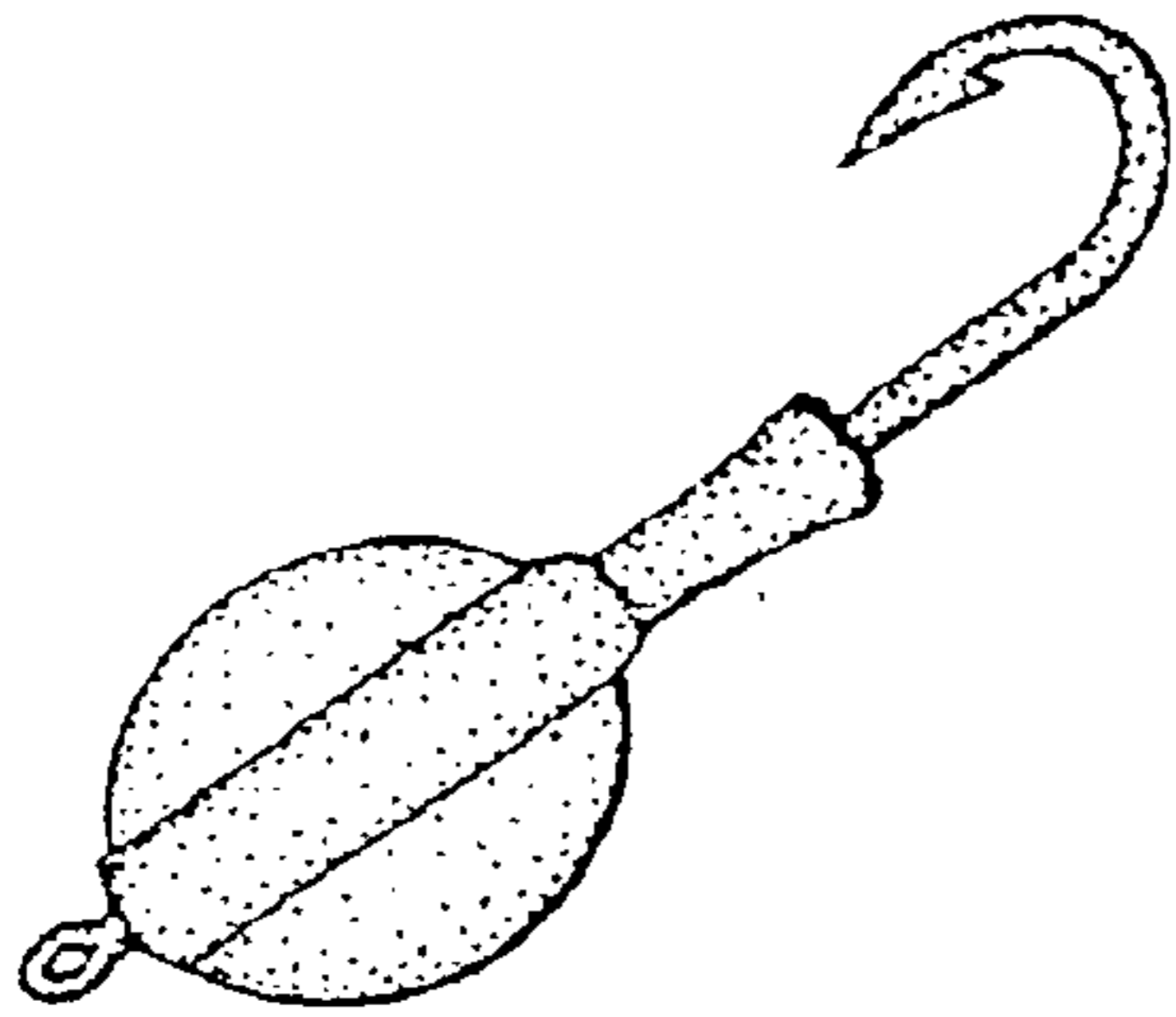

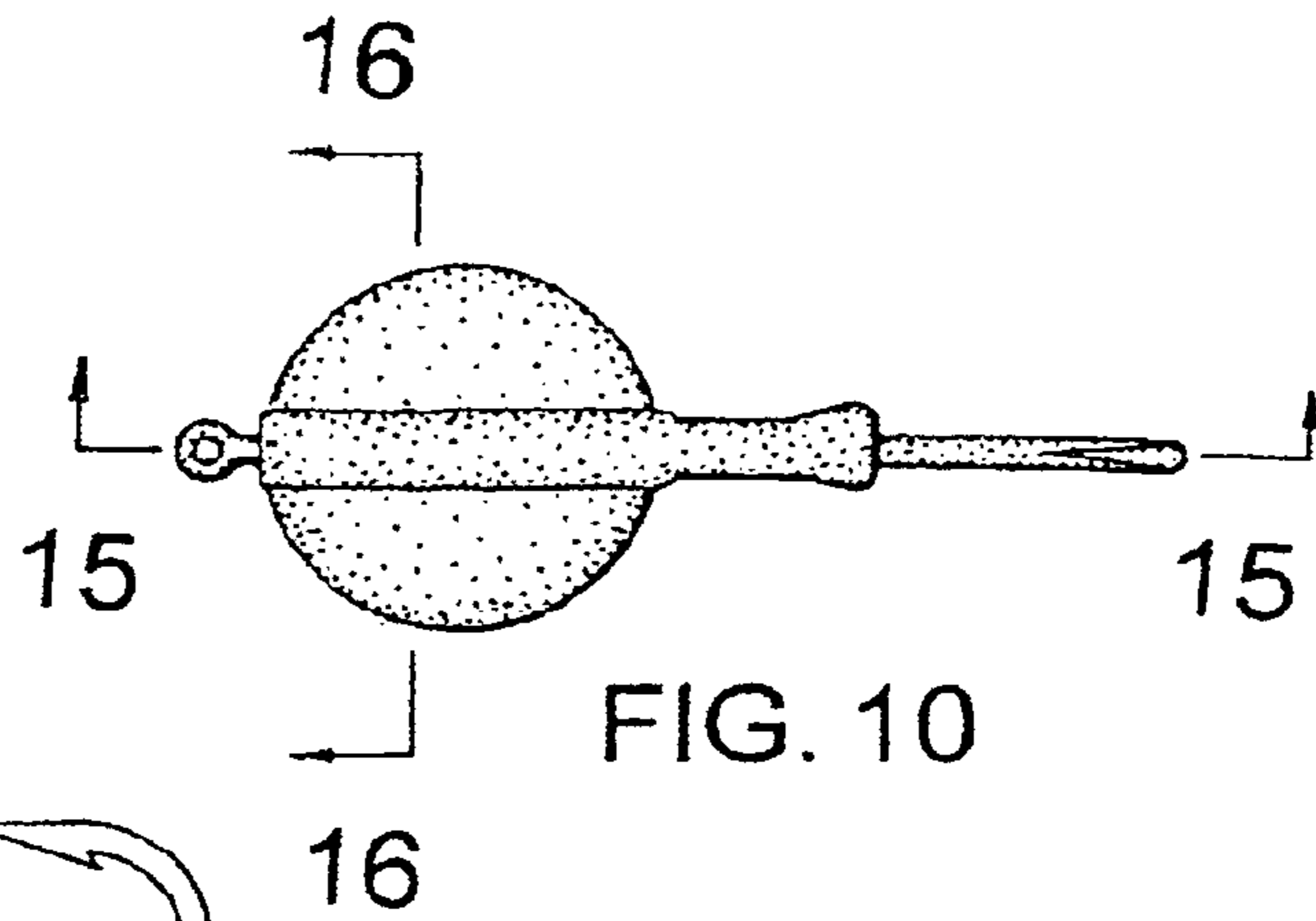

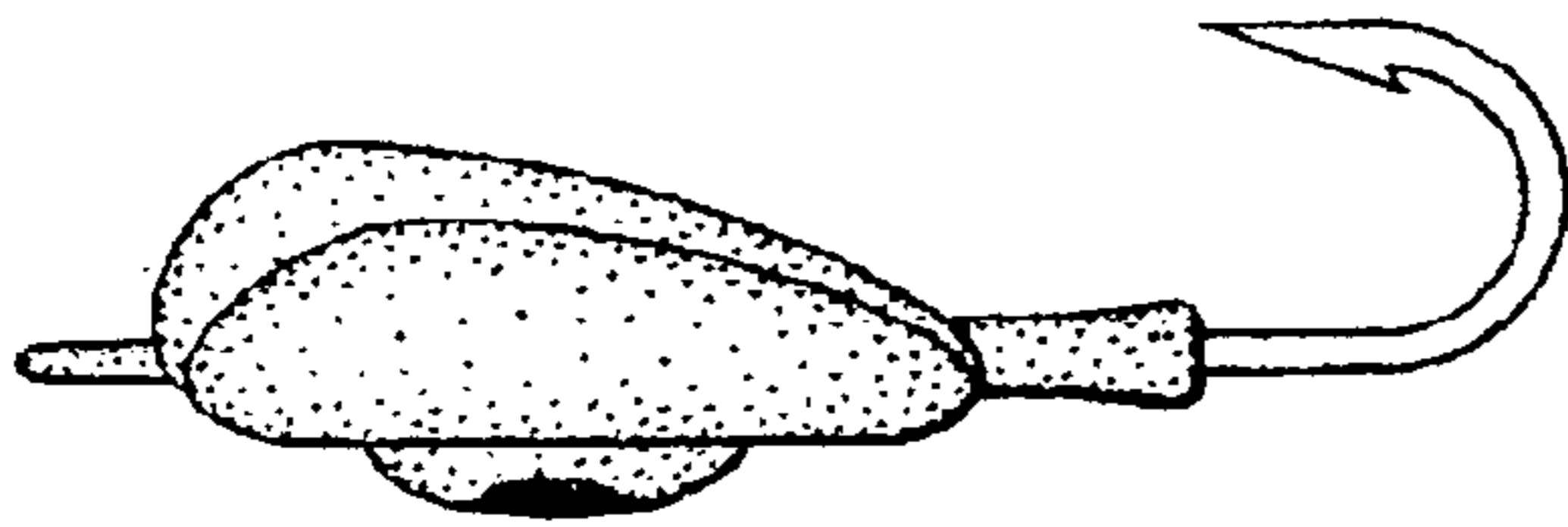

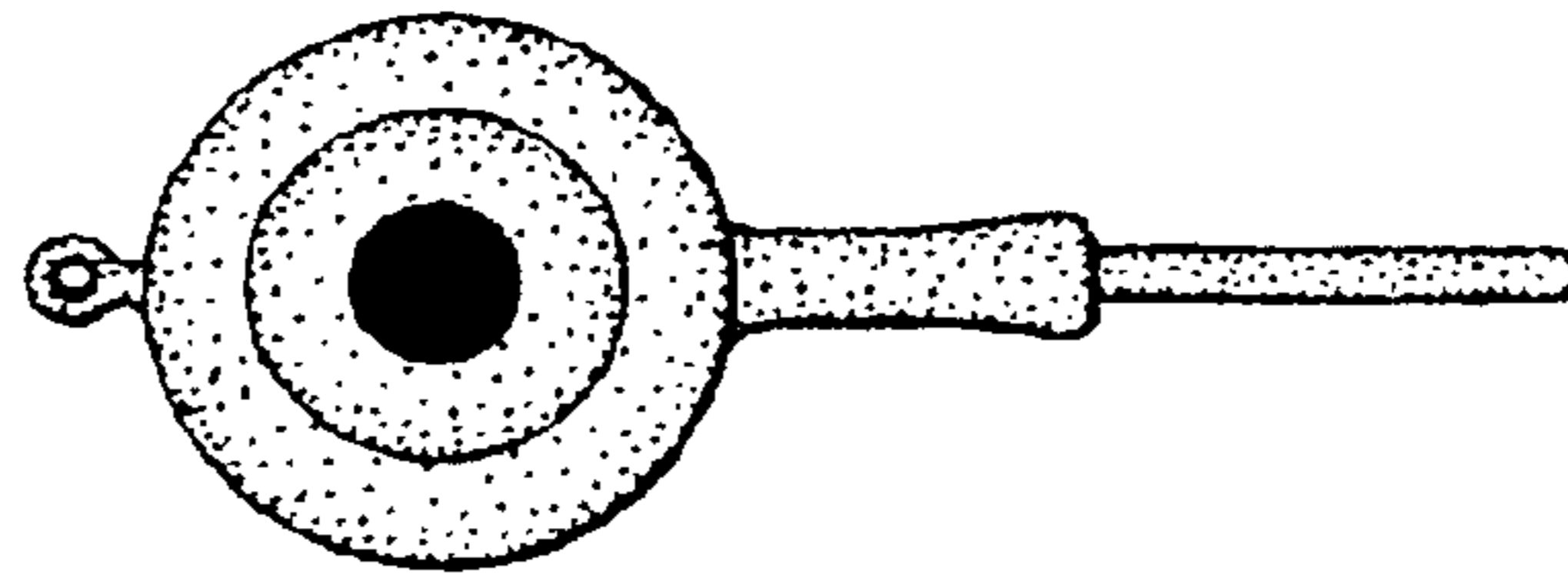

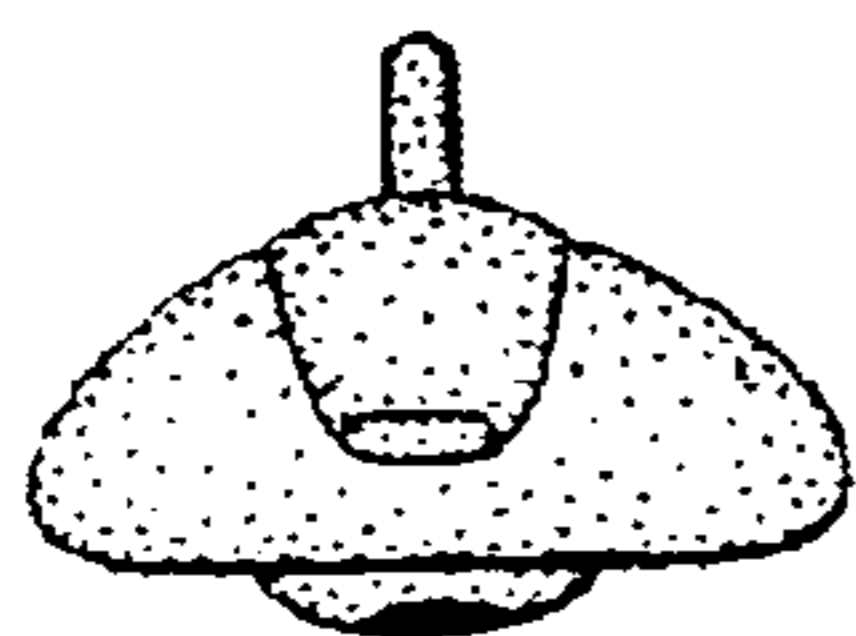

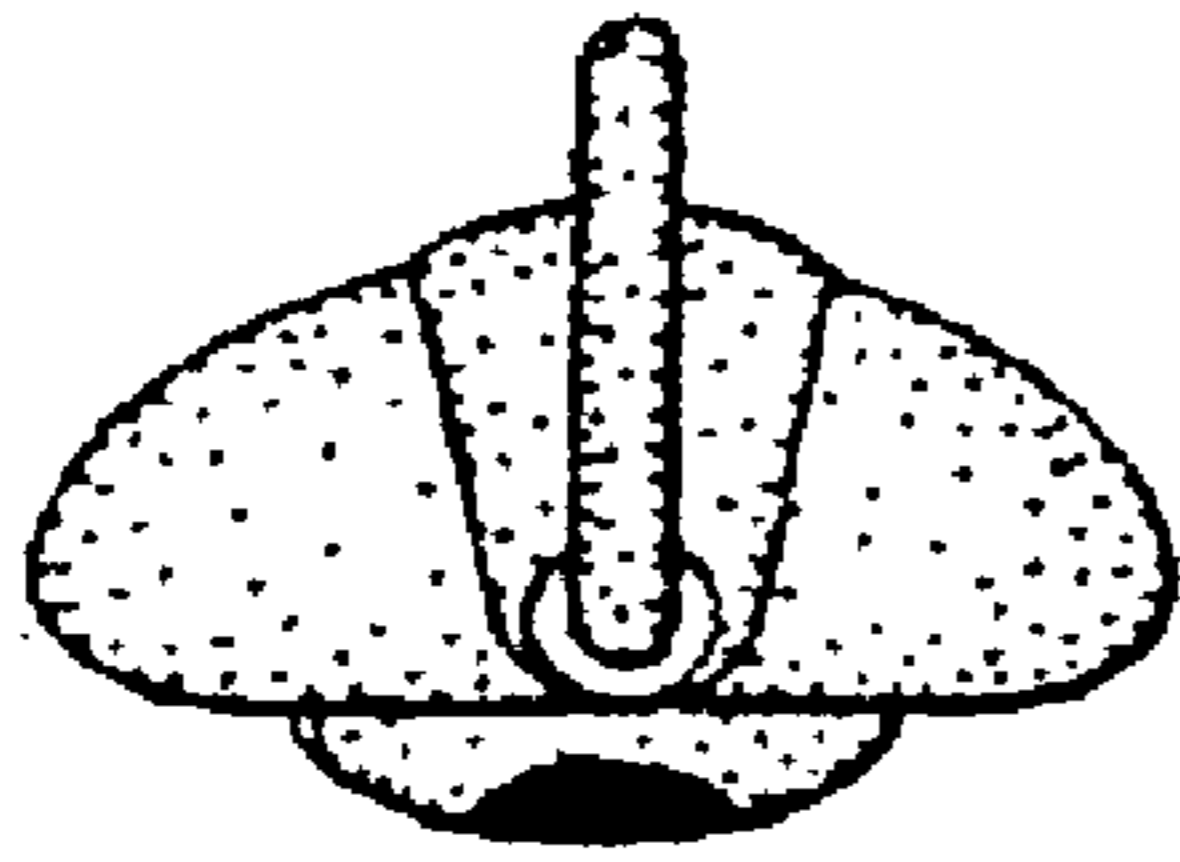

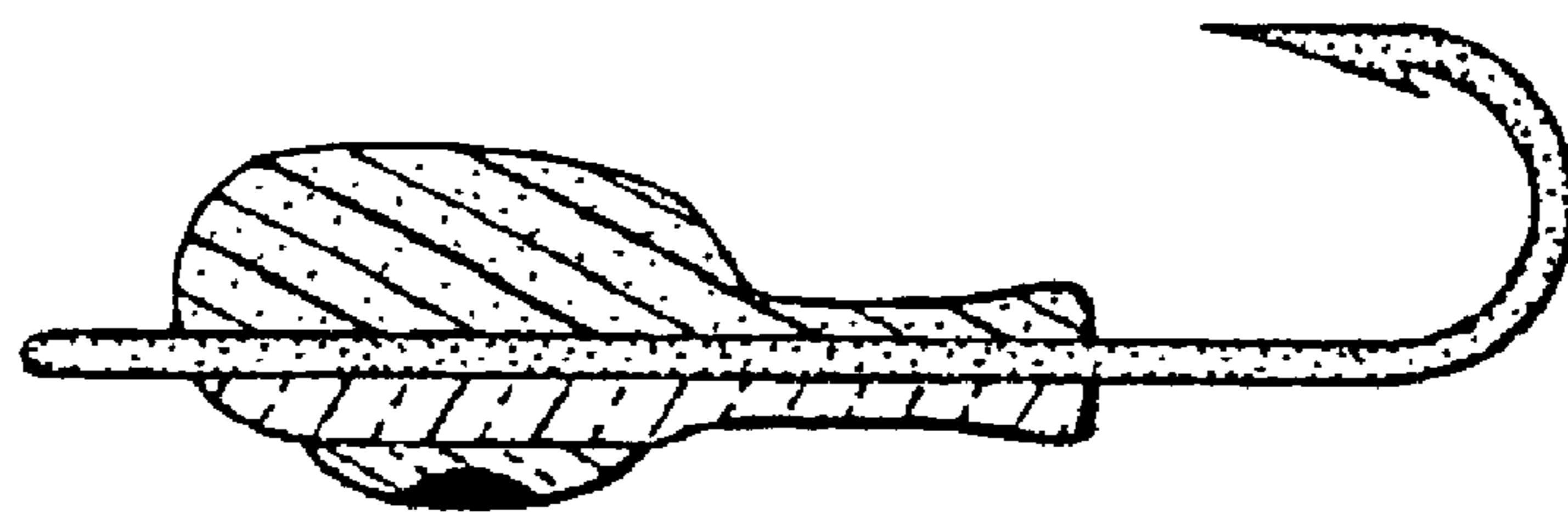

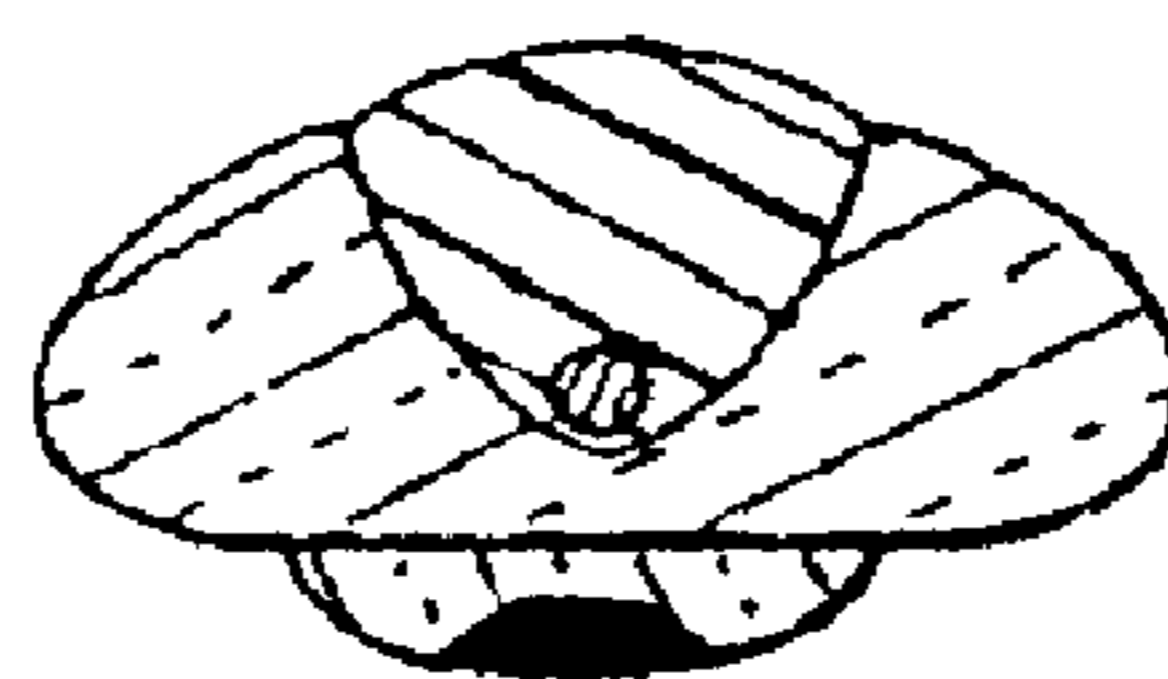
