FIG. 1 is a front elevational view of the accessory for forming and holding a hair bun incorporating my new design, with the rear elevational view thereof being a mirror image;

FIG. 2 is a top plan view thereof;

FIG. 3 is a side elevational view as viewed from the left side of FIG. 1;

FIG. 4 is a side elevational view as viewed from the right side in FIG. 1;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevational view of the accessory for forming and holding a hair bun in an inverted condition;

FIG. 7 is a top plan view of the inverted accessory for forming and holding a hair bun shown in FIG. 6; and,

FIG. 8 is a perspective view showing the accessory for forming and holding a hair bun in use.

The broken lines showing the head and neck of a person in FIG. 8 are for illustrative purposes only and do not form part of the claimed design. The broken lines shown on the accessory for forming and holding a hair bun represent stitching. FIG. 8 in the drawings is shown on a reduced scale.

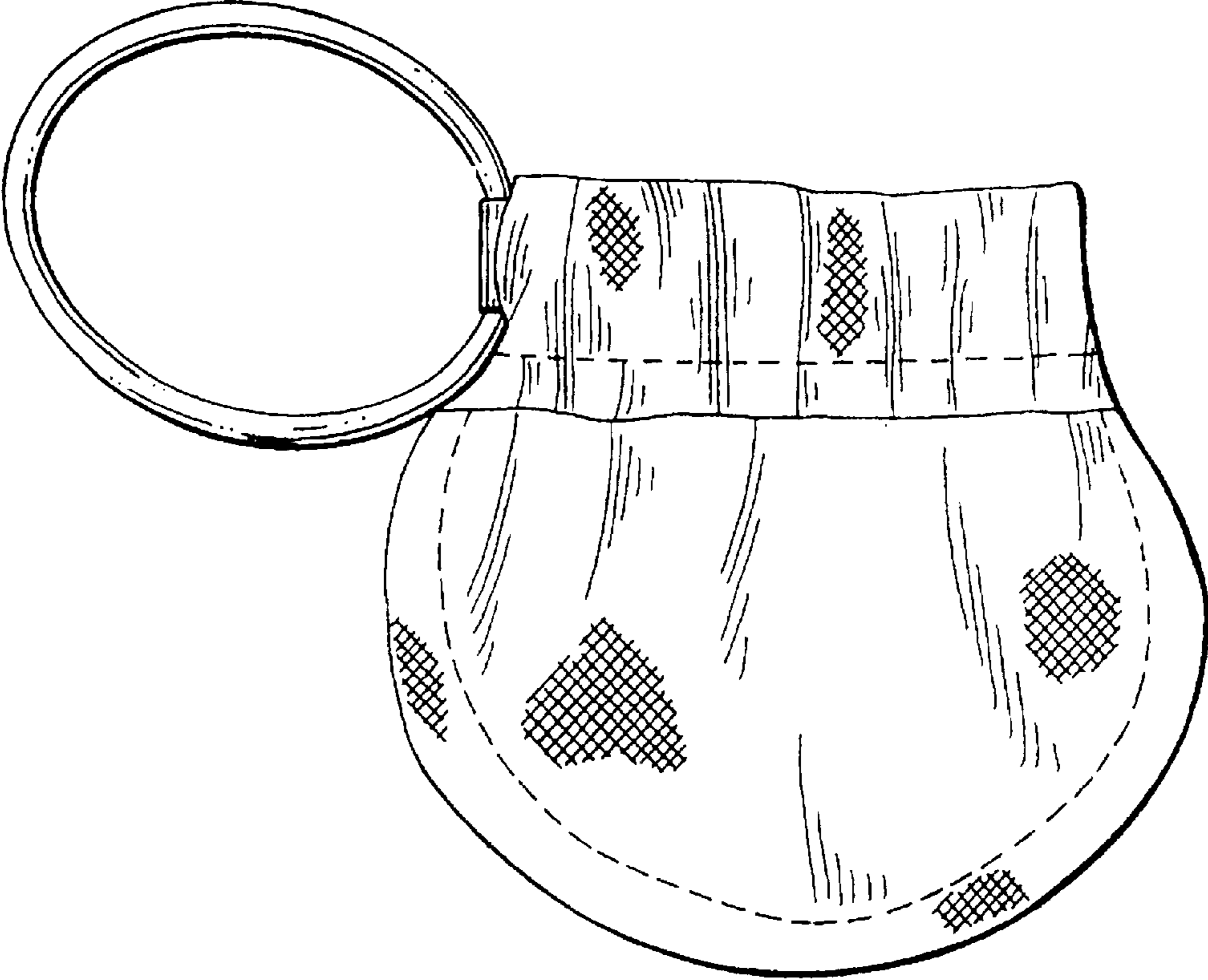

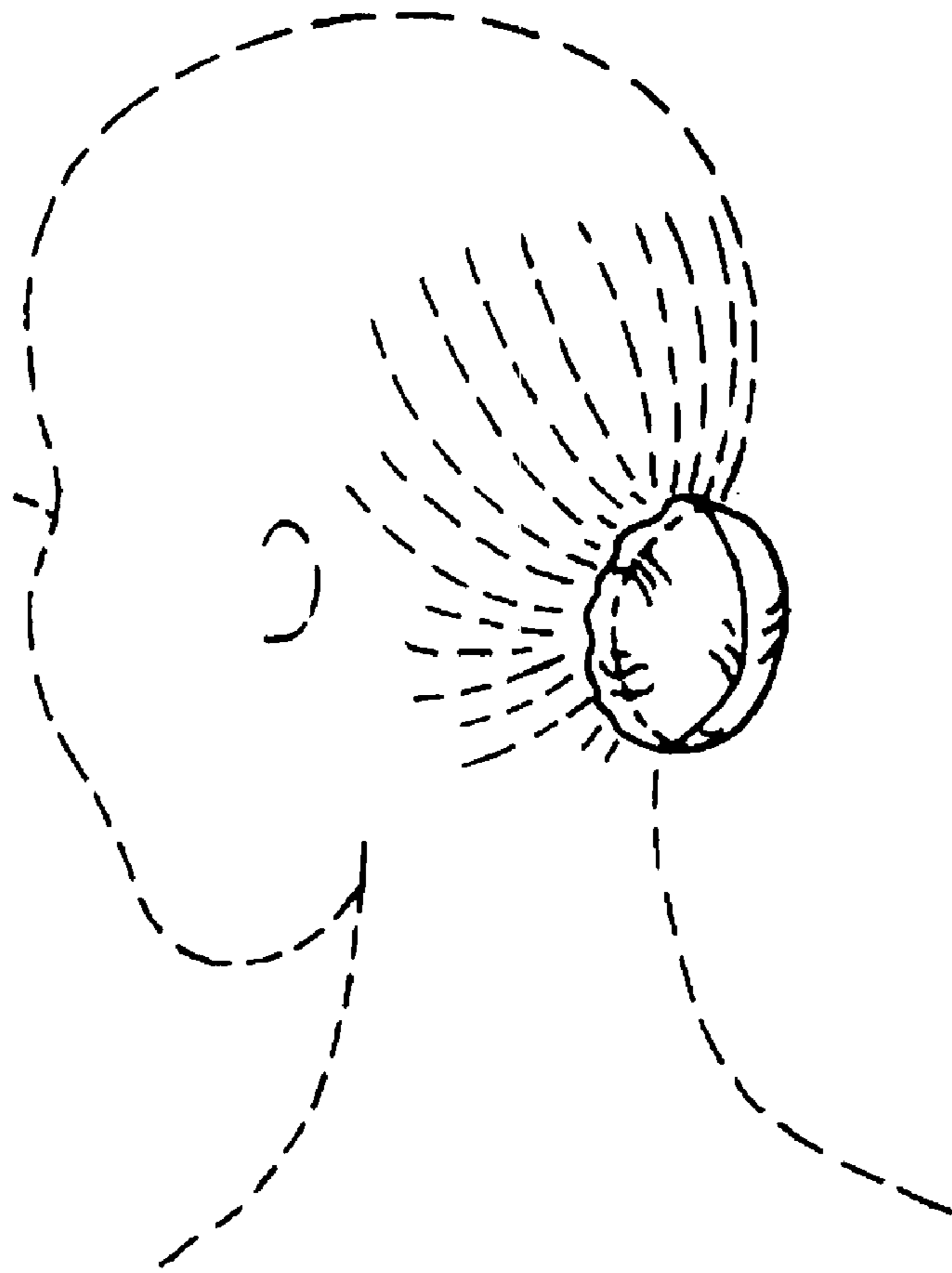
