(57) **CLAIM**

The ornamental design for a heart-shaped underwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing an embodiment of a heart-shaped underwear pocket on women's underwear; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; and, FIG. 5 is a left side view thereof, the right side view being a mirror image thereof.

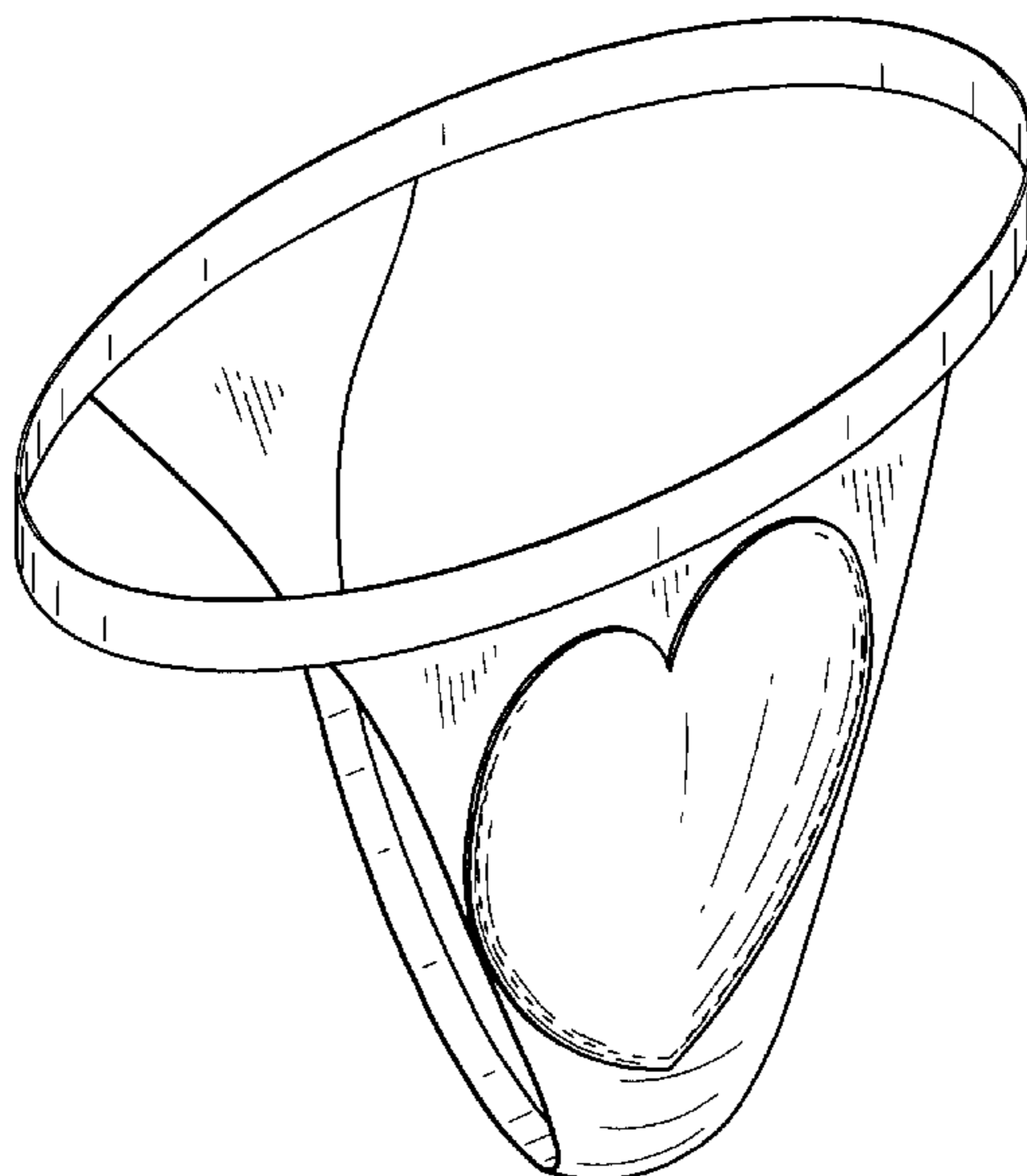

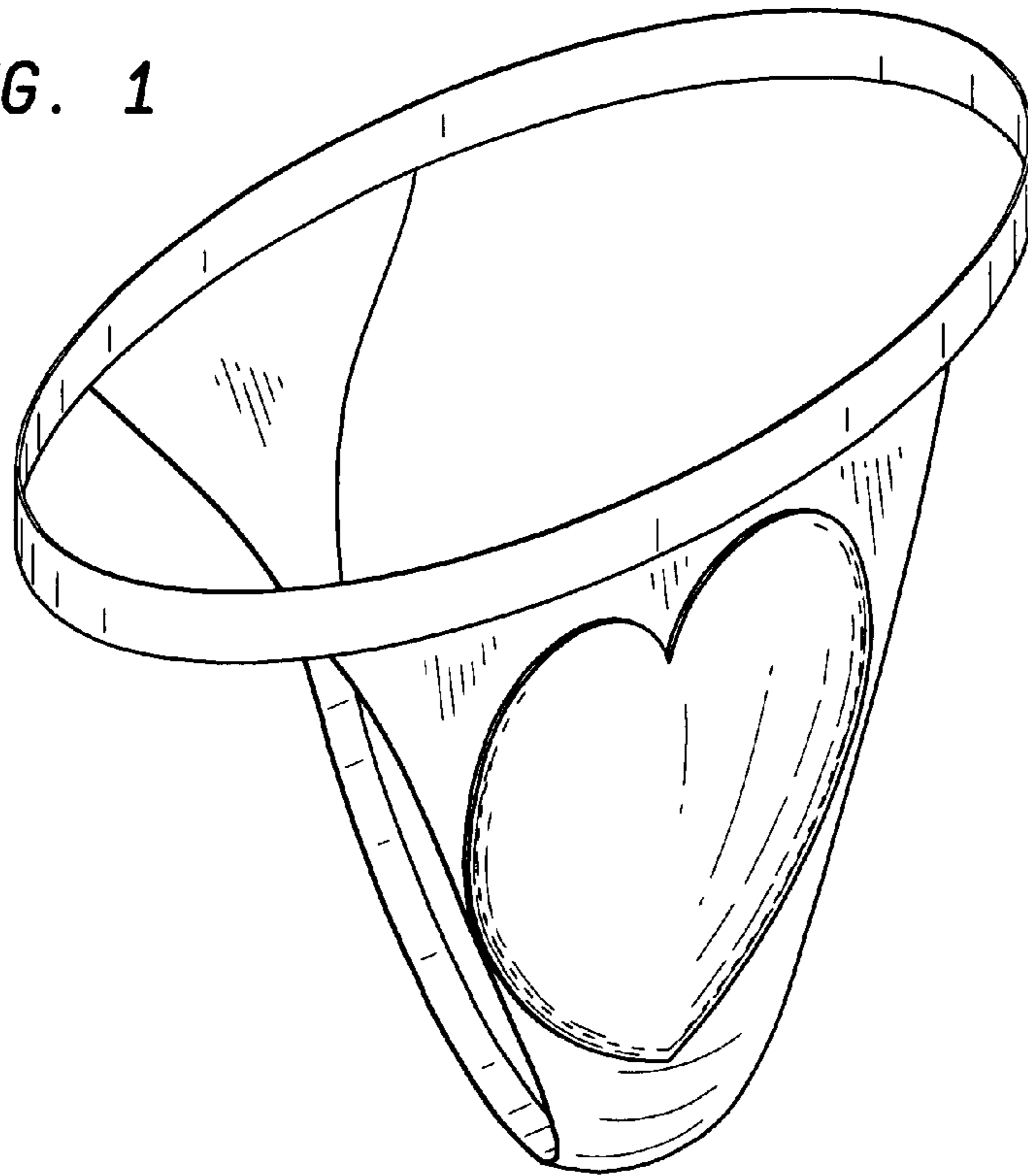

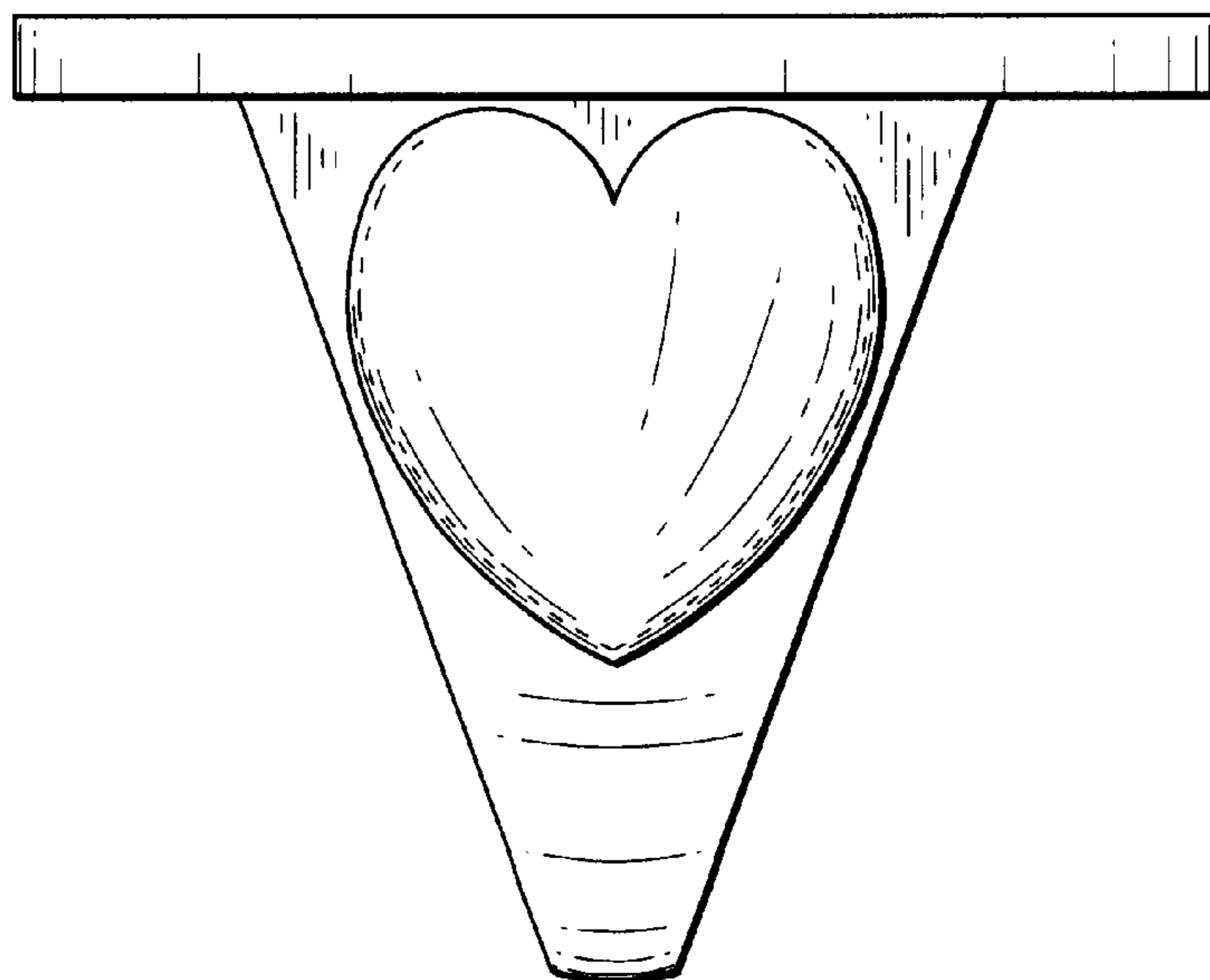

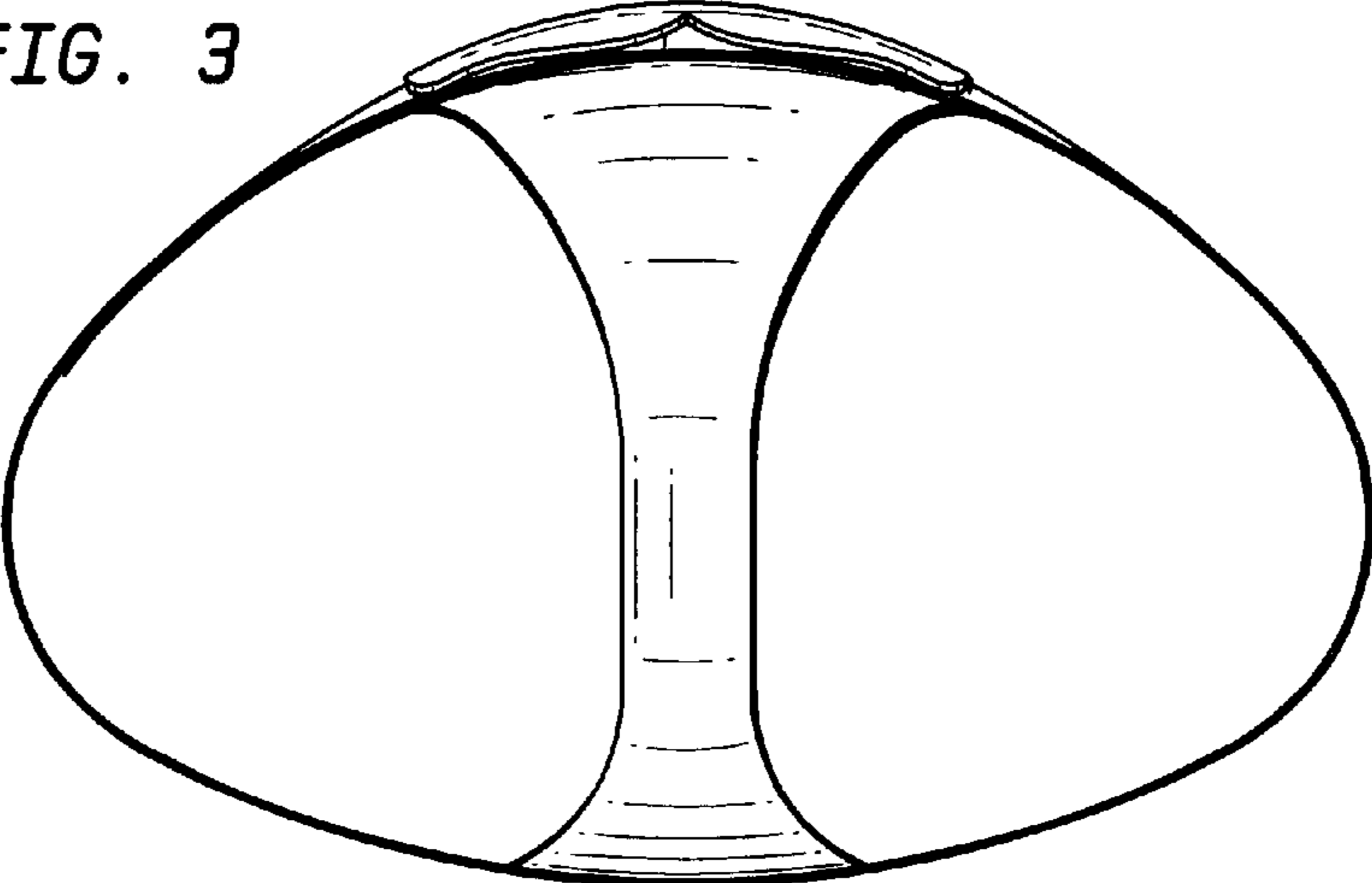

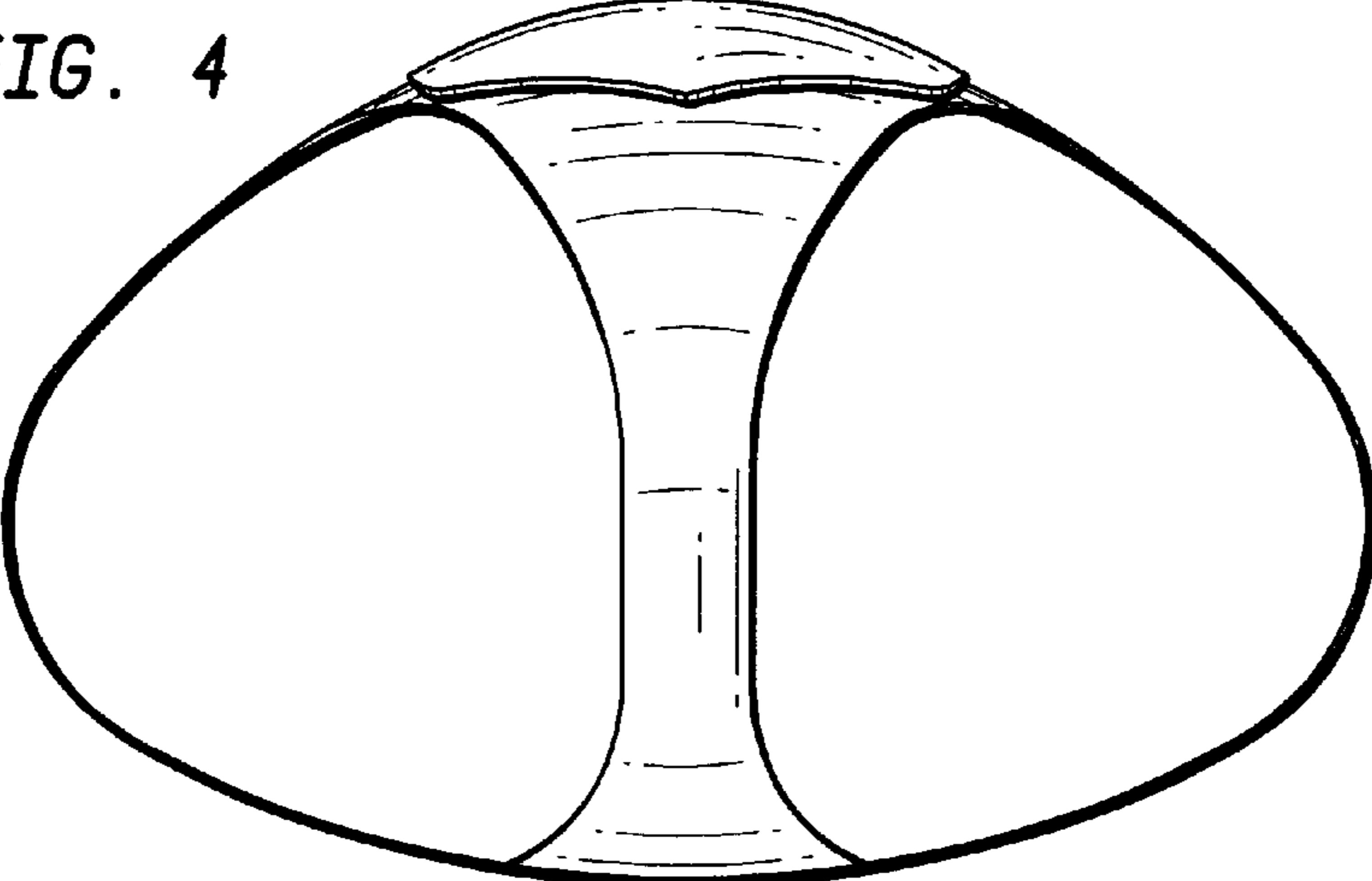
