The broken-line disclosure of toilet paper rolls in the view is for illustrative purposes only and forms no part of the claimed design.

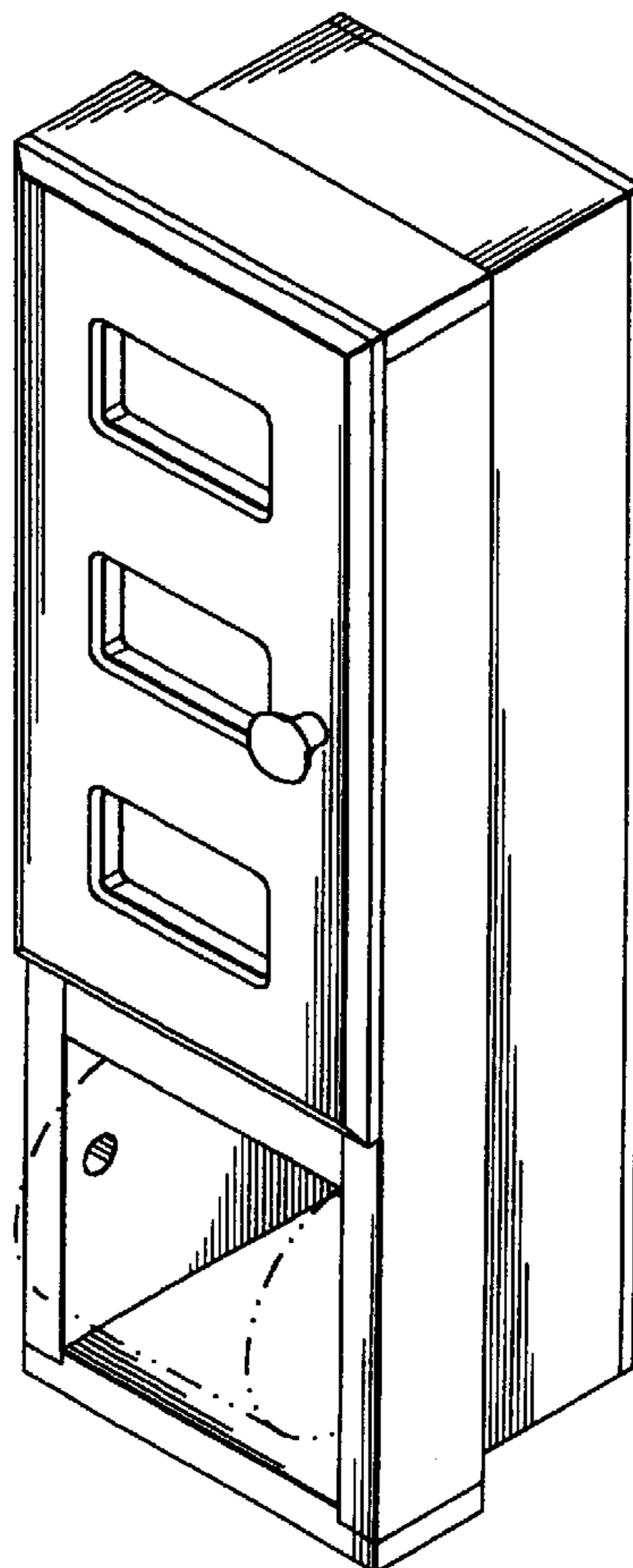

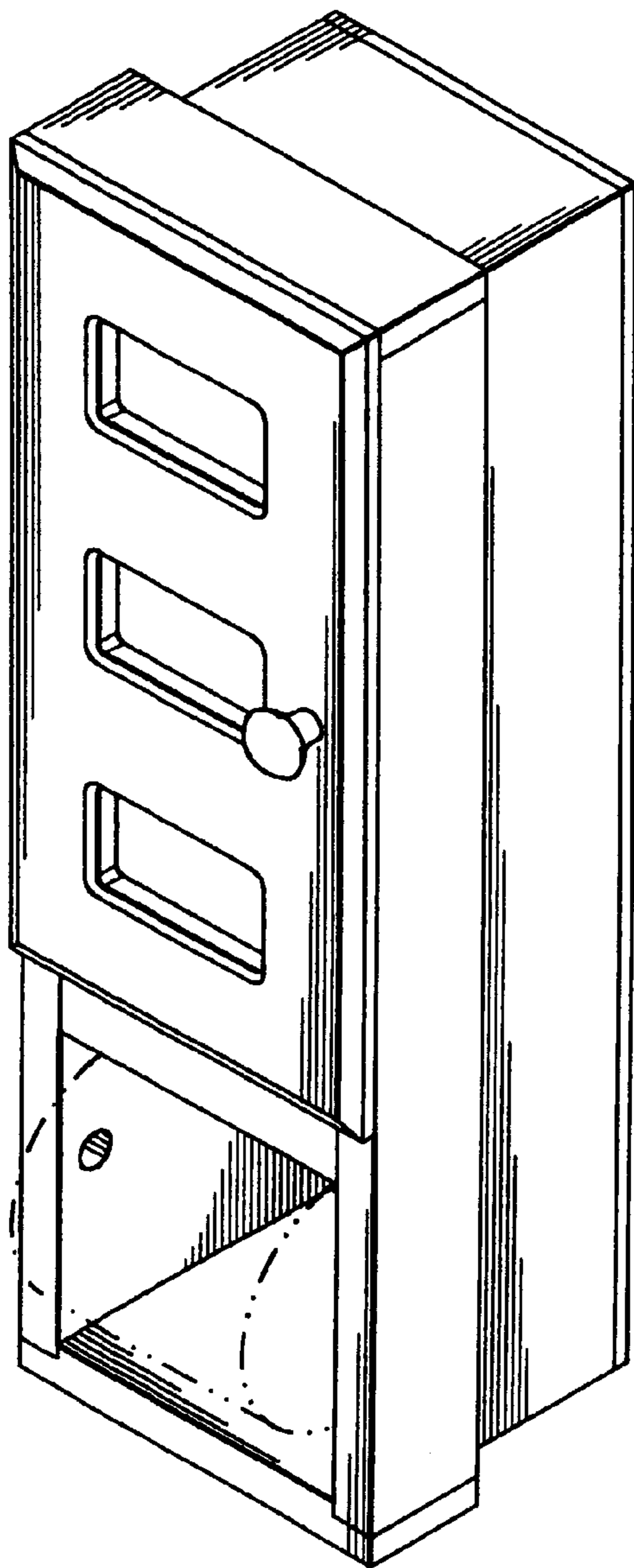

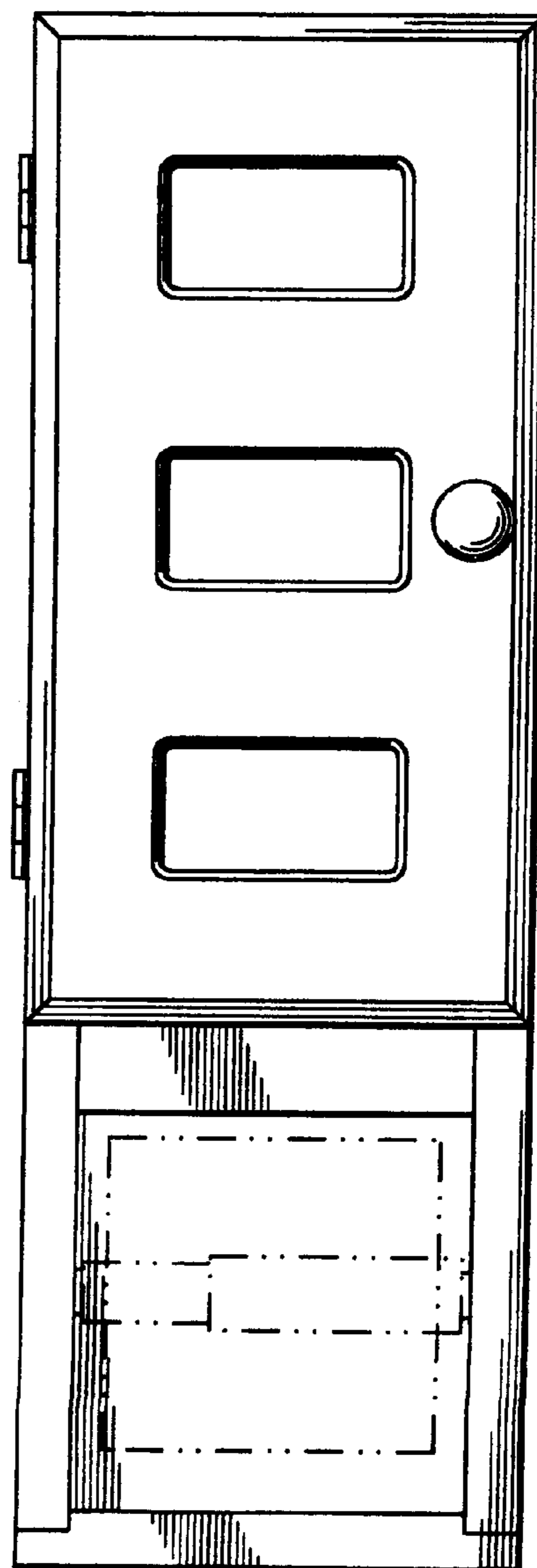

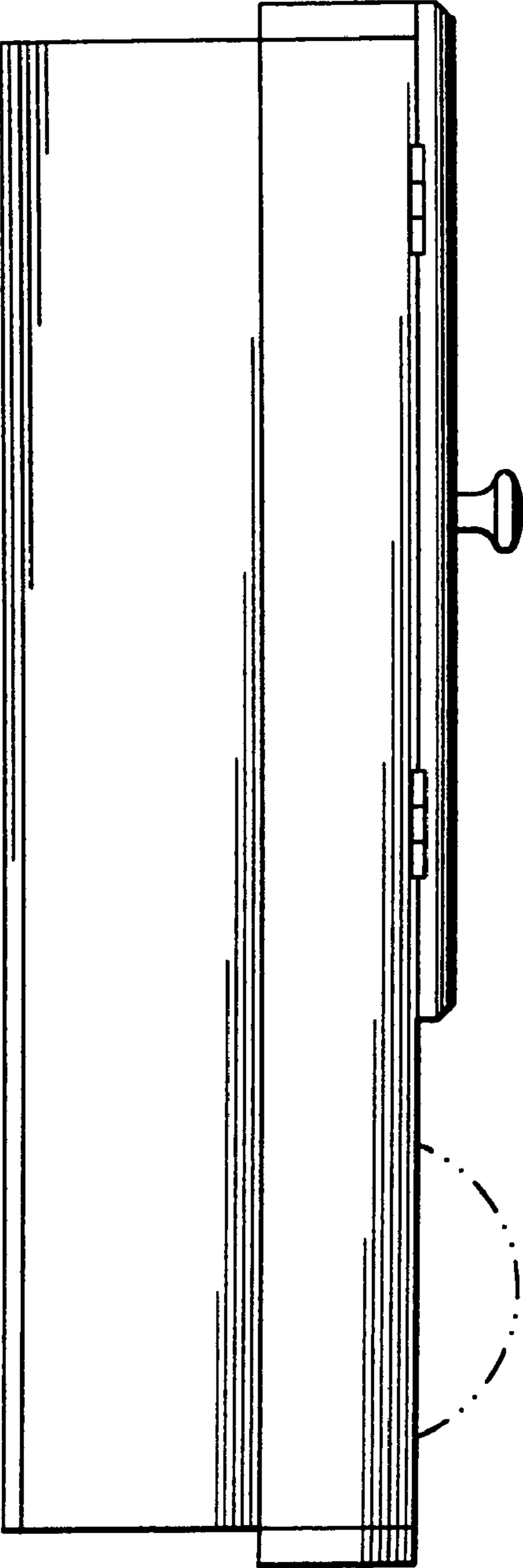




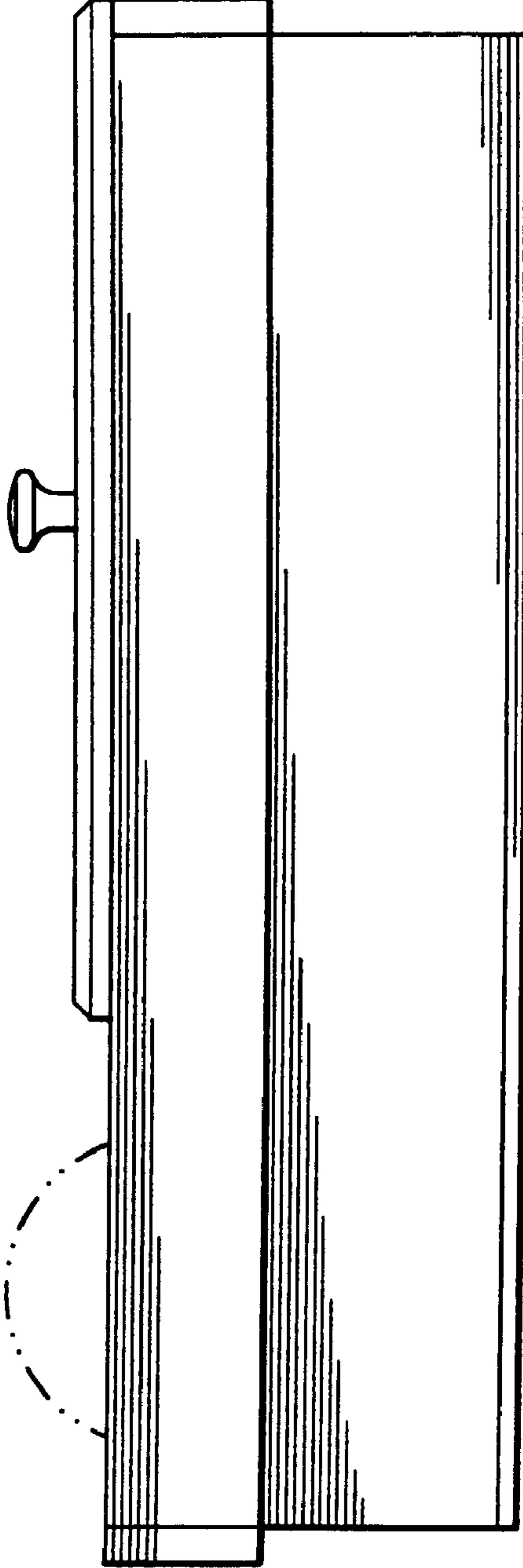

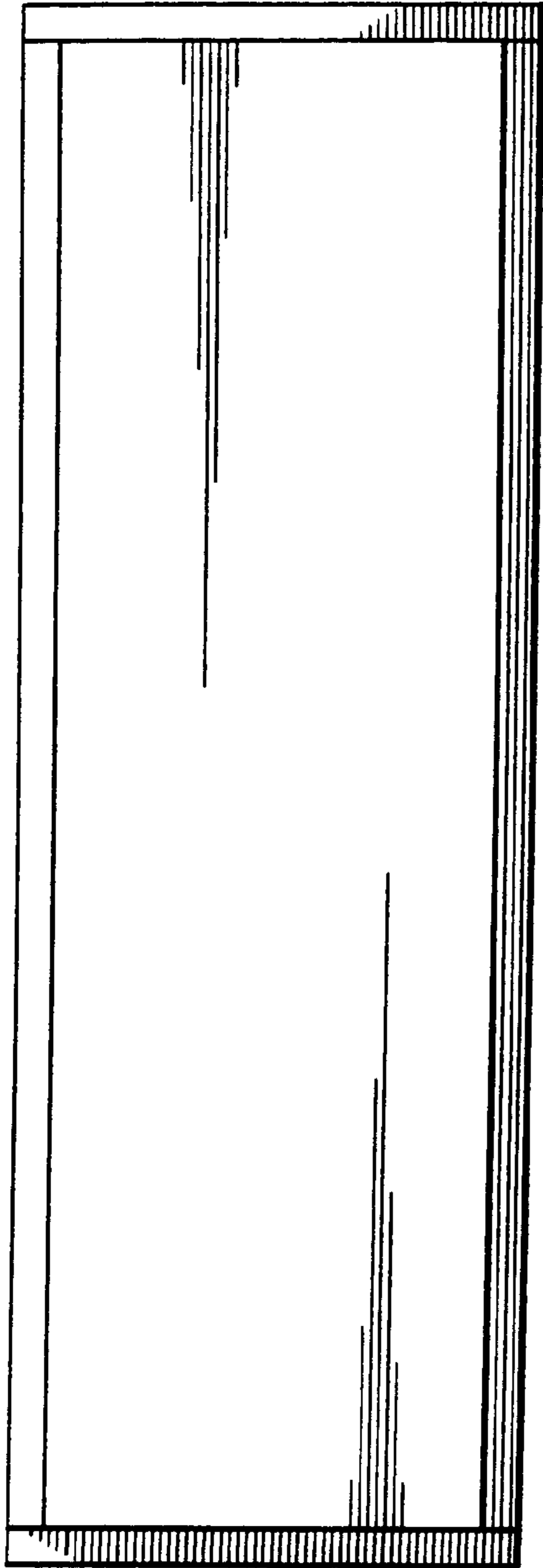

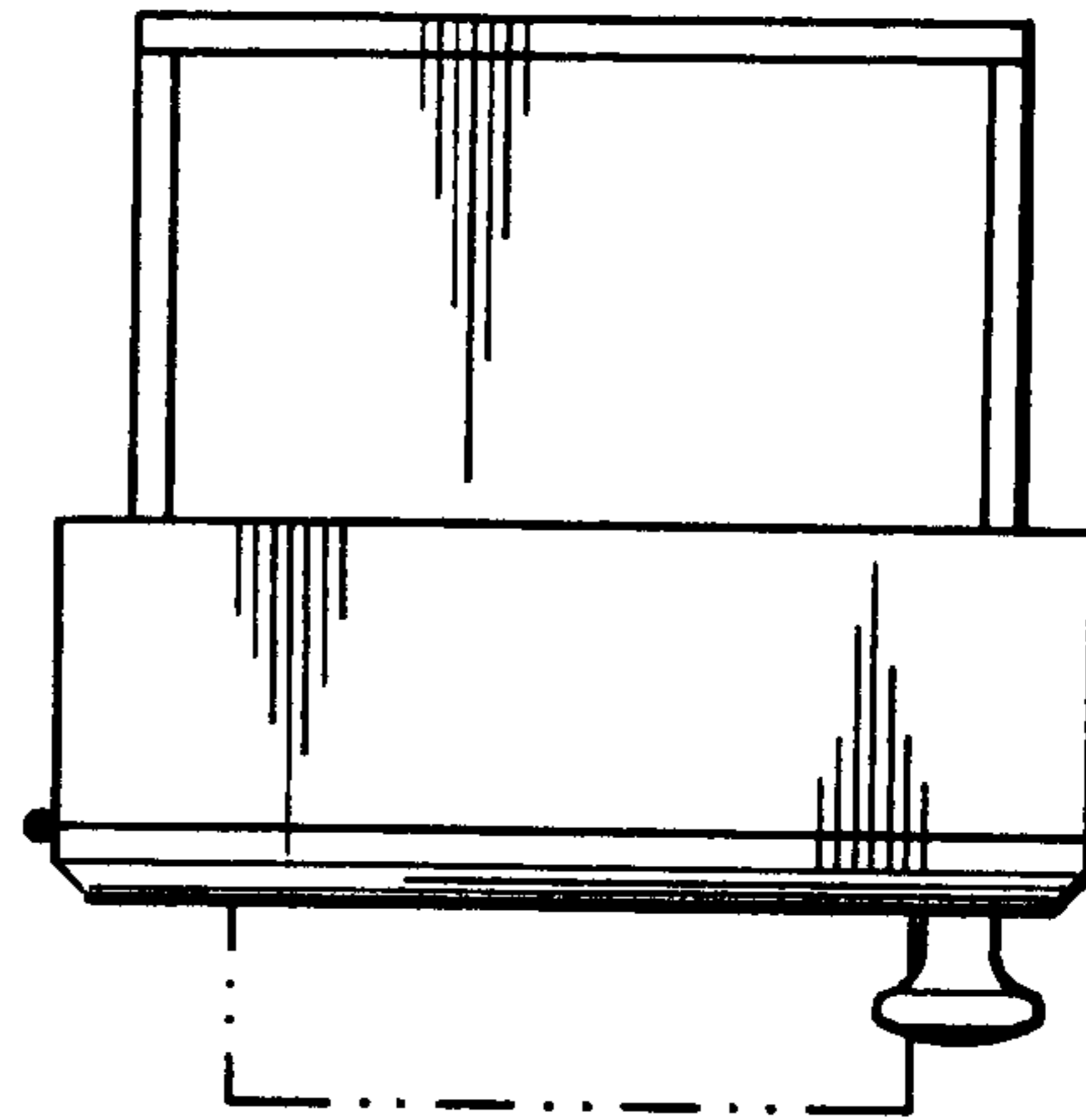

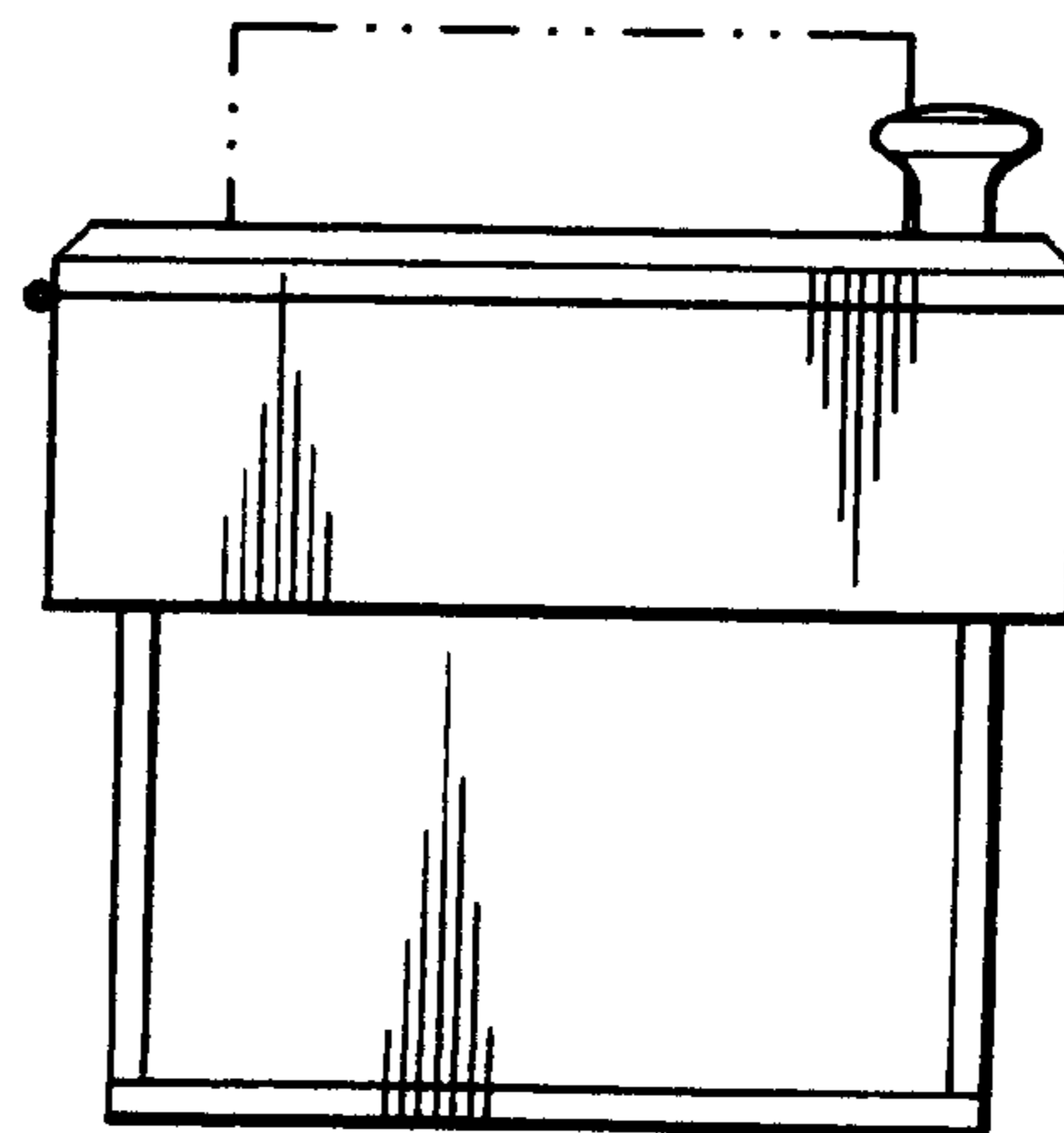

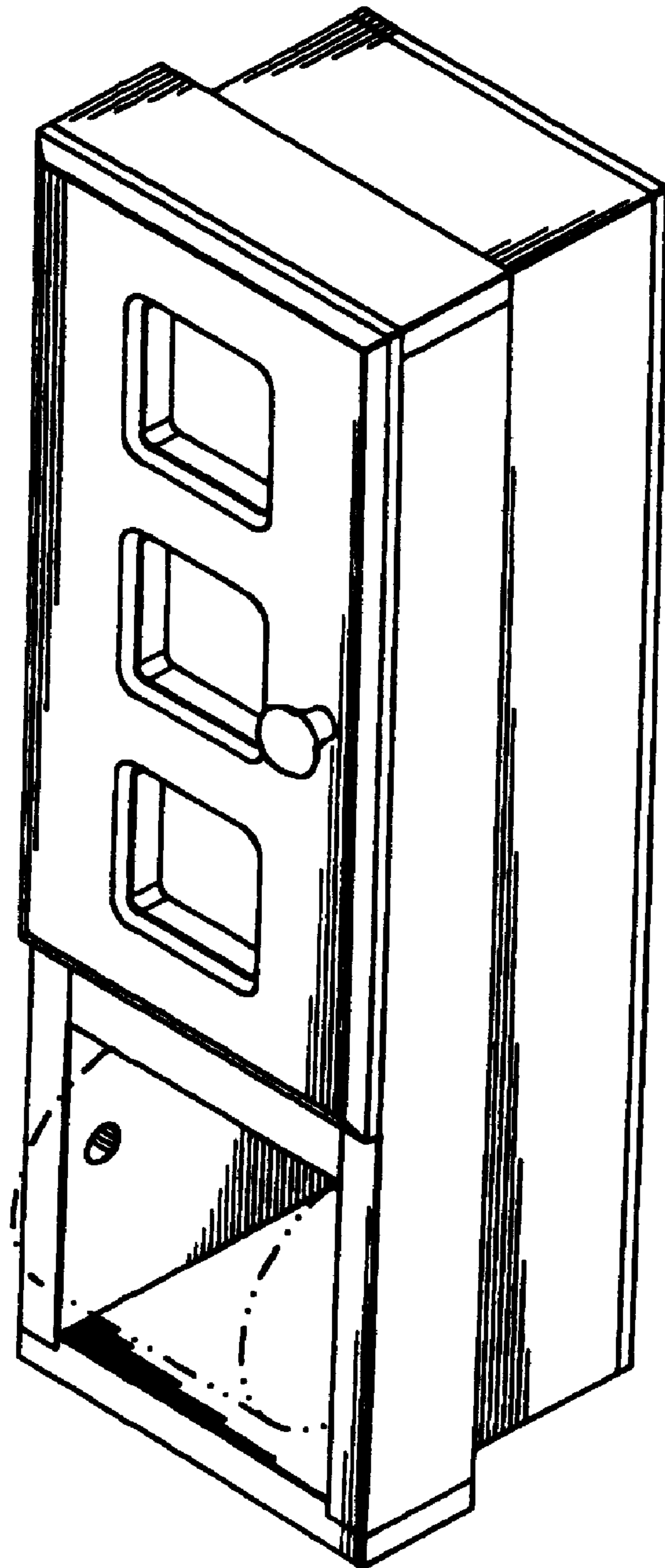
