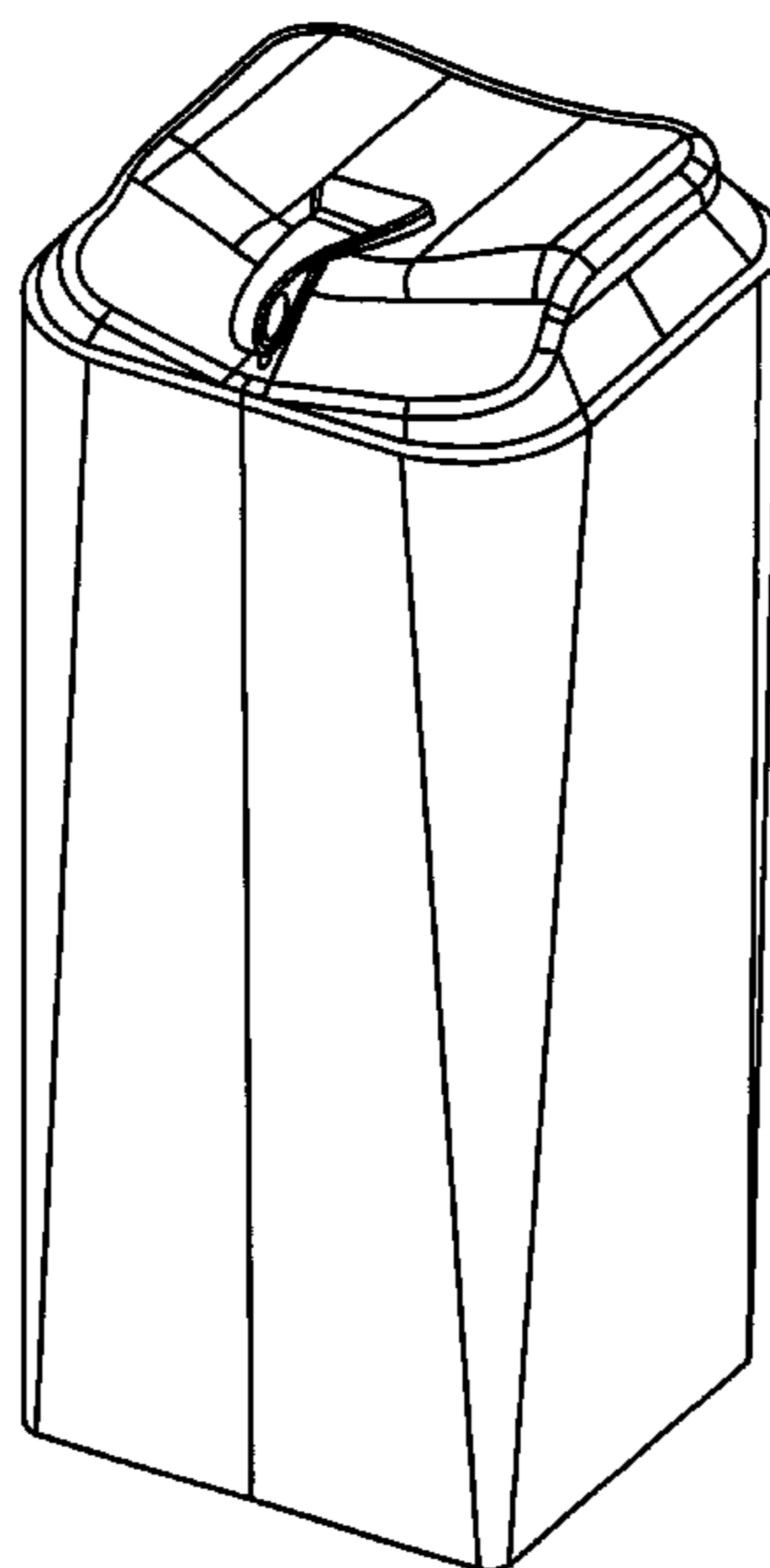
(57) **CLAIM**

The ornamental design for a packaging, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of a packaging showing my new design in the closed position. FIG. 2 is a bottom perspective view thereof. FIG. 3 is a front elevational view thereof. FIG. 4 is a right side elevational view thereof. FIG. 5 is a rear elevational view thereof. FIG. 6 is a left side elevational view thereof. FIG. 7 is a top plan view thereof. FIG. 8 is a front, top perspective view of a packaging showing my new design in the open position; and, FIG. 9 is a is front, top perspective view of a packaging showing my new design in the open position with a straw inserted through the opening. The broken line showing of the straw is for illustrational purposes only and forms no part of the claimed design.

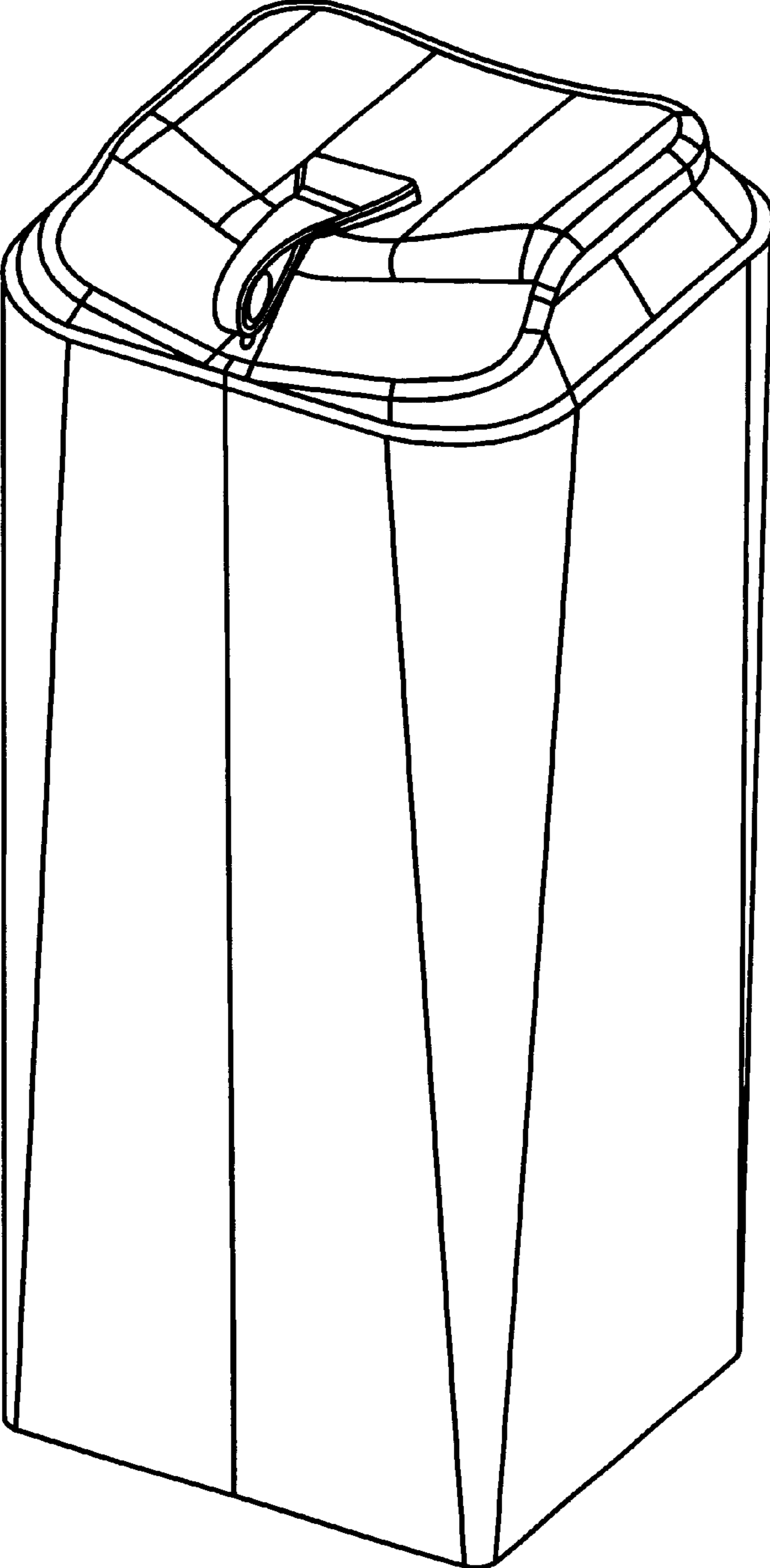

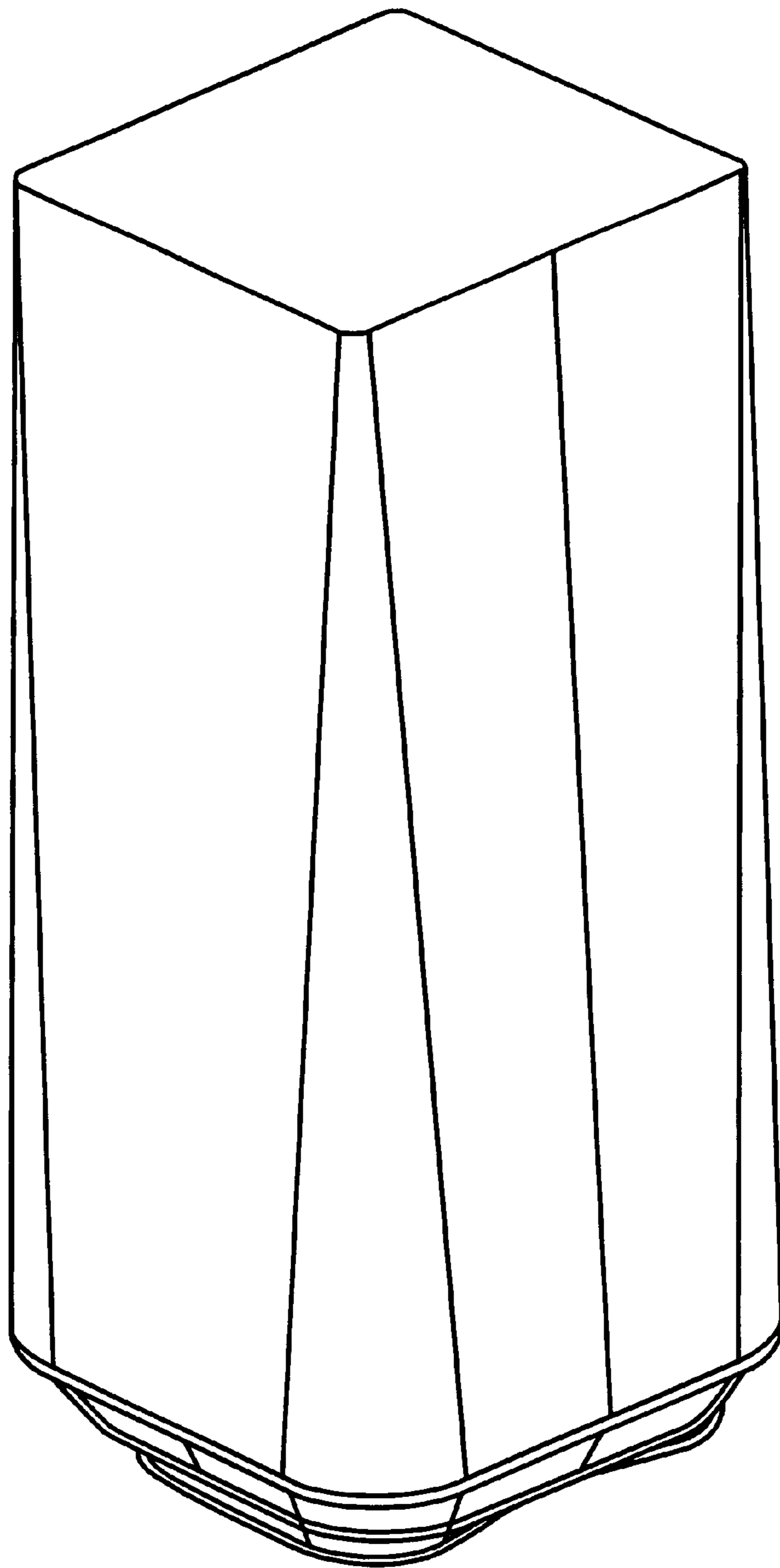

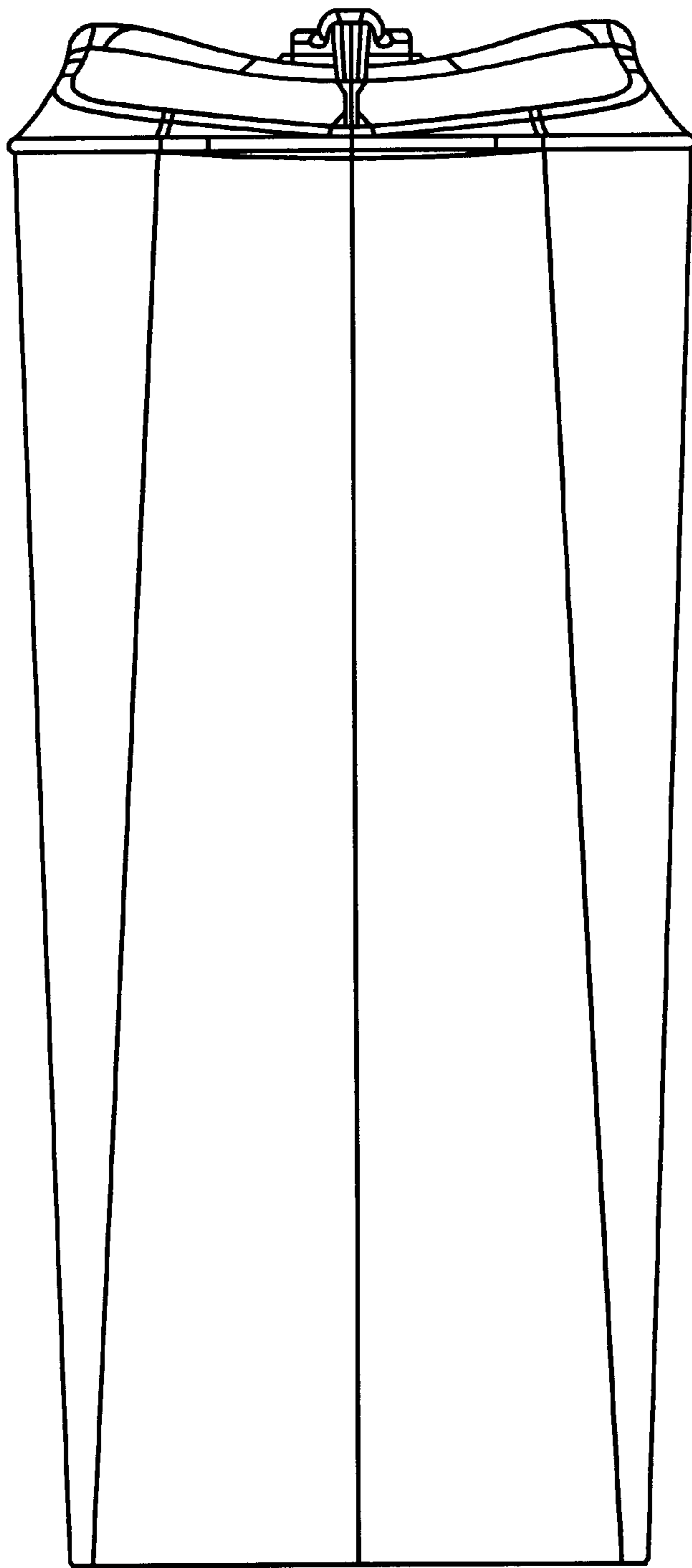

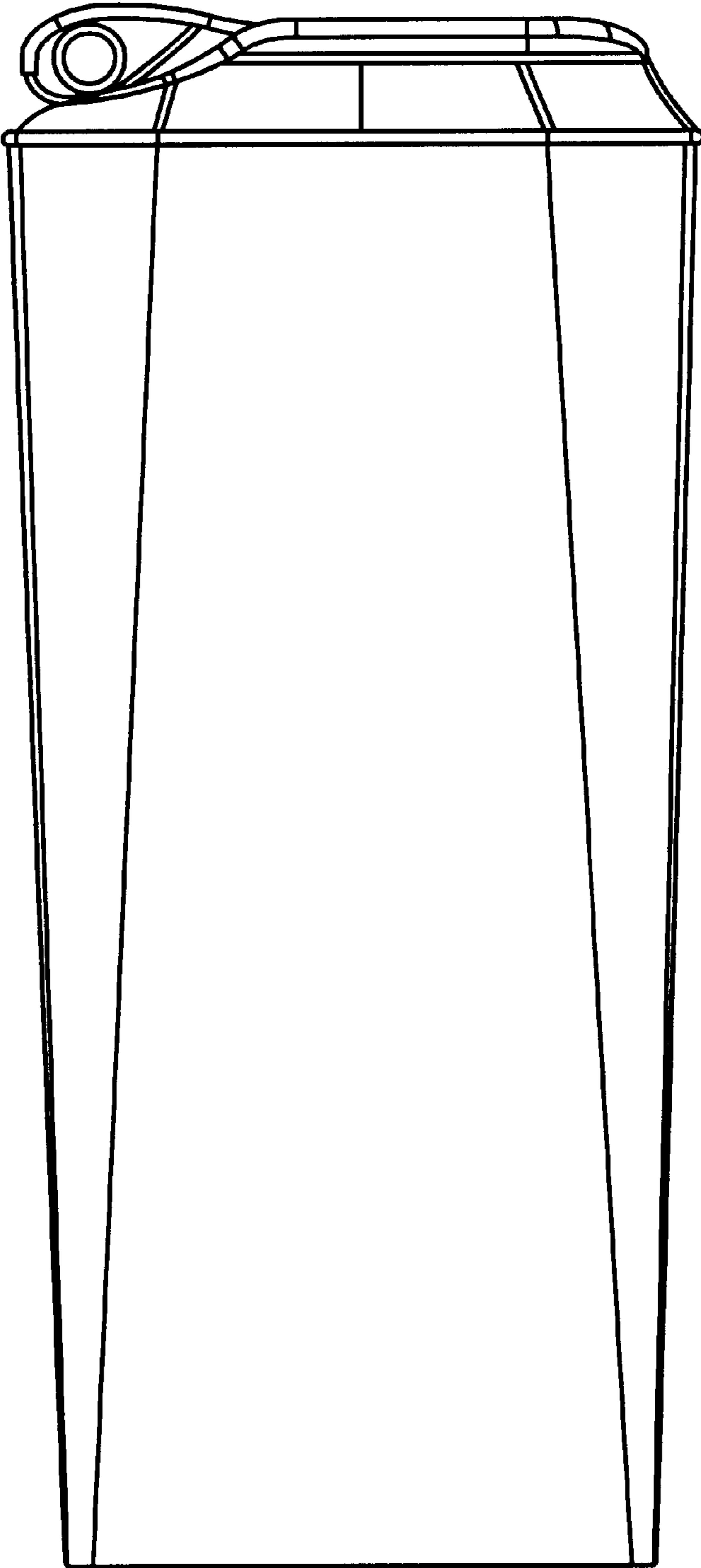

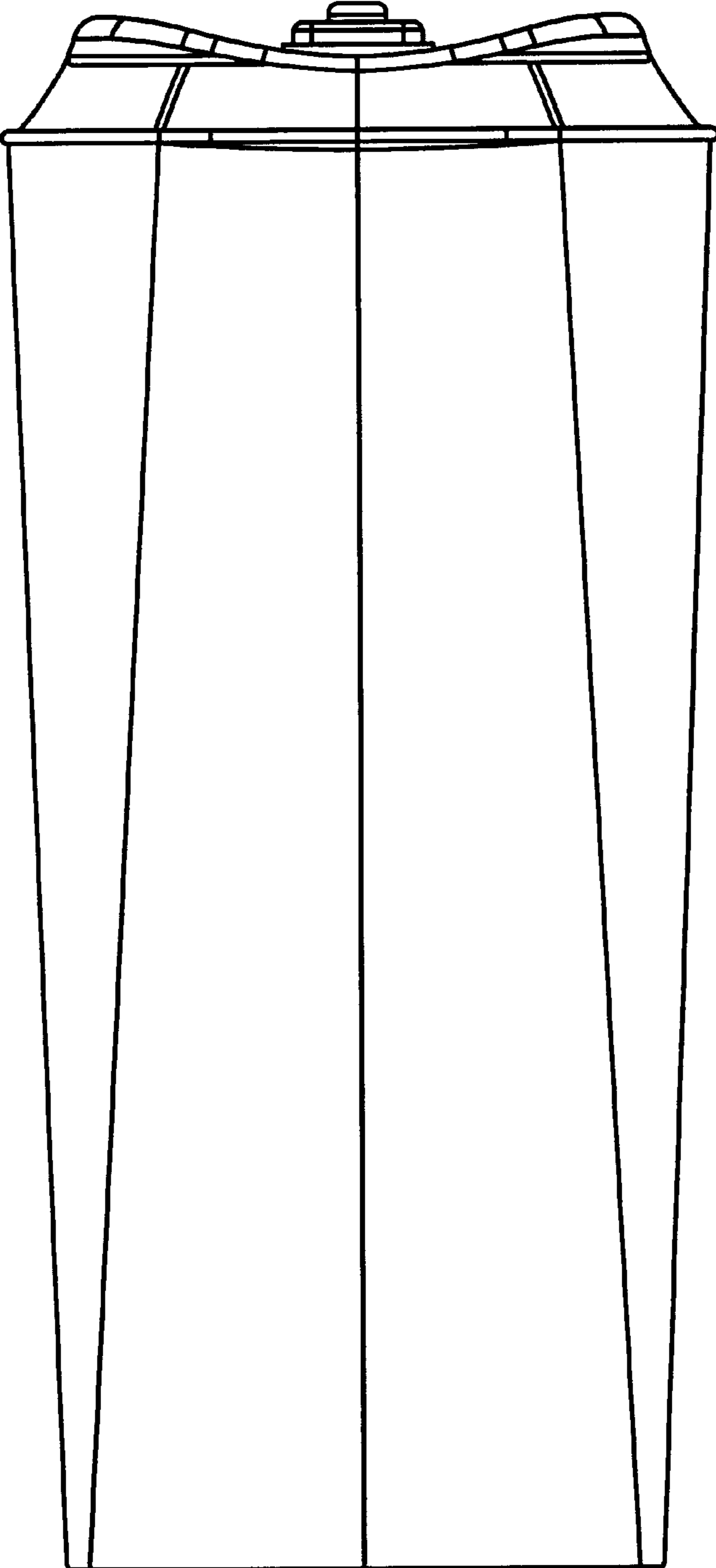

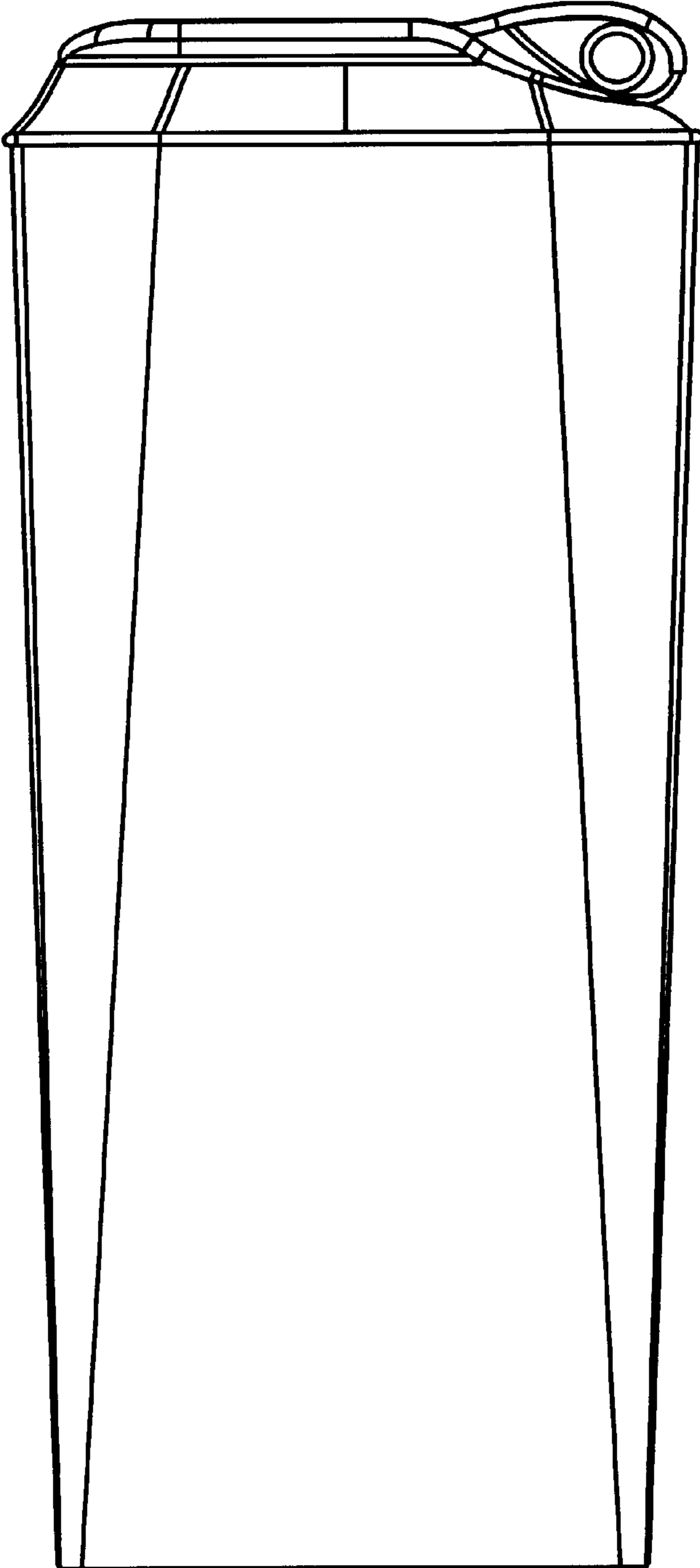

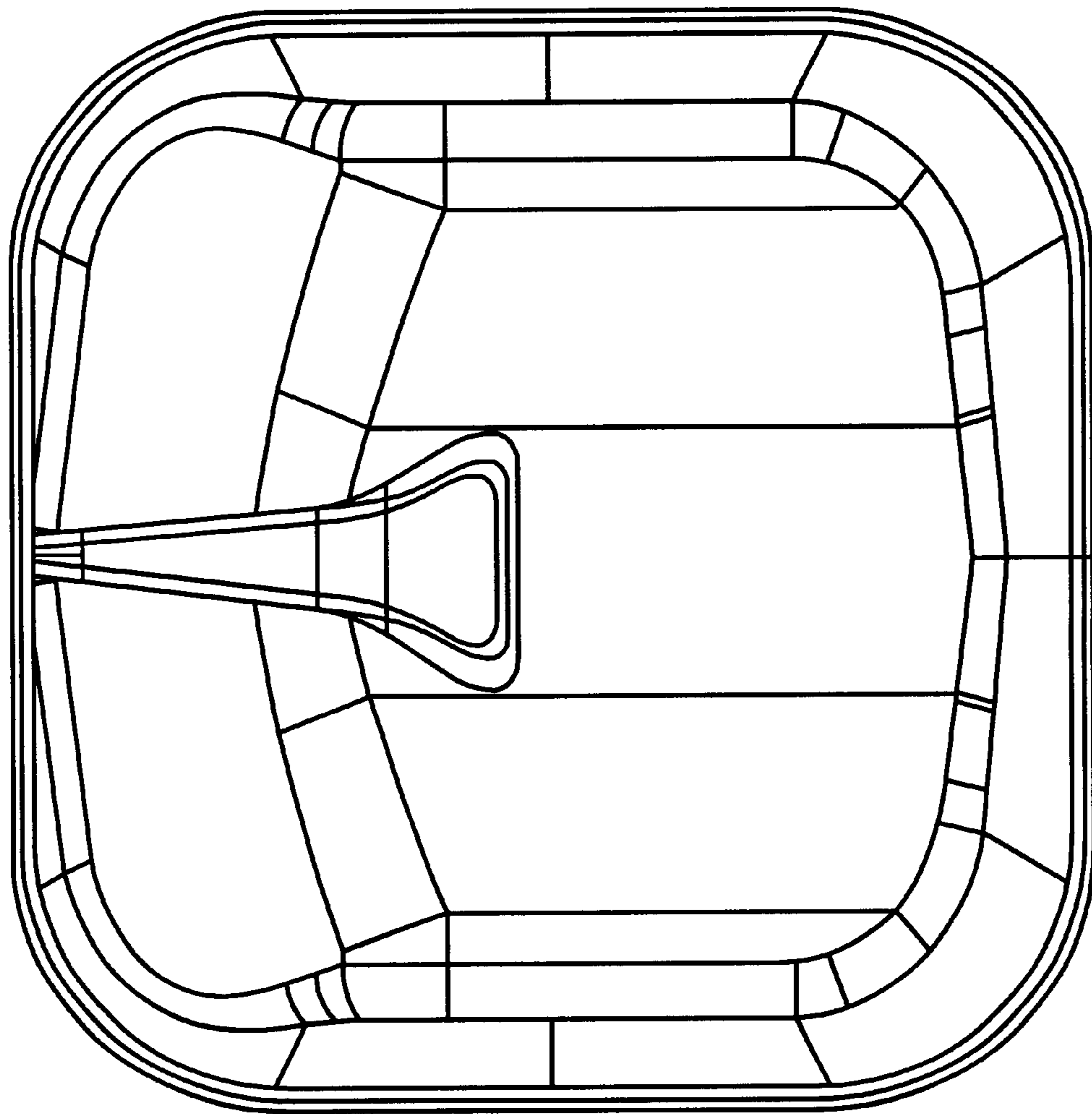

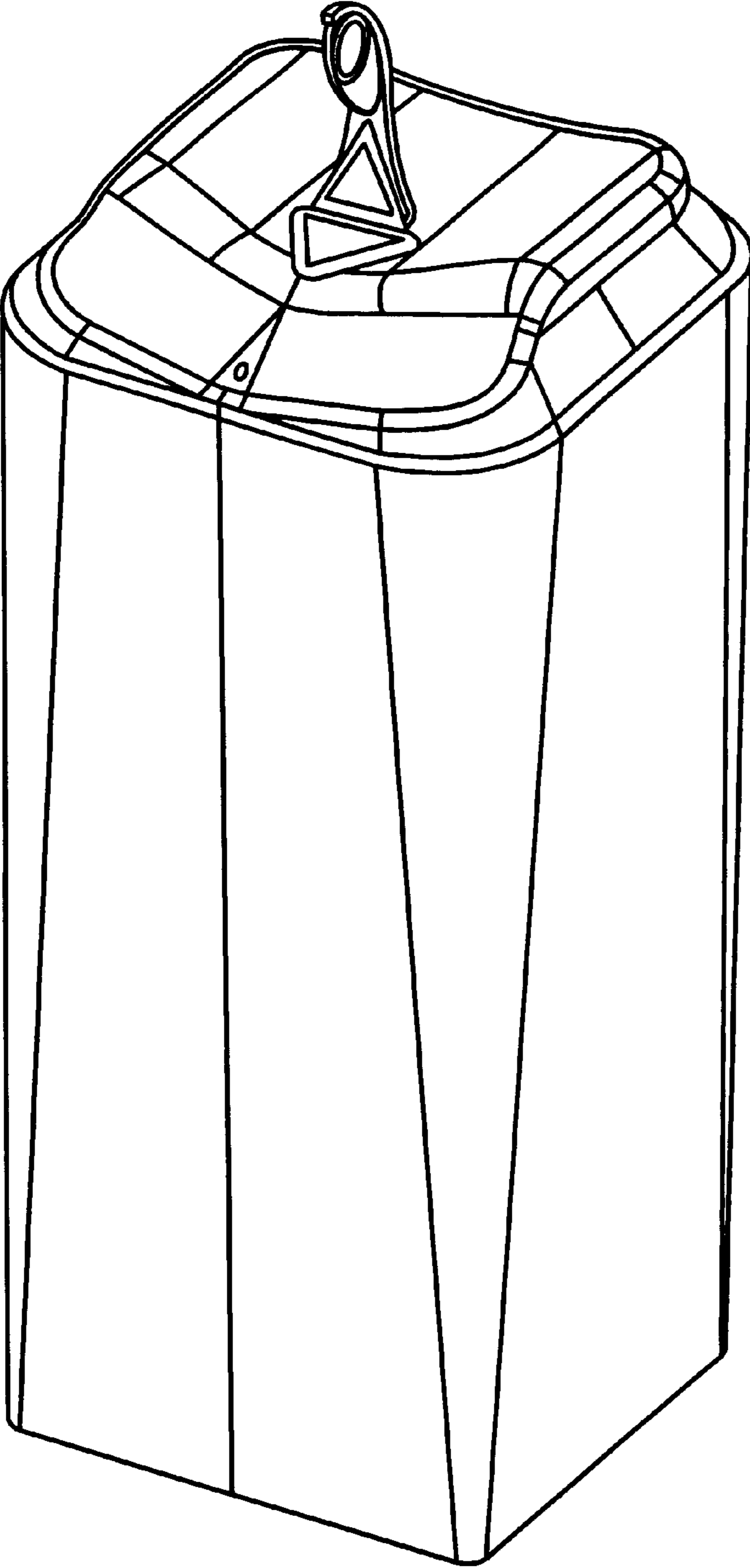

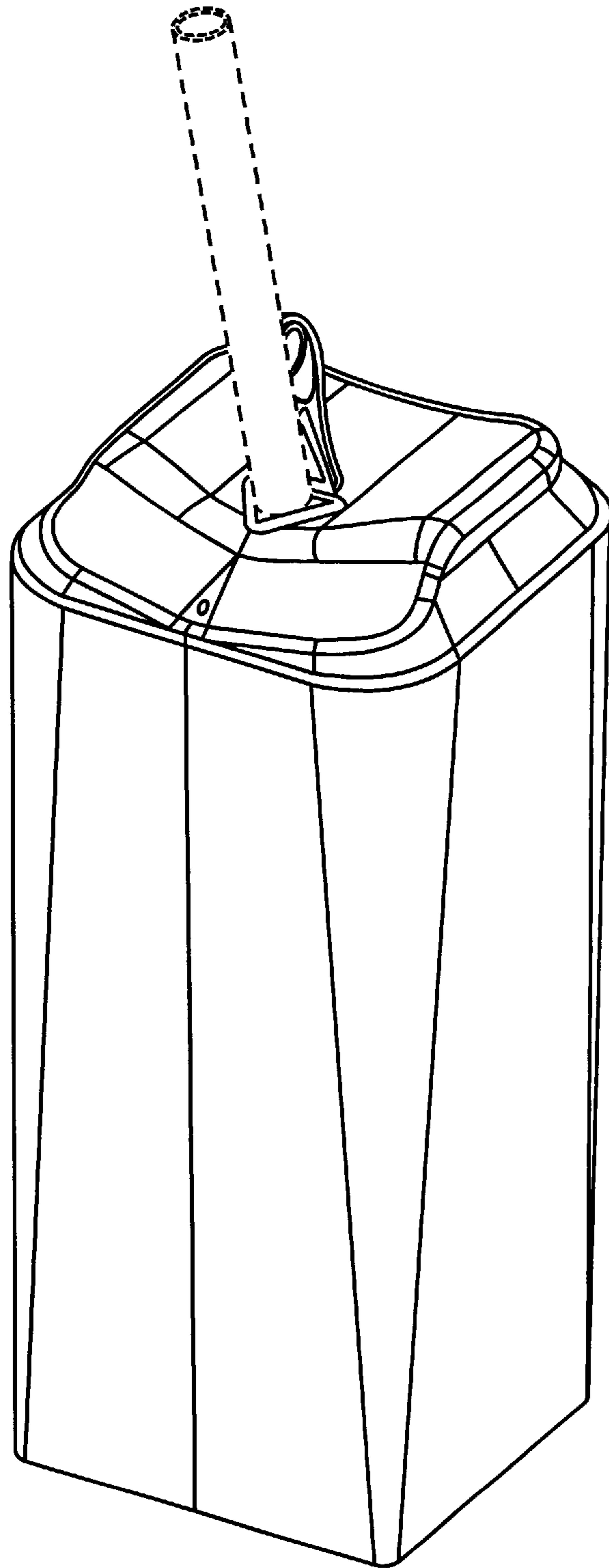
