(57) **CLAIM**

An ornamental design for a beverage bottle neck, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the beverage bottle neck of the claimed design;

FIG. 2 is a rear elevational view thereof;

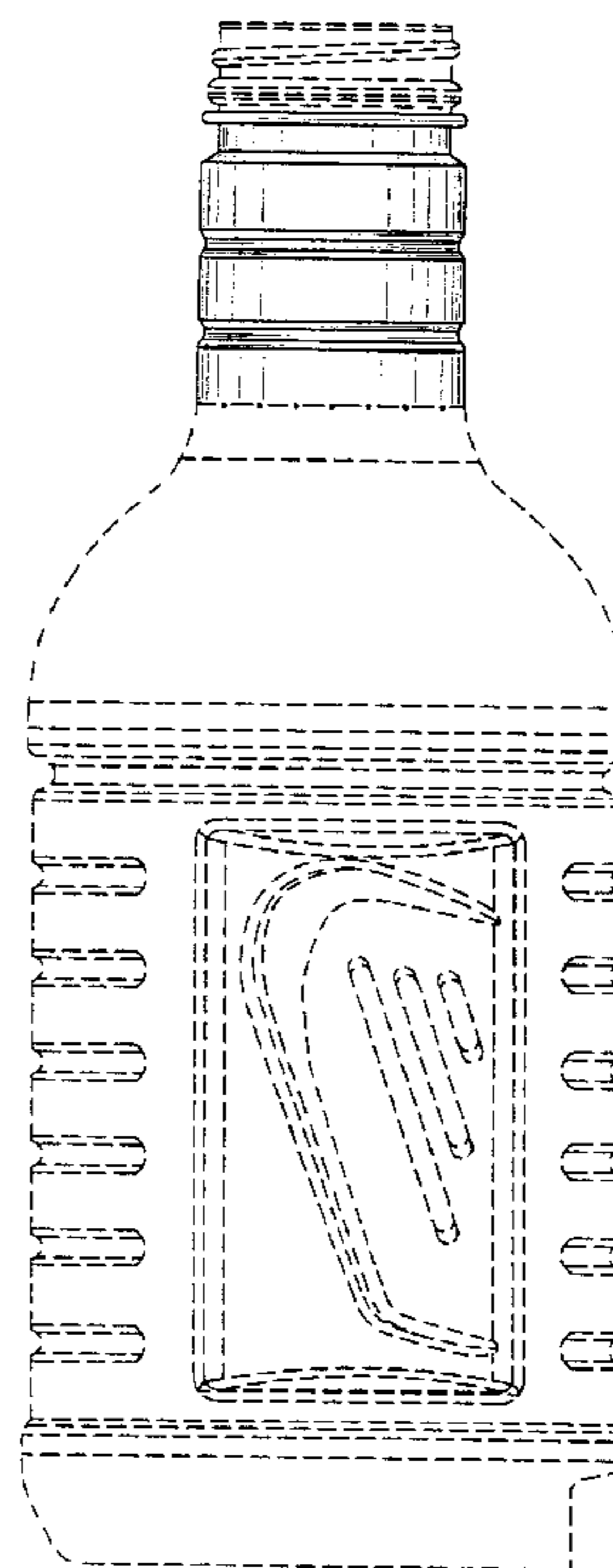
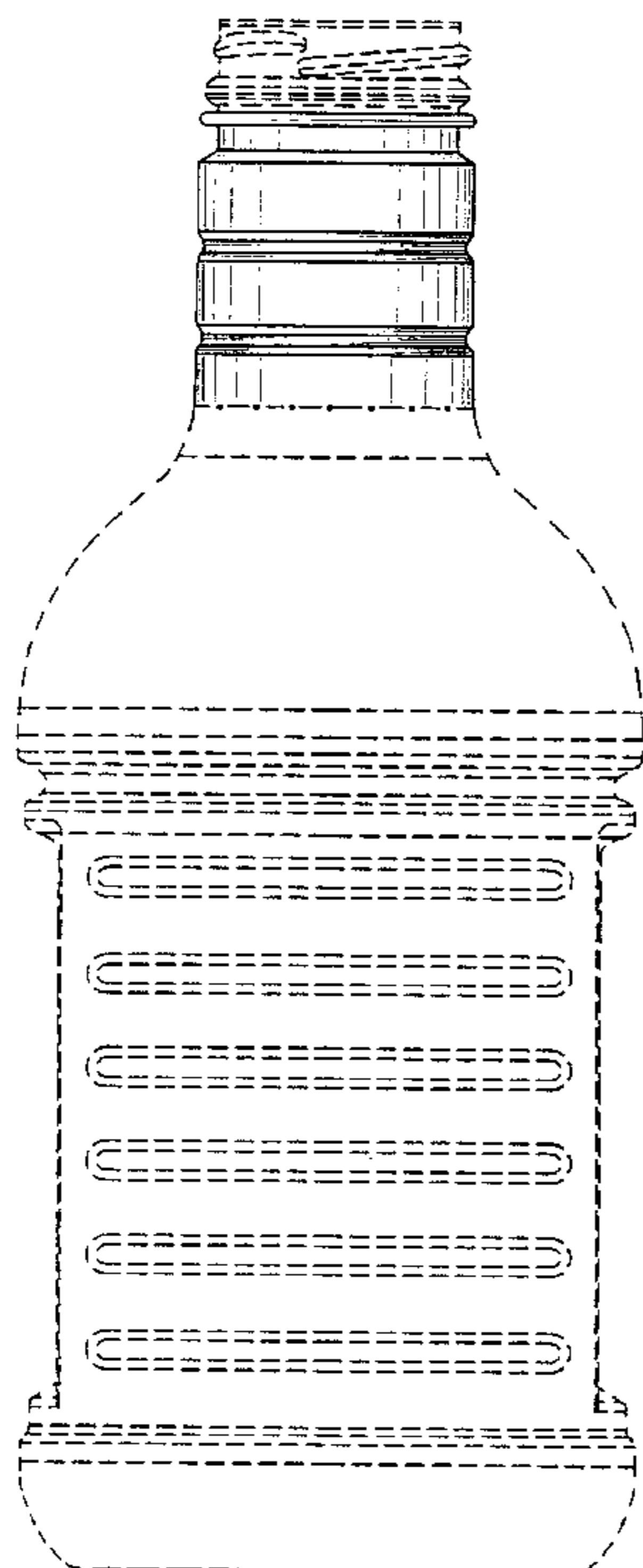
FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image except for the unclaimed threads; and,

FIG. 5 is a top plan view thereof.

The dotted lines shown in FIGS. 1 through 5 are for illustrative purposes only and form no part of the claimed design. The dot-dash-dot lines shown in the Figures define boundaries of the claim.

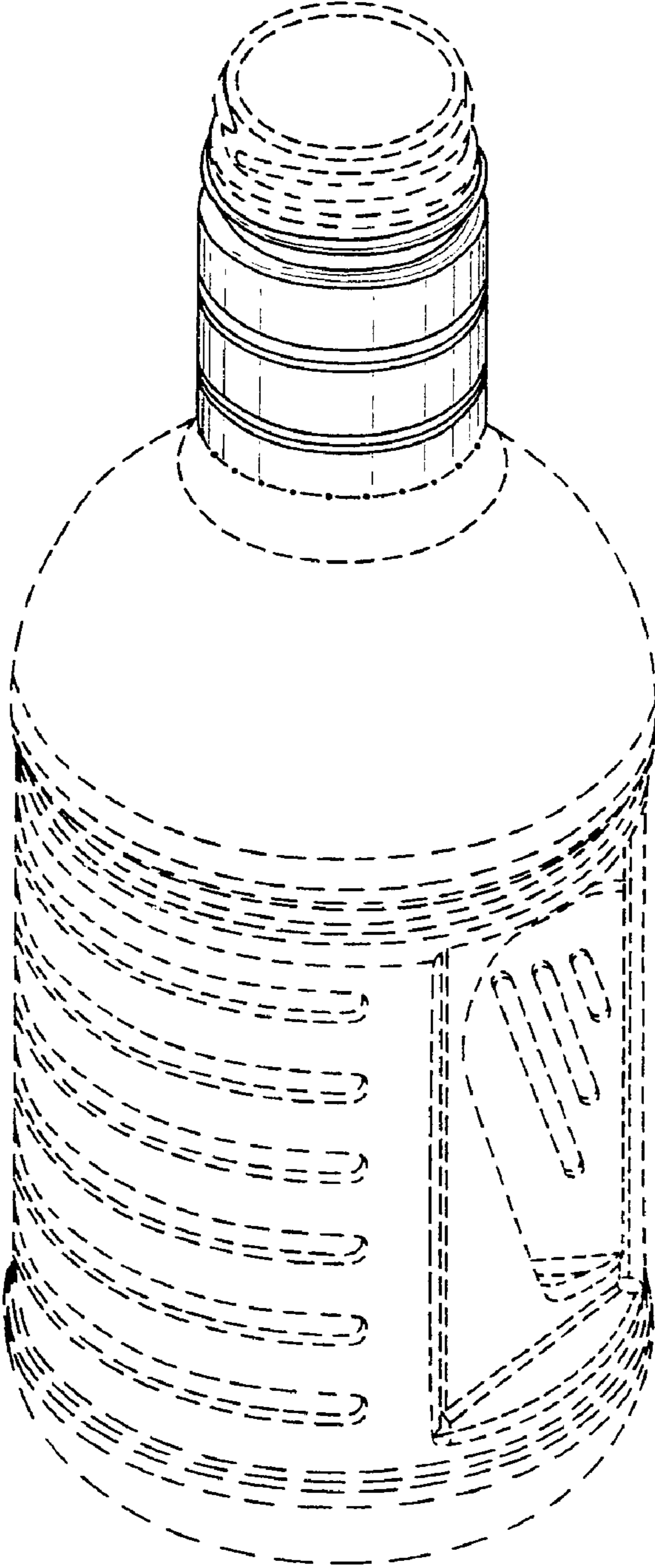

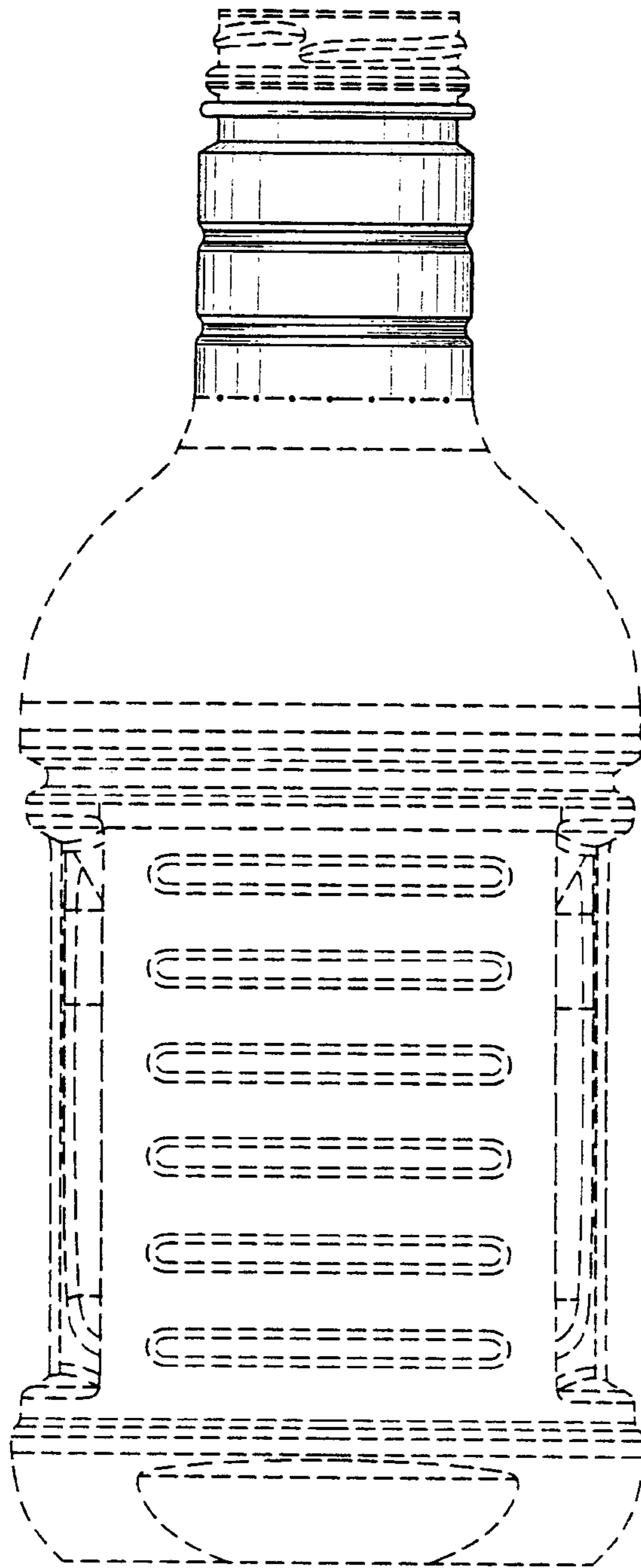

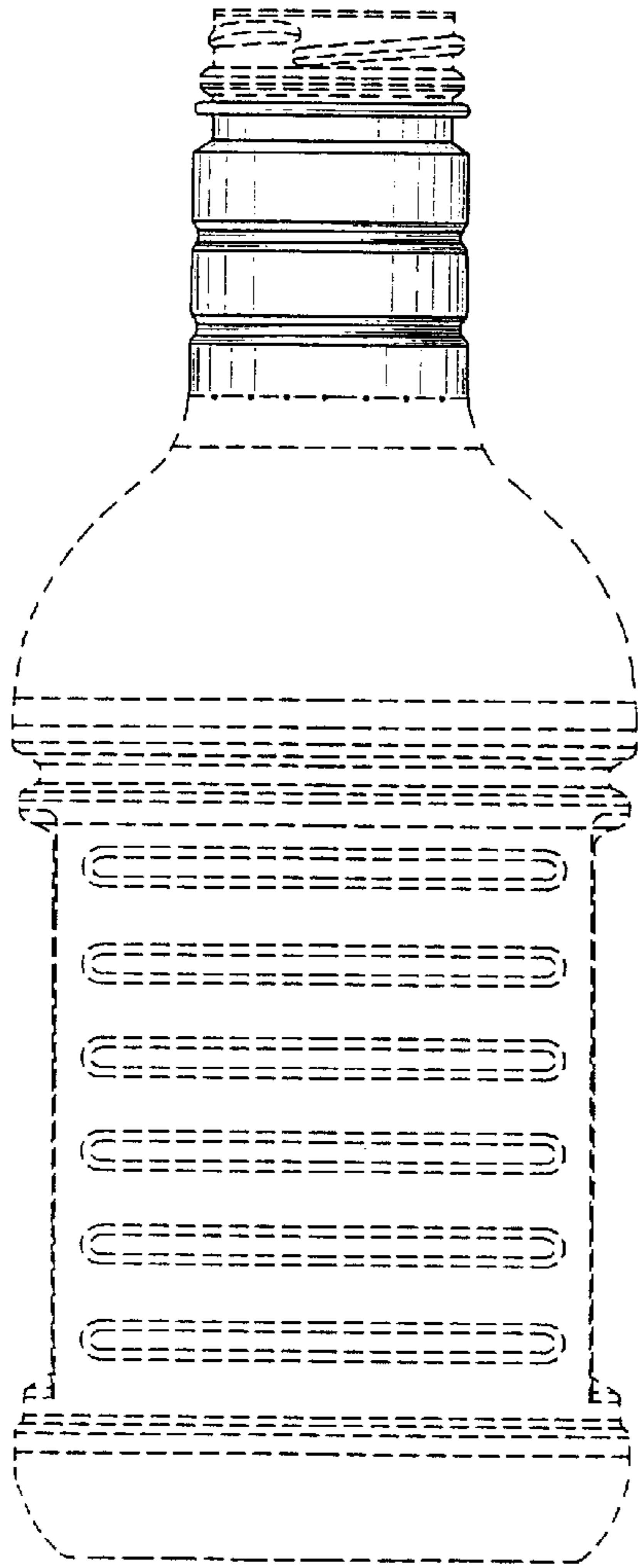

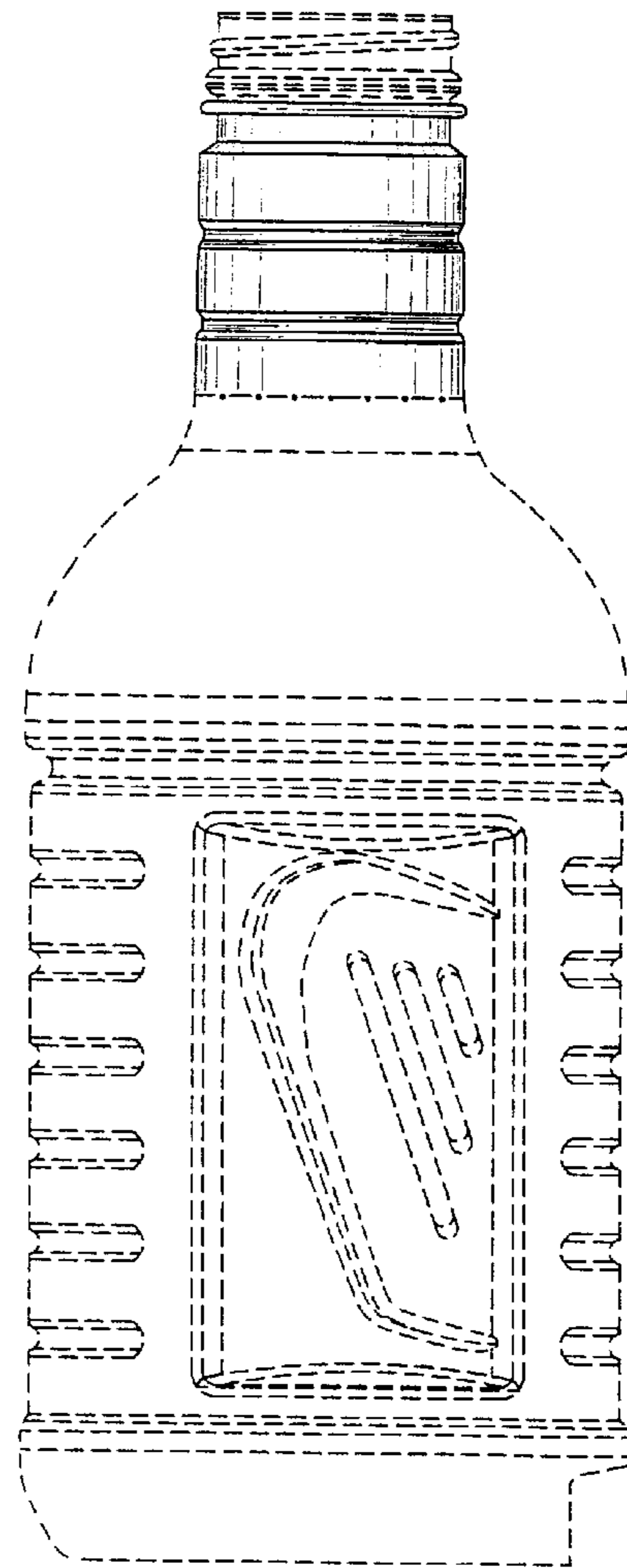

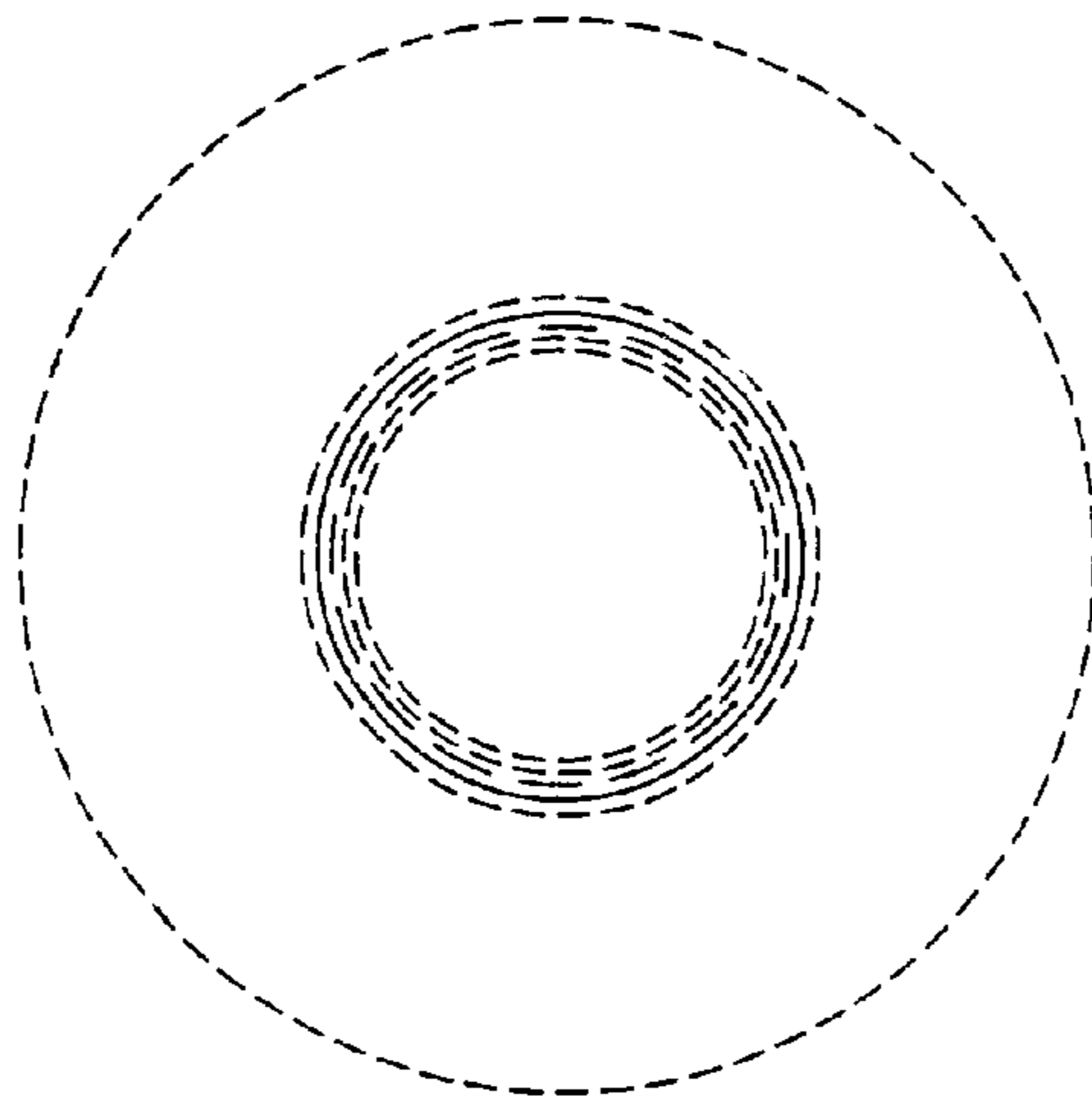
