FIG. 4 is a fragmentary top plan view of the snowmobile track lugs of our design shown in FIG. 2;

FIG. 5 is an elevation view of the snowmobile track lugs of our design shown in FIG. 2;

FIG. 6 is an elevation view of the snowmobile track lugs of our design shown in FIG. 2;

FIG. 7 is an elevation view of the snowmobile track lugs of our design shown in FIG. 2; and,

FIG. 8 is an elevation view of the snowmobile track lugs of our design shown in FIG. 2.

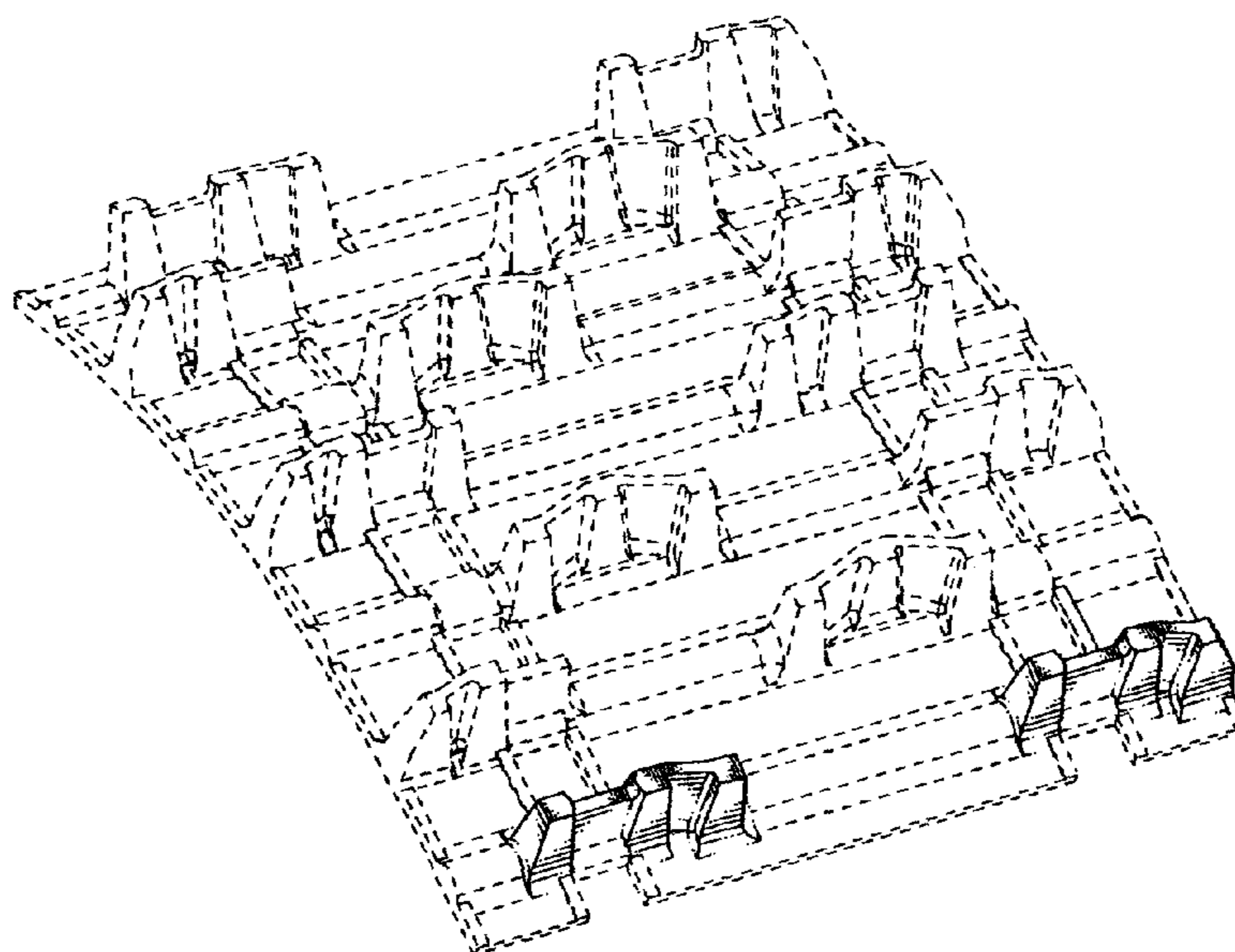

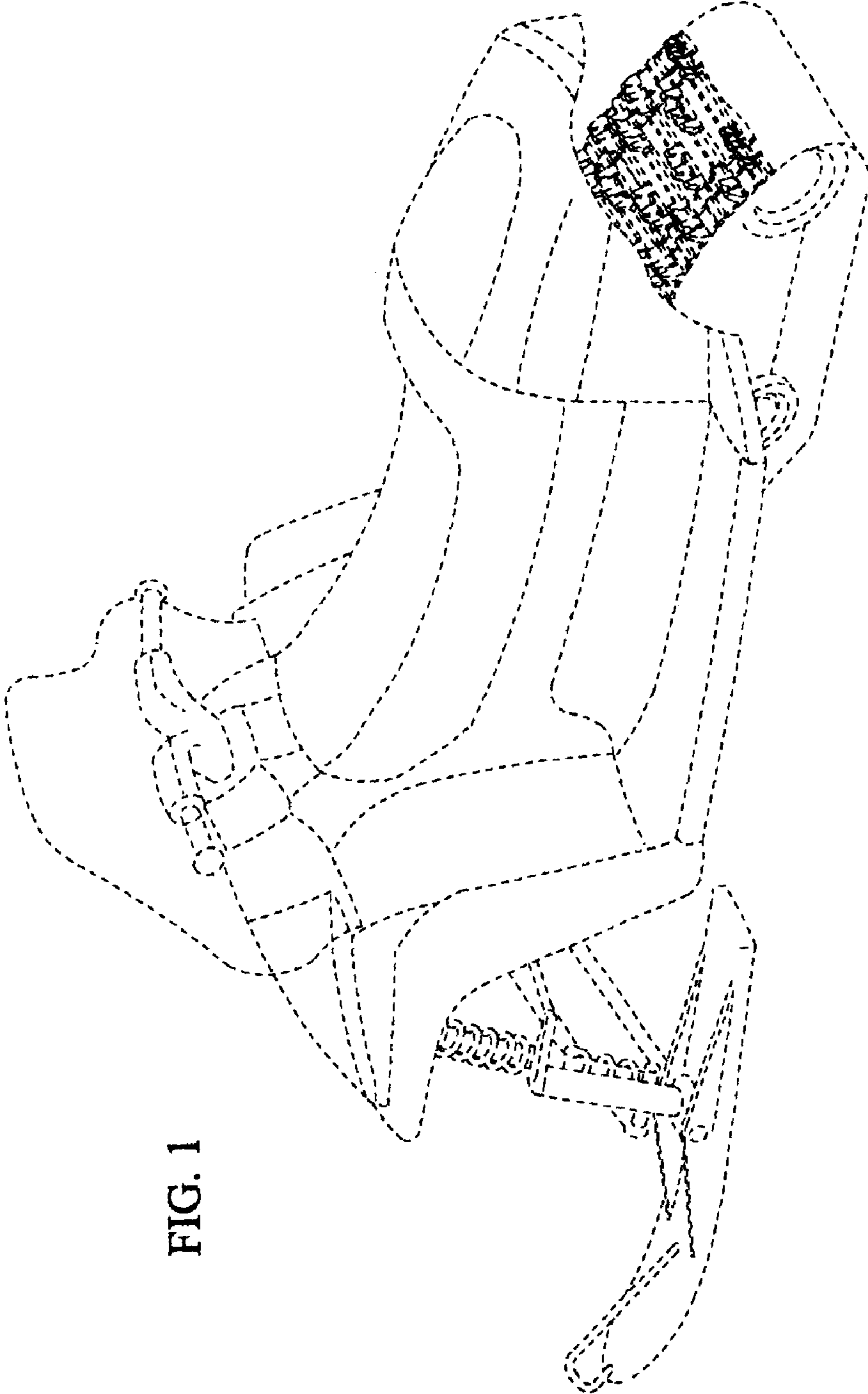

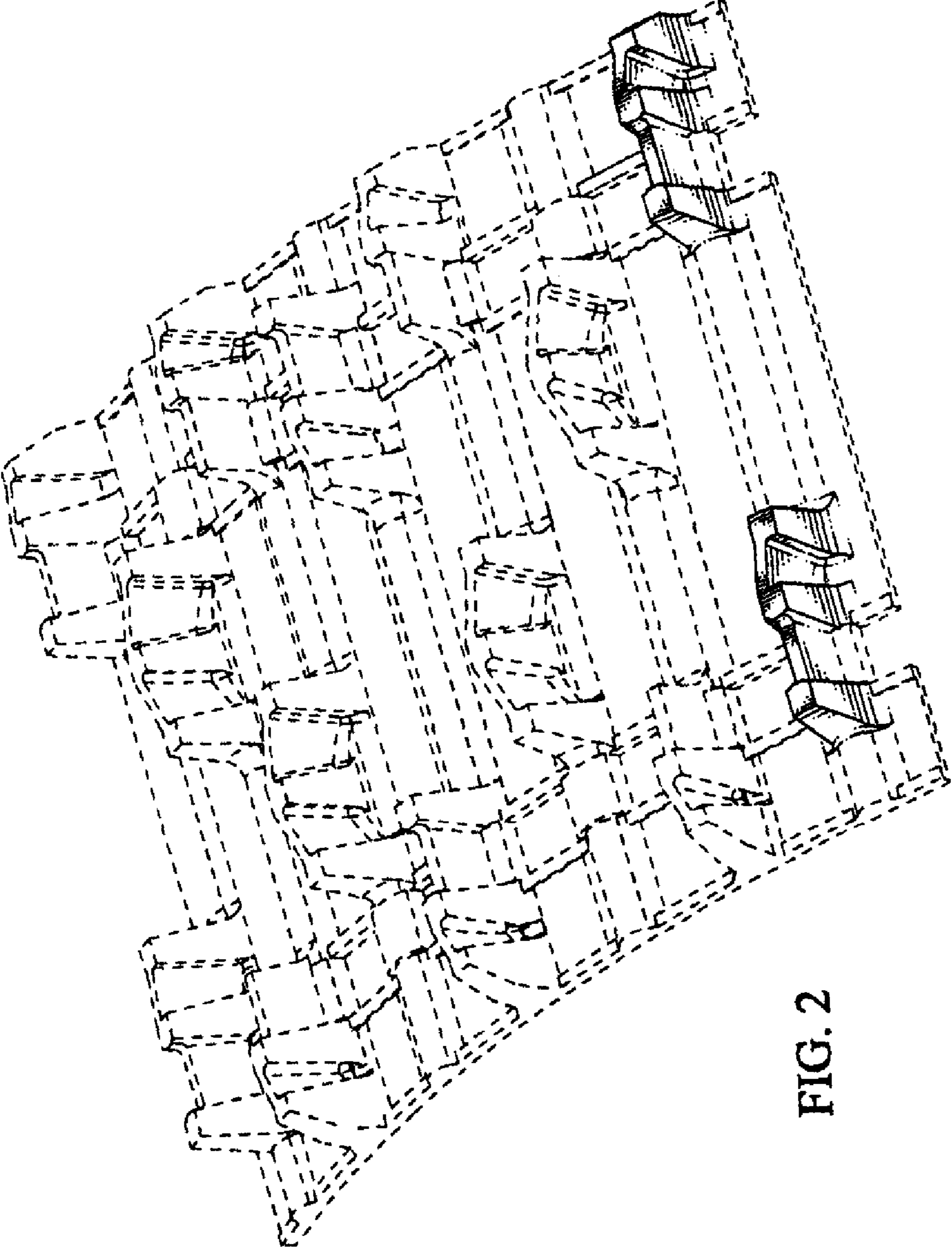

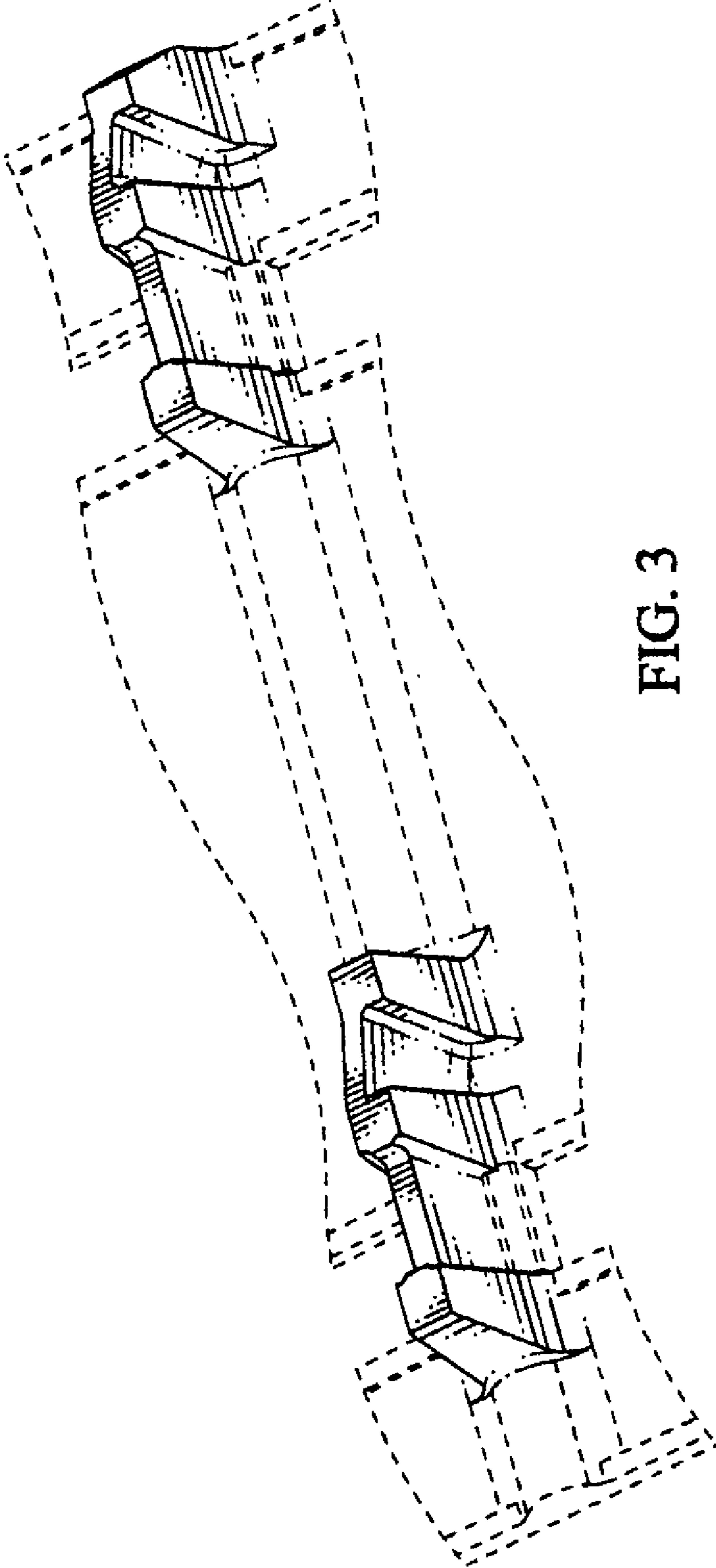

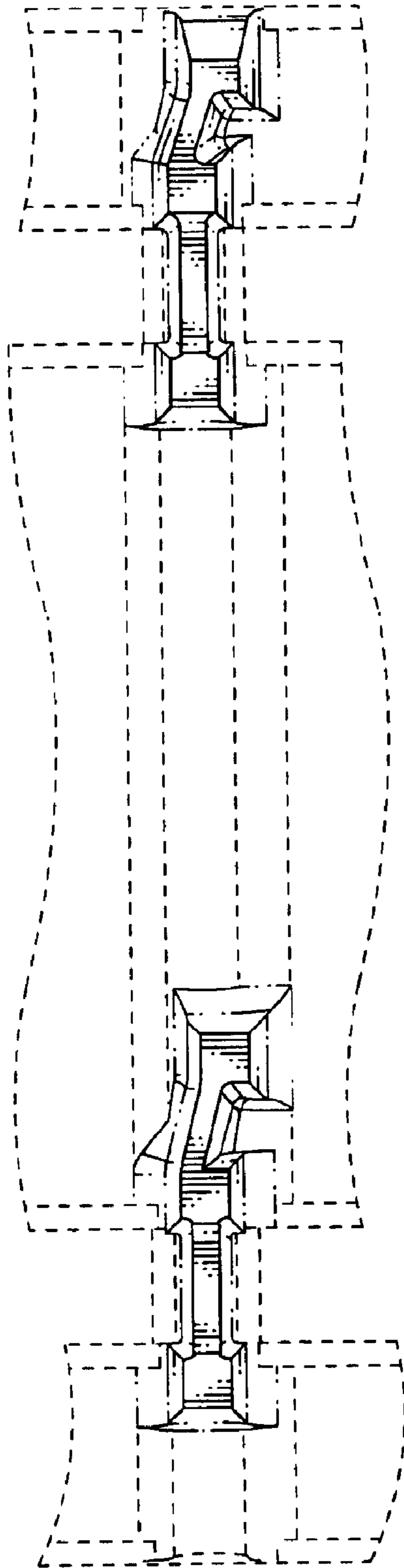

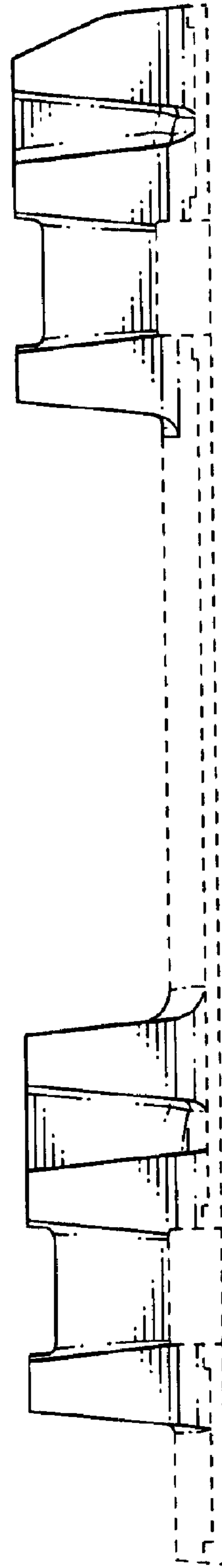

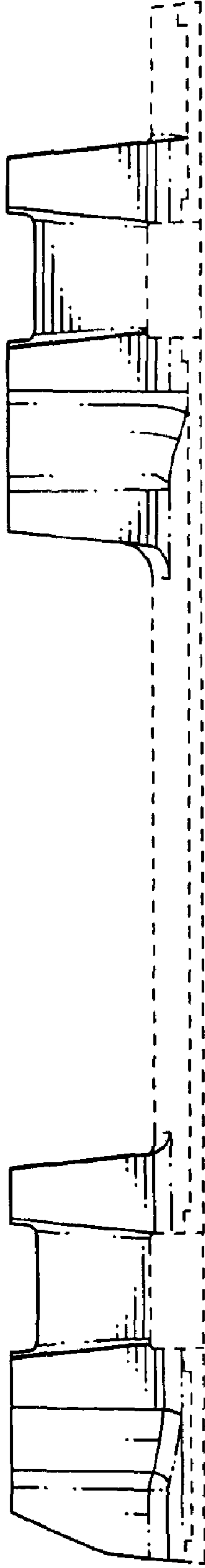

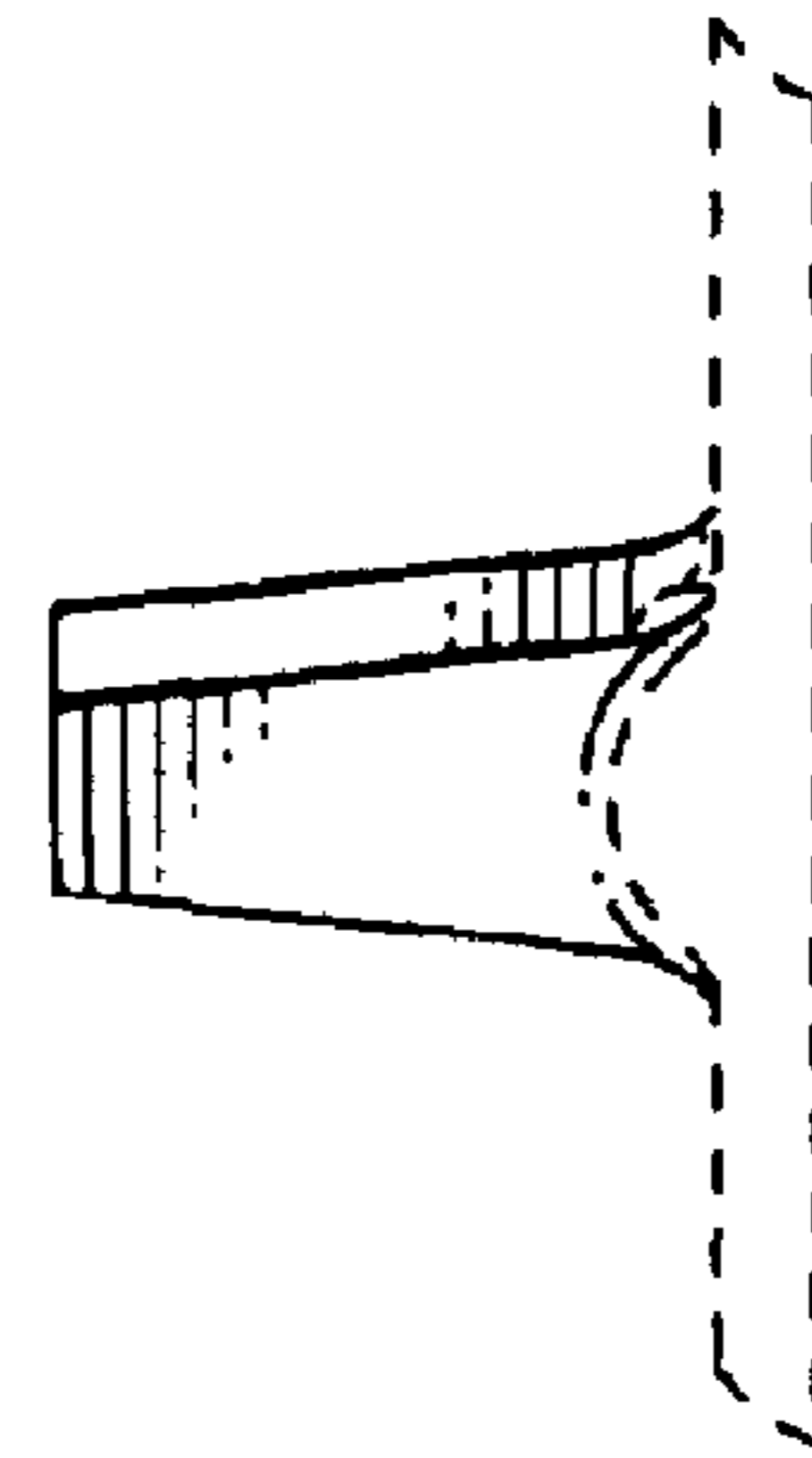

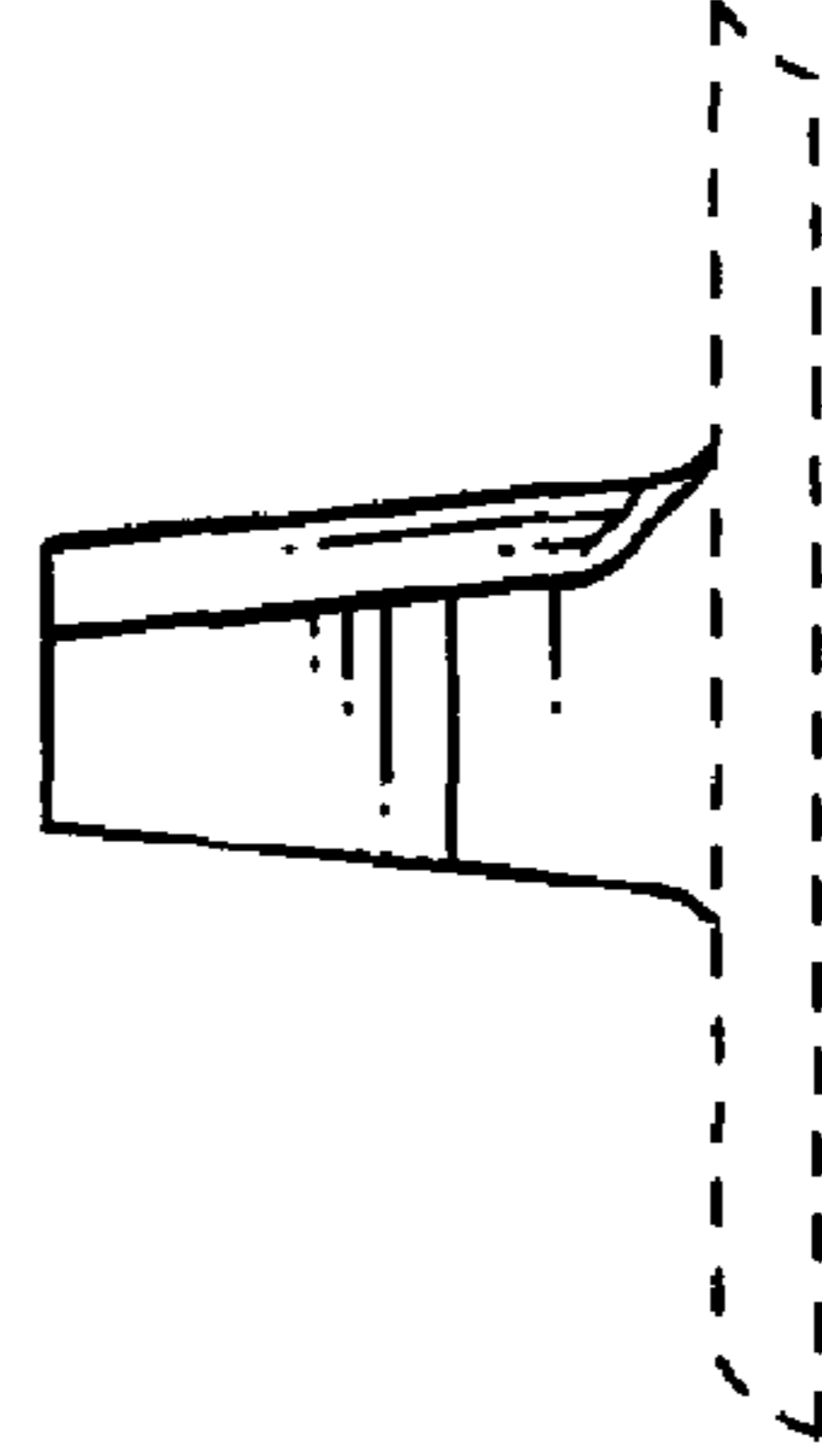
