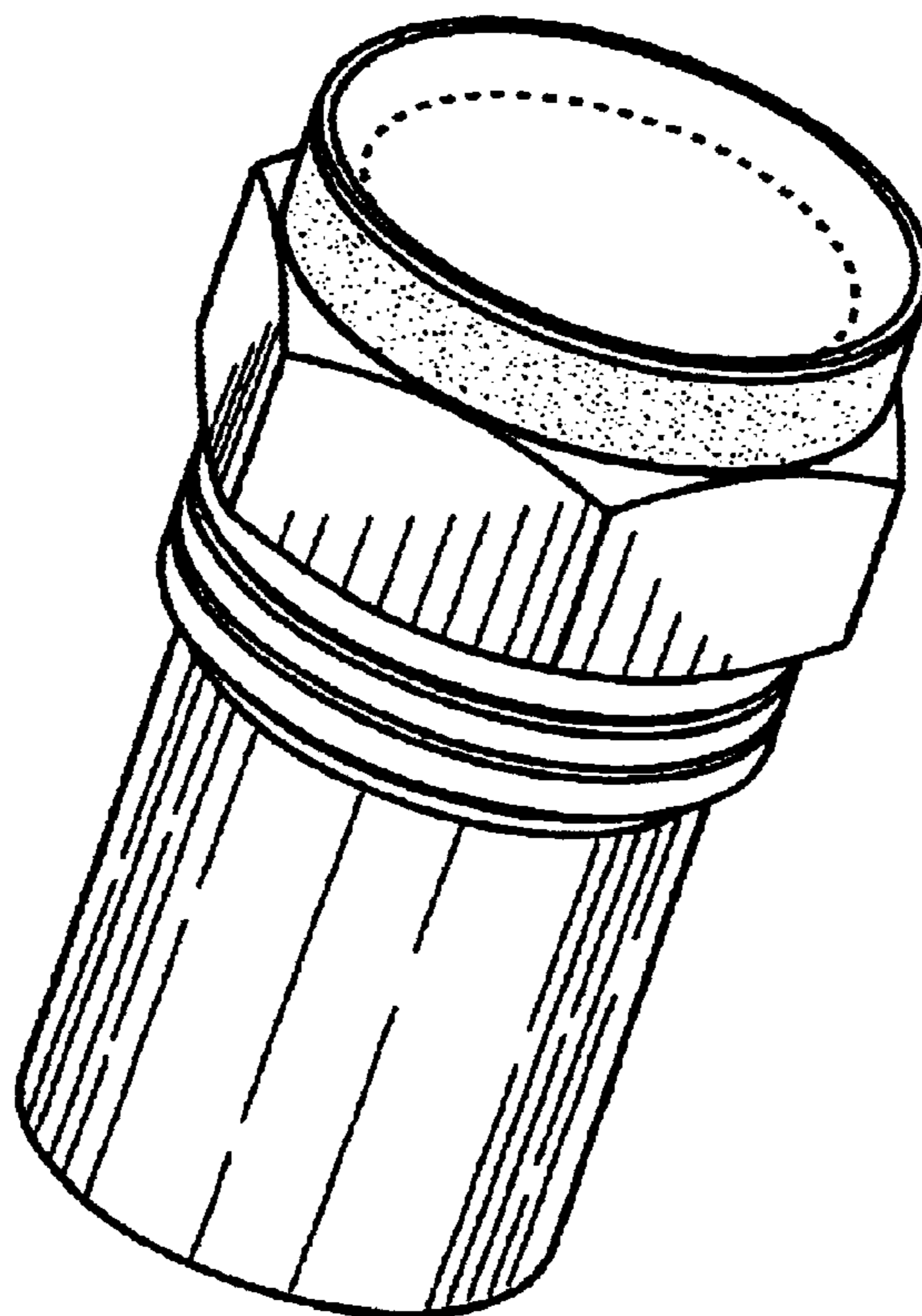
(57) **CLAIM**

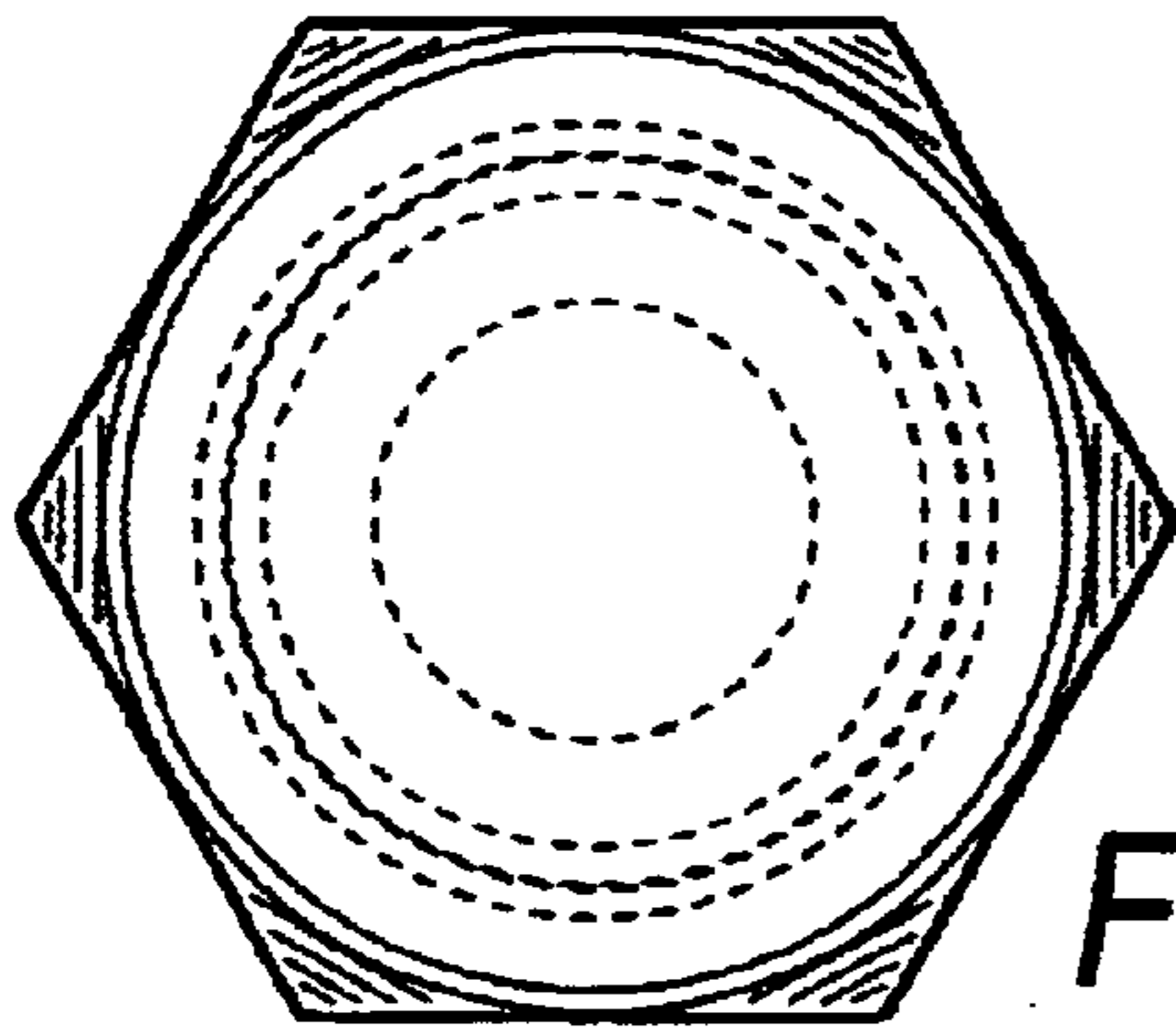
The ornamental design for a coaxial cable connector with colored band, as shown and described.

**DESCRIPTION**

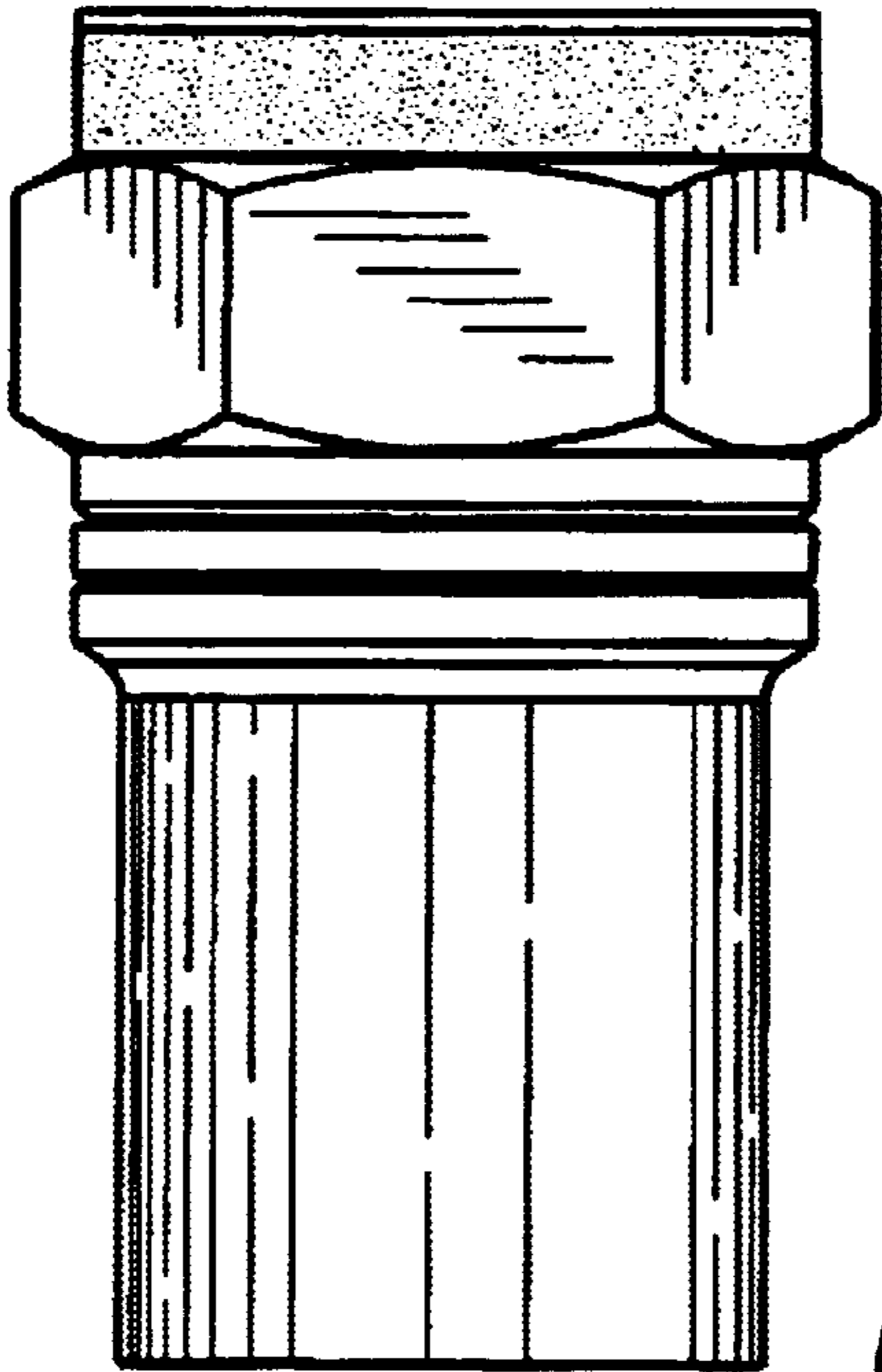
FIG. 1 is a perspective view of a coaxial cable connector with colored band showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is an end view thereof; and, FIG. 4 is an opposite end view thereof. 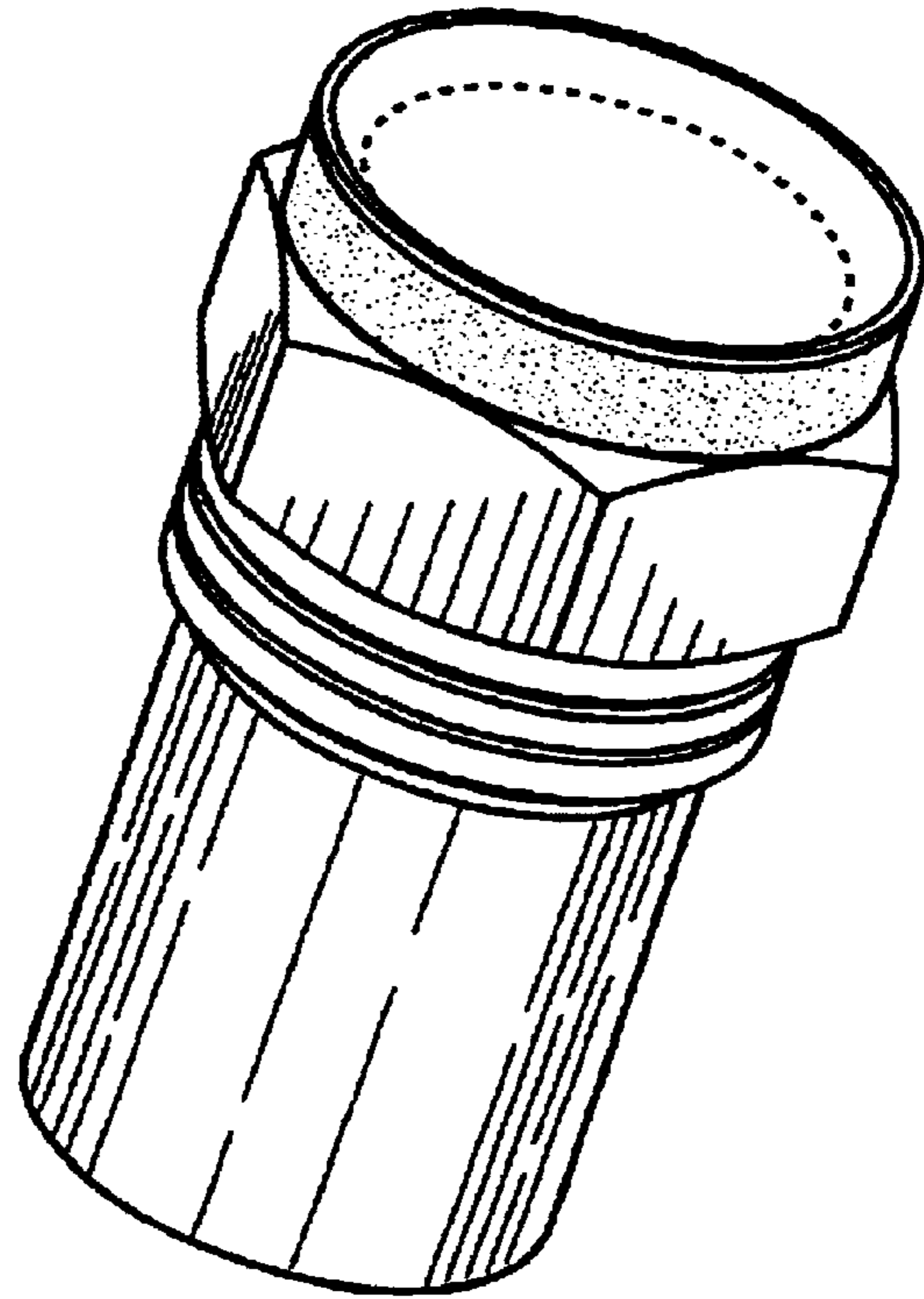




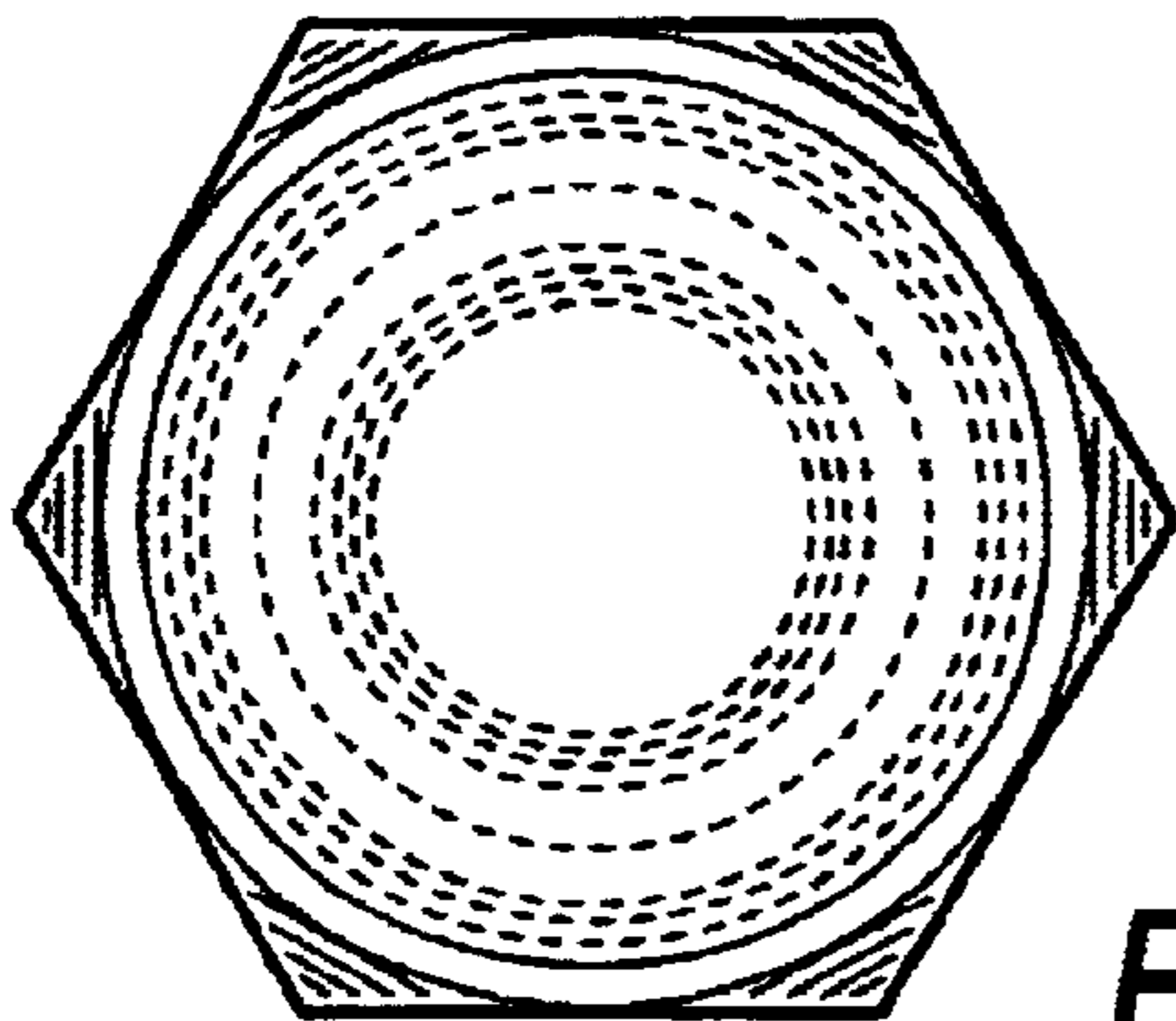
