**DESCRIPTION**

FIG. 1 is perspective view of a faucet incorporating our new design, viewed from in front of, above, and from the right side of the faucet;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof;

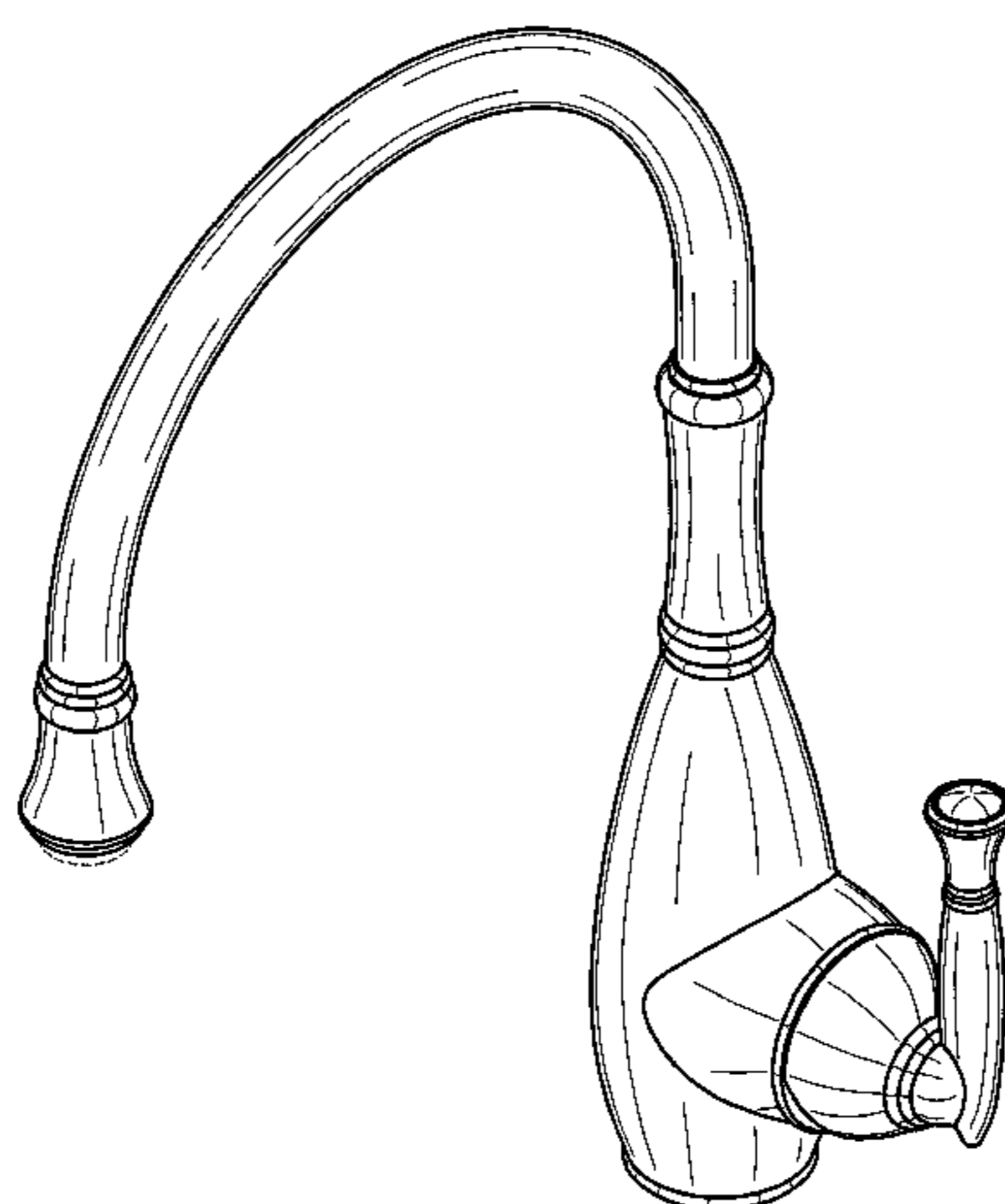
FIG. 5 is a bottom plan view thereof;

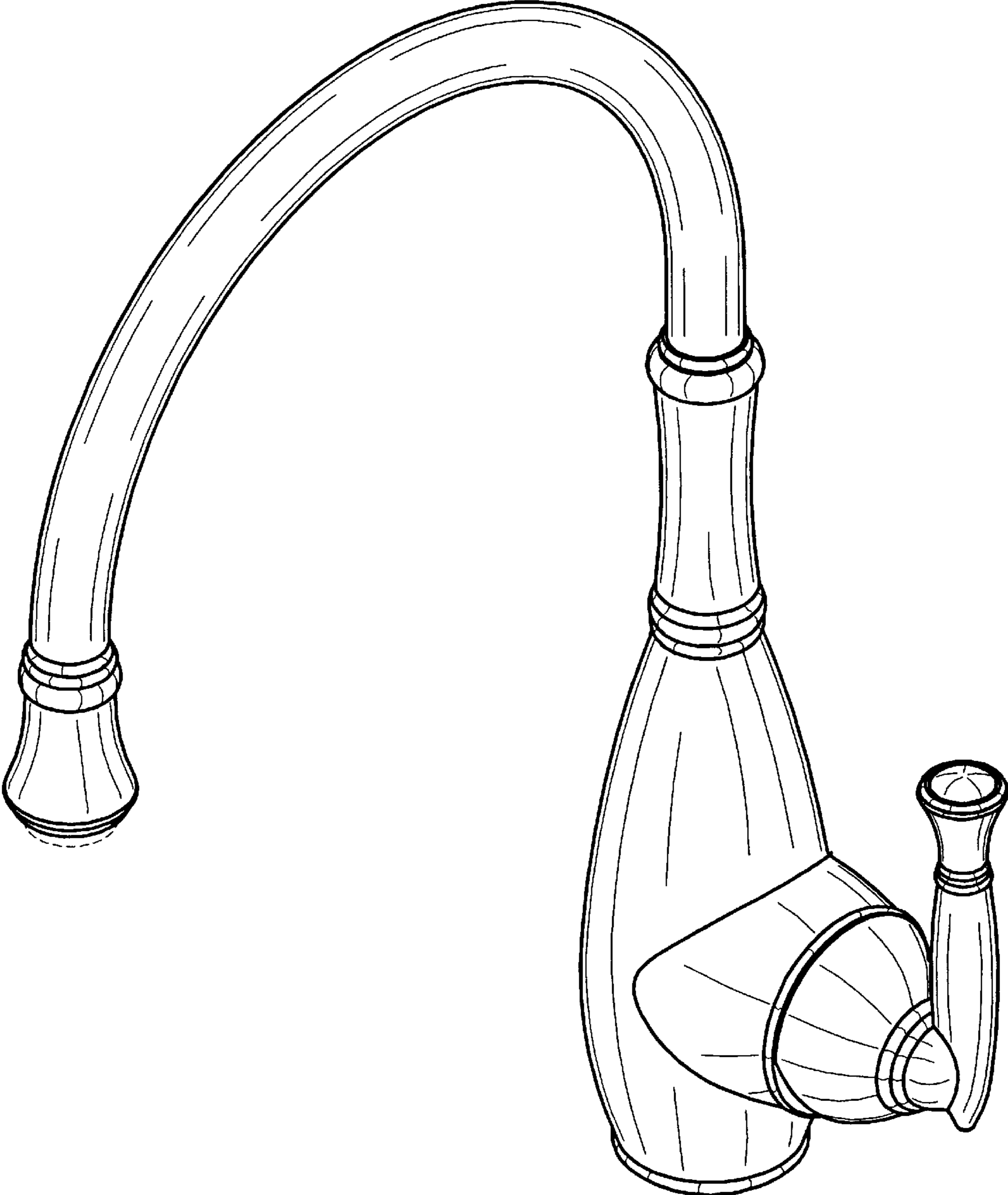

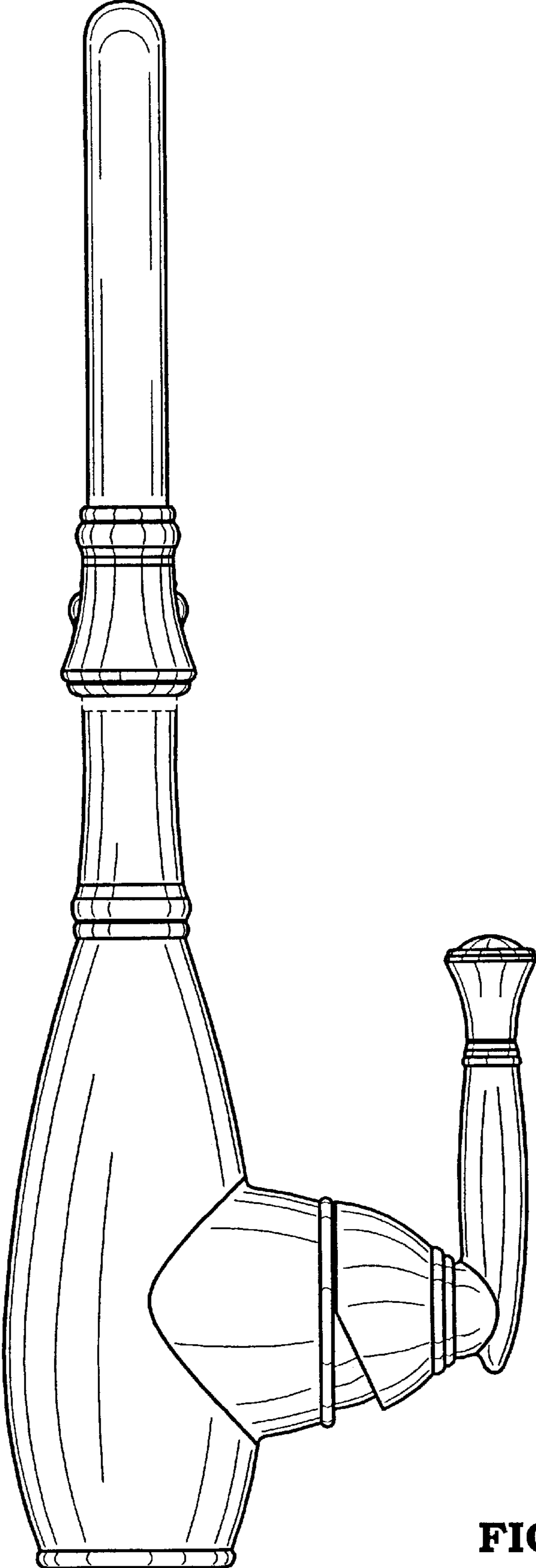
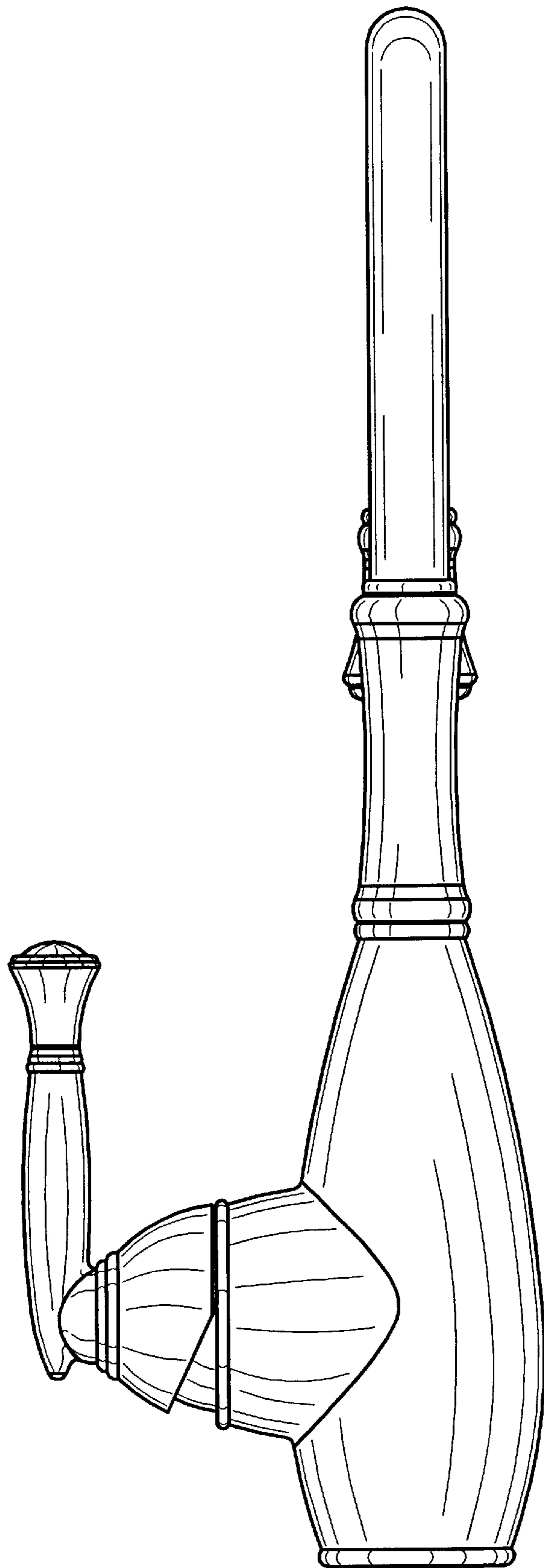
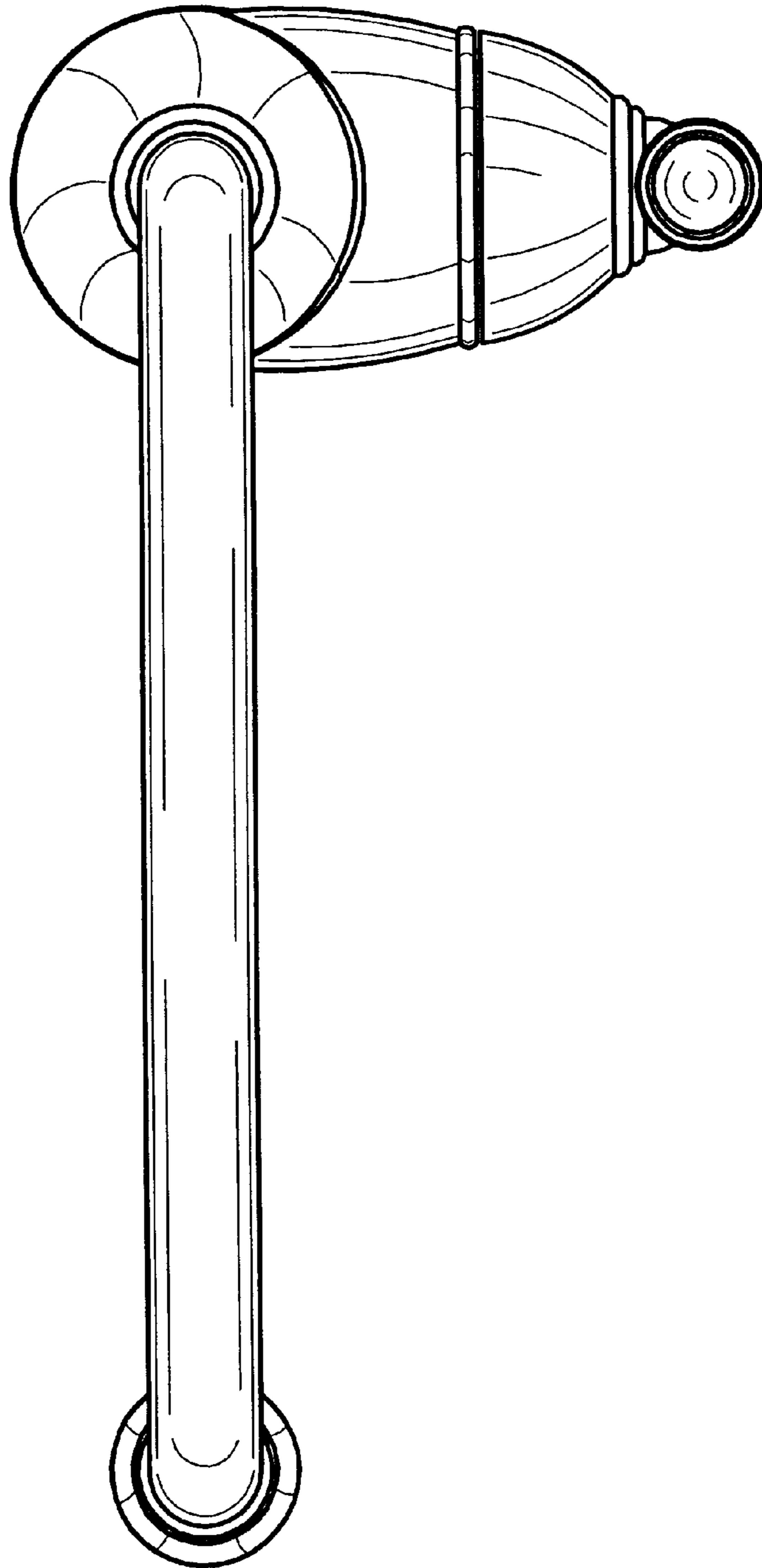


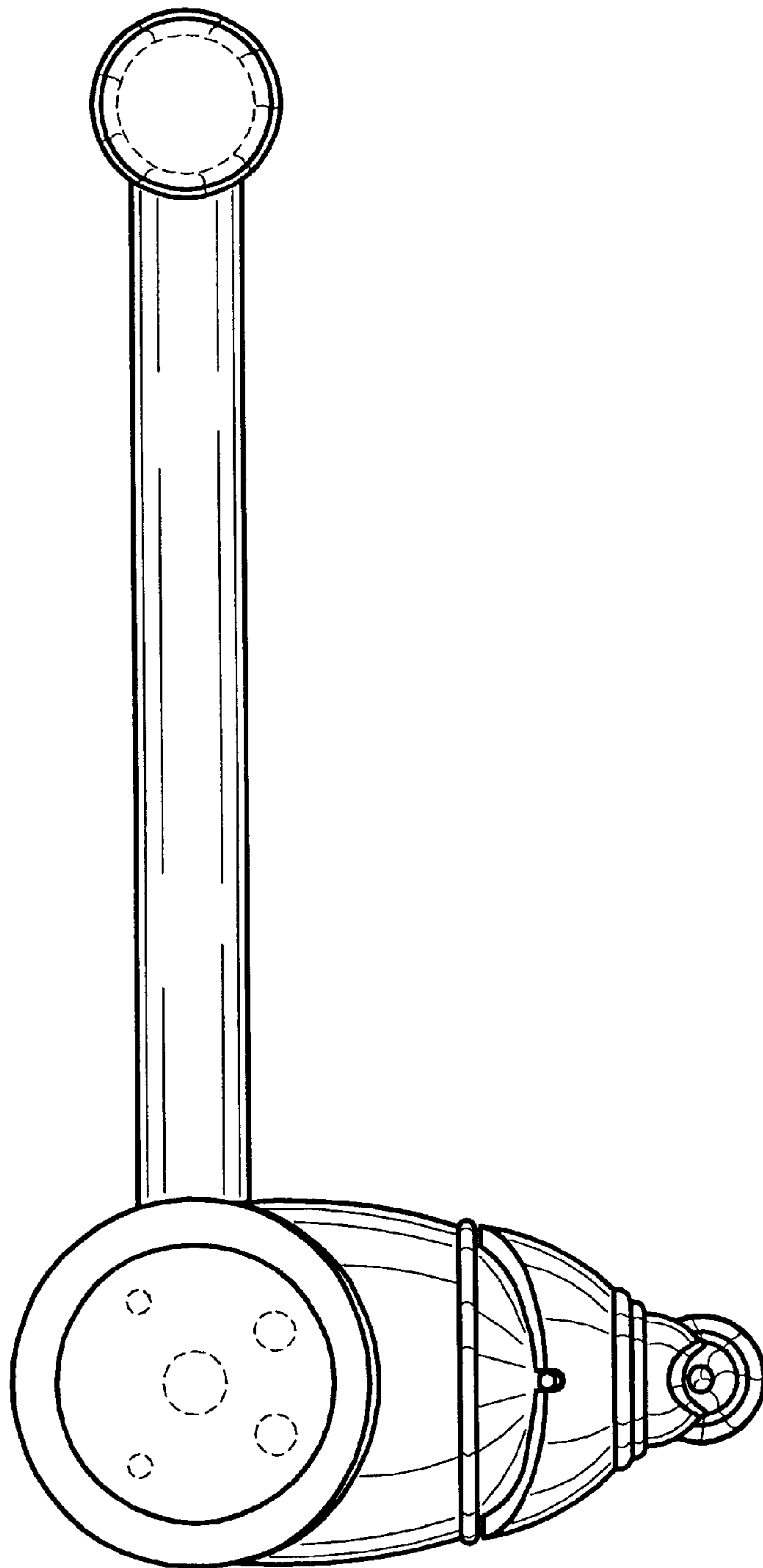

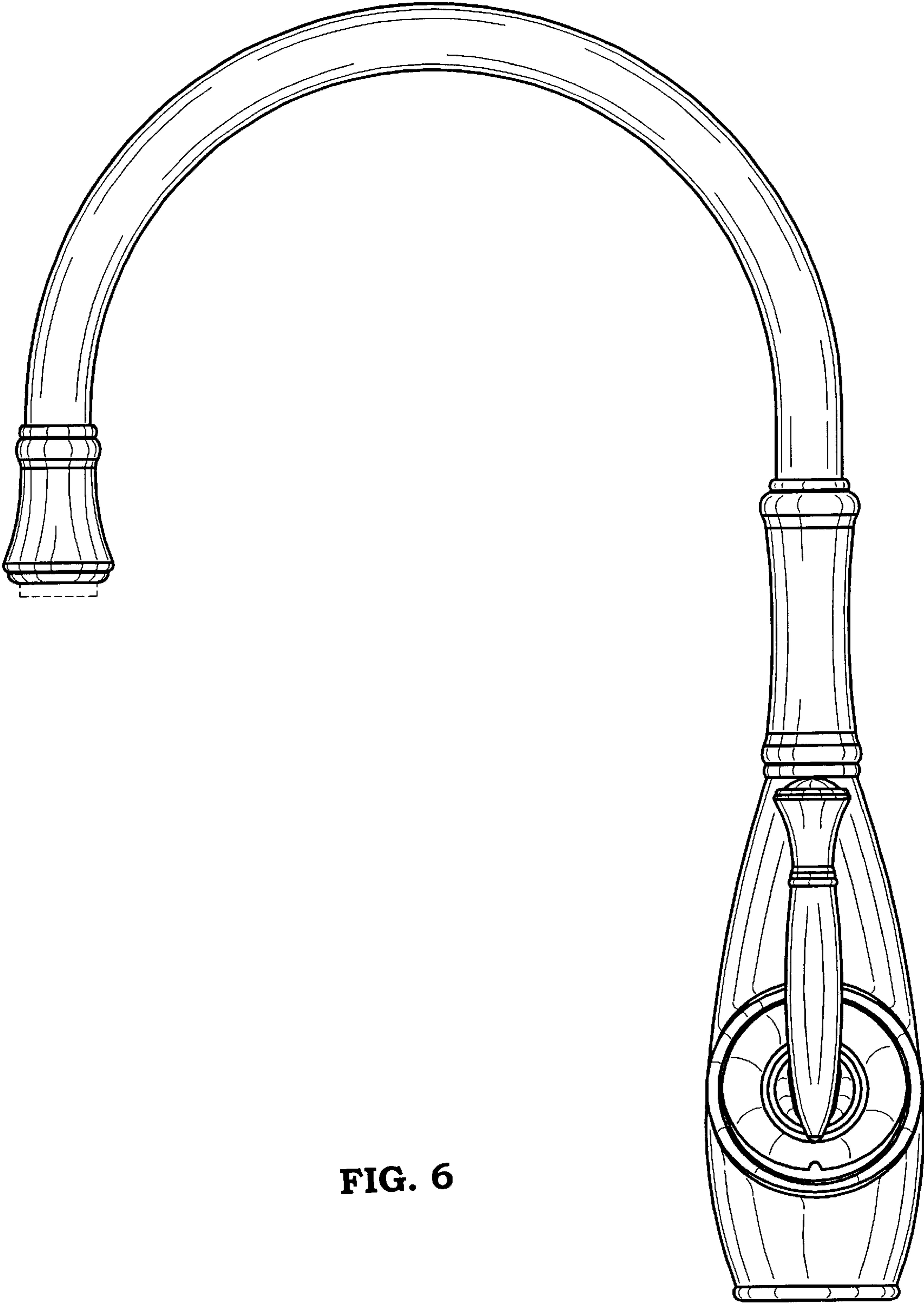

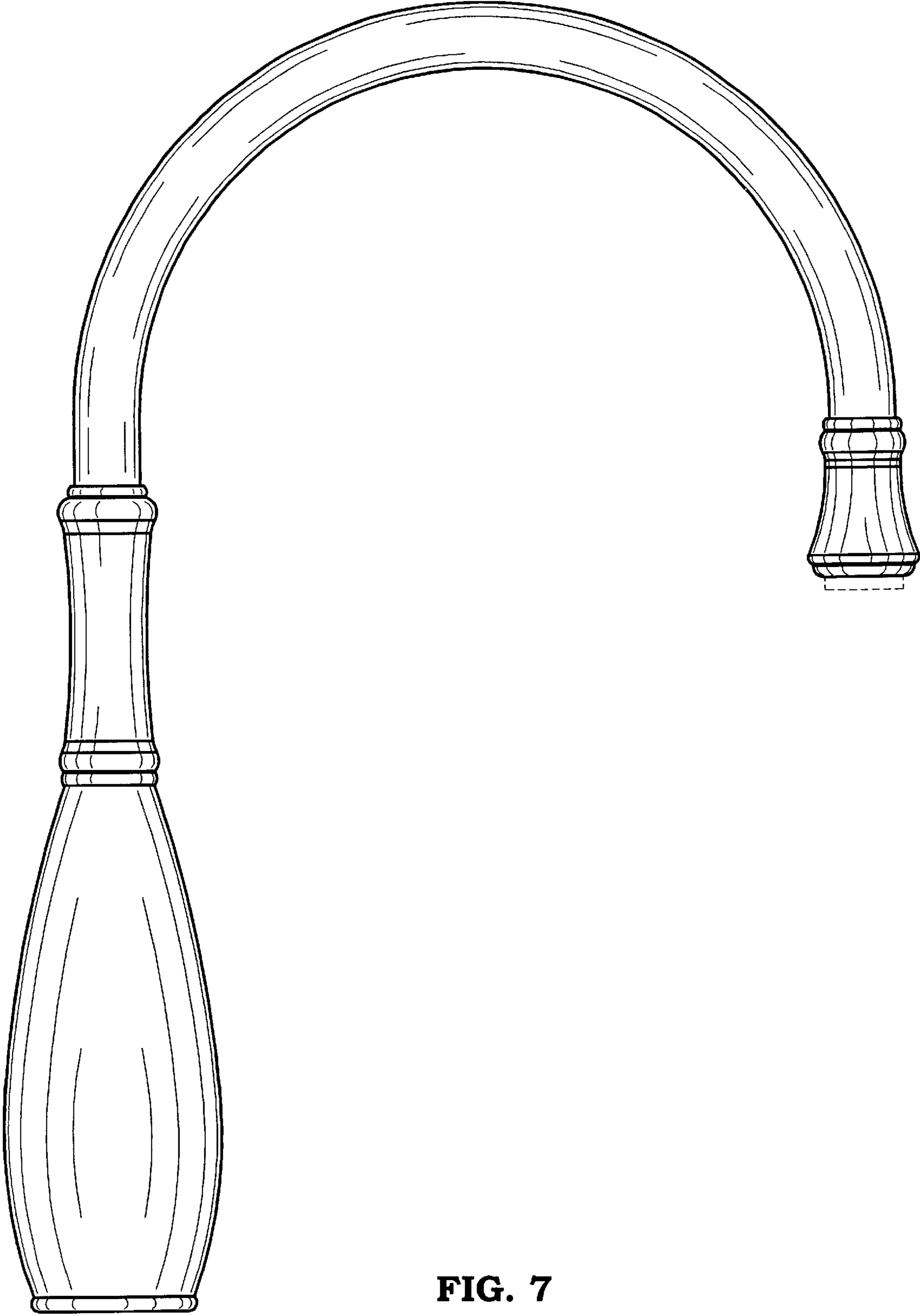
