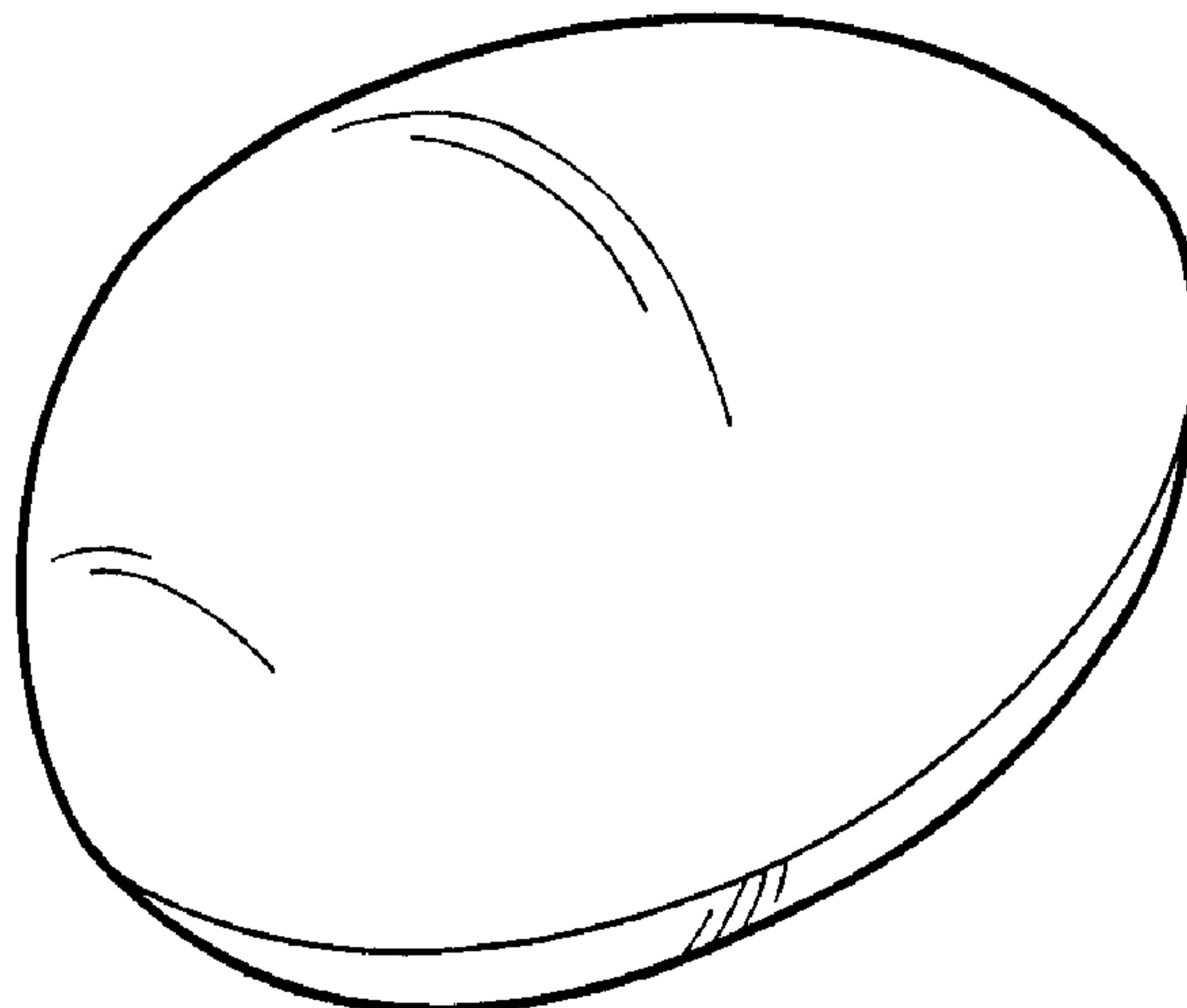
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an elevated, perspective view of the air freshener in accordance with my invention;

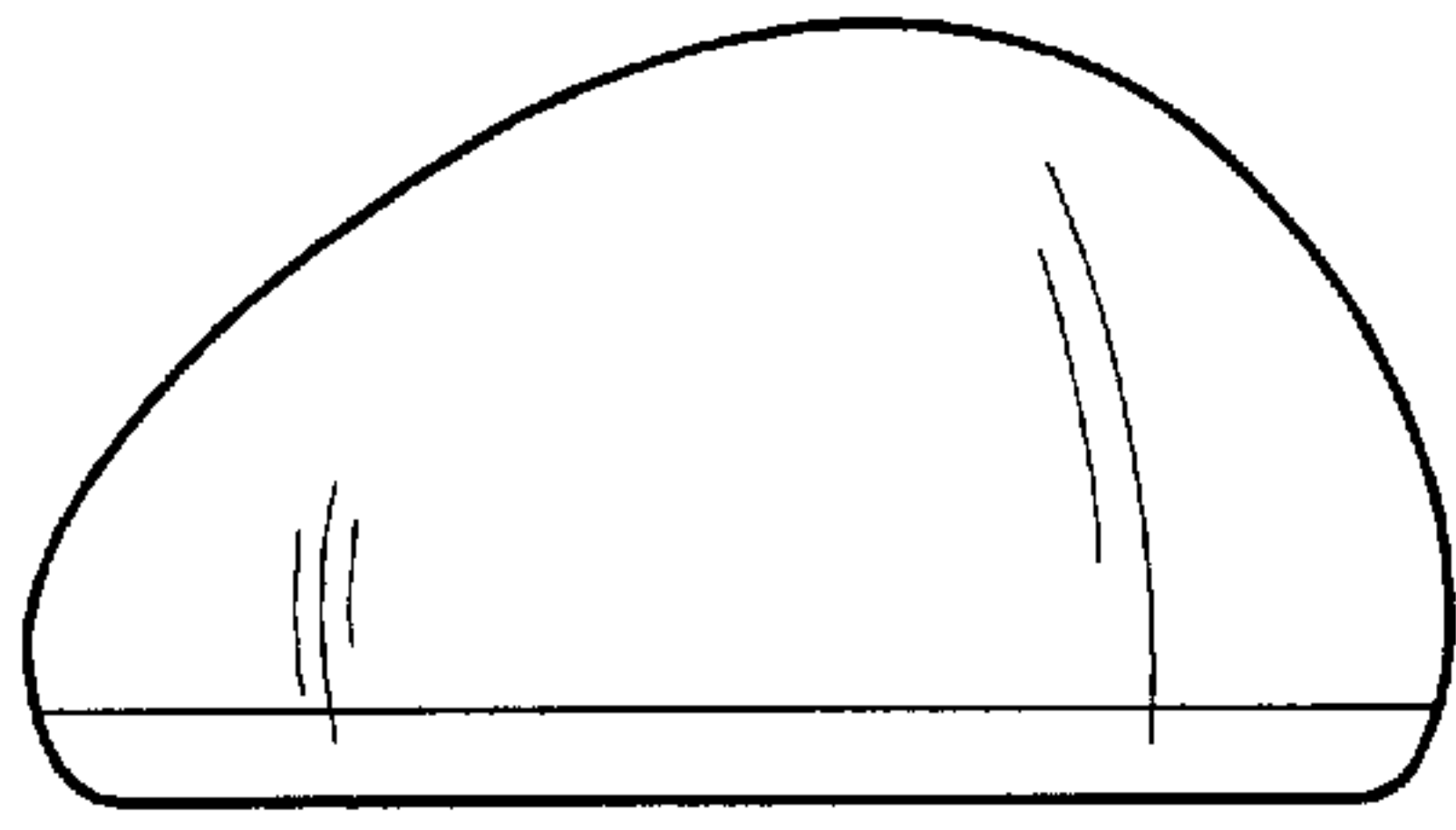

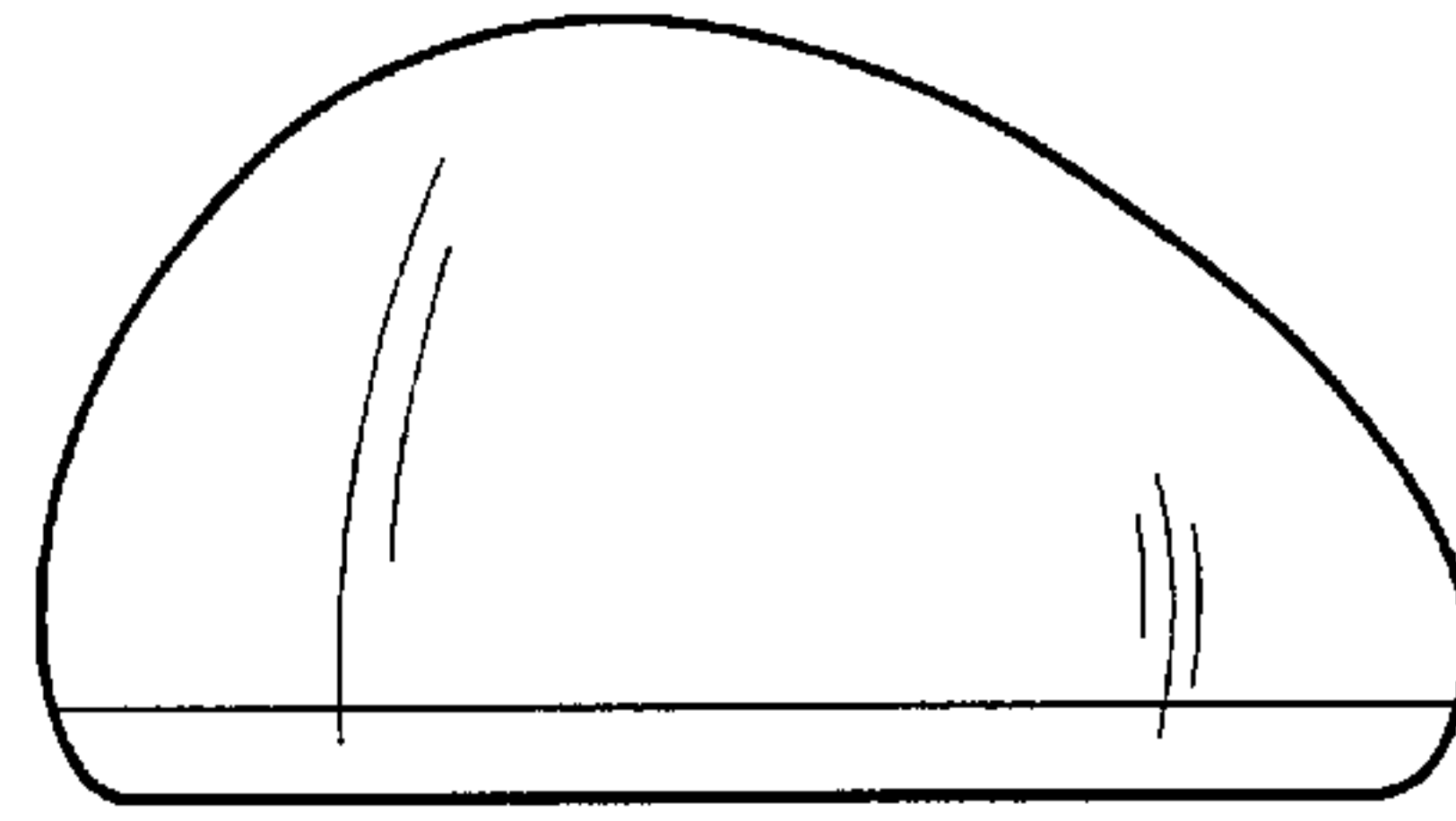

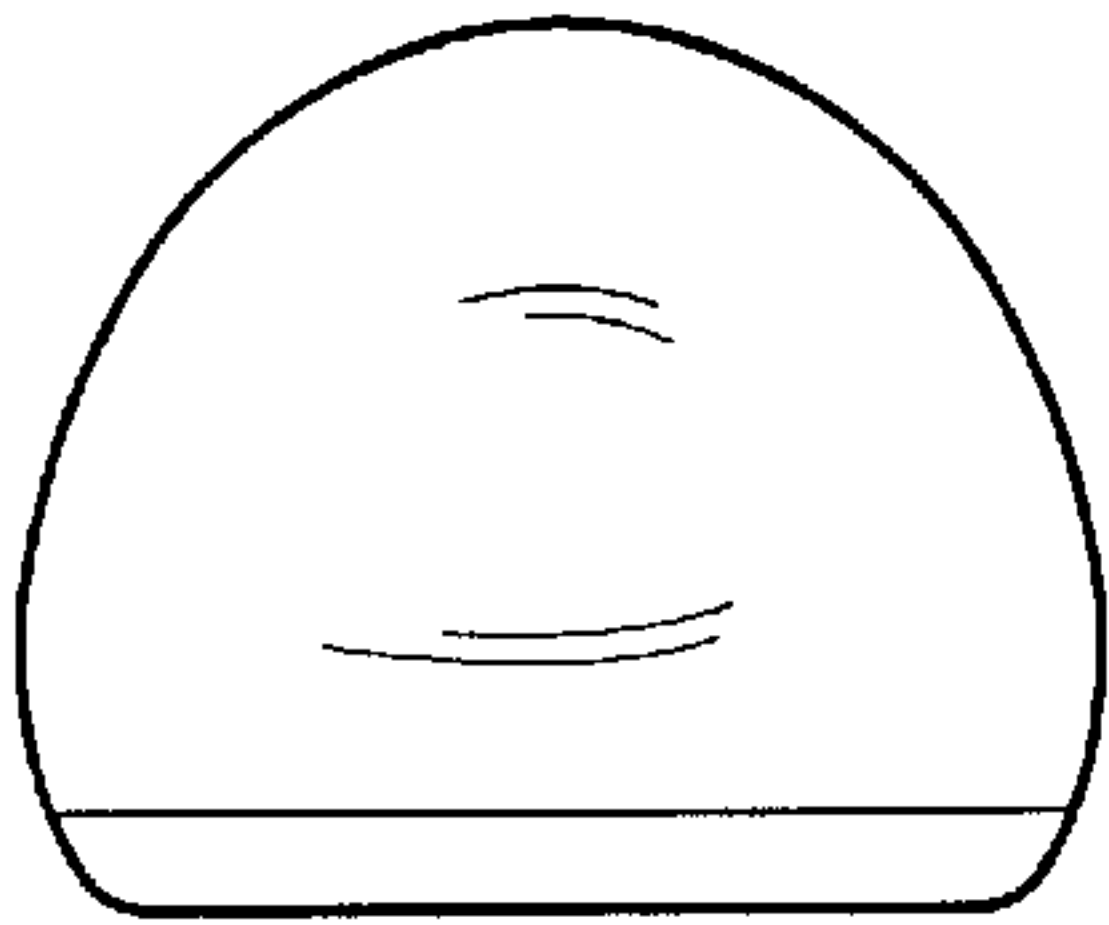

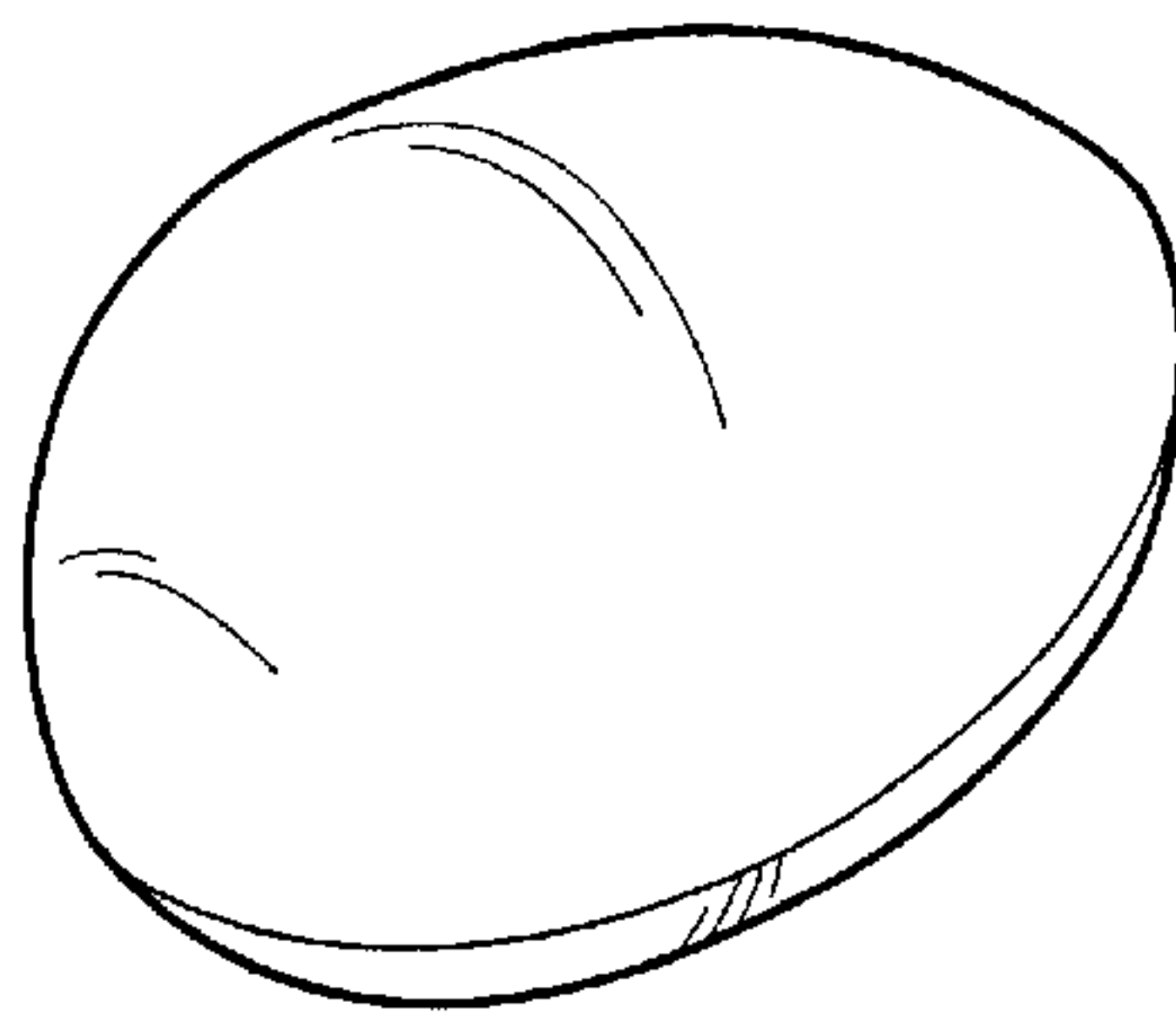

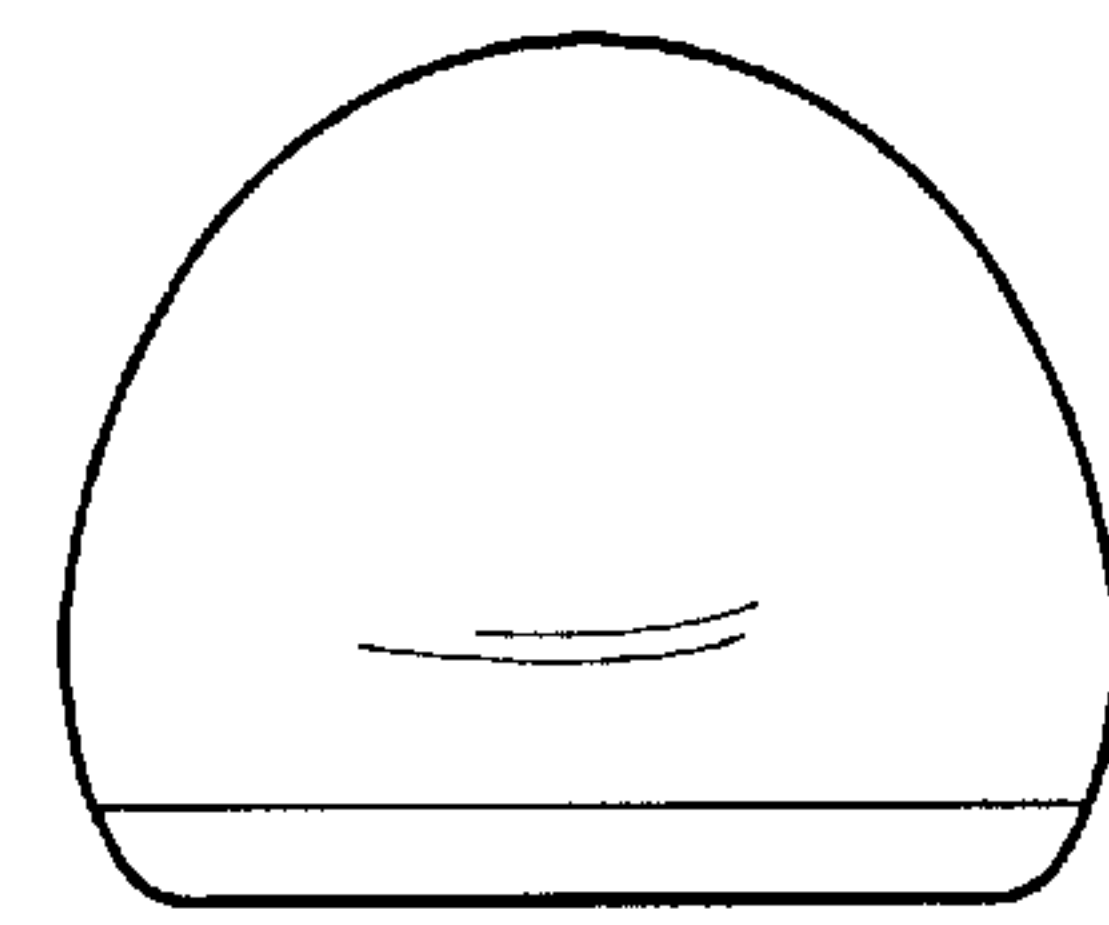

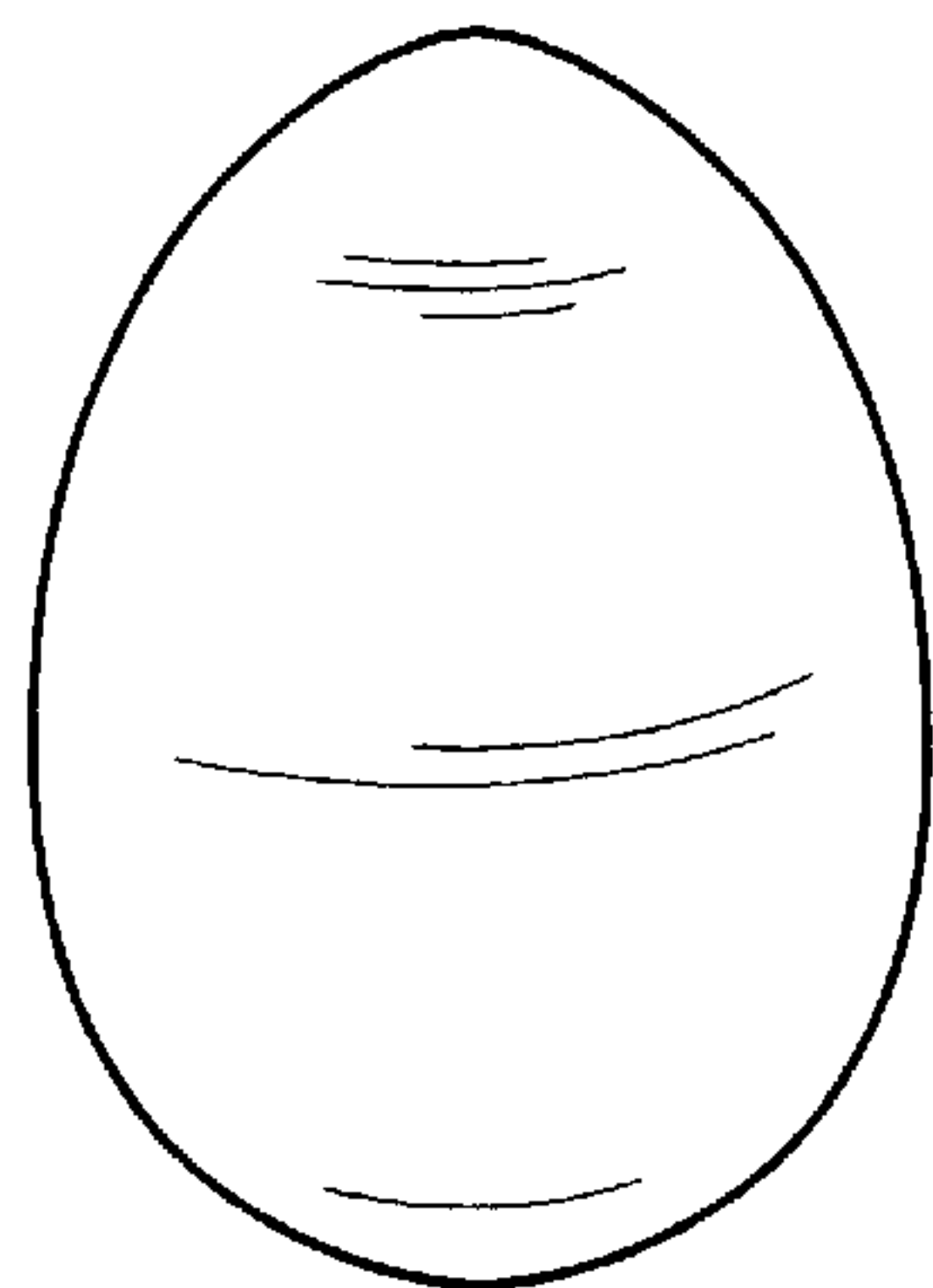

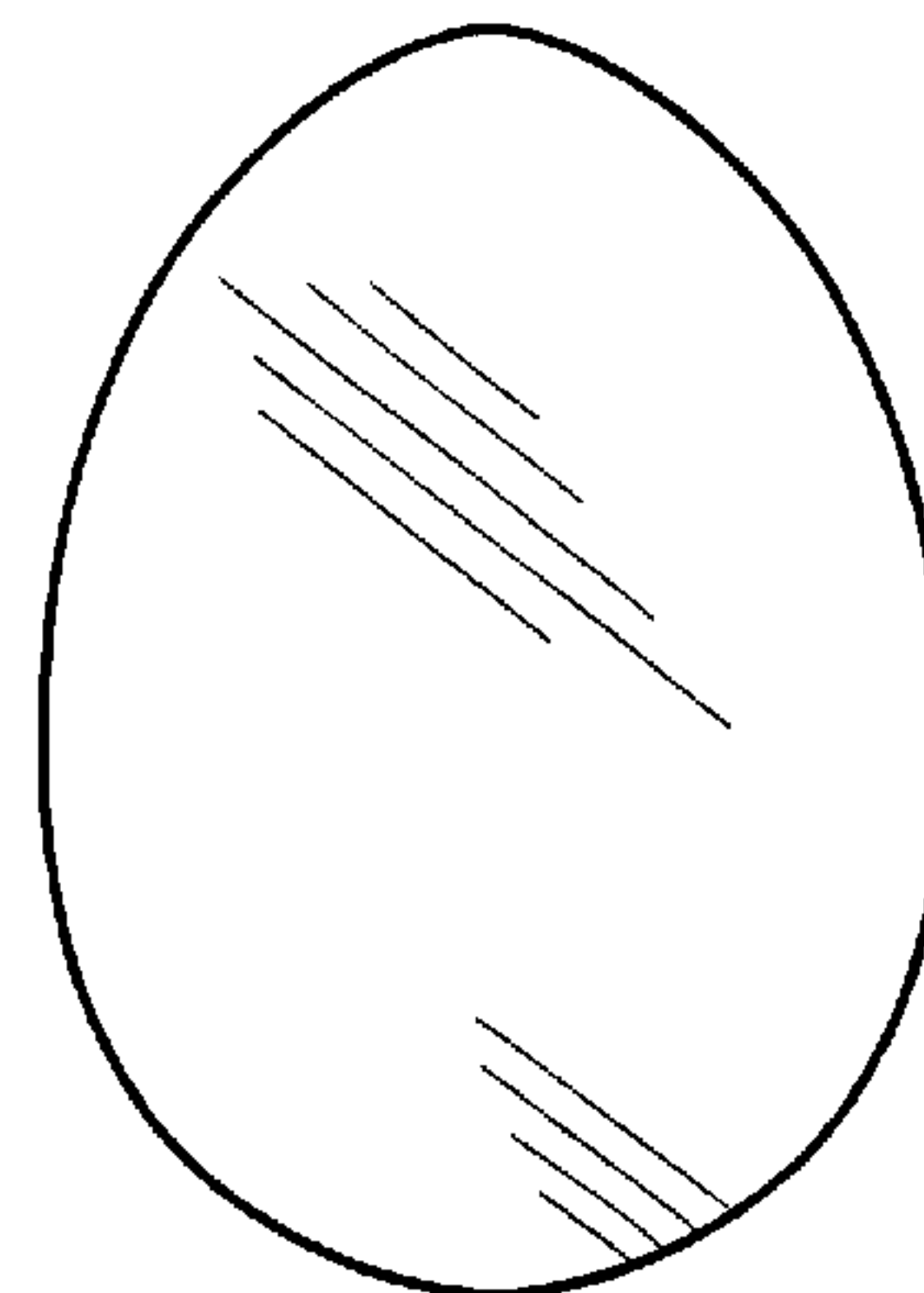
