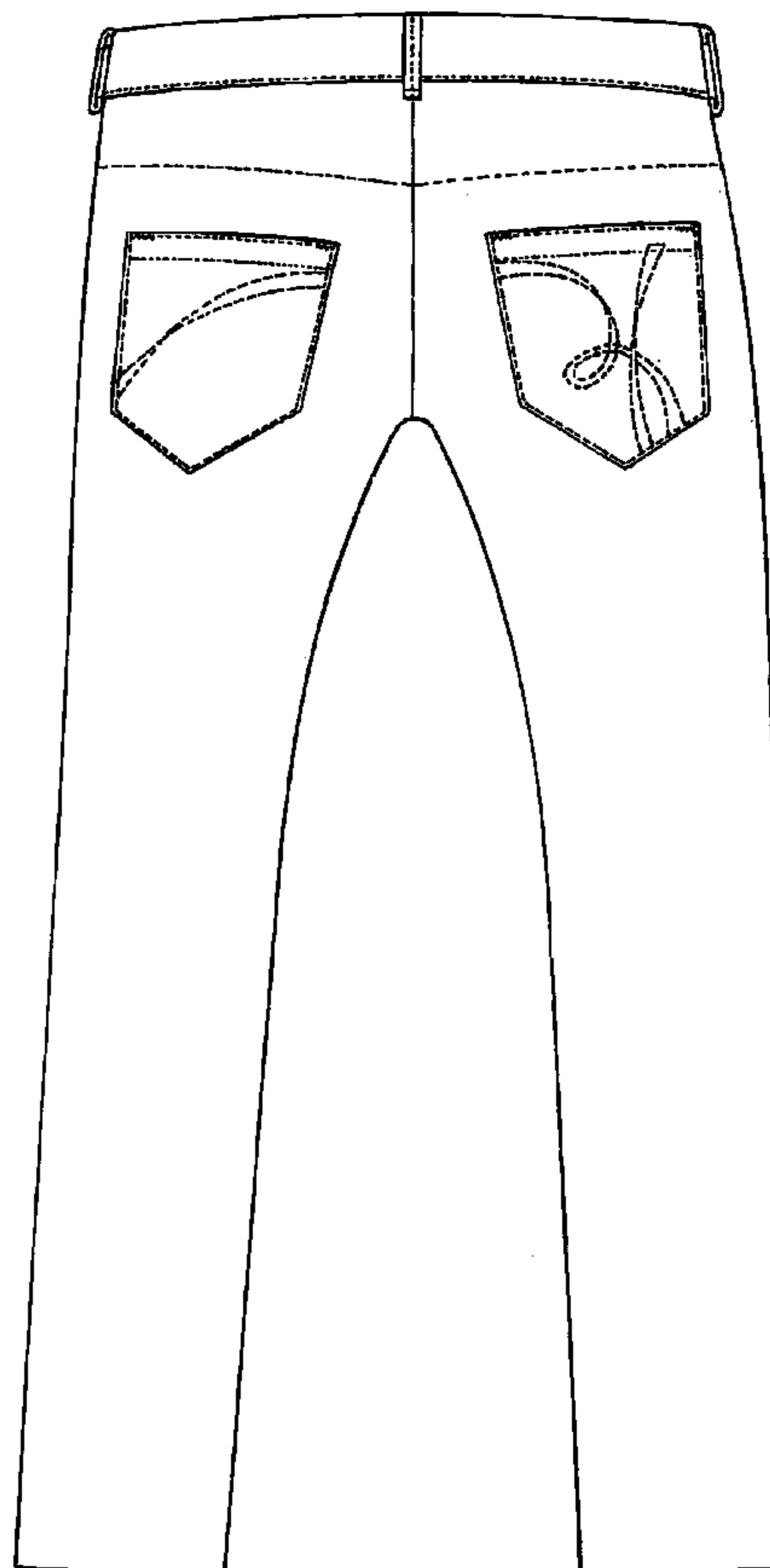
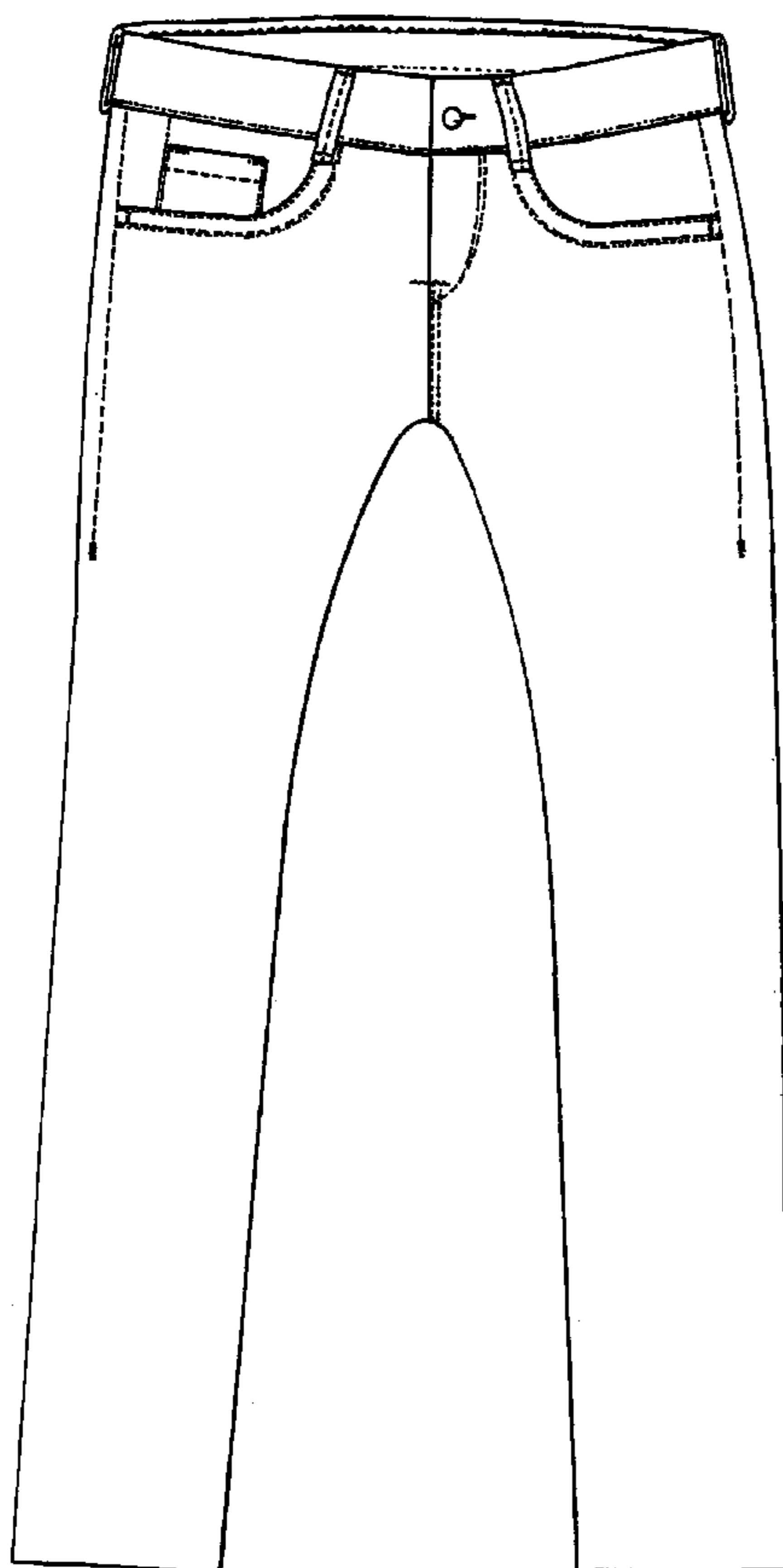
(57) **CLAIM**

I claim the ornamental design for the jeans, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the jeans showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a left side view thereof; and, FIG. 4 is a right side view thereof. The lines shown on the surface of the jeans in FIGS. 1–4 are understood to represent stitching.

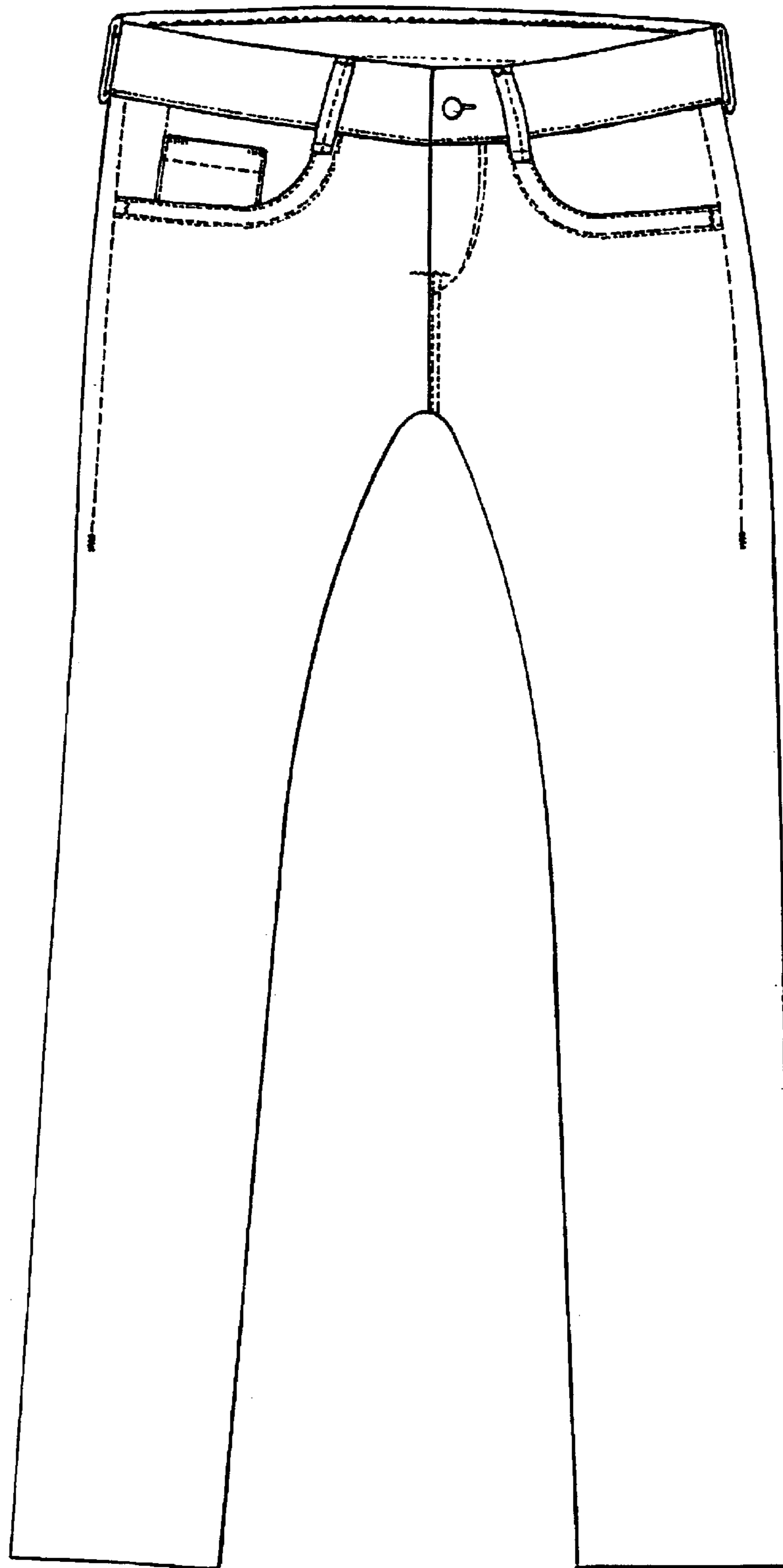

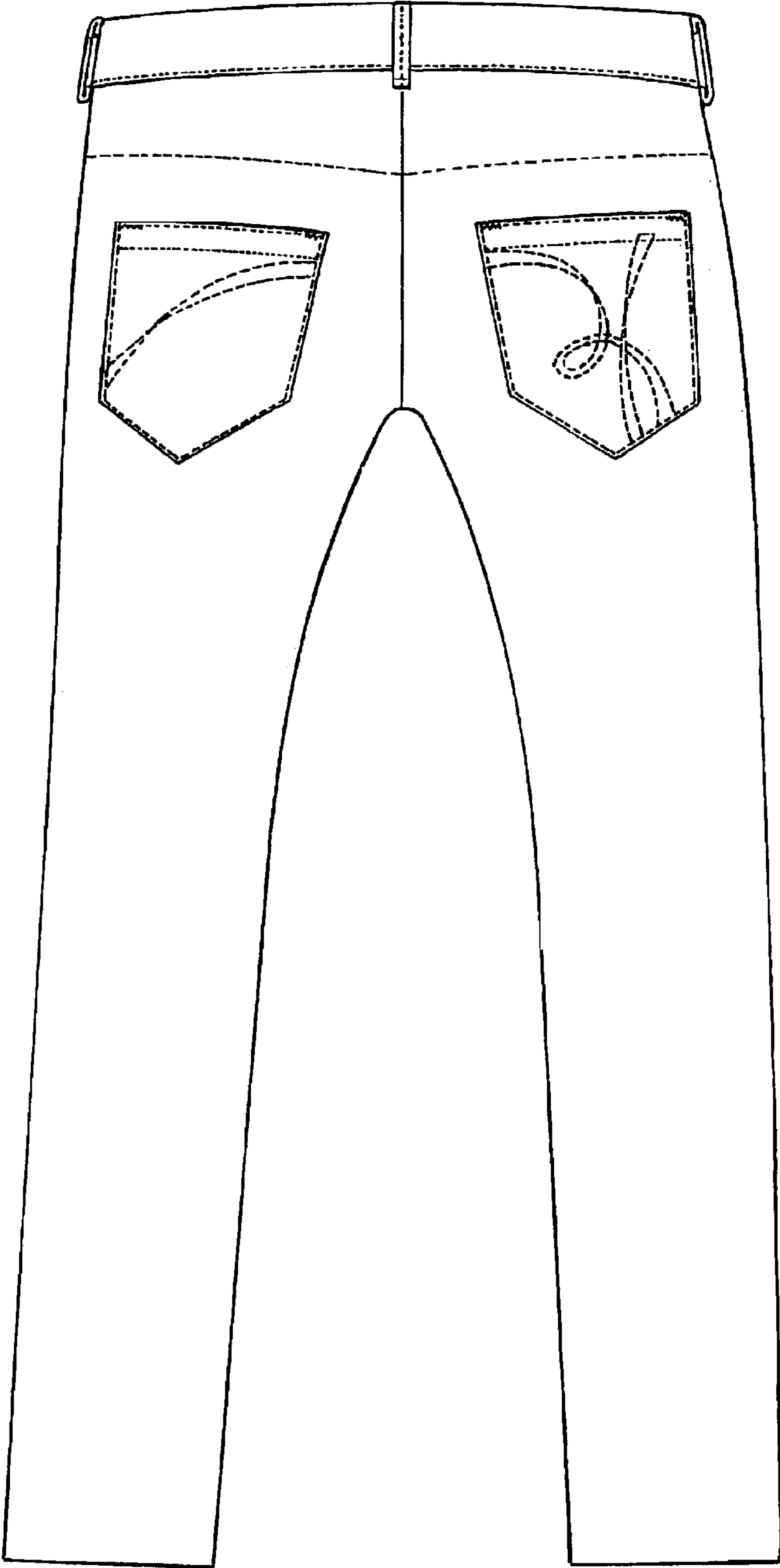

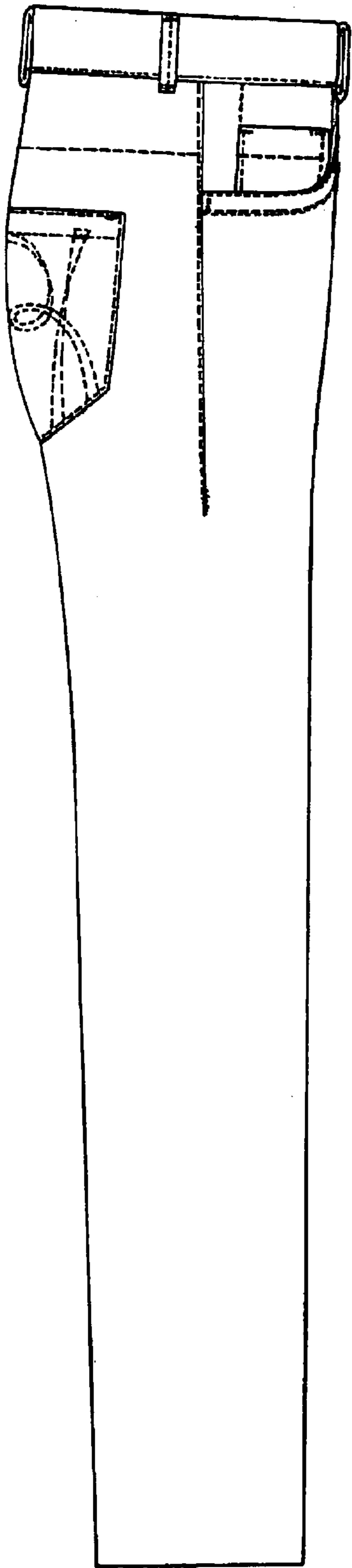

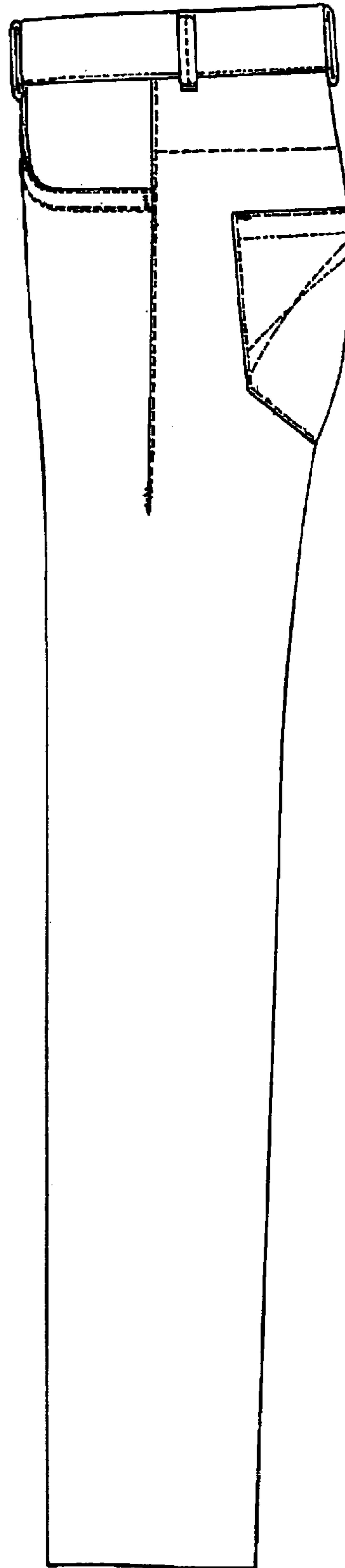
