(57) **CLAIM**

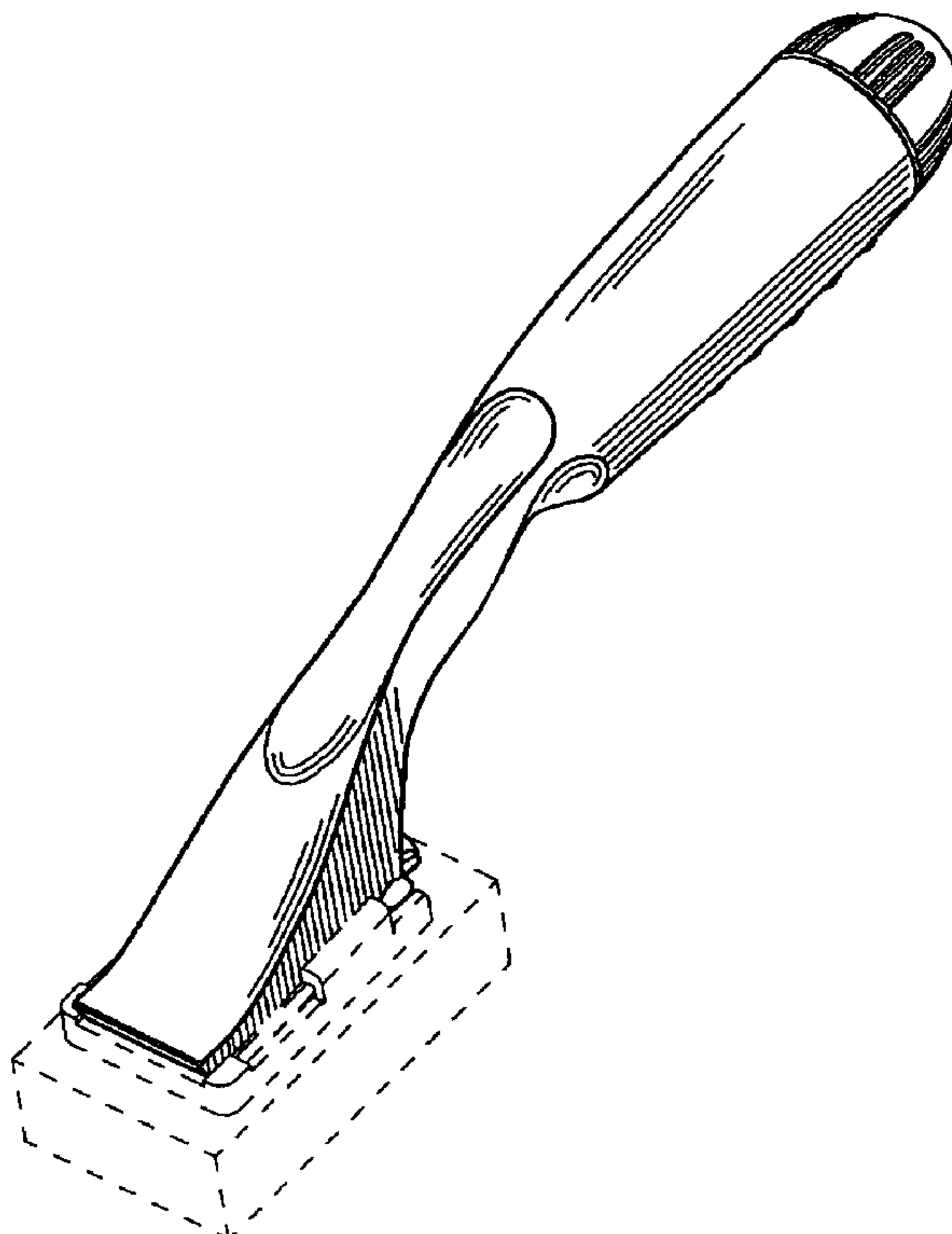
The ornamental design for a “handle with base for cleaning implement,” as shown and described.

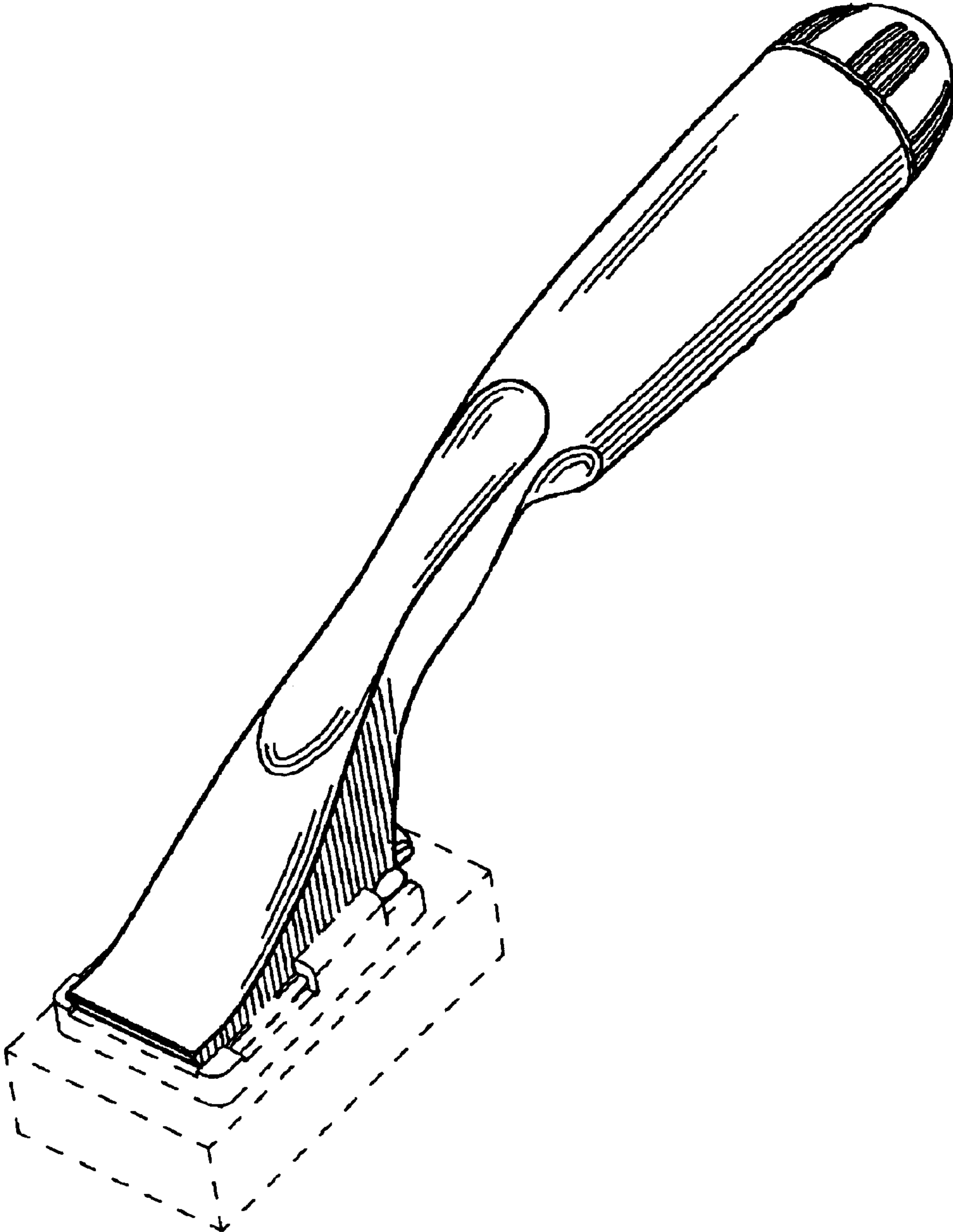

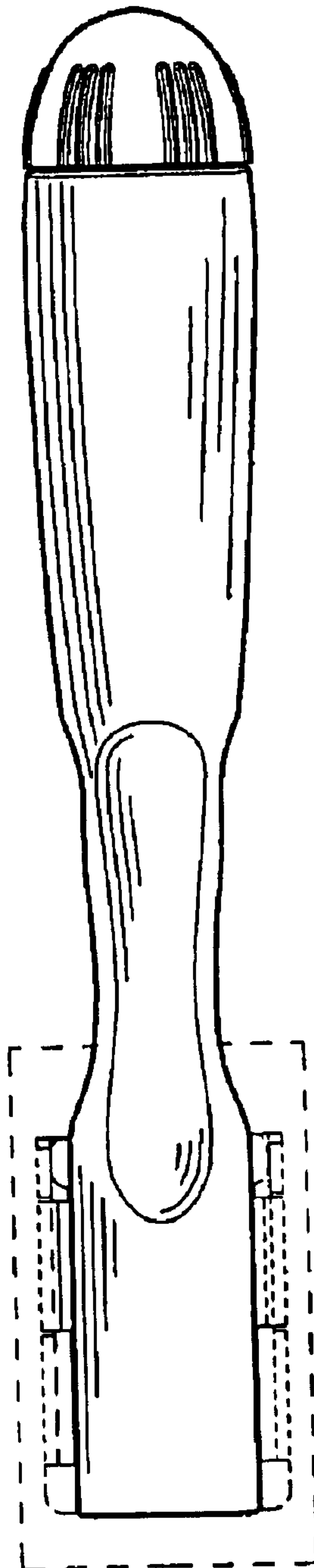

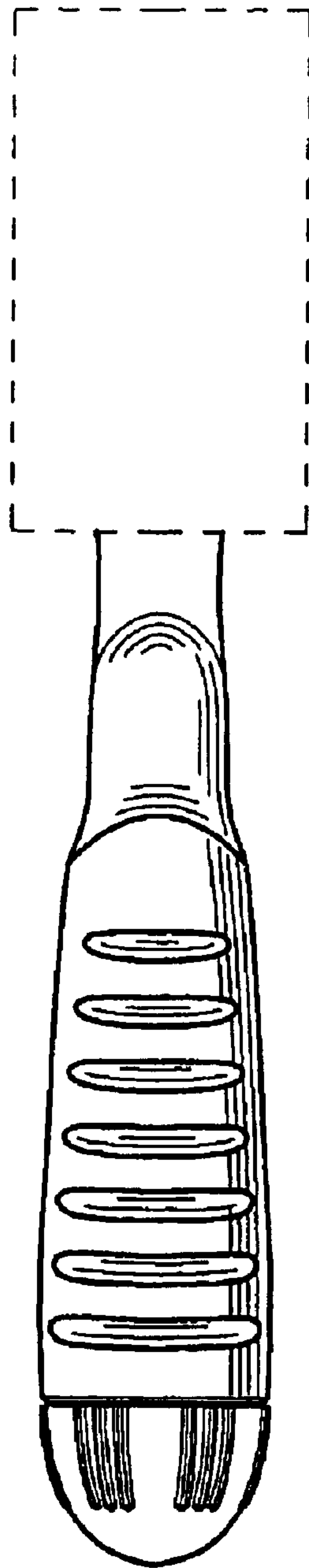

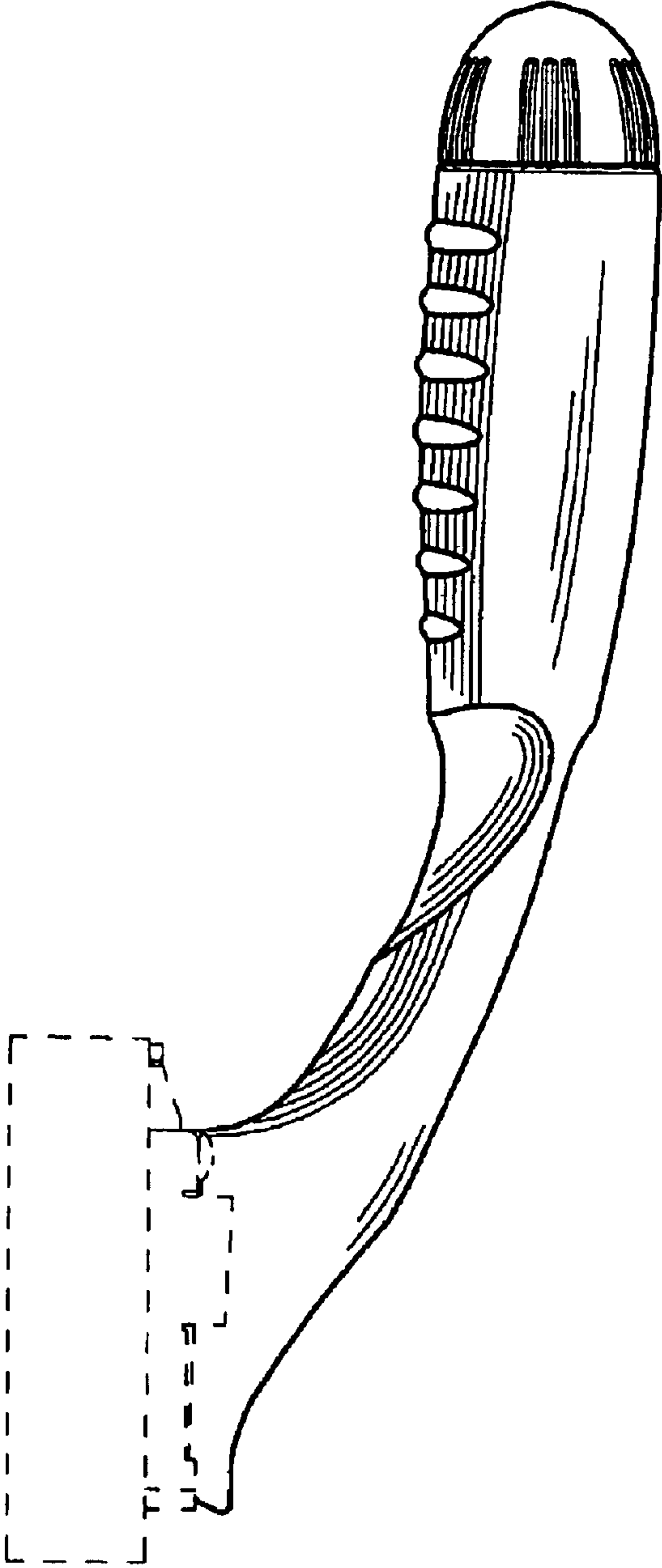

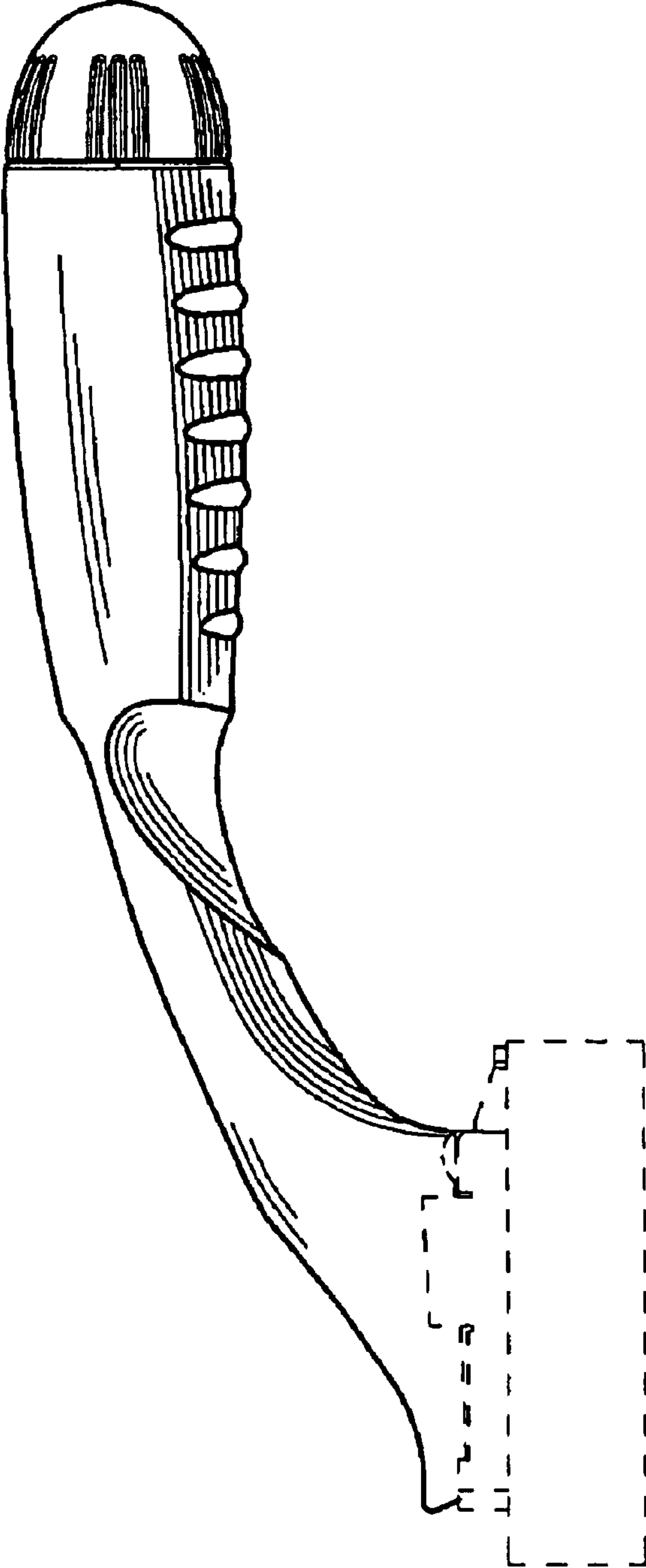

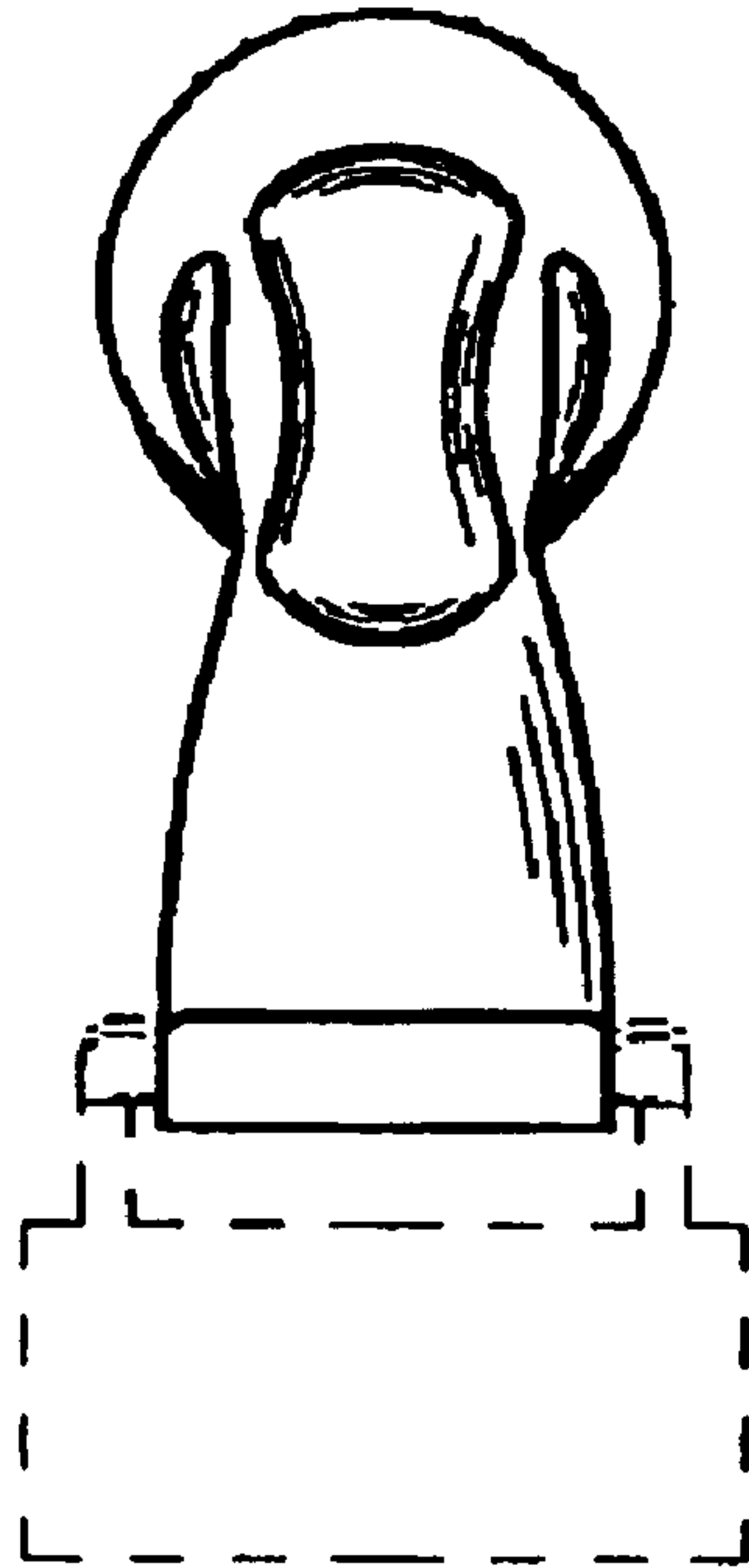

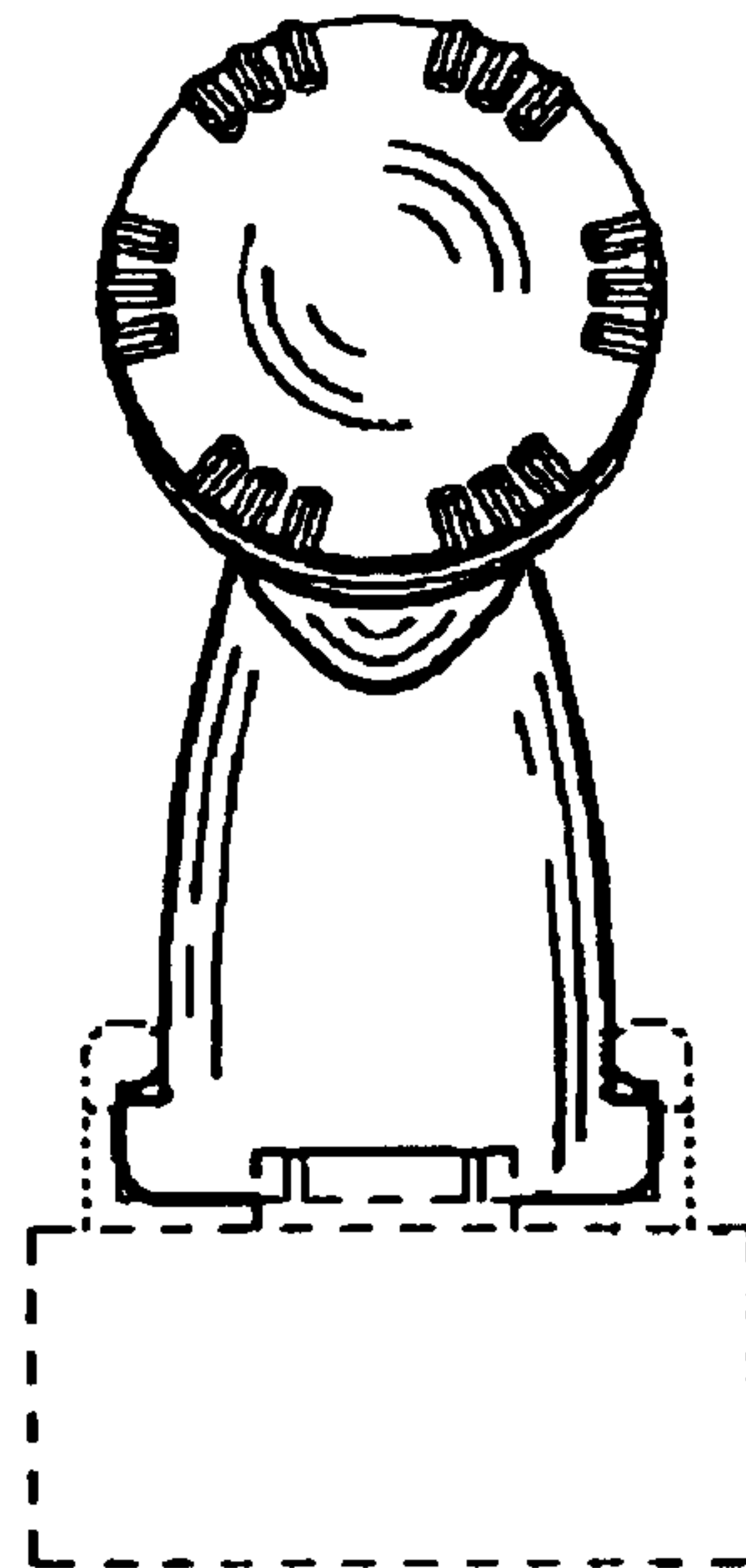
