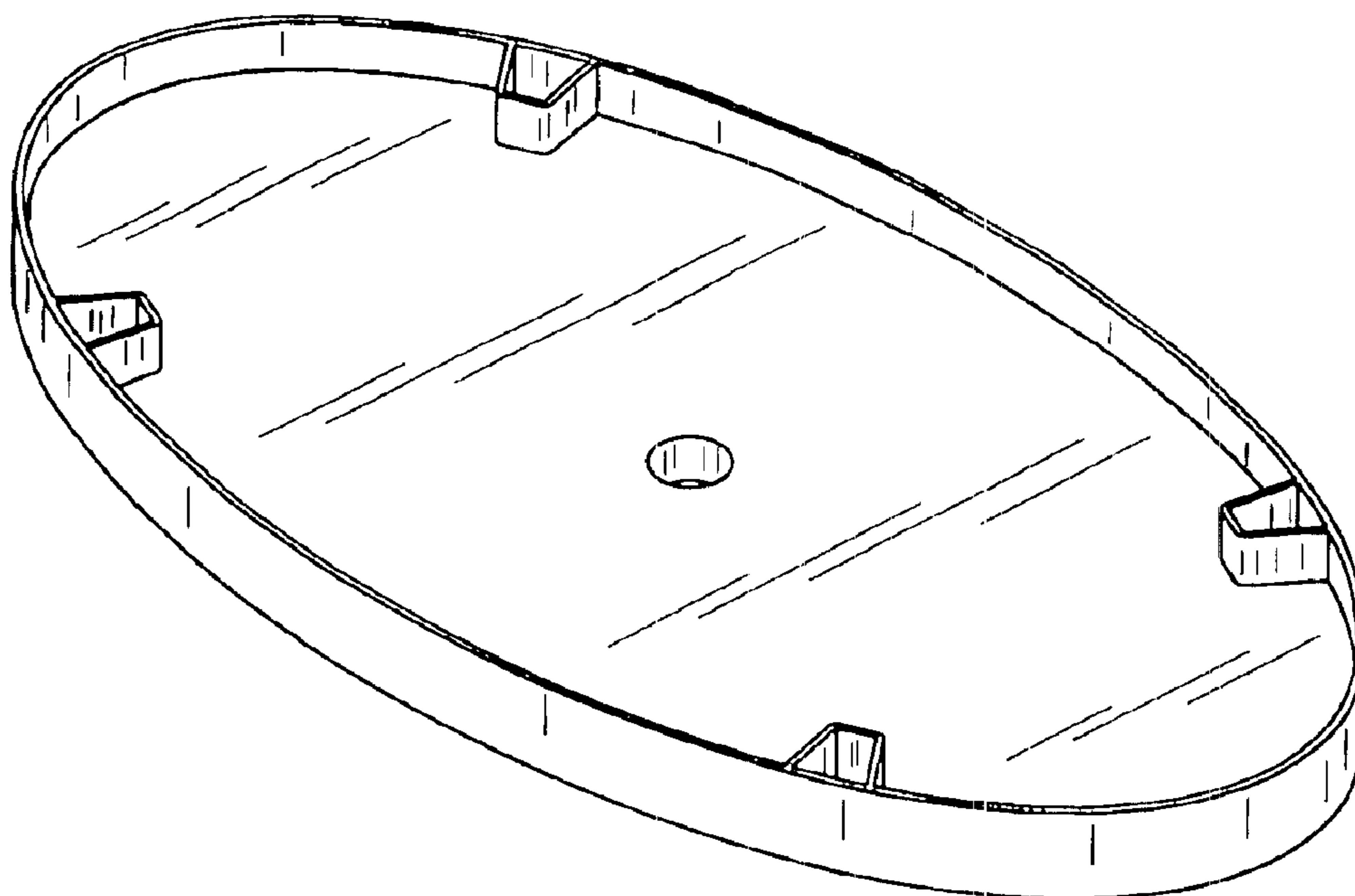
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a product holding shelf showing our new design.
FIG. 2 is a top plan view thereof.
FIG. 3 is a bottom plan view thereof.
FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image thereof; and,
FIG. 5 is a left side elevational view thereof, the right side elevational view being a mirror image thereof.

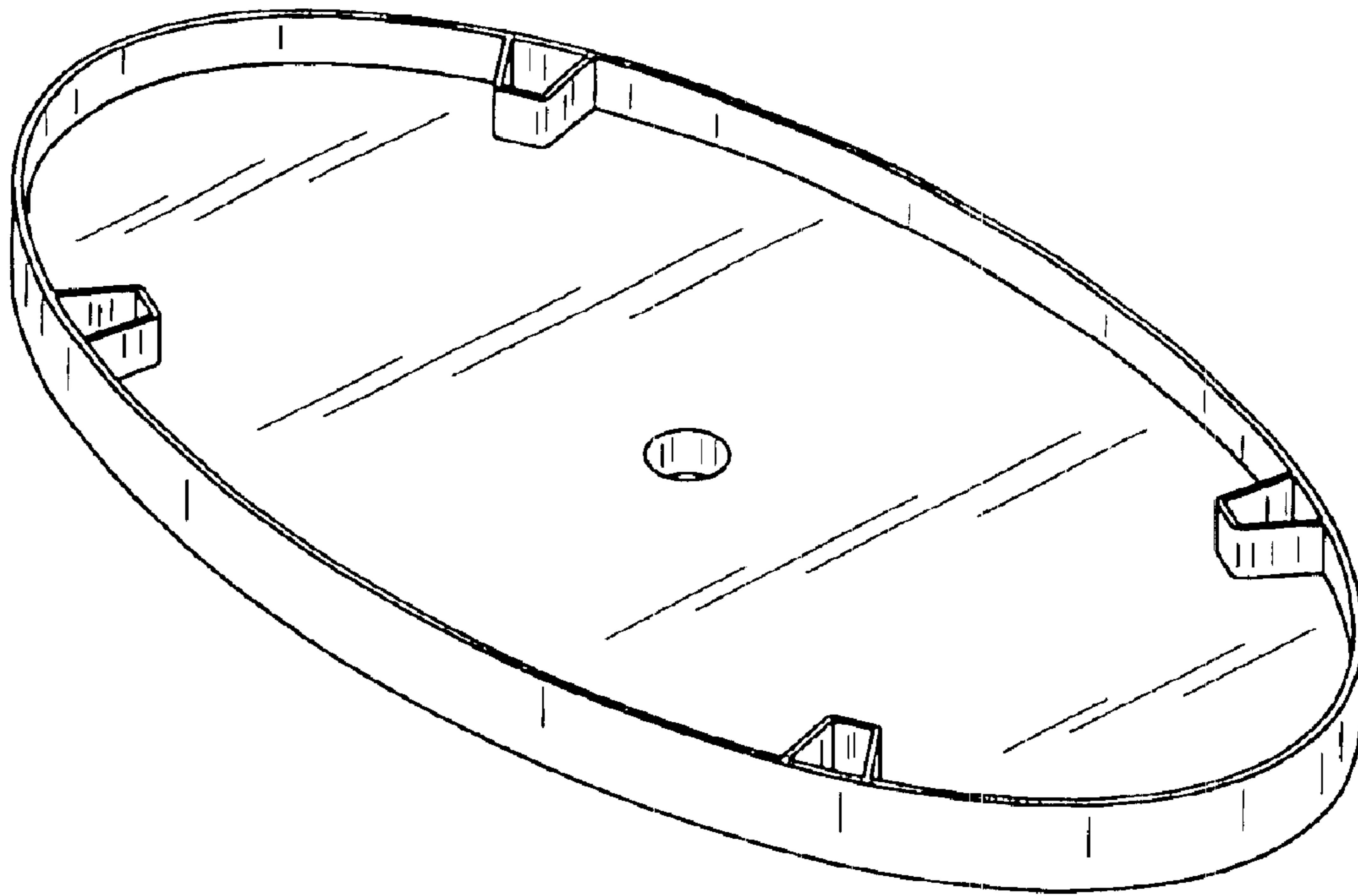

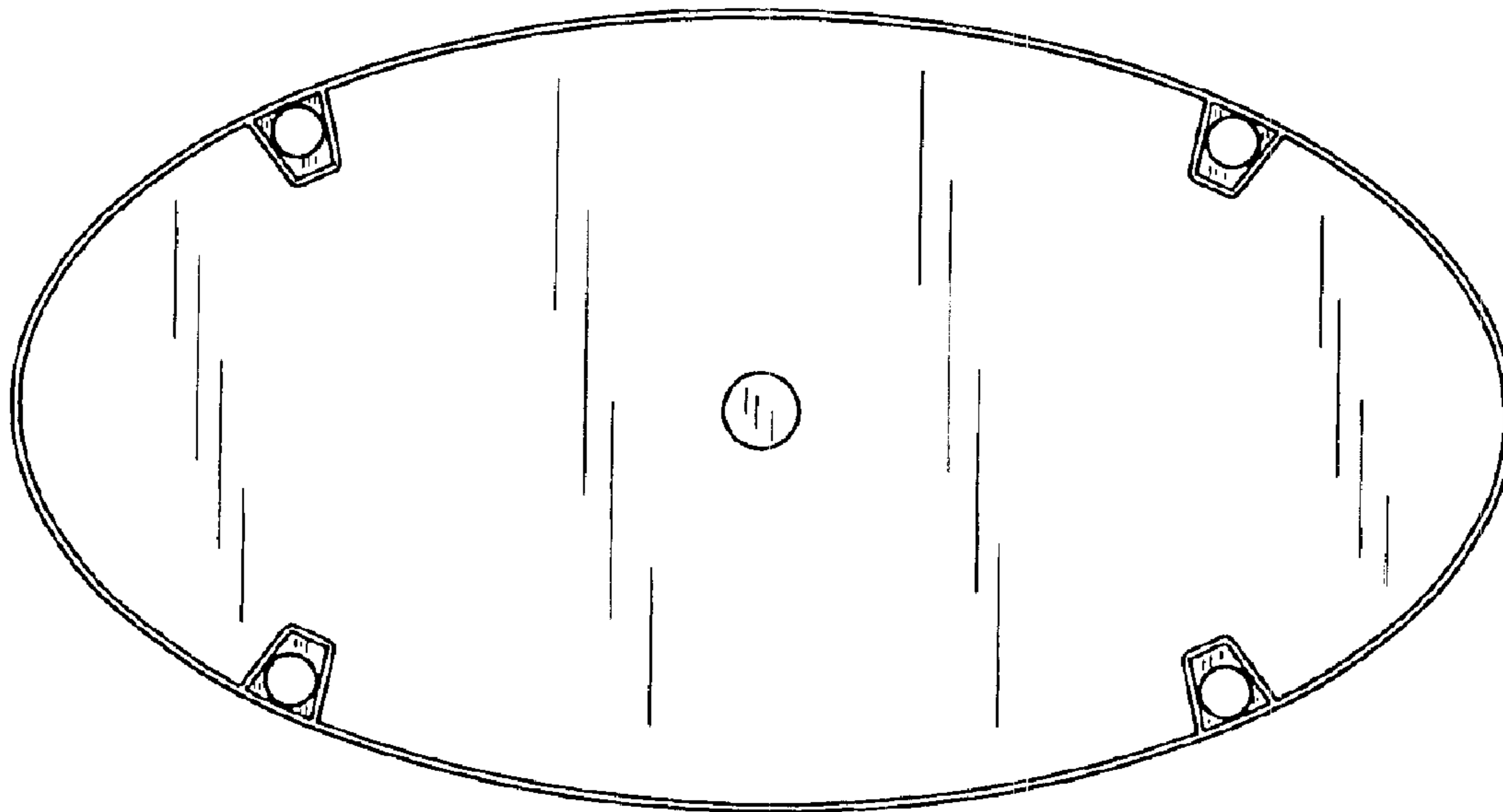

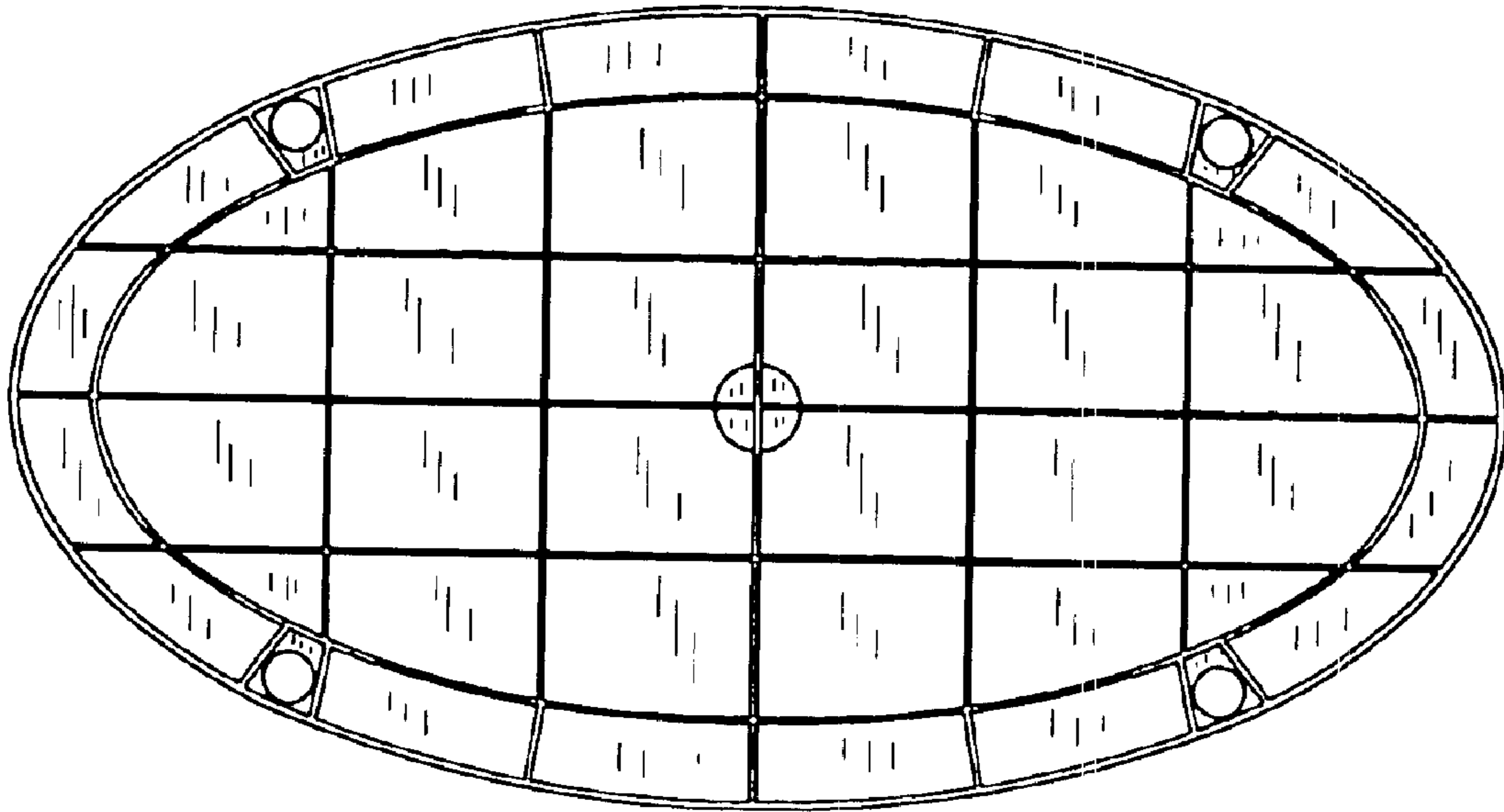

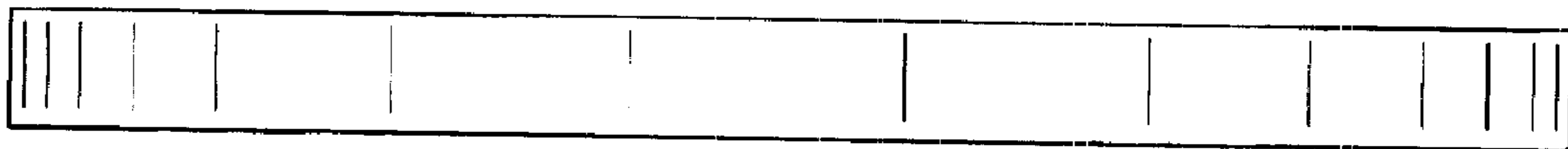

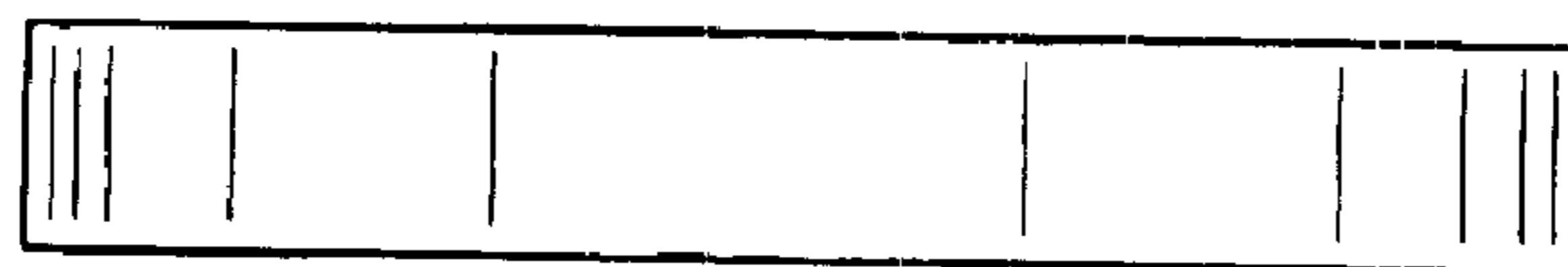
