FIG. 5 is a rear elevation view thereof.

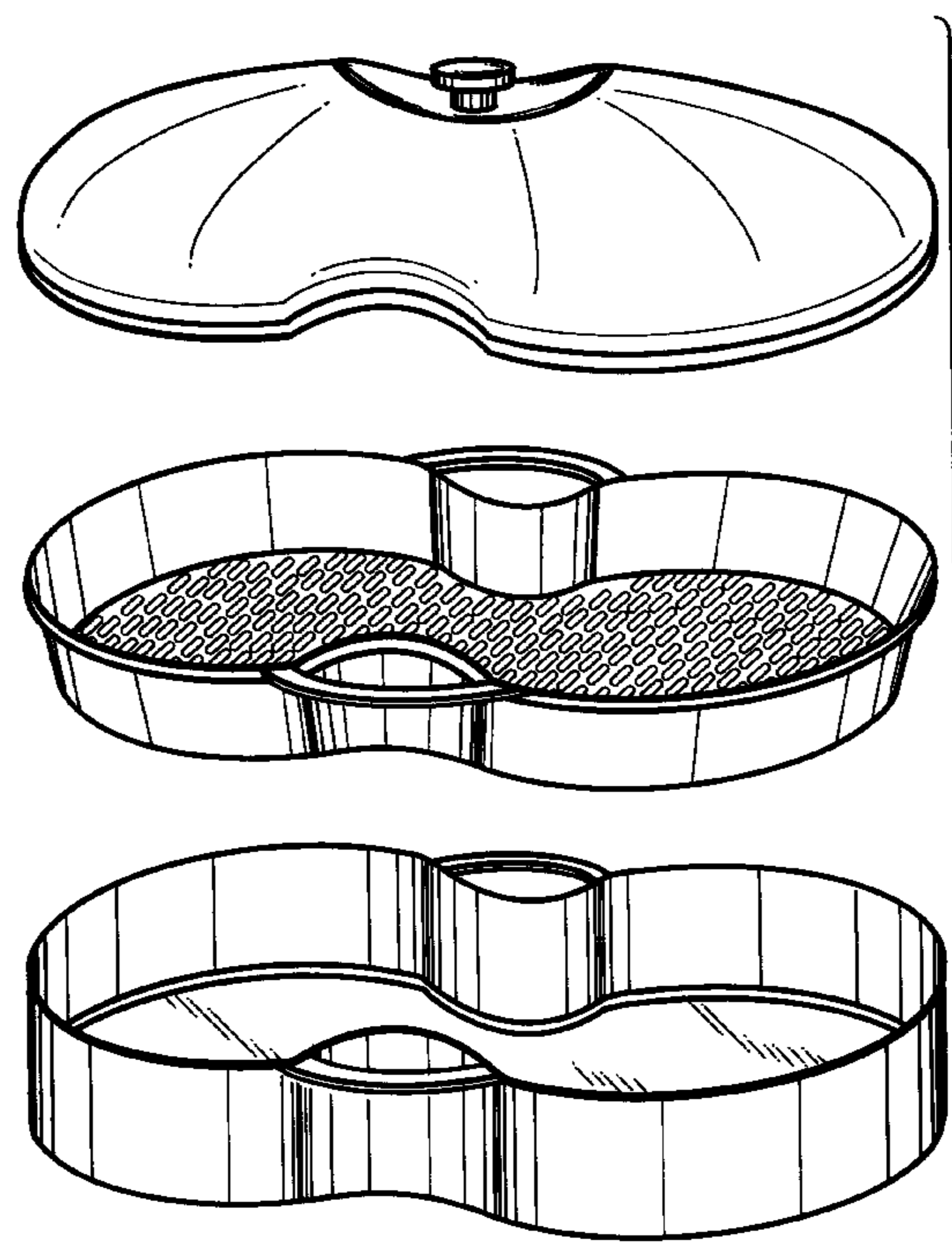
FIG. 6 is a top plan view thereof.

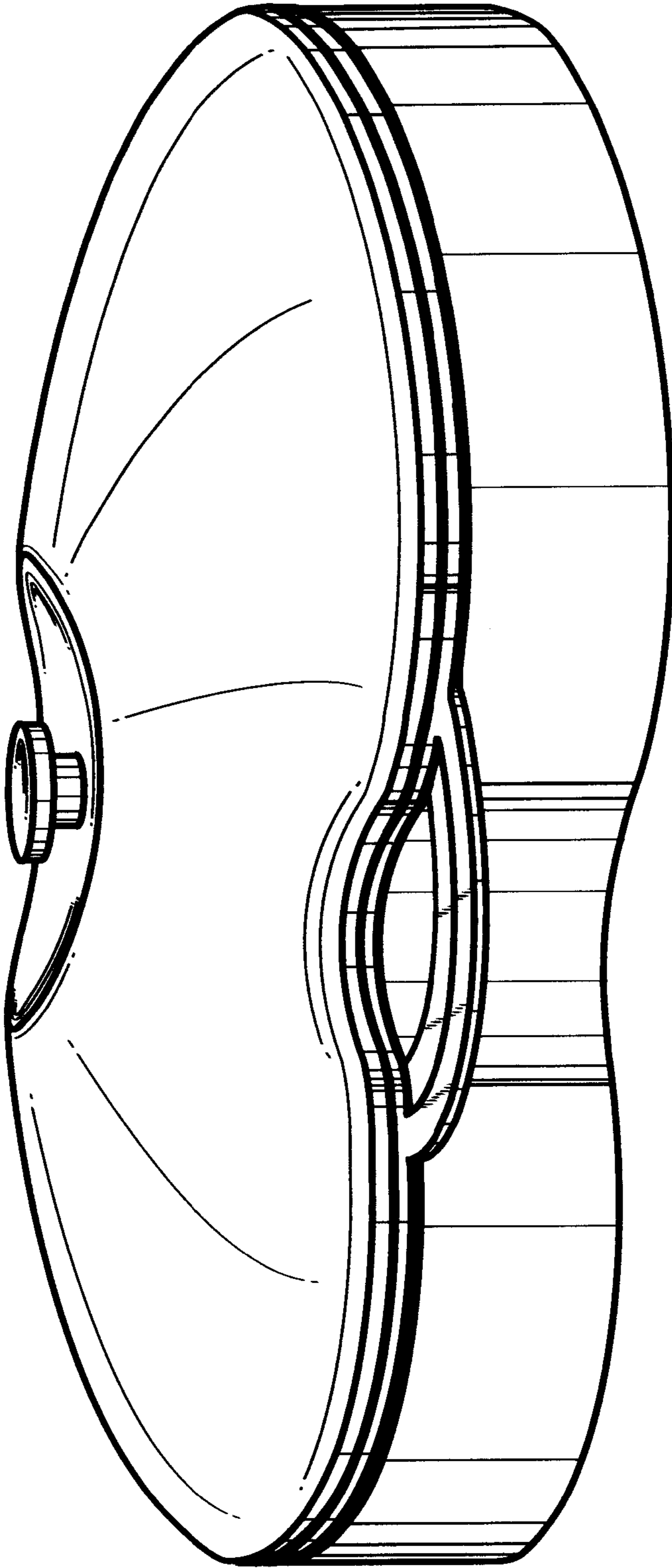
FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is an exploded isometric view thereof.

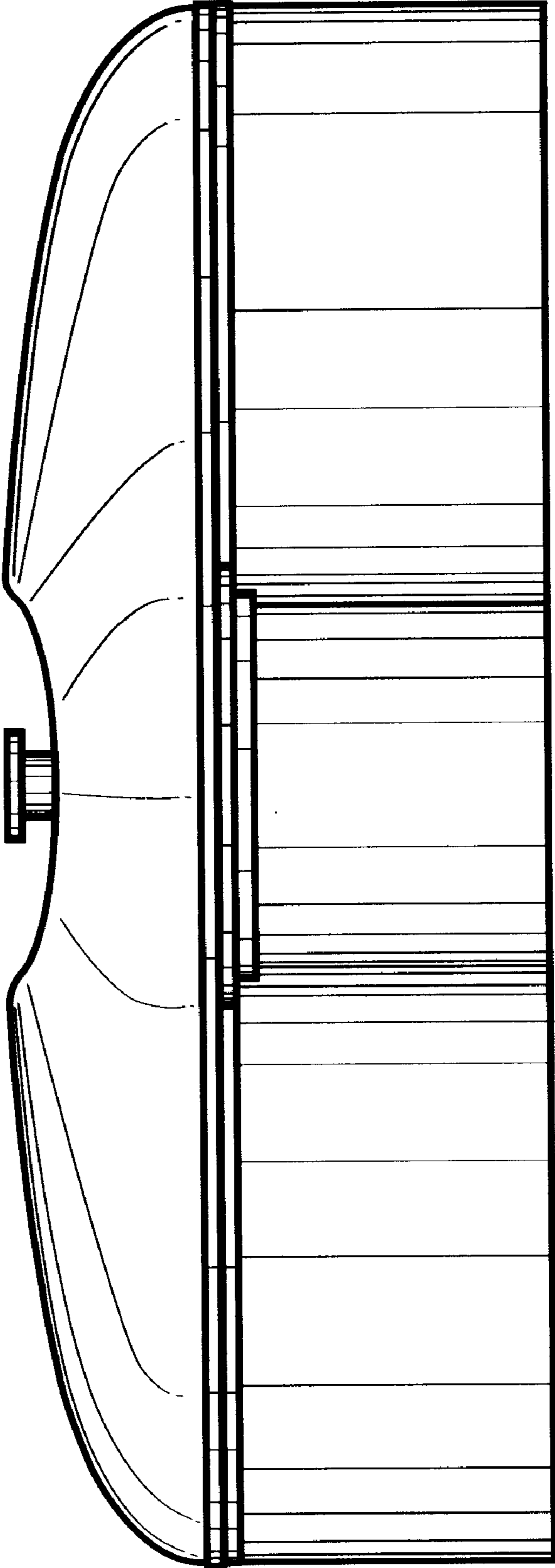

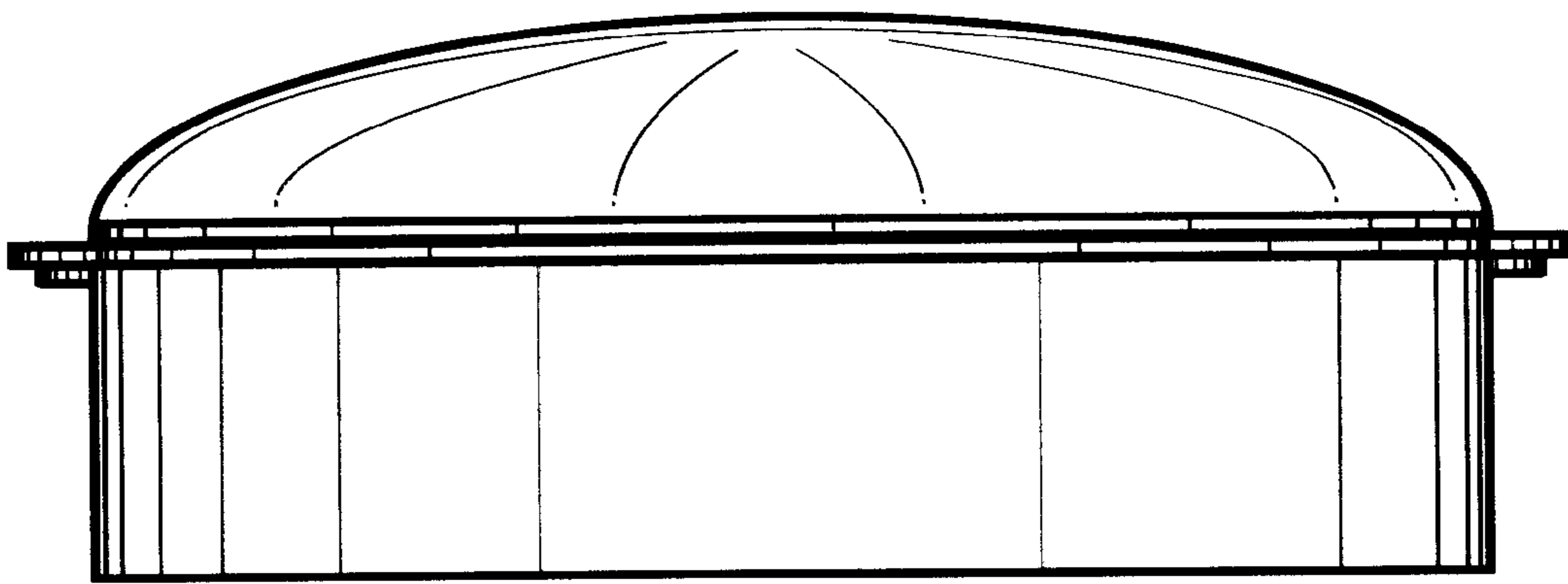




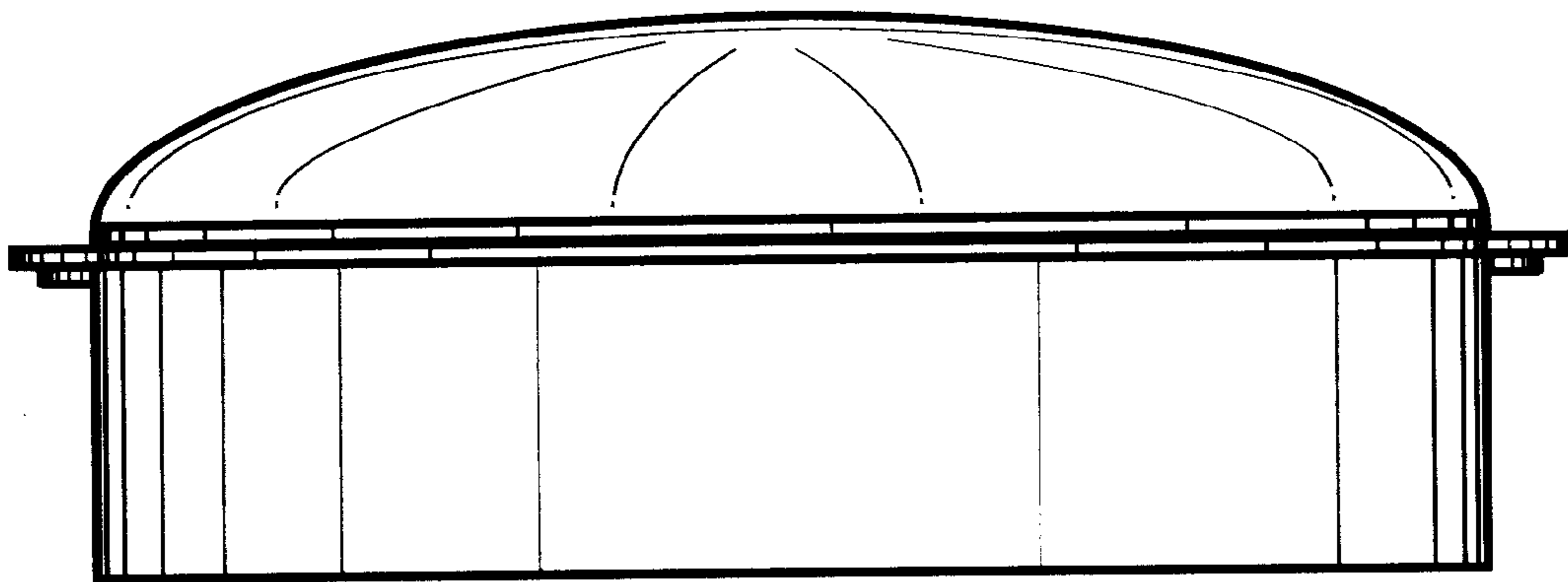

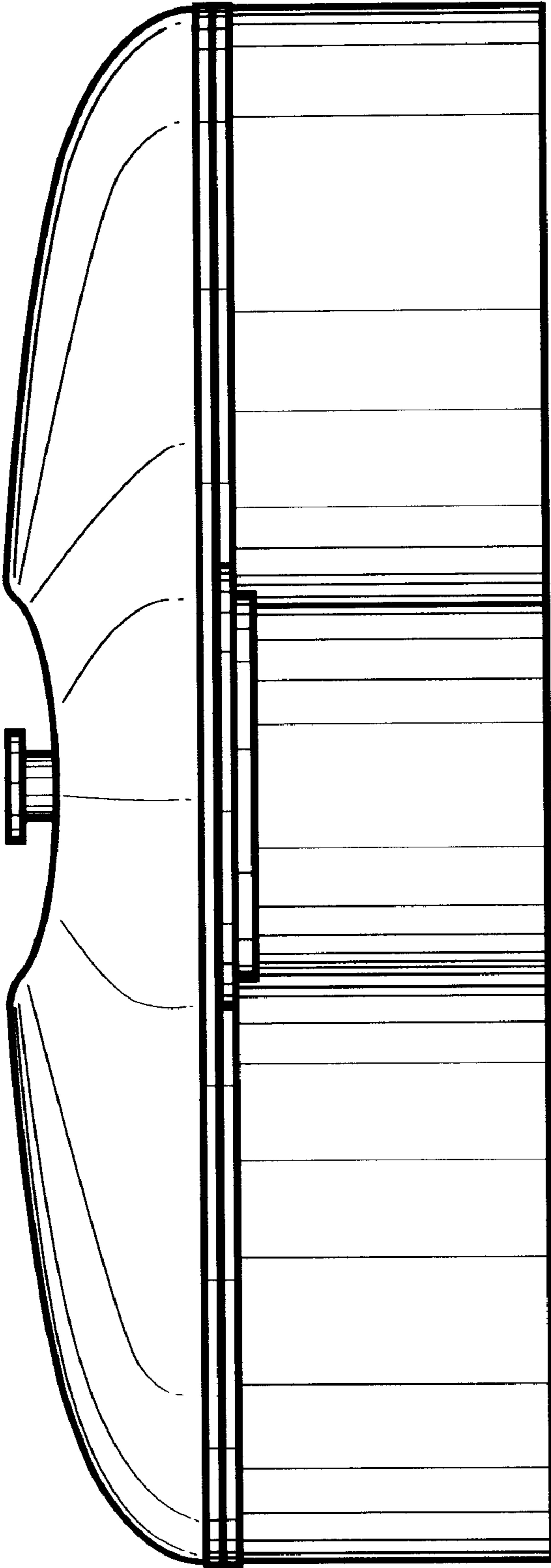

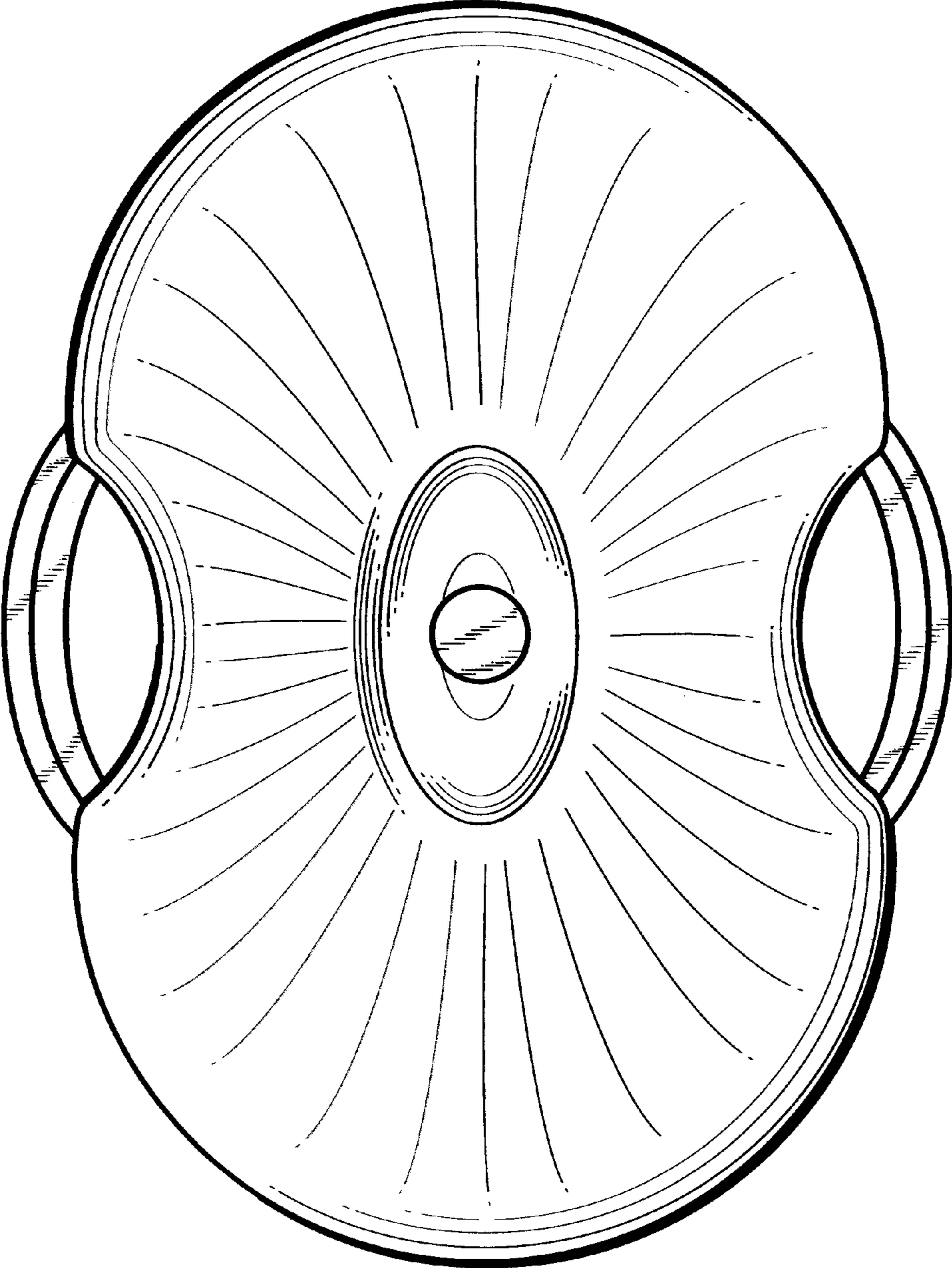

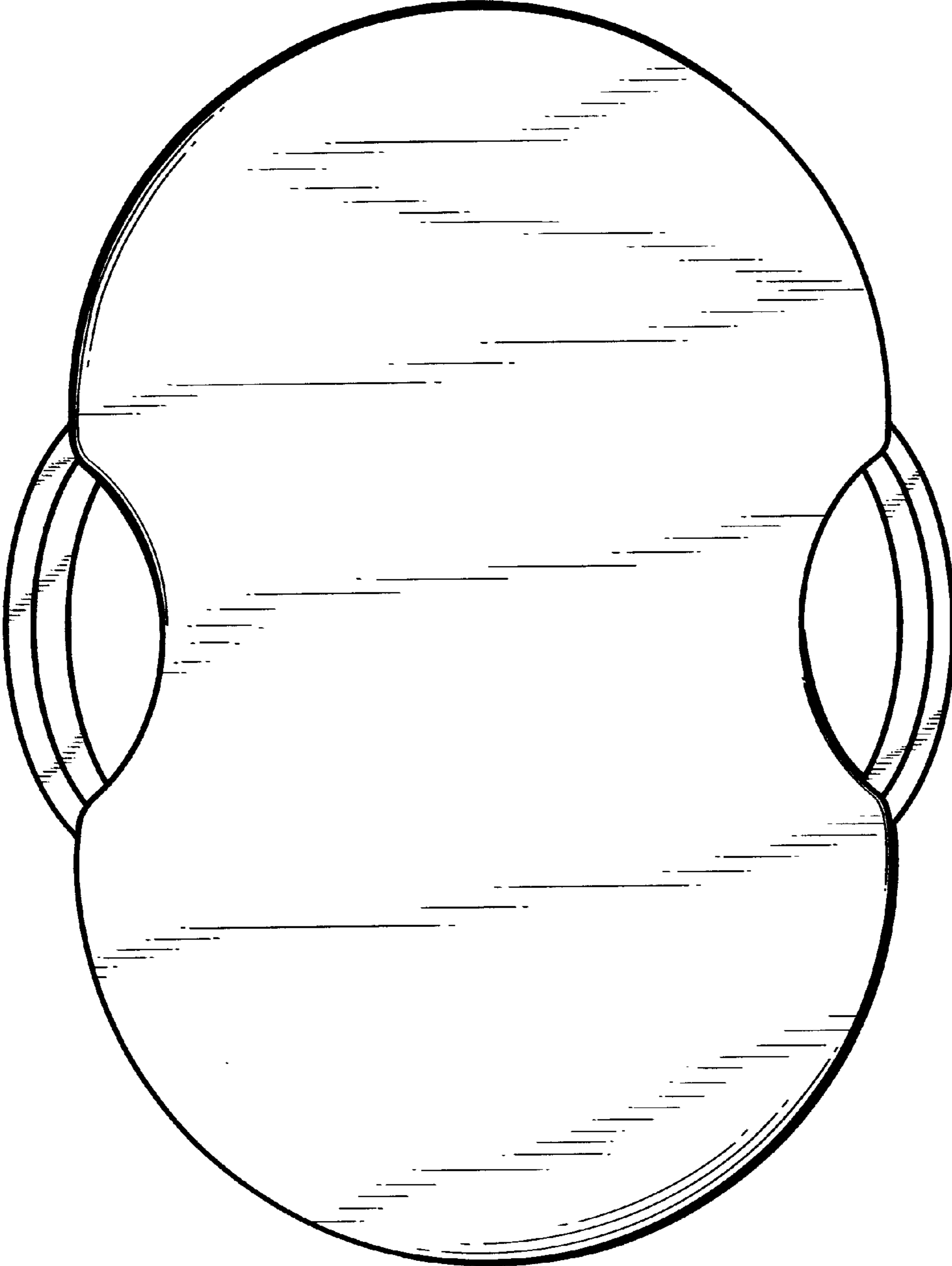

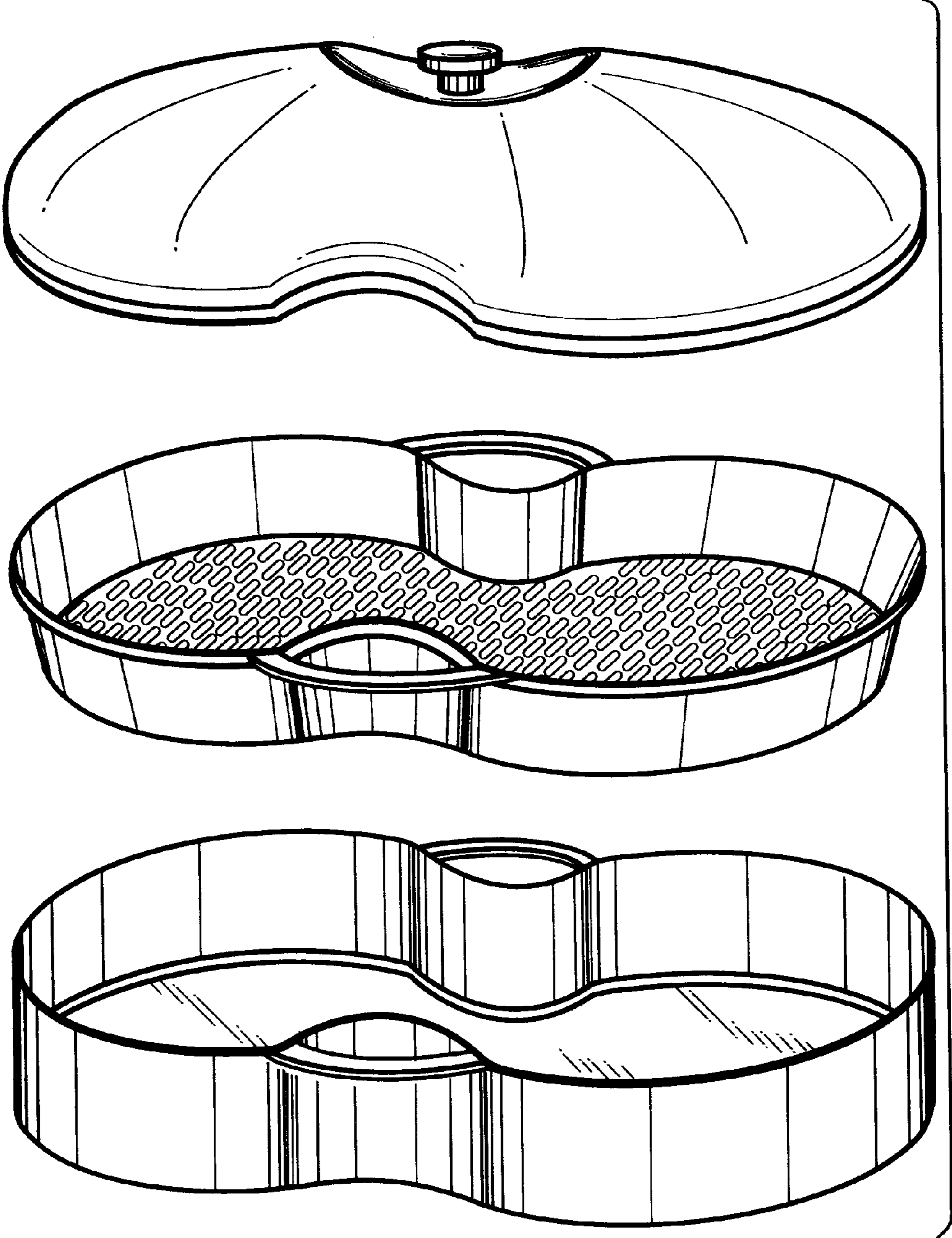
