FIG. 4 is a left side view of the stapler base outer surface.

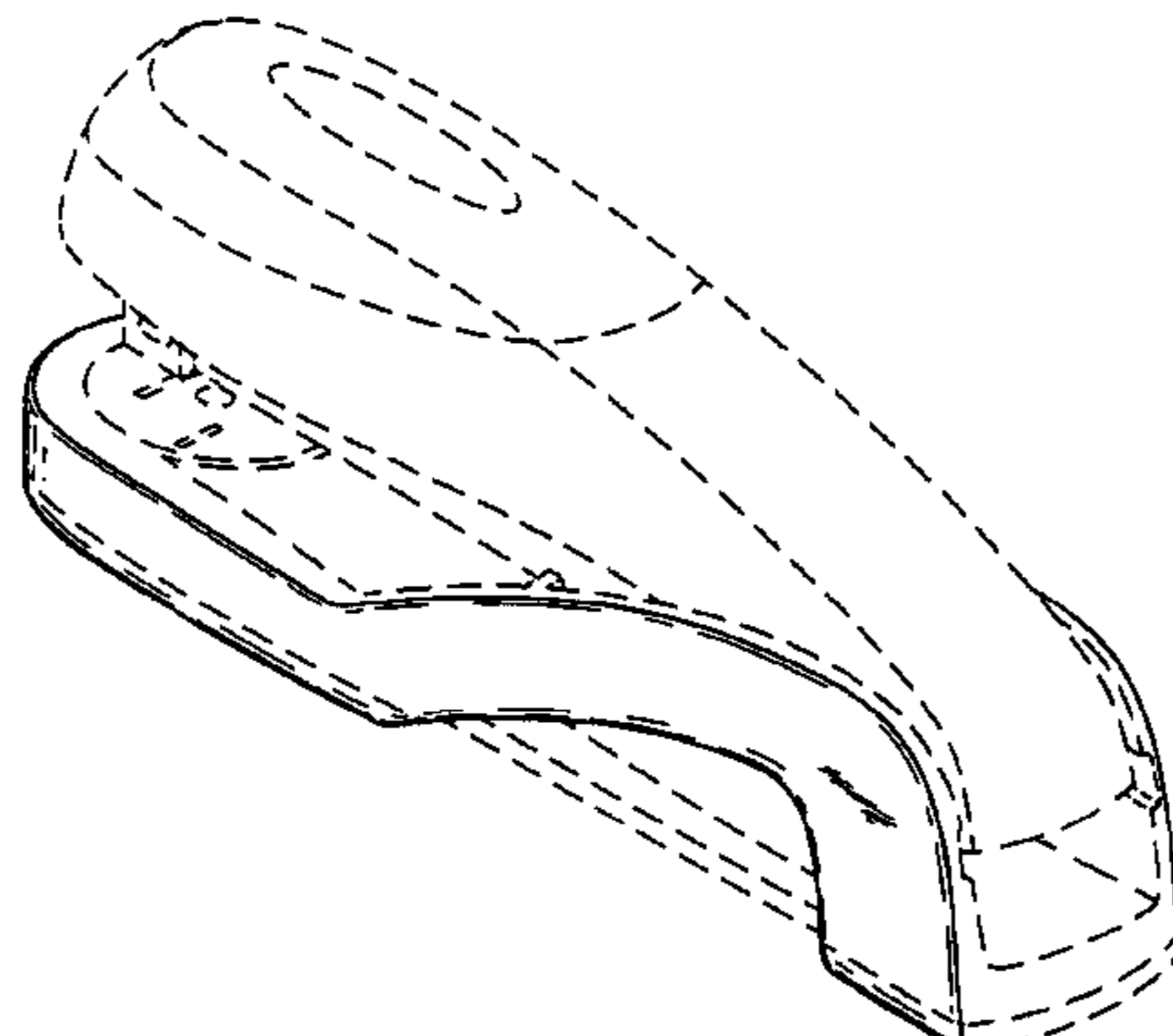
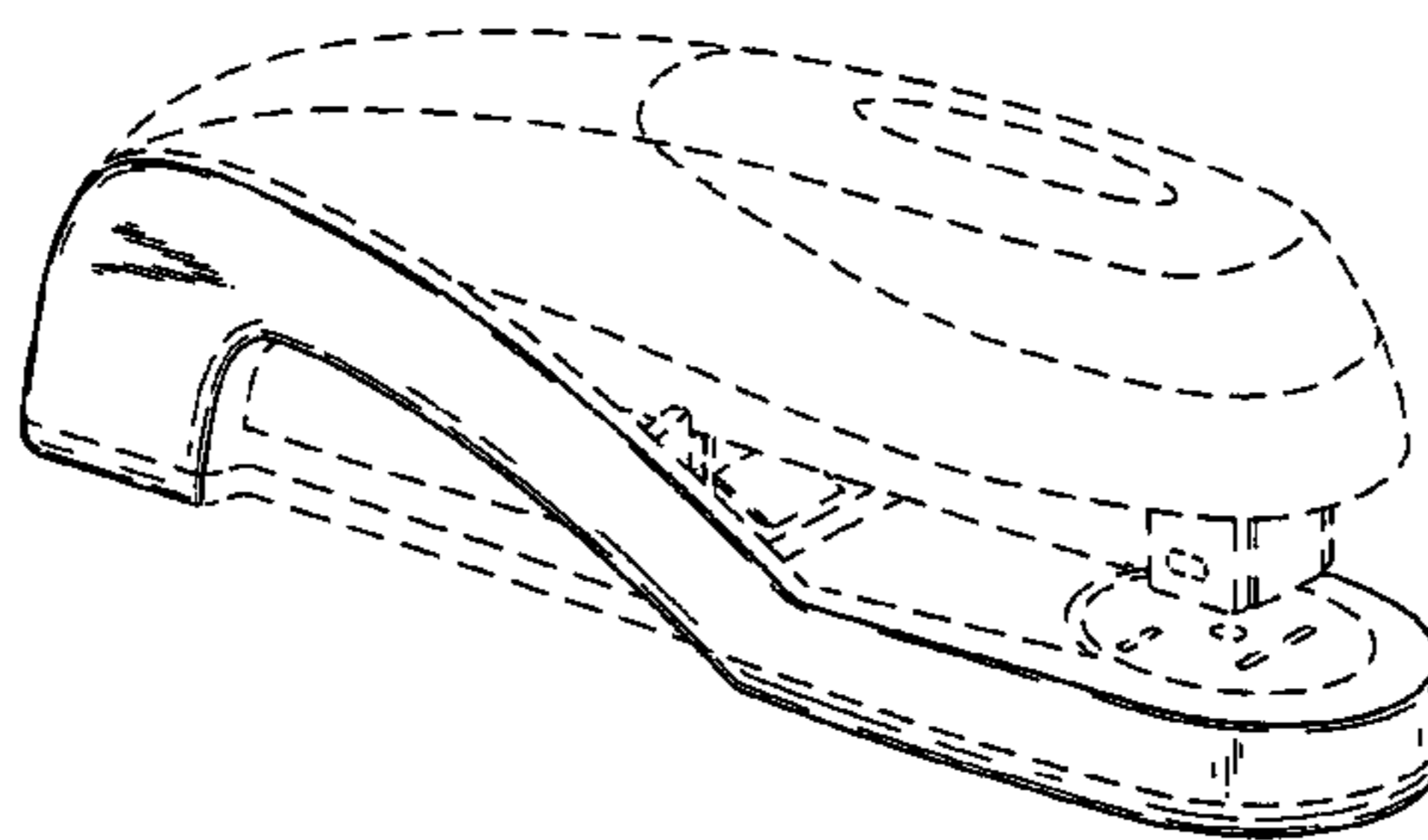
FIG. 5 is a front view of the stapler base outer surface.

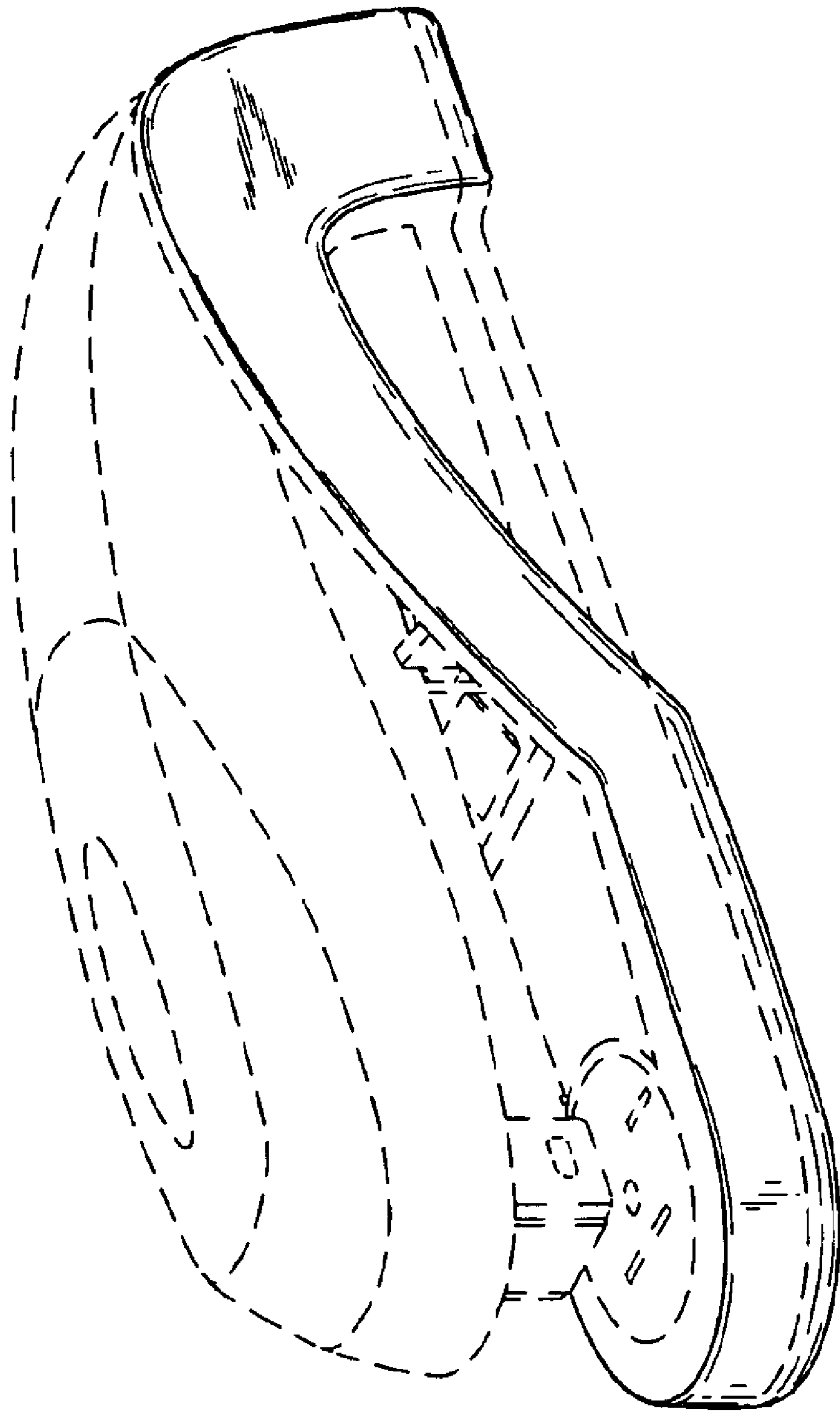

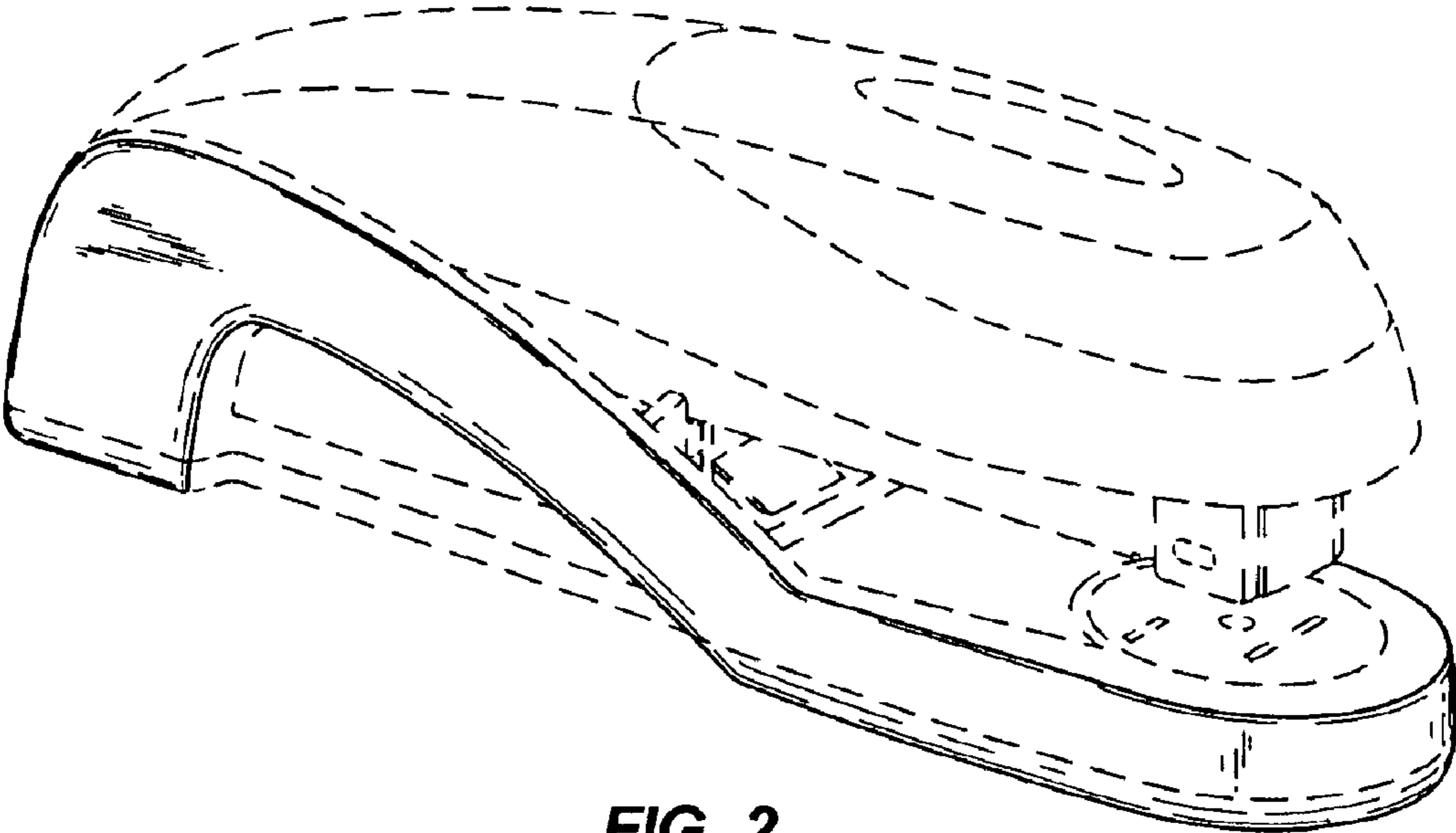

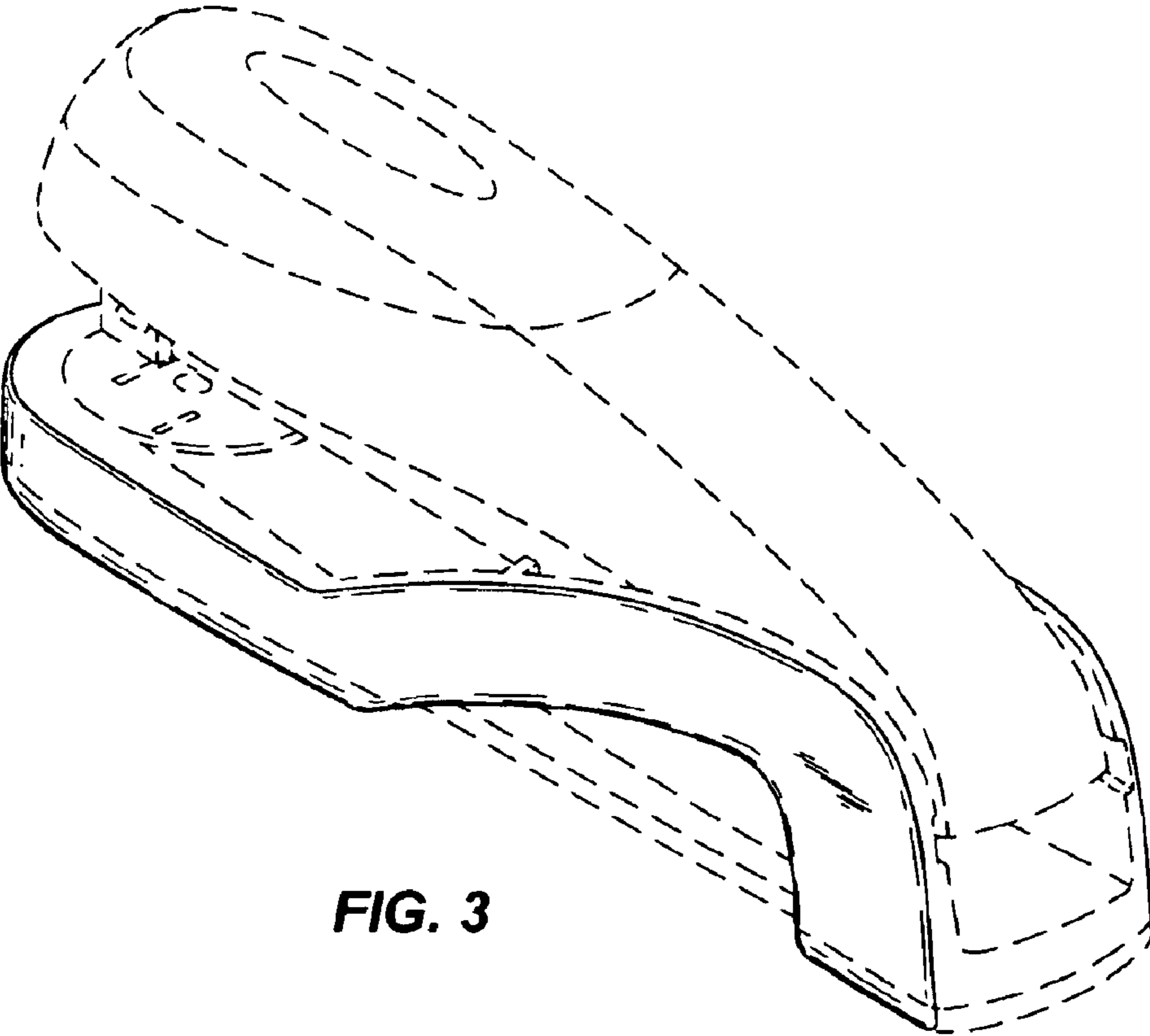

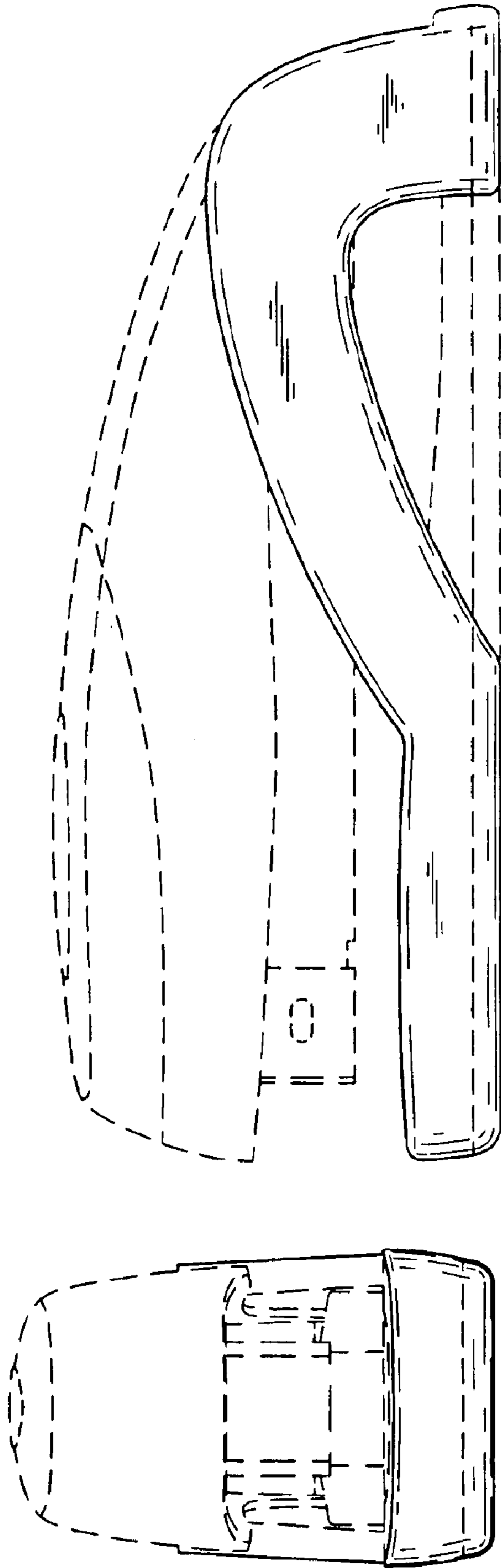

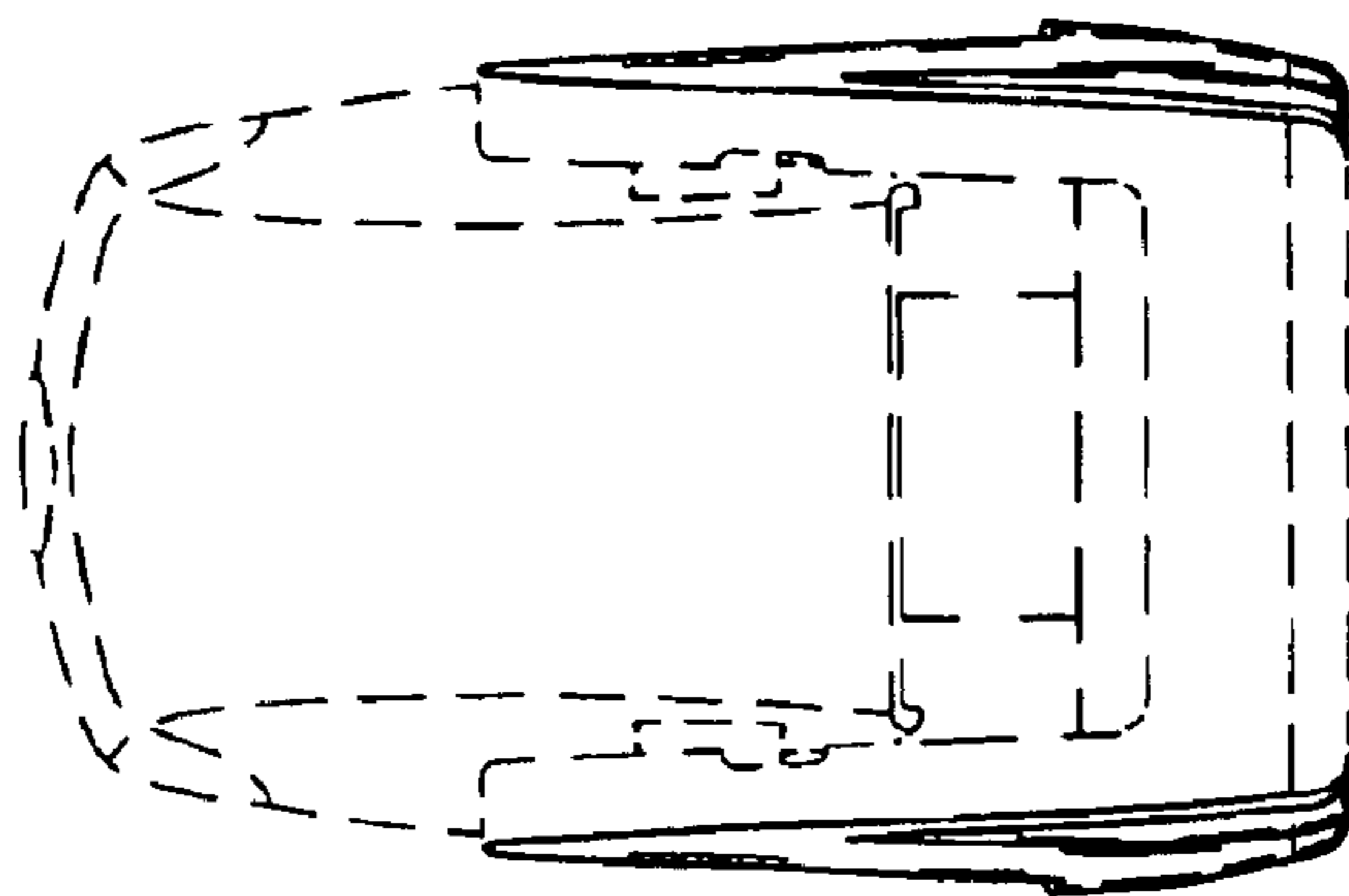

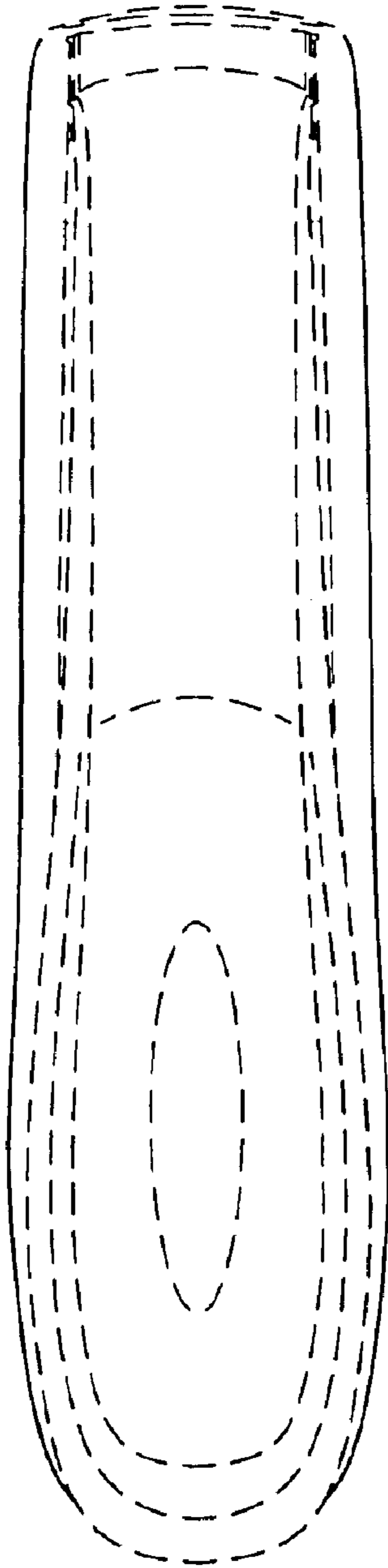
