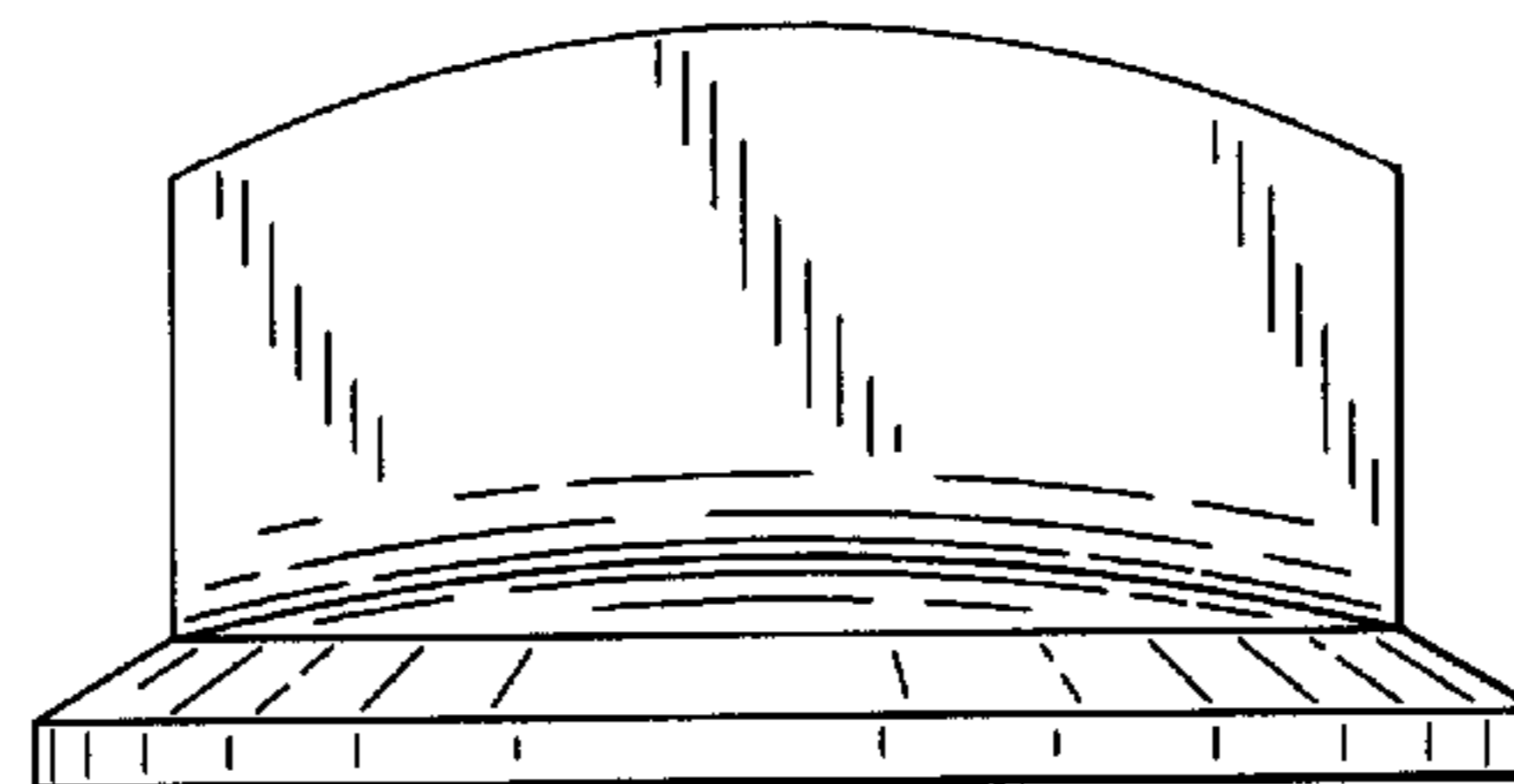
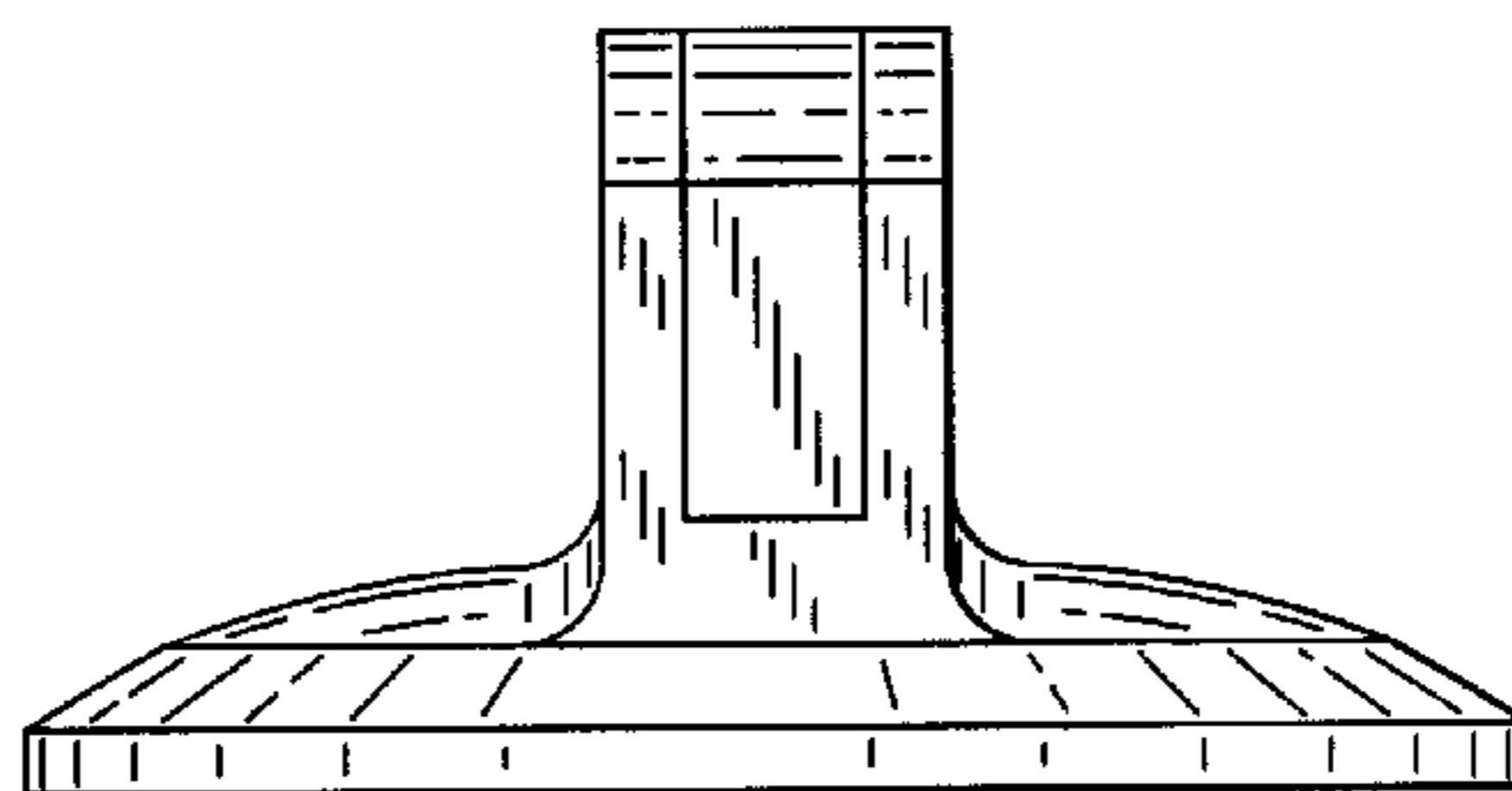

FIG. 2 is a bottom view of the rotary knob of FIG. 1; FIG. 3 is a first side view of the rotary knob of FIG. 1, the opposite side view being symmetric therewith; and, FIG. 4 is a second side view, rotated ninety degrees from the first side view of the rotary knob of FIG. 1, the opposite side being symmetric therewith.

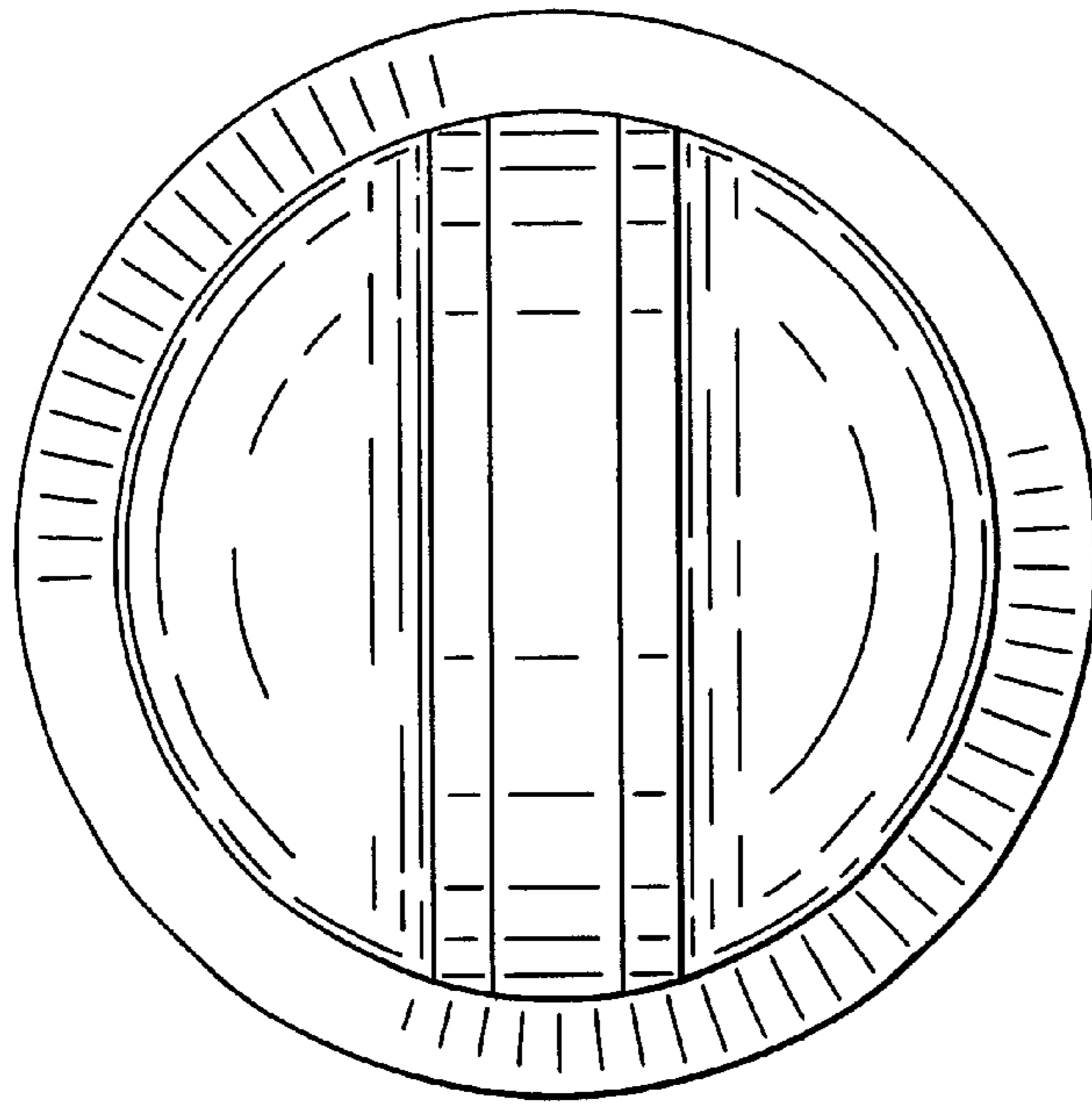

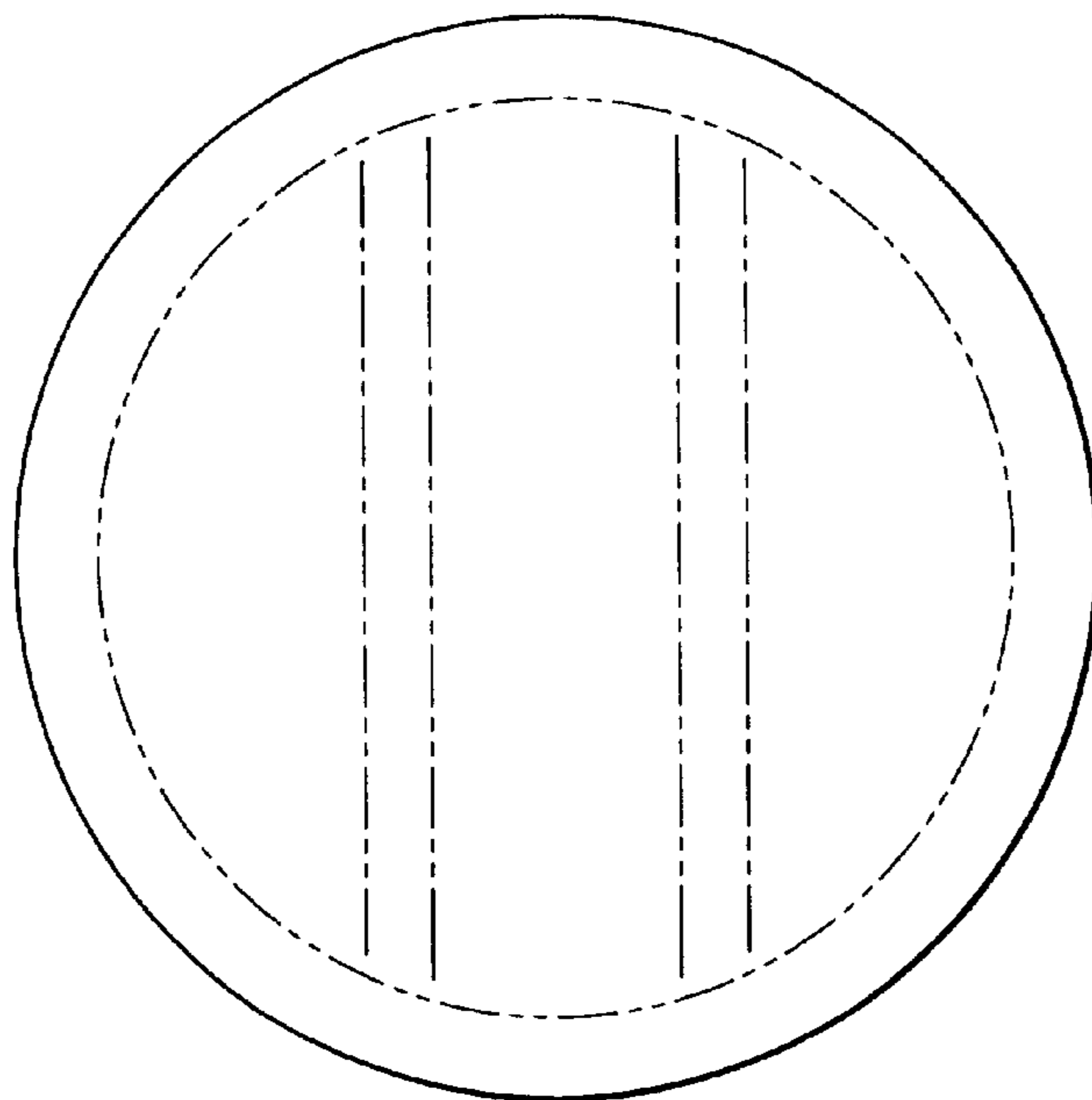

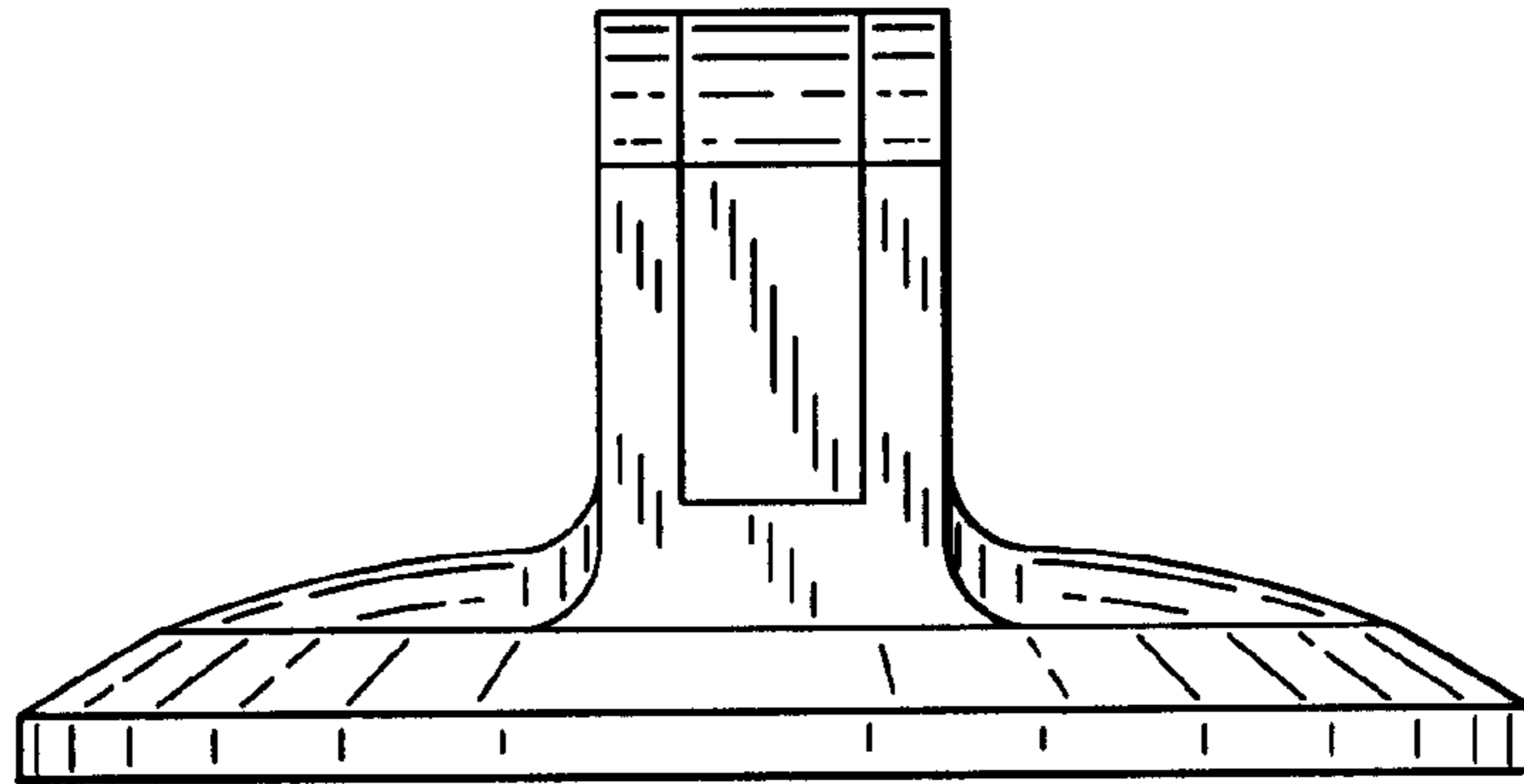

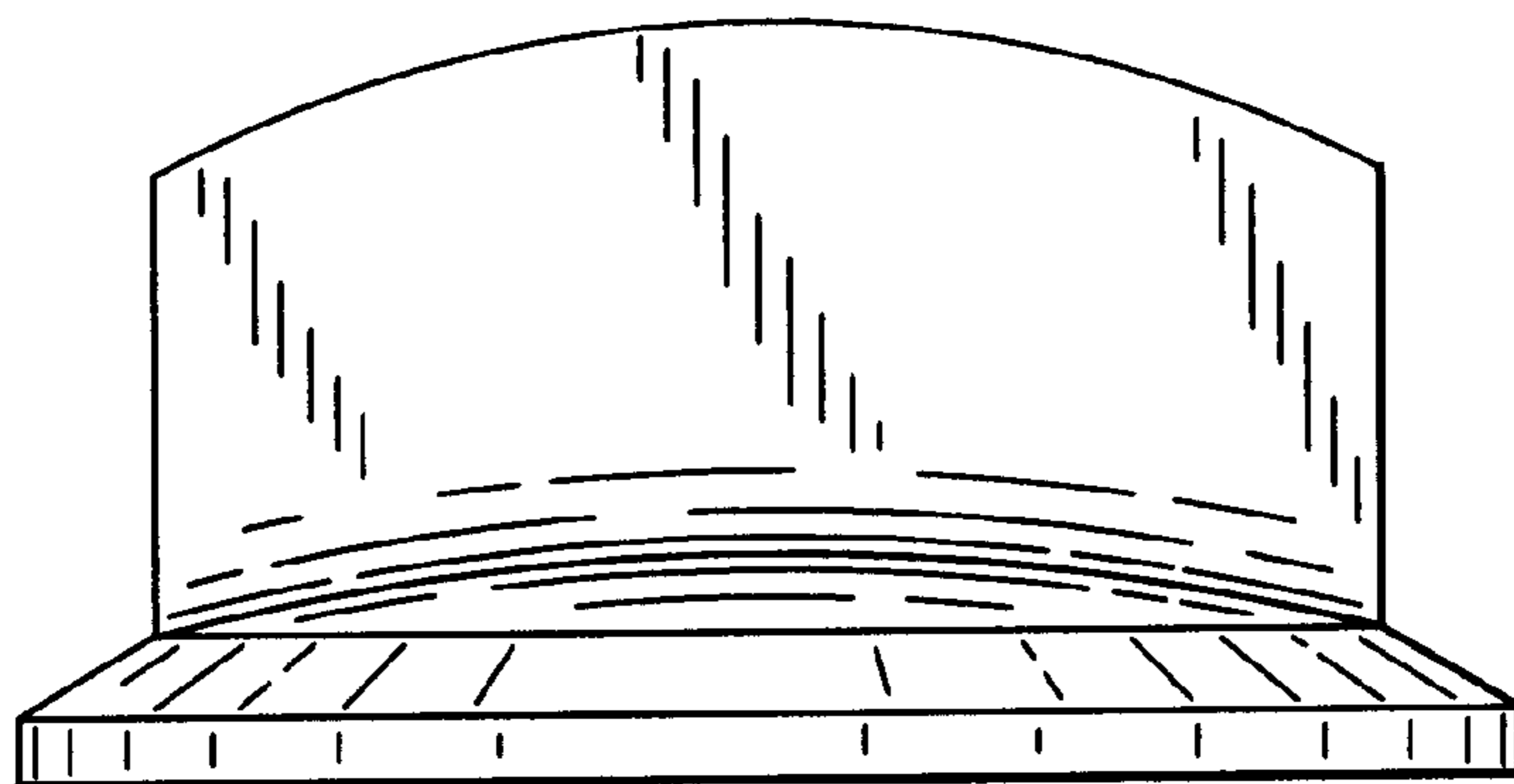
