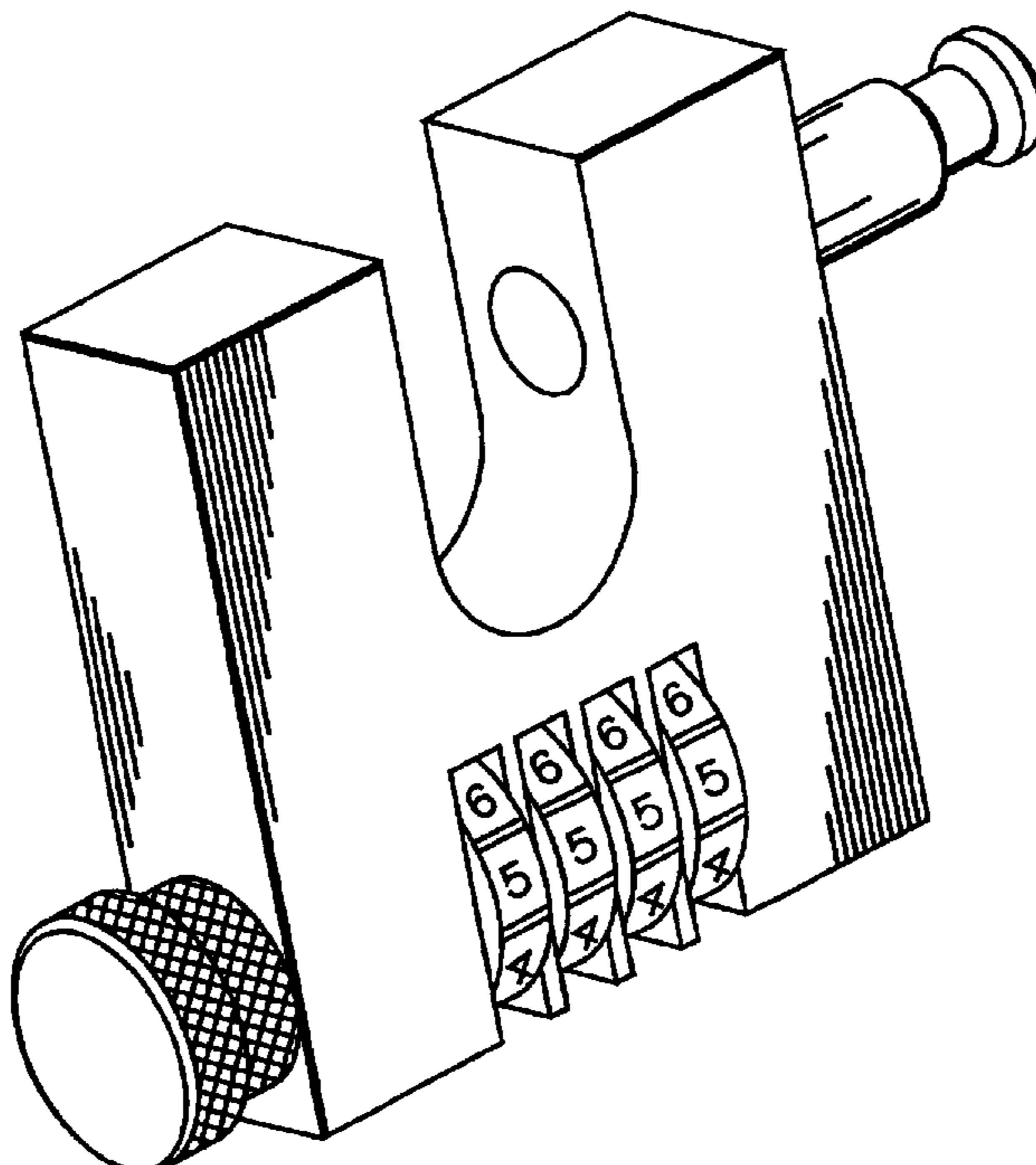
(57) **CLAIM**

The ornamental design for a combination padlock with horizontal locking bar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combination padlock with horizontal locking bar showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a side elevational view thereof, looking from the left side of FIG. 2;

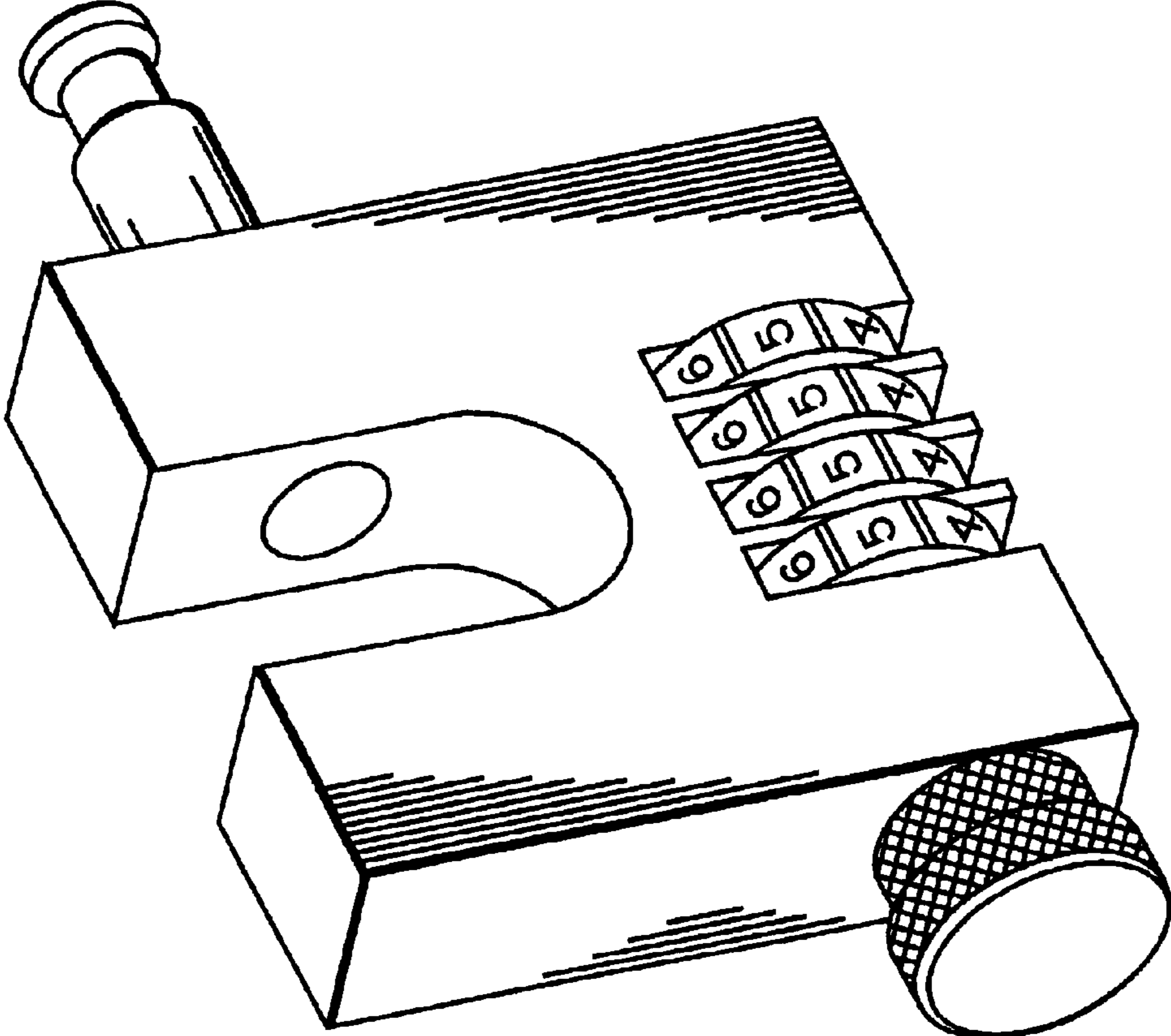

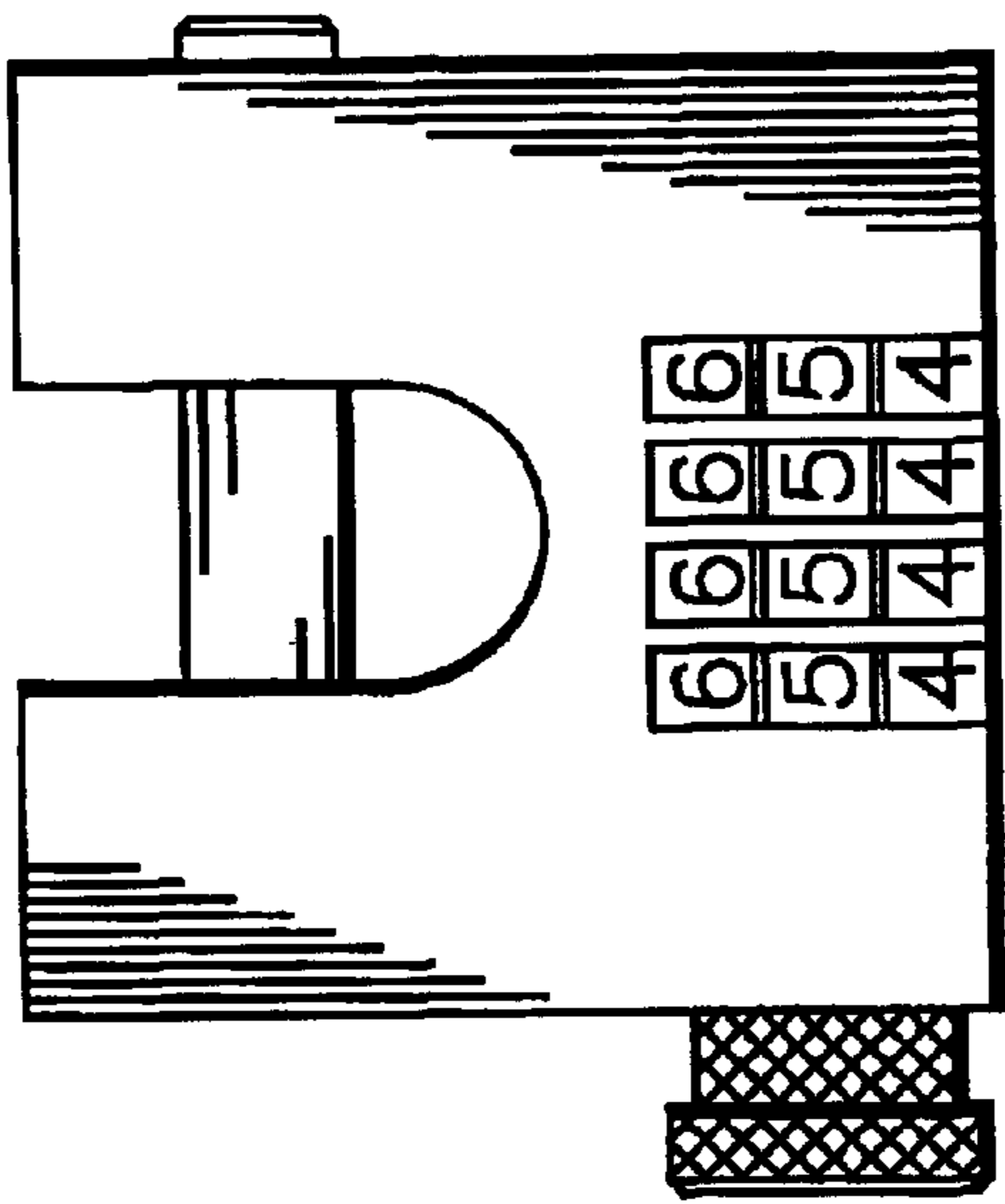

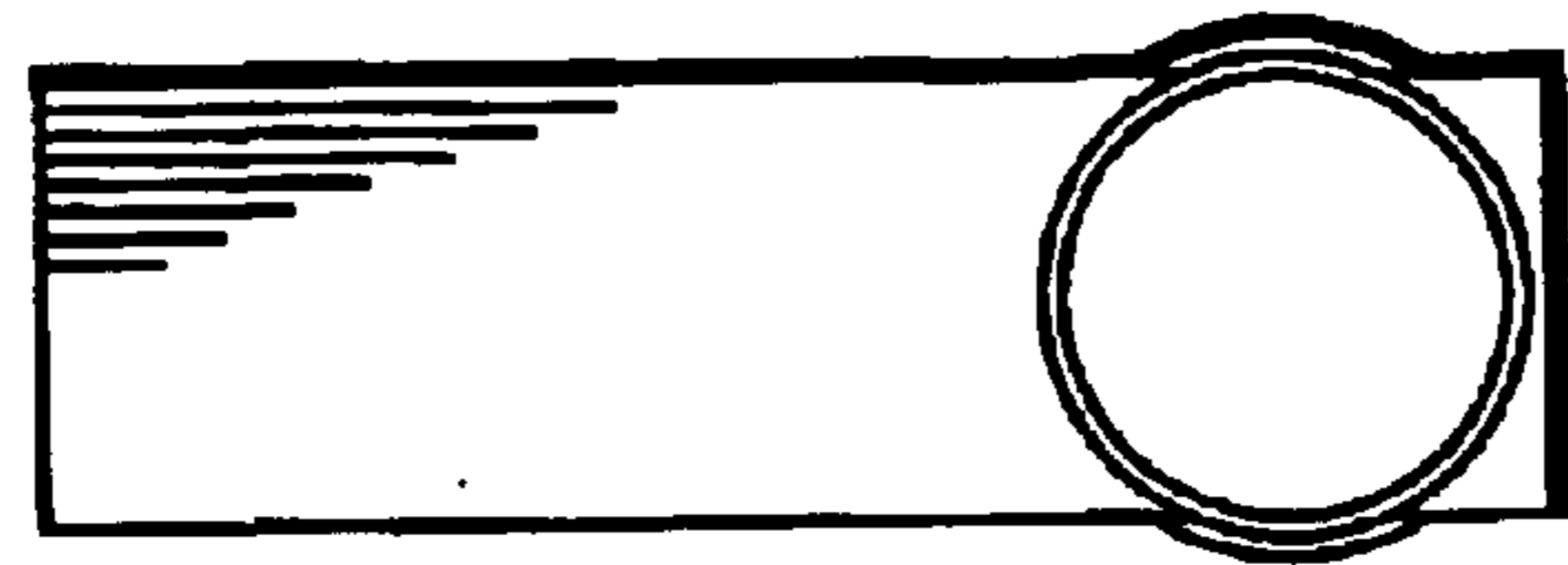

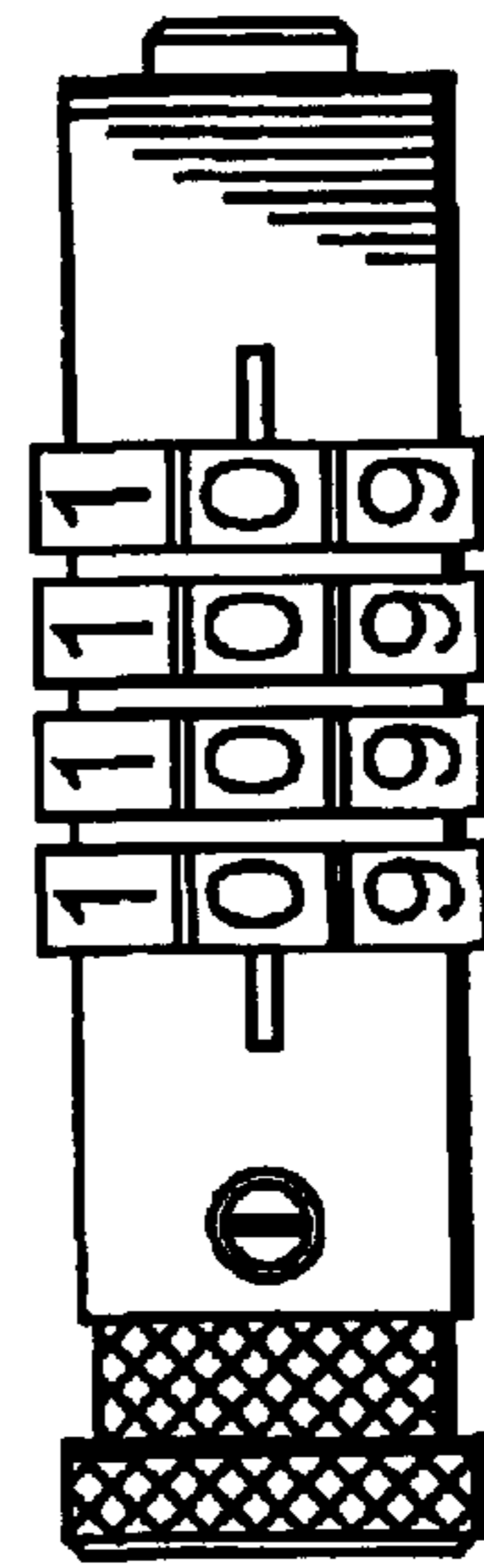

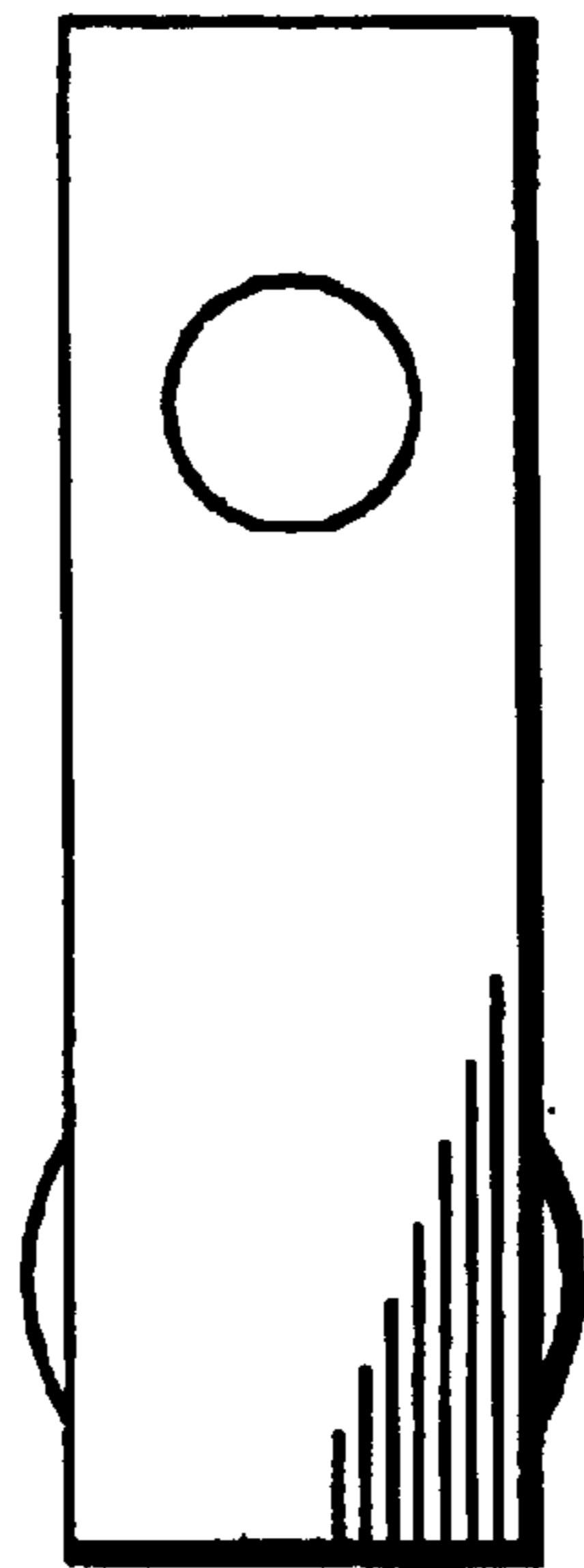

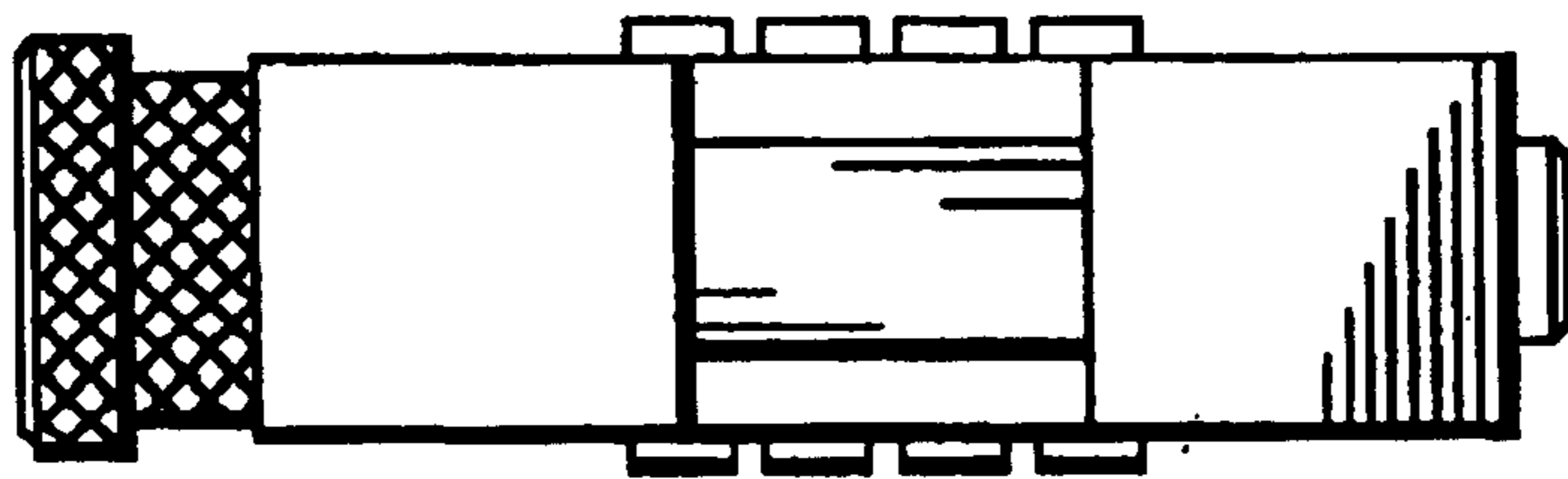

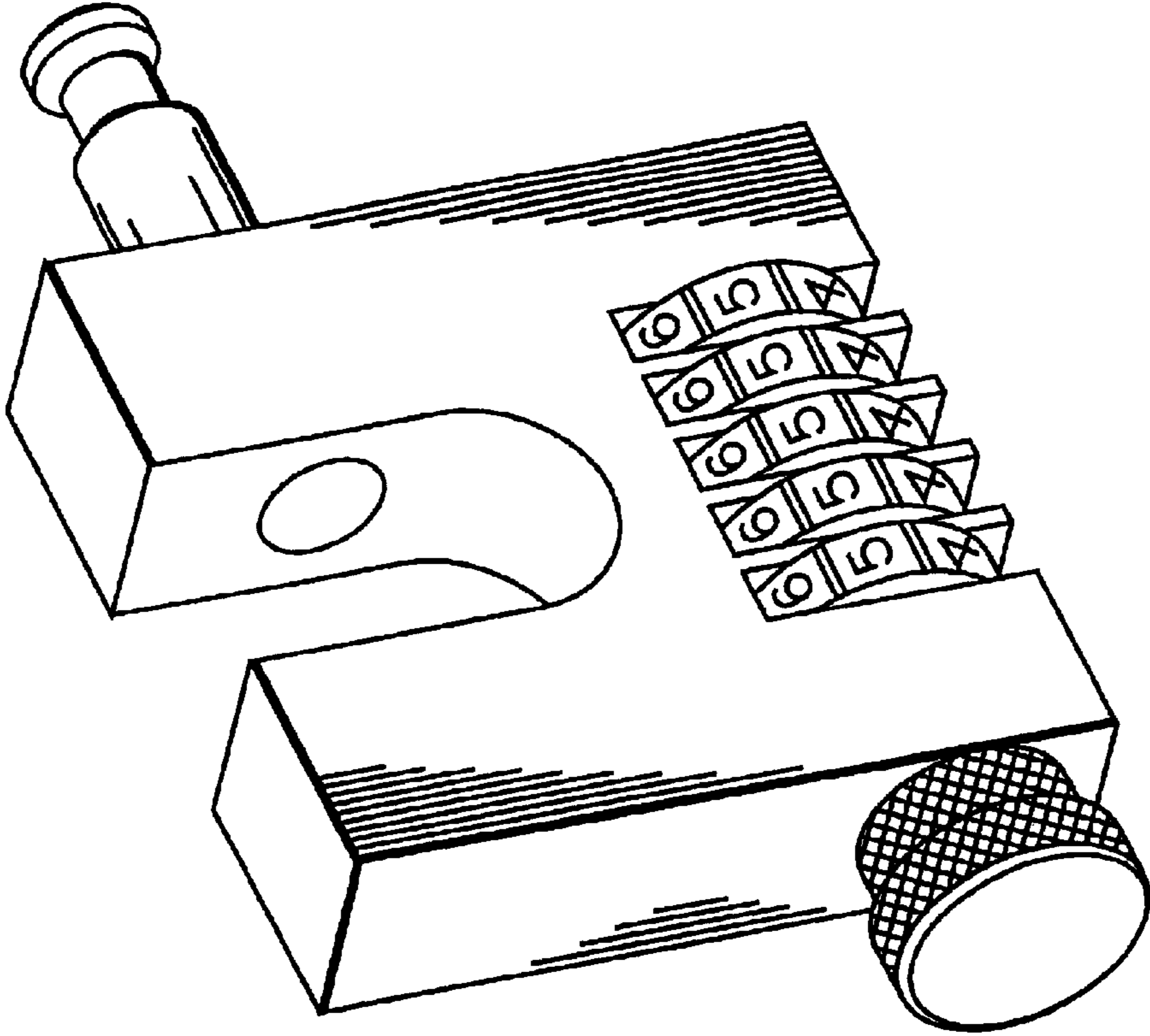

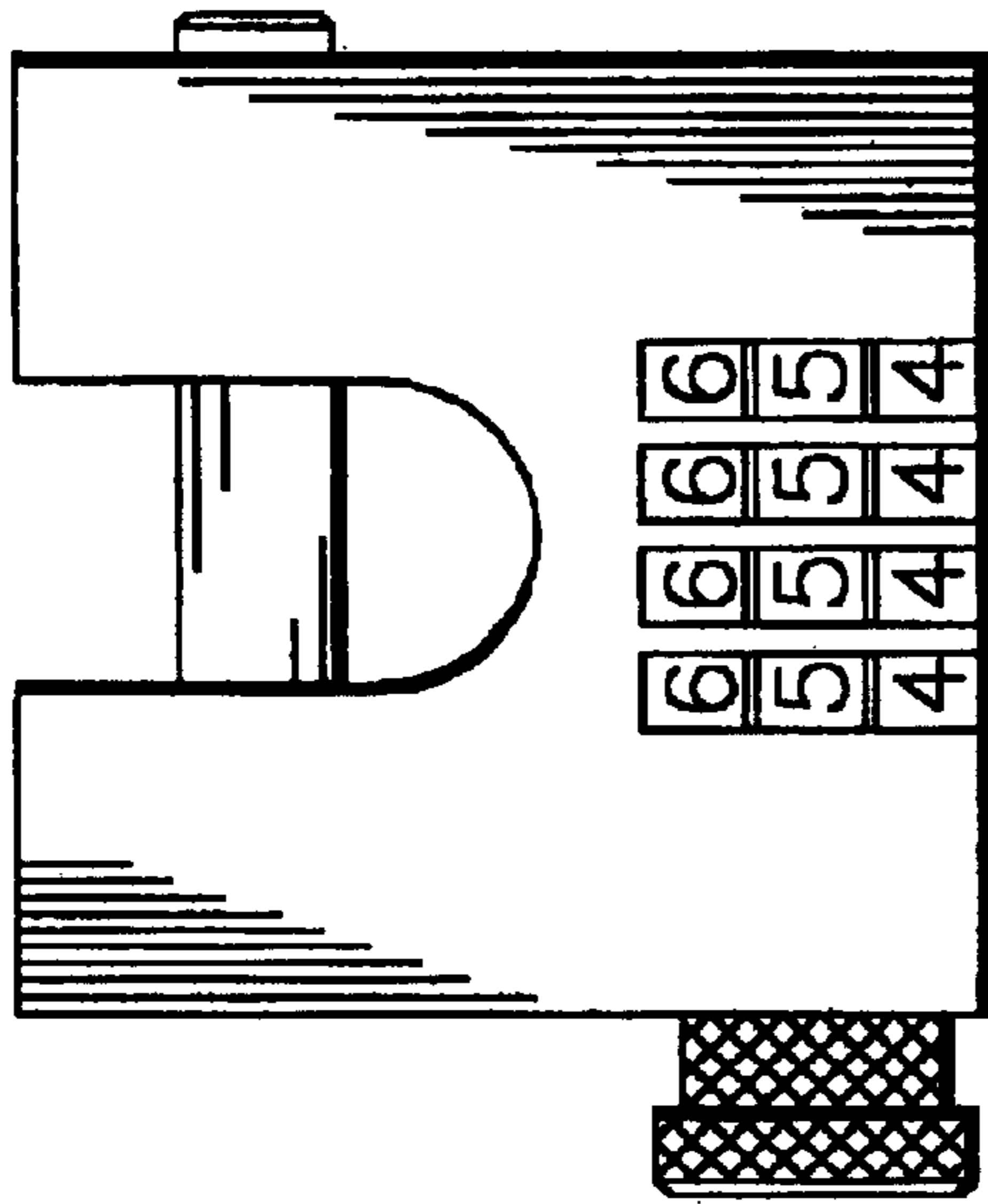

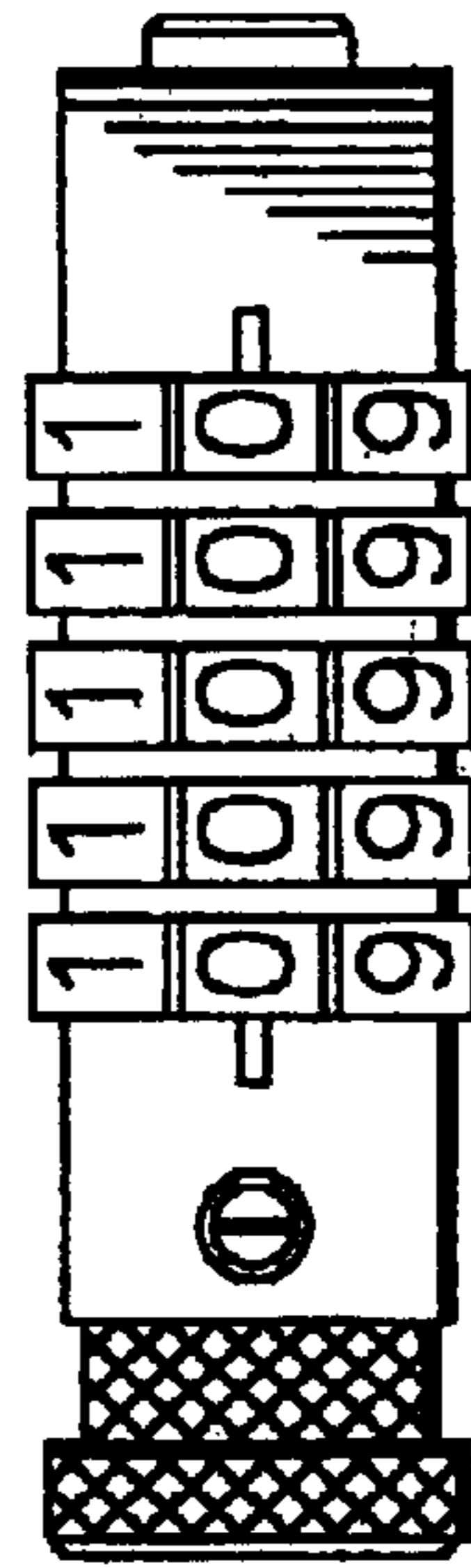

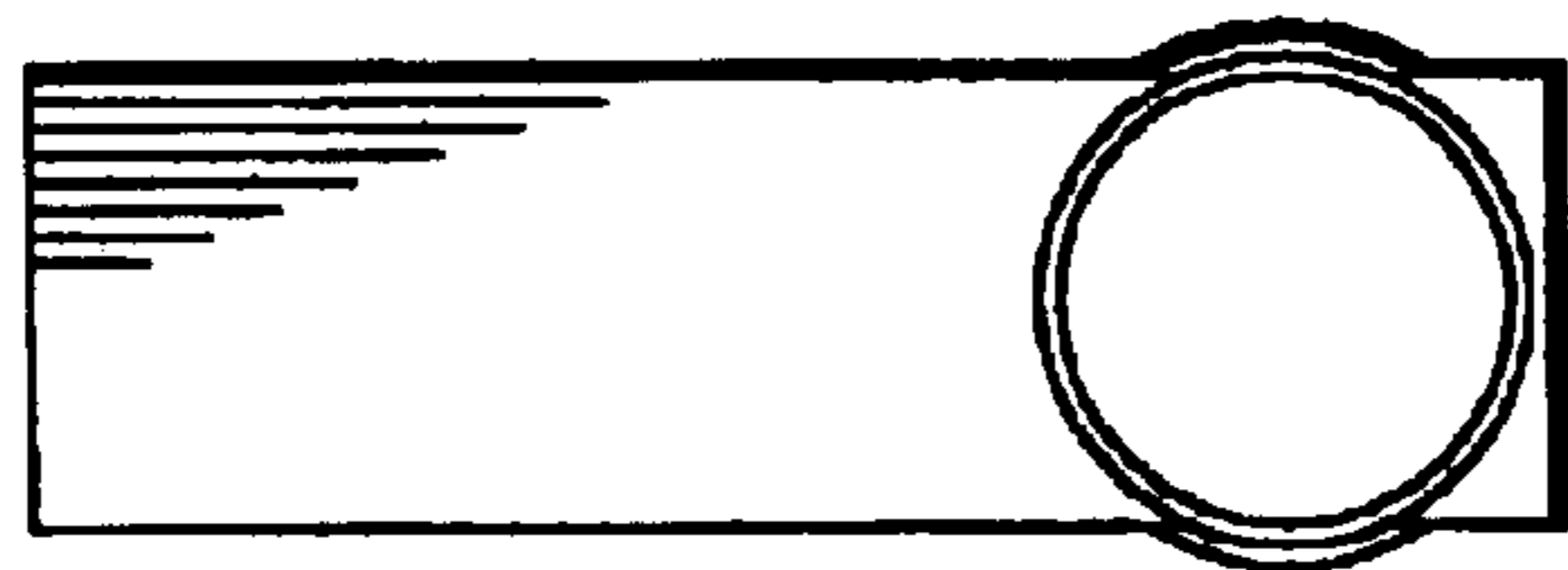

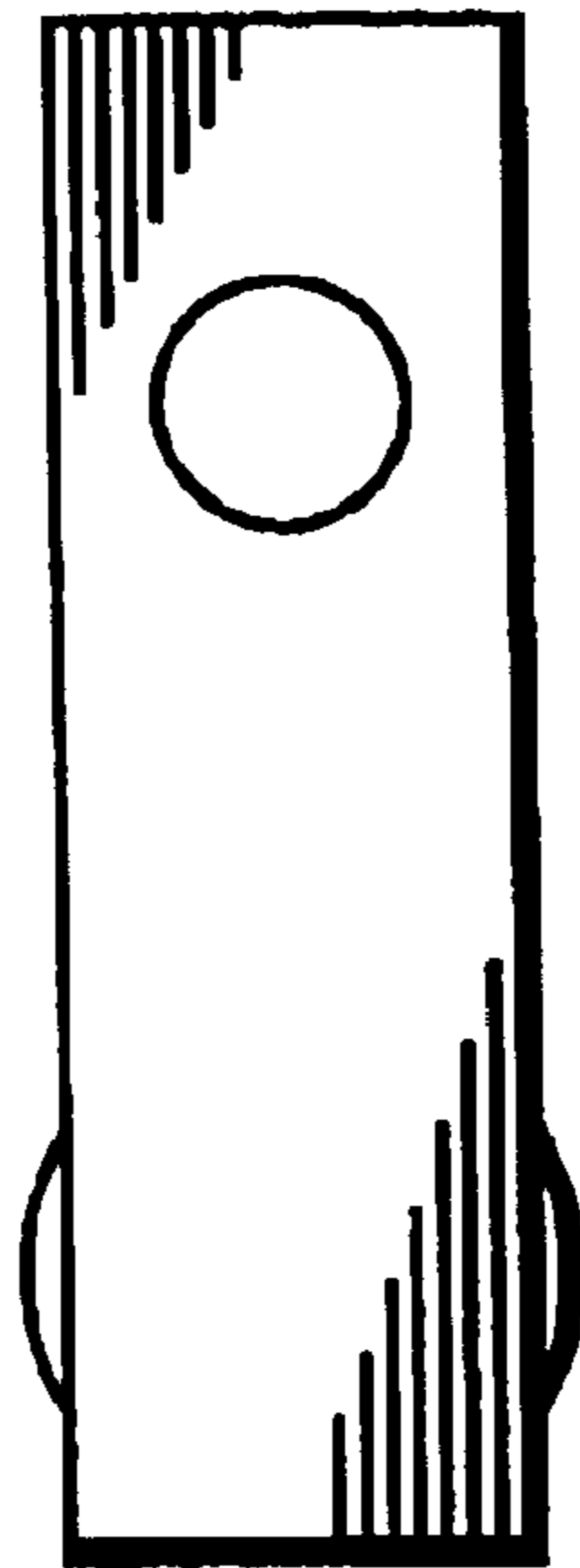

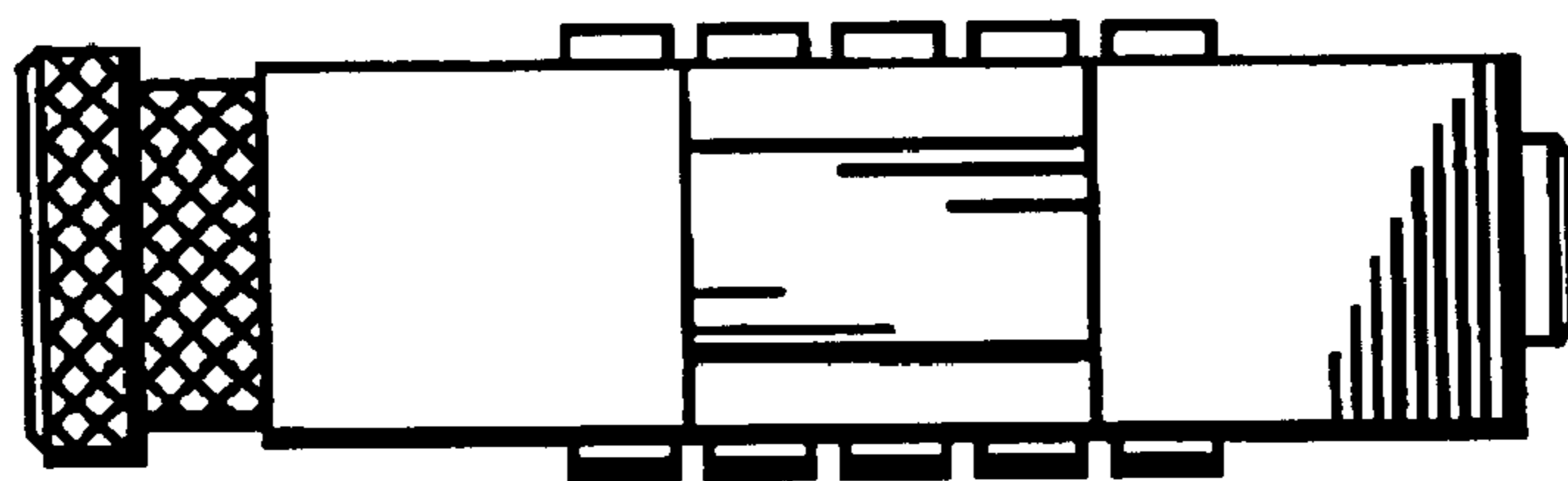
