FIG. 1 is a rear perspective view of a handlebar showing our new design.

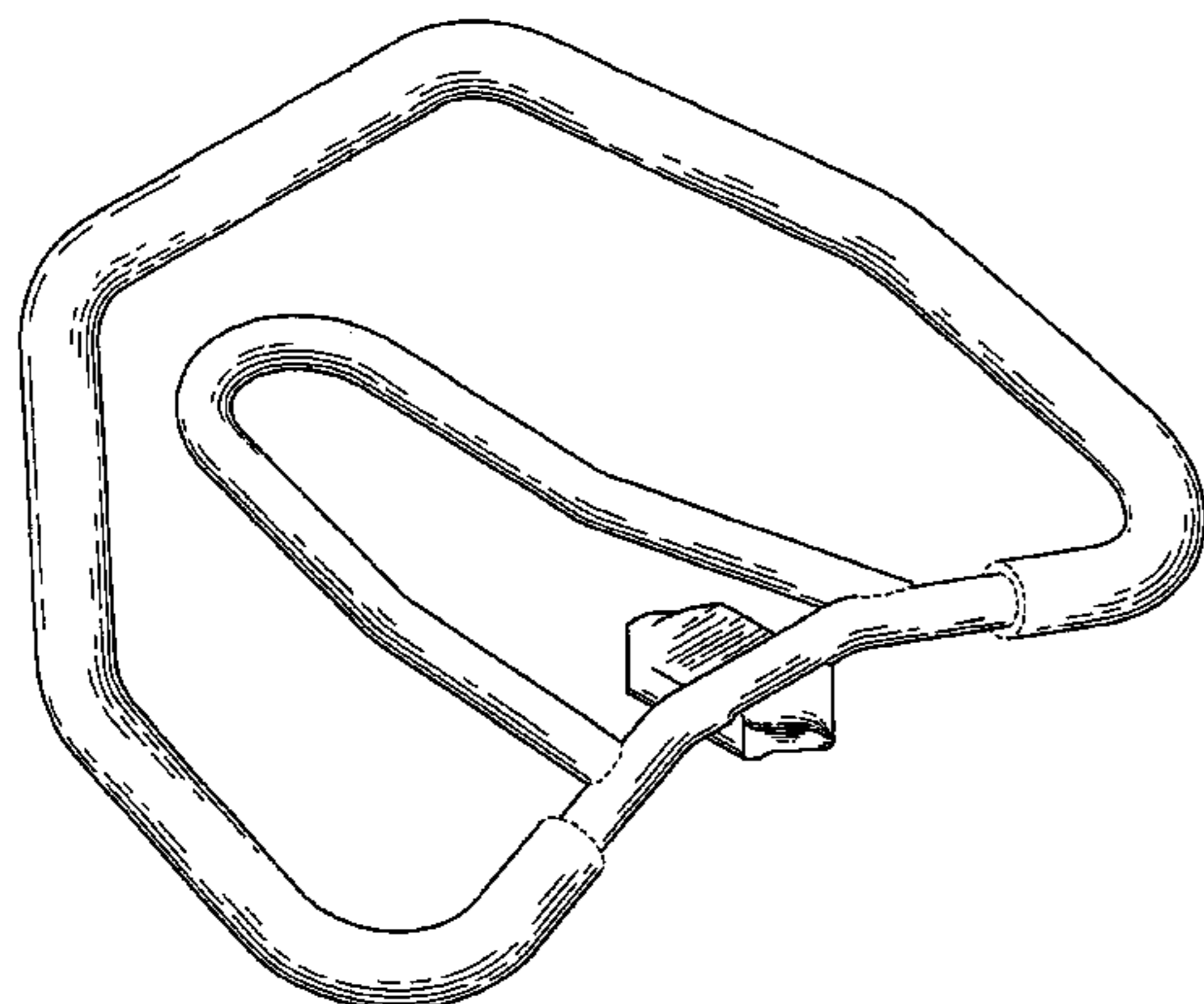


FIG. 2 is a top plan view thereof.

FIG. 25 is a front elevational view thereof.

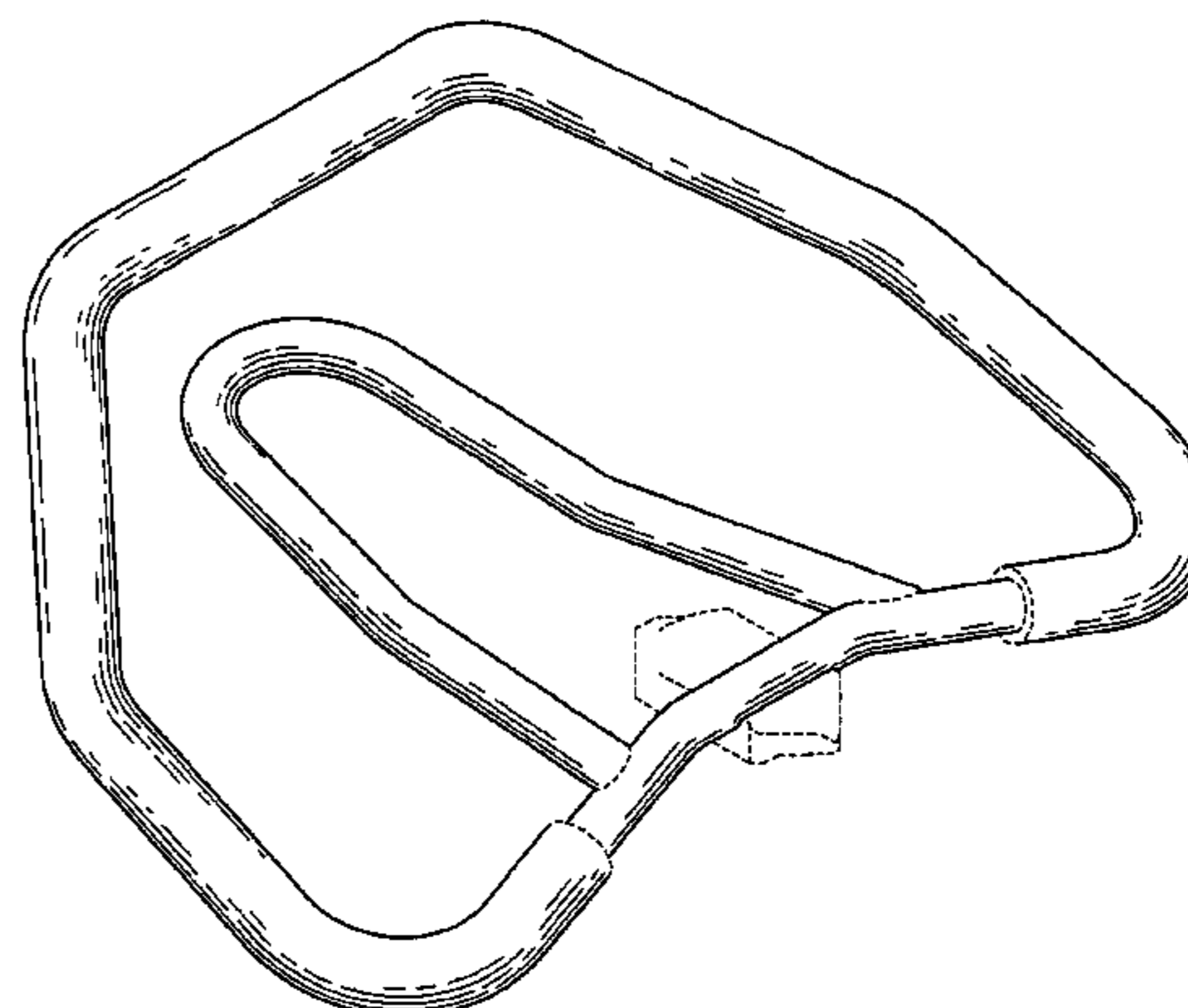
FIG. 26 is a rear elevational view thereof.

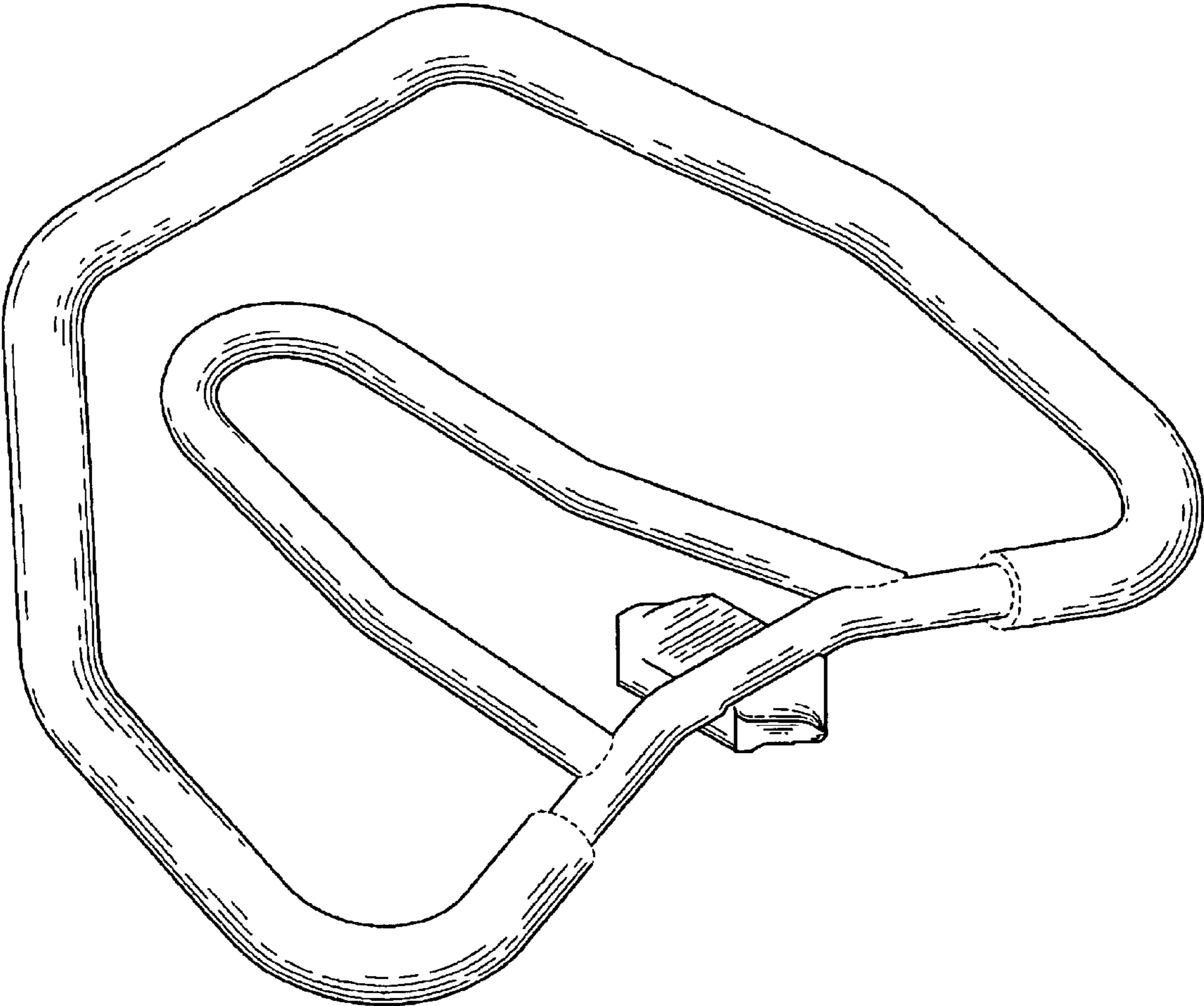

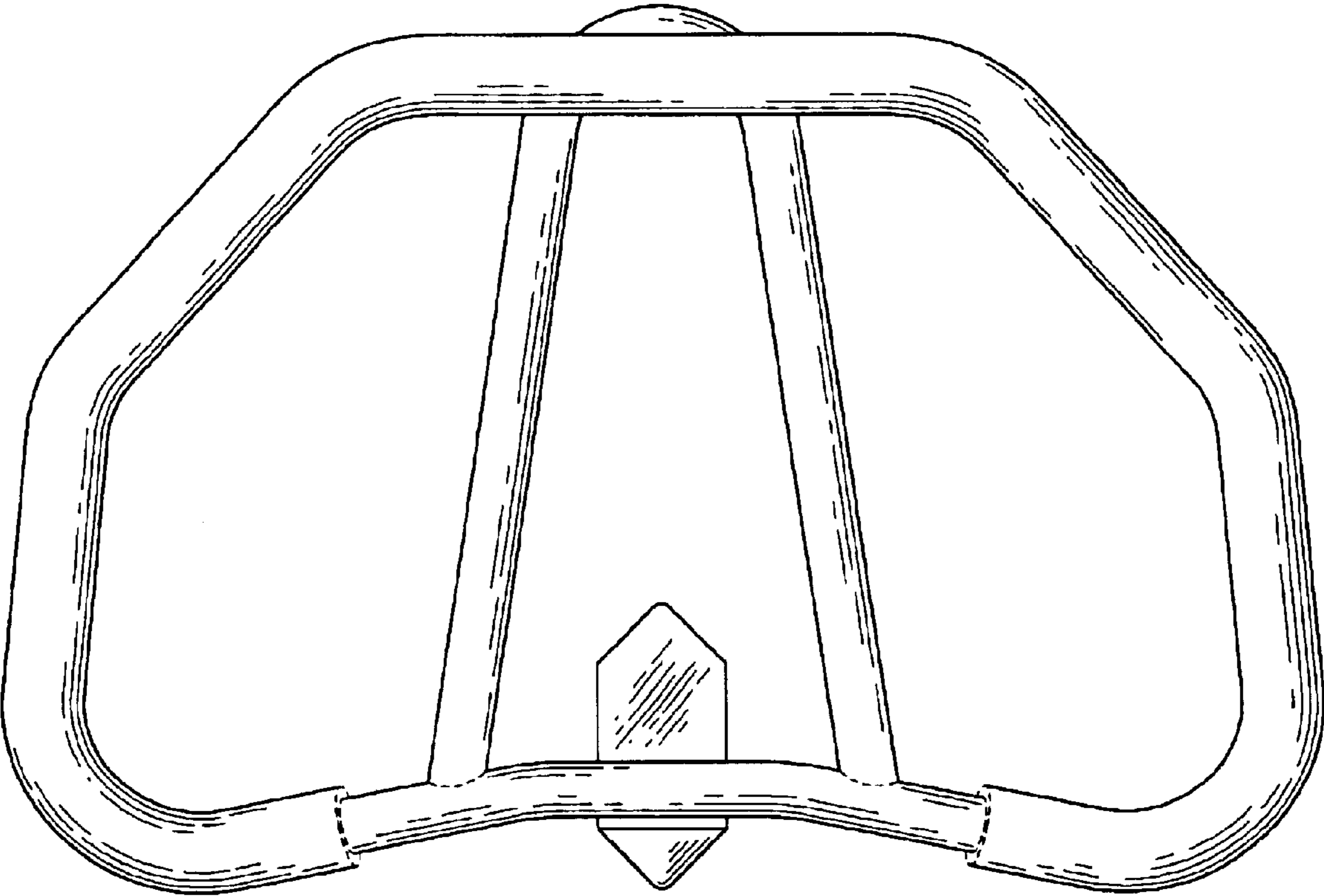

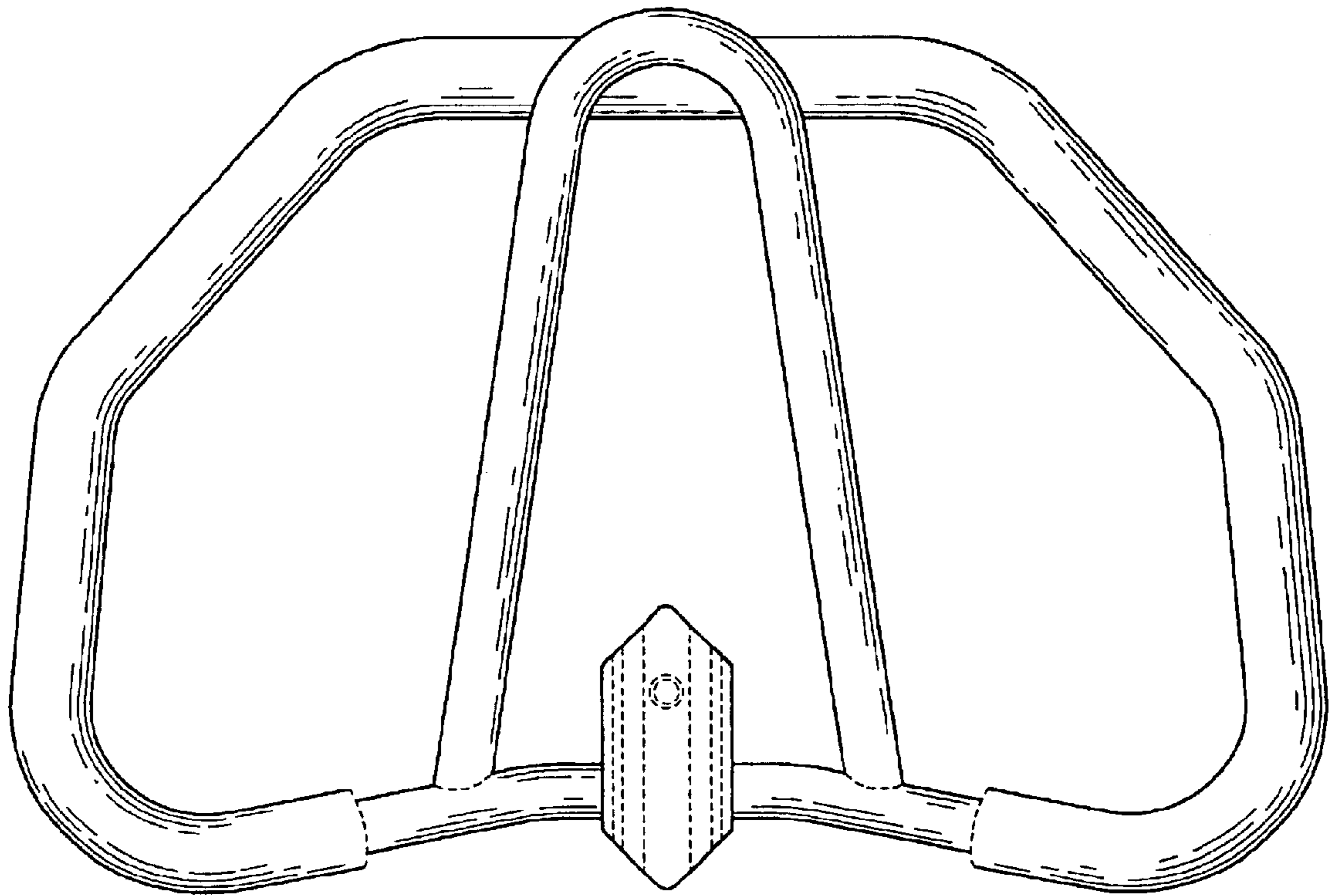

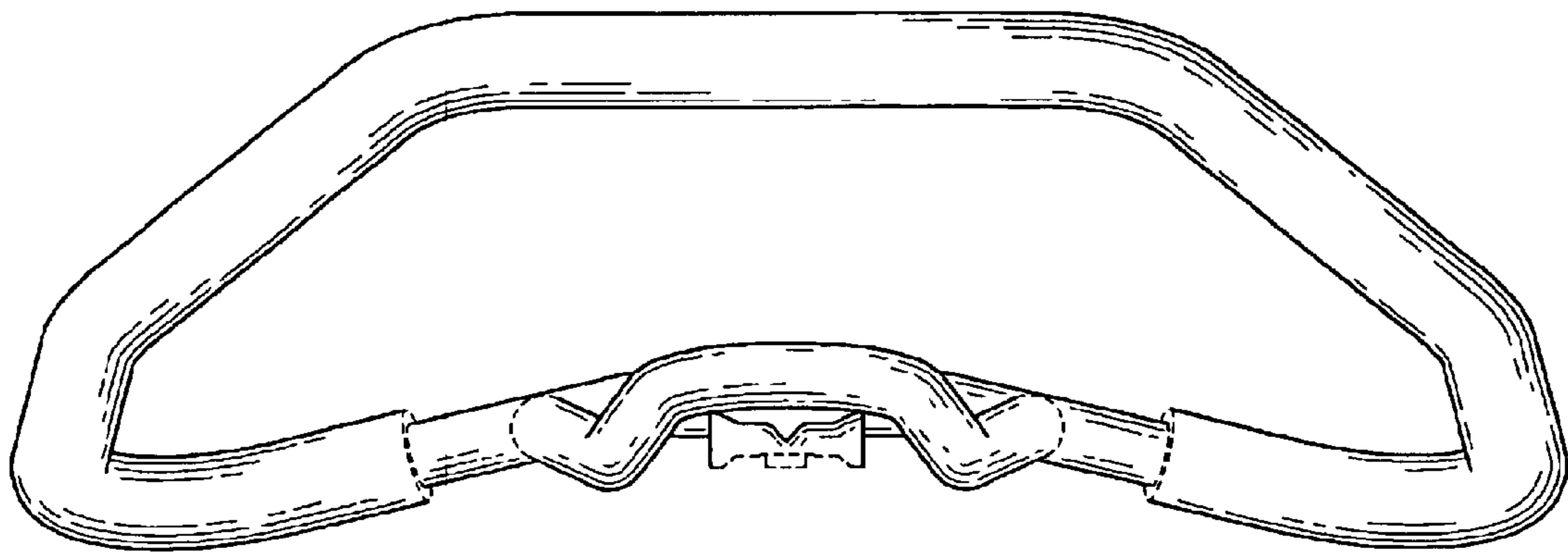

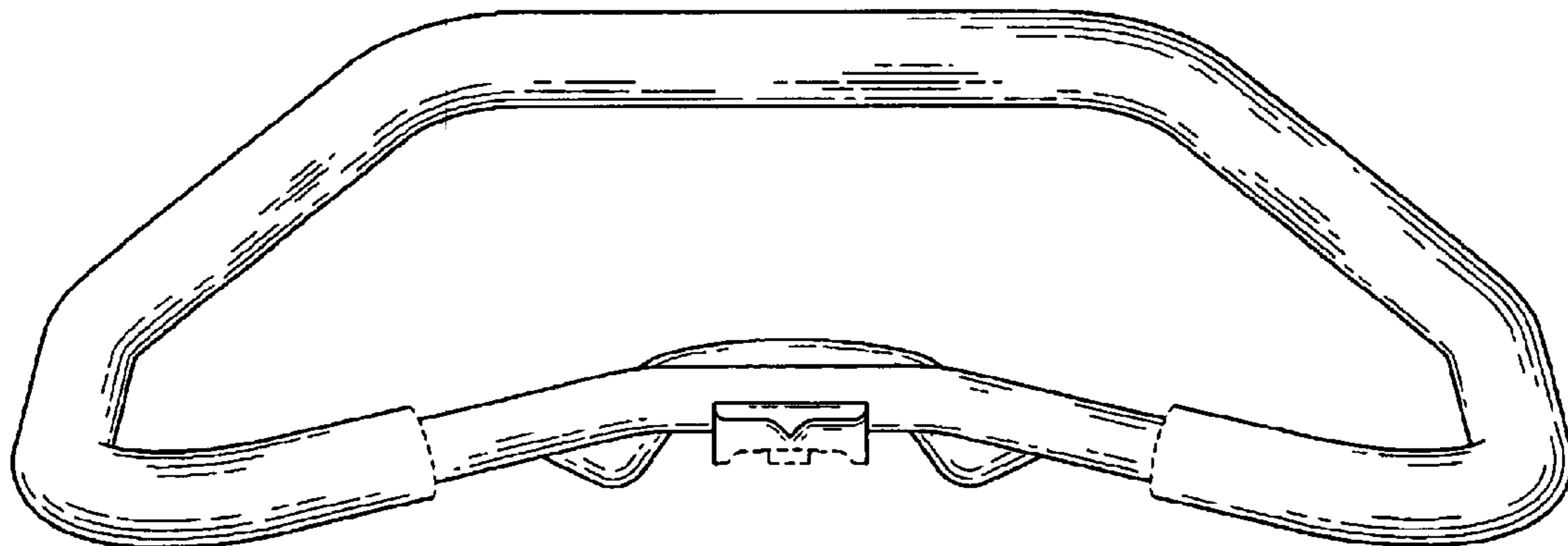

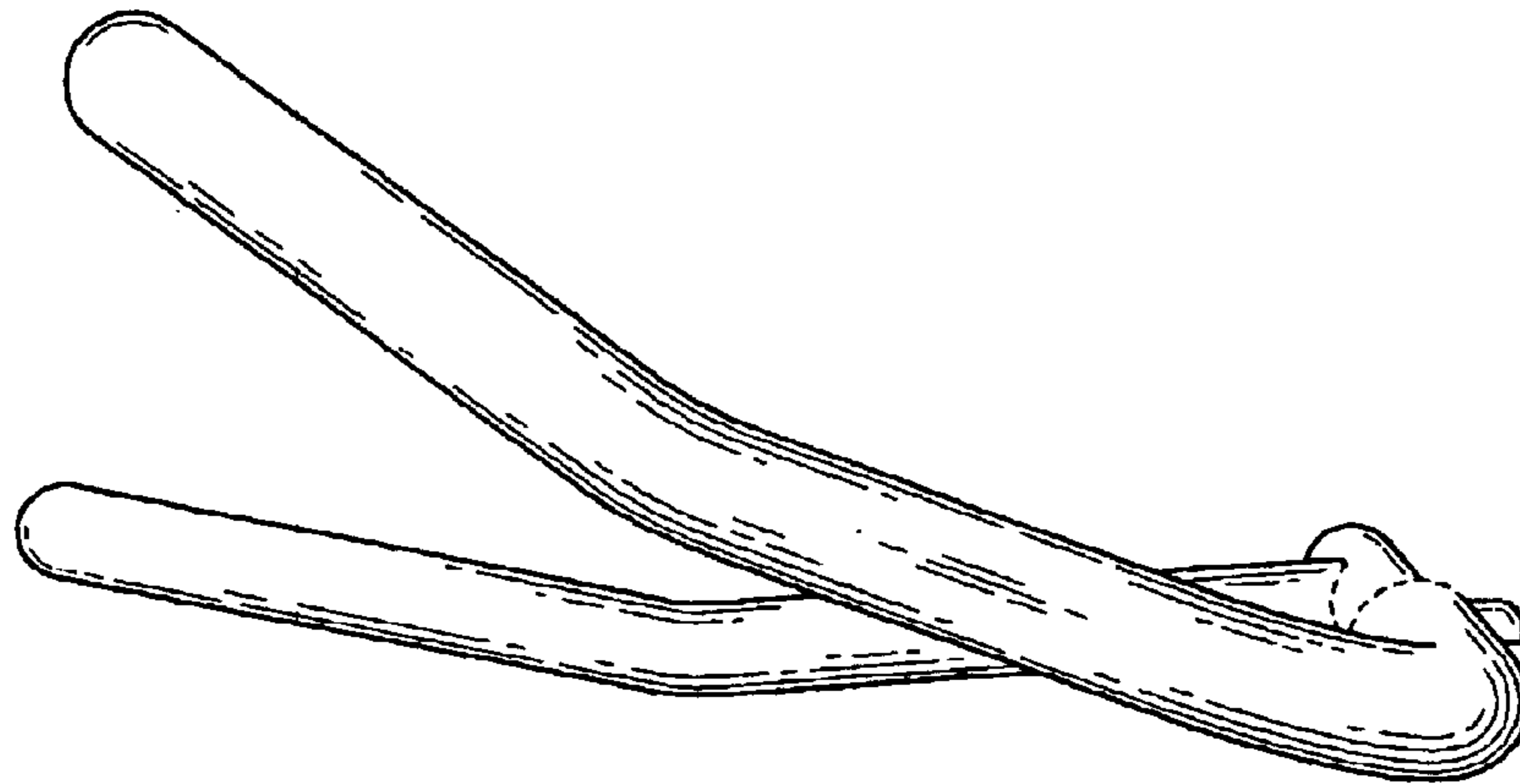

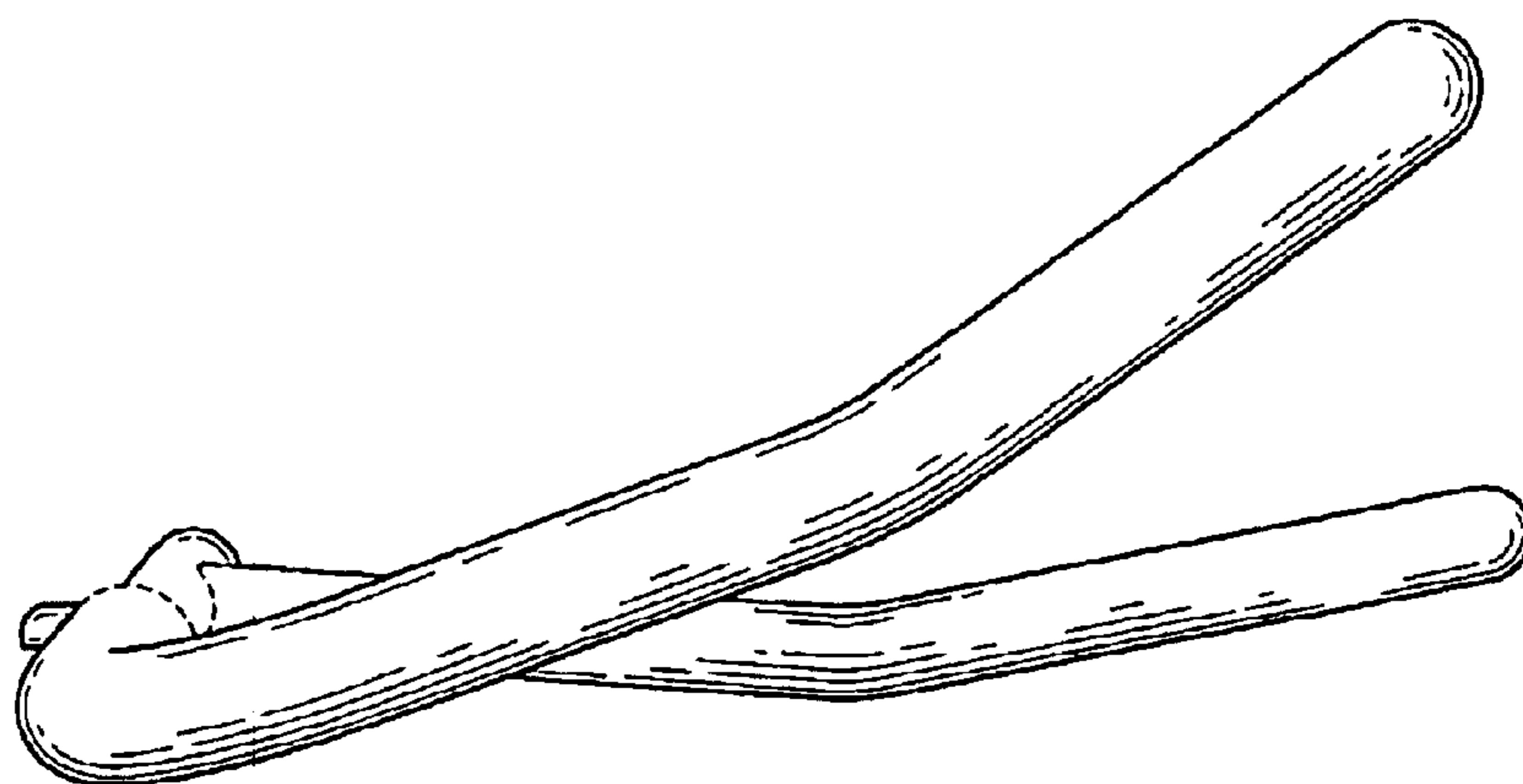

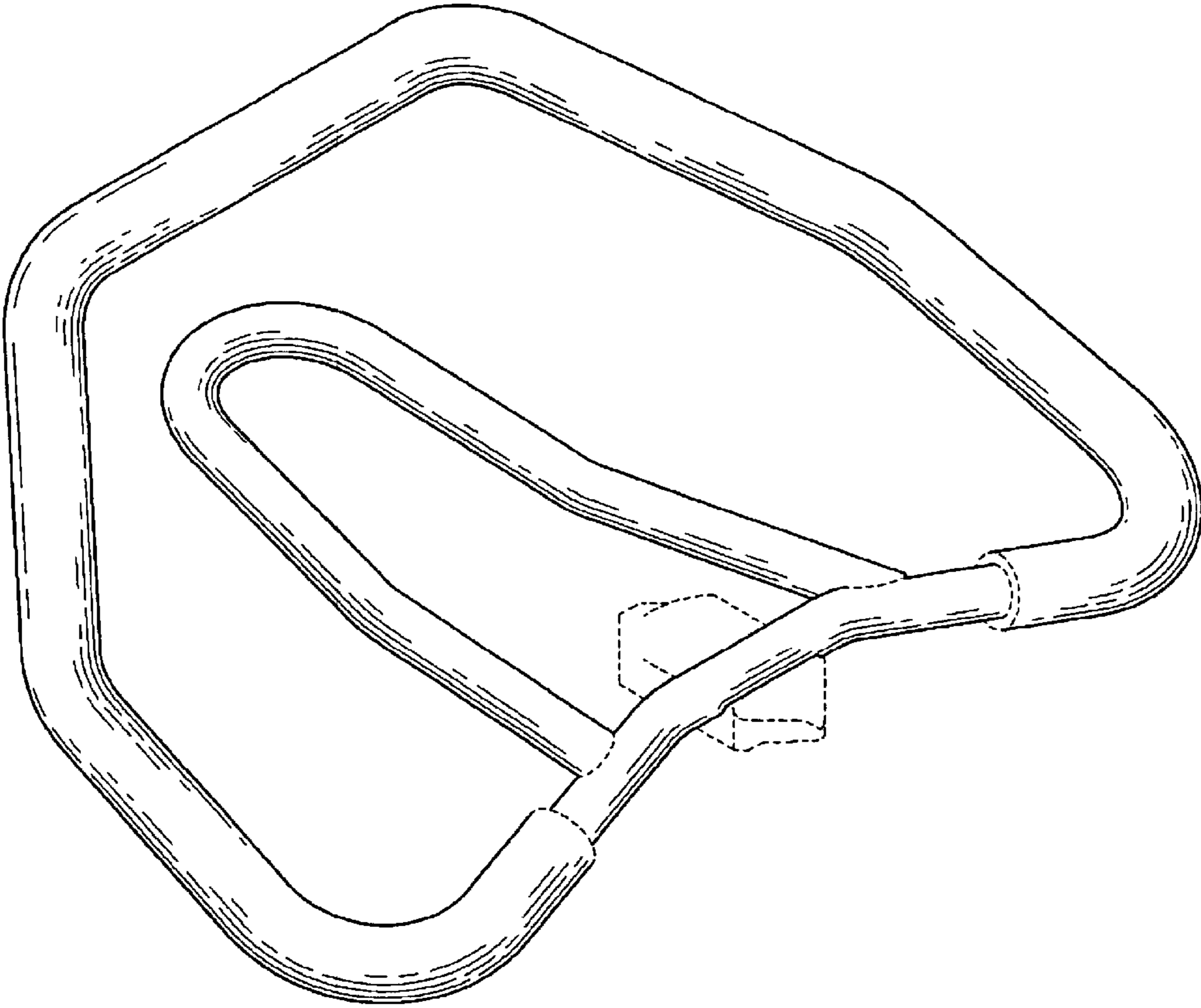

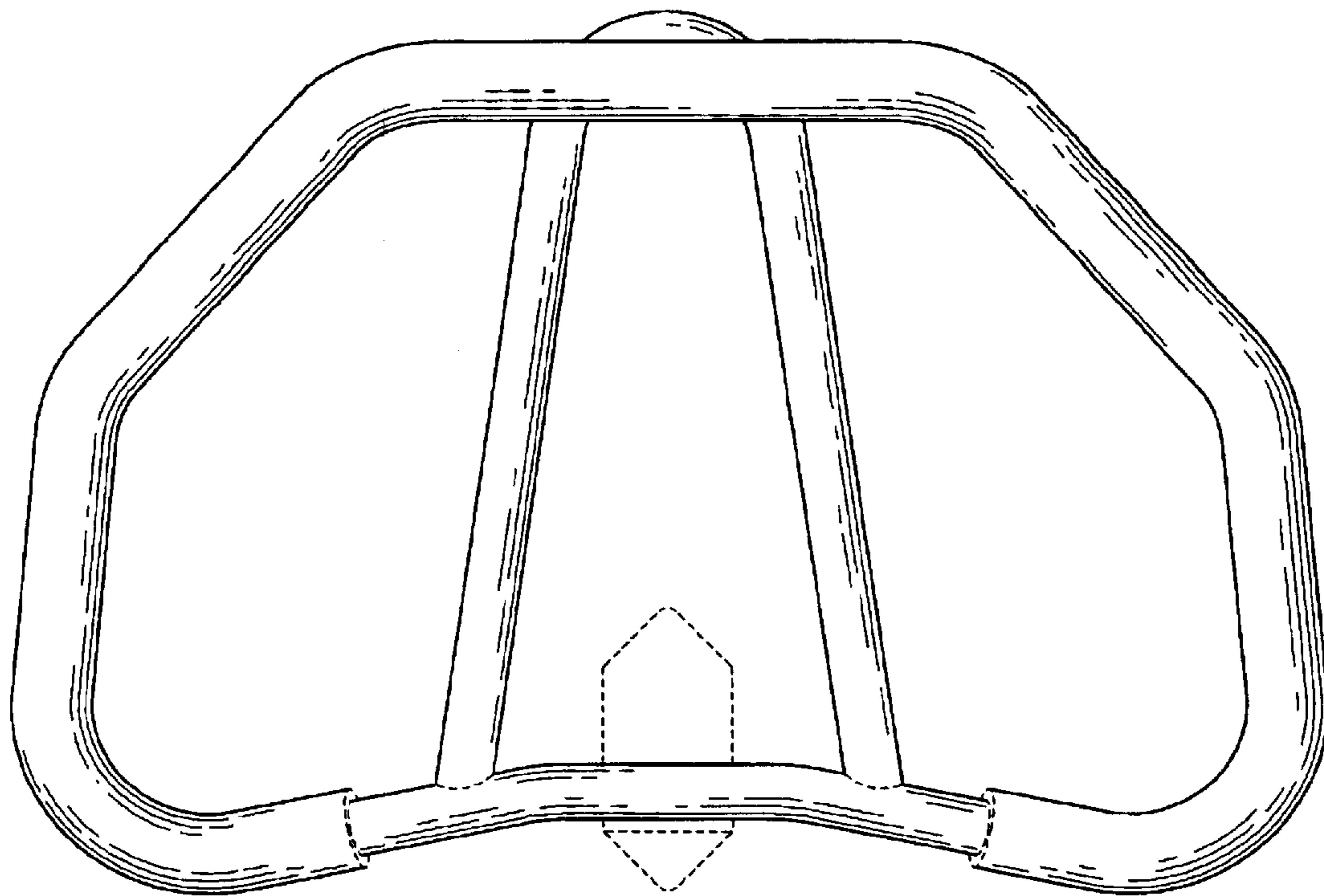

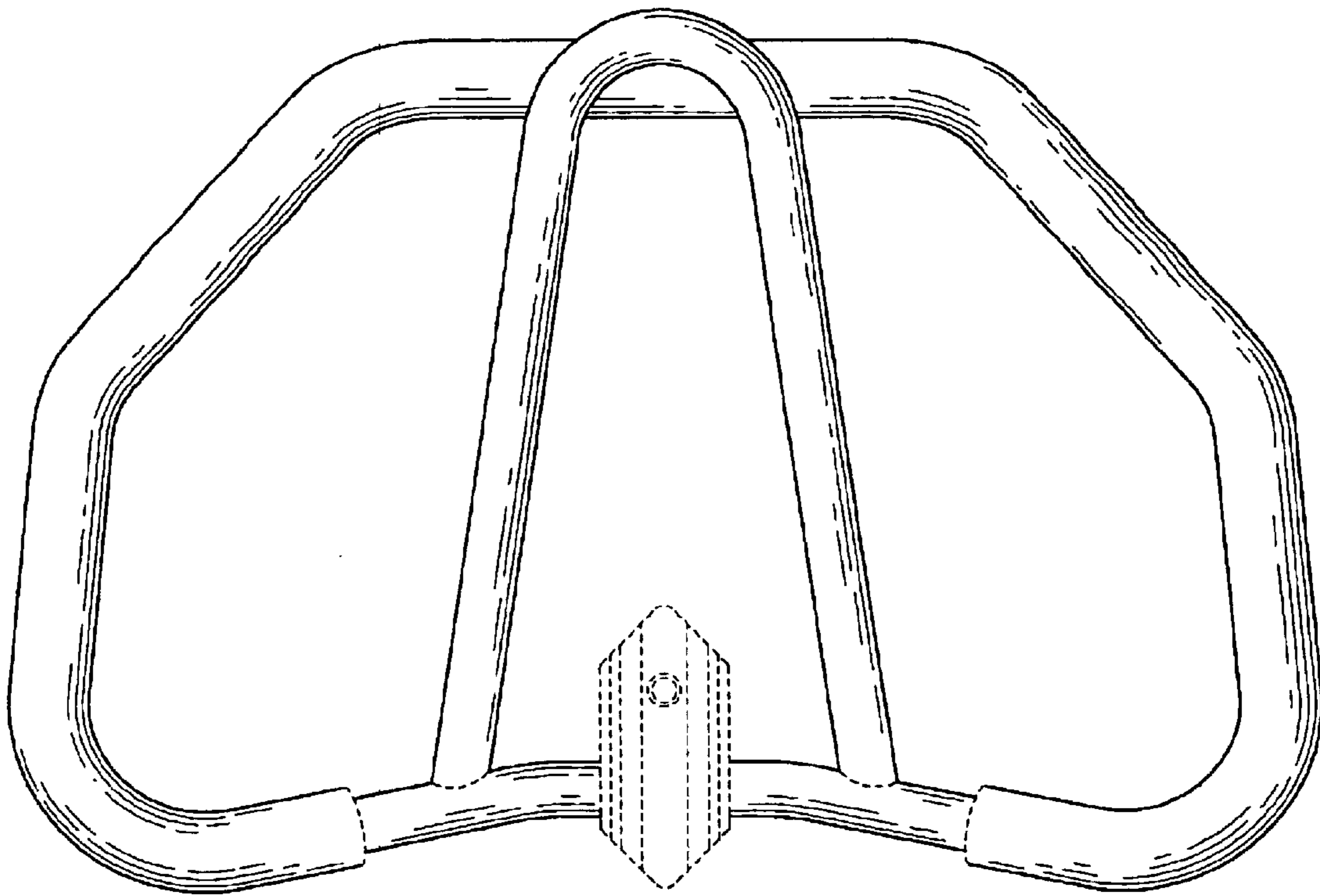

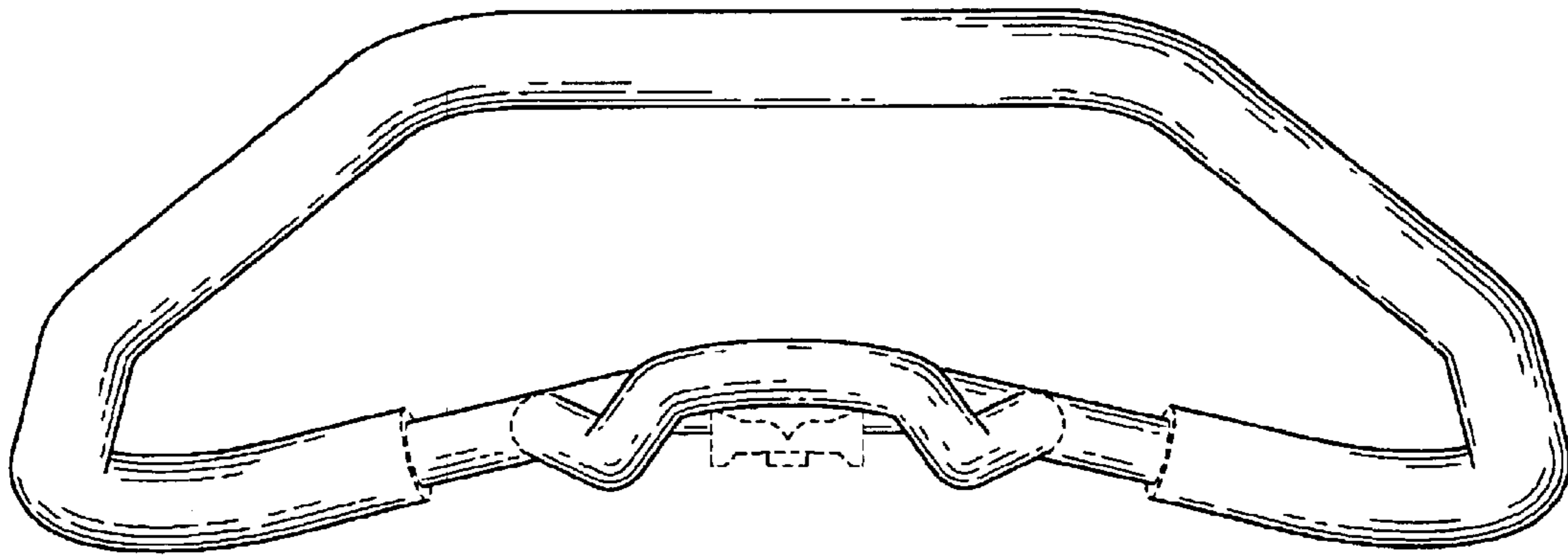

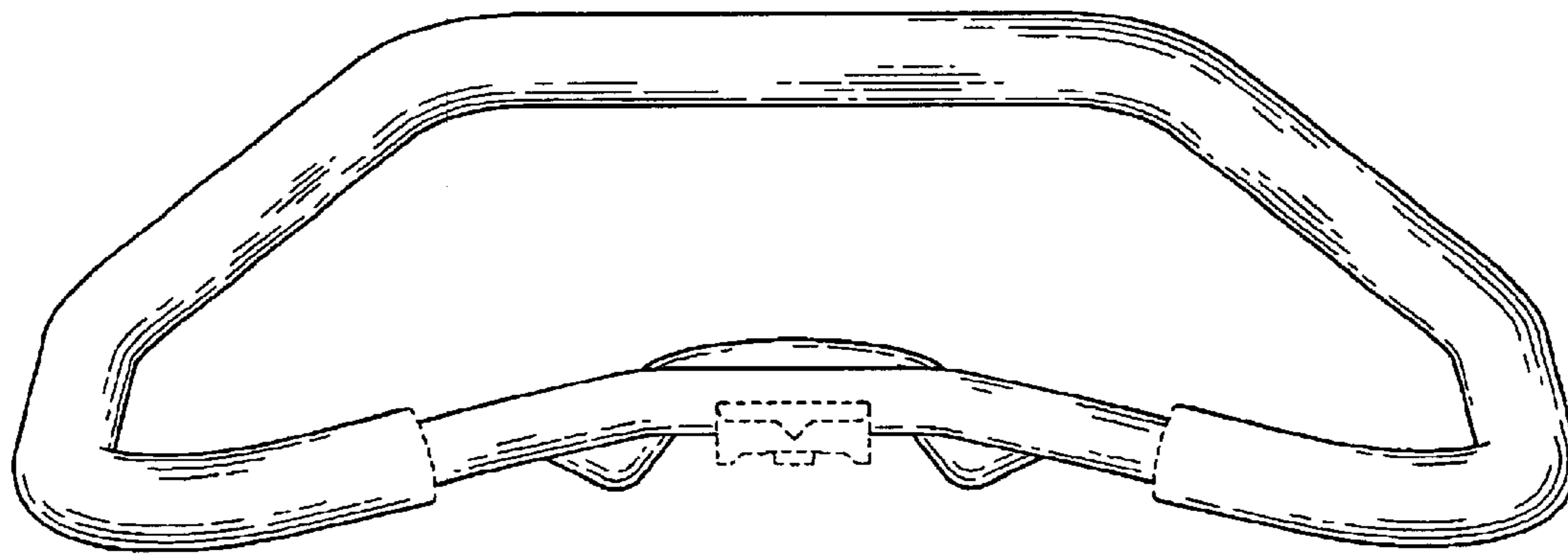

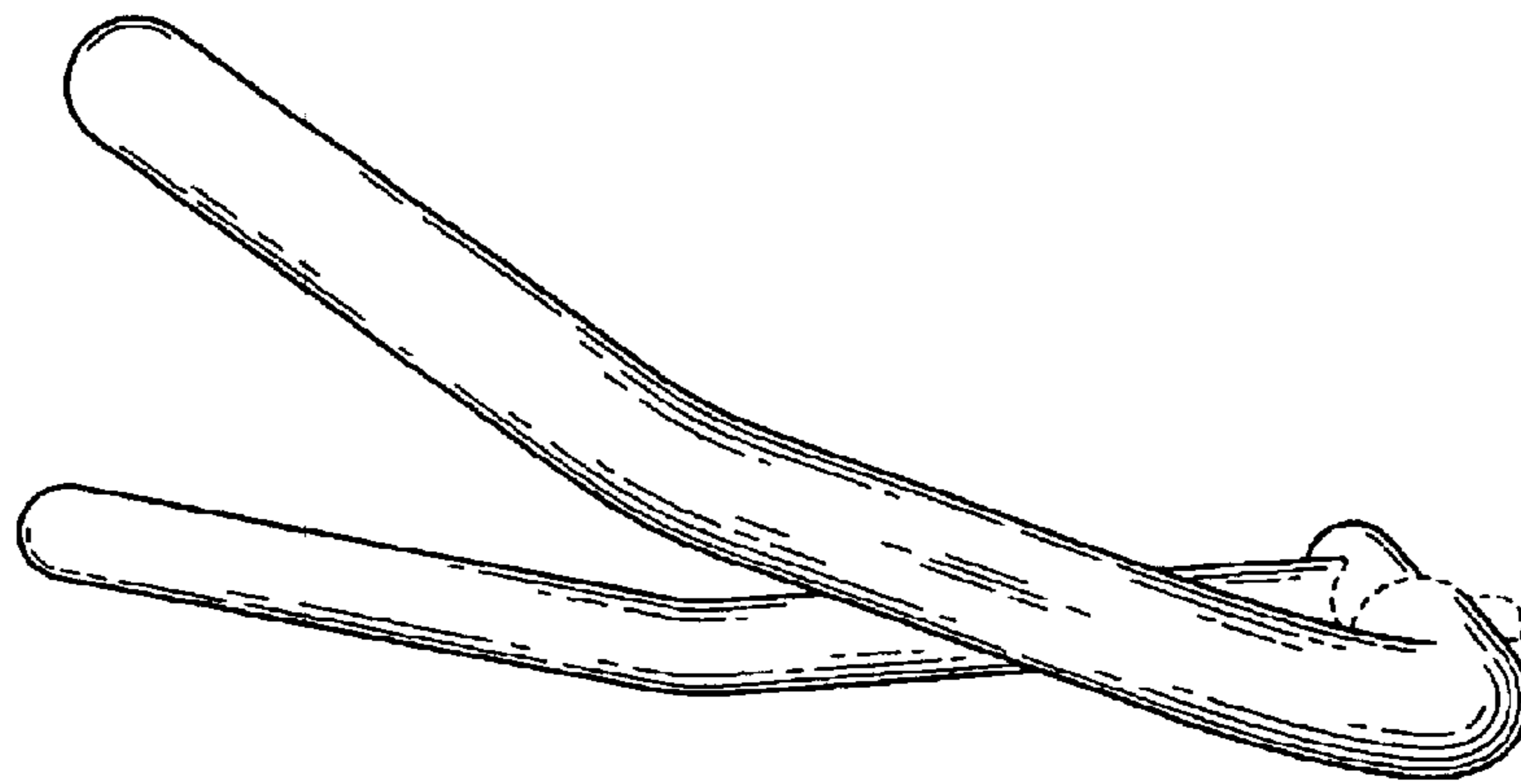

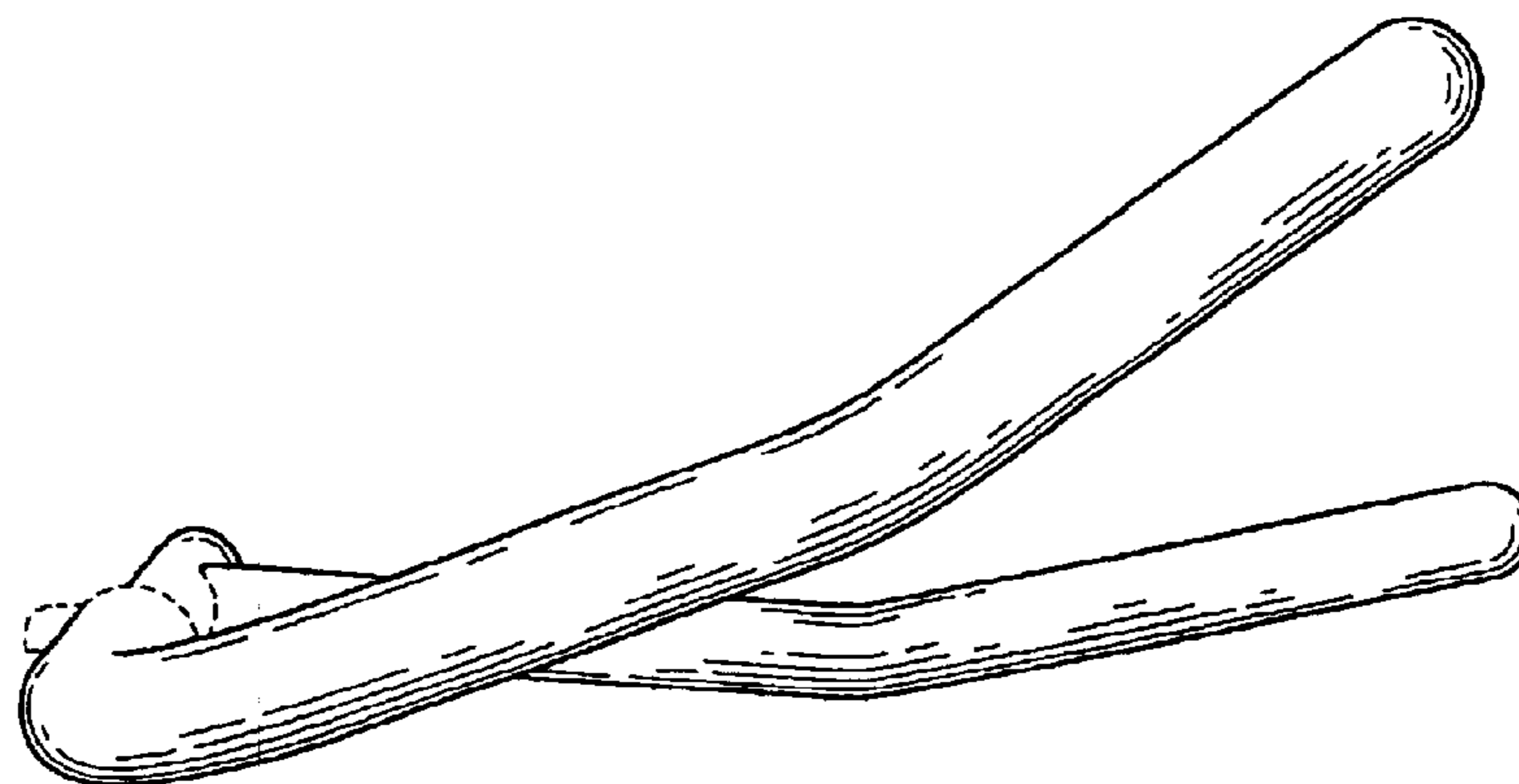

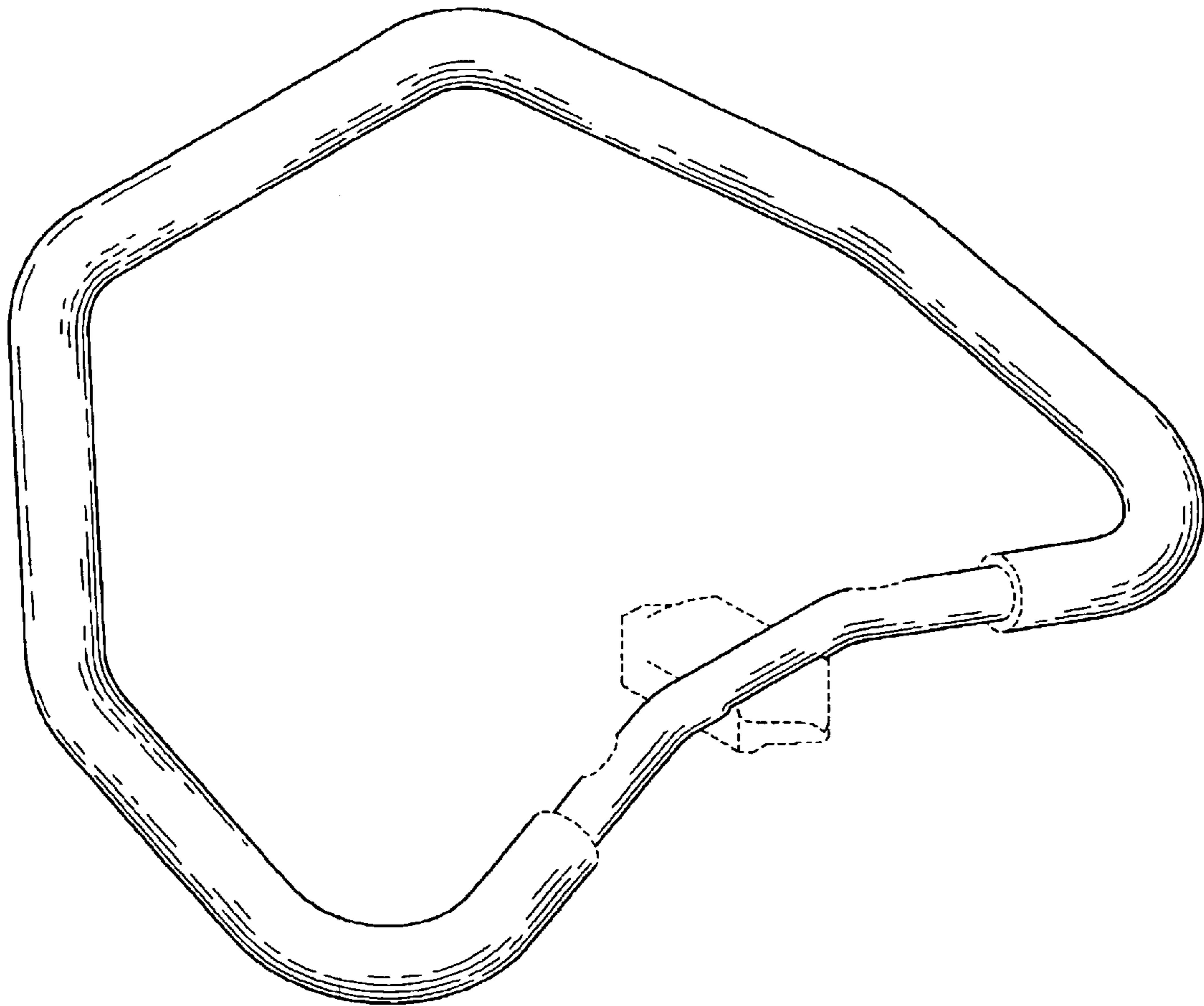

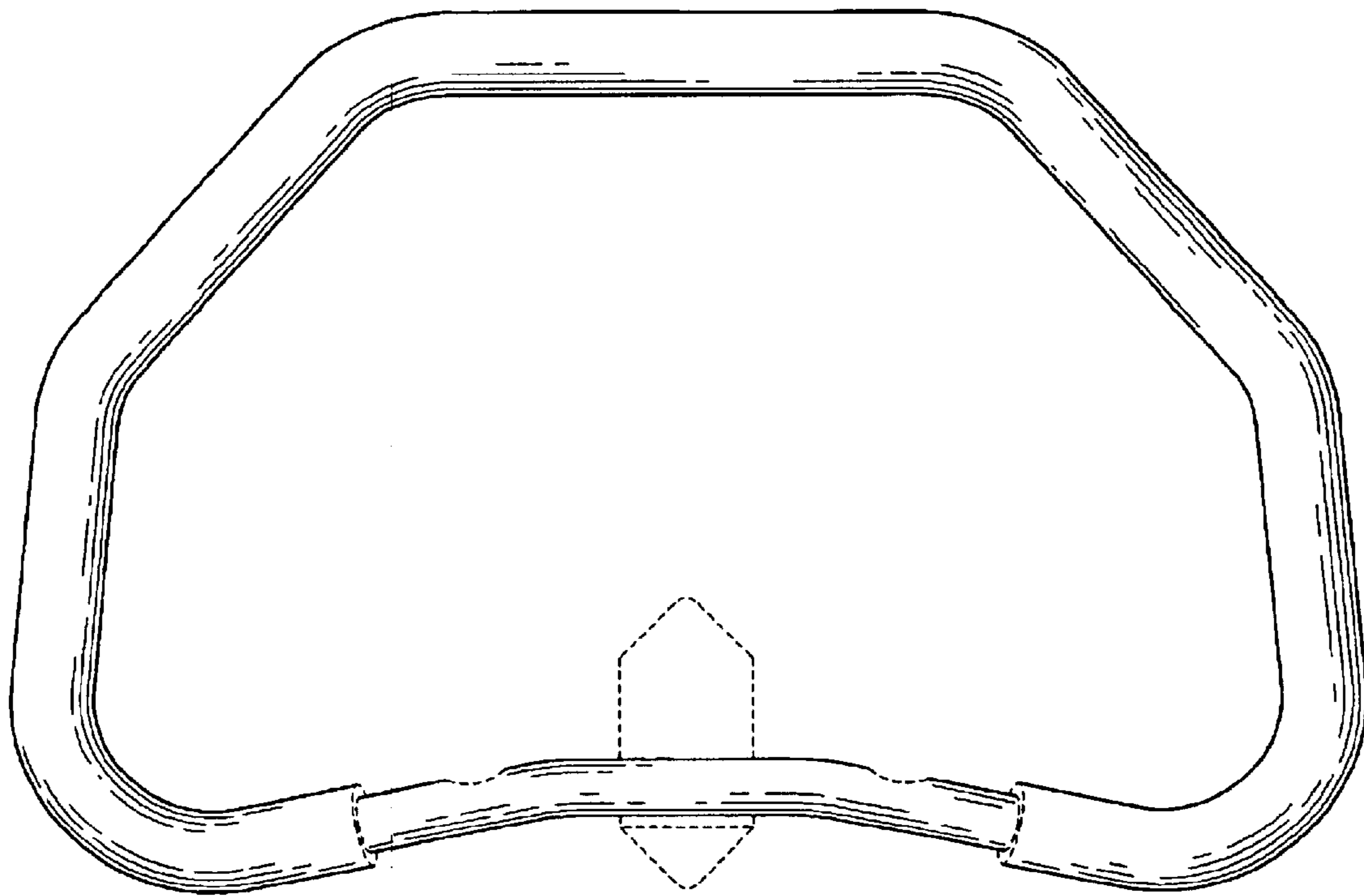

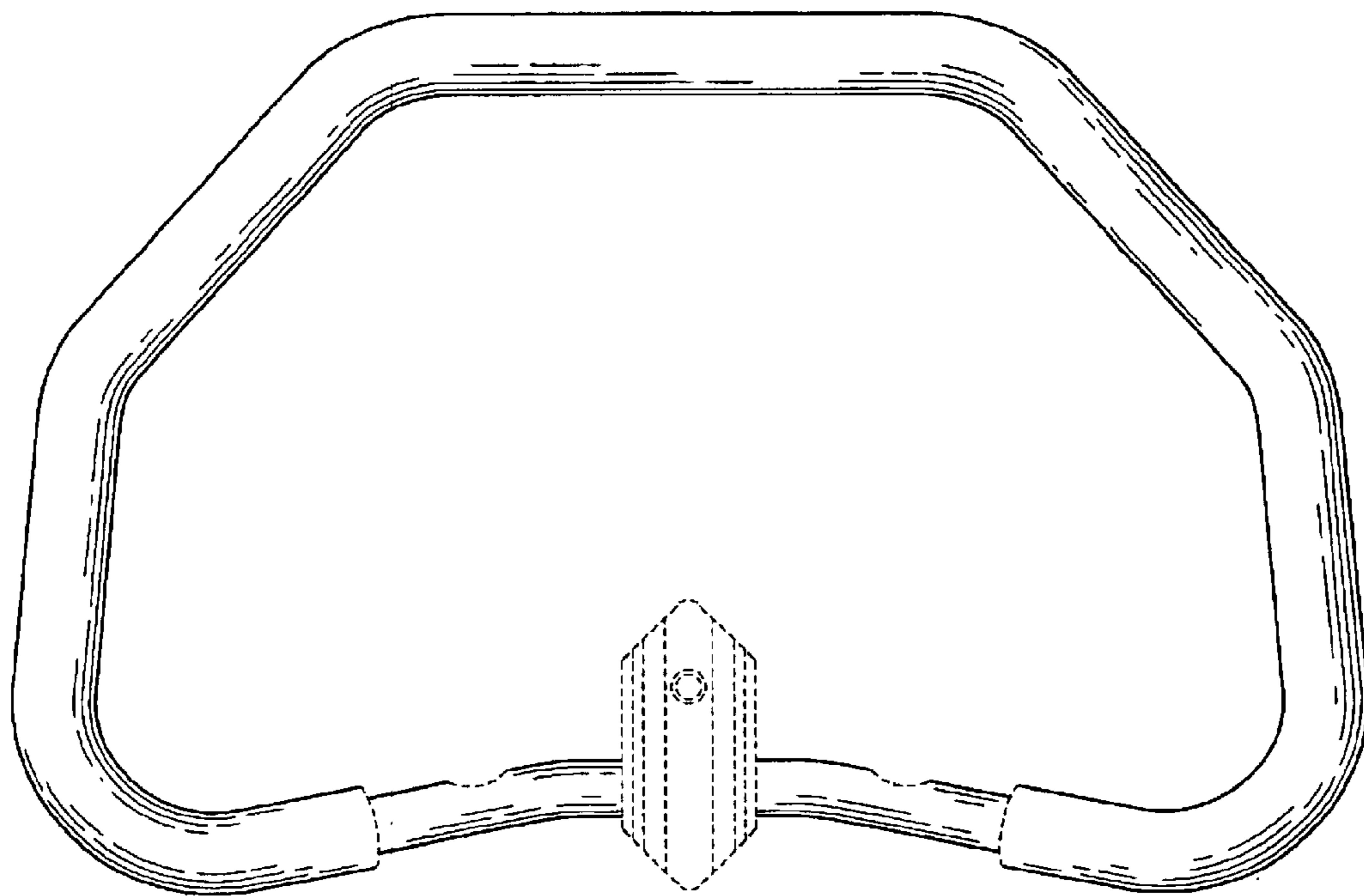

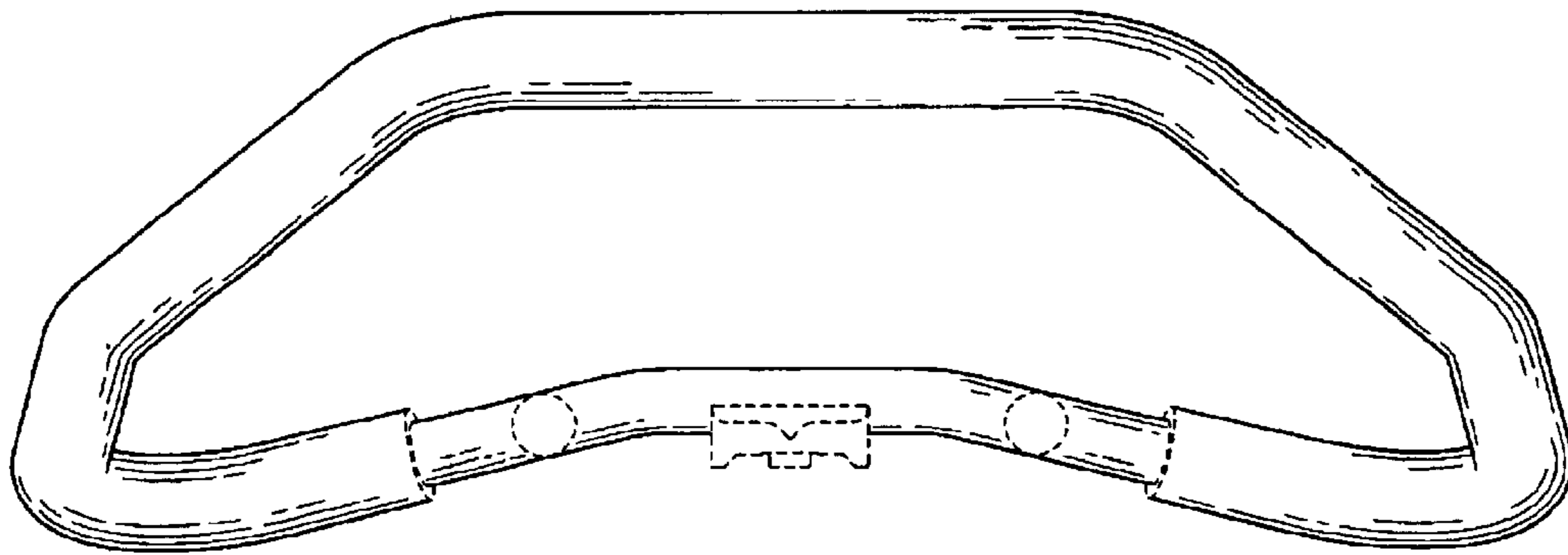

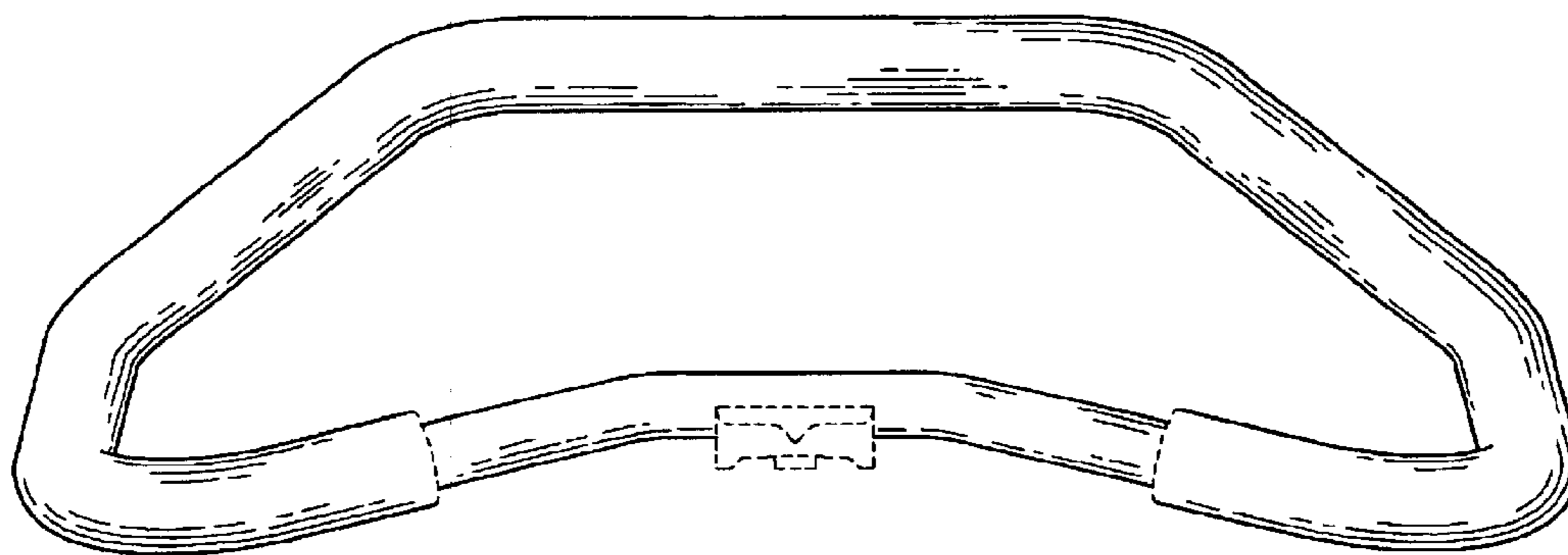

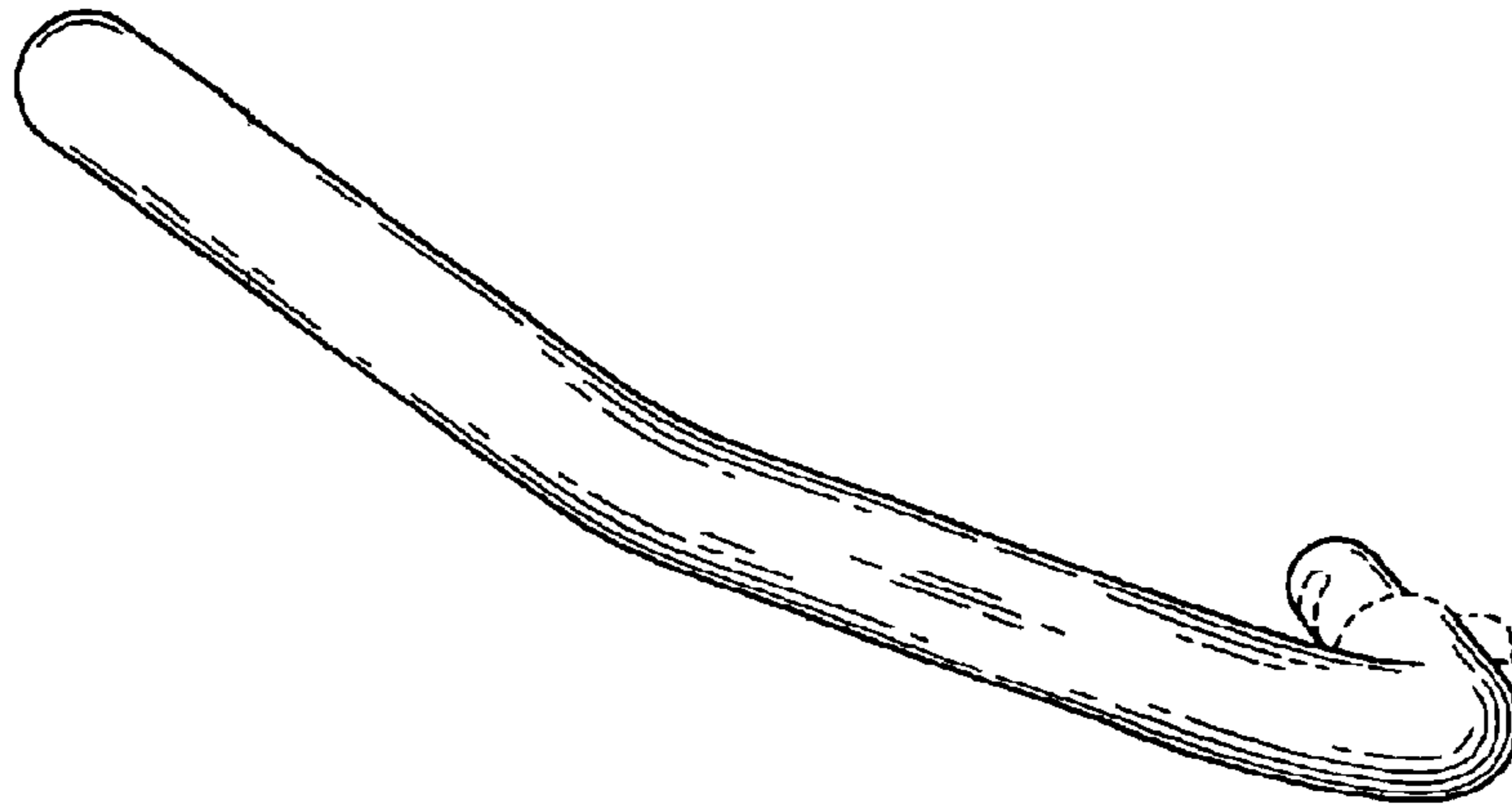

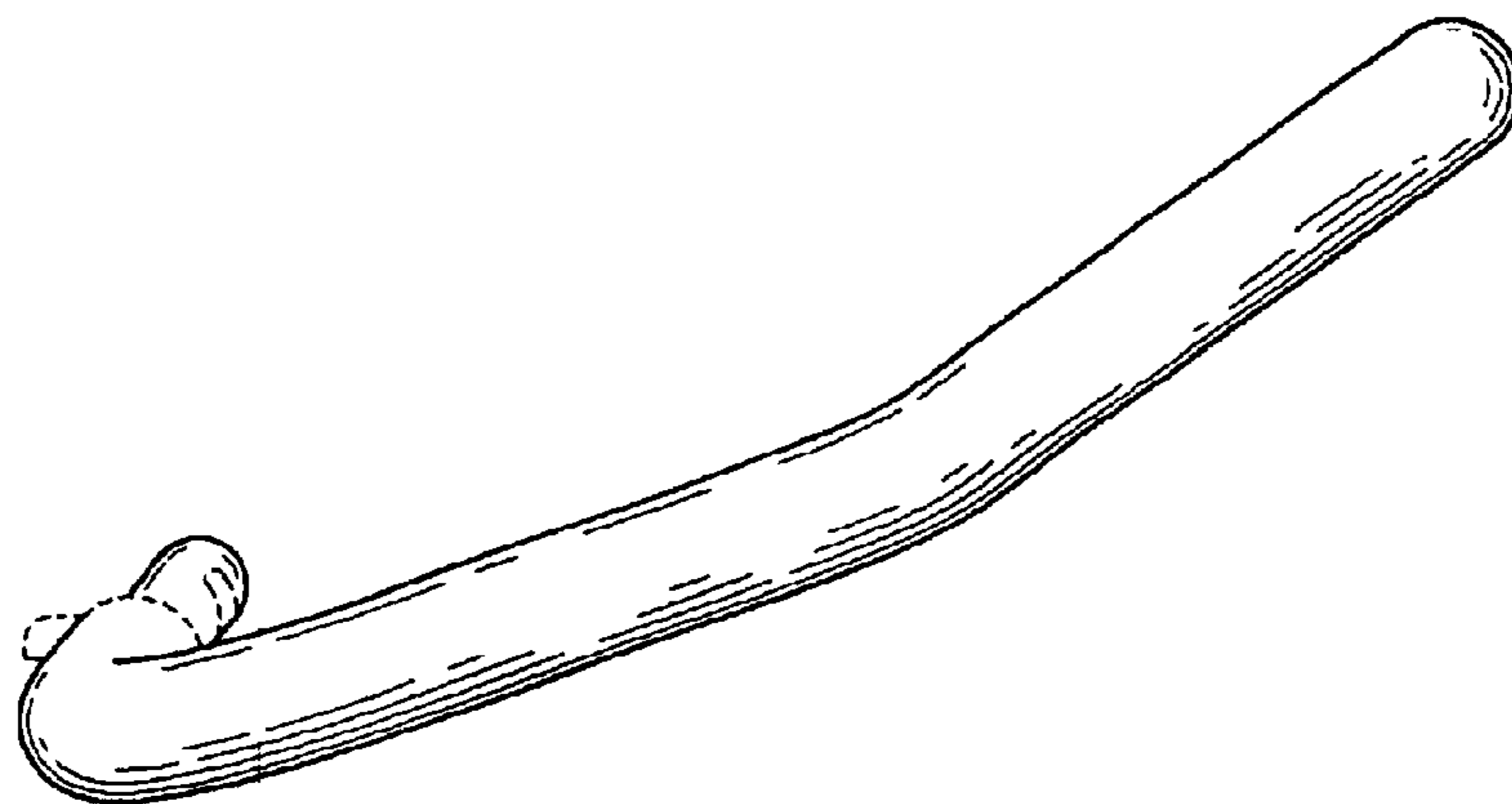

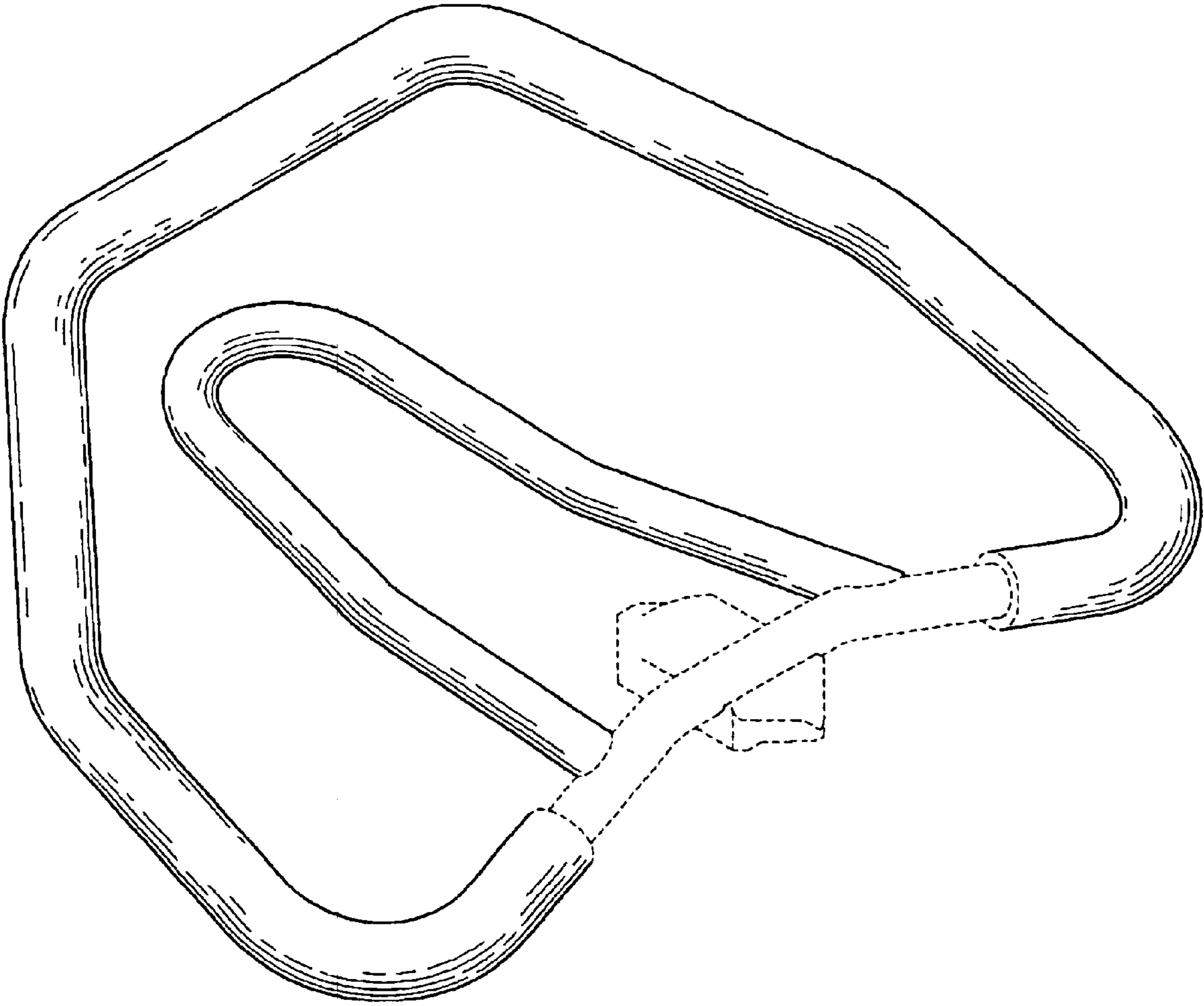

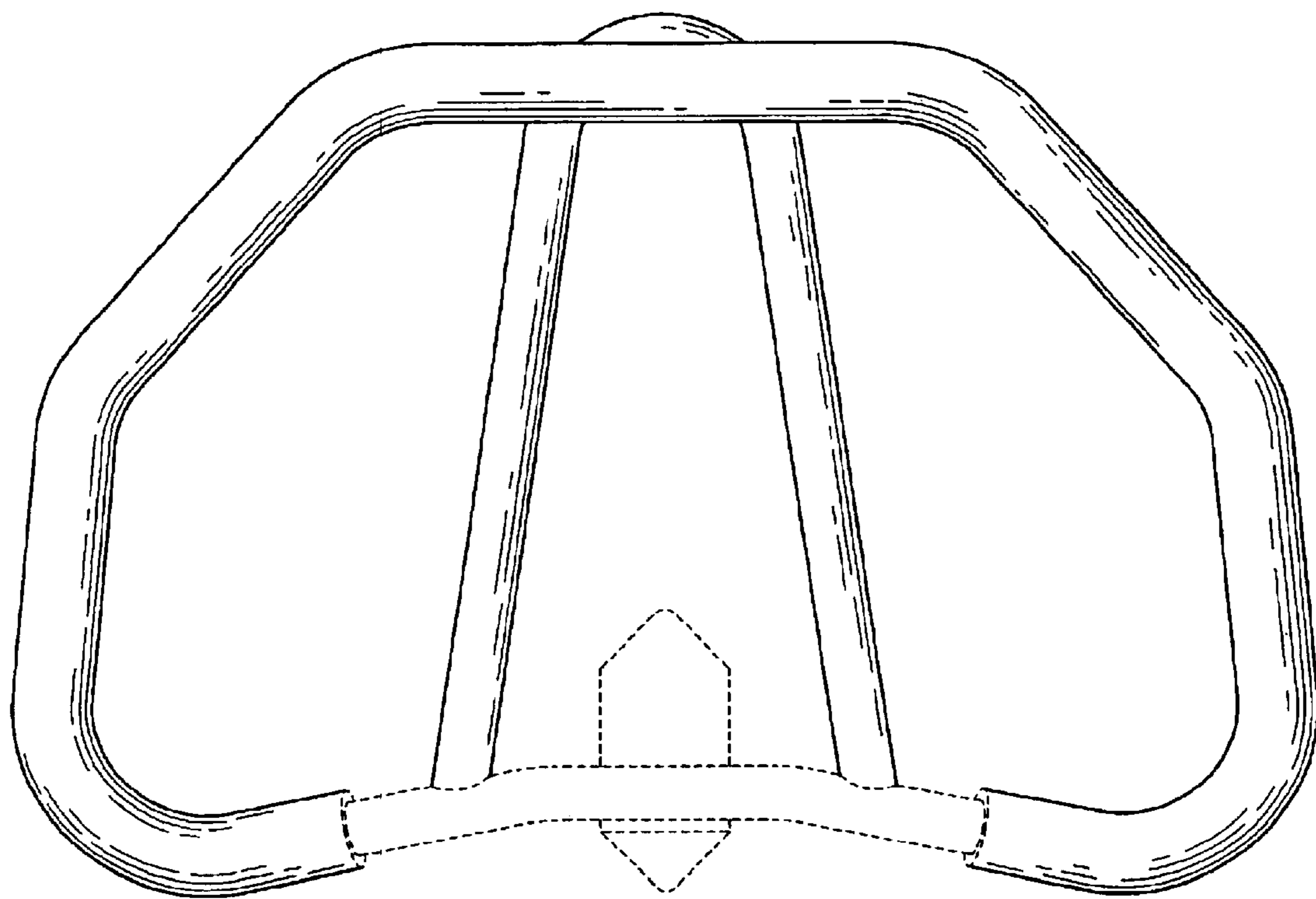

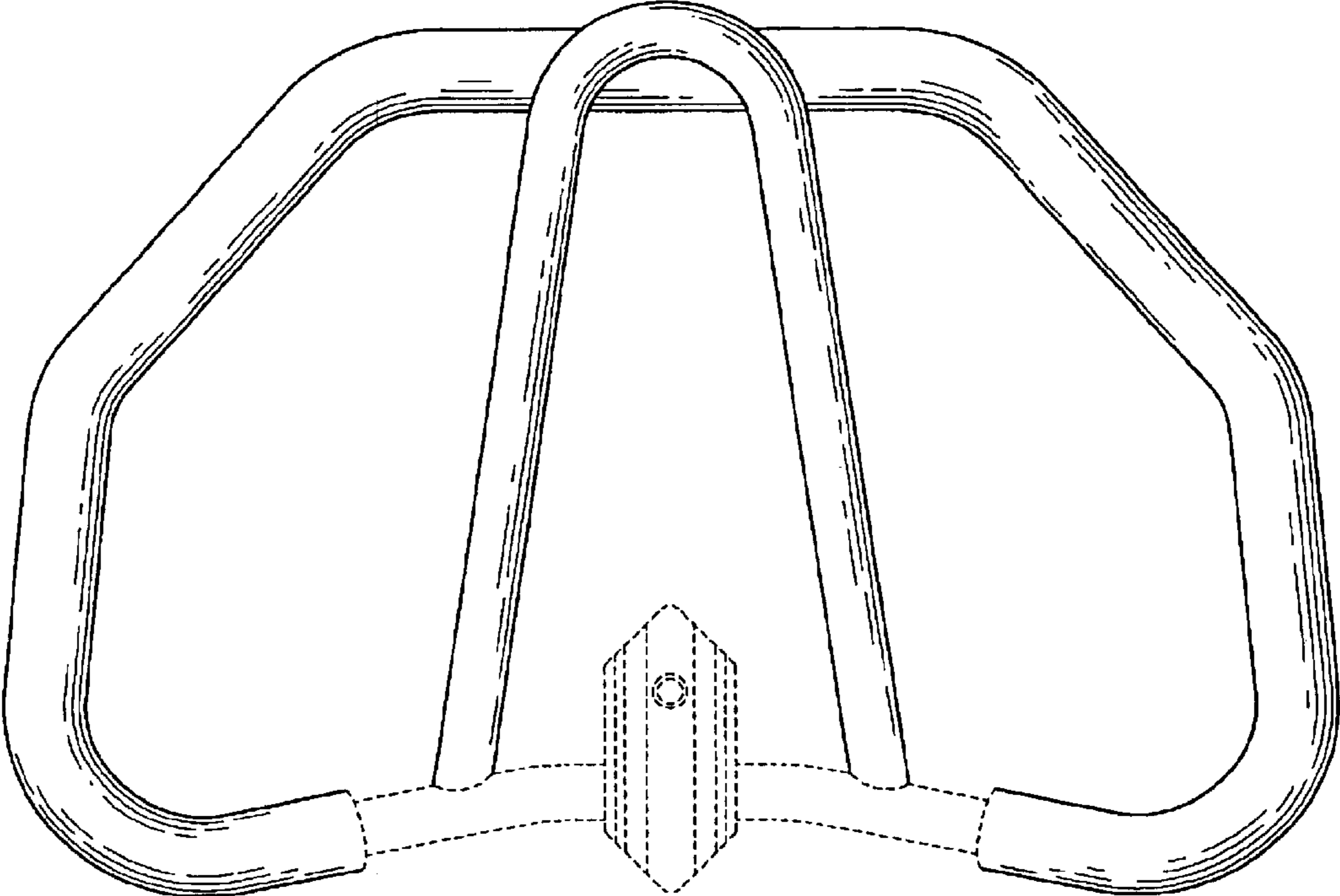

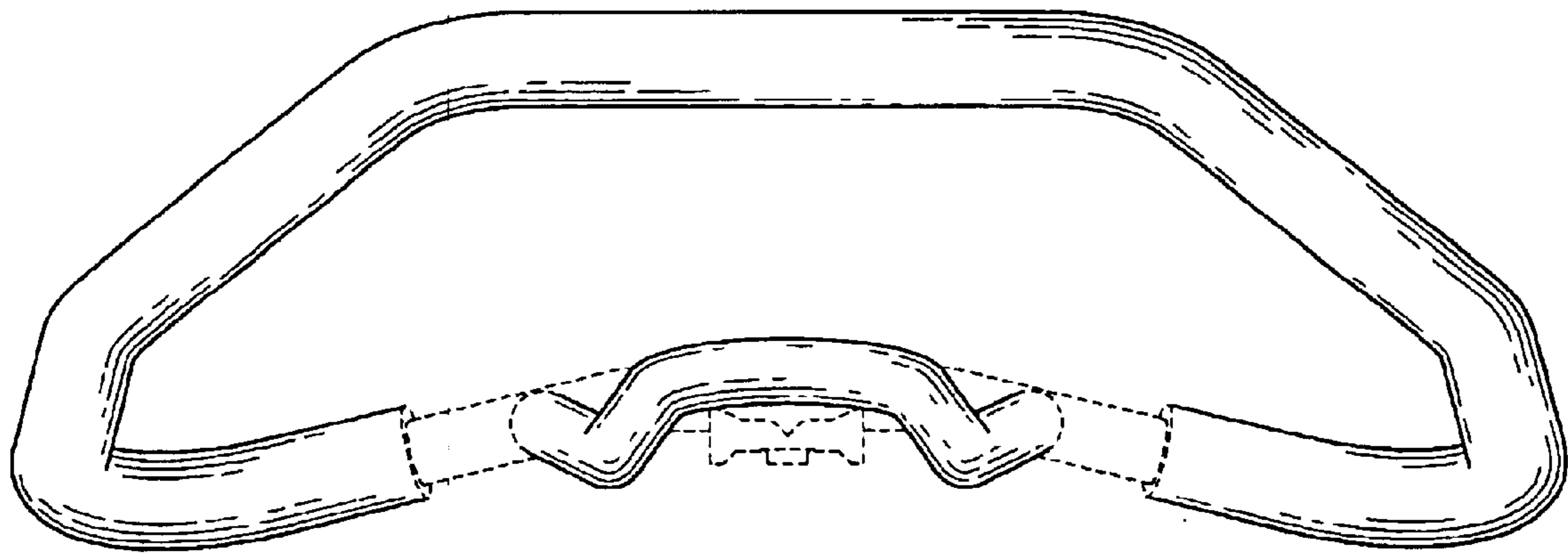

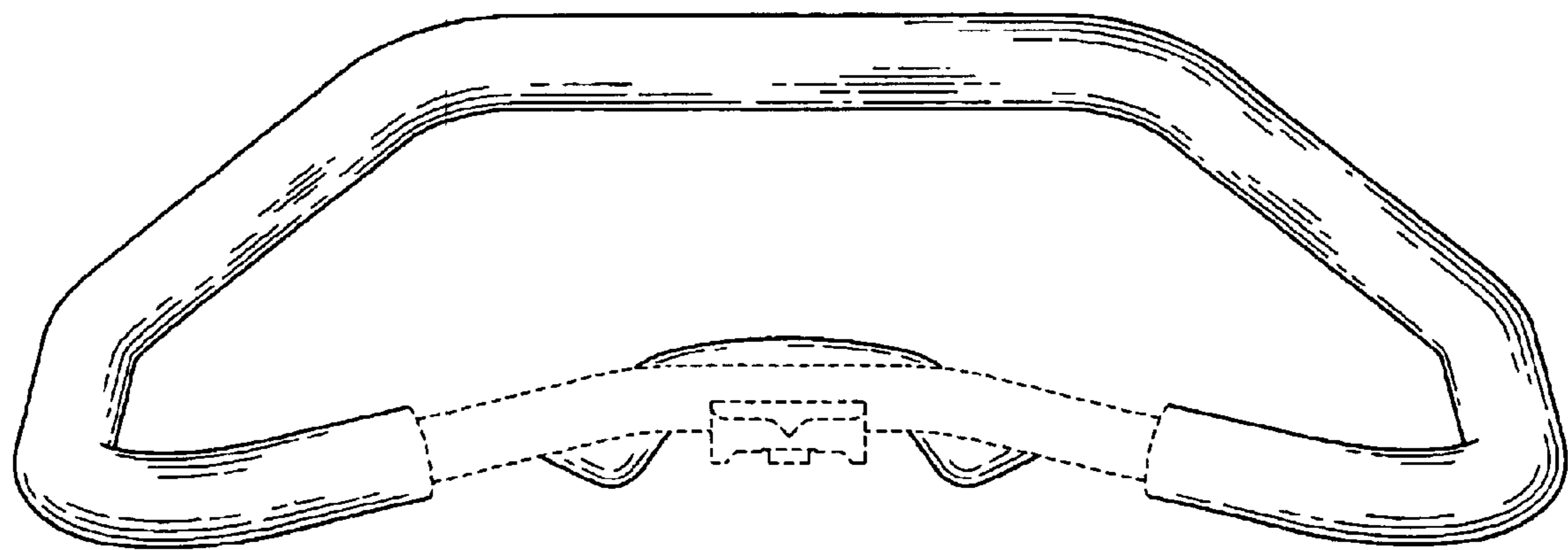

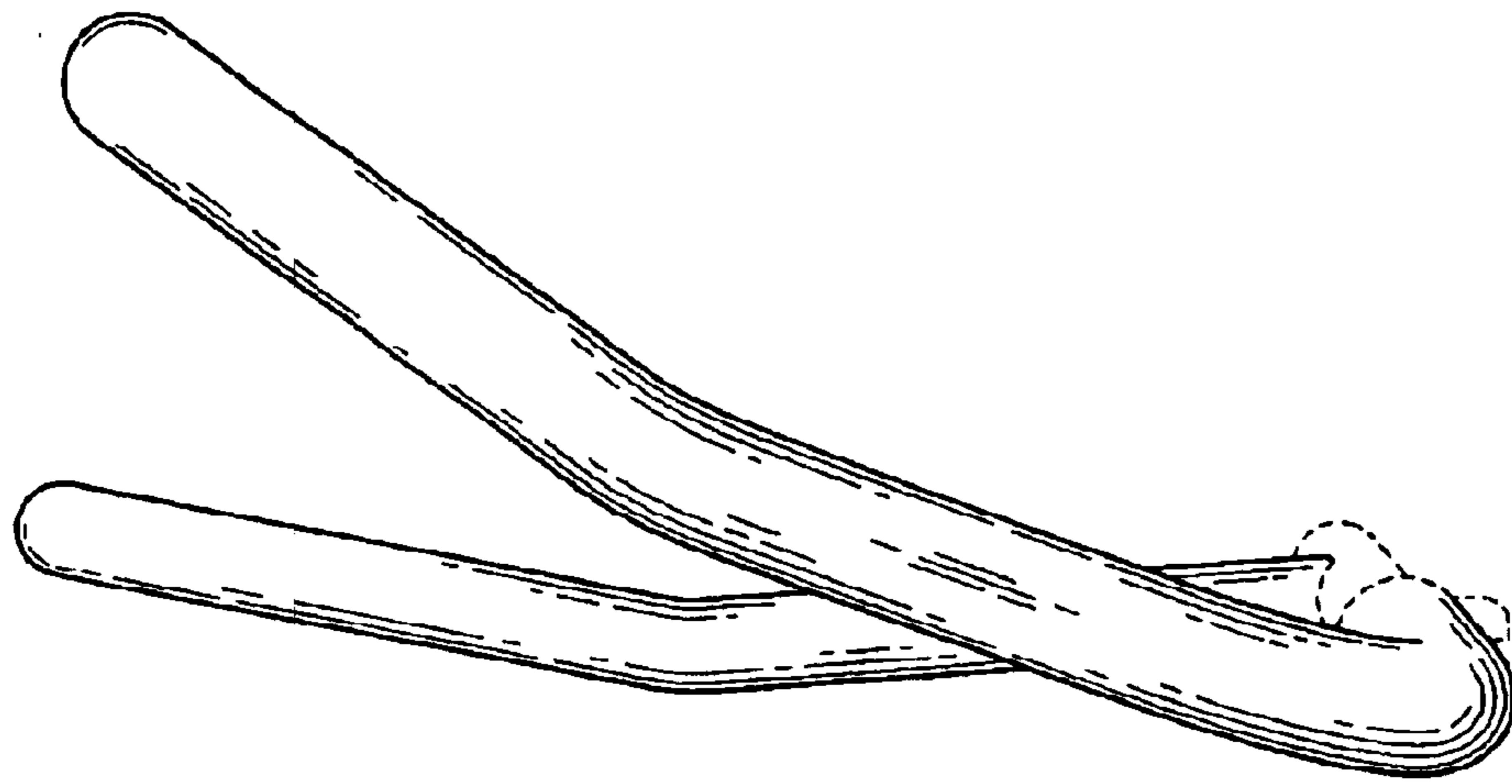

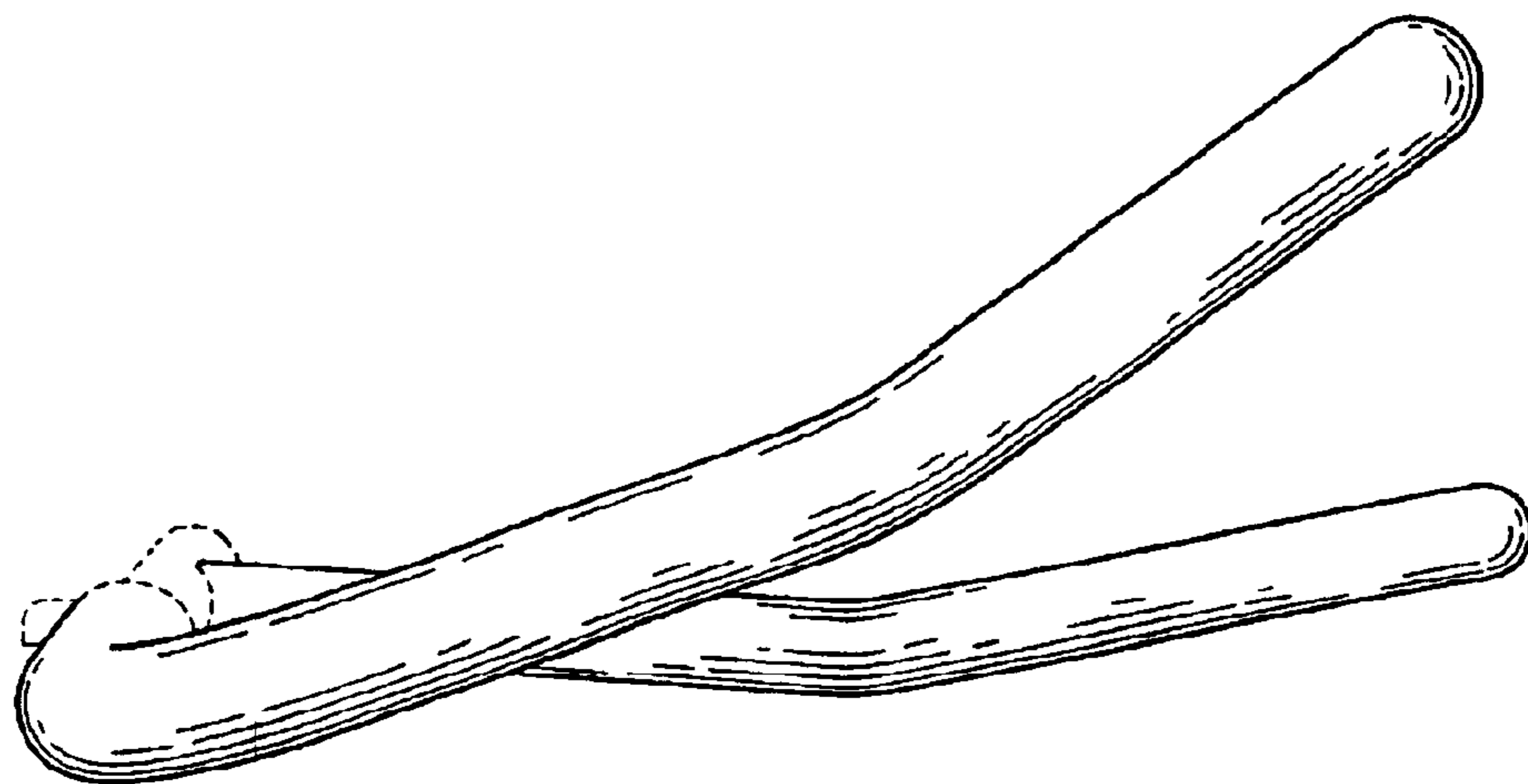
