with my design; and,

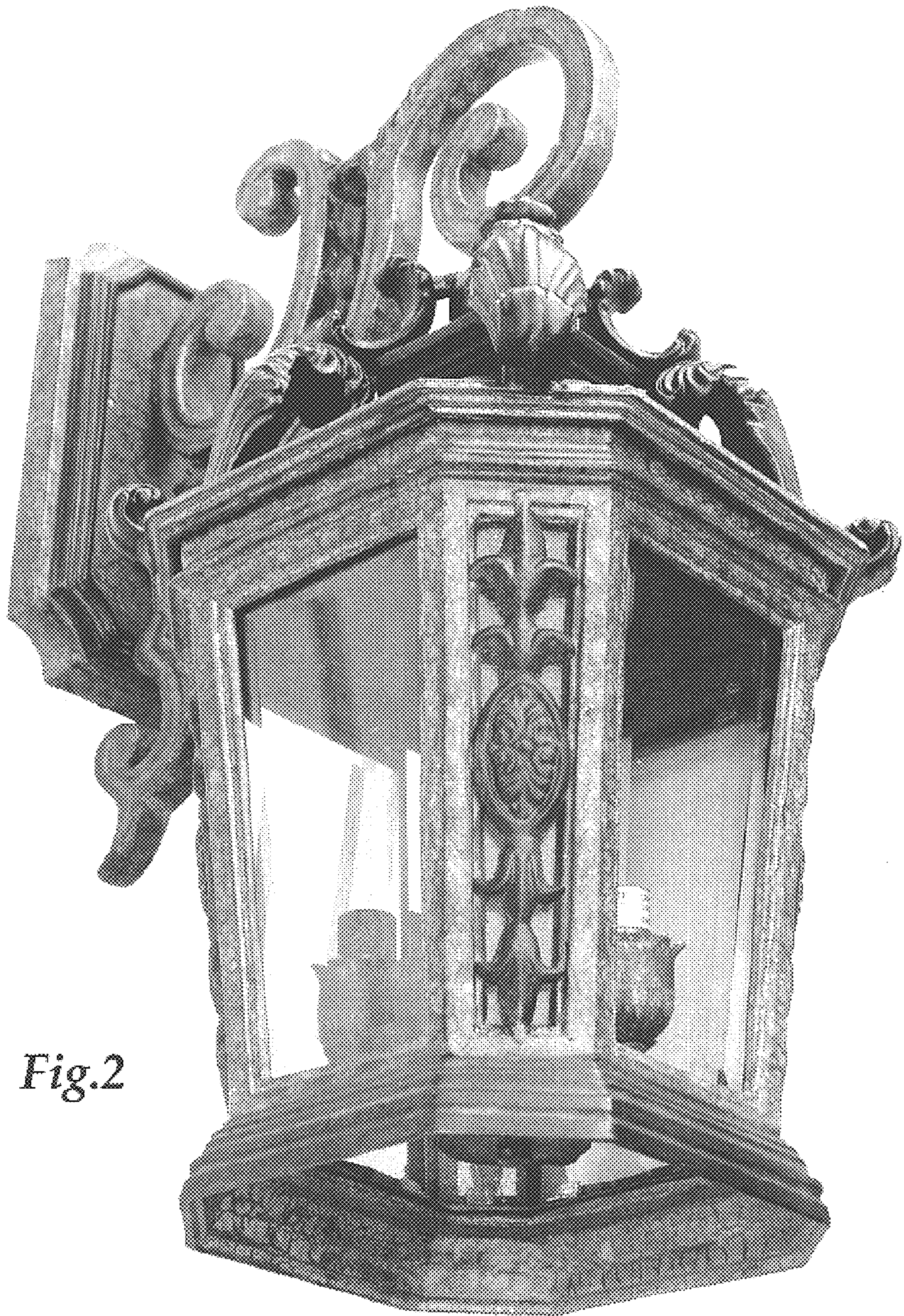
FIG. 6 is a bottom plan view of the lighting fixture in

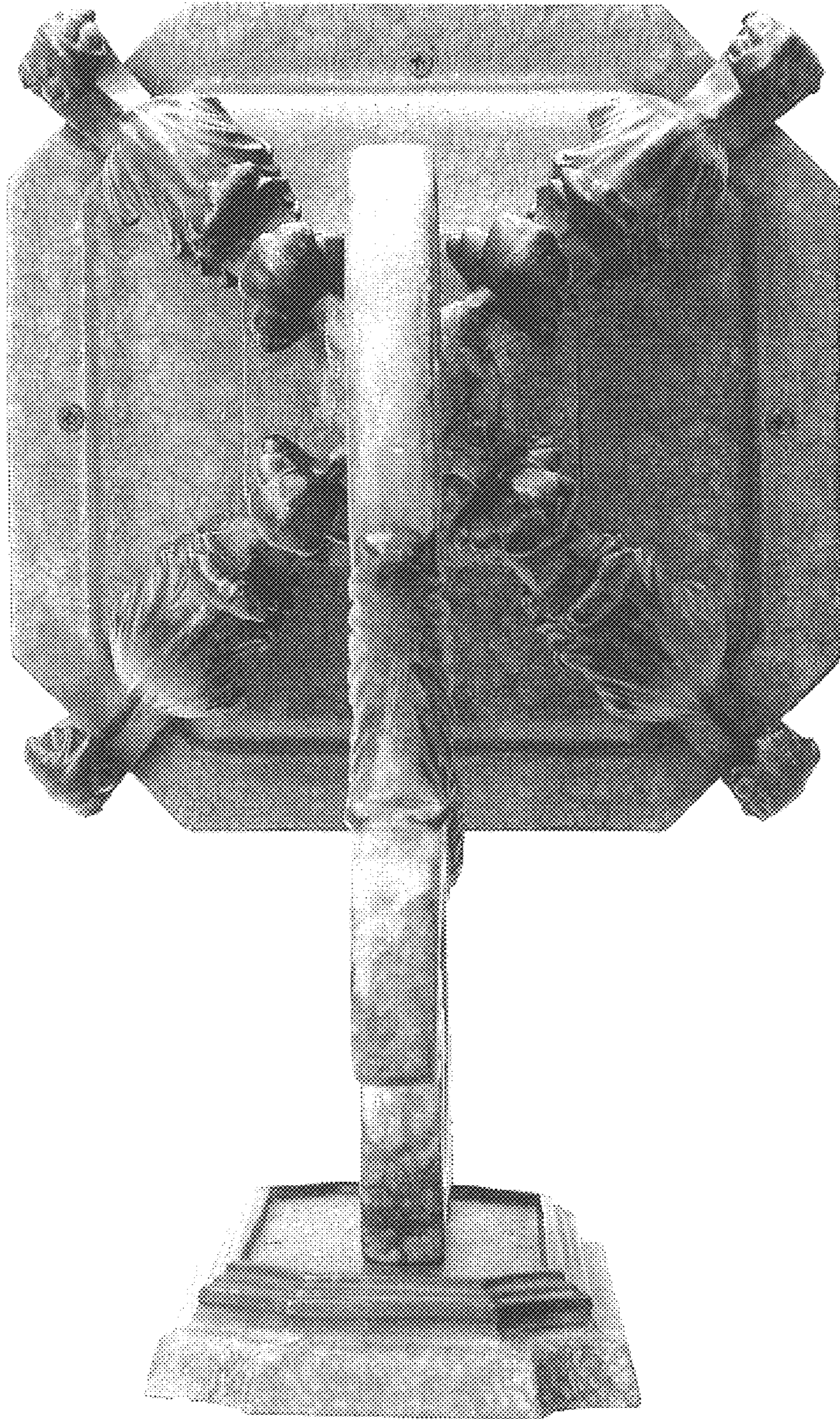

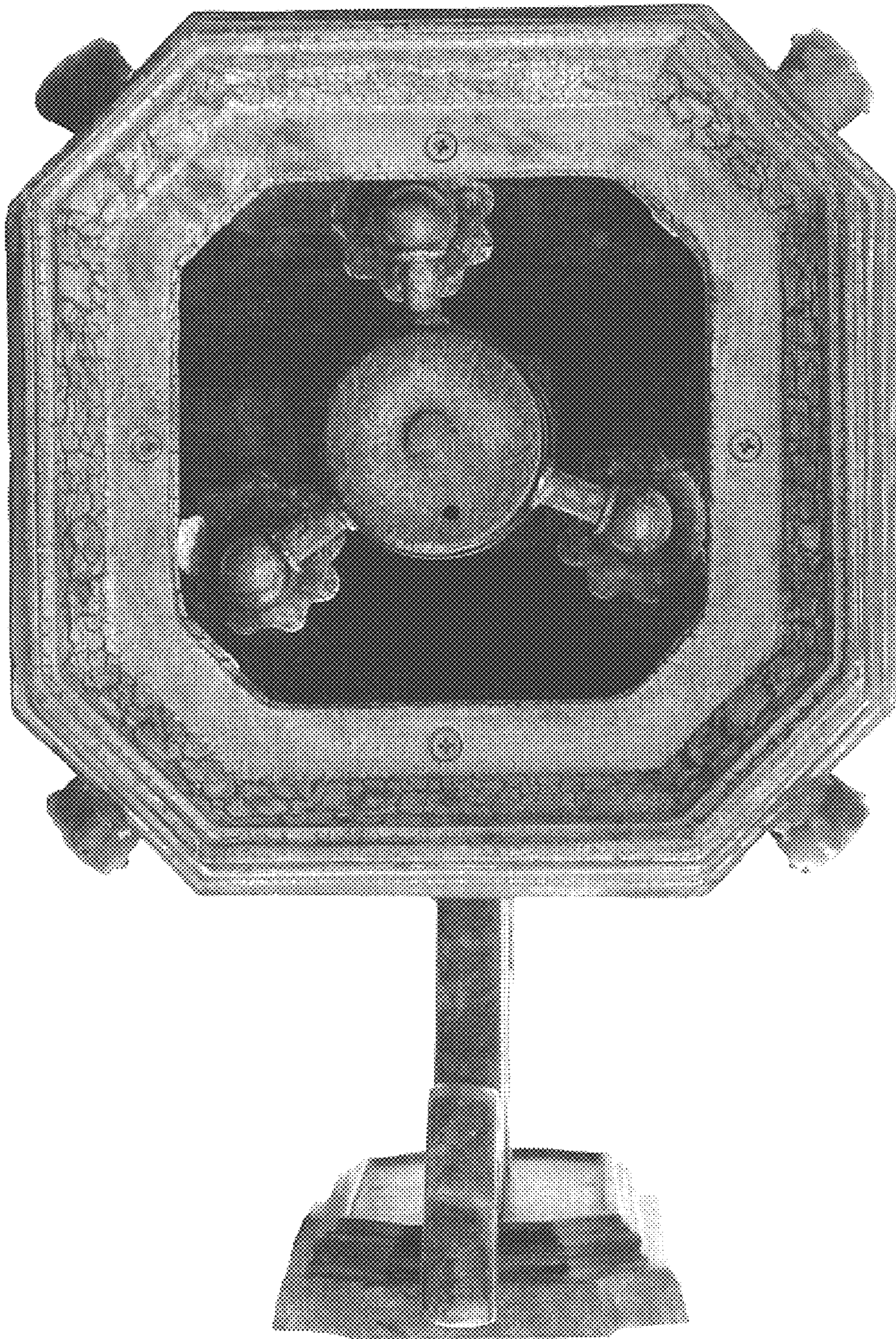
