(57) **CLAIM**

The ornamental design for a cover or coat for dogs and other animals, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cover or coat for dogs and other animals according to my invention, as worn, from above, one side and rear (view from other side corresponds); FIG. 2 is a perspective view of the cover or coat, as worn, from above, one side and rear, showing the cover or coat partially open;

FIG. 3 is a perspective view of the cover or coat opened out substantially flat; and,

FIG. 4 is a perspective view of the cover or coat as worn.

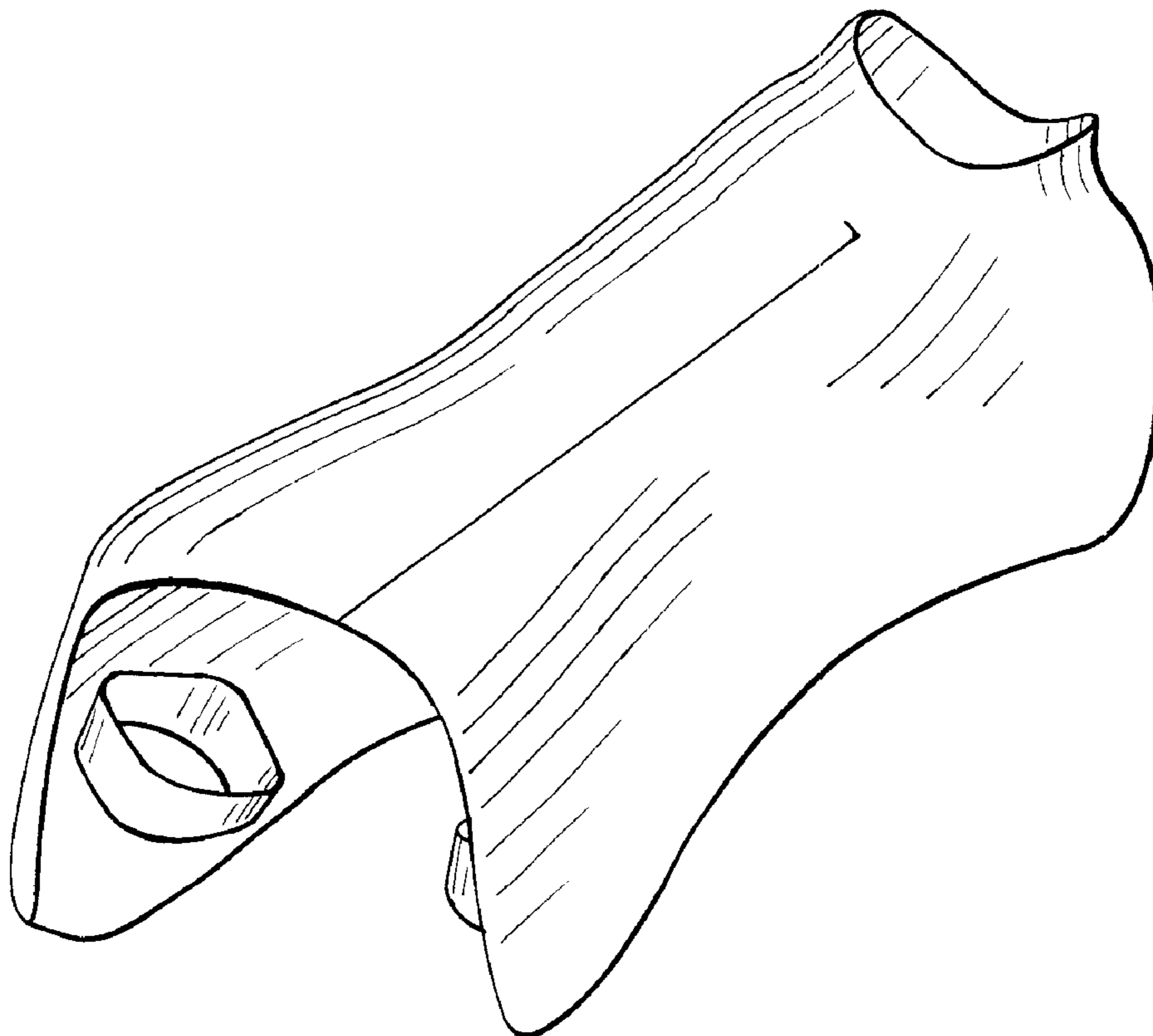

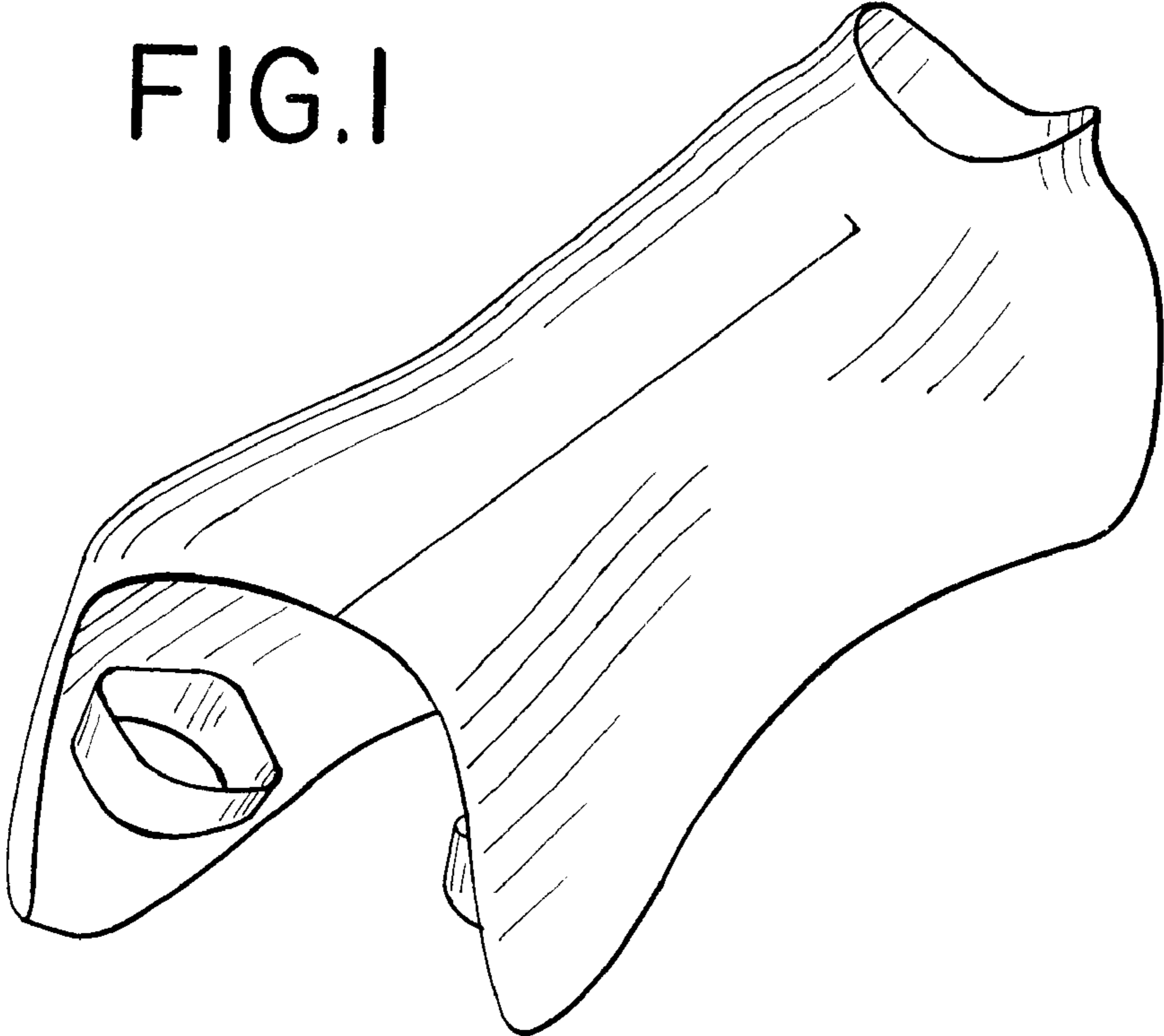

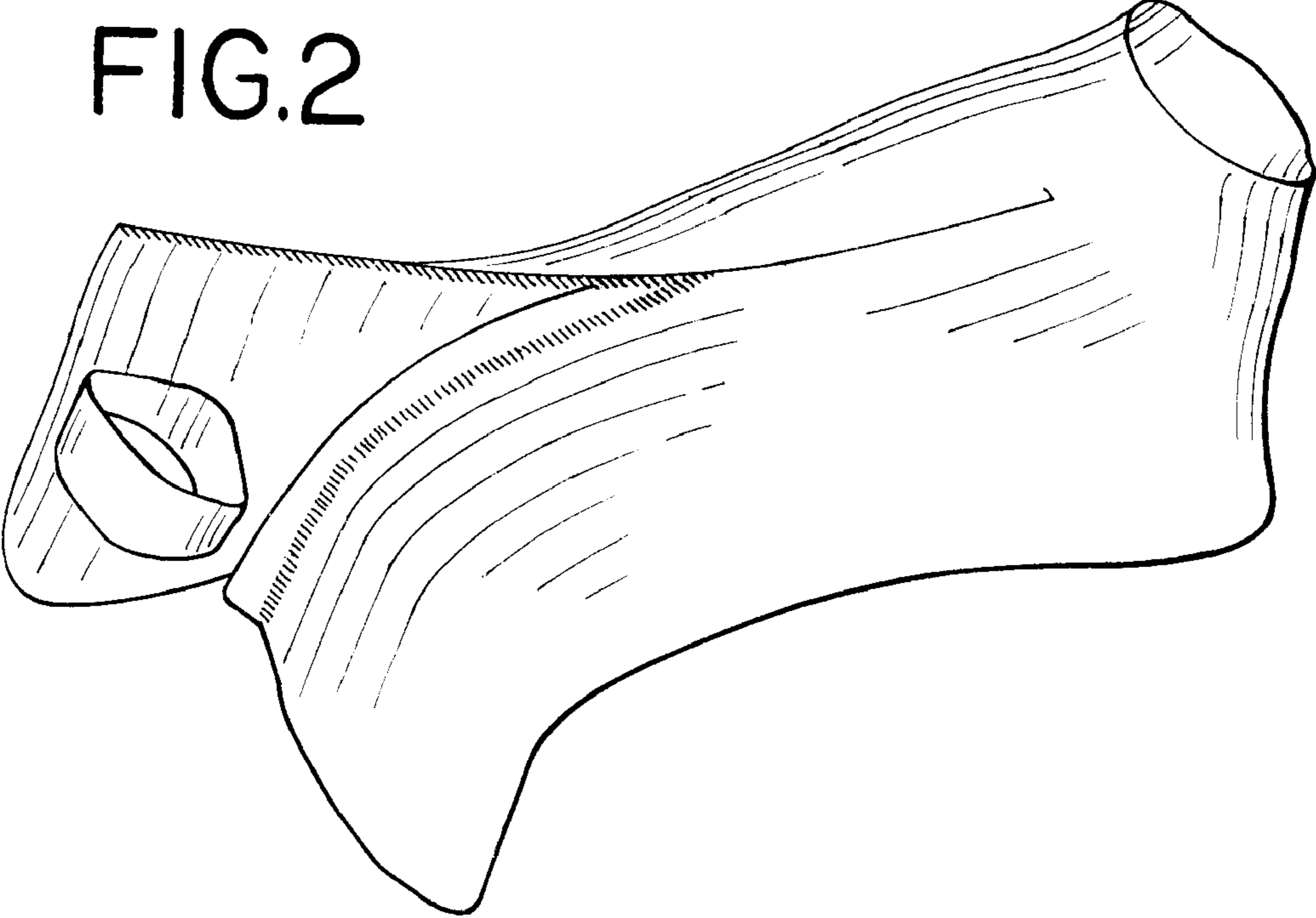

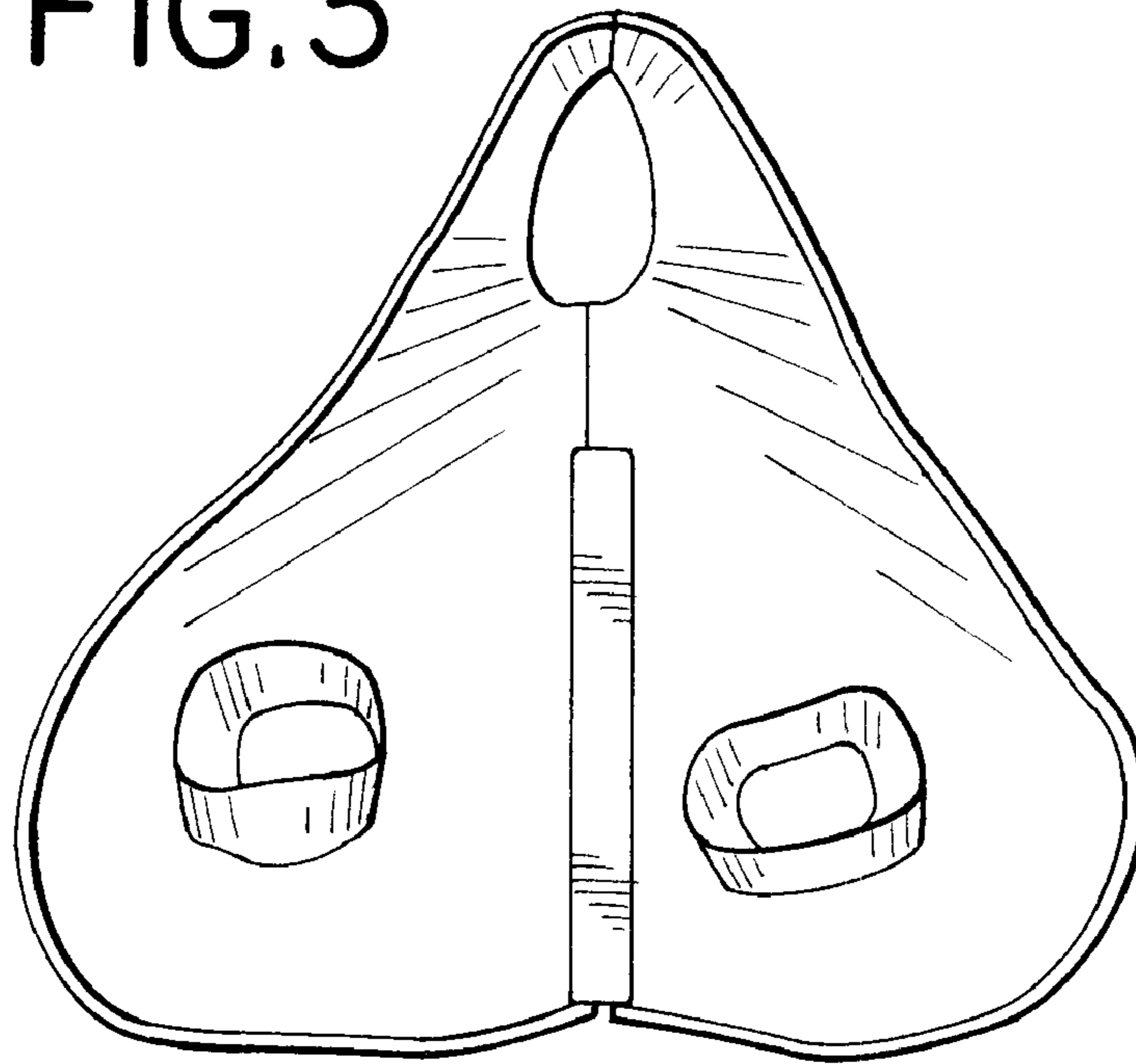
