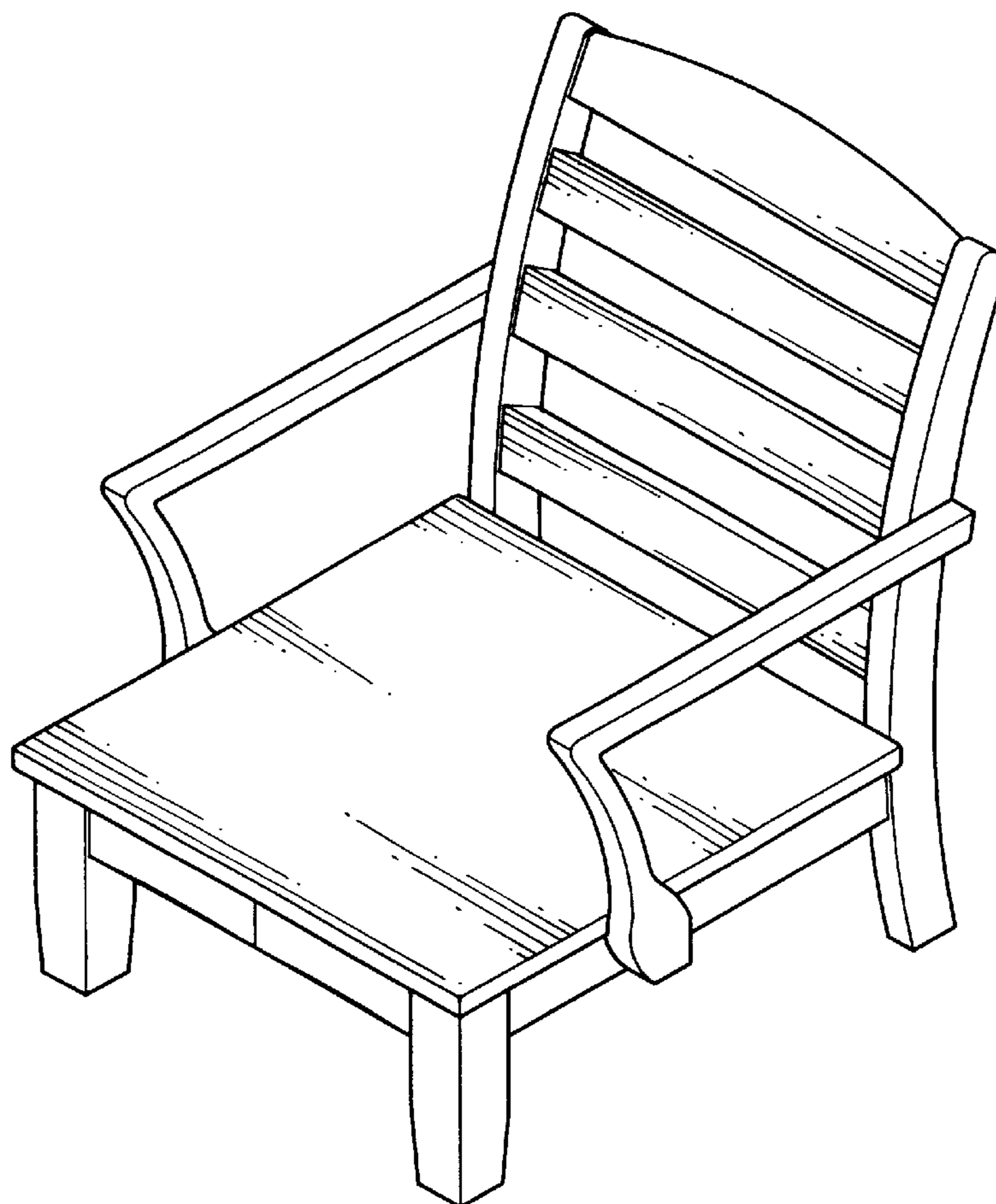
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a living room chair, showing my new design;

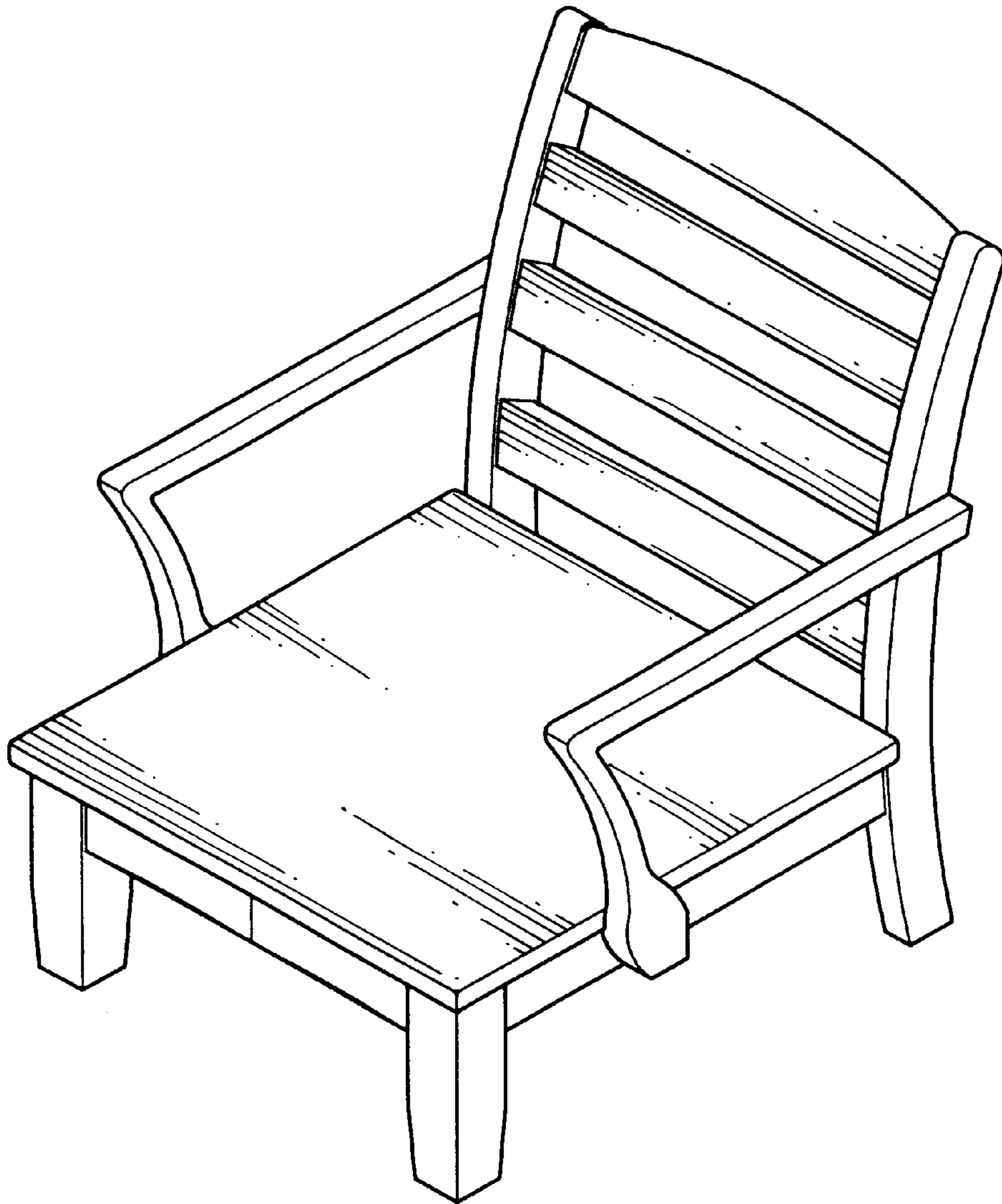

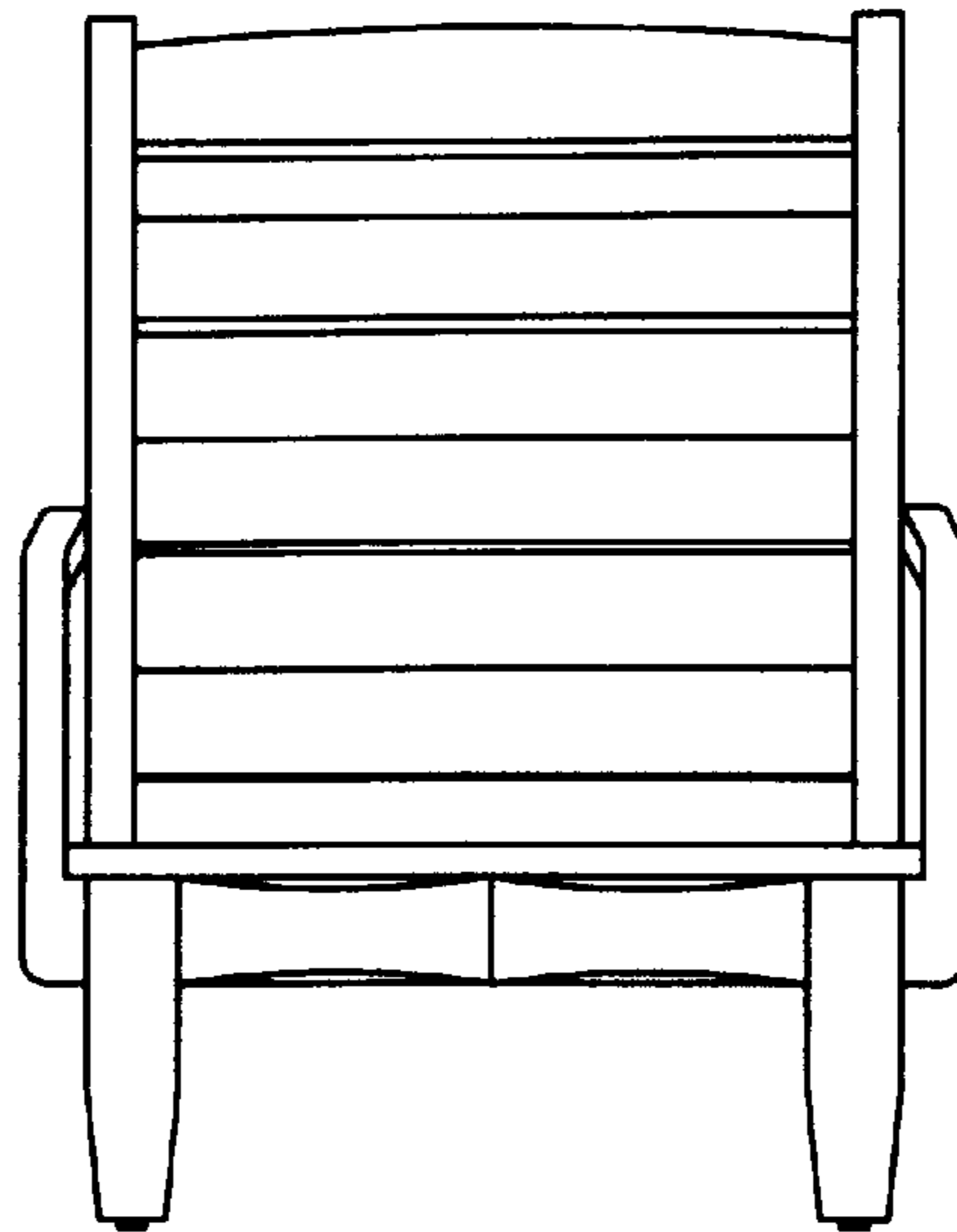

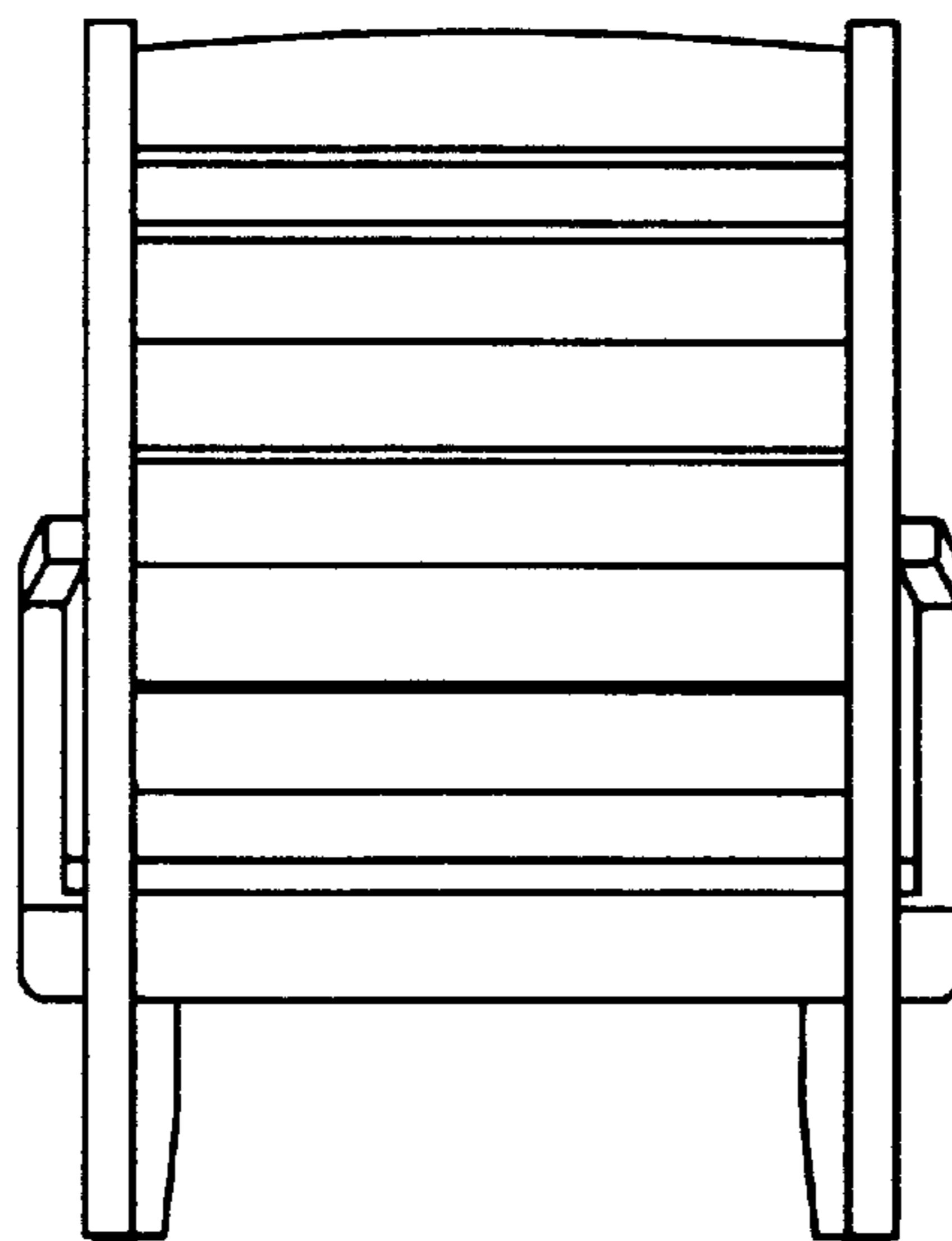

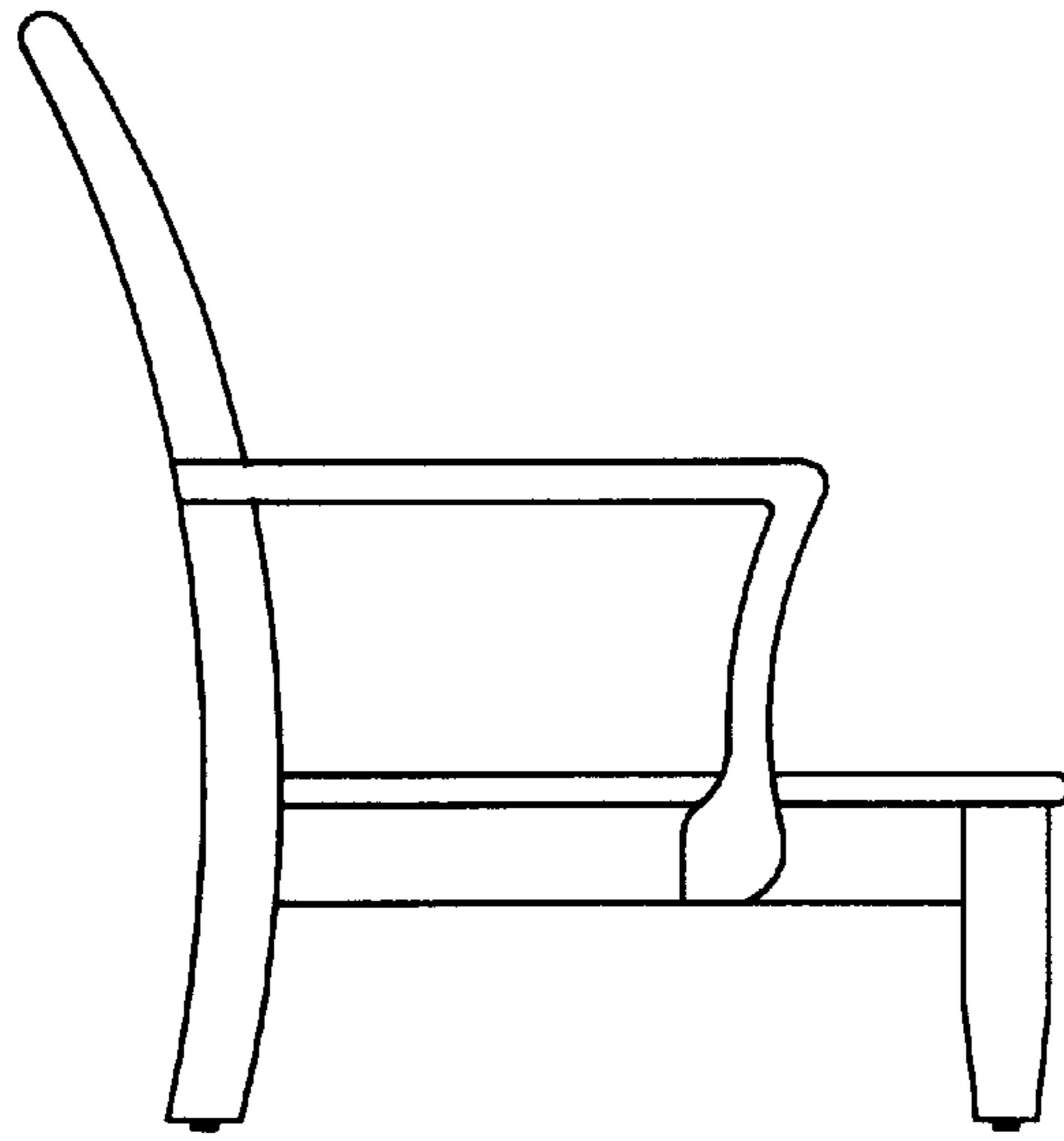

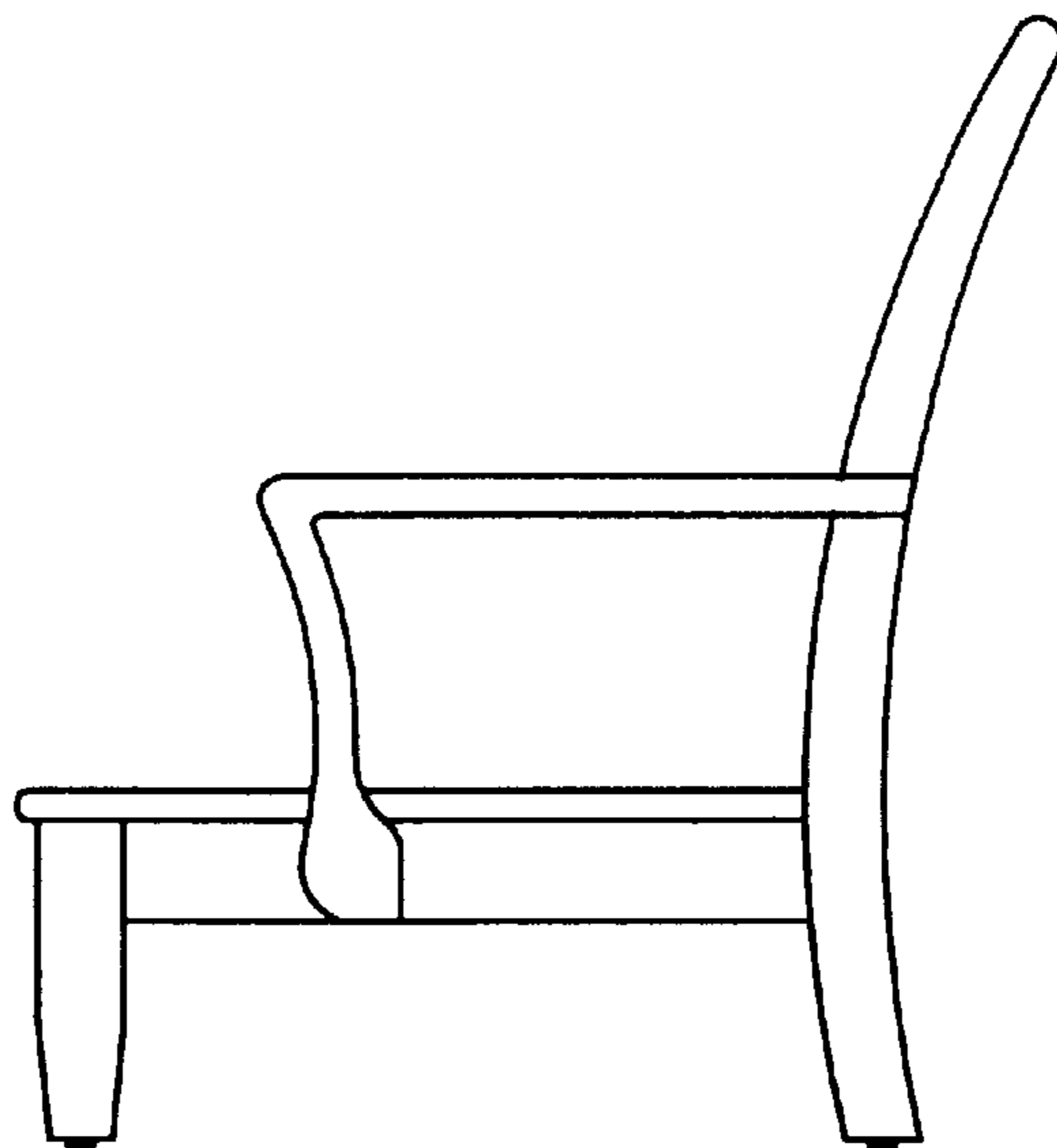

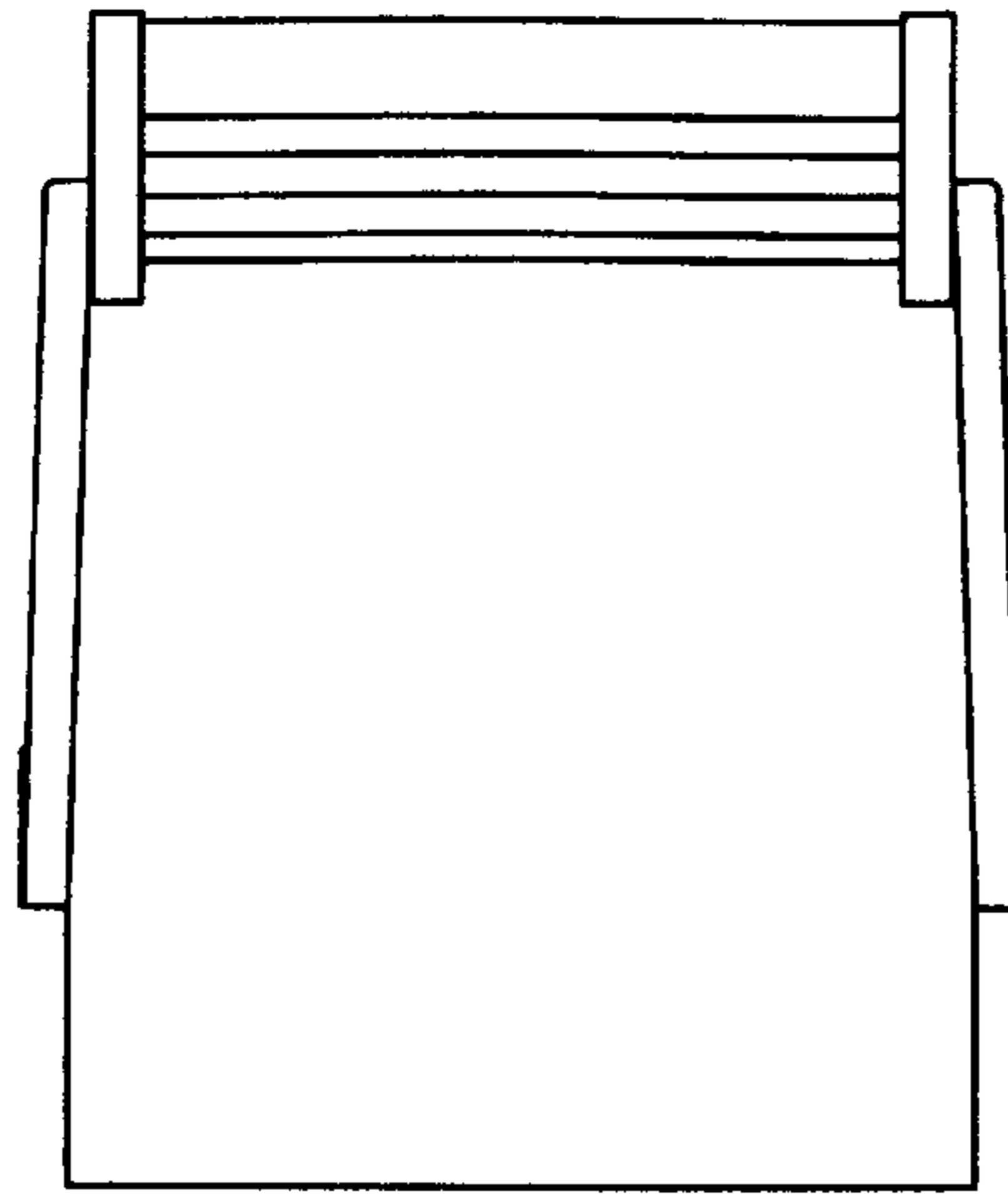

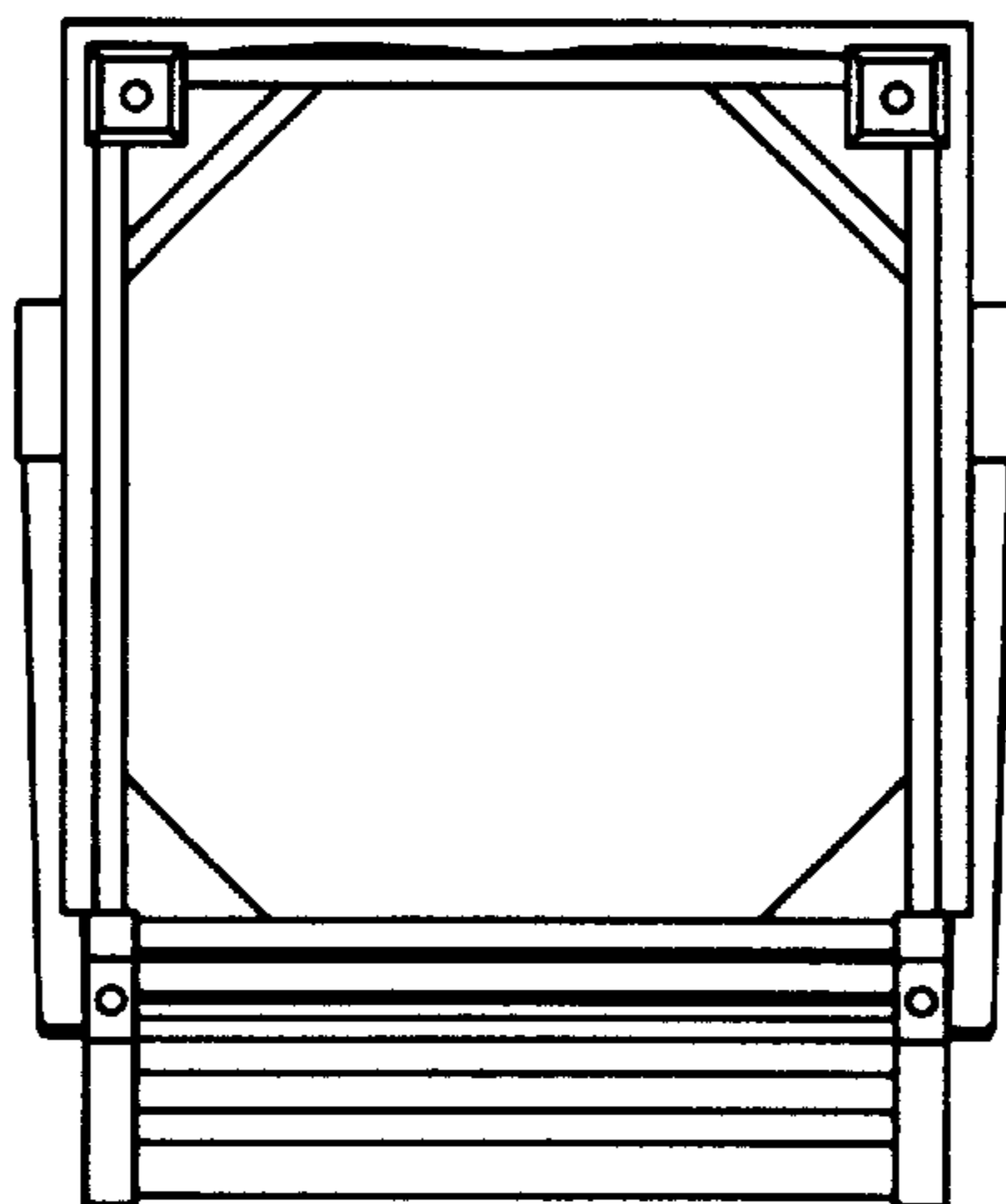
