FIG. 1 is a front perspective view of the design of the appliance handle;

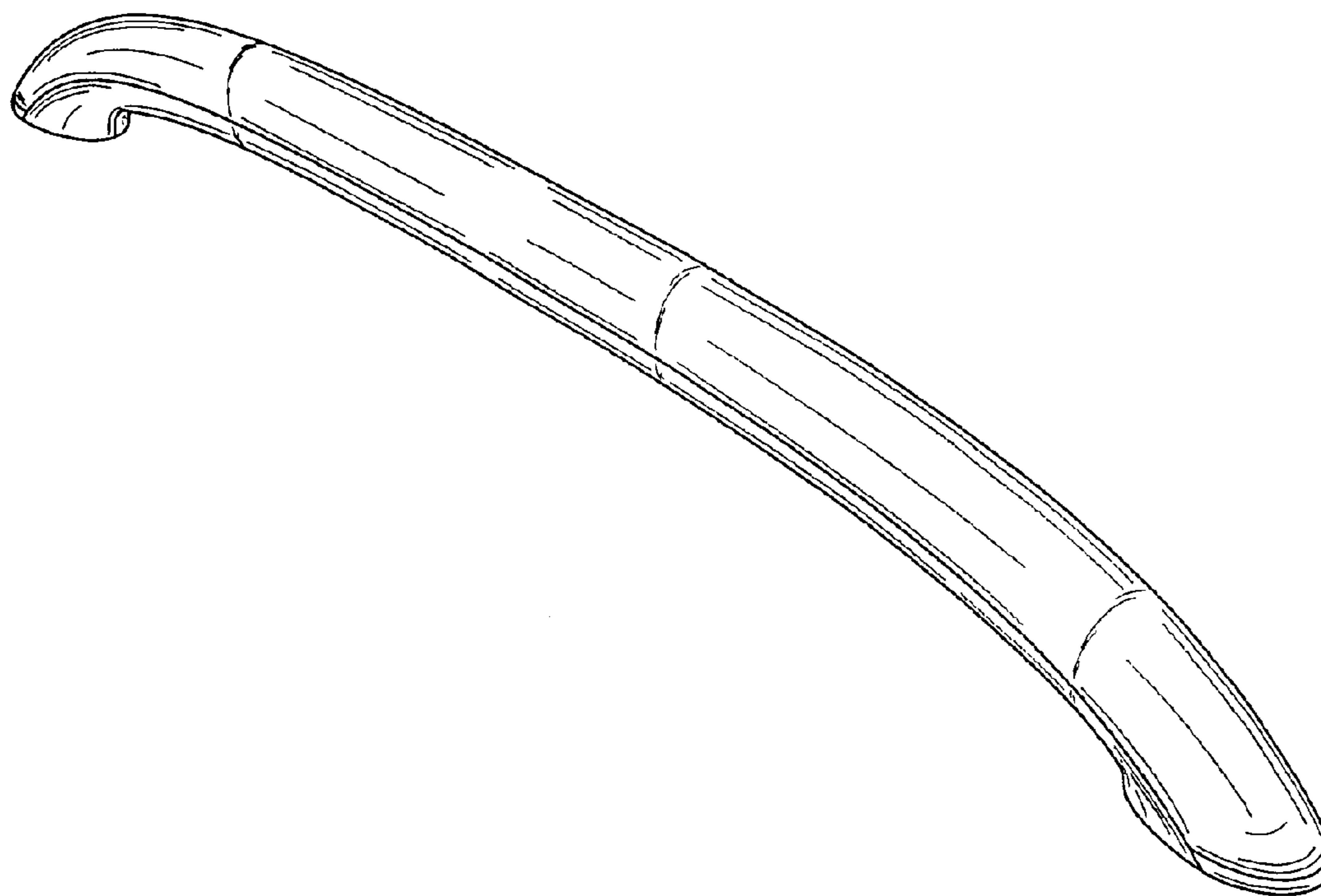
FIG. 2 is a top plan view thereof;

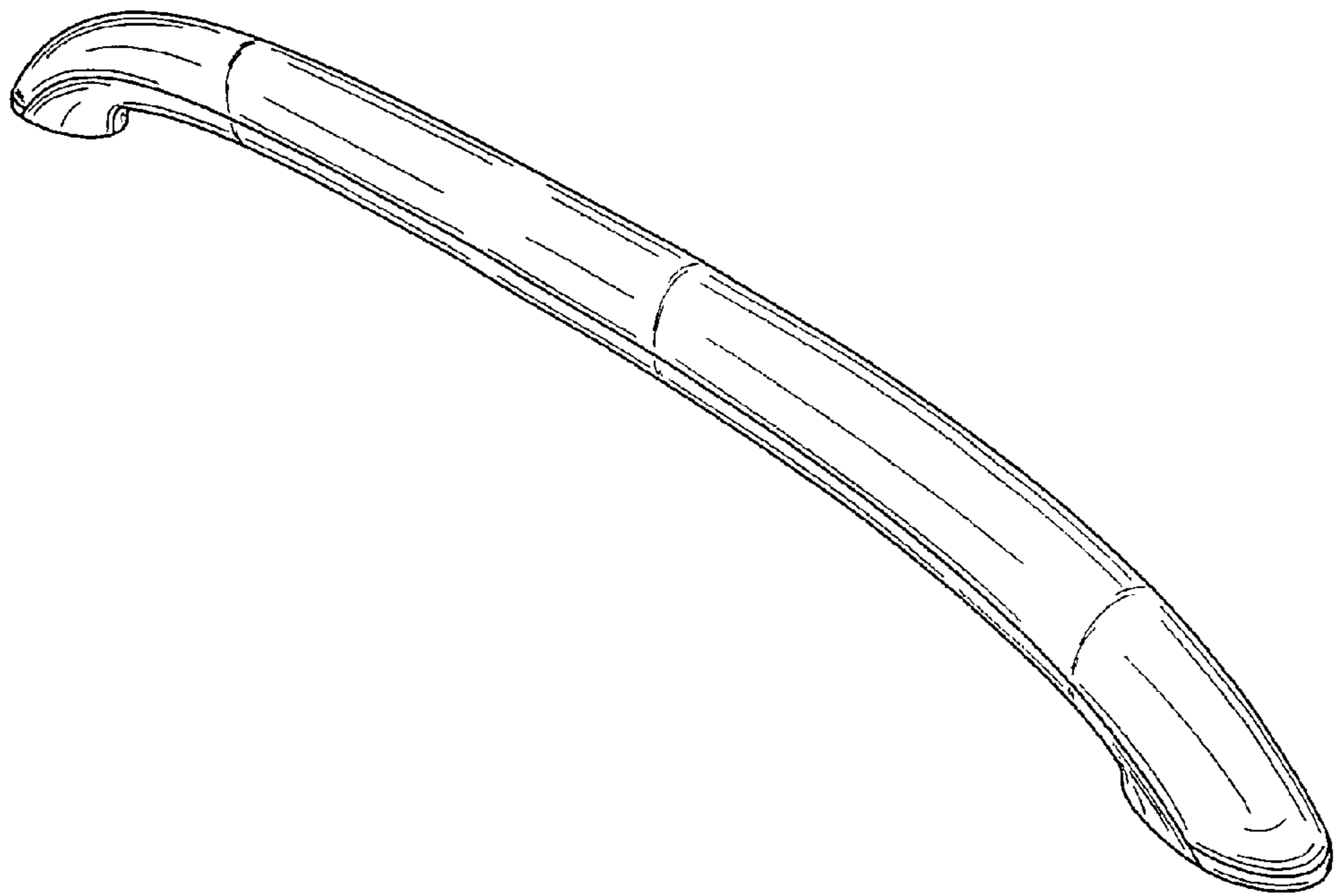

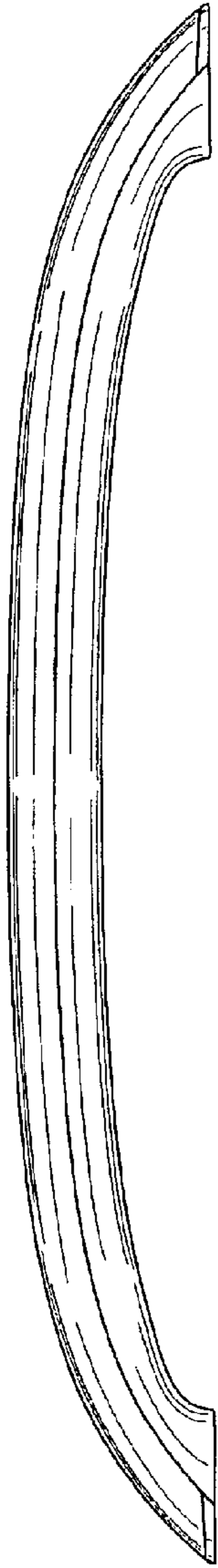

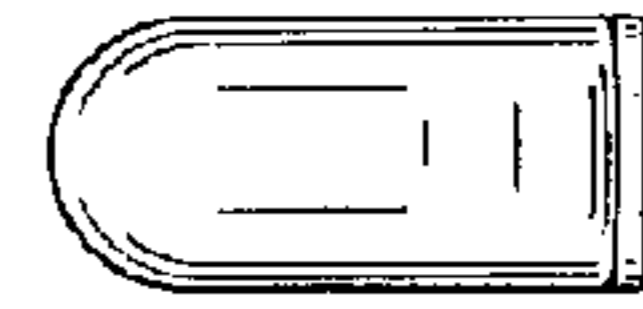
