(57) **CLAIM**

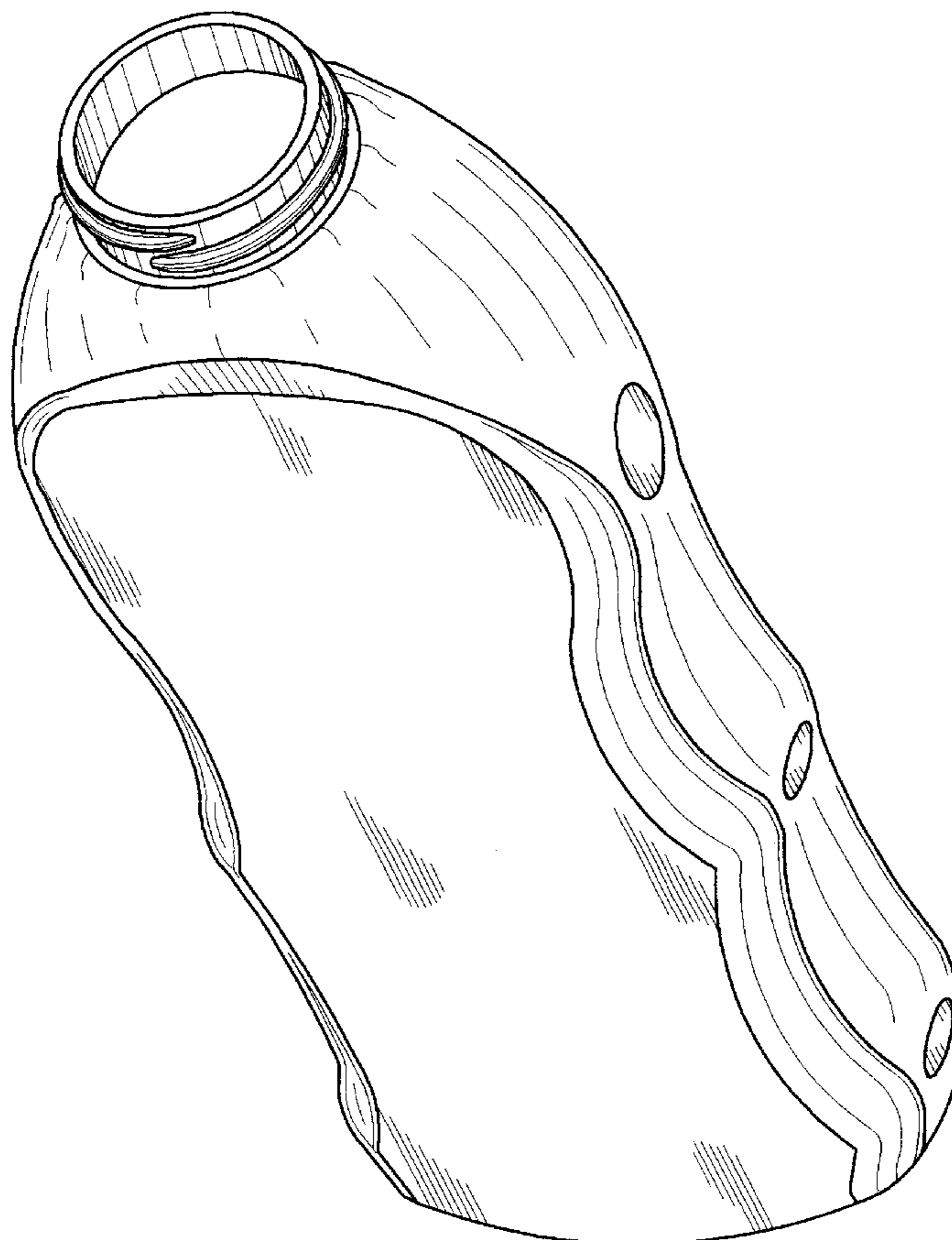
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bottle of the claimed design, the rear elevational view being identical except for the thread; and,

FIG. 2 is a top, front, right side perspective view thereof; the top, rear, left side perspective view being identical except for the thread.

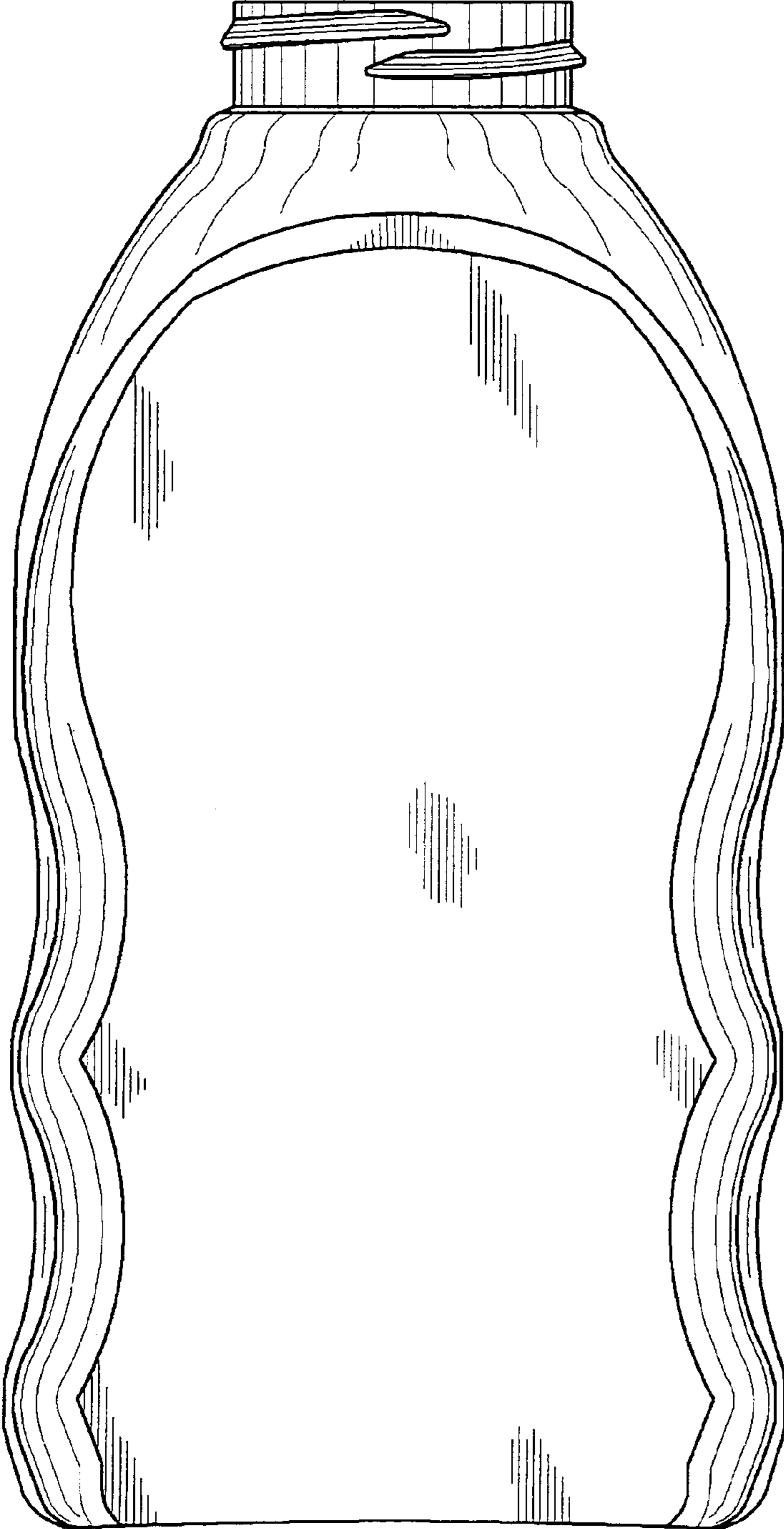

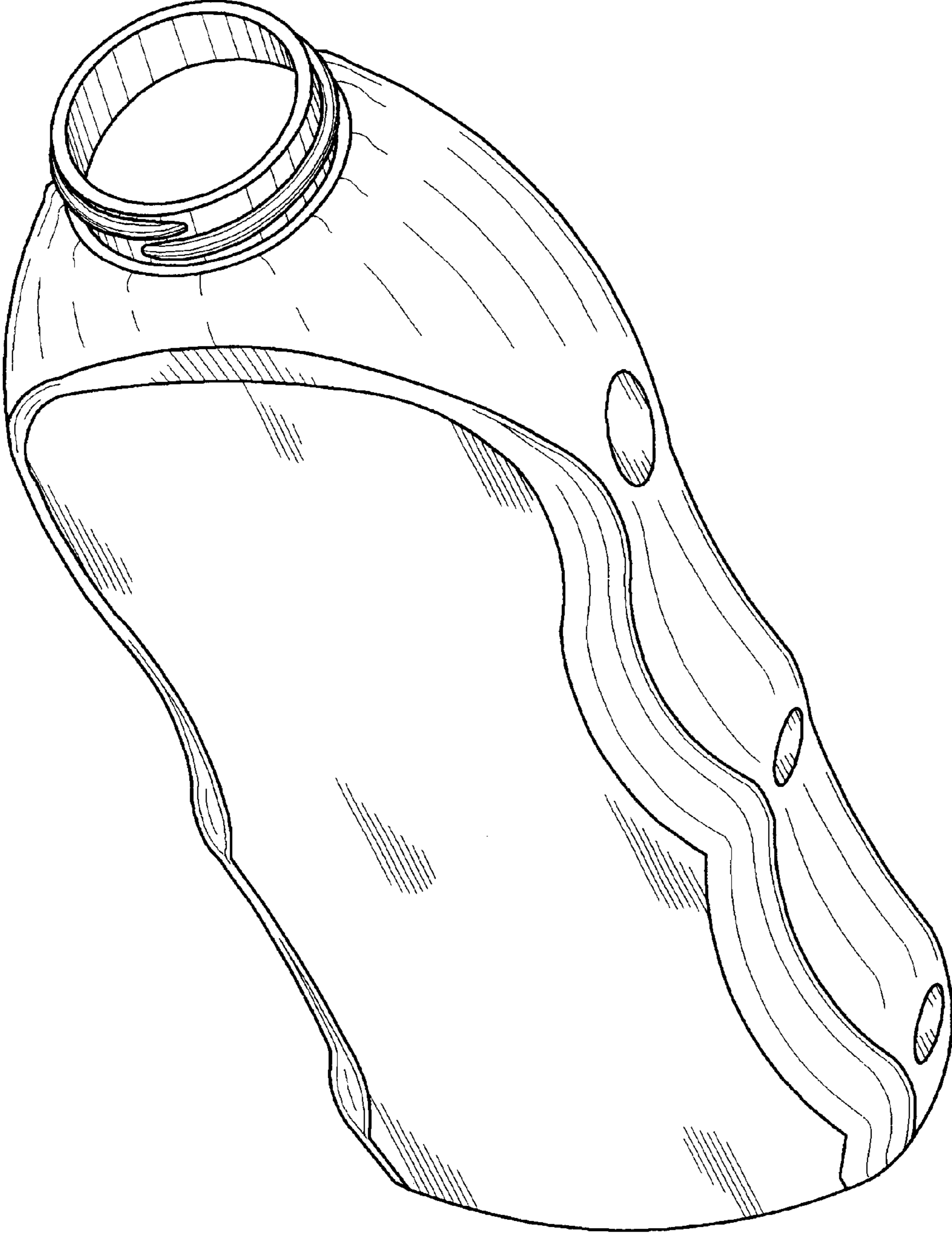
