The ornamental designs for container for aerosol cans, as shown and described.

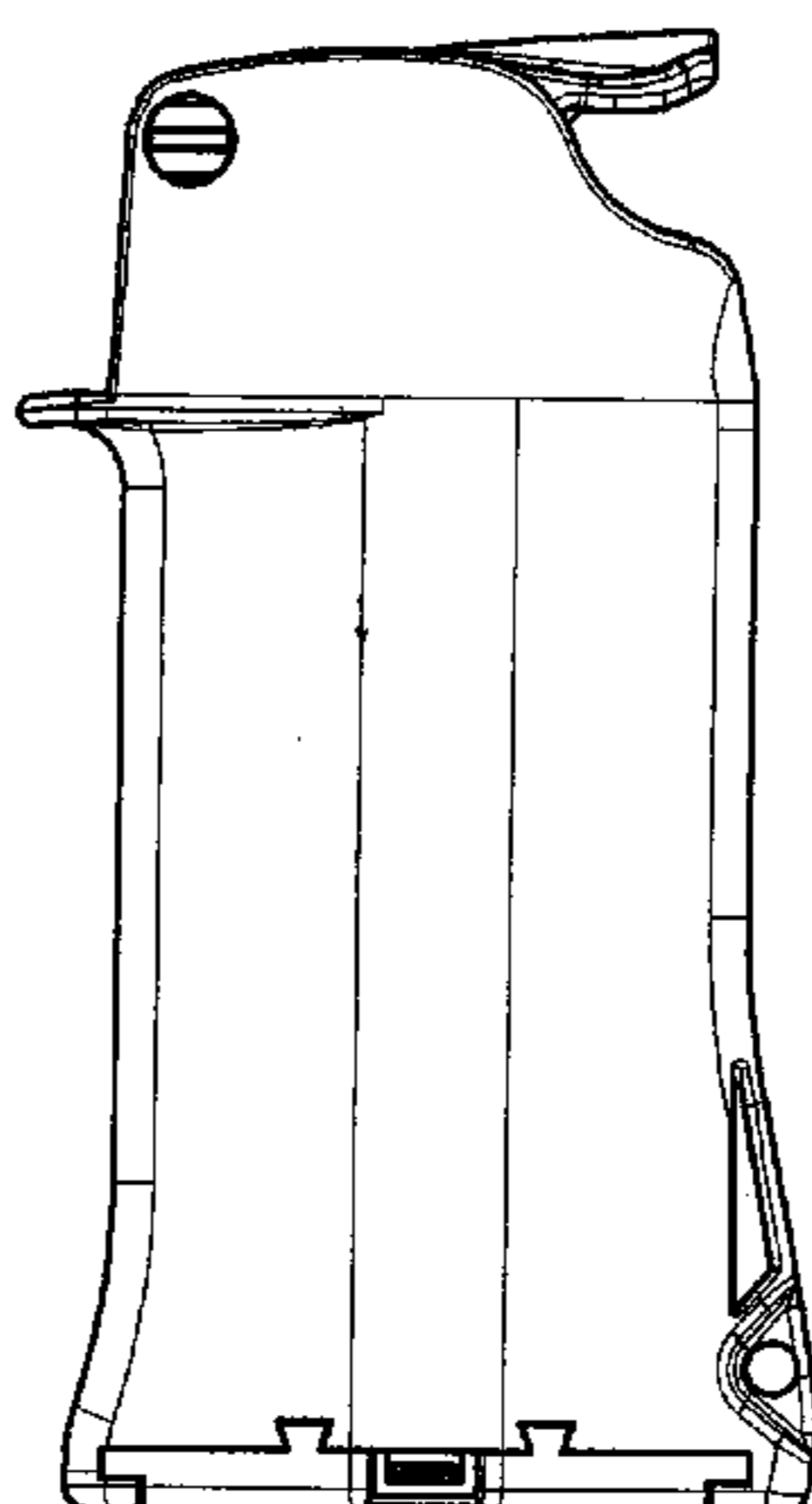
**DESCRIPTION**

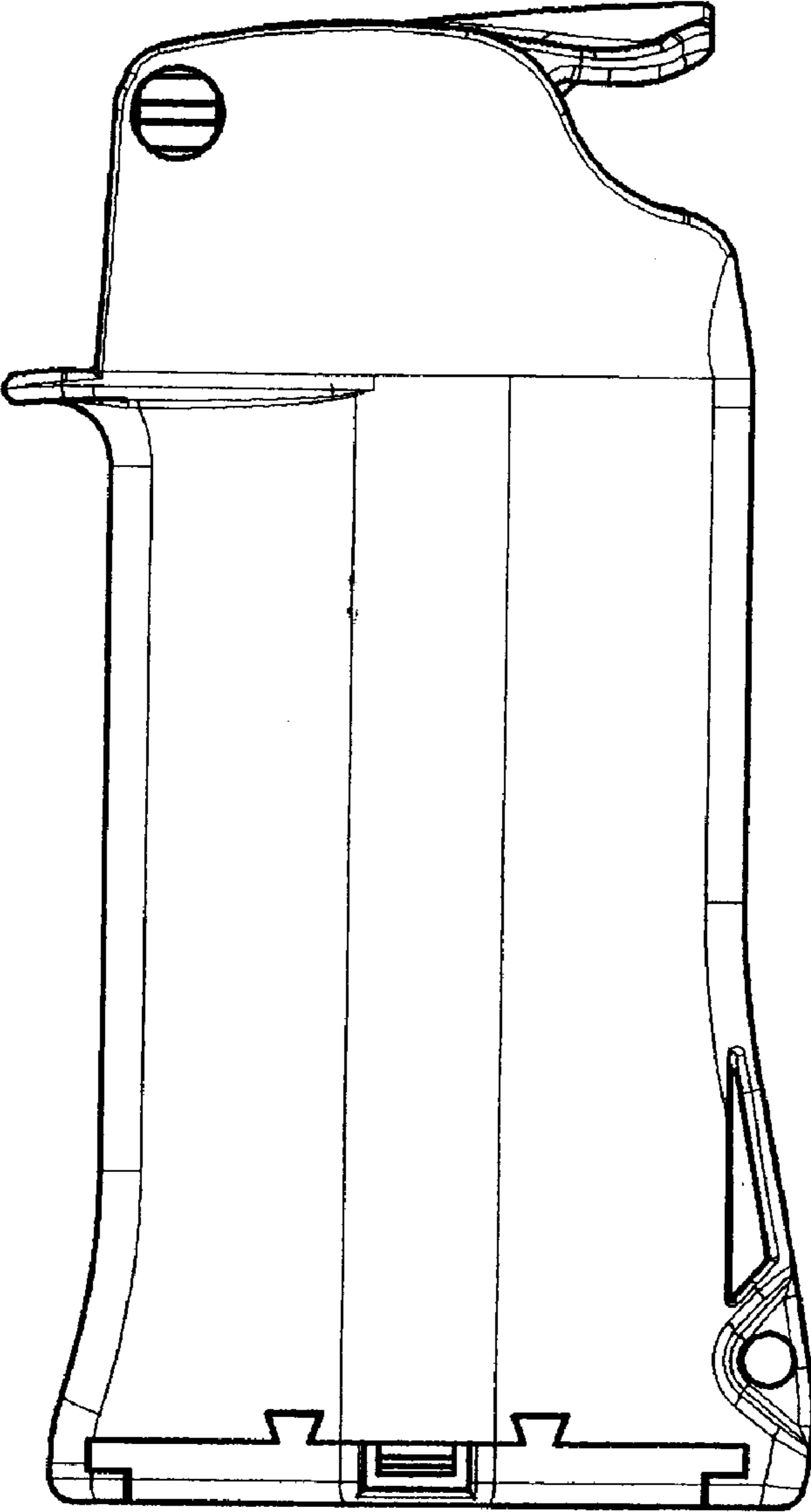

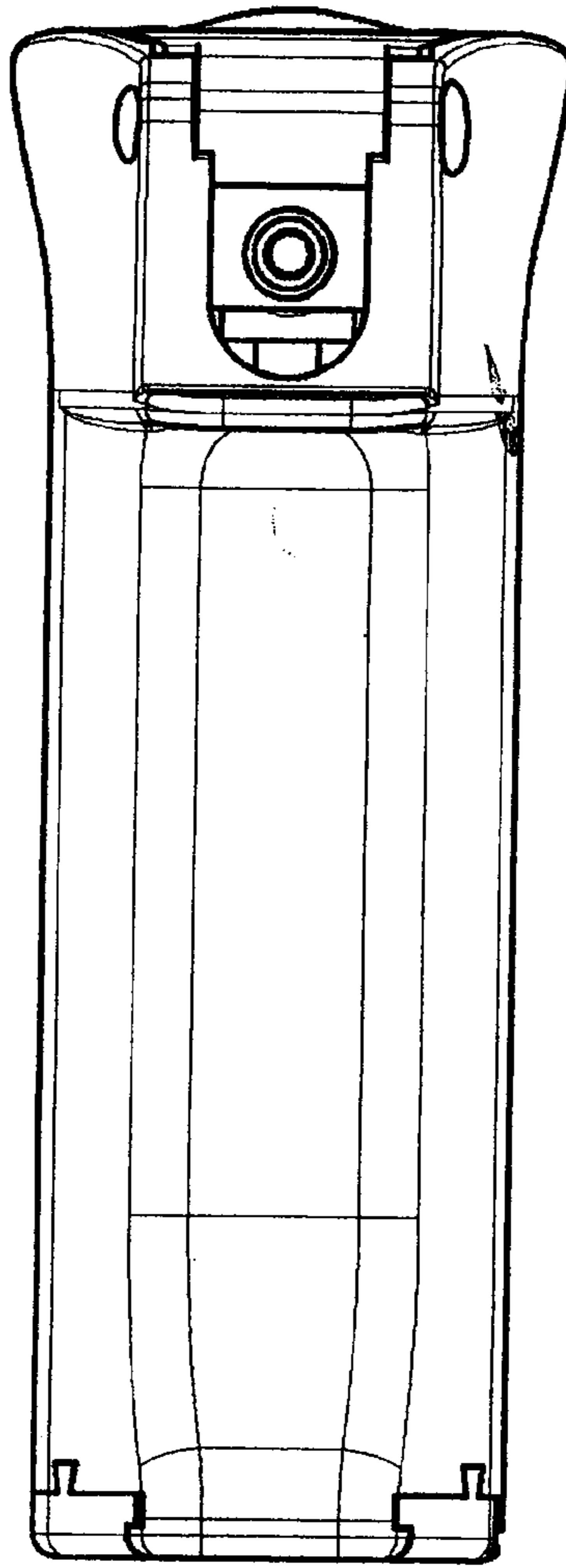

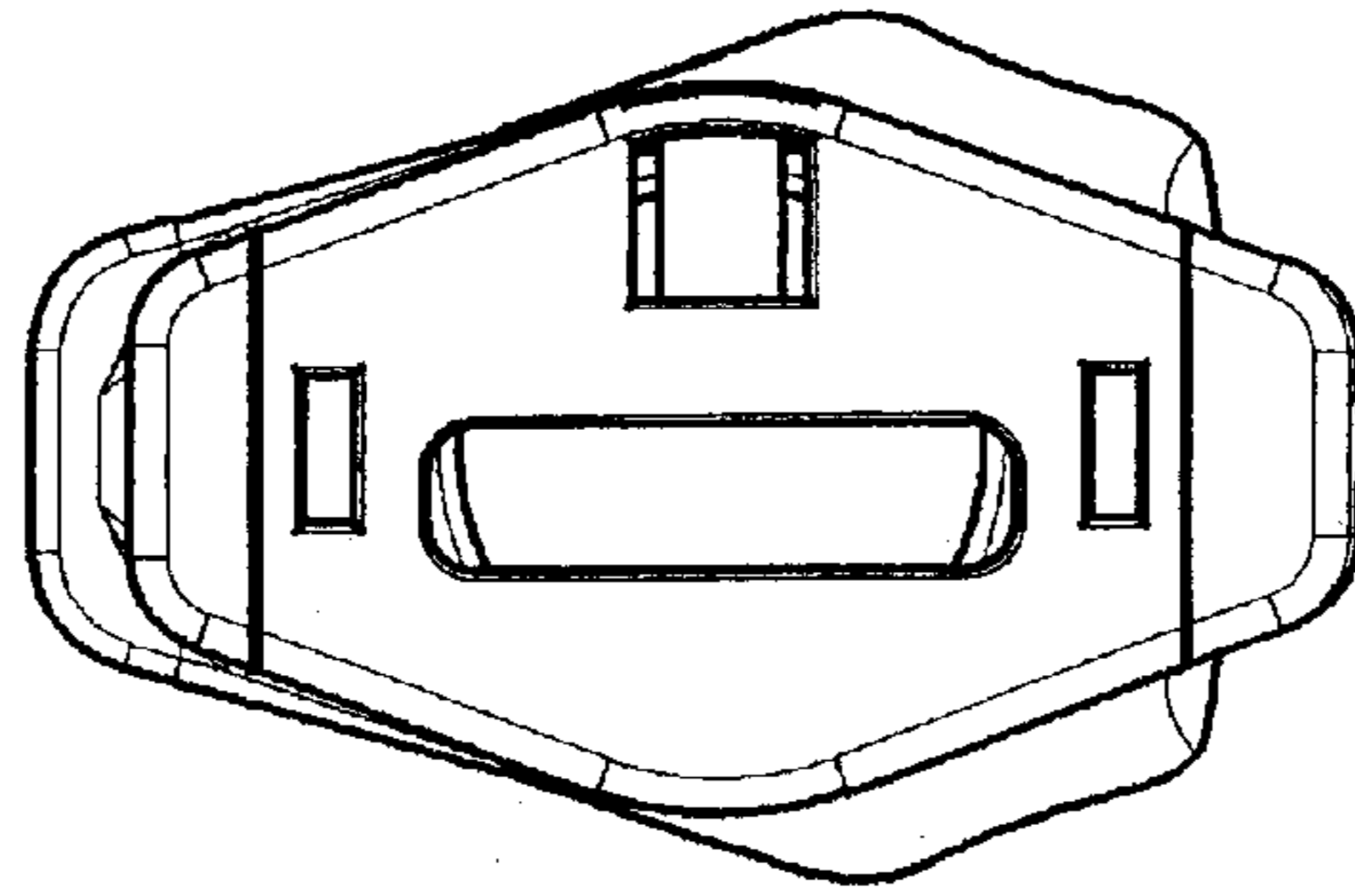

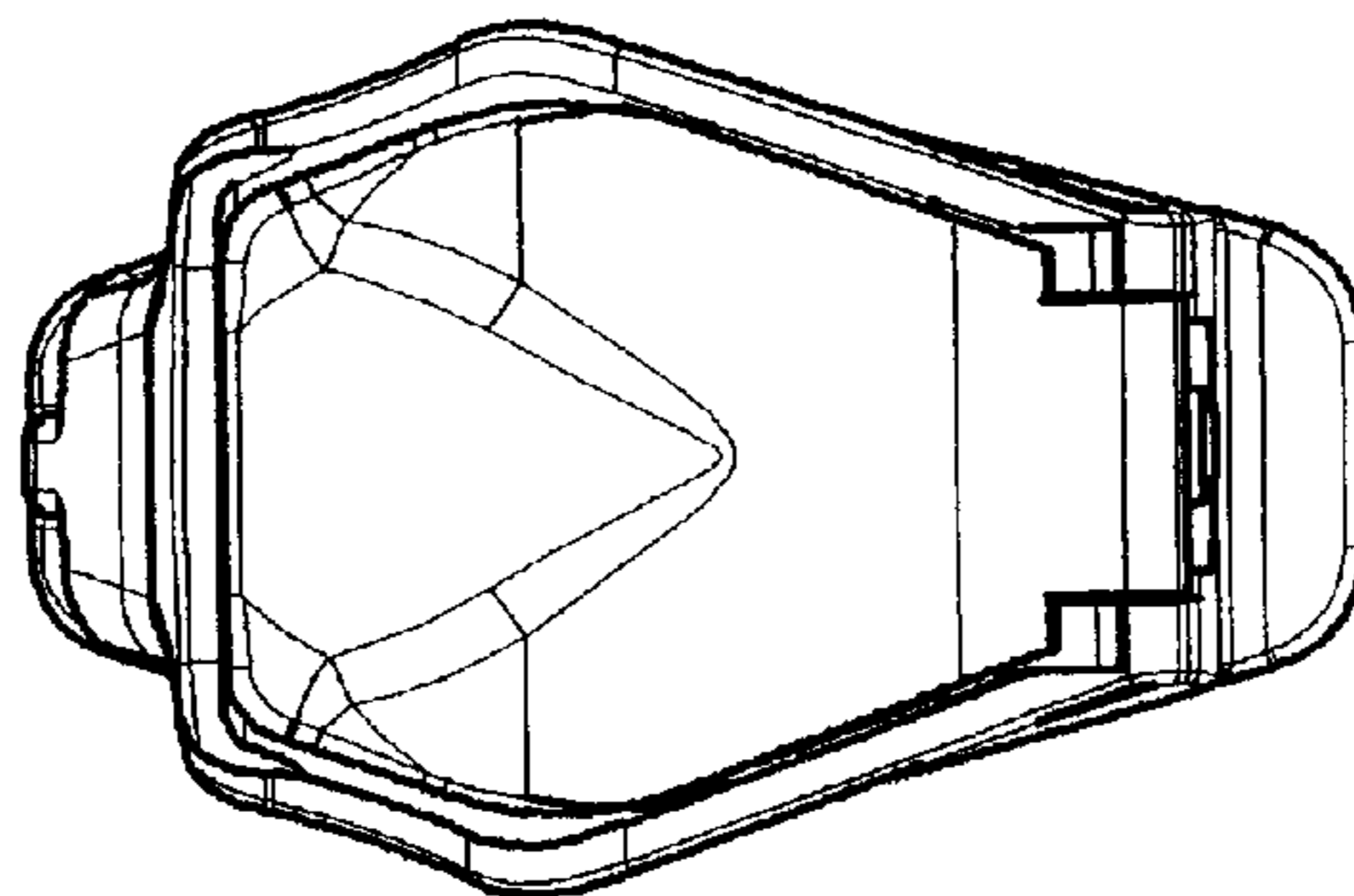

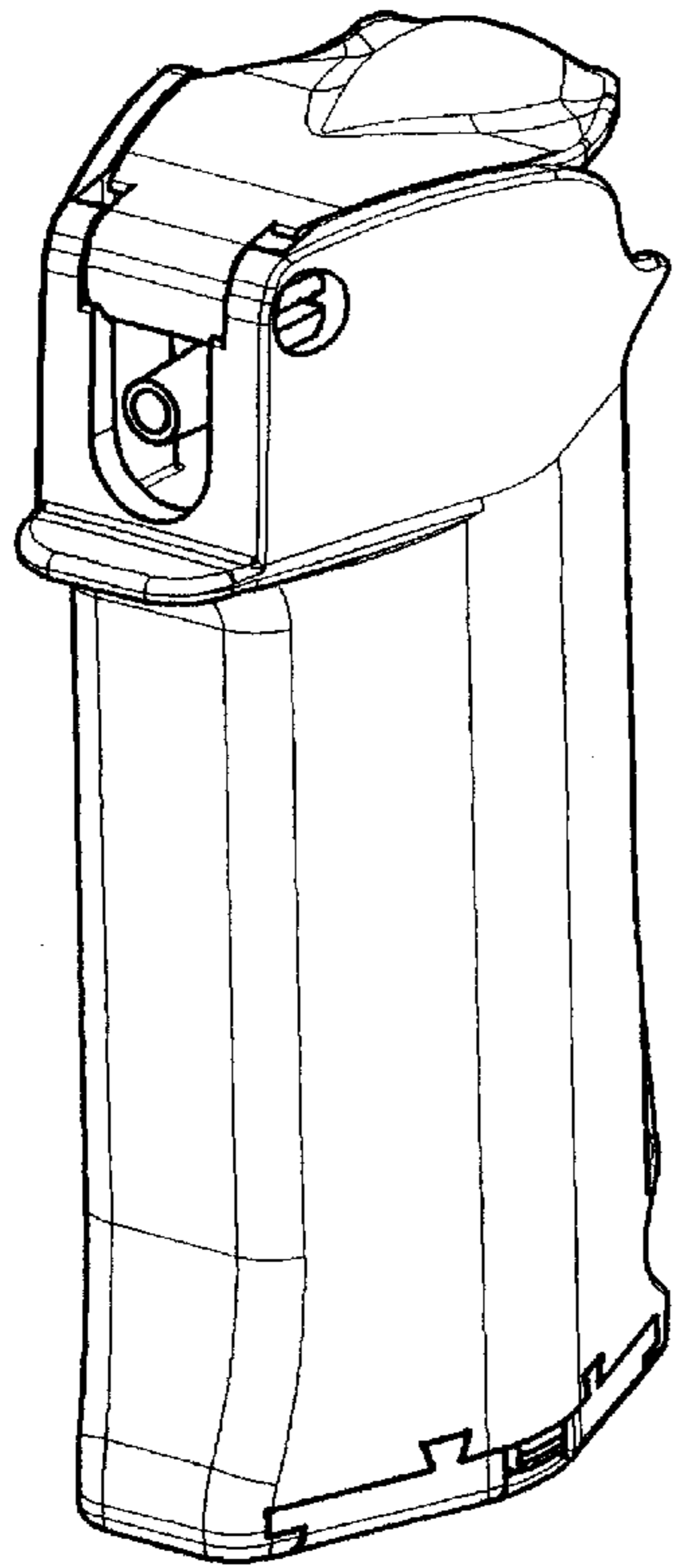

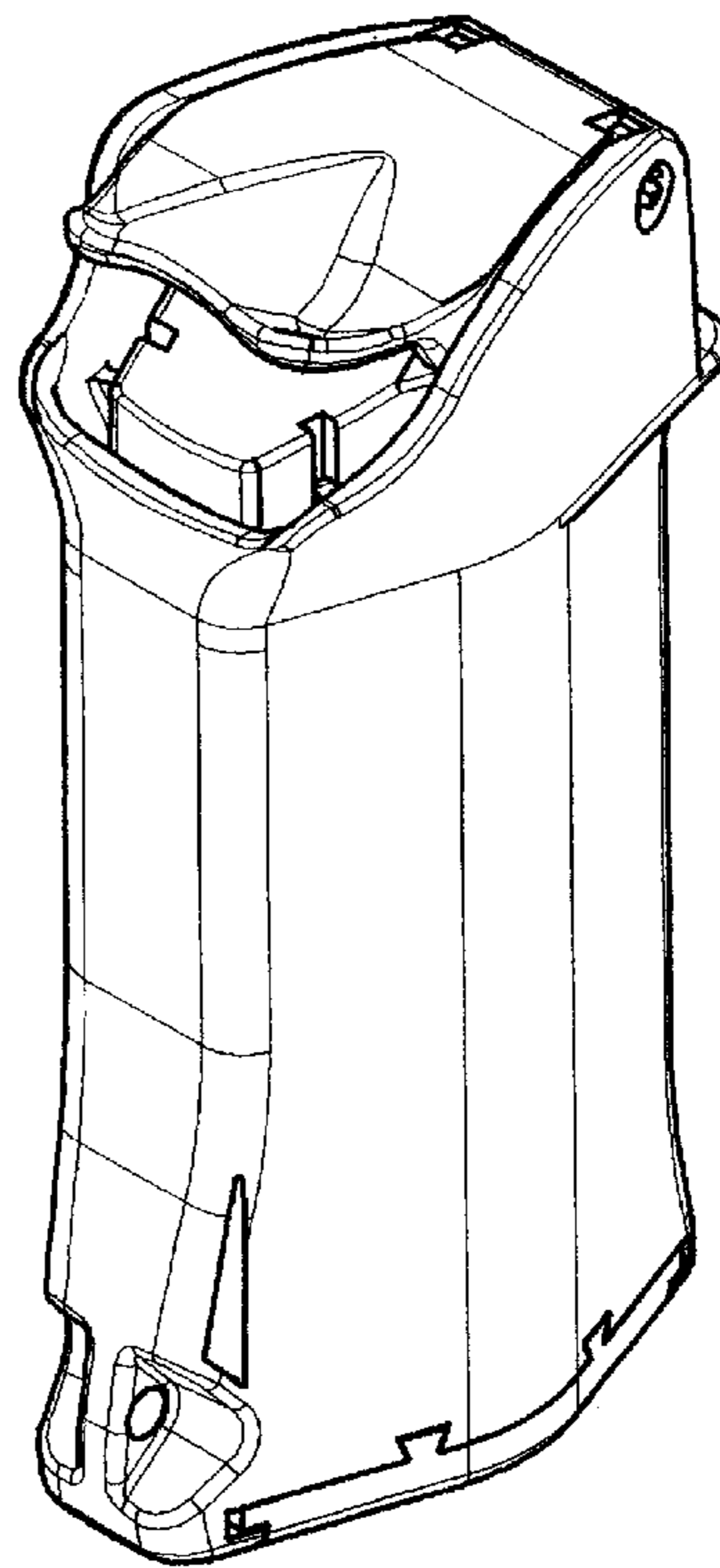

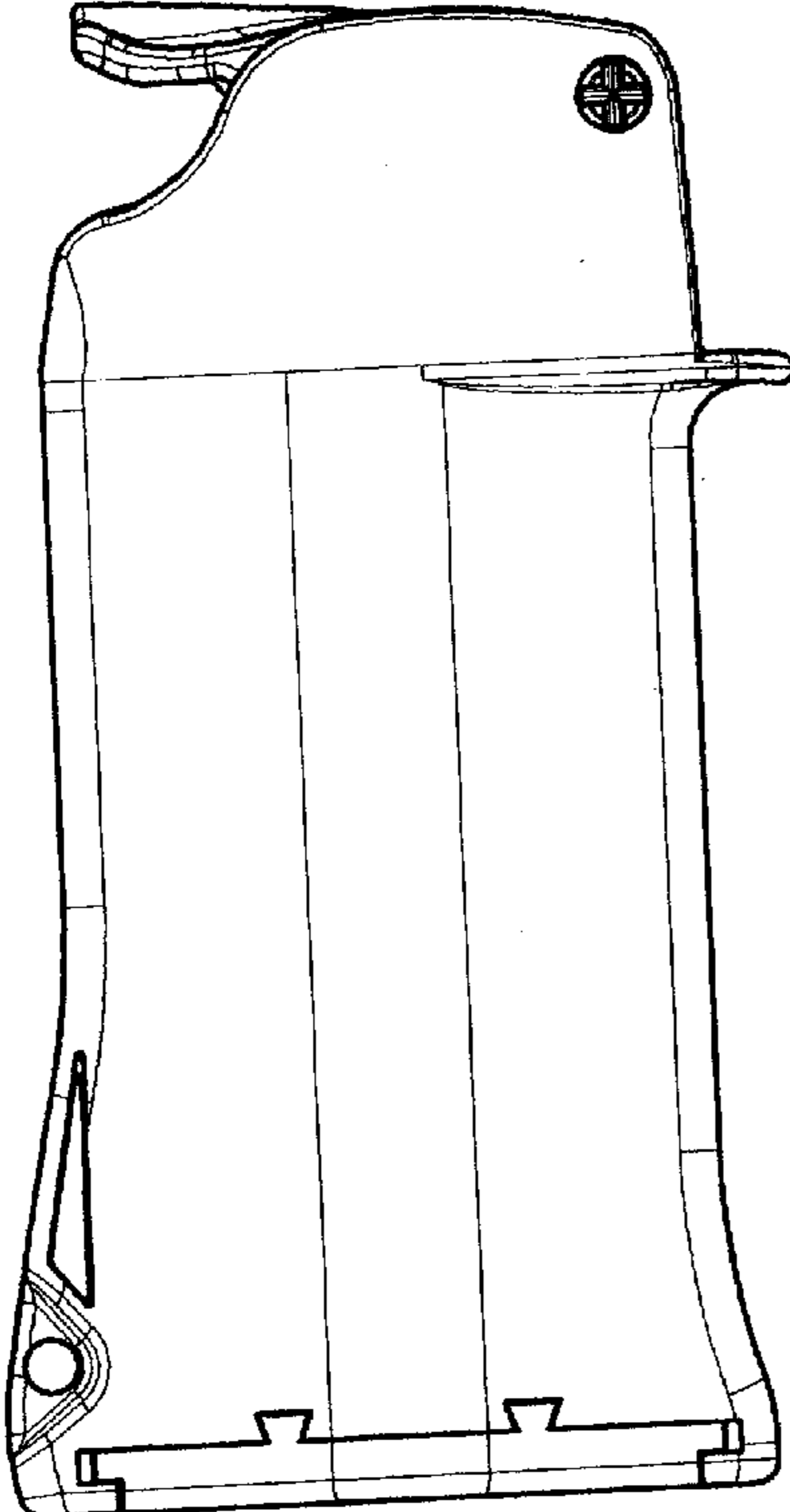

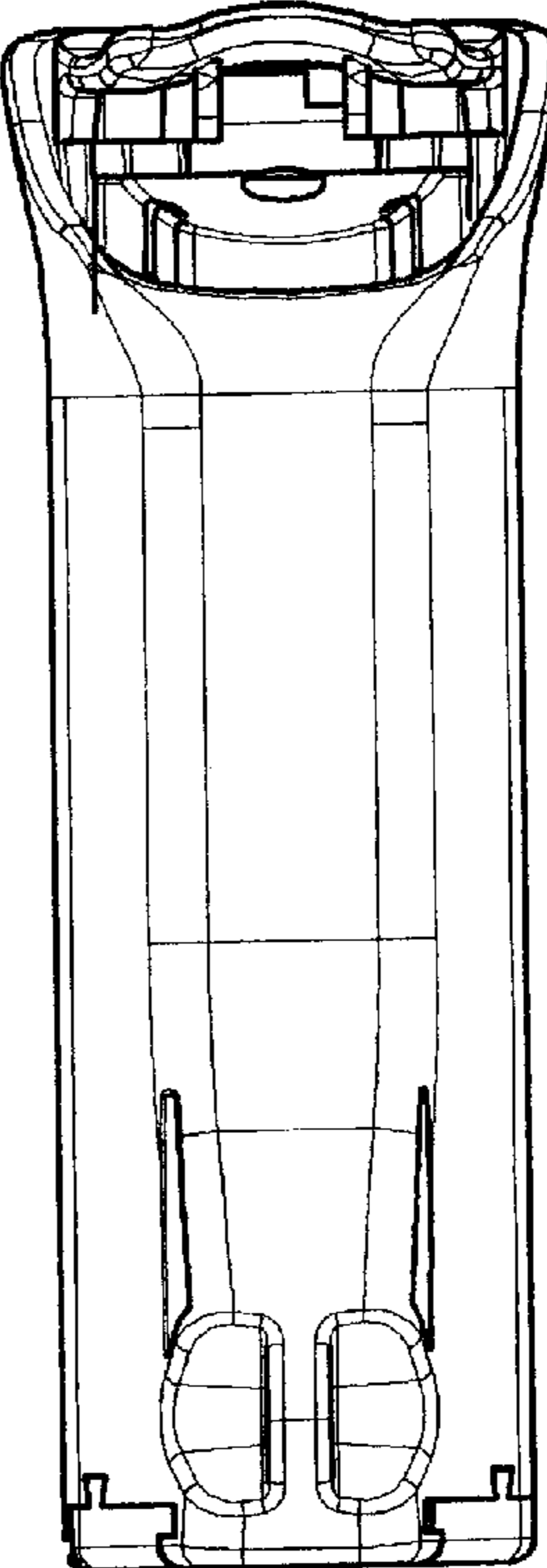

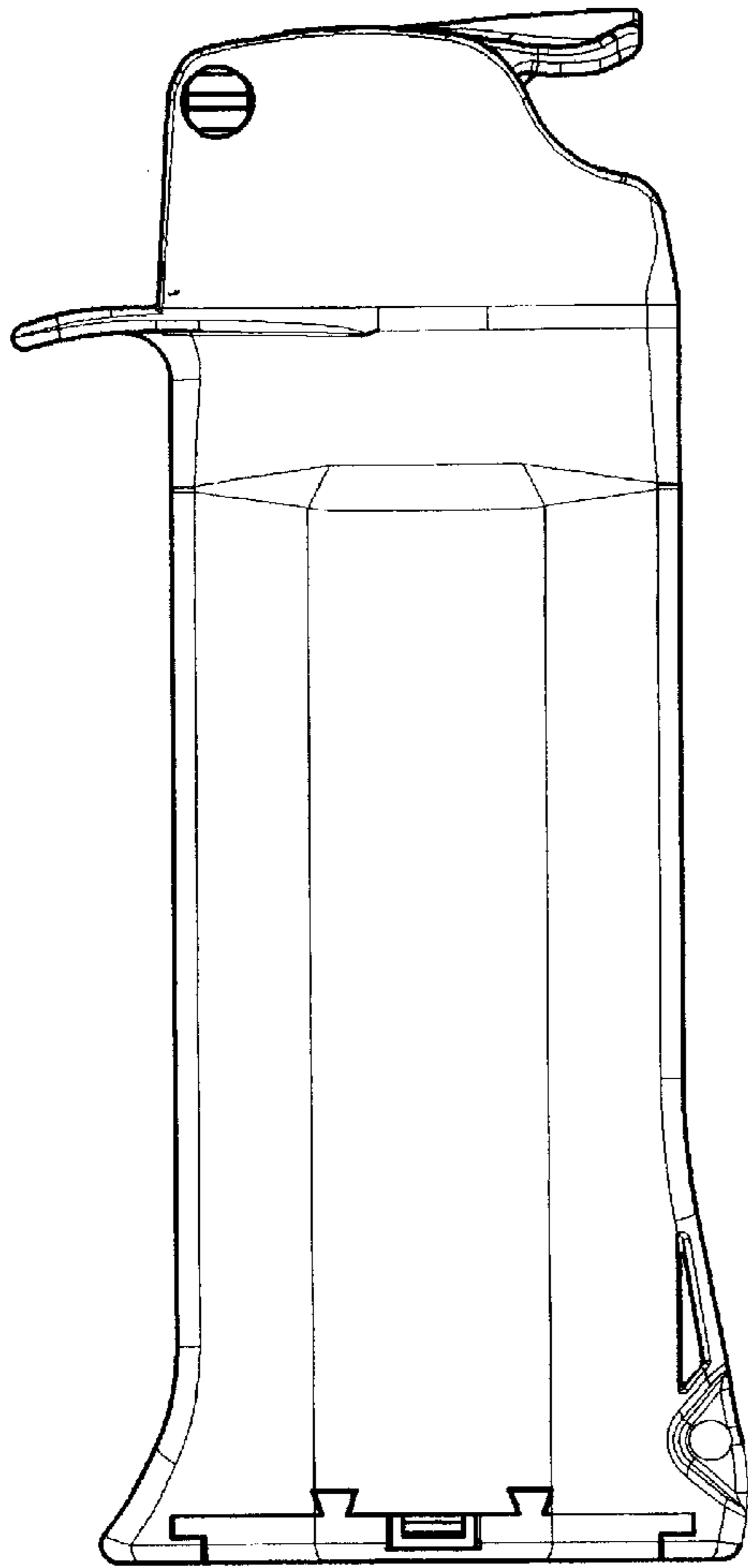

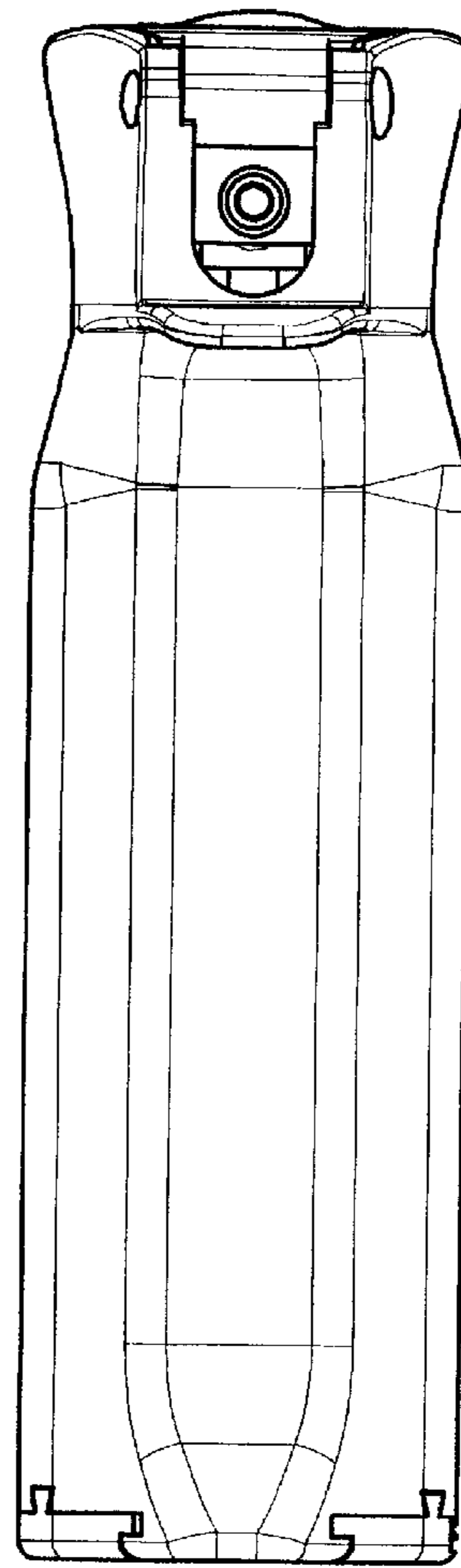

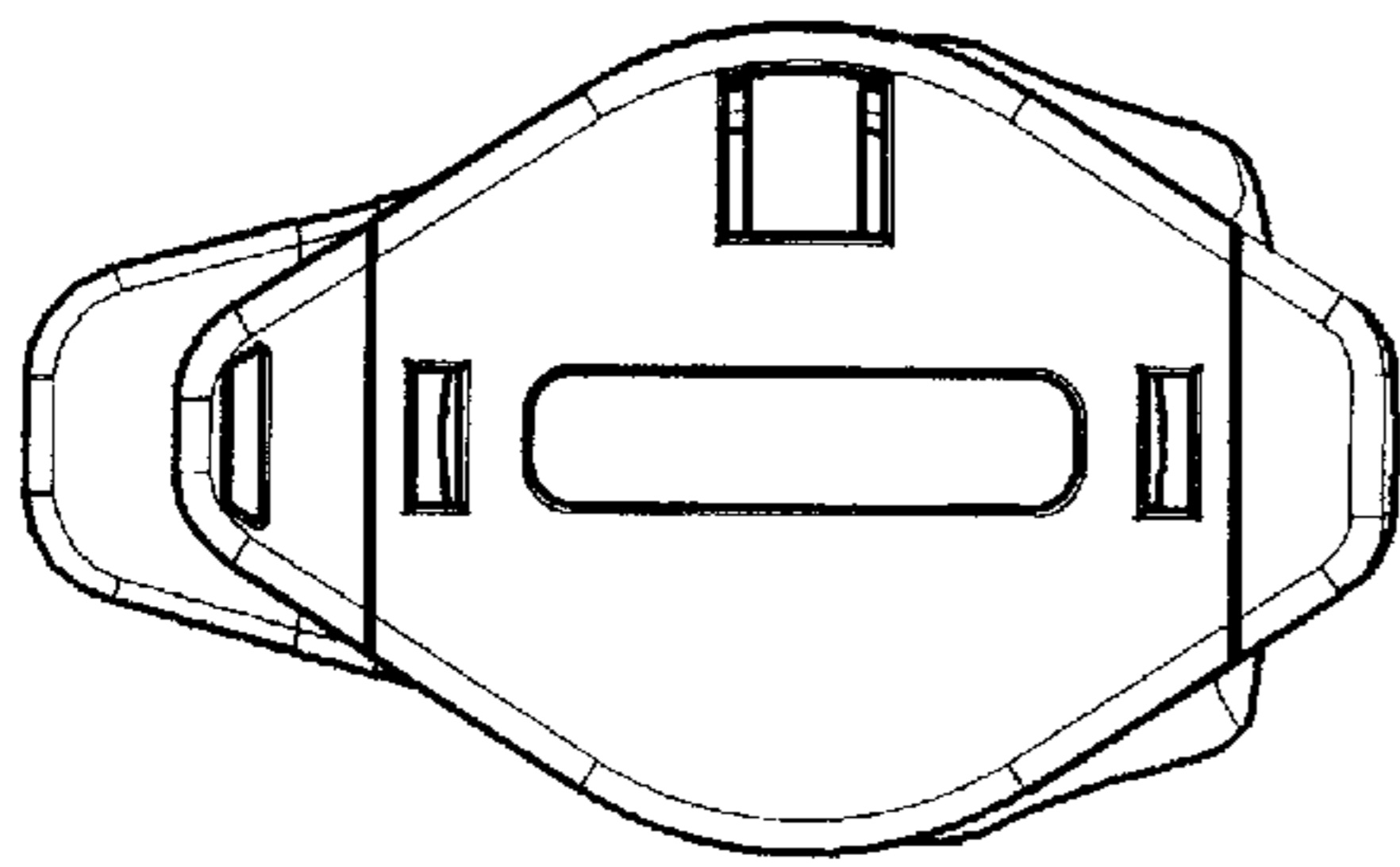

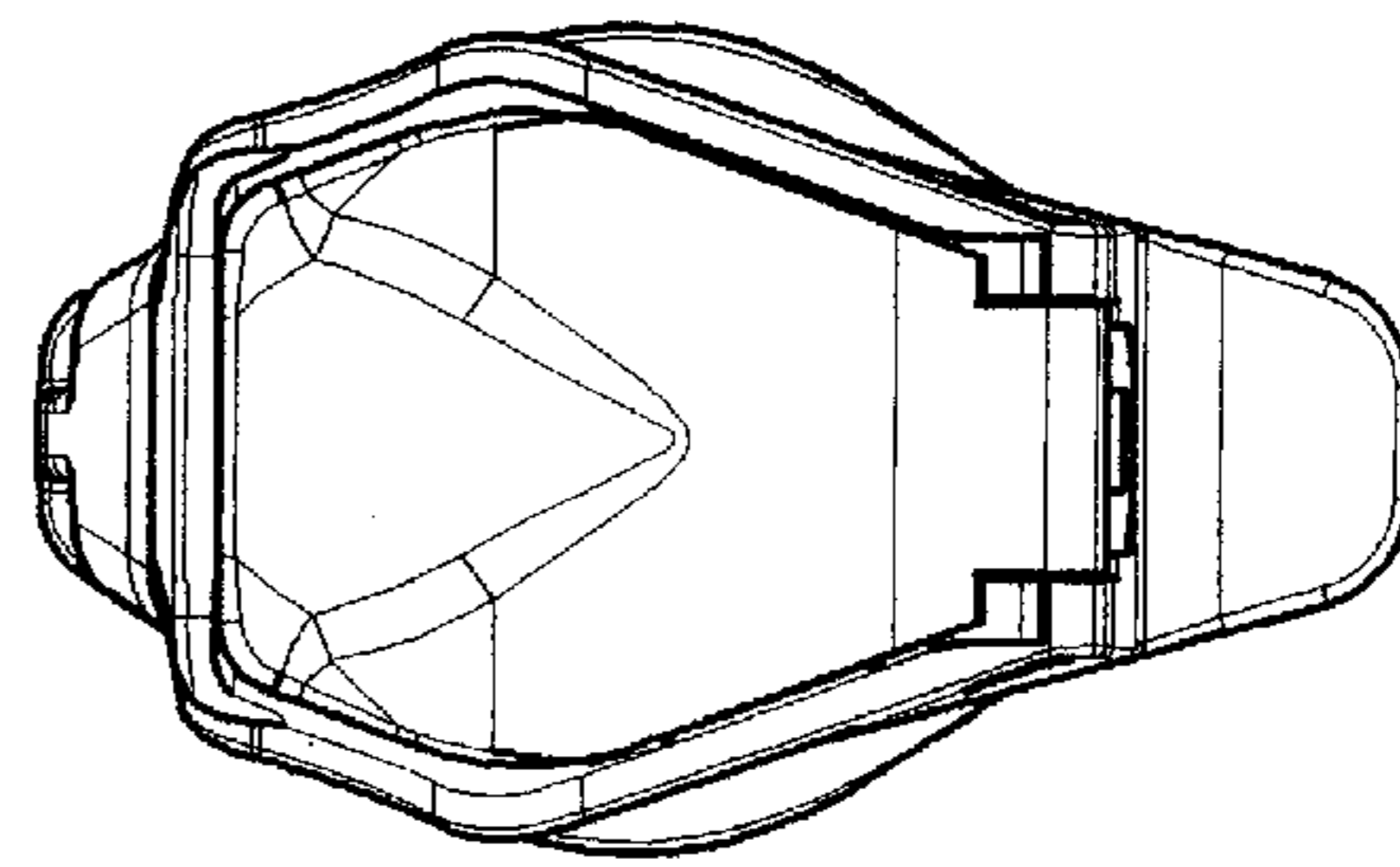

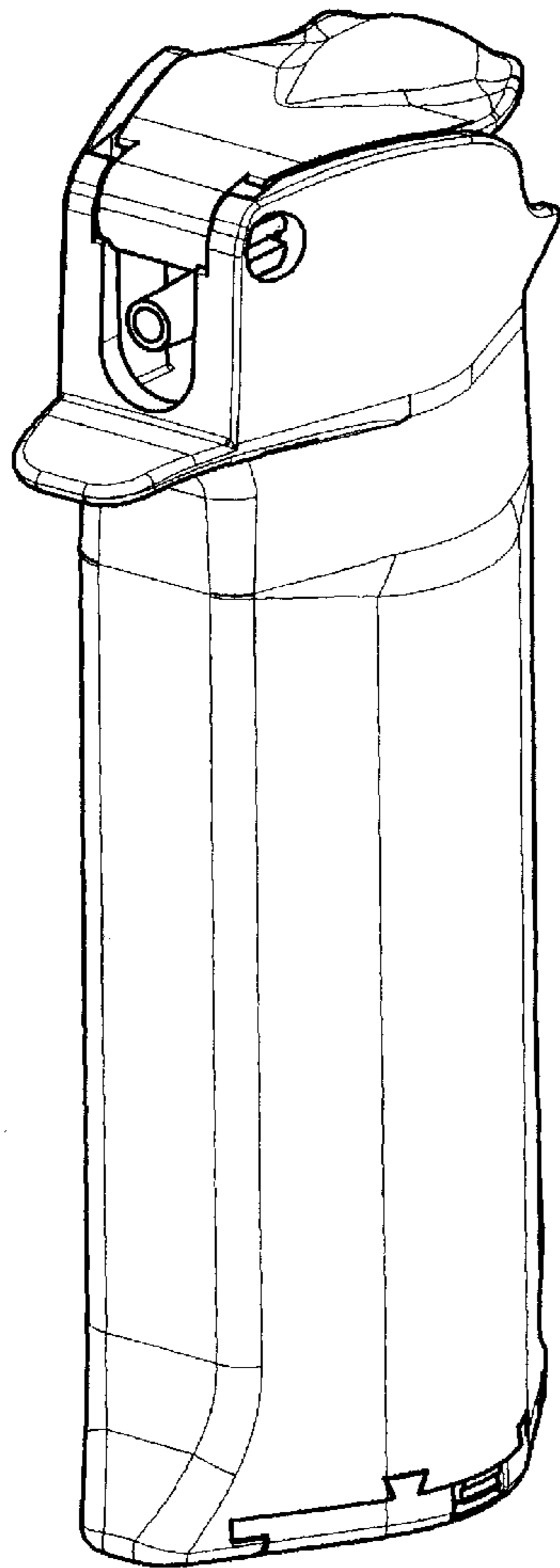

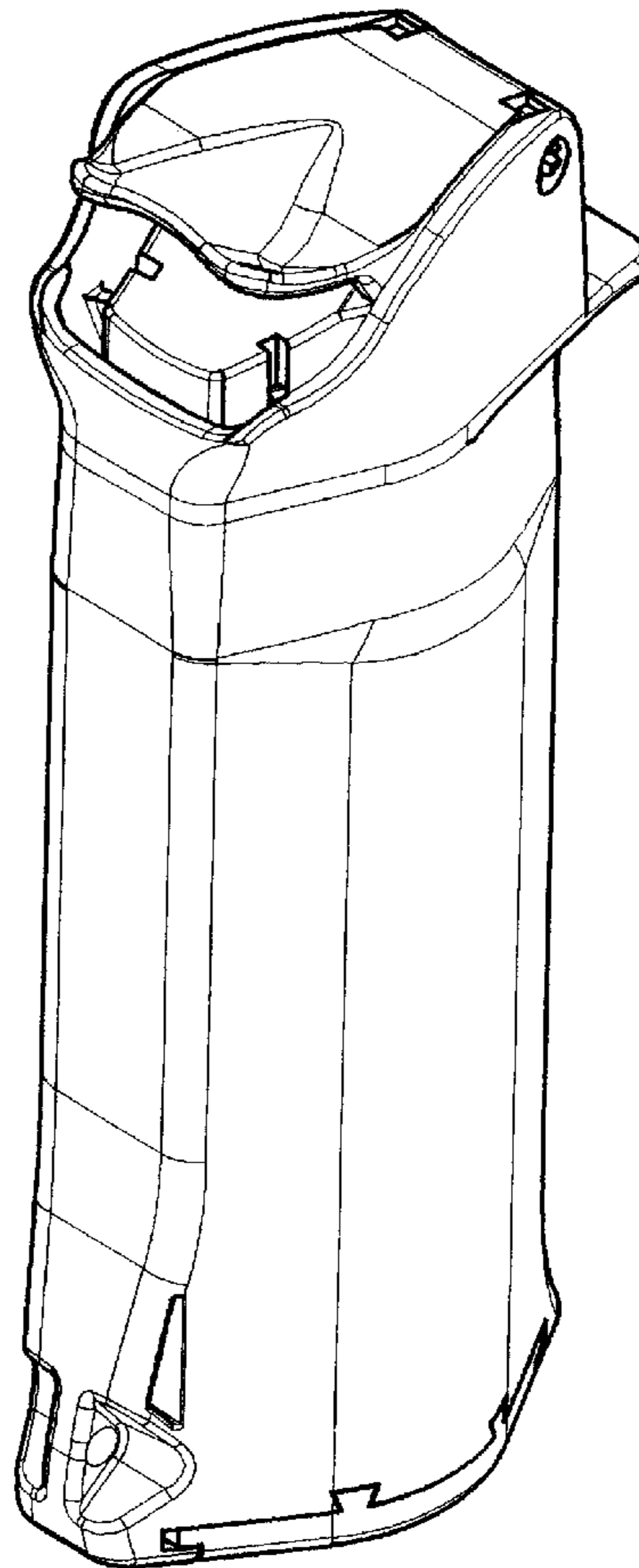

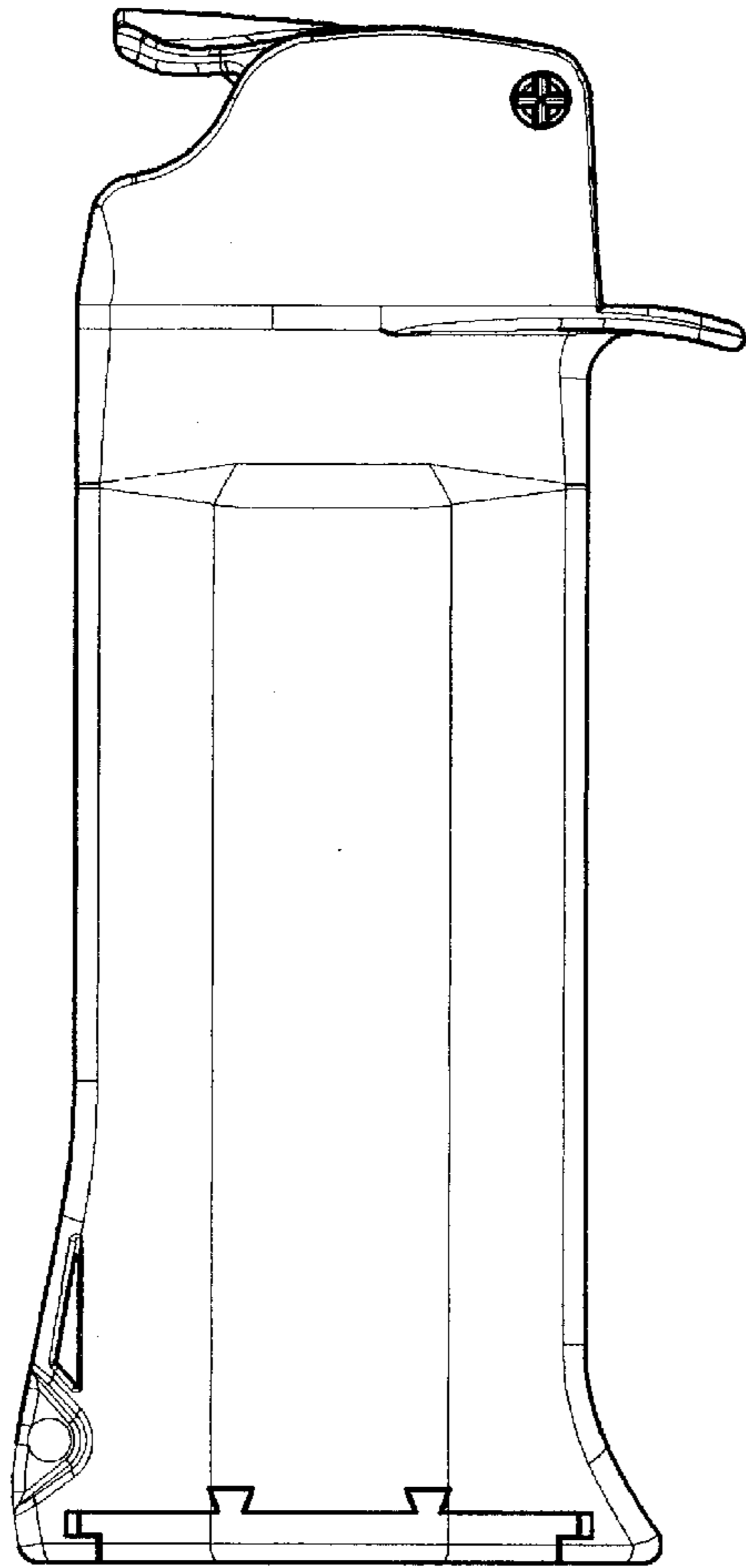

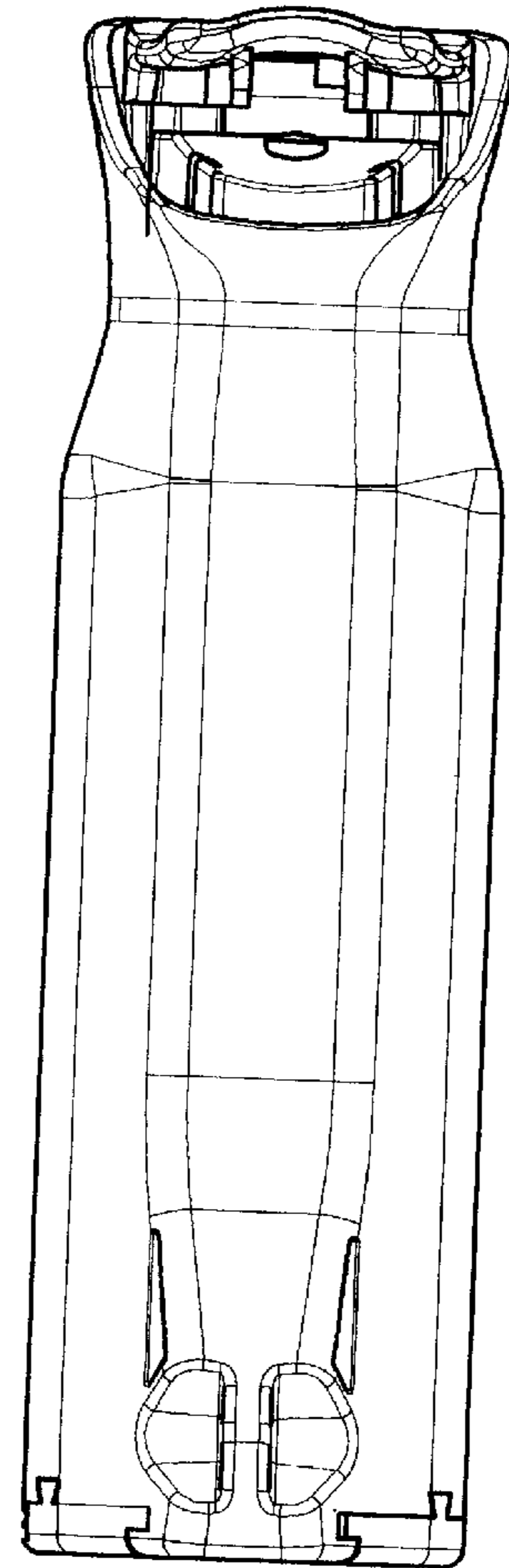
