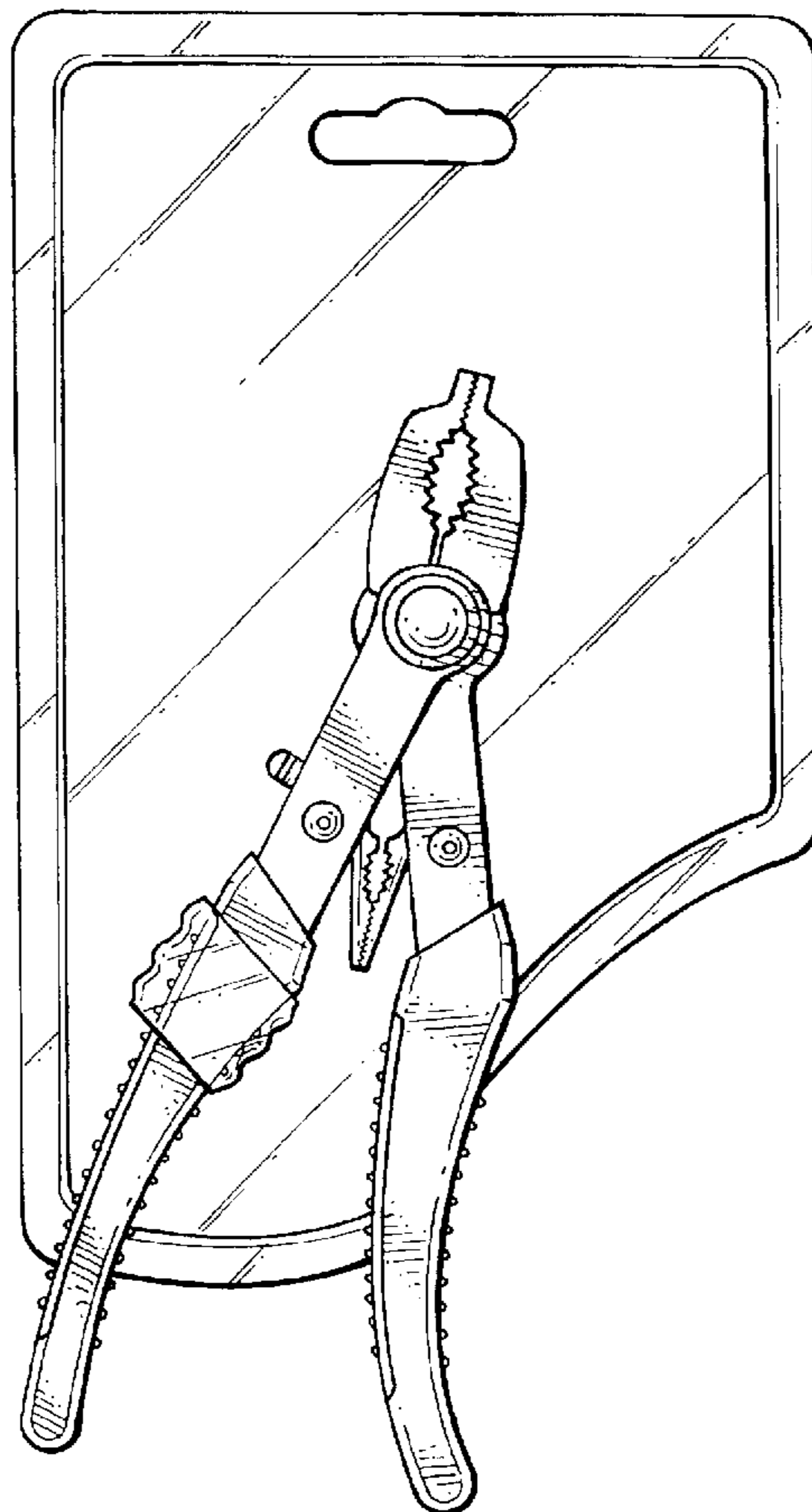

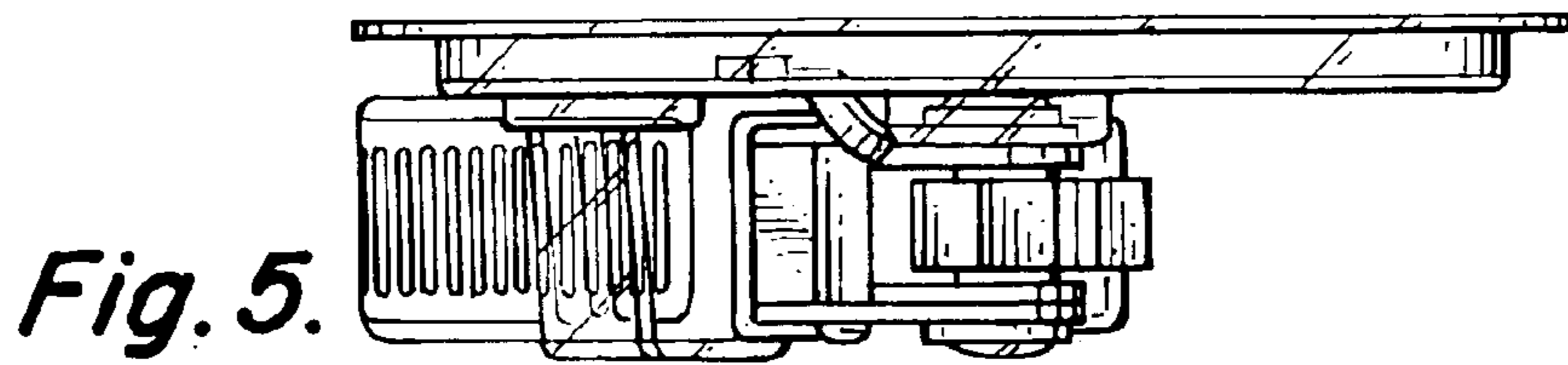
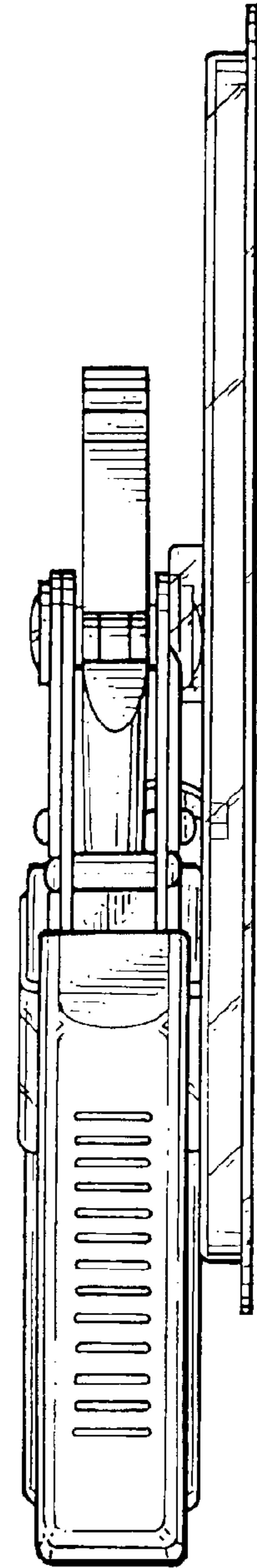
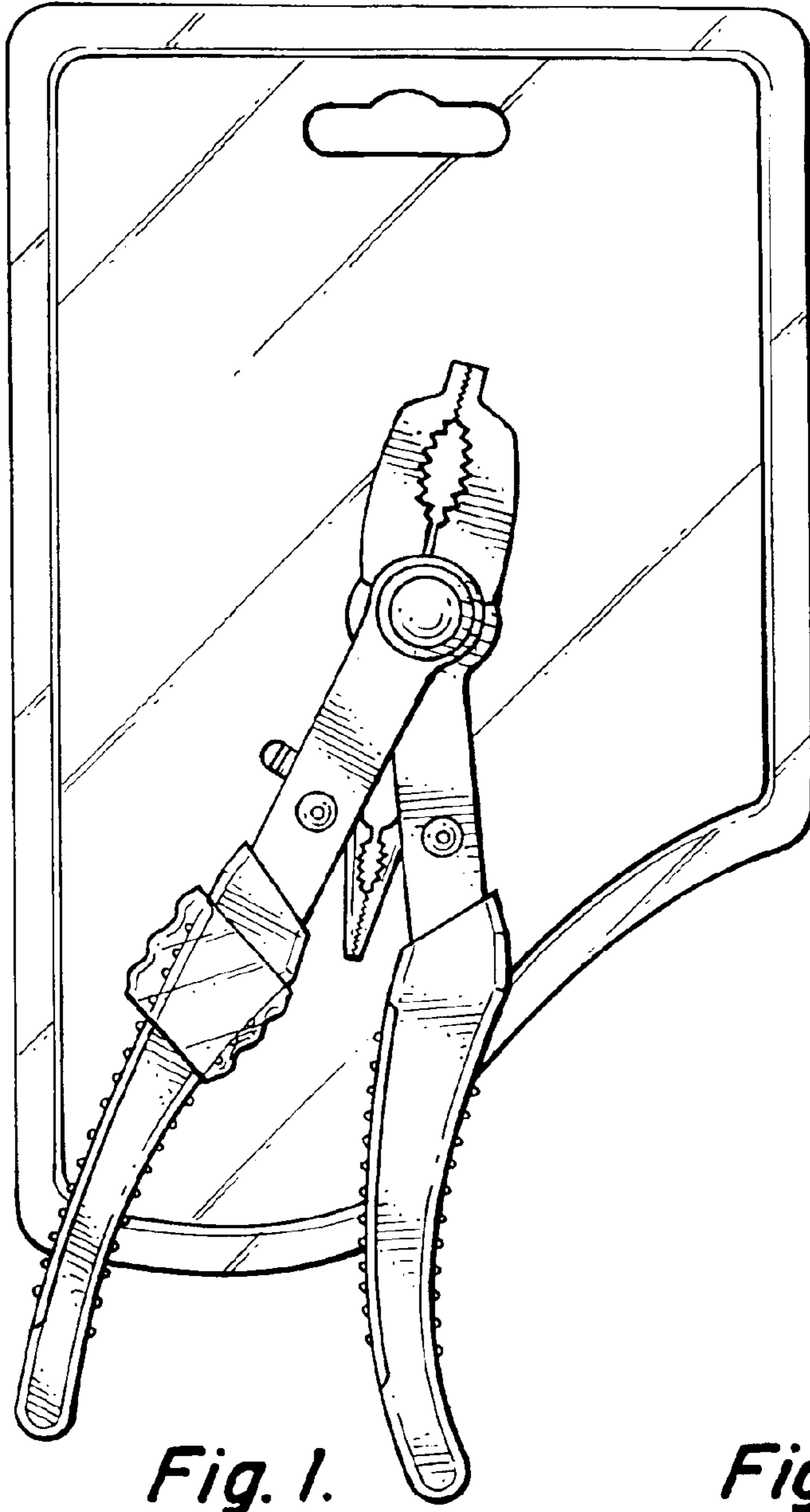
The ornamental design for pliers with display package, as shown and described.

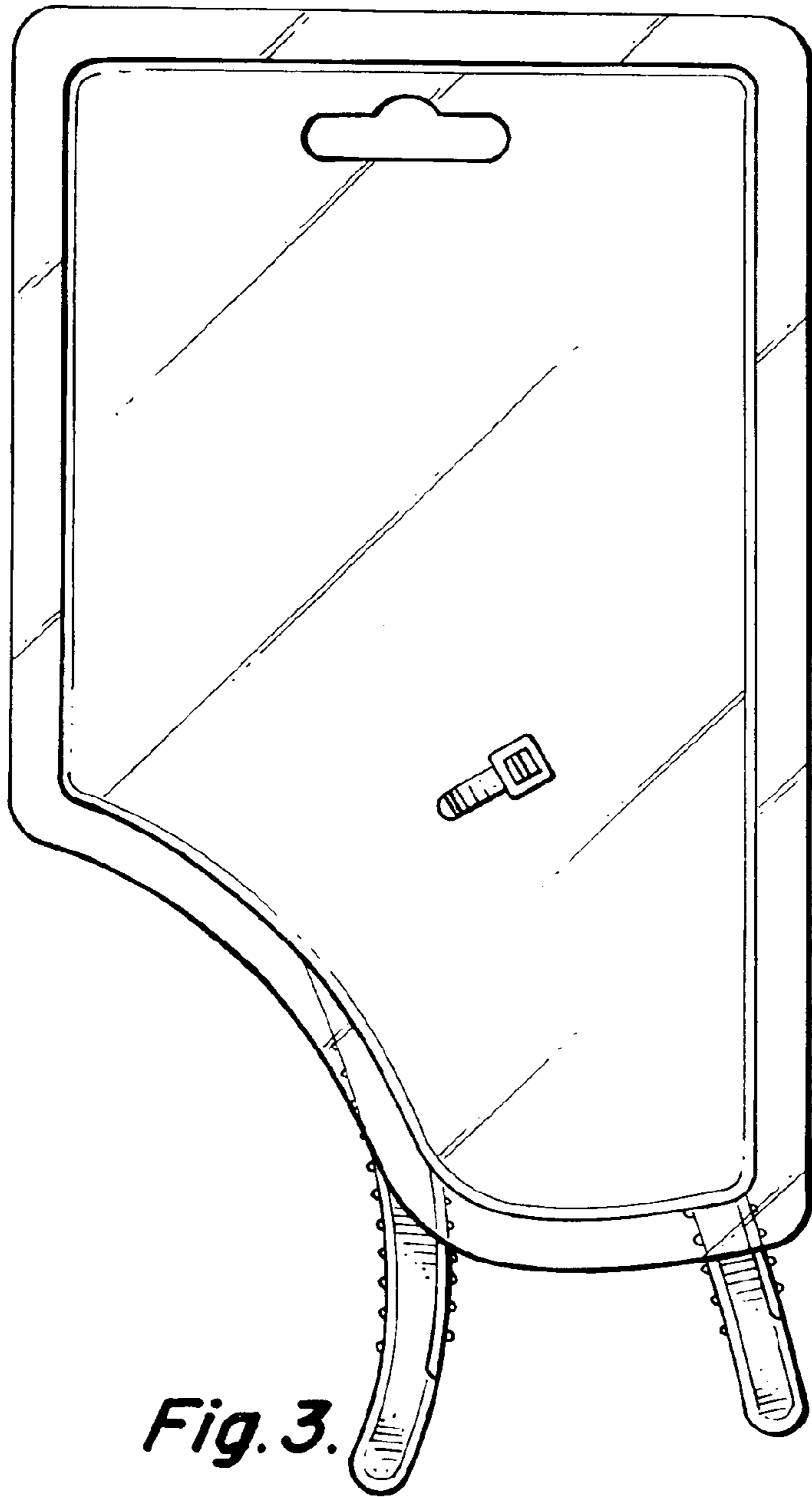
**DESCRIPTION**

 FIG. 6 is a bottom plan view thereof.

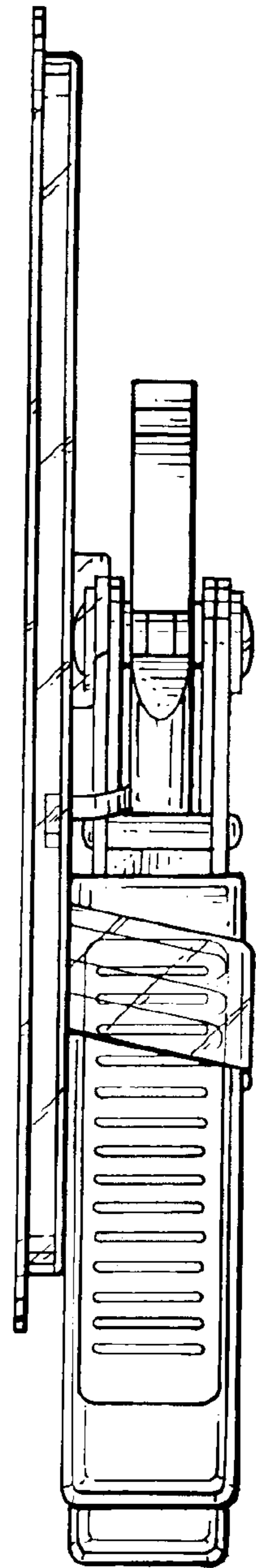

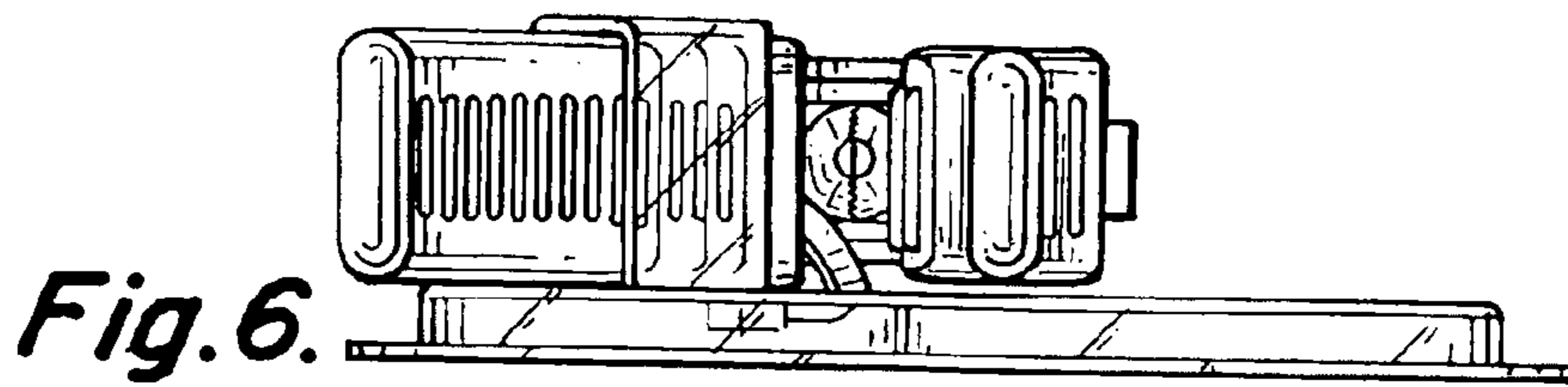
