The ornamental design for an outdoor timer, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the outdoor timer according to our design;
FIG. 2 is a rear elevation of our design shown inverted;
FIG. 3 is a top view of our design;
FIG. 4 is a right side view of our design;
FIG. 5 is a left side elevation of our design; and,
FIG. 6 is a front elevation of our design shown inverted.

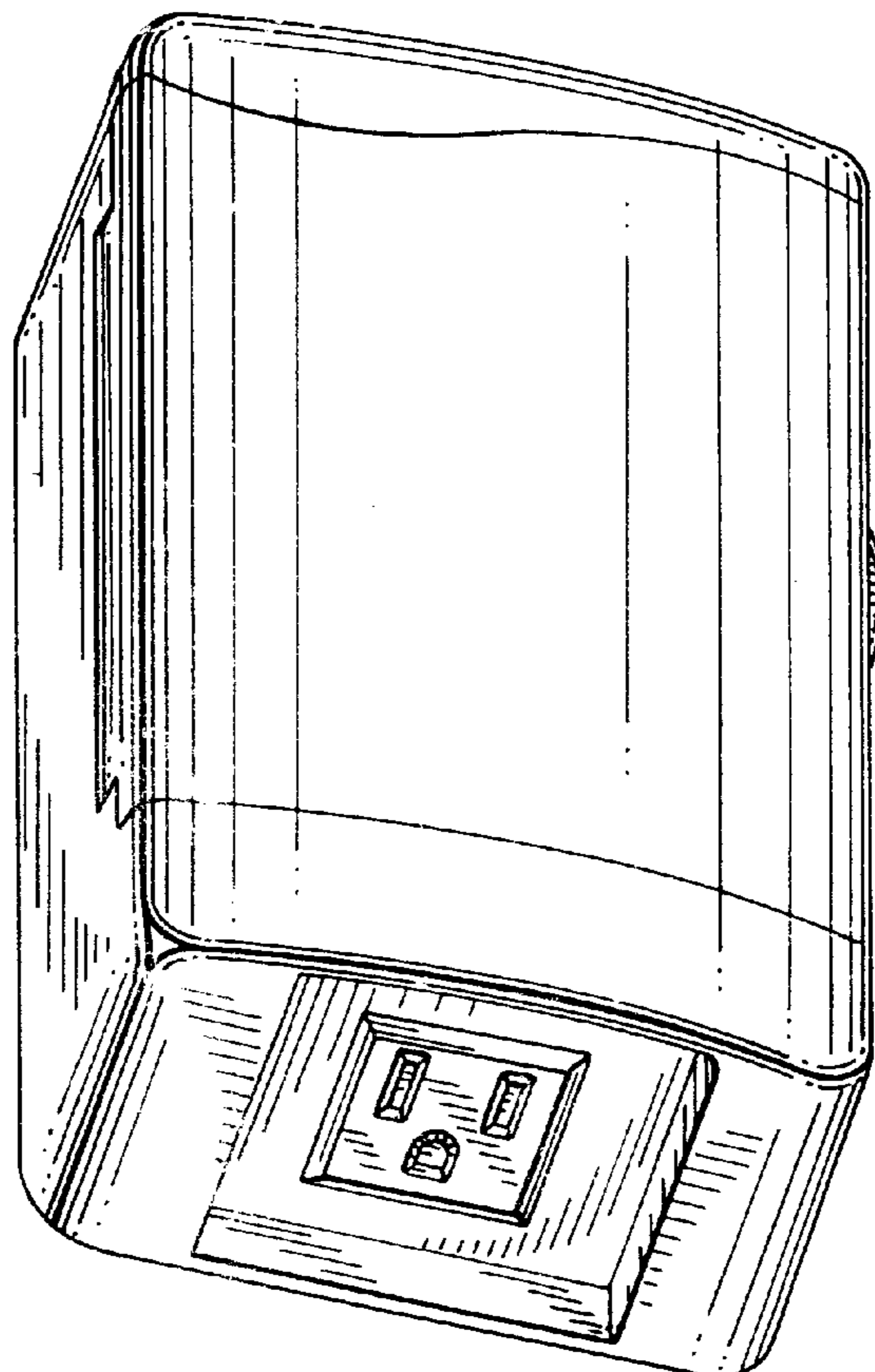

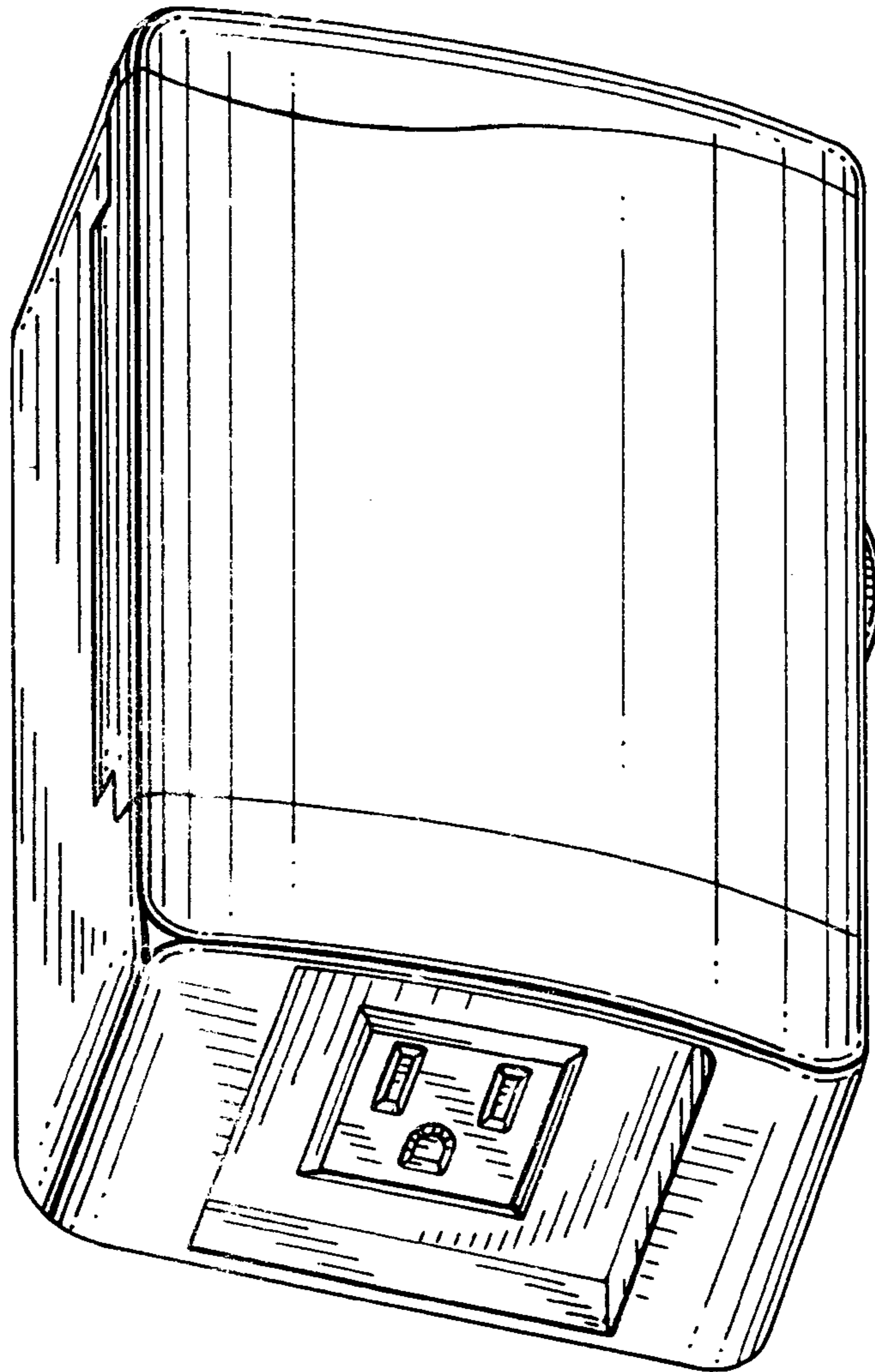

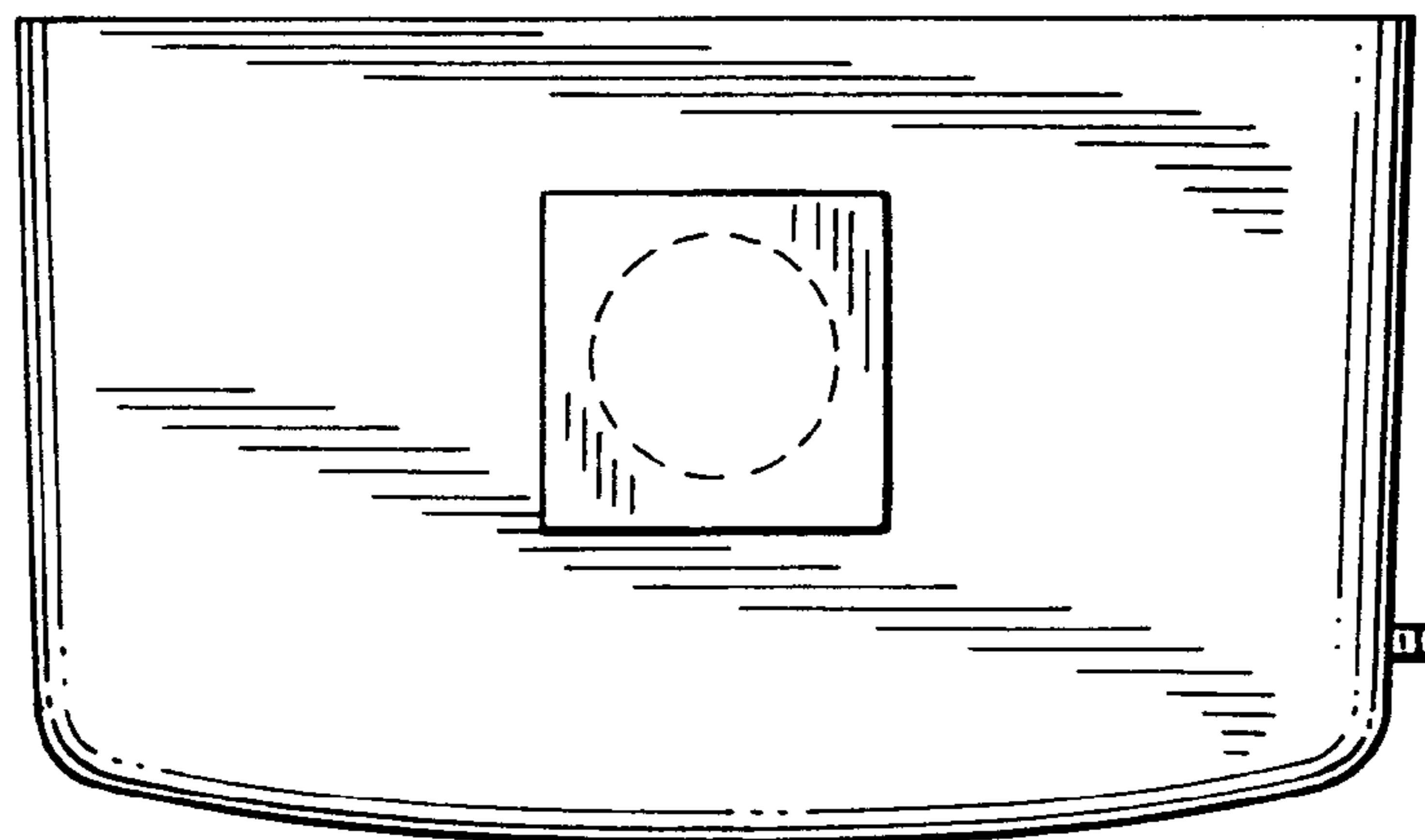

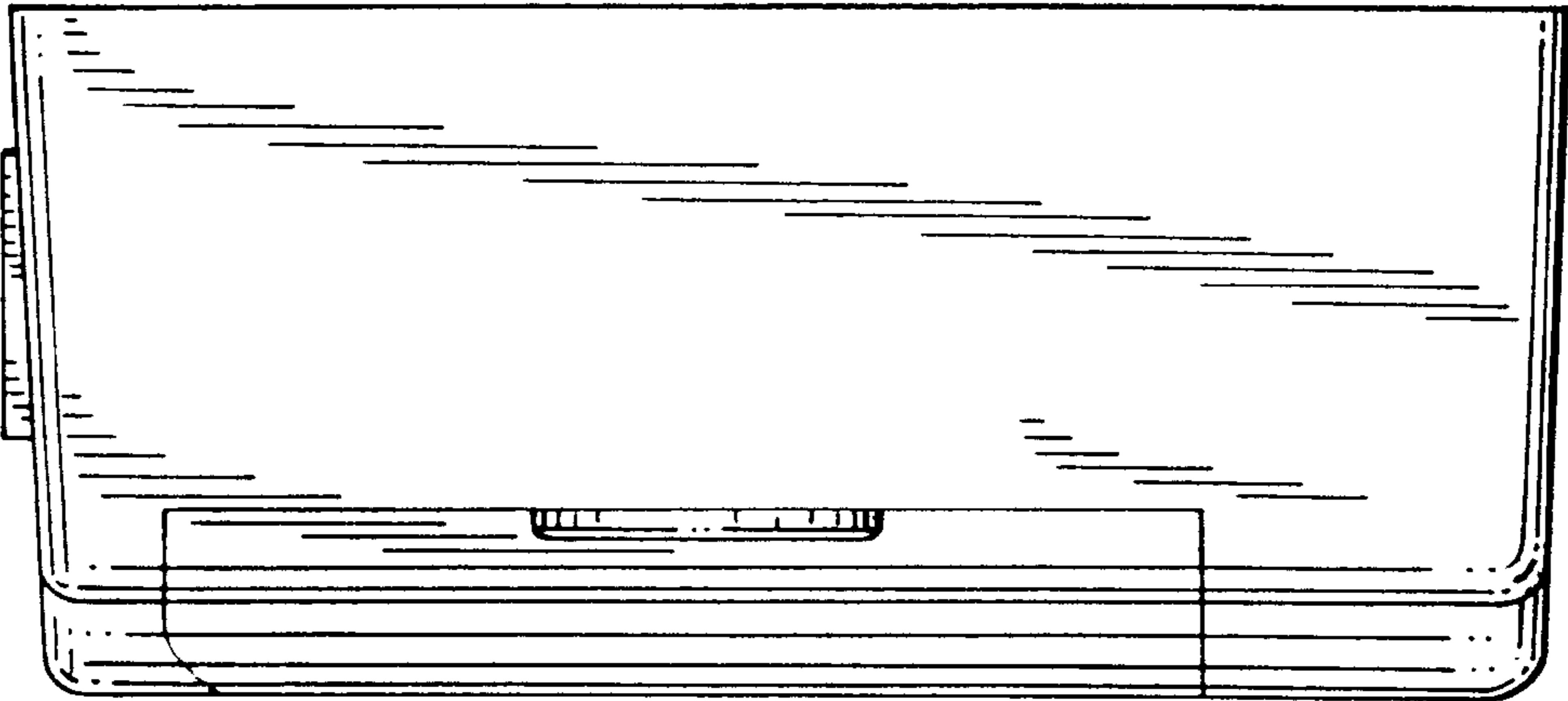

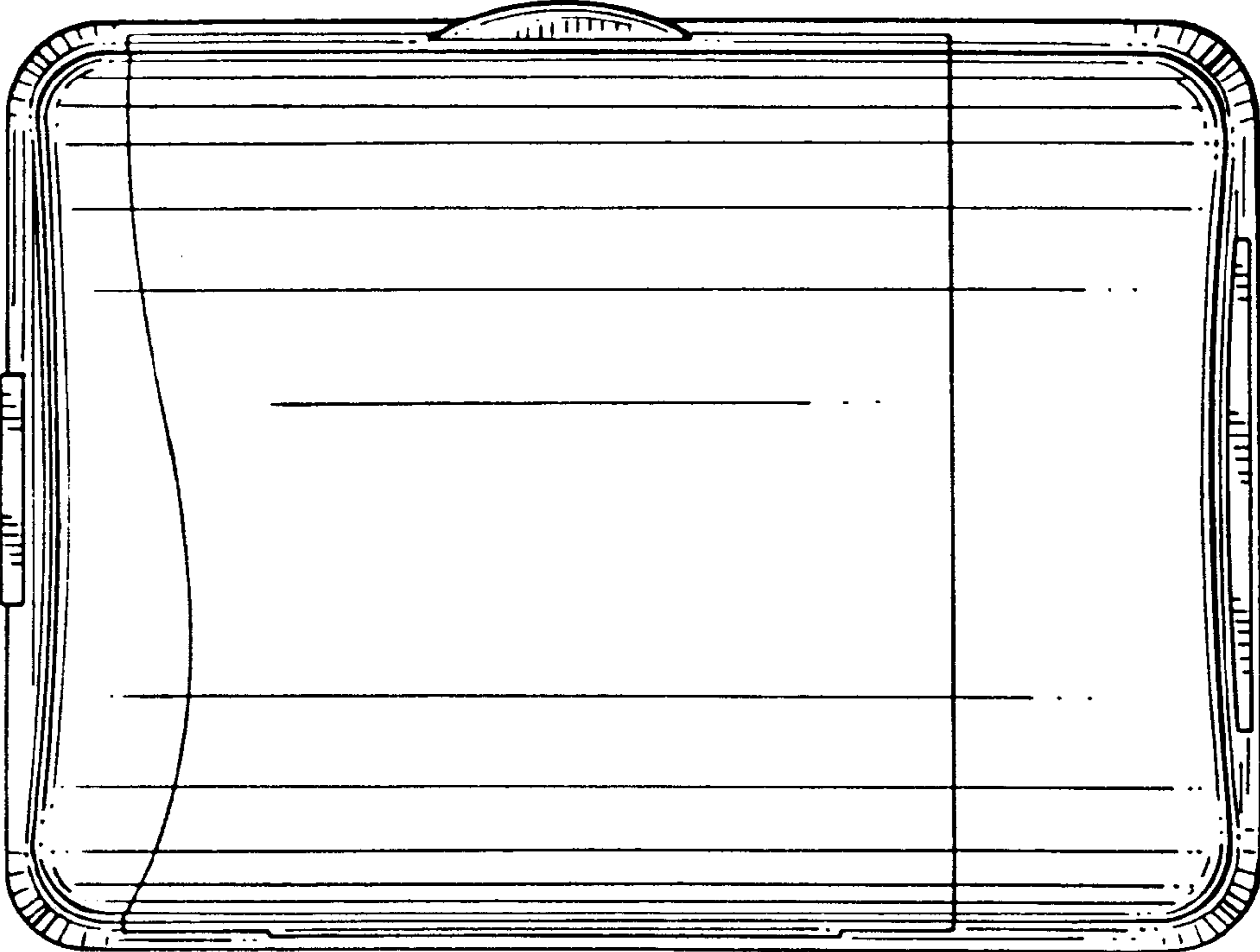

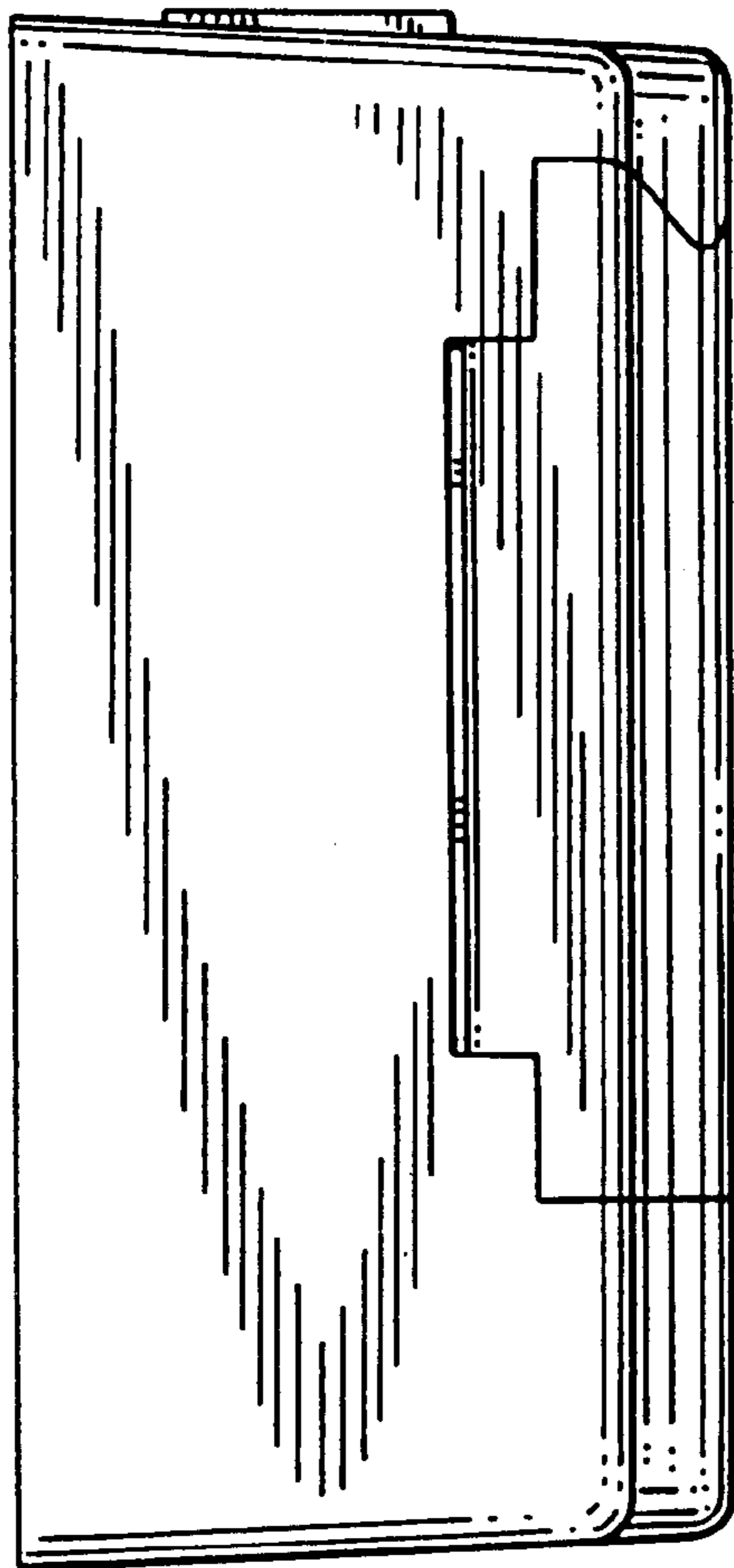
