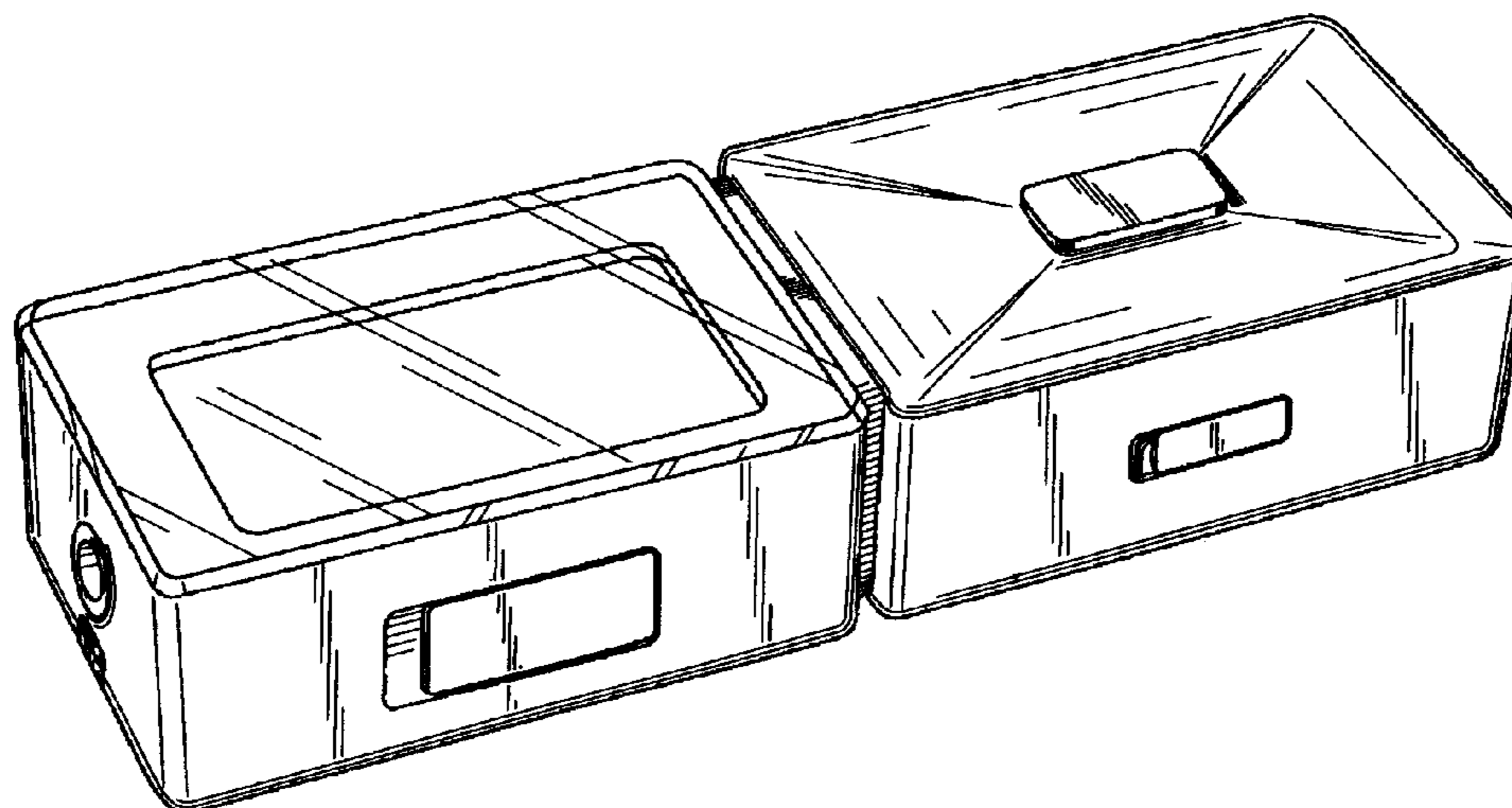
(57) **CLAIM**

I claim the ornamental design for a digital audio memory recorder, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a digital audio memory recorder of the present invention;

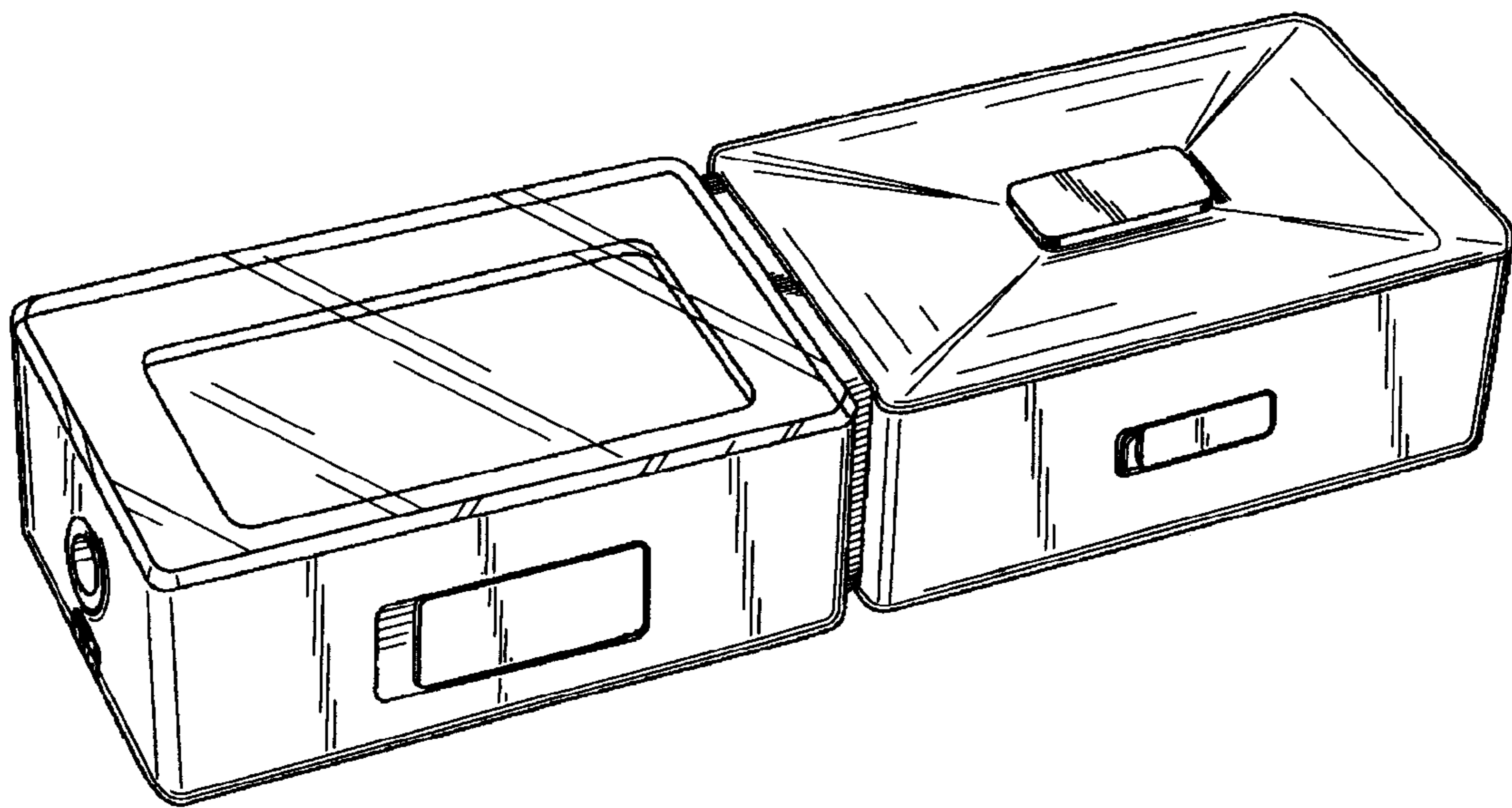

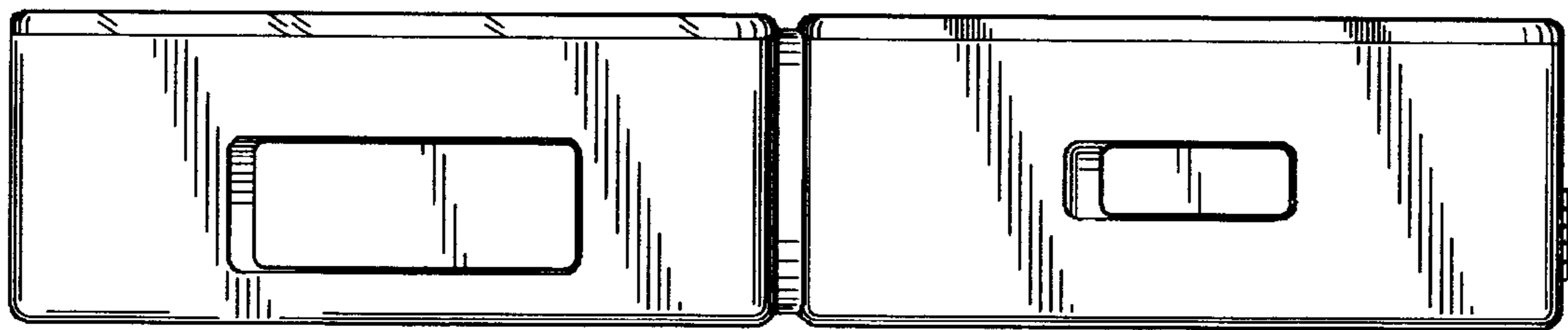
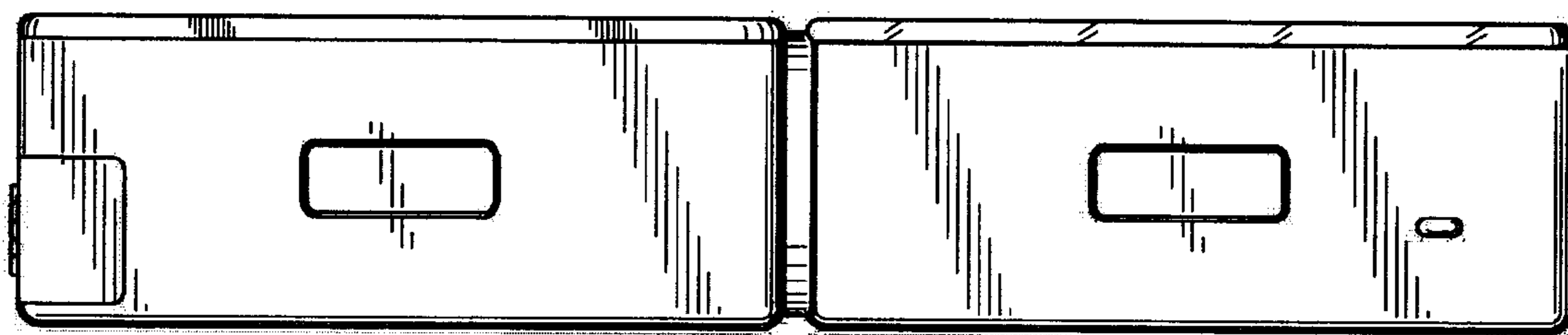
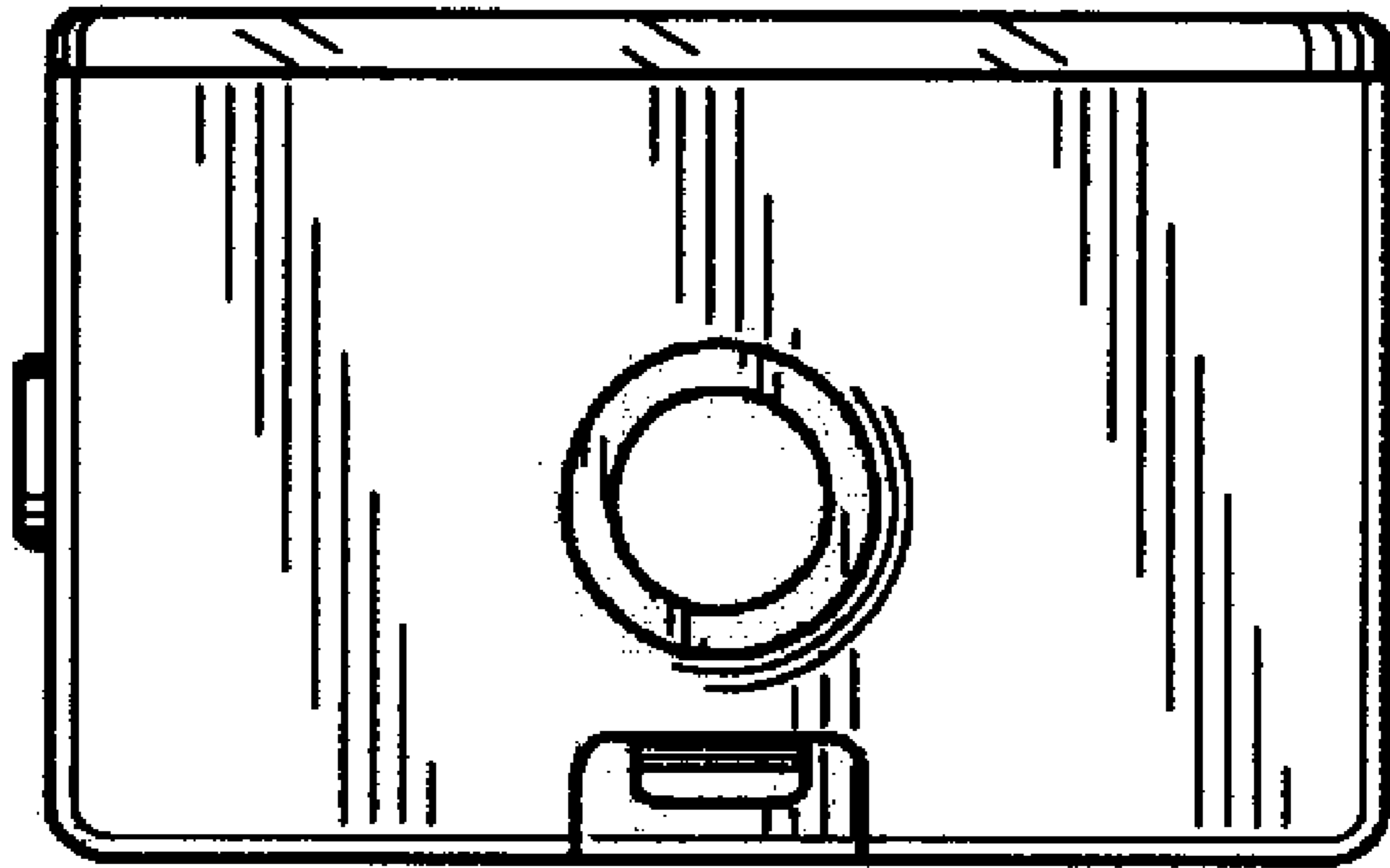


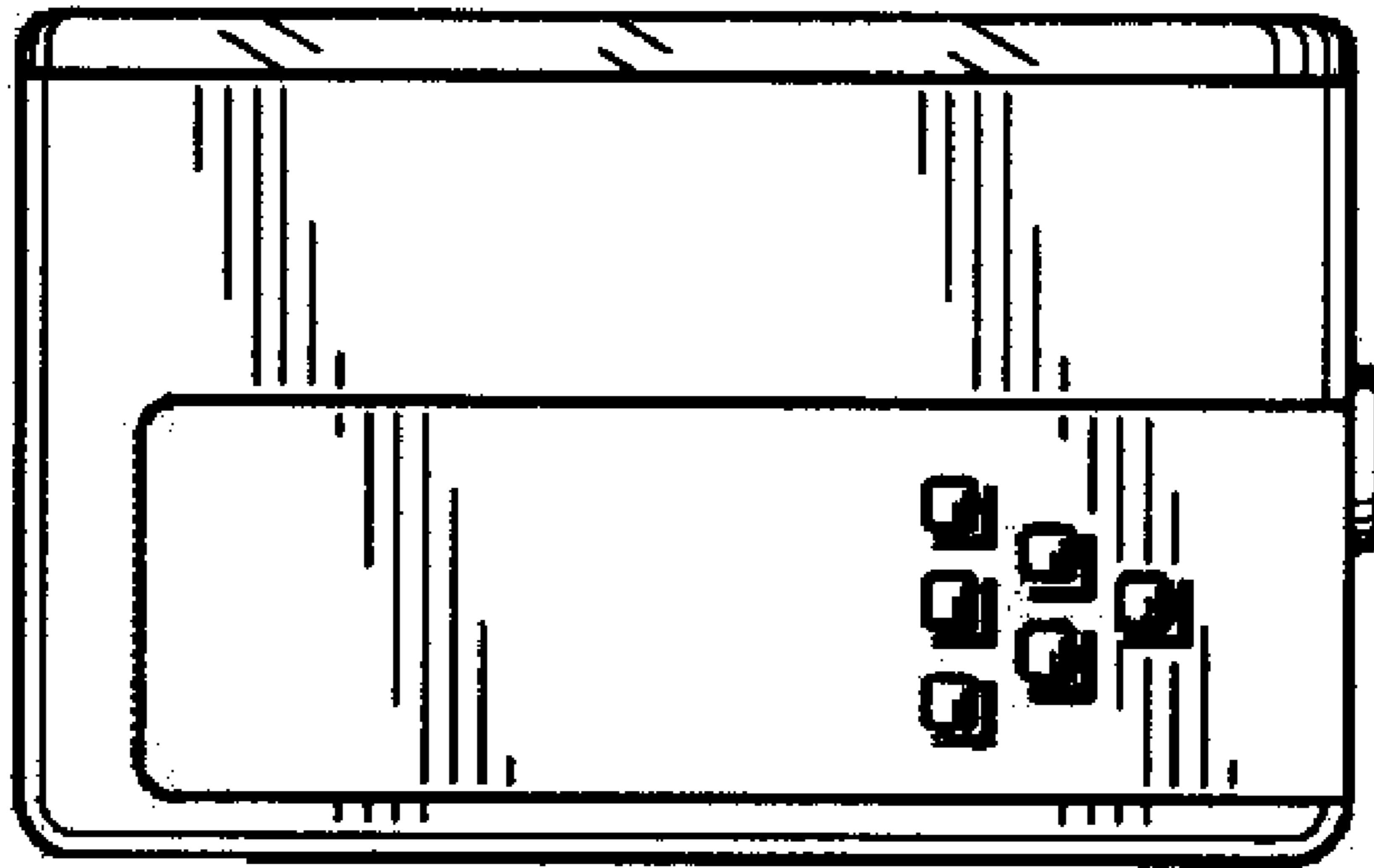

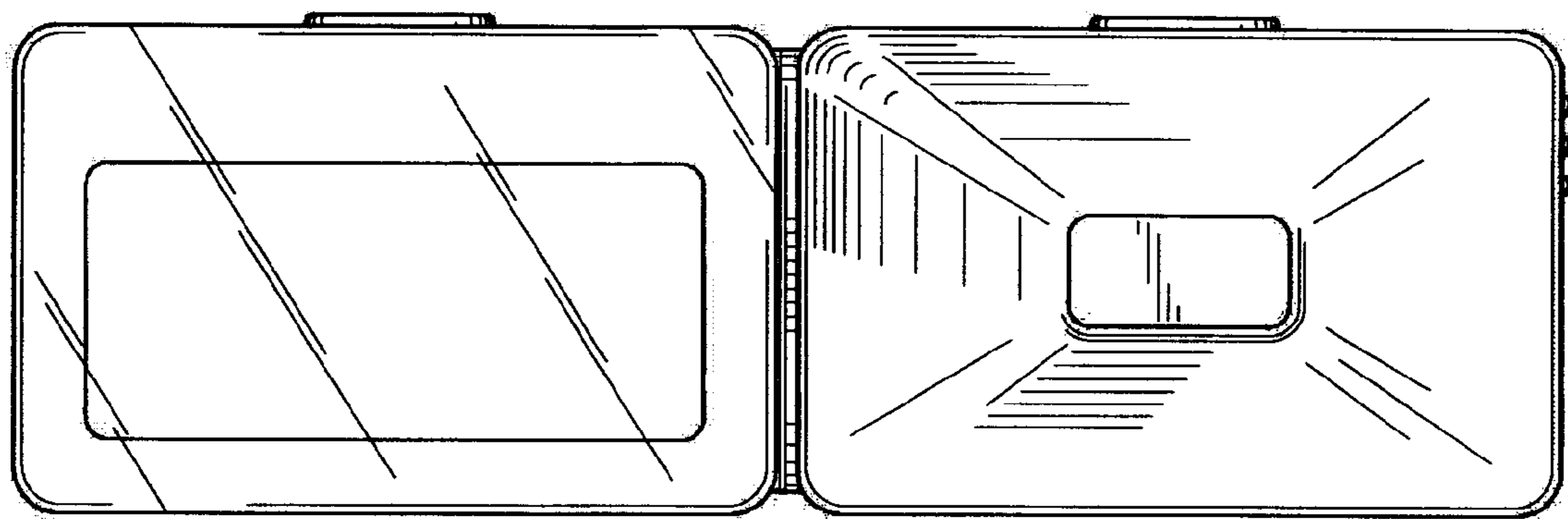
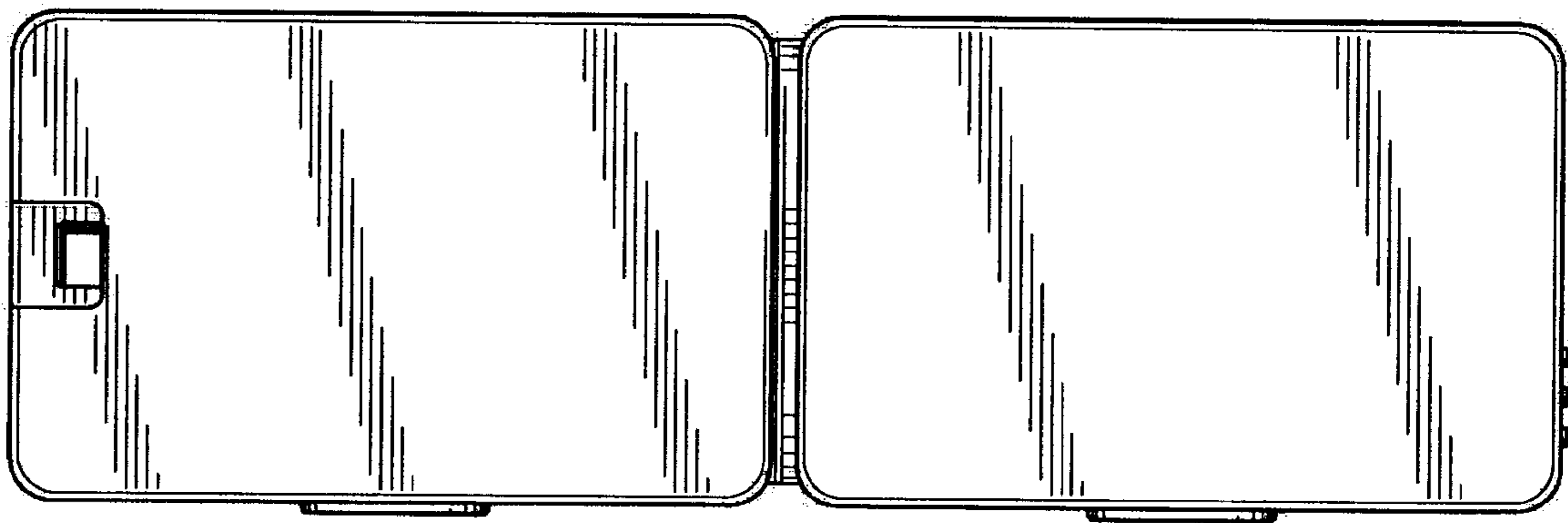
