(57) **CLAIM**

The ornamental design for a planner jacket, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a planner jacket showing our new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

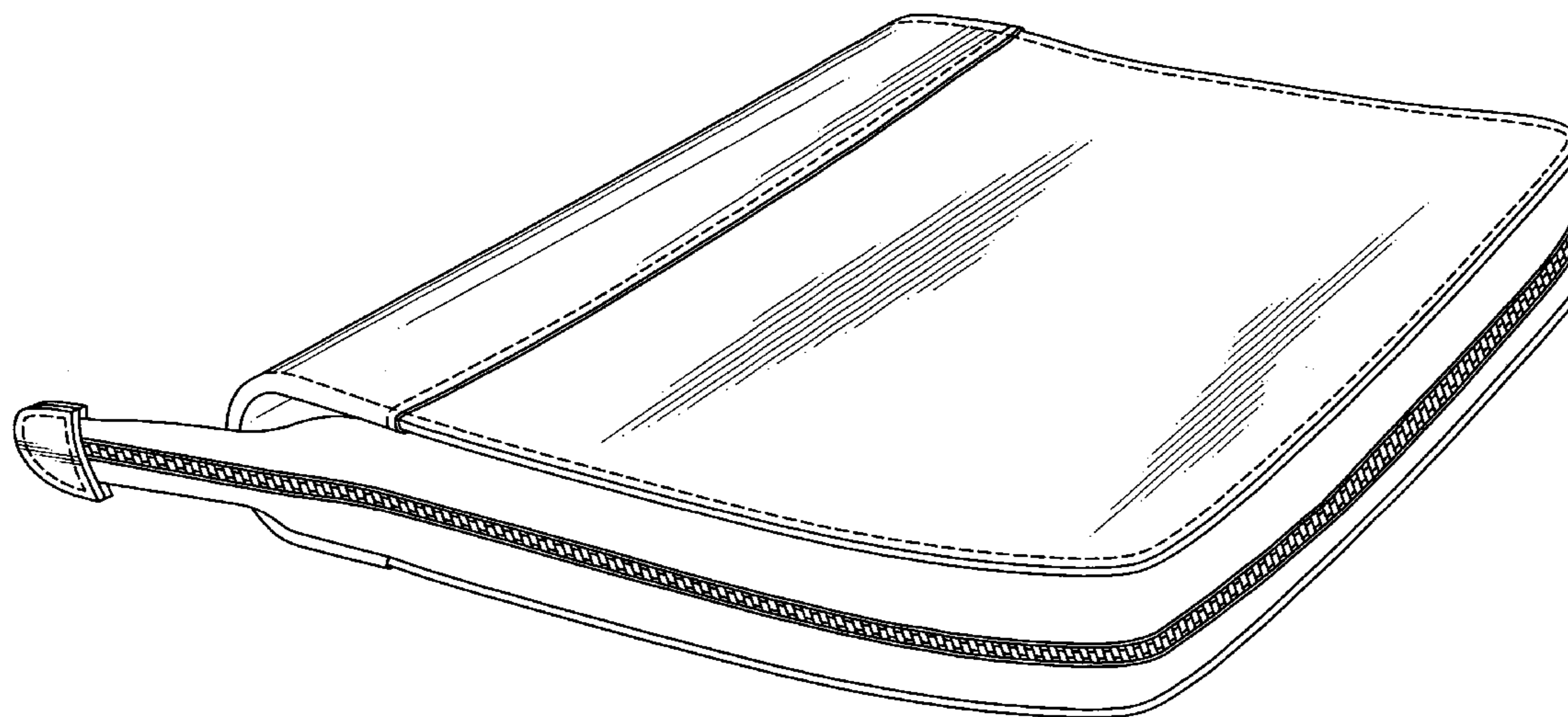
FIG. 7 is an elevation view of the interior of the planner jacket;

FIG. 8 is a perspective view of the planner jacket; and,

FIG. 9 is a perspective view showing the form of the planner jacket when it is filled with contents.

The broken lines shown on the planner jacket represent stitching.

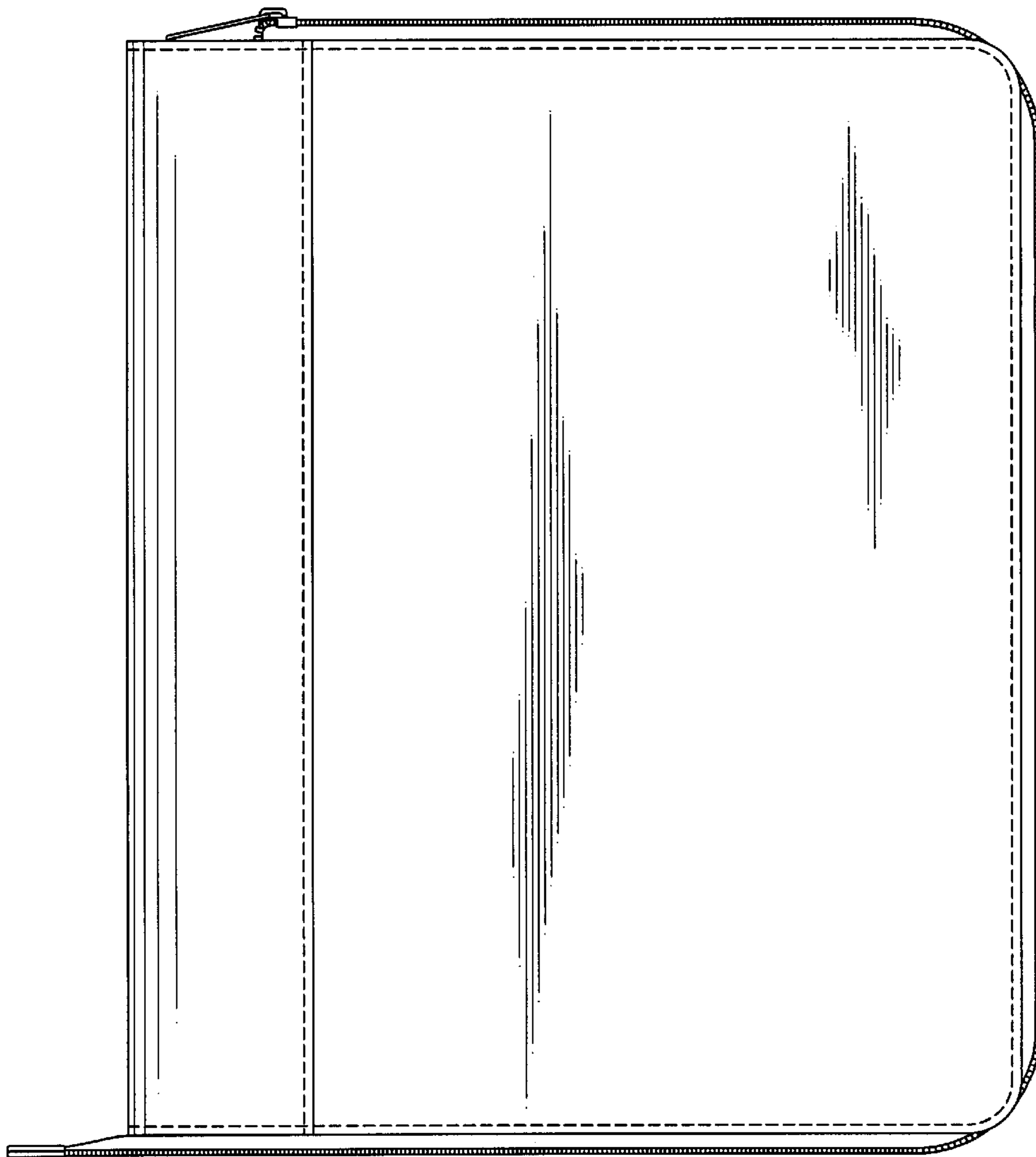

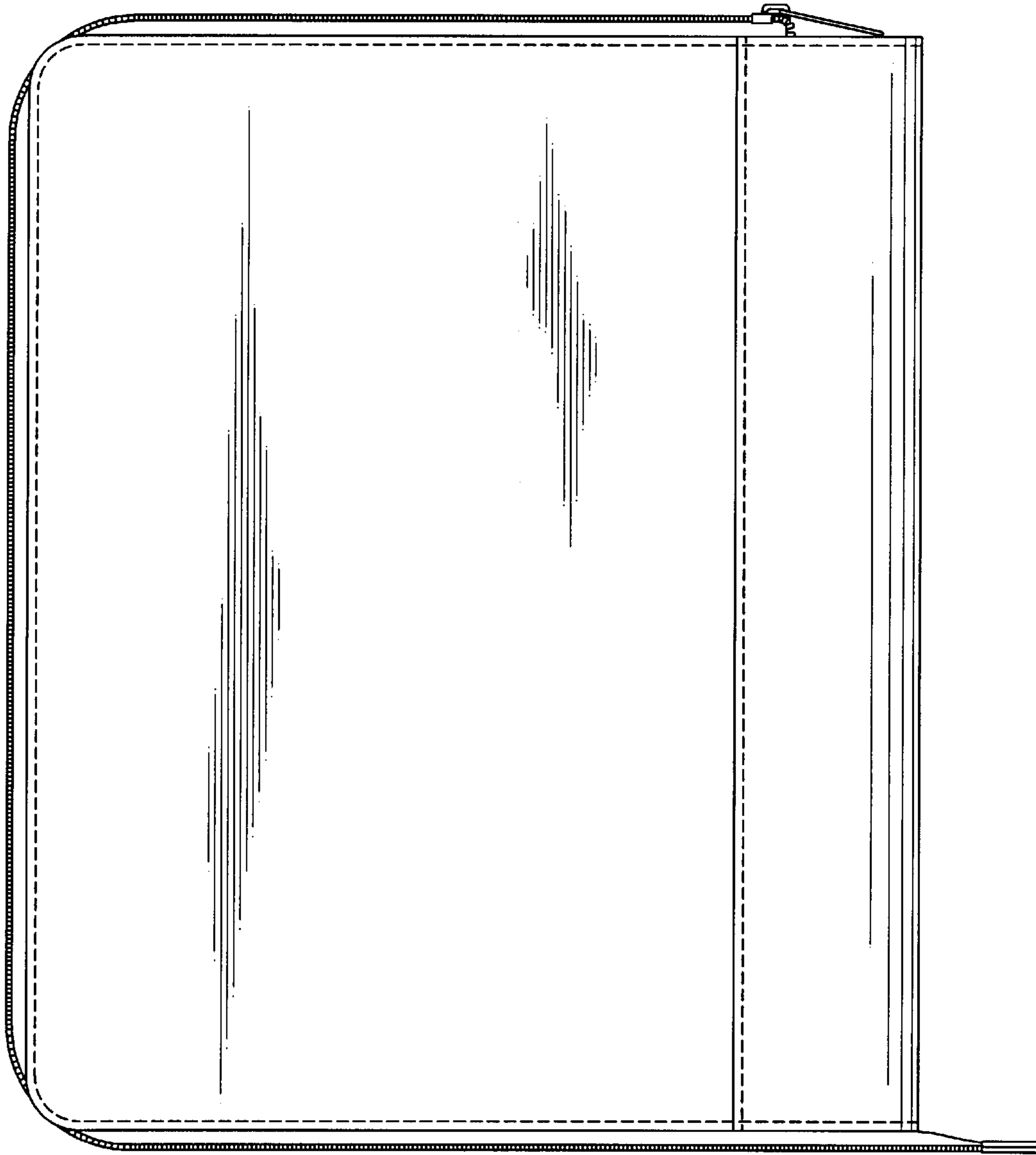

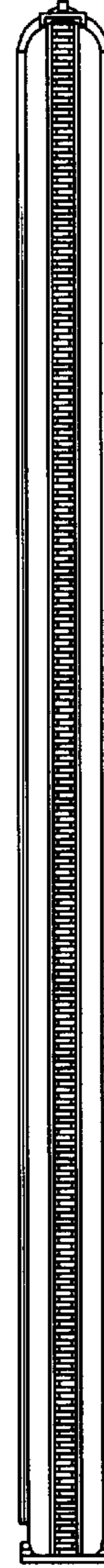

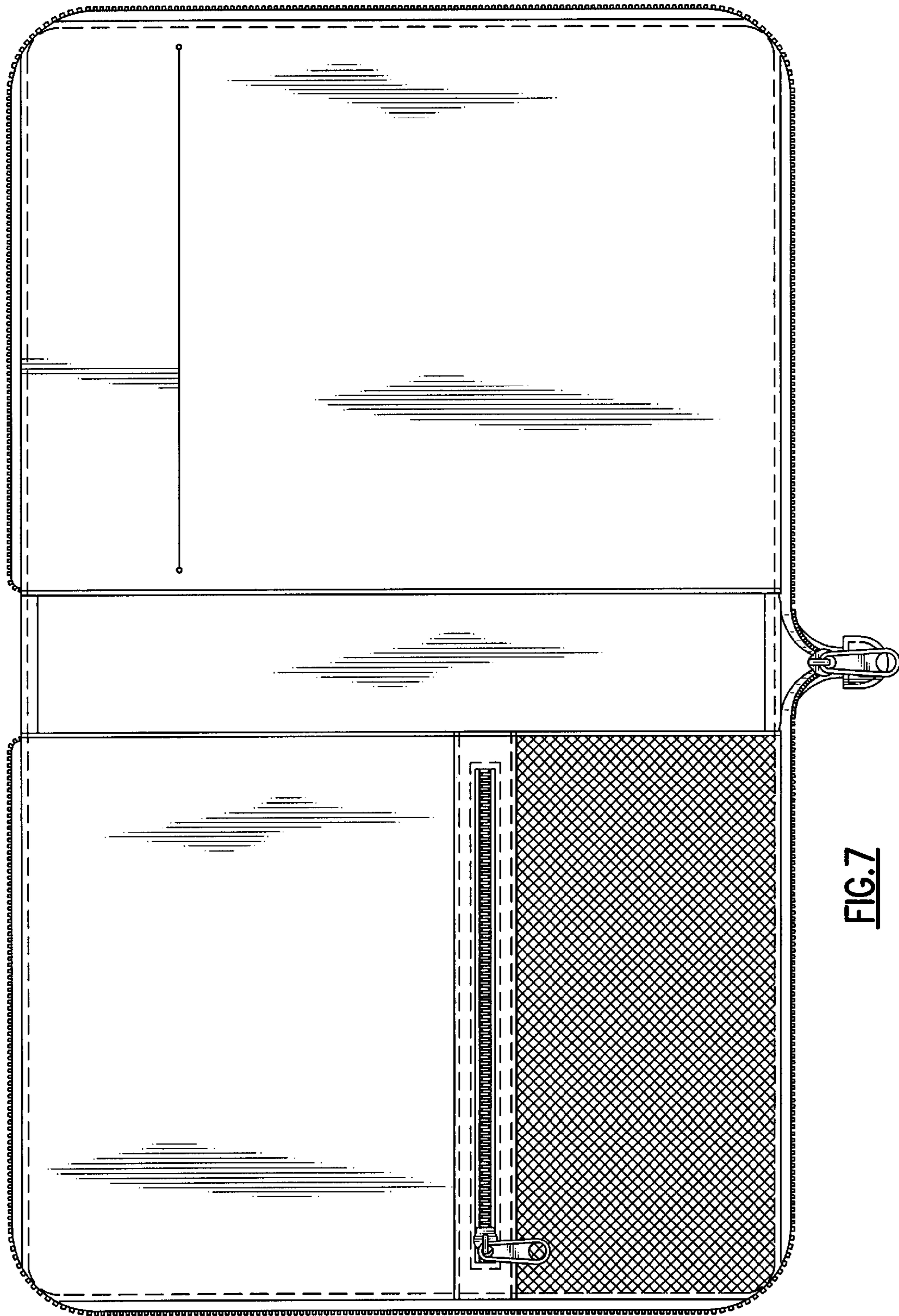

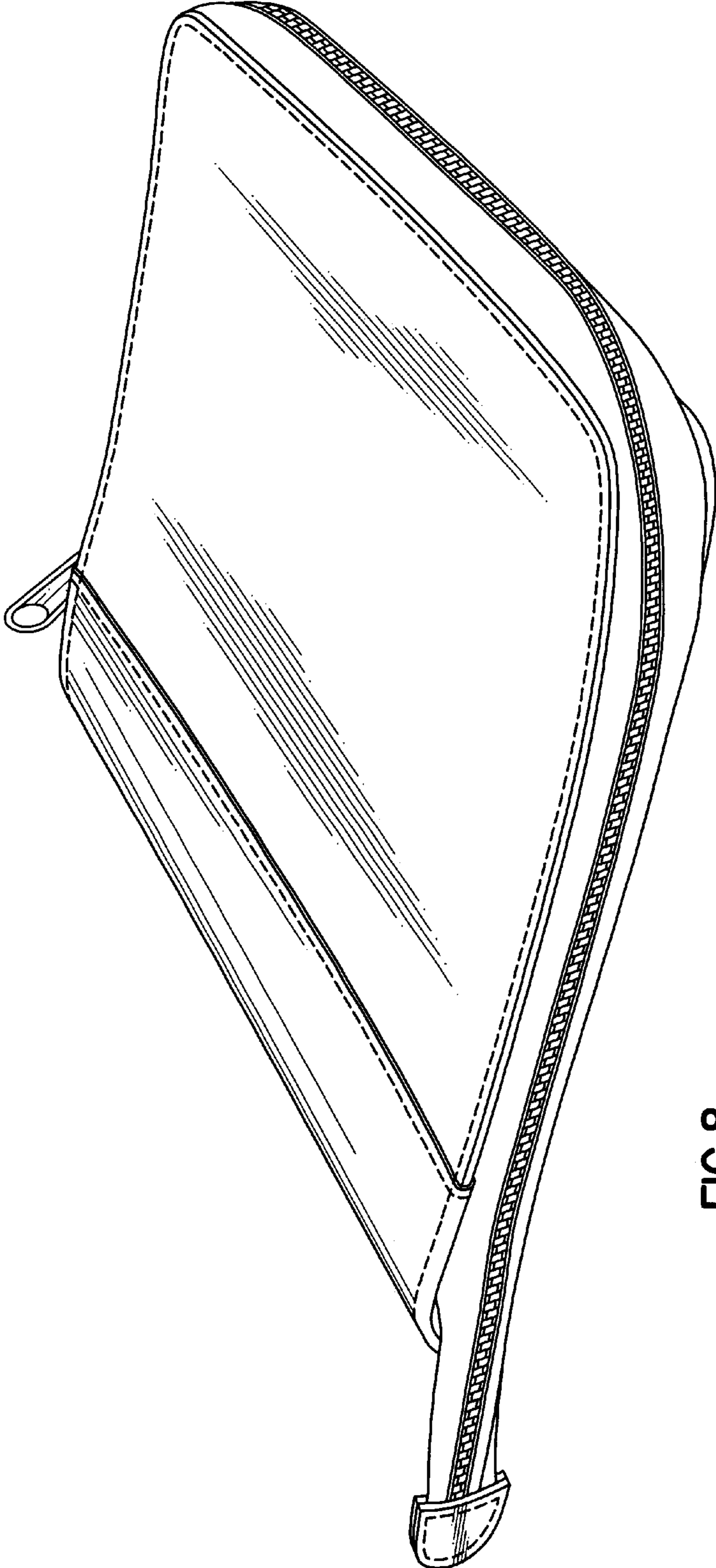

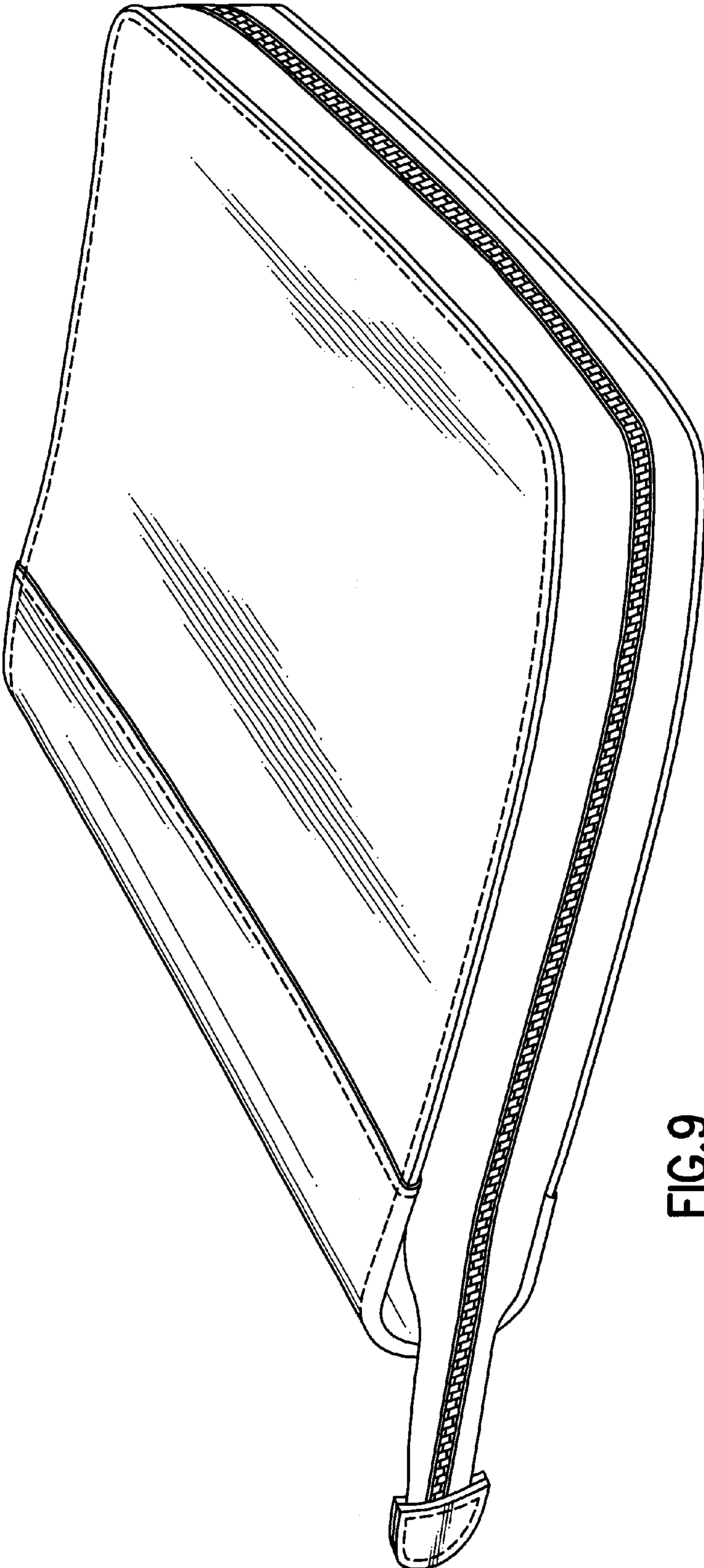
