(57) **CLAIM**

We claim the ornamental design for a "handle for a gaming machine," as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a handle for a gaming machine showing our new design.

FIG. 4 is a rear elevational view thereof.

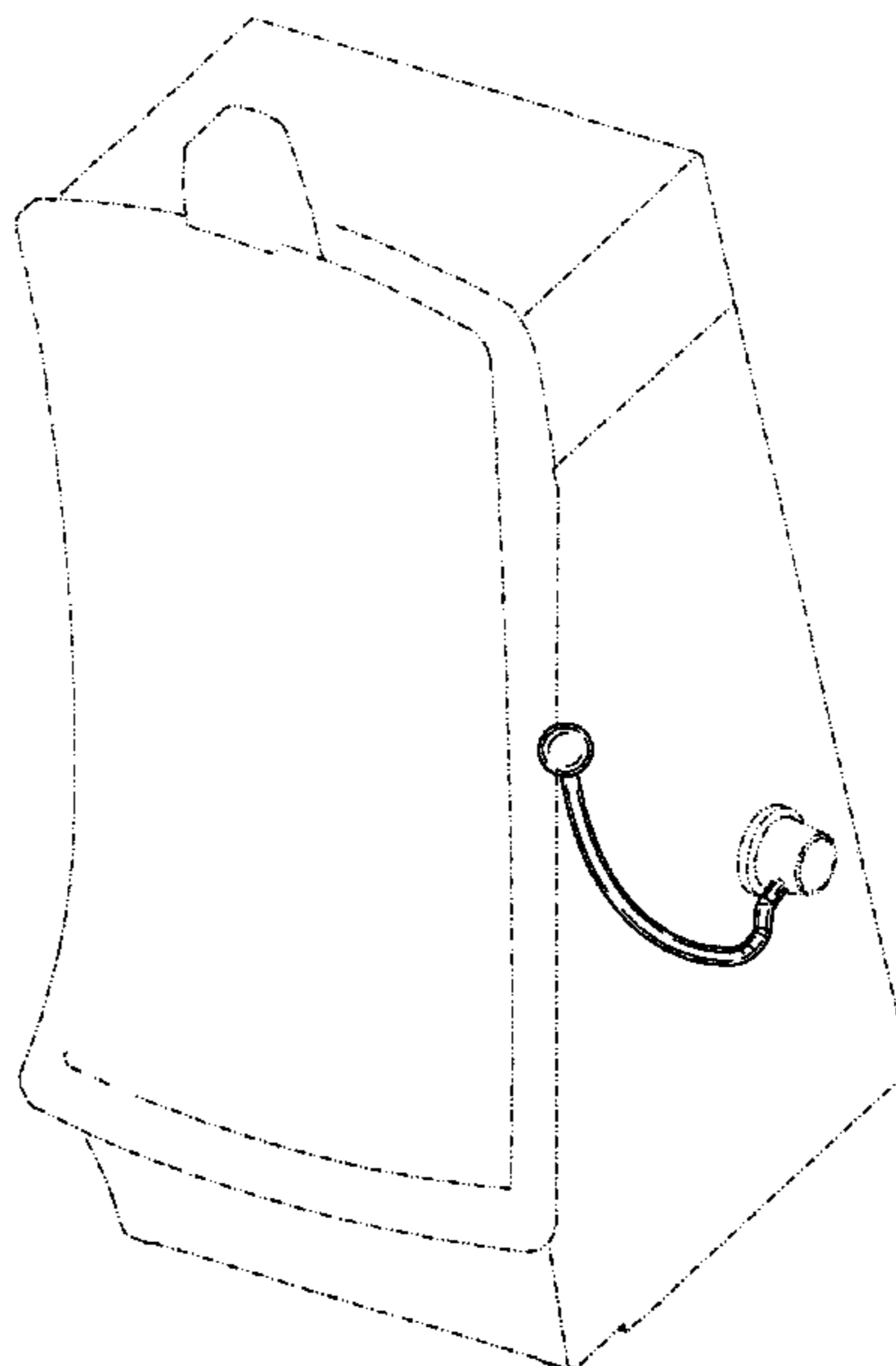
FIG. 5 is a top plan view thereof.

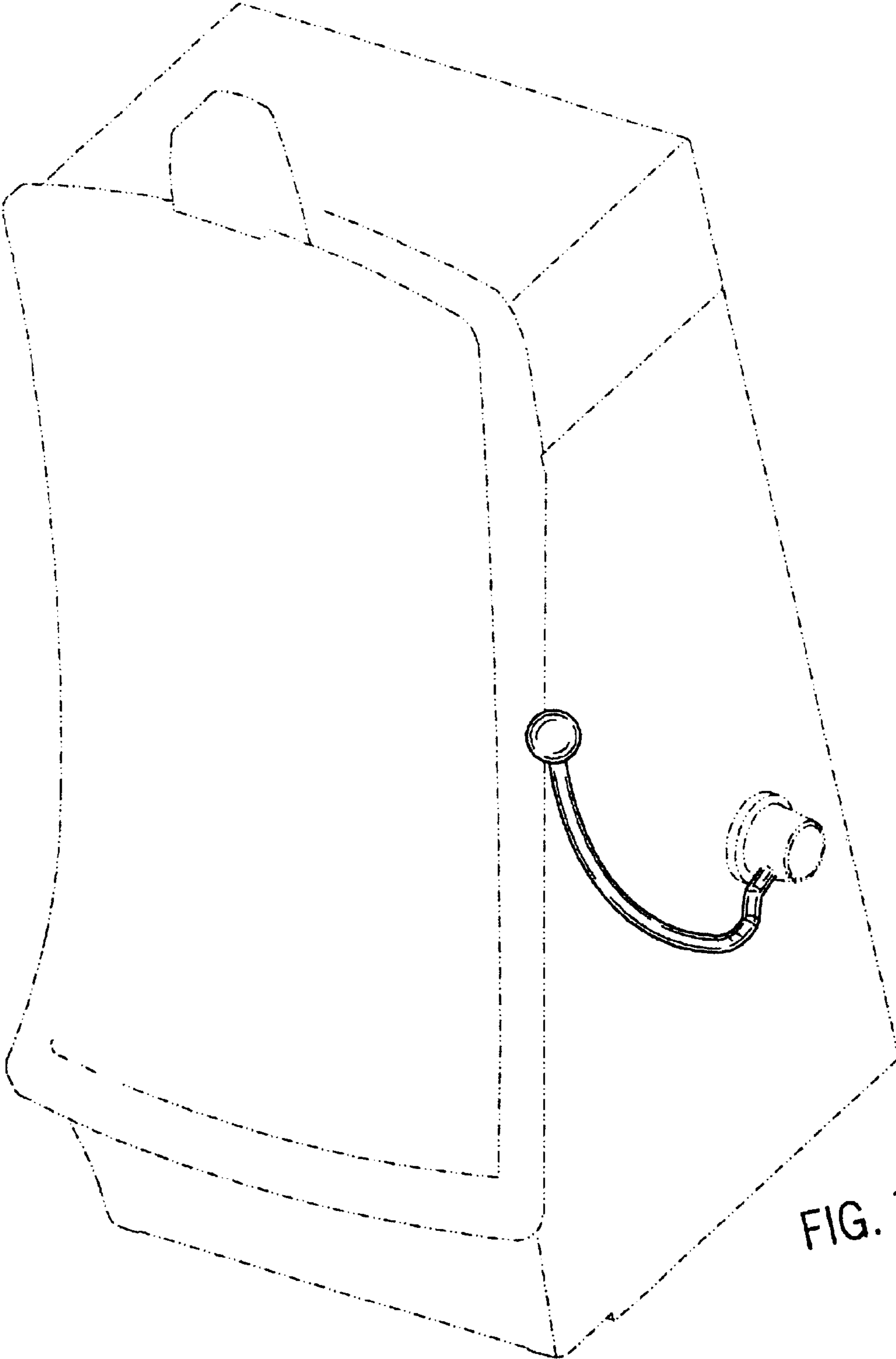

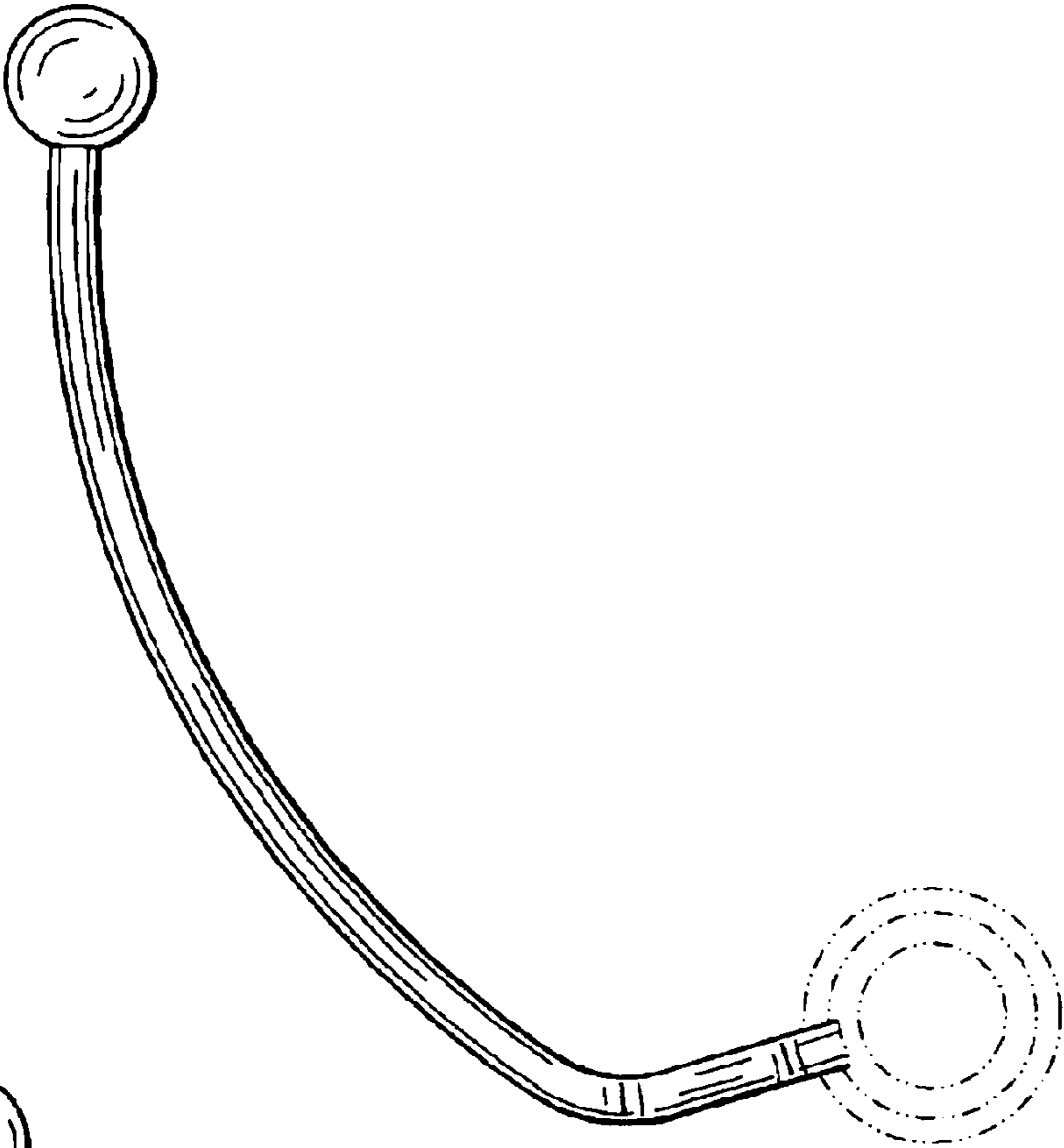

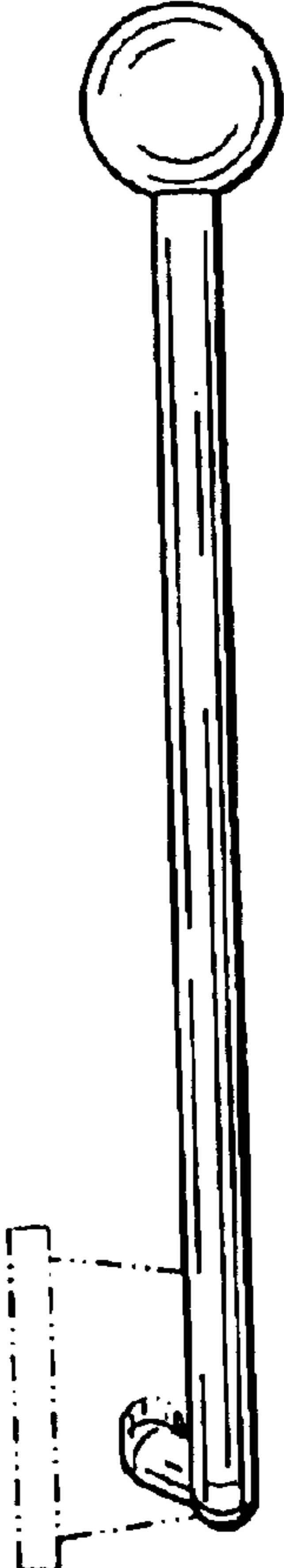

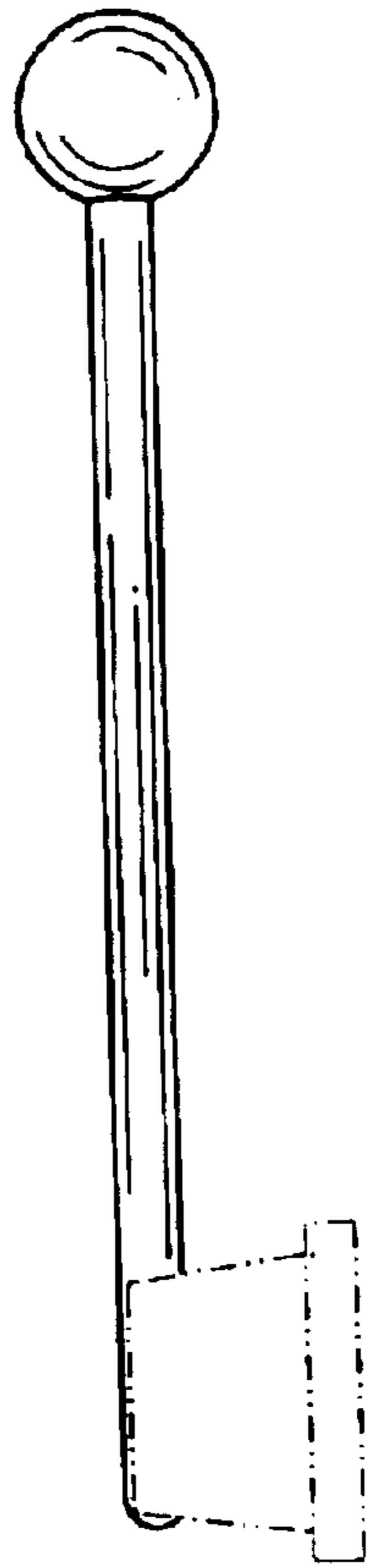

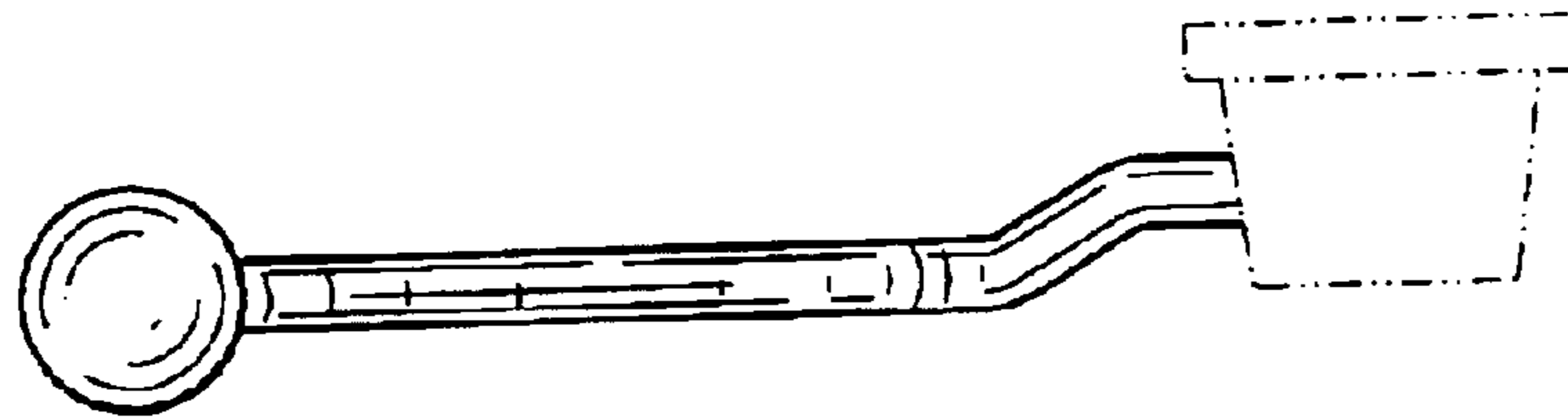

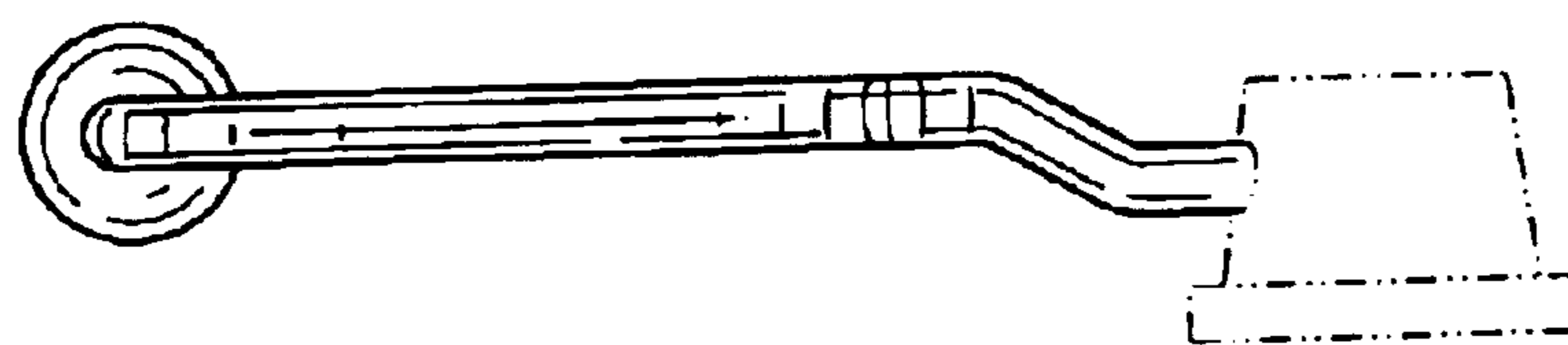

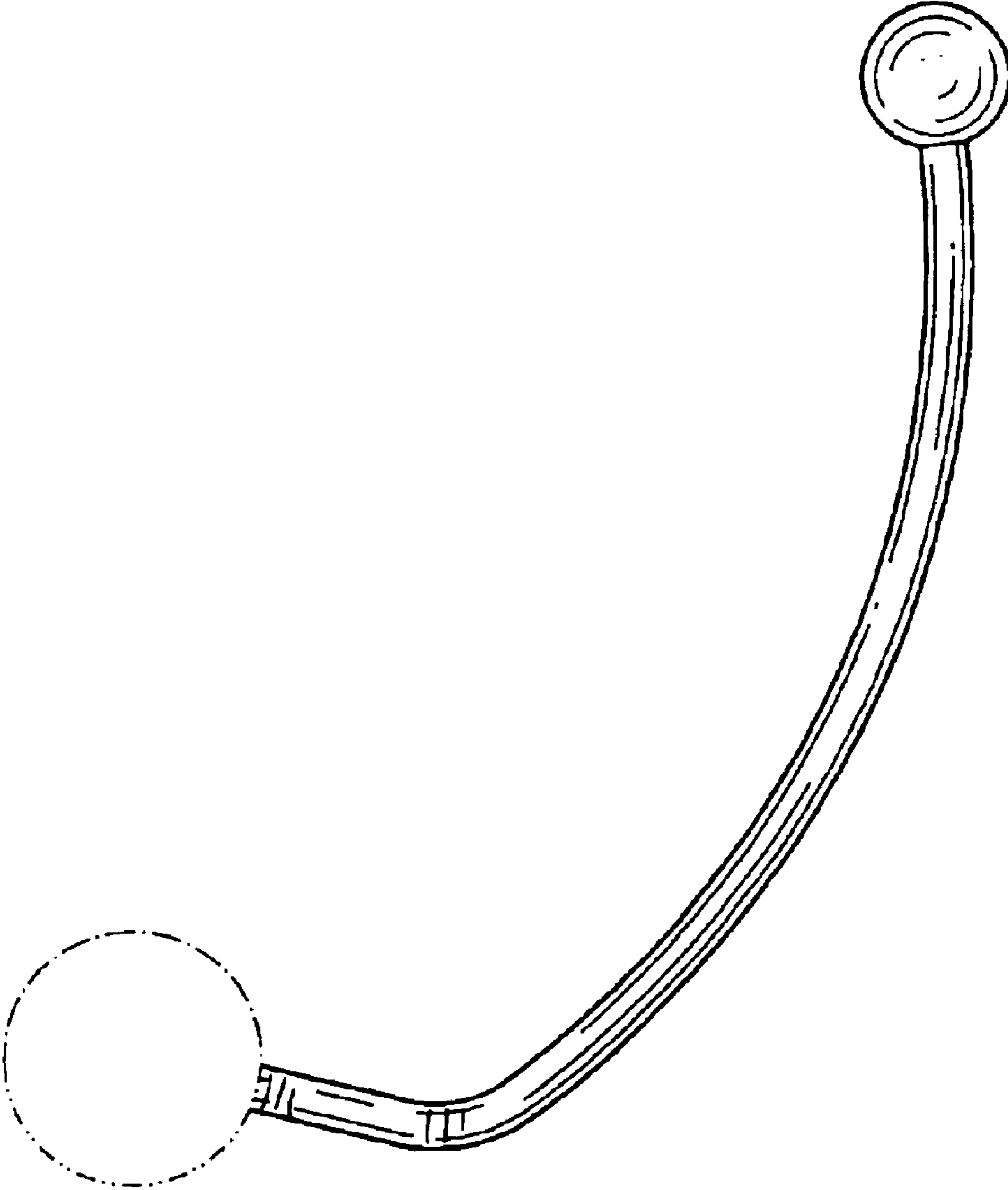
