I claim the ornamental design for a emergency first-aid kit carrying case, substantially as shown.

**DESCRIPTION**

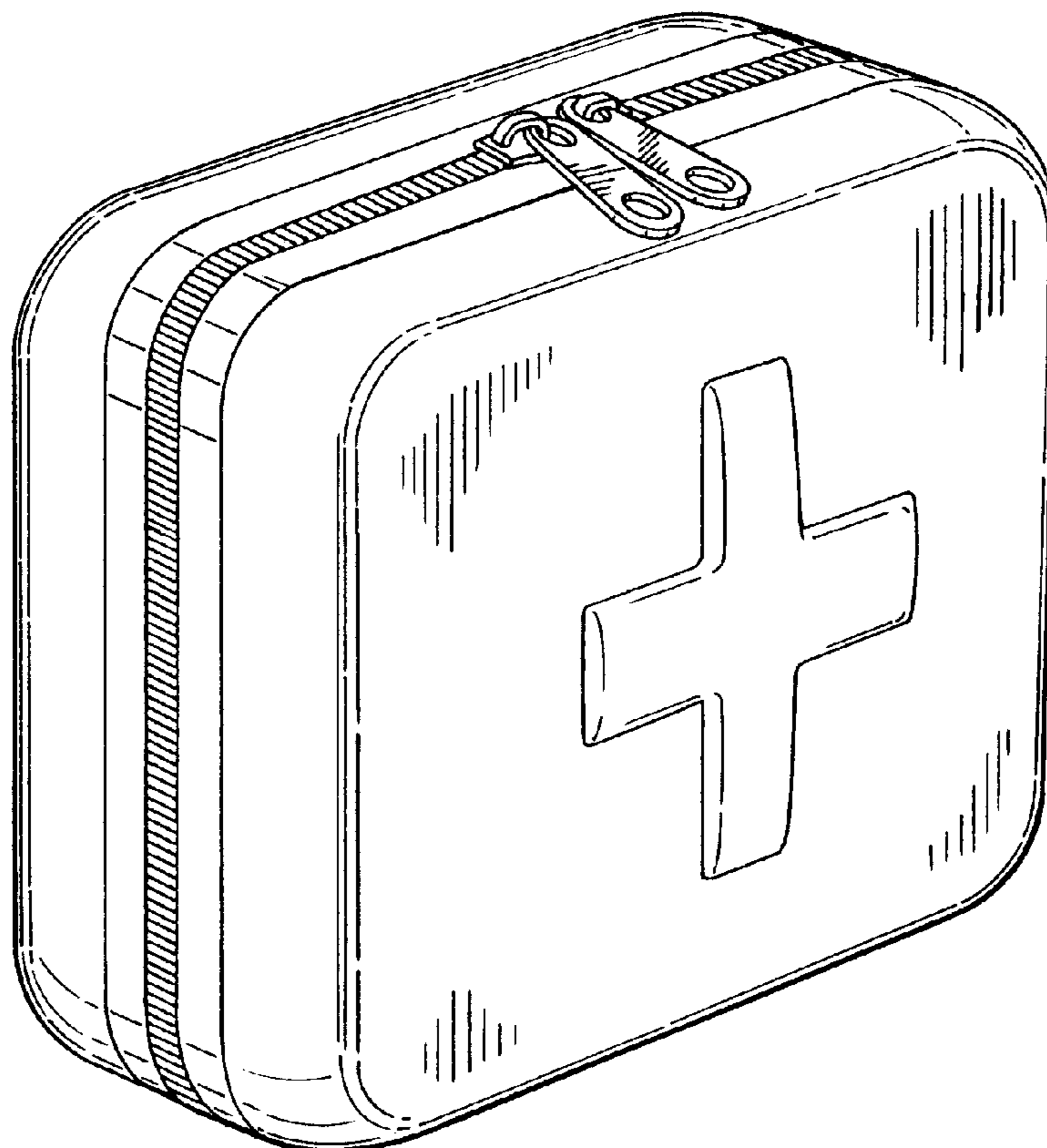

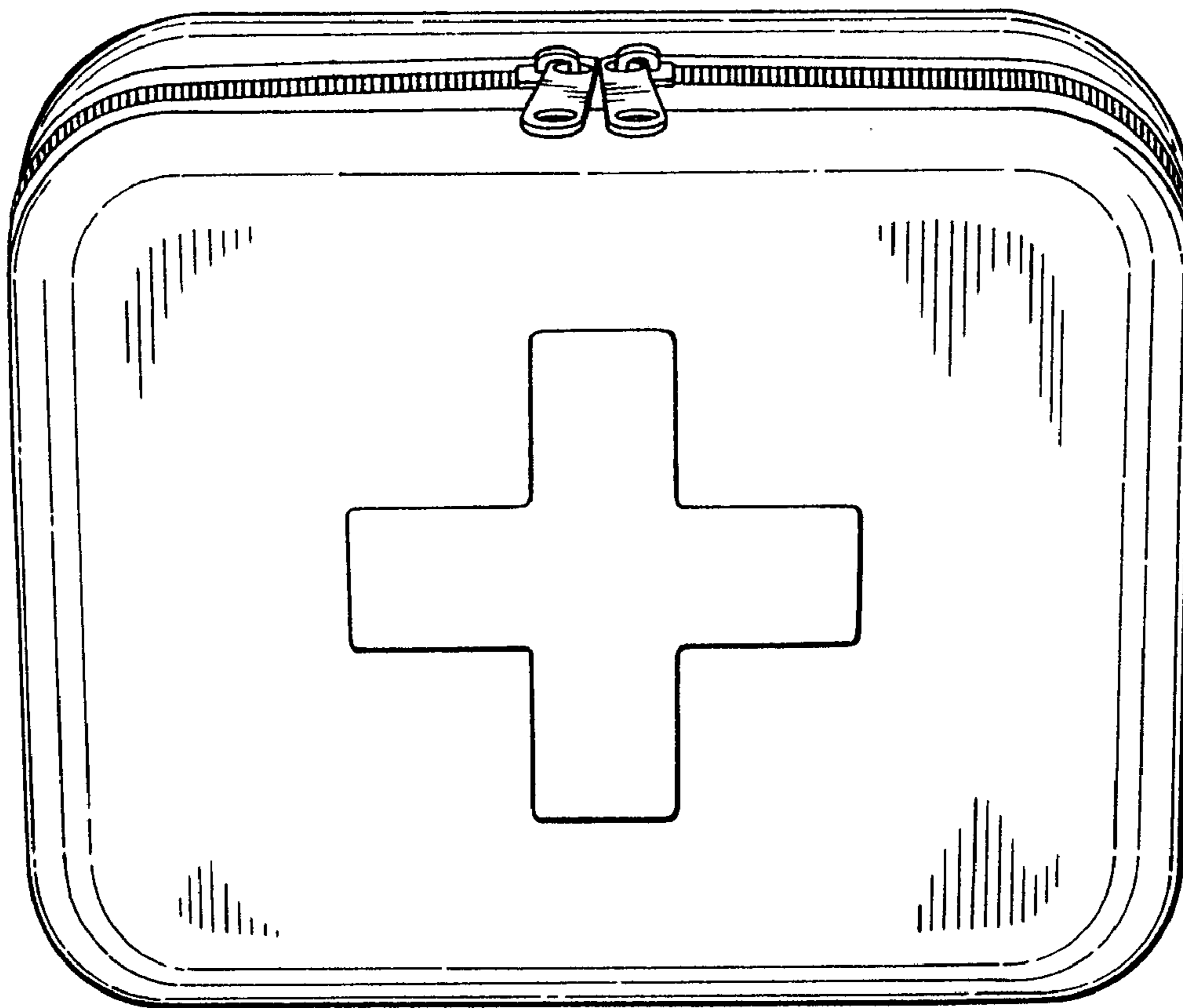

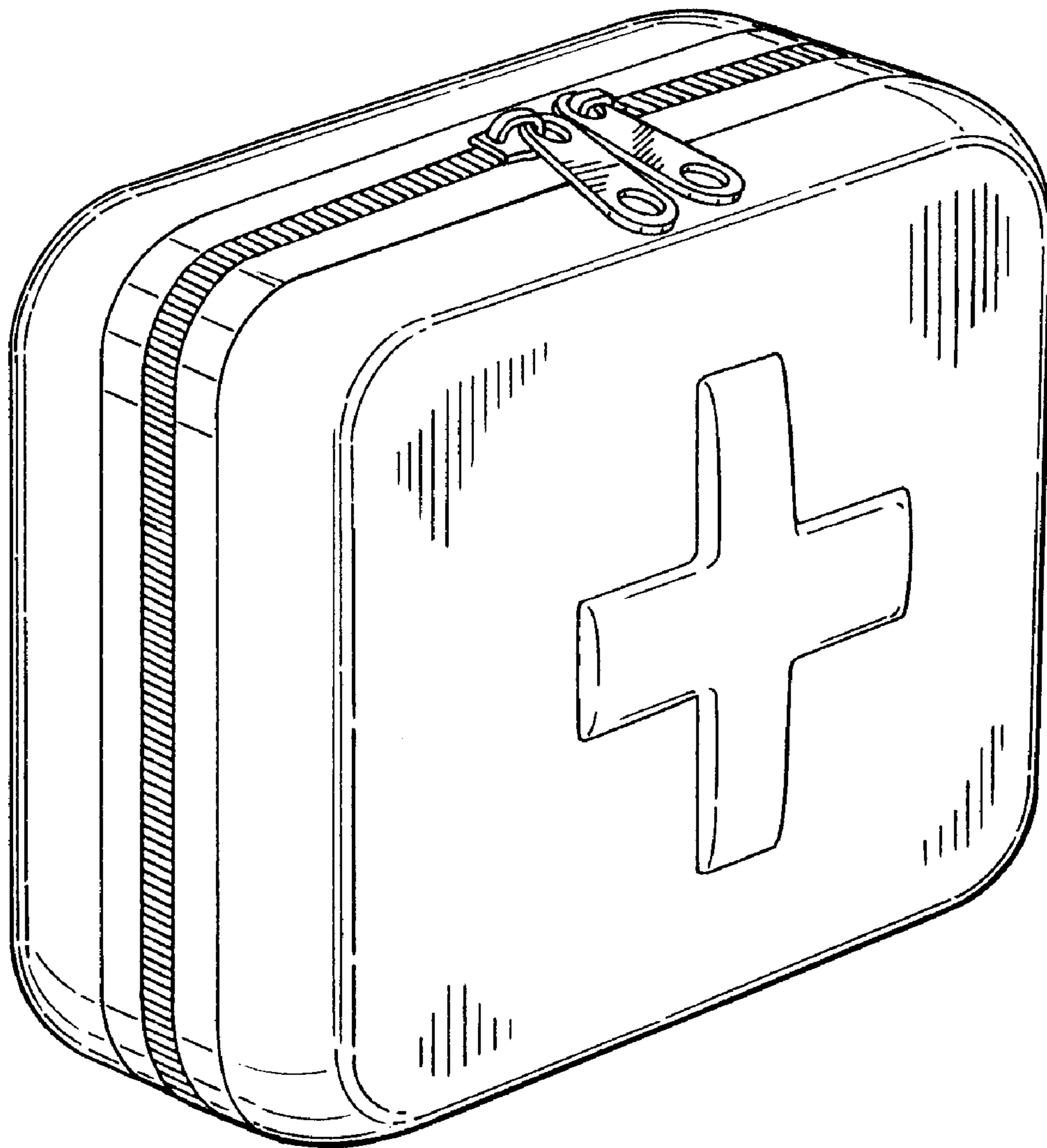

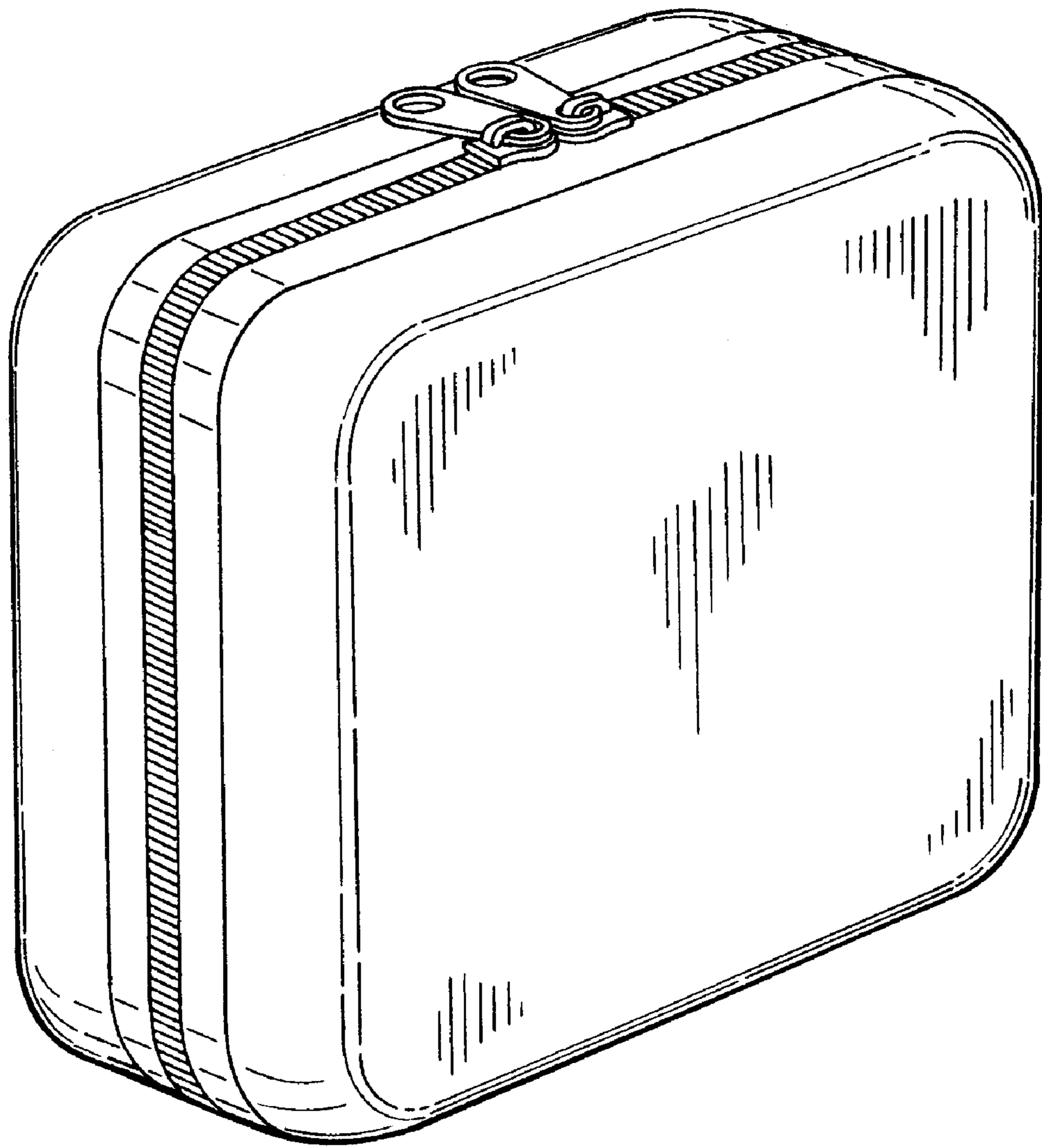

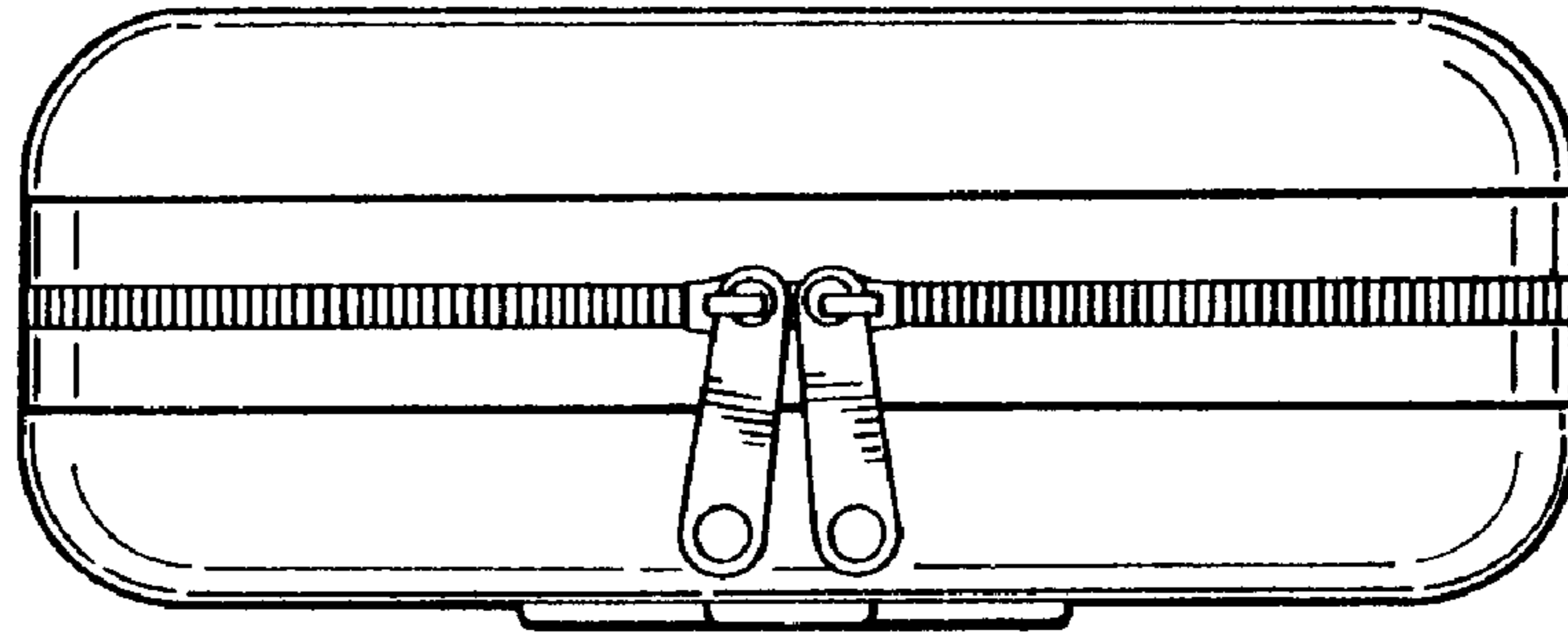

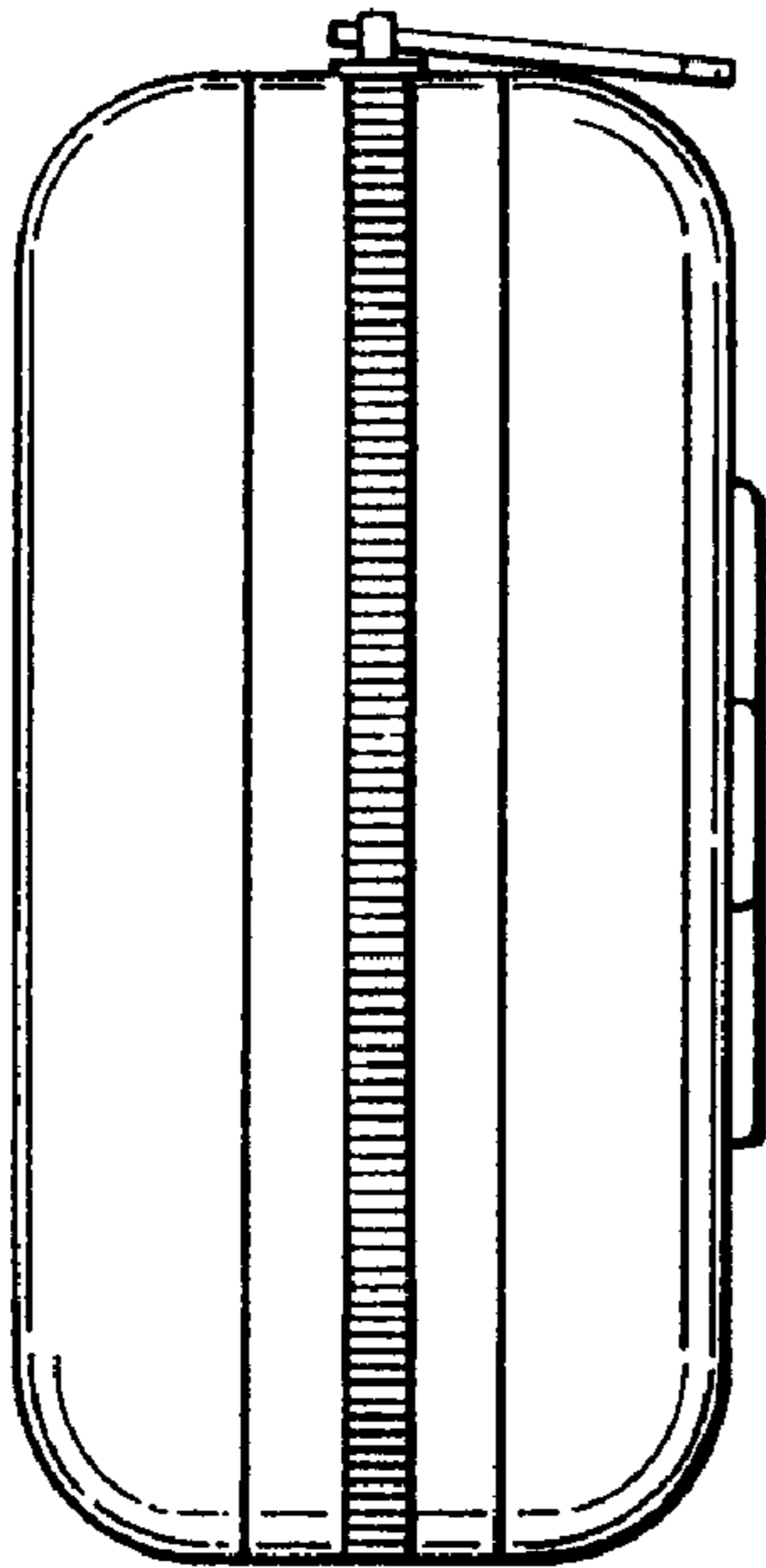

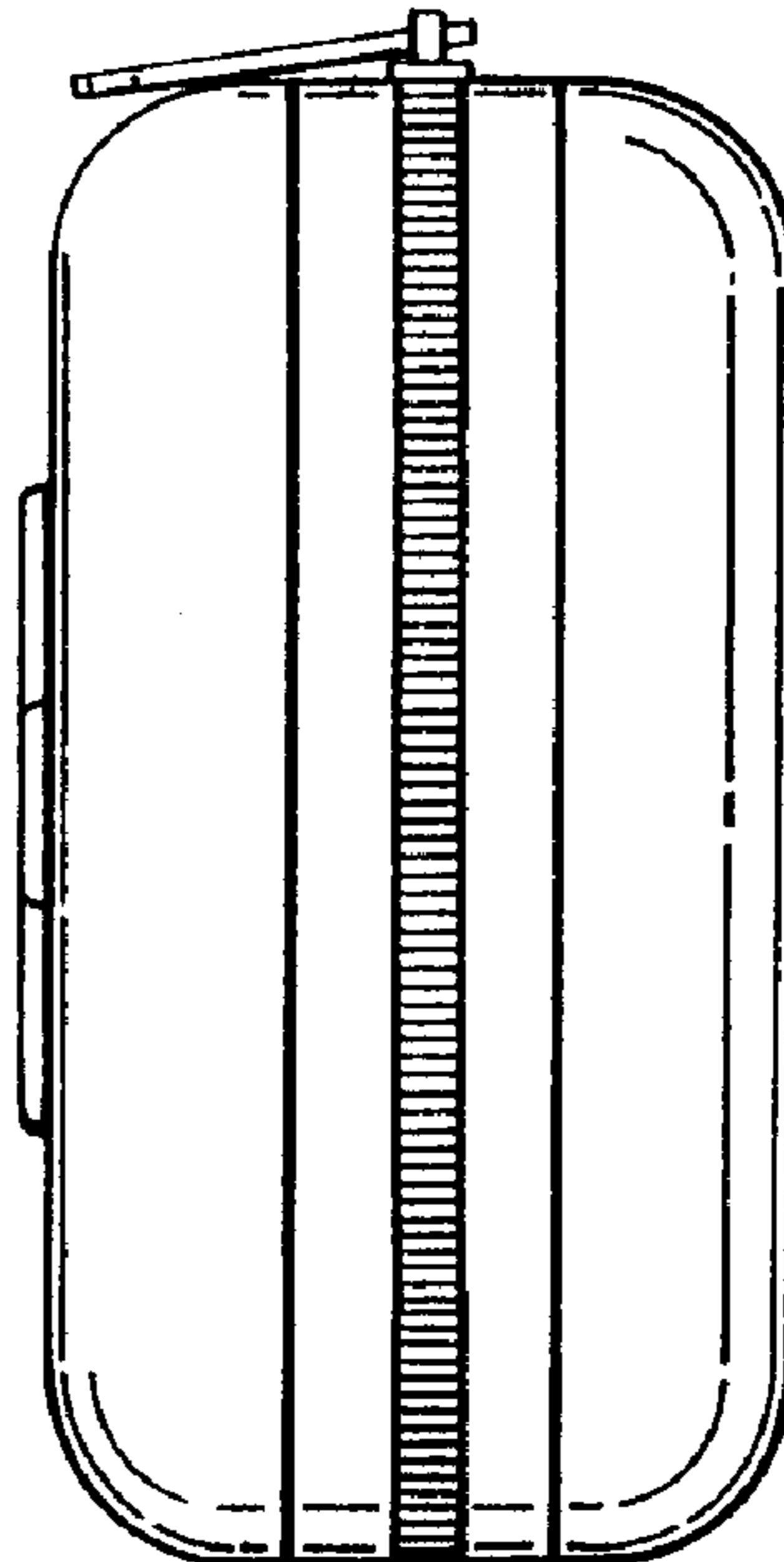
