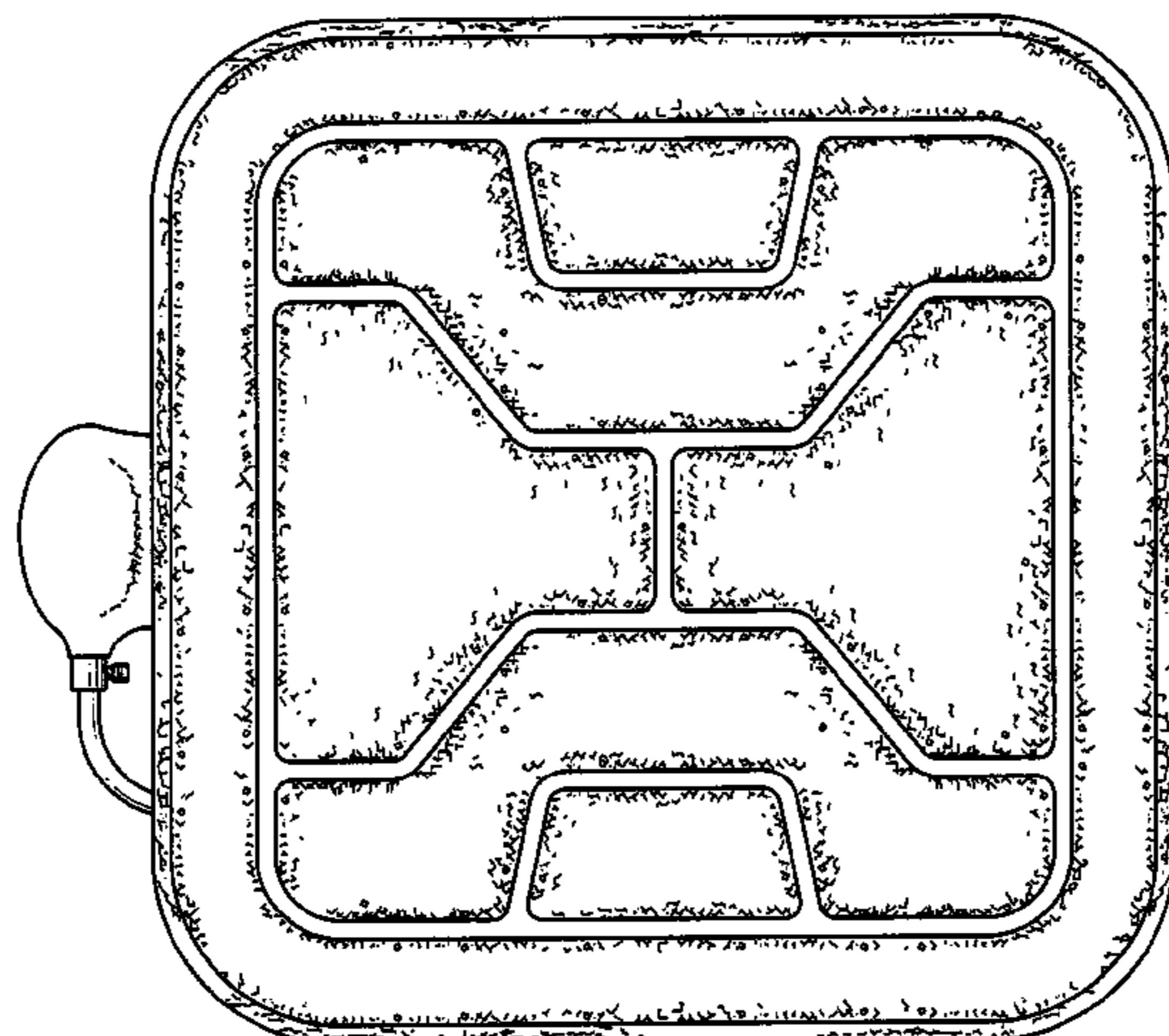
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a seat cushion showing my new design;  
FIG. 2 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;  
FIG. 5 is a left side elevational view thereof; and,

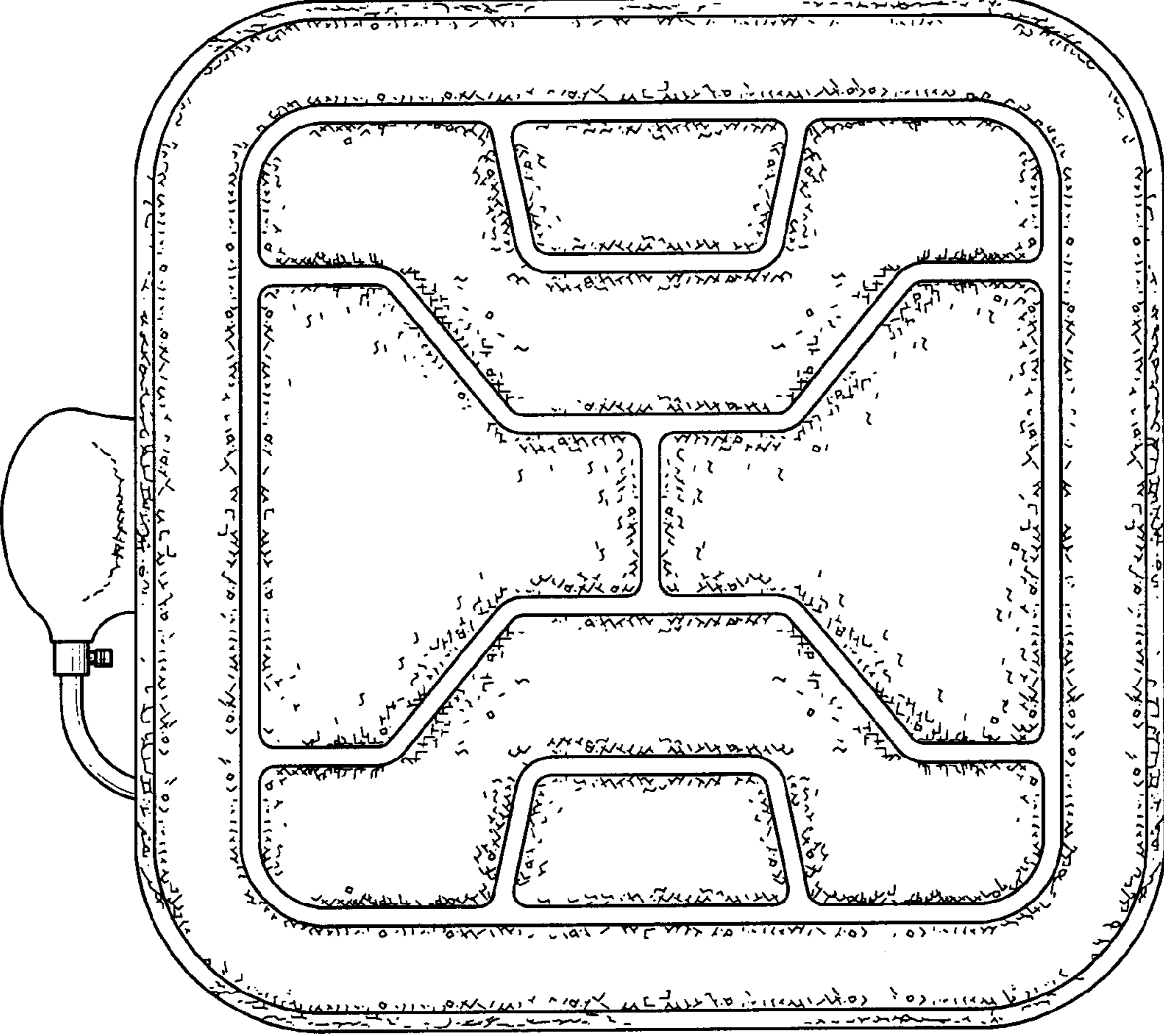

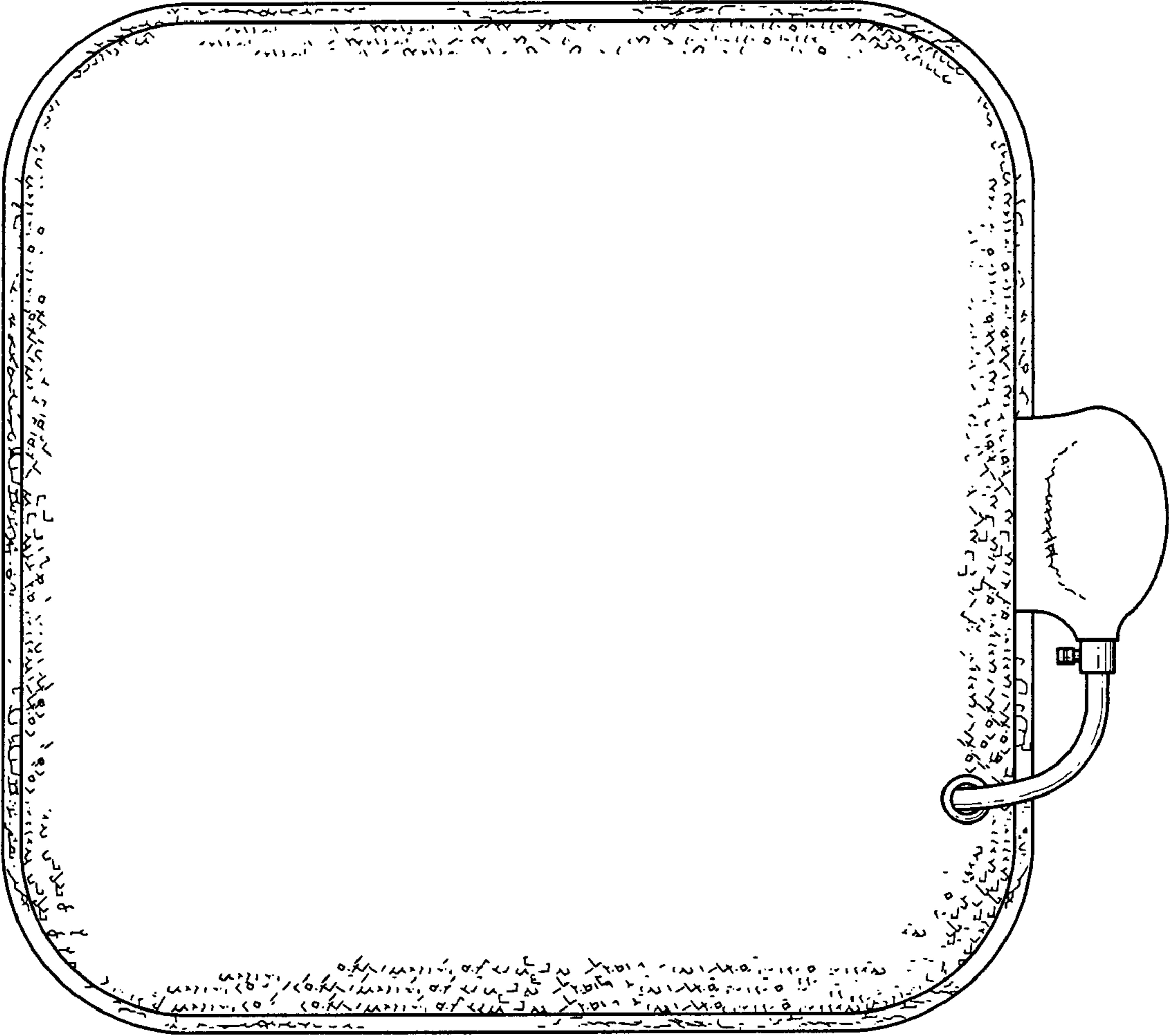

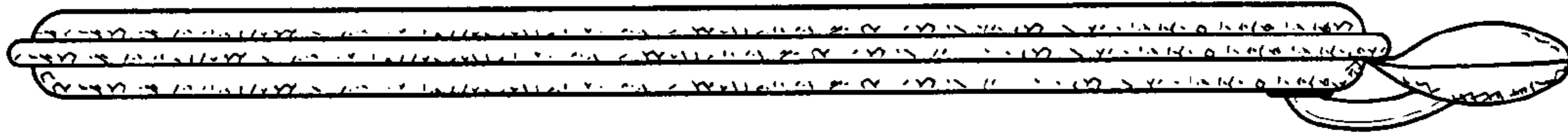

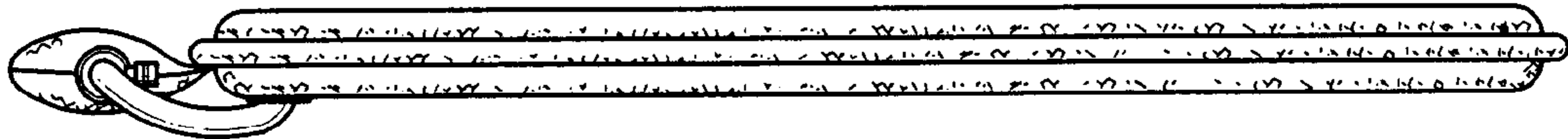

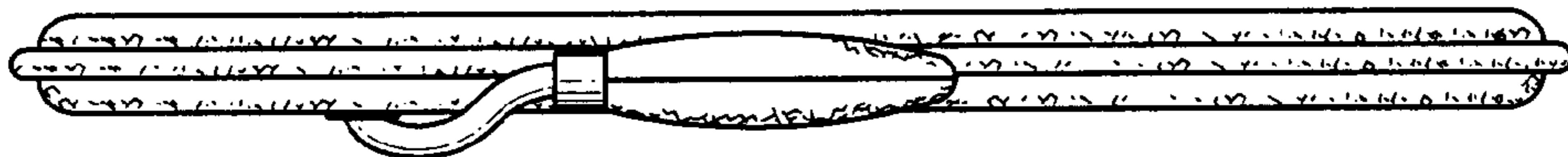

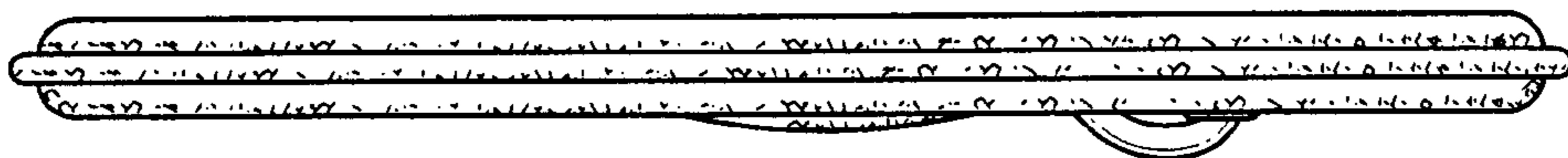
