FIG. 4 is a side view thereof;

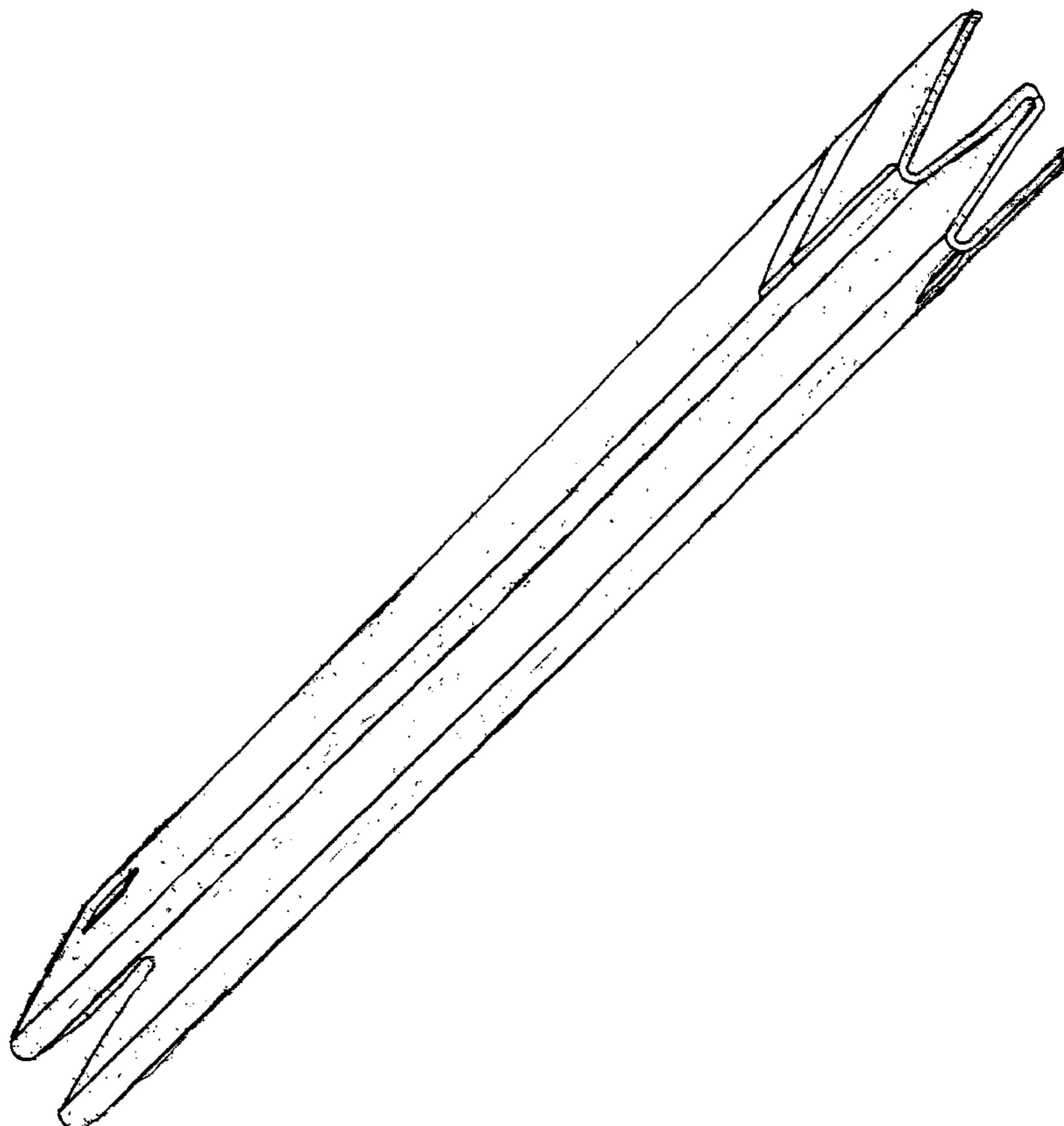
FIG. 5 is a bottom plan view thereof, the broken lines in this view also being understood to represent stitching;

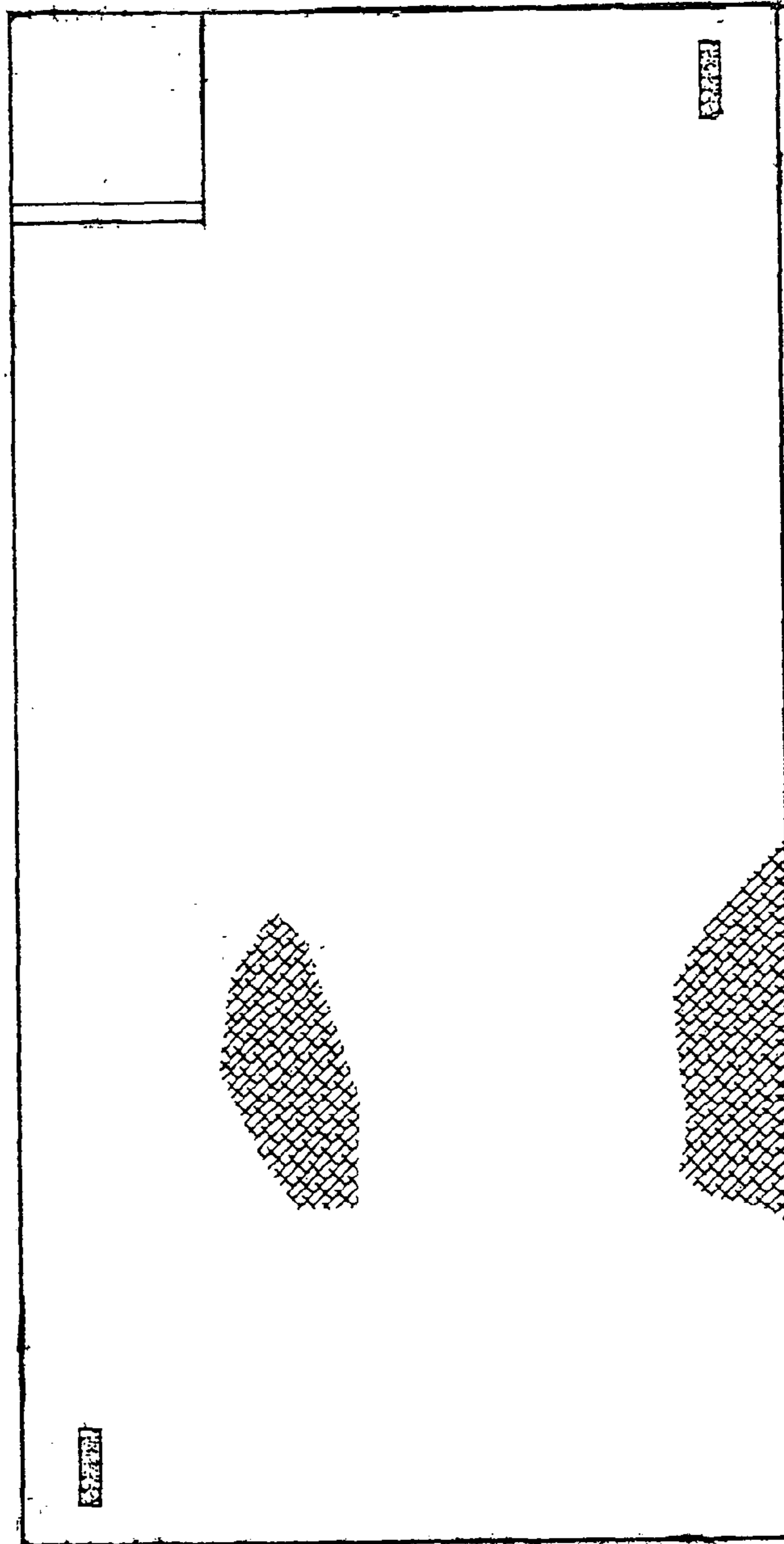

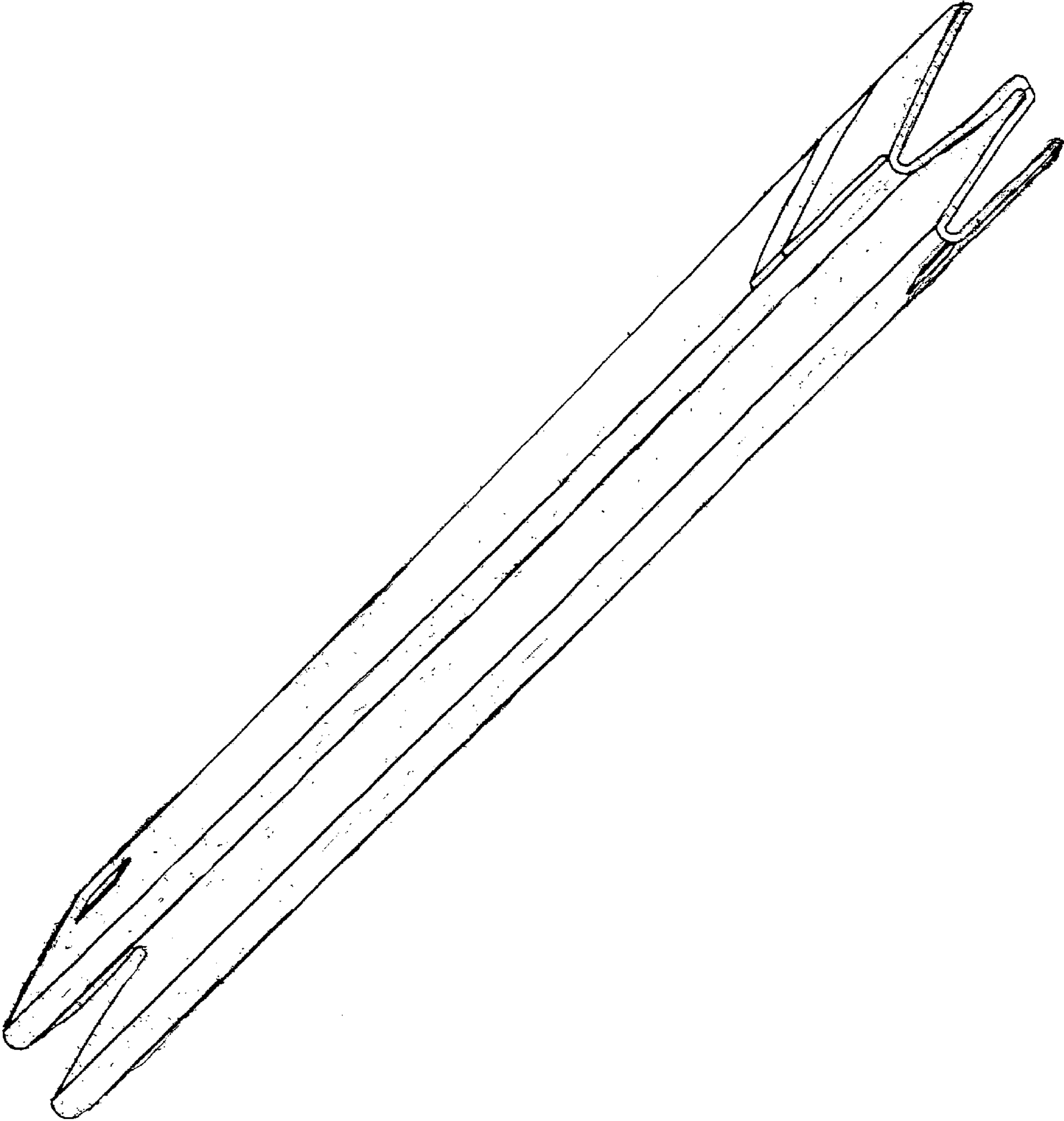

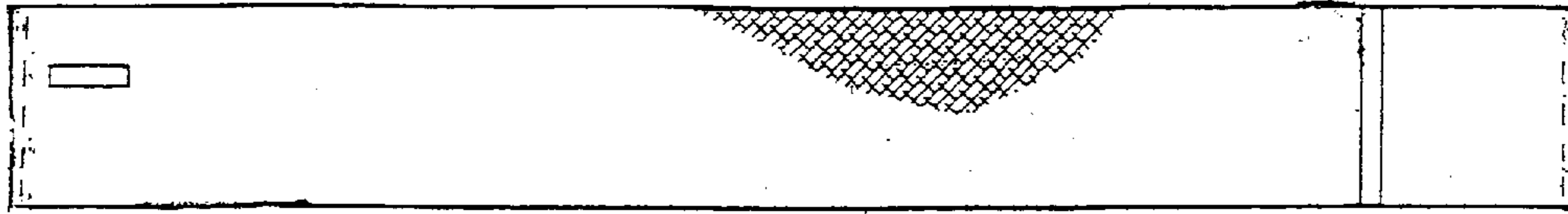

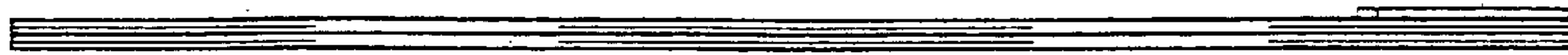

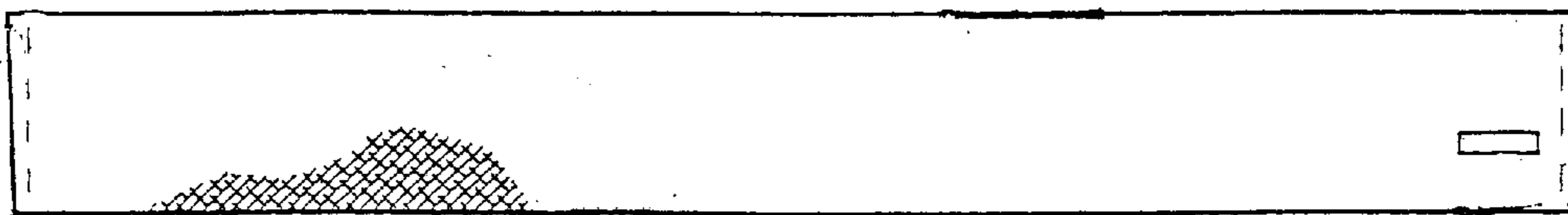

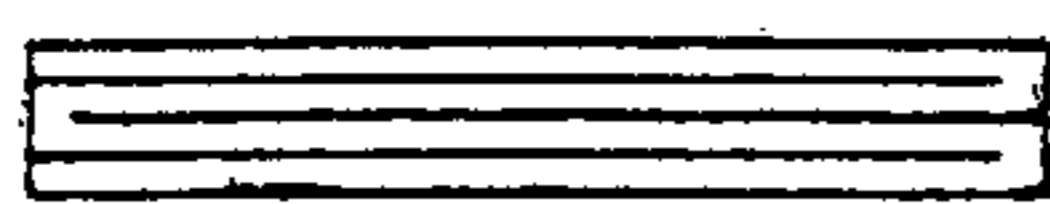

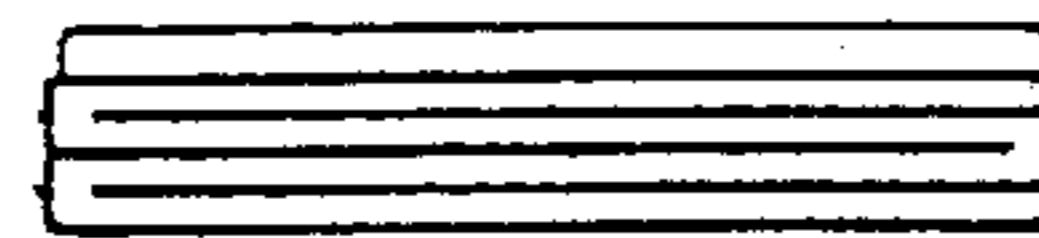
