The ornamental design for a golf green drink coaster, as shown and described.

**DESCRIPTION**

FIG. 9 is a rear elevation view of FIG. 8;

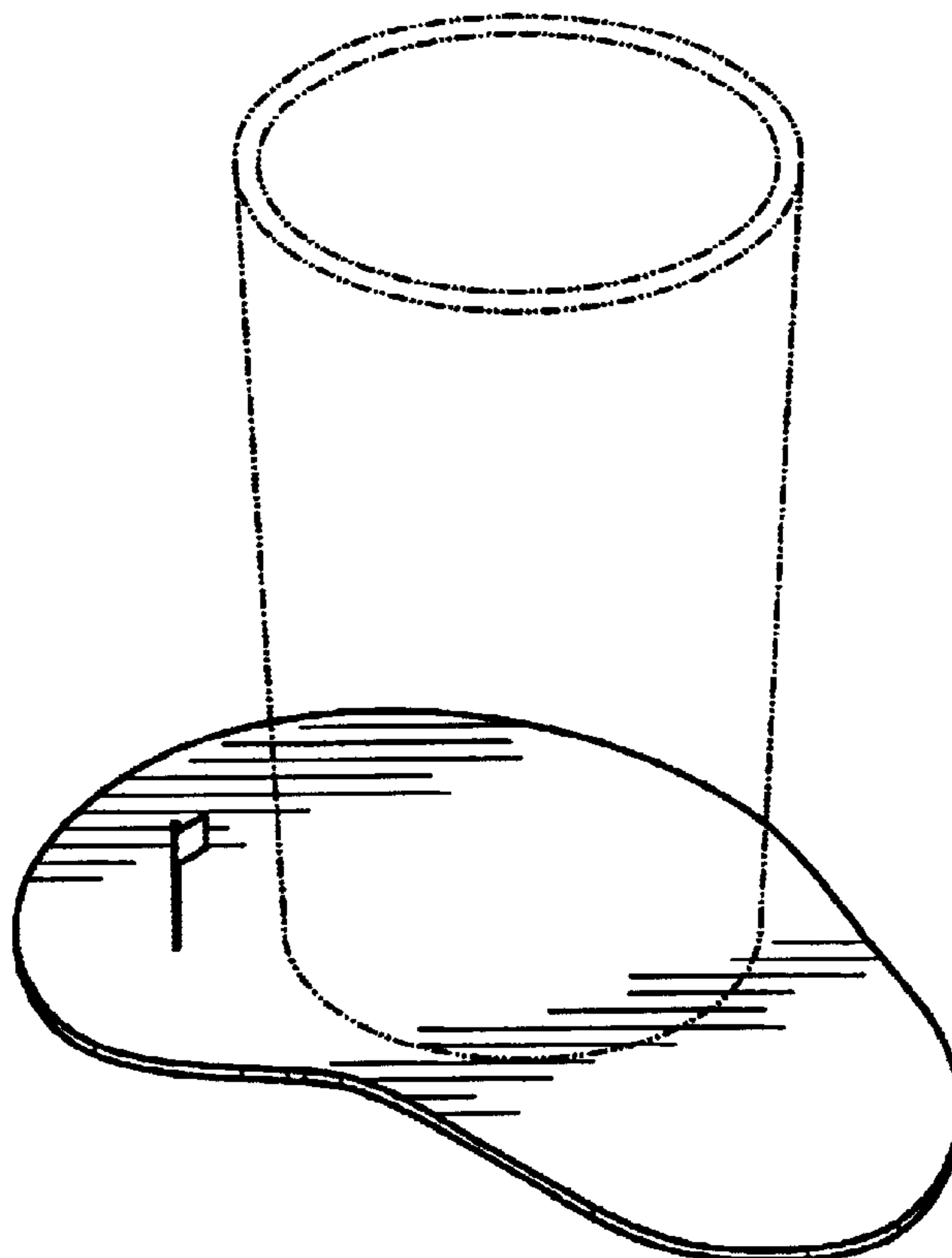
FIG. 10 is a front elevation view of FIG. 8;

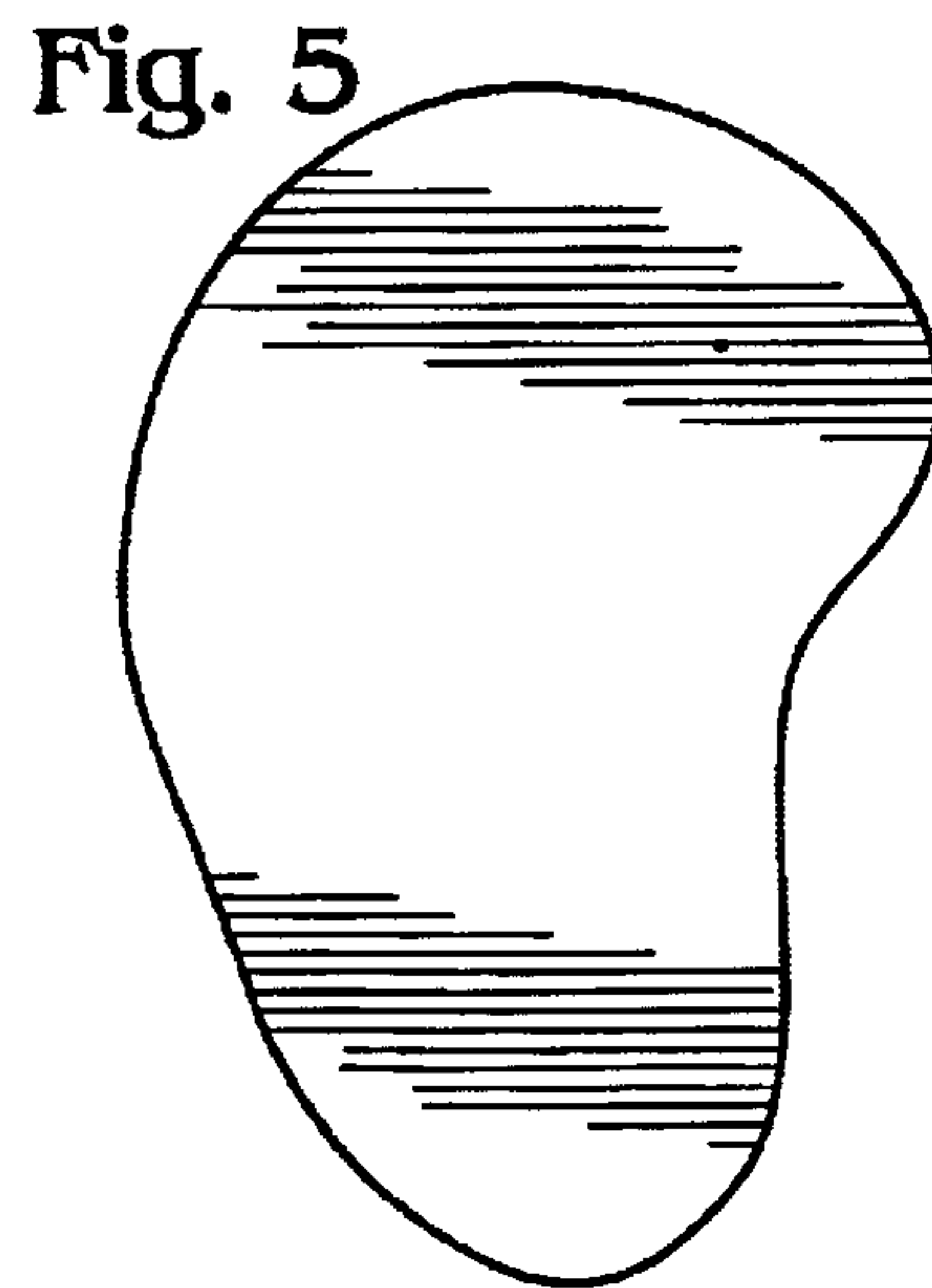
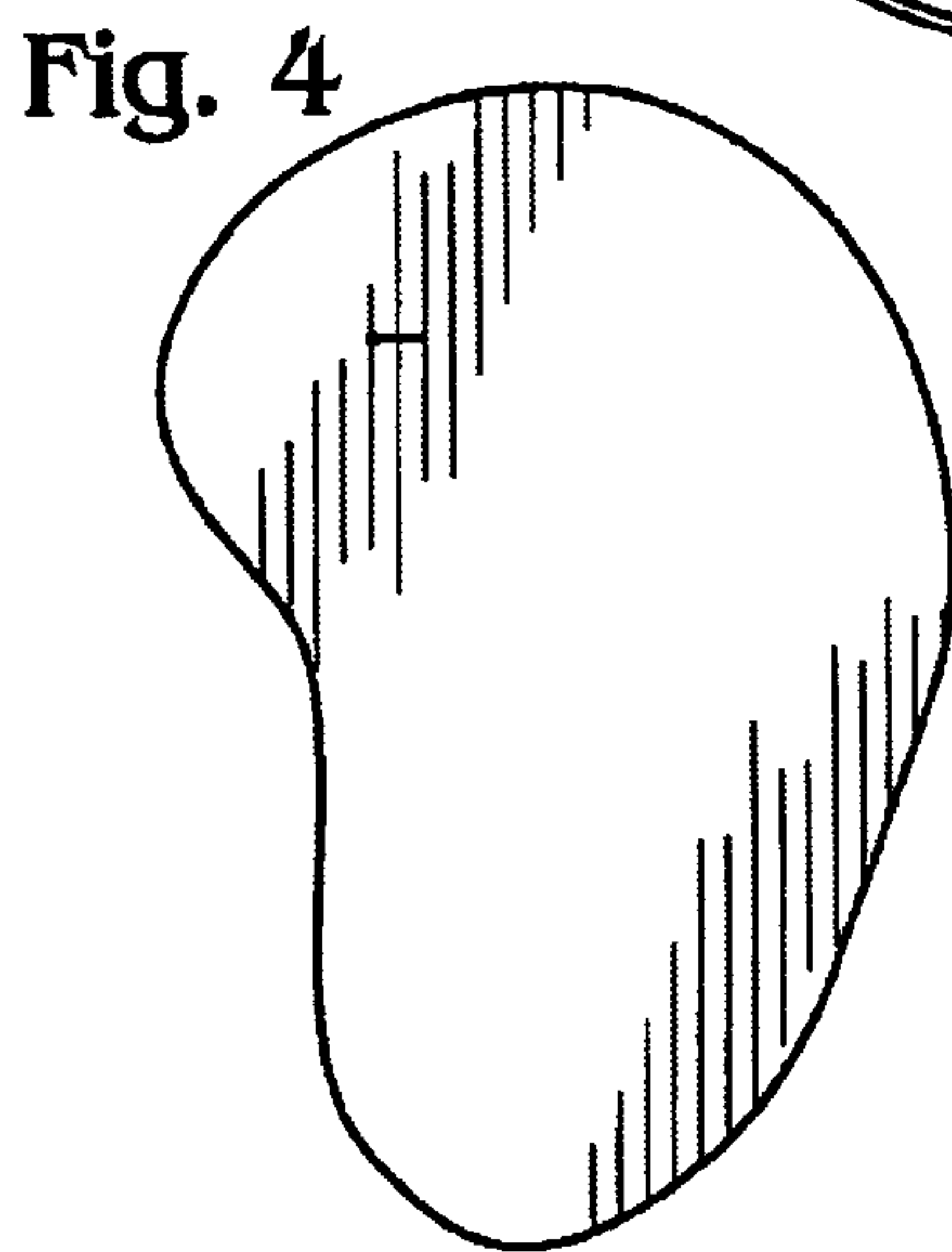
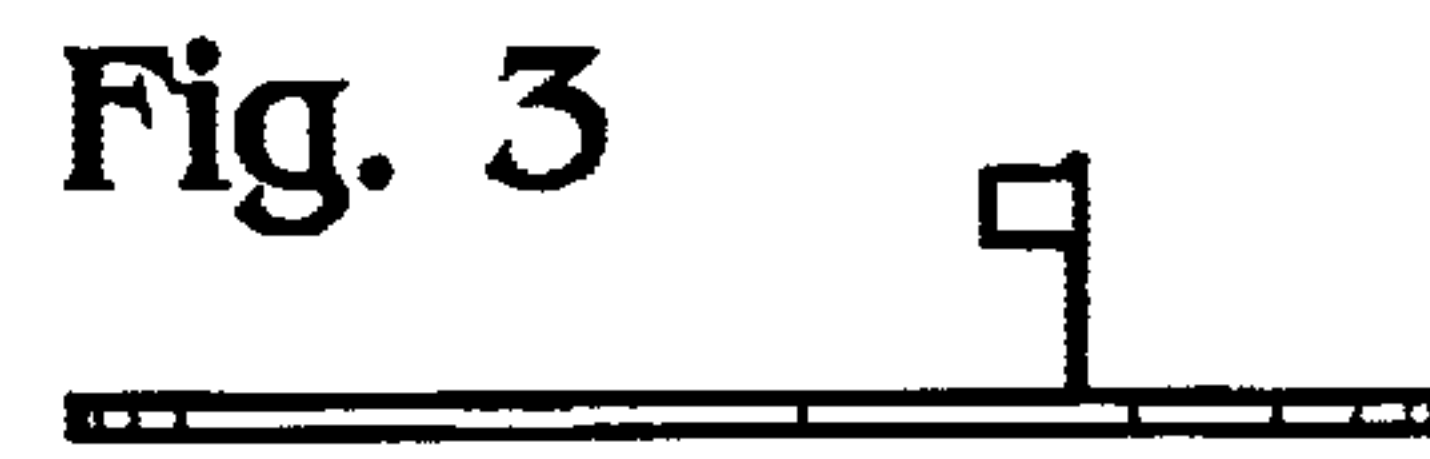
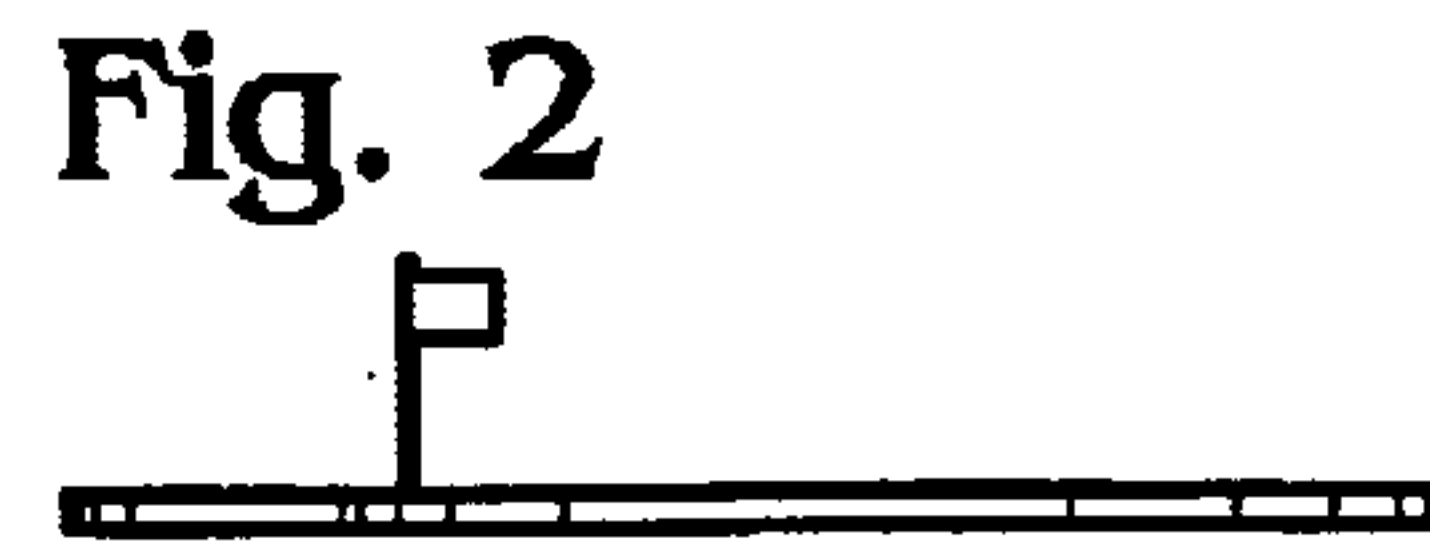
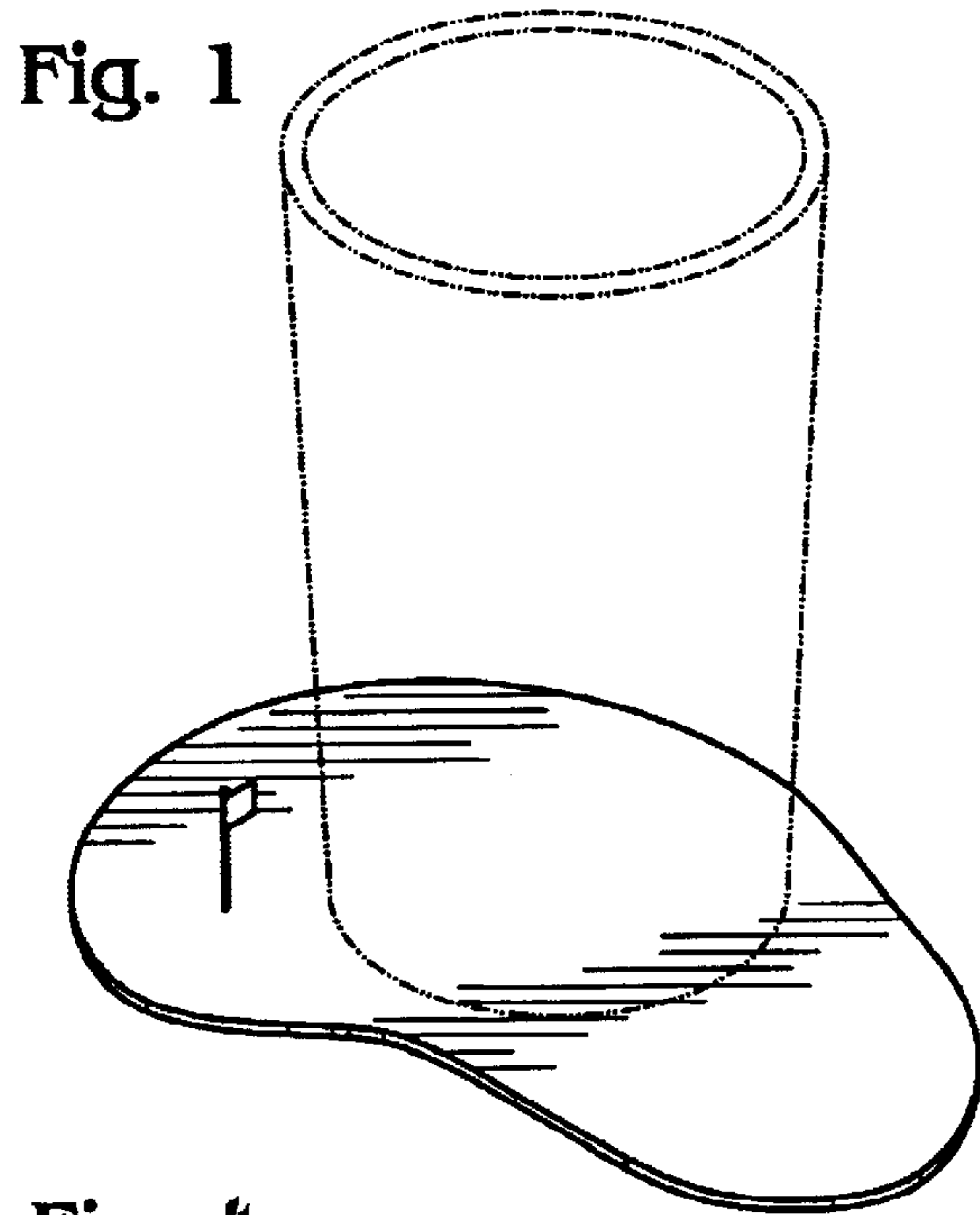

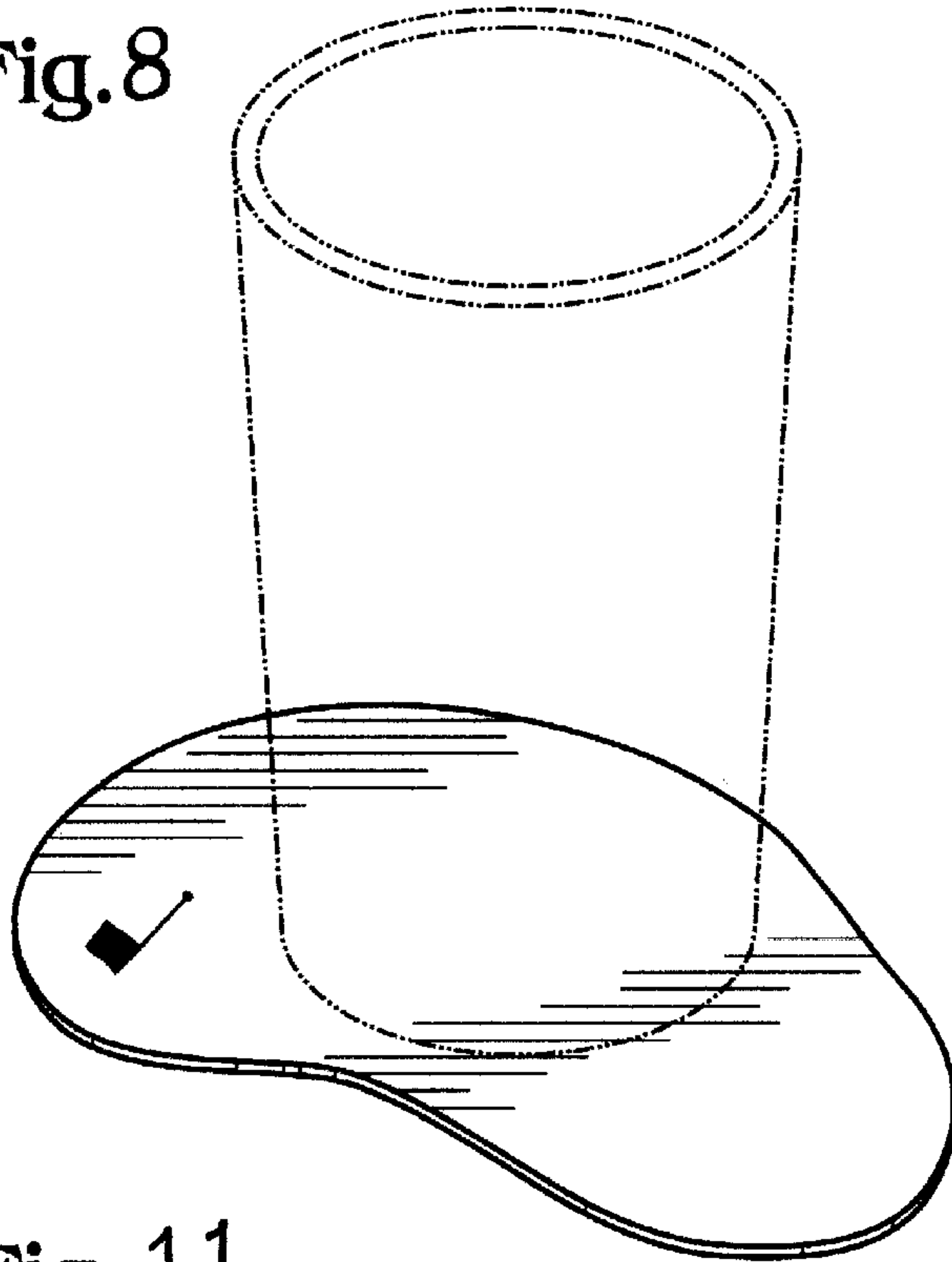

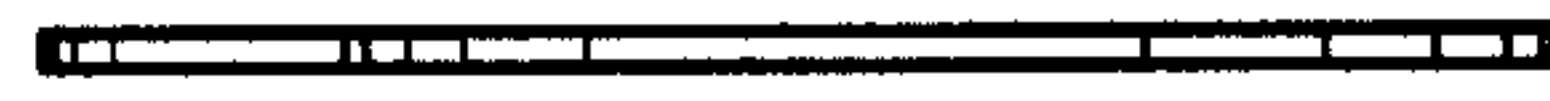

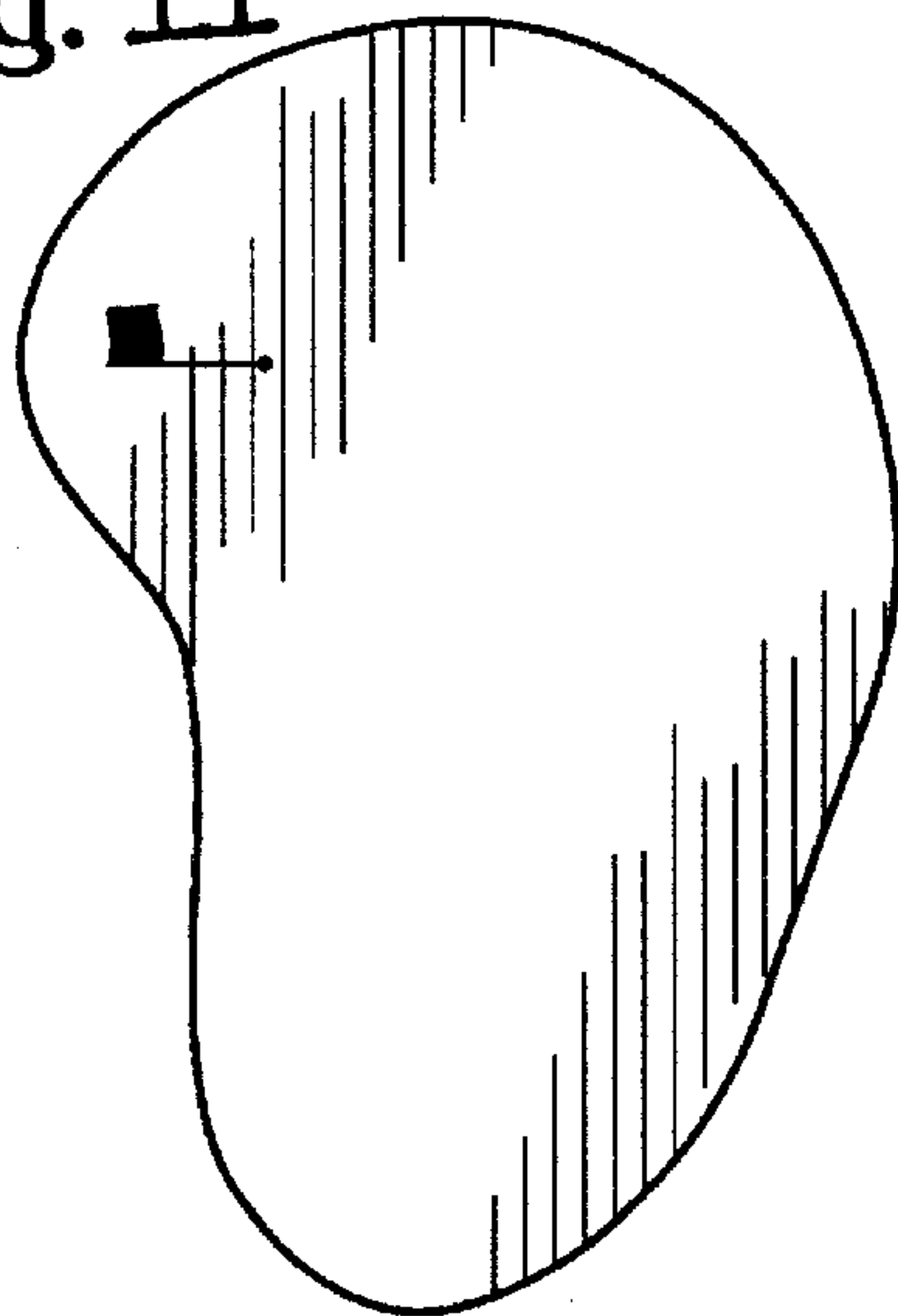
